ON L^p -HARDY INEQUALITIES FOR MAGNETIC p-LAPLACIANS

ABSTRACT. In this paper we revisit the remainder terms of L^p -Hardy inequalities for magnetic p-Laplacians. In particular, we will give an integral representation of the sharp constant for a crucial algebraic inequality established by C. Cazacu, D. Krejčiřík, N. Lam, and A. Laptev.

1. Introduction

The following well-known Euclidean L^p -Hardy inequalities (see [HLP52] for example) hold in any dimension $d \geq 2$ and for every 1 :

$$\int_{\mathbb{R}^d} |\nabla u|^p dx \ge \mu_{p,d} \int_{\mathbb{R}^d} \frac{|u|^p}{|x|^p} dx, \quad \forall u \in W^{1,p}(\mathbb{R}^d),$$

where the sharp constant $\mu_{p,d}$ is equal to $(\frac{d-p}{p})^p$. Recently there is a rising interest in the improved Hardy inequality for the magnetic p-Laplacian which we now recall.

Let $B: \mathbb{R}^d \to \mathbb{R}^{d \times d}$ be a smooth matrix-valued function representing the exact magnetic field, then there exists a smooth magnetic potential $A: \mathbb{R}^d \to \mathbb{R}^d$, such that dA = B (see for example [CK16] and [CKLL24, Section 1.2] for more details).

Definition 1. The magnetic p-Laplacian is formally defined on $C_c^{\infty}(\mathbb{R}^d)$ by

$$\Delta_{A,p}u := \operatorname{div}_A(|\nabla_A u|^{p-2}\nabla_A u),$$

where the magnetic gradient and magnetic divergence are given by

$$\nabla_A u := \nabla u + iA(x)u$$
, $\operatorname{div}_A F := \operatorname{div} F + iA \cdot F$.

Here, $1 and <math>F : \mathbb{R}^d \to \mathbb{C}^d$ denotes a smooth vector field.

The associated quadratic form $h_{A,p}$ of the magnetic p-Laplacian $\Delta_{A,p}$, with its form domain denoted by $\mathcal{D}(h_{A,p})$, is then defined by

$$h_{A,p}[u] := \int_{\mathbb{R}^d} |\nabla_A u|^p dx, \quad u \in \mathcal{D}(h_{A,p}) := \overline{C_c^{\infty}(\mathbb{R}^d)}^{\|\cdot\|},$$

where the norm $\|\cdot\|$ with respect to which the closure is taken is given by

$$||u|| := \left(h_{A,p}[u] + ||u||_{L^p(\mathbb{R}^d)}^p\right)^{1/p}.$$

In a recent interesting paper, C. Cazacu, D. Krejčiřík, N. Lam, and A. Laptev established for the magnetic p-Laplacians the following improved Hardy inequalities.

Theorem 2 ([CKLL24], Theorem 1.2). Let $2 \le p < d$ and B be a smooth and closed magnetic field with $B \neq 0$. Then there exists a constant $c_p > 0$ such that for any vector field A with dA = B, and for any $u \in \mathcal{D}(h_{A,p})$,

$$\int_{\mathbb{R}^d} |\nabla_A u|^p dx - \mu_{p,d} \int_{\mathbb{R}^d} \frac{|u|^p}{|x|^p} dx \ge c_p \int_{\mathbb{R}^d} \left| \nabla_A \left(u|x|^{\frac{d-p}{p}} \right) \right|^p |x|^{p-d} dx. \tag{1}$$

The constant c_p is given by

$$c_p = \inf_{(s,t)\in\mathbb{R}^2\setminus\{(0,0)\}} \frac{\left[t^2 + s^2 + 2s + 1\right]^{\frac{p}{2}} - 1 - ps}{\left[t^2 + s^2\right]^{\frac{p}{2}}} \in (0,1]. \tag{2}$$

The "improved" Hardy inequality (1) also holds when $p \in (1,2)$ with the same constant c_p in (2), however, $c_p \equiv 0$ in this case (see [CKLL24, Proposition 3.1]). Note that in [CKLL24], (1) was reduced to the following minimisation problem.

Question. What is the sharp constant c_p for the following algebraic inequality:

$$C_p(x,y) := |x|^p - |x-y|^p - p|x-y|^{p-2}\Re((x-y) \cdot \overline{y}) \ge c_p|y|^p, \quad \forall x, y \in \mathbb{C}^d, \quad (3)$$

where \Re stands for the real part of a complex number?

Inspired by the work [IIO17] of N. Ioku, M. Ishiwata and T. Ozawa, we propose an integral representation of $C_p(x,y)$ which allows us to revisit the sharp c_p in (3). Trivially, (3) holds for y = 0, x = 0 or y = x. Also, $c_p = 1$ for p = 2. Without loss of generality, we shall not analyze these trivial cases in what follows.

Firstly, for $\xi, \eta \in \mathbb{C}^d$ we introduce the following quantity

$$R_{p}(\xi, \eta) = \begin{cases} \frac{1}{|\xi - \eta|^{2}} \left(\frac{1}{p} |\eta|^{p} + \frac{1}{p'} |\xi|^{p} - |\xi|^{p-2} \Re(\xi \cdot \bar{\eta}) \right), & \text{if } \xi \neq \eta, \\ \frac{p-1}{2} |\xi|^{p-2}, & \text{if } \xi = \eta, \end{cases}$$

where p > 1 and $\frac{1}{p'} = 1 - \frac{1}{p}$. Our first result is stated as follows.

Theorem 3. We have the following integral representation: for any $\xi, \eta \in \mathbb{C}^d$,

$$R_{p}(\xi,\eta) = (p-1) \int_{0}^{1} |\theta\xi + (1-\theta)\eta|^{p-2}\theta d\theta + (p-2) \int_{0}^{1} |\theta\xi + (1-\theta)\eta|^{p-4} \frac{|\xi|^{2} |\eta|^{2} - \Re^{2}(\xi \cdot \bar{\eta})}{|\xi - \eta|^{2}} \theta d\theta,$$

$$(4)$$

and if $p \geq 2$,

$$R_p(\xi, \eta) \ge (p-1) \int_0^1 |\theta\xi + (1-\theta)\eta|^{p-2} \theta d\theta.$$

The above inequality becomes an equality when $\xi = \lambda \eta$ with $\lambda \in \mathbb{R}$.

Remark 4. The case $\xi, \eta \in \mathbb{R}$ was considered in [IIO17], in particular,

$$R_p(\xi, \eta) = (p-1) \int_0^1 |\theta\xi + (1-\theta)\eta|^{p-2} \theta d\theta.$$

Remark 5. Using Theorem 3 and setting $\xi = x - y$, $\eta = x$, we have

$$\frac{C_p(x,y)}{|y|^p} = p \frac{R_p(x-y,x)}{|y|^{p-2}}
= p(p-1) \int_0^1 \left| \theta \frac{y}{|y|} - \frac{x}{|y|} \right|^{p-2} \theta d\theta
+ (p-2) \int_0^1 |\theta y - x|^{p-4} \frac{|x-y|^2 |x|^2 - \Re^2((x-y) \cdot \bar{x})}{|y|^p} \theta d\theta,$$
(5)

and if $p \geq 2$,

$$\frac{C_p(x,y)}{|y|^p} \ge p(p-1) \int_0^1 \left| \theta \frac{y}{|y|} - \frac{x}{|y|} \right|^{p-2} \theta d\theta.$$

The above inequality becomes an equality when $x = \lambda y$ with $\lambda \in \mathbb{R}$.

Our second result is stated as follows.

Theorem 6. i) Let $p \ge 2$. The sharp constant c_p in (3) is determined as $c_p = (p-1)(1-k_0)^p + pk_0(1-k_0)^{p-1} + k_0^p > 0$,

in the case of $x = k_0 y$, where $k_0 = \frac{r_0}{1+r_0}$ and r_0 is the solution of the equation

$$r^{p-1} - (p-1)r - (p-2) = 0.$$

ii) Let $1 . The sharp constant <math>c_p$ in (3) is equal to 0.

Remark 7. Let p = 3. We obtain $r_0 = \sqrt{2} + 1$, $k_0 = \frac{\sqrt{2}}{2}$, and

$$c_3 = 2\left(1 - \frac{\sqrt{2}}{2}\right)^3 + 3\frac{\sqrt{2}}{2}\left(1 - \frac{\sqrt{2}}{2}\right)^2 + \left(\frac{\sqrt{2}}{2}\right)^3 = 2 - \sqrt{2}.$$

2. Proofs of Theorem 3 and Theorem 6

Proof of Theorem 3. Trivially, (4) holds for $\xi = \eta$. For $\xi \neq \eta$, we obtain

$$\frac{d}{d\theta}|\theta\xi + (1-\theta)\eta|^p = p|\theta\xi + (1-\theta)\eta|^{p-2}\Re\left((\theta\xi + (1-\theta)\eta) \cdot \overline{(\xi-\eta)}\right)$$

and

$$\begin{split} \frac{d}{d\theta} |\theta\xi + (1-\theta)\eta|^{p-2} \Re\left((\theta\xi + (1-\theta)\eta) \cdot \bar{\eta}\right) \\ &= (p-2) |\theta\xi + (1-\theta)\eta|^{p-4} \left(\theta|\xi|^2 + (\theta-1)|\eta|^2 + (1-2\theta)\Re(\xi \cdot \bar{\eta})\right) \\ &\times \left(\theta\Re(\xi \cdot \bar{\eta}) + (1-\theta)|\eta|^2\right) \\ &+ |\theta\xi + (1-\theta)\eta|^{p-2} \Re\left((\xi-\eta) \cdot \bar{\eta}\right). \end{split}$$

By a direct calculation, we obtain

$$\begin{split} \left(\theta|\xi|^{2} + (\theta - 1)|\eta|^{2} + (1 - 2\theta)\Re(\xi \cdot \bar{\eta})\right) \left(\theta\Re(\xi \cdot \bar{\eta}) + (1 - \theta)|\eta|^{2}\right) \\ &= \theta^{2}|\xi|^{2}\Re(\xi \cdot \bar{\eta}) + (\theta - 1)\theta|\eta|^{2}\Re(\xi \cdot \bar{\eta}) + \theta(1 - 2\theta)\Re^{2}(\xi \cdot \bar{\eta}) \\ &+ \theta(1 - \theta)|\xi|^{2}|\eta|^{2} - (1 - \theta)^{2}|\eta|^{2}|\eta|^{2} + (1 - 2\theta)(1 - \theta)\Re(\xi \cdot \bar{\eta})|\eta|^{2} \\ &= |\theta\xi + (1 - \theta)\eta|^{2}\Re((\xi - \eta) \cdot \bar{\eta}) + \theta|\xi|^{2}|\eta|^{2} - \theta\Re^{2}(\xi \cdot \bar{\eta}). \end{split}$$

Since

$$[|\theta\xi + (1-\theta)\eta|^p]_{\theta=0}^1 = |\xi|^p - |\eta|^p$$

and

$$[|\theta\xi + (1-\theta)\eta|^{p-2}\Re((\theta\xi + (1-\theta)\eta) \cdot \bar{\eta})]_{\theta=0}^{1} = |\xi|^{p-2}\Re(\xi \cdot \bar{\eta}) - |\eta|^{p-2}\Re(\eta \cdot \bar{\eta}),$$

we obtain

$$\begin{split} &\frac{1}{p}|\eta|^p + \frac{1}{p'}|\xi|^p - |\xi|^{p-2}\Re(\xi\cdot\bar{\eta}) \\ &= \left(1 - \frac{1}{p}\right)\left(|\xi|^p - |\eta|^p\right) - \left(|\xi|^{p-2}\Re(\xi\cdot\bar{\eta}) - |\eta|^{p-2}\Re(\eta\cdot\bar{\eta})\right) \\ &= (p-1)\int_0^1 |\theta\xi + (1-\theta)\eta|^{p-2}\Re((\theta\xi + (1-\theta)\eta)\cdot\overline{(\xi-\eta)})d\theta \\ &- (p-1)\int_0^1 |\theta\xi + (1-\theta)\eta|^{p-2}\Re\left((\xi-\eta)\cdot\bar{\eta}\right)d\theta \\ &+ (p-2)\int_0^1 |\theta\xi + (1-\theta)\eta|^{p-2}(|\xi|^2|\eta|^2 - \Re^2(\xi\cdot\bar{\eta}))\theta d\theta \\ &= (p-1)\int_0^1 |\theta\xi + (1-\theta)\eta|^{p-2}|\xi-\eta|^2\theta d\theta \\ &+ (p-2)\int_0^1 |\theta\xi + (1-\theta)\eta|^{p-2}|\xi-\eta|^2\theta d\theta \\ &+ (p-2)\int_0^1 |\theta\xi + (1-\theta)\eta|^{p-2}(|\xi|^2|\eta|^2 - \Re^2(\xi\cdot\bar{\eta}))\theta d\theta, \end{split}$$

and if p > 2,

$$\frac{1}{p}|\eta|^p + \frac{1}{p'}|\xi|^p - |\xi|^{p-2}\Re(\xi \cdot \bar{\eta}) \ge (p-1)\int_0^1 |\theta\xi + (1-\theta)\eta|^{p-2}|\xi - \eta|^2\theta d\theta.$$

The above inequality becomes an equality when $\xi = \lambda \eta$ with $\lambda \in \mathbb{R}$.

This finishes the proof of Theorem 3.

Proof of Theorem 6. If 1 , taking <math>x = ky with $k \to -\infty$ in (6), we obtain $c_p = 0$. Suppose $p \ge 2$ now. From (5) and the reasoning in Remark 5, we conclude that the sharp constant c_p is attained only if x = ky with $k \in \mathbb{R}$. Thus we obtain

$$c_{p} = \inf_{x,y \in \mathbb{C}^{d}} \frac{C_{p}(x,y)}{|y|^{p}} = p(p-1) \inf_{x=ky} \int_{0}^{1} \left| \theta \frac{y}{|y|} - \frac{x}{|y|} \right|^{p-2} \theta d\theta$$

$$= p(p-1) \inf_{k \in \mathbb{R}} \int_{0}^{1} |\theta - k|^{p-2} \theta d\theta.$$
(6)

Recall that we can omit the discussion for $k \in \{0, 1\}$.

For the case 0 < k < 1, we obtain

$$p(p-1) \int_0^1 |\theta - k|^{p-2} \, \theta d\theta$$

$$= p(p-1) \int_0^k (k-\theta)^{p-2} \, \theta d\theta + p(p-1) \int_k^1 (\theta - k)^{p-2} \, \theta d\theta$$

$$= k^p + pk(1-k)^{p-1} + (p-1)(1-k)^p.$$

Introduce

$$f(x) := x^p + px(1-x)^{p-1} + (p-1)(1-x)^p$$

thus

$$f'(x) = p\left(x^{p-1} + (1-x)^{p-1} - (p-1)(1-x)^{p-2}\right).$$

Note that $f'(0) = p(2-p) \le 0$ and f'(1) = p > 0. Suppose $f'(x_0) = 0$ and $x_0 = \frac{r_0}{r_0+1}$ with $r_0 > 0$, then the equation $f'(x_0) = 0$ can be rewritten as

$$r_0^{p-1} - (p-1)r_0 - (p-2) = 0. (7)$$

Note that

$$(r^{p-1} - (p-1)r - (p-2))' = (p-1)(r^{p-2} - 1),$$

which alternates the sign passing r = 1. Moreover,

$$(r^{p-1} - (p-1)r - (p-2))|_{r=0} = -(p-2) \le 0$$

and

$$(r^{p-1} - (p-1)r - (p-2))|_{r=+\infty} = +\infty.$$

We then conclude that r_0 is unique for $f'(\frac{r_0}{r_0+1})=0$. For the case k>1, we obtain

$$p(p-1)\int_0^1 (k-\theta)^{p-2}\theta d\theta > p(p-1)\int_0^1 (1-\theta)^{p-2}\theta d\theta = 1 = f(1).$$

For the case k < 0, we obtain

$$p(p-1)\int_0^1 (\theta - k)^{p-2}\theta d\theta > p(p-1)\int_0^1 \theta^{p-1} d\theta = p - 1 = f(0).$$

Thus $c_p = f(x_0)$.

Now we check $f(x_0)$ is always positive. Suppose that $f(x_0) = 0$, we obtain

$$\left(\frac{r_0}{r_0+1}\right)^p + p\frac{r_0}{r_0+1} \left(\frac{1}{r_0+1}\right)^{p-1} + (p-1) \left(\frac{1}{r_0+1}\right)^p = 0.$$
(8)

Using (7), (8) can be rewritten as

$$(p-1)(r_0^2+2r_0+1)=0,$$

which is a contradiction to $r_0 > 0$. This proves Theorem 6.
