# GEOMETRIC REALIZATIONS OF RINGEL-HALL ALGEBRAS OF CONTINUOUS QUIVERS OF TYPE A

#### MINGHUI ZHAO

ABSTRACT. Lusztig introduced the geometric realizations of quantum groups associated to finite quivers and defined their canonical bases. Sala and Schiffmann introduced the Ringel-Hall algebra of line and realized it as the direct limit of Ringel-Hall algebras of finite quivers of type A. In this paper, we shall give geometric realizations of Ringel-Hall algebras of continuous quivers of type A via the geometric realizations of Lusztig by using the method of approximation given by Sala and Schiffmann.

## 1. Introduction

1.1. The Ringel-Hall algebra of the category of representations of a finite quiver  $Q = (Q_0, Q_1)$  was introduced by Ringel in [18]. The composition subalgebra of the Ringel-Hall algebra is isomorphic to the negative part  $U^-$  of the quantum group associated to the quiver Q ([18, 8, 26]).

Inspired by the work of Ringel, Lusztig gave a geometric realization of  $\mathbf{U}^-$  in [13, 14]. Fix a  $Q_0$ -graded vector space  $\mathbb{V} = \bigoplus_{x \in Q_0} \mathbb{V}_x$  with dimension vector  $\nu$  and denote by  $E_{\mathbb{V}}$  the variety consisting of representations of the quiver Q. There is a  $G_{\mathbb{V}} = \prod_{x \in Q_0} GL(\mathbb{V}_x)$  action on  $E_{\mathbb{V}}$ . Denote by  $\mathcal{D}^b_{G_{\mathbb{V}}}(E_{\mathbb{V}})$  the  $G_{\mathbb{V}}$ -equivariant bounded derived category of  $\overline{\mathbb{Q}}_l$ -constructible mixed complexes on  $E_{\mathbb{V}}$ . Let  $K(Q_{\mathbb{V}})$  be the Grothendieck group of an additive subcategory  $Q_{\mathbb{V}}$  of  $\mathcal{D}^b_{G_{\mathbb{V}}}(E_{\mathbb{V}})$ . Lusztig proved that  $\bigoplus_{\nu} K(Q_{\mathbb{V}})$  is isomorphic to the integral form of  $\mathbf{U}^-$ . By this isomorphism, the isomorphism classes of simple perverse sheaves in  $Q_{\mathbb{V}}$  provide a basis of the  $\mathbf{U}^-$  ([13, 14, 16]). Xiao, Xu and Zhao generalized the geometric construction to the generic form of the whole Ringel-Hall algebra in [27].

Lusztig also gave constructions of Ringel-Hall algebras via functions in [15]. Denoted by  $\mathcal{F}_{G_{\mathbb{V}}^F}(E_{\mathbb{V}}^F)$  the set of  $G_{\mathbb{V}}^F$ -invariant finitely supported  $\mathbb{C}$ -valued functions on  $E_{\mathbb{V}}^F$ , where  $G_{\mathbb{V}}^F$  and  $E_{\mathbb{V}}^F$  are closed points in  $G_{\mathbb{V}}$  and  $E_{\mathbb{V}}$  fixed by Frobenius morphisms. Let  $\mathcal{F}_Q = \bigoplus_{\nu} \mathcal{F}_{G_{\mathbb{V}}^F}(E_{\mathbb{V}}^F)$ . Lusztig showed that  $\mathcal{F}_Q$  is isomorphic to the Ringel-Hall algebra of Q. According to the sheaf-function correspondence ([12]), there is a homomorphism of algebras  $\chi^F: K_Q \to \mathcal{F}_Q$ .

1.2. Representation theory of continuous quivers of type A is important in persistent homology and widely used in topological data analysis ([17]). In [7, 5], Crawley-Boevey and Botnan gave a classification of indecomposable representations of  $\mathbb{R}$ . In [4], Botnan gave a classification of indecomposable representations of infinite zigzag. Igusa, Rock and Todorov introduced general continuous quivers of type A and classified indecomposable representations ([11, 19, 10, 20]). Hanson and Rock introduced continuous quivers of type  $\tilde{A}$  and gave a classification of indecomposable representations ([9]). Rock and Zhu studied Nakayama representations of this quiver in [21]. In [1, 2, 22, 23], Appel, Sala and Schiffmann introduced continuum quivers, continuum Kac-Moody algebras and continuum quantum groups associated to continuum quivers.

In [22, 23], Sala and Schiffmann showed that the continuum quantum group associated to the circle can be realized as the direct limit of a direct system of quantum groups of type  $\tilde{A}$ . This result also holds for quantum group of the line (a continuous quiver of type A). In [22, 23], Sala and Schiffmann introduced the Ringel-Hall algebras associated to the circle and the line. They also studied relations between Ringel-Hall algebras and continuum quantum groups.

1.3. In this paper, we shall give a geometric realization of the Ringel-Hall algebra of a continuous quiver of type A by using the method of approximation in [22, 23] and the geometric realizations of quantum groups of type A in [13, 14, 16].

Let  $A_{\mathbb{R}}$  be a continuous quiver of type A and  $\mathcal{I}$  a partition of  $\mathbb{R}$ . We define a finite quiver  $Q_{\mathcal{I}}$  of type A associated to  $A_{\mathbb{R}}$  and  $\mathcal{I}$ . Similarly to the method of approximation in [22, 23], we introduce a  $\mathbb{Z}[v, v^{-1}]$ -algebra  $K_{A_{\mathbb{R}}}$  as a direct limit of a direct system  $(K_{Q_{\mathcal{I}}}, \Phi_{\mathcal{I}_1, \mathcal{I}_2})$ . Let  $\mathcal{F}_{A_{\mathbb{R}}}$  be the Ringel-Hall algebra associated to  $A_{\mathbb{R}}$ . According to the sheaf-function correspondence, there is a homomorphism of  $\mathbb{Z}$ -algebras  $\chi_{A_{\mathbb{R}}}: K_{A_{\mathbb{R}}} \to \mathcal{F}_{A_{\mathbb{R}}}$ . The algebra  $K_{A_{\mathbb{R}}}$  can be viewed as a geometric version of  $\mathcal{F}_{A_{\mathbb{R}}}$ . In this paper, we also define a canonical basis of a completion  $K_{A_{\mathbb{R}}}$  of  $K_{A_{\mathbb{R}}}$ .

1.4. In Section 2, we shall recall the definitions of Ringel-Hall algerbas of finite quivers and their geometric realizations. In Section 3, the concepts of continuous quivers of type A and their representations are recalled. In this section, we also define a finite quiver  $Q_{\mathcal{I}}$  of type A associated to a continuous quivers  $A_{\mathbb{R}}$  and a partition  $\mathcal{I}$ . In Section 4, we recall the Ringel-Hall algebras  $\mathcal{F}_{A_{\mathbb{R}}}$  associated to a continuous quiver  $A_{\mathbb{R}}$  of type A. Then the geometric version  $K_{A_{\mathbb{R}}}$  of  $\mathcal{F}_{A_{\mathbb{R}}}$  is defined. The completion  $K_{A_{\mathbb{R}}}$  of  $K_{A_{\mathbb{R}}}$  and its canonical basis are defined in Section 5.

## 2. Ringel-Hall algebras and canonical bases

In this section, we shall recall the definitions of Ringel-Hall algerbas of finite quivers ([18, 24]) and their geometric realizations ([13, 14, 16, 25]).

**2.1.** A quiver  $Q = (Q_0, Q_1, s, t)$  is consisting of a set  $Q_0$  of vertices, a set  $Q_1$  of arrows and two maps  $s, t : Q_1 \to Q_0$  such that s(h) is the source of h and t(h) is the target of h for any  $h \in Q_1$ .

Let K be a fixed field. A representation V = (V(x), V(h)) of Q over K is consisting of a K-vector space V(x) for any  $x \in Q_0$  and a K-linear map  $V(h) : V(s(h)) \to V(t(h))$  for any  $h \in Q_1$ .

The collection of linear maps  $f_x: V(x) \to W(x)$  for all  $x \in Q_0$  is called a map from V to W, if  $f_{t(h)}V(h) = W(h)f_{s(h)}$  for all  $h \in Q_1$ .

Denote by  $\operatorname{Rep}_K(Q)$  the category of K-linear representations of Q and by  $\operatorname{rep}_K(Q)$  the subcategory of finitely dimensional representations.

A function  $\nu: Q_0 \to \mathbb{Z}_{\geq 0}$  is called the dimension vector of a representation V = (V(x), V(h)), if  $\dim V(x) = \nu(x)$  for all  $x \in Q_0$ . In this case, we denote  $\underline{\dim} V = \nu$ .

Fix a dimension vector  $\nu$  and a  $Q_0$ -graded K-vector space  $\mathbb{V} = \bigoplus_{x \in Q_0} \mathbb{V}_x$  such that  $\dim \mathbb{V}_x = \nu(x)$ . In this case, we also denote  $\underline{\dim} \mathbb{V} = \nu$ . Let

$$E_{\mathbb{V}} = E_{Q,\mathbb{V}} = \prod_{h \in Q_1} \operatorname{Hom}_K(\mathbb{V}_{s(h)}, \mathbb{V}_{t(h)}).$$

The group  $G_{\mathbb{V}} = \prod_{x \in Q_0} GL_K(\mathbb{V}_x)$  acts on  $E_{\mathbb{V}}$  by  $g.\phi = g\phi g^{-1}$  for any  $g \in G_{\mathbb{V}}$  and  $\phi \in E_{\mathbb{V}}$ .

**Proposition 2.1** ([6]). There is an one to one correspondence between the  $G_{\mathbb{V}}$ -orbits in  $E_{\mathbb{V}}$  and the isomorphism classes of finitely dimensional representations of Q.

For any representation V, let  $\mathcal{O}_V$  be the orbit corresponding to [V].

**2.2.** In this section, we follow the notations in [12, 3].

Let  $\mathbb{F}_q$  be a finite field with q elements and K the algebraic closure of  $\mathbb{F}_q$ . Let G be an algebraic group over K and X a scheme of finite type over K together with a G-action. Assume that X and G have  $\mathbb{F}_q$ -structures and let  $F_X: X \to X$  and  $F_G: G \to G$  be the Frobenius morphisms. Let  $G^F$  and  $X^F$  be the sets of closed points of G and X fixed by the Frobenius morphisms.

Denote by  $\mathcal{D}_{G}^{b}(X)$  the G-equivariant bounded derived category of  $\overline{\mathbb{Q}}_{l}$ -constructible mixed complexes on X. Let  $K_{G}(X)$  be the Grothendieck group of  $\mathcal{D}_{G}^{b}(X)$ . Denoted by  $\mathcal{F}_{G^{F}}(X^{F})$  the set of  $G^{F}$ -invariant finitely supported  $\mathbb{C}$ -valued functions on  $X^{F}$ . According to the sheaf-function correspondence ([12]), there is a map

$$\chi^F: K_G(X) \to \mathcal{F}_{G^F}(X^F)$$

sending  $\mathcal{L}$  to  $\chi_{\mathcal{L}}^F$ .

**2.3.** Let  $Q = (Q_0, Q_1)$  be a quiver. Fix a dimension vector  $\nu$  and a  $Q_0$ -graded K-vector space  $\mathbb{V}$  such that  $\underline{\dim} \mathbb{V} = \nu$ . Note that  $\mathbb{V}$ ,  $E_{\mathbb{V}}$  and  $G_{\mathbb{V}}$  have  $\mathbb{F}_q$ -structures. Let  $F_{\mathbb{V}} : \mathbb{V} \to \mathbb{V}$ ,  $F_{E_{\mathbb{V}}} : E_{\mathbb{V}} \to E_{\mathbb{V}}$  and  $F_{G_{\mathbb{V}}} : G_{\mathbb{V}} \to G_{\mathbb{V}}$  be the corresponding Frobenius morphisms. Let  $\mathbb{V}^F$ ,  $E_{\mathbb{V}}^F$  and  $G_{\mathbb{V}}^F$  be the sets of closed points of  $\mathbb{V}$ ,  $E_{\mathbb{V}}$  and  $G_{\mathbb{V}}$  fixed by the Frobenius morphisms, respectively.

For any  $\nu, \nu', \nu''$  such that  $\nu = \nu' + \nu''$ , fix  $Q_0$ -graded K-vector spaces  $\mathbb{V}$ ,  $\mathbb{V}'$ ,  $\mathbb{V}''$  with dimension vectors  $\nu, \nu', \nu''$ , respectively.

Consider the following diagram

$$(1) E_{\mathbb{V}'} \times E_{\mathbb{V}''} \stackrel{p_1}{\longleftrightarrow} E' \stackrel{p_2}{\longrightarrow} E'' \stackrel{p_3}{\longrightarrow} E_{\mathbb{V}} ,$$

where

- (1)  $E'' = \{(\phi, \mathbb{W})\}$ , where  $\phi \in E_{\mathbb{V}}$  and  $\mathbb{W}$  is a  $\phi$ -stable (i.e.  $\phi_h(\mathbb{W}_{s(h)}) \subset \mathbb{W}_{t(h)}$  for any  $h \in Q_1$ ) subspace of  $\mathbb{V}$  with dimension vector  $\nu''$ ;
- (2)  $E' = \{(\phi, \mathbb{W}, R'', R')\}$ , where  $(\phi, \mathbb{W}) \in E''$ ,  $R'' : \mathbb{V}'' \simeq \mathbb{W}$  and  $R' : \mathbb{V}' \simeq \mathbb{V}/\mathbb{W}$ ;
- (3)  $p_1(\phi, \mathbb{W}, R'', R') = (\phi', \phi'')$ , where  $\phi'$  and  $\phi''$  are induced by the following commutative diagrams

$$\begin{array}{ccc} \mathbb{V}'_{s(h)} & \xrightarrow{\phi'_h} & \mathbb{V}'_{t(h)} \\ & & \downarrow R'_{s(h)} & & \downarrow R'_{t(h)} \\ (\mathbb{V}/\mathbb{W})_{s(h)} & \xrightarrow{\phi_h} & (\mathbb{V}/\mathbb{W})_{t(h)} \end{array}$$

and

$$\mathbb{V}_{s(h)}'' \xrightarrow{\phi_h''} \mathbb{V}_{t(h)}''$$

$$\downarrow R_{s(h)}'' \qquad \downarrow R_{t(h)}''$$

$$\mathbb{W}_{s(h)} \xrightarrow{\phi_h} \mathbb{W}_{t(h)}$$

for all  $h \in Q_1$ ;

- (4)  $p_2(\phi, \mathbb{W}, R'', R') = (\phi, \mathbb{W});$
- (5)  $p_3(\phi, \mathbb{W}) = \phi$ .

The group  $G_{\mathbb{V}}$  acts on E'' by  $g.(\phi, \mathbb{W}) = (g\phi g^{-1}, g\mathbb{W})$  for any  $g \in G_{\mathbb{V}}$ . The groups  $G_{\mathbb{V}'} \times G_{\mathbb{V}''}$  and  $G_{\mathbb{V}}$  act on E' by  $(g_1, g_2).(\phi, \mathbb{W}, R'', R') = (\phi, \mathbb{W}, g_2 R'', g_1 R')$  and  $g.(\phi, \mathbb{W}, R'', R') = (g\phi g^{-1}, g\mathbb{W}, R''g^{-1}, R'g^{-1})$  for any  $(g_1, g_2) \in G_{\mathbb{V}'} \times G_{\mathbb{V}''}$  and  $g \in G_{\mathbb{V}}$ . The map  $p_1$  is  $G_{\mathbb{V}'} \times G_{\mathbb{V}''} \times G_{\mathbb{V}}$ -equivariant  $(G_{\mathbb{V}} \text{ acts on } E_{\mathbb{V}'} \times E_{\mathbb{V}''} \text{ trivially})$  and  $p_2$  is a principal  $G_{\mathbb{V}'} \times G_{\mathbb{V}''}$ -bundle.

Since  $p_2$  is a principal  $G_{\mathbb{V}'} \times G_{\mathbb{V}''}$ -bundle, there is an equivalence

$$p_2^*: \mathcal{D}^b_{G_{\mathbb{V}}}(E'') \to \mathcal{D}^b_{G_{\mathbb{V}} \times G_{\mathbb{V}'} \times G_{\mathbb{V}''}}(E').$$

The inverse of  $p_2^*$  is denoted by

$$p_{2\flat}: \mathcal{D}^b_{G_{\mathbb{V}}\times G_{\mathbb{V}'}\times G_{\mathbb{V}''}}(E') \to \mathcal{D}^b_{G_{\mathbb{V}}}(E'').$$

Then we can define the induction functor

$$*: \mathcal{D}^b_{G_{\mathbb{V}'}}(E_{\mathbb{V}'}) \times \mathcal{D}^b_{G_{\mathbb{V}''}}(E_{\mathbb{V}''}) \rightarrow \mathcal{D}^b_{G_{\mathbb{V}}}(E_{\mathbb{V}})$$

$$(\mathcal{L}', \mathcal{L}'') \mapsto \mathcal{L}' * \mathcal{L}'' = p_{31}p_{2b}p_1^*(\mathcal{L}' \boxtimes \mathcal{L}'').$$

Let

$$K_Q = \bigoplus_{\nu \in \mathbb{N}Q_0} K_{G_{\mathbb{V}}}(E_{\mathbb{V}}),$$

which is a  $\mathbb{Z}[v, v^{-1}]$ -module by  $v^{\pm 1}[\mathcal{L}] = [\mathcal{L}[\pm 1](\pm \frac{1}{2})]$ , where [n] is the shift functor and  $(\frac{n}{2})$  is the Tate twist.

**Proposition 2.2** ([13, 14, 16]). The induction functors for various  $\nu$ ,  $\nu'$ ,  $\nu''$  induce an associative multiplication structure

$$*: K_Q \times K_Q \to K_Q$$

sending  $(\mathcal{L}', \mathcal{L}'')$  to  $\mathcal{L}' * \mathcal{L}''$ .

**2.4.** Similarly to (1), consider the following diagram over  $\mathbb{F}_q$ 

$$E^F_{\mathbb{V}'}\times E^F_{\mathbb{V}''} \stackrel{p_1}{\longleftarrow} E'^F \stackrel{p_2}{\longrightarrow} E''^F \stackrel{p_3}{\longrightarrow} E^F_{\mathbb{V}} \ .$$

Since  $p_2$  is a principal  $G_{\mathbb{V}'}^F \times G_{\mathbb{V}''}^F$ -bundle, there is bijection

$$p_2^*: \mathcal{F}_{G_{\mathbb{V}}^F}(E''^F) \to \mathcal{F}_{G_{\mathbb{V}}^F \times G_{\mathbb{V}'}^F \times G_{\mathbb{V}''}^F}(E'^F).$$

At the same time,  $|p_3^{-1}(\phi)| < \infty$ . Then we can define the induction map

$$*: \mathcal{F}_{G_{\mathbb{V}'}^F}(E_{\mathbb{V}'}^F) \times \mathcal{F}_{G_{\mathbb{V}''}^F}(E_{\mathbb{V}''}^F) \to \mathcal{F}_{G_{\mathbb{V}}^F}(E_{\mathbb{V}}^F) (f', f'') \mapsto f' * f'' = p_{3!}(p_2^*)^{-1} p_1^*(f' \otimes f'').$$

Let

$$\mathcal{F}_Q = \bigoplus_{\nu \in \mathbb{N}Q_0} \mathcal{F}_{G_{\mathbb{V}}^F}(E_{\mathbb{V}}^F).$$

**Proposition 2.3** ([15]). The induction maps for various  $\nu$ ,  $\nu'$ ,  $\nu''$  induce an associative multiplication structure

$$*: \mathcal{F}_Q \times \mathcal{F}_Q o \mathcal{F}_Q$$

sending (f', f'') to f' \* f''.

**Proposition 2.4** ([25, 27]). The map  $\chi_Q^F: K_Q \to \mathcal{F}_Q$  is a homomorphism of  $\mathbb{Z}$ -algebras.

The embedding  $\mathbb{Z}[v,v^{-1}] \to \mathbb{C}$  sending v to  $\sqrt{q}$  induces a  $\mathbb{Z}[v,v^{-1}]$ -module structure on  $\mathbb{C}$ . The  $\mathbb{Z}$ -linear homomorphism  $\chi_Q^F$  induces an epimorphism of  $\mathbb{C}$ -algebras

$$\chi_Q^F: K_Q \otimes_{\mathbb{Z}[v,v^{-1}]} \mathbb{C} \to \mathcal{F}_Q.$$

**2.5.** Assume that Q is a quiver of finite type in this section. Let  $B_{\mathbb{V}}$  be the set of isomorphism classes  $[\mathcal{L}[n](\frac{n}{2})]$ , where  $\mathcal{L}$  is a simple perverse sheaf in  $\mathcal{D}_{G_{\mathbb{V}}}^{b}(E_{\mathbb{V}})$  and  $n \in \mathbb{Z}$ .

For any finitely dimensional representation V of Q, let  $\mathcal{O}_V$  be the orbit in  $E_{\mathbb{V}}$  corresponding to V and  $j_V : \mathcal{O}_V \to E_{\mathbb{V}}$  the natural embedding. Let

$$IC_{\mathcal{O}_V} = (j_V)_{!*} 1_{\mathcal{O}_V},$$

where  $1_{\mathcal{O}_V}$  is the constant sheaf on  $\mathcal{O}_V$ .

**Theorem 2.5** ([13, 14, 16]). For any  $Q_0$ -graded K-vector space  $\mathbb{V}$  such that  $\underline{\dim} \mathbb{V} = \nu$ , it holds that

$$B_{\mathbb{V}} = \{ [IC_{\mathcal{O}_{V}}[n](\frac{n}{2})] | \underline{\dim} V = \nu, n \in \mathbb{Z} \}$$

and the set  $B_{\mathbb{V}}$  is a  $\mathbb{Z}$ -basis of  $K_{G_{\mathbb{V}}}(E_{\mathbb{V}})$ .

Let

$$B_Q = \bigcup_{\nu \in \mathbb{N}Q_0} B_{\mathbb{V}},$$

which is a  $\mathbb{Z}$ -basis of  $K_Q$  and called the canonical basis of  $K_Q$ .

## 3. Continuous quivers of type A and their representations

In this section, we shall recall the definitions of continuous quivers of type A. We follow the notations in [11].

- **3.1.** A continuous quiver  $A_{\mathbb{R}} = (\mathbb{R}, \mathbf{S}, \prec)$  of type A is consisting of
  - (1) the set  $\mathbb{R}$  of real numbers;
  - (2) a discrete subset  $\mathbf{S} = \{S_i | i = I\}$  of  $\mathbb{R}$ , where the index set I is one of the following four sets

$$\{i \in \mathbb{Z} | m \leqslant i \leqslant n\}, \{i \in \mathbb{Z} | i \leqslant n\}, \{i \in \mathbb{Z} | i \geqslant m\} \text{ and } \mathbb{Z};$$

(3) a partial order  $\prec$  such that  $\prec = <$  or > in every intervals

$$[S_i, S_{i+1}], (-\infty, S_m] \text{ and } [S_n, +\infty).$$

A representation V = (V(x), V(x, y)) of  $A_{\mathbb{R}}$  over K is consisting of

- (1) a K-vector space V(x) for any  $x \in \mathbb{R}$ ;
- (2) a K-linear map  $V(x,y):V(x)\to V(y)$  for any  $x\preccurlyeq y$  such that

$$V(y,z)V(x,y) = V(x,z)$$

for any  $x \preccurlyeq y \preccurlyeq z$ .

The collection of linear maps  $f_x: V(x) \to W(x)$  for all  $x \in \mathbb{R}$  is called a map from V to W, if the following diagram is commutative

$$V(x) \xrightarrow{V(x,y)} V(y)$$

$$\downarrow^{f_x} \qquad \downarrow^{f_y}$$

$$W(x) \xrightarrow{W(x,y)} W(y).$$

Denote by  $\operatorname{Rep}_K(A_{\mathbb{R}})$  the category of K-linear representations of  $A_{\mathbb{R}}$ , and by  $\operatorname{Rep}_K^{pwf}(A_{\mathbb{R}})$  the subcategory of pointwise finitely dimensional representations. Denote by  $\operatorname{rep}_K(A_{\mathbb{R}})$  the subcategory of finitely generated representations of  $A_{\mathbb{R}}$  defined in [11]. The category  $\operatorname{rep}_K(A_{\mathbb{R}})$  is the category of tame representations of  $A_{\mathbb{R}}$  in [23].

Let  $\nu : \mathbb{R} \to \mathbb{Z}_{\geq 0}$  be a function and V = (V(x), V(x, y)) be a representation of  $A_{\mathbb{R}}$ . If dim  $V(x) = \nu(x)$ , then  $\nu$  is called the dimension function of V and we denote  $\underline{\dim} V = \nu$ .

**3.2.** Fix a dimension function  $\nu$  and a  $\mathbb{R}$ -graded K-vector space  $\mathbf{V} = \bigoplus_{x \in \mathbb{R}} \mathbf{V}_x$  such that dim  $\mathbf{V}_x = \nu(x)$ . In this case, we also denote  $\underline{\dim} \mathbf{V} = \nu$ . Let

$$\tilde{E}_{\mathbf{V}} = \tilde{E}_{A_{\mathbb{R}}, \mathbf{V}} = \prod_{x \preccurlyeq y} \operatorname{Hom}_{K}(\mathbf{V}_{x}, \mathbf{V}_{y})$$

and

$$E'_{\mathbf{V}} = E'_{A_{\mathbf{v}},\mathbf{V}} = \{ \phi = (\phi_{xy})_{x \preccurlyeq y} \in \tilde{E}_{\mathbf{V}} | \phi_{xz} = \phi_{yz}\phi_{xy} \}.$$

Let  $E_{\mathbf{V}} = E_{A_{\mathbb{R}},\mathbf{V}}$  be the subset of  $E'_{\mathbf{V}}$  consisting of  $\phi$  such that  $V = (\mathbf{V}, \phi)$  is a finitely generated representation in  $\operatorname{rep}_K(A_{\mathbb{R}})$ .

The group  $G_{\mathbf{V}} = \prod_{x \in \mathbb{R}} GL_K(\mathbf{V}_x)$  acts on  $\tilde{E}_{\mathbf{V}}$  by  $g.\phi = g\phi g^{-1}$  for any  $g \in G_{\mathbf{V}}$  and  $\phi \in \tilde{E}_{\mathbf{V}}$ . Note that  $G_{\mathbf{V}}(E'_{\mathbf{V}}) \subset E'_{\mathbf{V}}$  and  $G_{\mathbf{V}}(E_{\mathbf{V}}) \subset E_{\mathbf{V}}$ . Hence there are  $G_{\mathbf{V}}$ -actions on  $E'_{\mathbf{V}}$  and  $E_{\mathbf{V}}$ .

Similarly to Proposition 2.1, we have the following proposition.

**Proposition 3.1.** There is an one to one correspondence between the  $G_{\mathbf{V}}$ -orbits in  $E_{\mathbf{V}}$  and the isomorphism classes of finitely generated representations of  $A_{\mathbb{R}}$ .

For any finitely generated representation V of  $A_{\mathbb{R}}$ , let  $\mathcal{O}_V$  be the orbit in  $E_{\mathbf{V}}$  corresponding to V.

**3.3.** Let  $A_{\mathbb{R}} = (\mathbb{R}, \mathbf{S}, \prec)$  be a continuous quiver of type A. A sequence  $\mathcal{I} = (I_1, I_2, \dots, I_n)$  is called a partition of  $\mathbb{R}$ , if

- (1)  $I_1 = (-\infty, a_1|, I_i = |a_{i-1}, a_i| (1 < i < n), I_n = |a_{n-1}, +\infty)$  such that  $a_1 \le a_2 \le \cdots \le a_{n-1}$ , where the notation | is [, (, ] or );
- (2)  $\mathbb{R} = \bigcup_i I_i$  and  $I_i \cap I_{i+1} = \emptyset$   $(1 \leqslant i < n)$ .

For any partition  $\mathcal{I}$  of  $\mathbb{R}$ , let  $E_{\mathbf{V},\mathcal{I}}$  be the subset of  $E_{\mathbf{V}}$  consisting of  $\phi$  such that  $\phi_{xy}$  is an isomorphsim for any  $x \leq y$  in some  $I \in \mathcal{I}$ . In [11], it is proved that

$$E_{\mathbf{V}} = \bigcup_{\mathcal{I}} E_{\mathbf{V},\mathcal{I}}.$$

Denote by  $\tau_{\mathcal{I}}$  the embedding of  $E_{\mathbf{V},\mathcal{I}}$  in  $E_{\mathbf{V}}$ .

Fix  $\phi \in E_{\mathbf{V},\mathcal{I}}$ , let  $\phi_{yx} = \phi_{xy}^{-1}$  for  $x \prec y$  in some  $I \in \mathcal{I}$ . For any x < y in some  $I \in \mathcal{I}$ , there exist  $x_0 = x < x_1 < x_2 < \ldots < x_s = y$  such that  $x_i \prec x_{i+1}$  or  $x_{i+1} \prec x_i$ . Let

$$\phi_{xy} = \phi_{x_{s-1}x_s} \cdots \phi_{x_1x_2} \phi_{x_0x_1}$$

and  $\phi_{yx} = \phi_{xy}^{-1}$ .

Let  $\mathcal{I}_1$  and  $\mathcal{I}_2$  be two partitions of  $\mathbb{R}$ . The partition  $\mathcal{I}_2$  is called a refinement of  $\mathcal{I}_1$  if, for any  $I \in \mathcal{I}_2$ , there exists an interval  $J \in \mathcal{I}_1$  such that I is a subset of J.

Since  $E_{\mathbf{V},\mathcal{I}_1}$  is a subset of  $E_{\mathbf{V},\mathcal{I}_2}$ , there is a natural embedding

$$\tau_{\mathcal{I}_1,\mathcal{I}_2}: E_{\mathbf{V},\mathcal{I}_1} \to E_{\mathbf{V},\mathcal{I}_2}.$$

**3.4.** Let  $\mathcal{I} = (I_1, I_2, \dots, I_n)$  be a partition of  $\mathbb{R}$ . Denote by  $I_i \prec I_{i+1}$  in  $\mathcal{I}$ , if

- (1)  $a_i \prec a_i + \epsilon$ , when  $I_i = [a_{i-1}, a_i], I_{i+1} = (a_i, a_{i+1}],$
- (2)  $a_i \epsilon \prec a_i$ , when  $I_i = |a_{i-1}, a_i|$ ,  $I_{i+1} = [a_i, a_{i+1}]$ ,

and by  $I_{i+1} \prec I_i$  in  $\mathcal{I}$ , if

- (1)  $a_i + \epsilon \prec a_i$ , when  $I_i = [a_{i-1}, a_i], I_{i+1} = (a_i, a_{i+1}],$
- (2)  $a_i \prec a_i \epsilon$ , when  $I_i = |a_{i-1}, a_i|$ ,  $I_{i+1} = [a_i, a_{i+1}]$ ,

where  $\epsilon$  is a real number small enough.

Consider a finite quiver  $Q_{\mathcal{I}} = (Q_{\mathcal{I},0}, Q_{\mathcal{I},1})$  of type A associated to the continuous quiver  $A_{\mathbb{R}}$  and the partition  $\mathcal{I}$  of  $\mathbb{R}$ , where

- (1)  $Q_{\mathcal{I},0} = \{I_1, I_2, \dots, I_n\}$  is the set of vertices;
- (2)  $Q_{\mathcal{I},1} = \{h_1, h_2, \dots, h_{n-1}\}$ , where

$$h_i = \begin{cases} I_i \to I_{i+1}, & I_i \prec I_{i+1}; \\ I_i \leftarrow I_{i+1}, & I_{i+1} \prec I_i. \end{cases}$$

For any finite dimensional  $\mathbb{R}$ -graded K-vector space  $\mathbf{V} = \bigoplus_{x \in \mathbb{R}} \mathbf{V}_x$ , let  $\mathbf{V}_{\mathcal{I}}$  be the  $Q_{\mathcal{I},0}$ -graded K-vector space with  $(\mathbf{V}_{\mathcal{I}})_{I_i} = \mathbf{V}_{b_i}$ , where

$$b_i = \begin{cases} a_1 - 1, & i = 1; \\ \frac{a_i + a_{i-1}}{2}, & 1 < i < n; \\ a_{n-1} + 1, & i = n. \end{cases}$$

Define a map

$$\sigma_{\mathcal{I}}: E_{\mathbf{V},\mathcal{I}} \to E_{Q_{\mathcal{I}},\mathbf{V}_{\mathcal{I}}},$$

by

- (1)  $\sigma_{\mathcal{I}}(\phi)_{I_{i} \to I_{i+1}} = \phi_{a_{i} + \epsilon b_{i+1}} \phi_{a_{i} a_{i} + \epsilon} \phi_{b_{i} a_{i}}$ , when  $I_{i} = |a_{i-1}, a_{i}|$ ,  $I_{i+1} = (a_{i}, a_{i+1})$  and  $a_{i} \prec a_{i} + \epsilon$ ;
- (2)  $\sigma_{\mathcal{I}}(\phi)_{I_i \leftarrow I_{i+1}} = \phi_{a_i b_i} \phi_{a_i + \epsilon a_i} \phi_{b_{i+1} a_i + \epsilon}$ , when  $I_i = |a_{i-1}, a_i|$ ,  $I_{i+1} = (a_i, a_{i+1})$  and  $a_i + \epsilon \prec a_i$ ;
- (3)  $\sigma_{\mathcal{I}}(\phi)_{I_{i} \to I_{i+1}} = \phi_{a_{i}b_{i+1}}\phi_{a_{i}-\epsilon a_{i}}\phi_{b_{i}a_{i}-\epsilon}$ , when  $I_{i} = |a_{i-1}, a_{i}\rangle$ ,  $I_{i+1} = [a_{i}, a_{i+1}|$  and  $a_{i} \epsilon \prec a_{i}$ ;
- (4)  $\sigma_{\mathcal{I}}(\phi)_{I_{i} \leftarrow I_{i+1}} = \phi_{a_{i} \epsilon b_{i}} \phi_{a_{i} a_{i} \epsilon} \phi_{b_{i+1} a_{i}}$ , when  $I_{i} = |a_{i-1}, a_{i}|$ ,  $I_{i+1} = [a_{i}, a_{i+1}]$  and  $a_{i} \prec a_{i} \epsilon$ .

**Proposition 3.2.** The map  $\sigma_{\mathcal{I}}$  induces an one to one correspondence between the  $G_{\mathbf{V}}$ -orbits in  $E_{\mathbf{V},\mathcal{I}}$  and the  $G_{\mathbf{V}_{\mathcal{I}}}$ -orbits in  $E_{Q_{\mathcal{I}},\mathbf{V}_{\mathcal{I}}}$ .

*Proof.* Let  $\phi_1, \phi_2 \in E_{\mathbf{V},\mathcal{I}}$ . Since  $(\mathbf{V}, \phi_1) \cong (\mathbf{V}, \phi_2)$  if and only if  $(\mathbf{V}_{\mathcal{I}}, \sigma_{\mathcal{I}}(\phi_1)) \cong (\mathbf{V}_{\mathcal{I}}, \sigma_{\mathcal{I}}(\phi_2))$ , we get the desired result.

## 4. Geometric realization of Ringel-Hall algebra of $A_{\mathbb{R}}$

**4.1.** In this section, we shall recall the definitions of Ringel-Hall algebras of  $A_{\mathbb{R}}$  introduced in [22, 23].

Let  $A_{\mathbb{R}}$  be a continuous quiver. Fix a dimension function  $\nu$  and a  $\mathbb{R}$ -graded  $\mathbb{F}_q$ -vector space  $\mathbf{V}$  such that  $\underline{\dim} \mathbf{V} = \nu$ . Denote by

$$\mathcal{F}_{G_{\mathbf{V}}}(E_{\mathbf{V}})$$

the set of  $G_{\mathbf{V}}$ -invariant finitely supported  $\mathbb{C}$ -valued functions on  $E_{\mathbf{V}}$ . Let

$$\mathcal{F}_{A_{\mathbb{R}}} = \bigoplus_{\mathcal{V}} \mathcal{F}_{G_{\mathbf{V}}}(E_{\mathbf{V}}).$$

For dimension functions  $\nu, \nu', \nu''$  such that  $\nu = \nu' + \nu''$ , fix  $\mathbb{R}$ -graded  $\mathbb{F}_q$ -vector spaces  $\mathbf{V}, \mathbf{V}', \mathbf{V}''$  with  $\underline{\dim} \mathbf{V} = \nu$ ,  $\underline{\dim} \mathbf{V}' = \nu'$  and  $\underline{\dim} \mathbf{V}'' = \nu''$ .

Consider the following diagram

$$\tilde{E}_{\mathbf{V}'} \times \tilde{E}_{\mathbf{V}''} \stackrel{q_1}{\longleftarrow} \tilde{E}' \stackrel{q_2}{\longrightarrow} \tilde{E}'' \stackrel{q_3}{\longrightarrow} \tilde{E}_{\mathbf{V}}$$

where

- (1)  $\tilde{E}'' = \{(\phi, \mathbf{W})\}$ , where  $\phi \in \tilde{E}_{\mathbf{V}}$  and  $\mathbf{W}$  is a  $\phi$ -stable subspace of  $\mathbf{V}$  with dimension function  $\nu''$ ;
- (2)  $\tilde{E}' = \{(\phi, \mathbf{W}, R'', R')\}$ , where  $(\phi, \mathbf{W}) \in \tilde{E}''$ ,  $R'' : \mathbf{V}'' \simeq \mathbf{W}$  and  $R' : \mathbf{V}' \simeq \mathbf{V}/\mathbf{W}$ ;
- (3)  $q_1(\phi, \mathbf{W}, R'', R') = (\phi', \phi'')$ , where  $\phi' = (\phi'_{xy})$  and  $\phi'' = (\phi''_{xy})$  are induced by the following commutative diagrams

$$\mathbf{V}_{x}' \xrightarrow{\phi_{xy}'} \mathbf{V}_{y}' \\
\downarrow^{R_{x}'} \qquad \downarrow^{R_{y}'} \\
(\mathbf{V}/\mathbf{W})_{x} \xrightarrow{\phi_{xy}} (\mathbf{V}/\mathbf{W})_{y}$$

and

$$\mathbf{V}_{x}^{"} \xrightarrow{\phi_{xy}^{"}} \mathbf{V}_{y}^{"}$$

$$\downarrow R_{x}^{"} \qquad \downarrow R_{y}^{"}$$

$$\mathbf{W}_{x} \xrightarrow{\phi_{xy}} \mathbf{W}_{y}$$

for all  $x \prec y$ ;

- (4)  $q_2(\phi, \mathbf{W}, R'', R') = (\phi, \mathbf{W});$
- (5)  $q_3(\phi, \mathbf{W}) = \phi$ .

The group  $G_{\mathbf{V}}$  acts on  $\tilde{E}''$  by  $g.(\phi, \mathbf{W}) = (g\phi g^{-1}, g\mathbf{W})$  for any  $g \in G_{\mathbf{V}}$ . The groups  $G_{\mathbf{V}'} \times G_{\mathbf{V}''}$  and  $G_{\mathbf{V}}$  act on  $\tilde{E}'$  by  $(g_1, g_2).(\phi, \mathbf{W}, R'', R') = (\phi, \mathbf{W}, g_2 R'', g_1 R')$  and  $g.(\phi, \mathbf{W}, R'', R') = (g\phi g^{-1}, g\mathbf{W}, R''g^{-1}, R'g^{-1})$  for any  $(g_1, g_2) \in G_{\mathbf{V}'} \times G_{\mathbf{V}''}$  and  $g \in G_{\mathbf{V}}$ .

Since  $\phi \in E_{\mathbf{V}}$  implies that  $\phi' \in E_{\mathbf{V}'}$  and  $\phi'' \in E_{\mathbf{V}''}$ , we have the following diagram

$$E_{\mathbf{V}'} \times E_{\mathbf{V}''} \stackrel{q_1}{\longleftrightarrow} E' \stackrel{q_2}{\longrightarrow} E'' \stackrel{q_3}{\longrightarrow} E_{\mathbf{V}}$$

where

- (1)  $E'' = \{(\phi, \mathbf{W}) \in \tilde{E}'' | \phi \in E_{\mathbf{V}} \};$
- (2)  $E' = \{(\phi, \mathbf{W}, R'', R') \in \tilde{E}' | (\phi, \mathbf{W}) \in E'' \};$
- (3) the restrictions of  $q_1$  and  $q_2$  on E' are still denoted by  $q_1$  and  $q_2$ , respectively;
- (4) the restriction of  $q_3$  on E'' is still denoted by  $q_3$ .

Since  $G_{\mathbf{V}}(E'') = E''$ , there is a  $G_{\mathbf{V}}$ -action on E''. Similarly, there are  $G_{\mathbf{V}'} \times G_{\mathbf{V}''}$  and  $G_{\mathbf{V}}$ -actions on E'. The map  $g_1$  induces a map

$$q_1^*: \mathcal{F}_{G_{\mathbf{V}'} \times G_{\mathbf{V}''}}(E_{\mathbf{V}'} \times E_{\mathbf{V}''}) \to \mathcal{F}_{G_{\mathbf{V}} \times G_{\mathbf{V}'} \times G_{\mathbf{V}''}}(E').$$

Since the map  $q_2$  is a principal  $G_{\mathbf{V}'} \times G_{\mathbf{V}''}$ -bundle, it induces a bijection

$$q_2^*: \mathcal{F}_{G_{\mathbf{V}}}(E'') \to \mathcal{F}_{G_{\mathbf{V}} \times G_{\mathbf{V}'} \times G_{\mathbf{V}''}}(E').$$

Since  $p_3^{-1}(\phi)$  is a finite set for any  $\phi \in E_{\mathbf{V}}$ , it induces a map

$$p_{3!}: \mathcal{F}_{G_{\mathbf{V}}}(E'') \to \mathcal{F}_{G_{\mathbf{V}}}(E_{\mathbf{V}}).$$

Then we can define the induction map

$$*: \mathcal{F}_{G_{\mathbf{V}'}}(E_{\mathbf{V}'}) \times \mathcal{F}_{G_{\mathbf{V}''}}(E_{\mathbf{V}''}) \rightarrow \mathcal{F}_{G_{\mathbf{V}}}(E_{\mathbf{V}})$$
$$(f', f'') \mapsto f' * f'' = p_{3!}(p_2^*)^{-1} p_1^* (f' \otimes f'').$$

**Proposition 4.1** ([22, 23]). The induction maps for various dimension functions  $\nu$ ,  $\nu'$ ,  $\nu''$  induce an associative multiplication structure

$$*:\mathcal{F}_{A_{\mathbb{R}}} imes\mathcal{F}_{A_{\mathbb{R}}} o\mathcal{F}_{A_{\mathbb{R}}}$$

sending (f', f'') to f' \* f''.

The  $\mathbb{C}$ -algebra  $(\mathcal{F}_{A_{\mathbb{R}}}, *)$  is called the Ringel-Hall algebra of  $A_{\mathbb{R}}$ . For any partition  $\mathcal{I}$  of  $\mathbb{R}$ , let

$$\mathcal{F}_{G_{\mathbf{V}}}(E_{\mathbf{V},\mathcal{I}})$$

be the set of  $G_{\mathbf{V}}$ -invariant finitely supported  $\mathbb{C}$ -valued functions on  $E_{\mathbf{V},\mathcal{I}}$  and

$$\mathcal{F}_{A_{\mathbb{R},\mathcal{I}}} = \bigoplus_{\nu} \mathcal{F}_{G_{\mathbf{V}}}(E_{\mathbf{V},\mathcal{I}}).$$

**Lemma 4.2.** The subset  $\mathcal{F}_{A_{\mathbb{R},\mathcal{I}}}$  is a subalgebra of  $\mathcal{F}_{A_{\mathbb{R}}}$ .

Proof. Note that  $p_1(\phi, \mathbf{W}, R'', R') = (\phi', \phi'')$  and  $(\phi', \phi'') \in E_{\mathbf{V}', \mathcal{I}} \times E_{\mathbf{V}'', \mathcal{I}}$  implies that  $\phi \in E_{\mathbf{V}, \mathcal{I}}$ . Hence, for any  $f \in \mathcal{F}_{G_{\mathbf{V}'}}(E_{\mathbf{V}', \mathcal{I}})$  and  $g \in \mathcal{F}_{G_{\mathbf{V}''}}(E_{\mathbf{V}'', \mathcal{I}})$ , we have  $f * g \in \mathcal{F}_{G_{\mathbf{V}}}(E_{\mathbf{V}, \mathcal{I}})$ .

Let  $\mathcal{I}_1$  and  $\mathcal{I}_2$  be two partitions of  $\mathbb{R}$  such that  $\mathcal{I}_2$  is a refinement of  $\mathcal{I}_1$ . The embedding

$$\tau_{\mathcal{I}_1,\mathcal{I}_2}: E_{\mathbf{V},\mathcal{I}_1} \to E_{\mathbf{V},\mathcal{I}_2}$$

induces a map

$$(\tau_{\mathcal{I}_1,\mathcal{I}_2})_!: \mathcal{F}_{G_{\mathbf{V}}}(E_{\mathbf{V},\mathcal{I}_1}) \to \mathcal{F}_{G_{\mathbf{V}}}(E_{\mathbf{V},\mathcal{I}_2}).$$

**Corollary 4.3.** The algebra  $\mathcal{F}_{A_{\mathbb{R},\mathcal{I}_1}}$  is a subalgebra of  $\mathcal{F}_{A_{\mathbb{R},\mathcal{I}_2}}$  and  $(\tau_{\mathcal{I}_1,\mathcal{I}_2})_!$  is an embedding of algebras.

**4.2.** Let  $Q_{\mathcal{I}} = (Q_{\mathcal{I},0}, Q_{\mathcal{I},1})$  be the finite quiver associated to the continuous quiver  $A_{\mathbb{R}}$  and a partition  $\mathcal{I}$  and  $\mathbf{V}_{\mathcal{I}}$  be the  $Q_{\mathcal{I},0}$ -graded vector space induced by  $\mathbf{V}$ . The map

$$\sigma_{\mathcal{I}}: E_{\mathbf{V},\mathcal{I}} \to E_{Q_{\mathcal{I}},\mathbf{V}_{\mathcal{I}}}$$

induces a map

$$\sigma_{\mathcal{I}}^*: \mathcal{F}_{G_{\mathbf{V}_{\mathcal{I}}}}(E_{Q_{\mathcal{I}},\mathbf{V}_{\mathcal{I}}}) \to \mathcal{F}_{G_{\mathbf{V}}}(E_{\mathbf{V},\mathcal{I}}).$$

**Lemma 4.4.** The map  $\sigma_{\mathcal{I}}^*$  is an isomorphism of algebras.

*Proof.* Consider the following commutative diagram

$$E_{\mathbf{V}',\mathcal{I}} \times E_{\mathbf{V}'',\mathcal{I}} \stackrel{q_{1}}{\longleftarrow} E'_{1} \stackrel{q_{2}}{\longrightarrow} E''_{1} \stackrel{q_{3}}{\longrightarrow} E_{\mathbf{V},\mathcal{I}}$$

$$\downarrow^{\sigma_{\mathcal{I}} \times \sigma_{\mathcal{I}}} \qquad \downarrow^{\gamma_{1}} \qquad \downarrow^{\delta_{1}} \qquad \downarrow^{id}$$

$$E_{\mathbf{V}'_{\mathcal{I}}} \times E_{\mathbf{V}''_{\mathcal{I}}} \stackrel{\alpha_{1}}{\longleftarrow} X \stackrel{\alpha_{2}}{\longrightarrow} Y \stackrel{\alpha_{3}}{\longrightarrow} E_{\mathbf{V},\mathcal{I}}$$

$$\downarrow^{id \times id} \qquad \downarrow^{\gamma_{2}} \qquad \downarrow^{\delta_{2}} \qquad \downarrow^{\sigma_{\mathcal{I}}}$$

$$E_{\mathbf{V}'_{\mathcal{I}}} \times E_{\mathbf{V}''_{\mathcal{I}}} \stackrel{p_{1}}{\longleftarrow} E'_{2} \stackrel{p_{2}}{\longrightarrow} E''_{2} \stackrel{p_{3}}{\longrightarrow} E_{\mathbf{V}_{\mathcal{I}}}.$$

Here,

- (1)  $E_1'' = \{(\phi, \mathbf{W})\}$ , where  $\phi \in E_{\mathbf{V},\mathcal{I}}$  and  $\mathbf{W}$  is a  $\phi$ -stable subspace of  $\mathbf{V}$  with dimension function  $\nu''$ ;
- (2)  $E_1' = \{(\phi, \mathbf{W}, R'', R')\}$ , where  $(\phi, \mathbf{W}) \in E_1''$ ,  $R'' : \mathbf{V}'' \simeq \mathbf{W}$  and  $R' : \mathbf{V}' \simeq \mathbf{V}/\mathbf{W}$ ;
- (3)  $E_2'' = \{(\phi, \mathbb{W})\}$ , where  $\phi \in E_{\mathbf{V}_{\mathcal{I}}}$  and  $\mathbb{W}$  is a  $\phi$ -stable subspace of  $\mathbf{V}_{\mathcal{I}}$  with dimension vector  $\nu_{\mathcal{I}}''$ ;
- (4)  $E_2' = \{(\phi, \mathbb{W}, R'', R')\}$ , where  $(\phi, \mathbb{W}) \in E_1''$ ,  $R'' : \mathbf{V}_{\mathcal{I}}'' \simeq \mathbb{W}$  and  $R' : \mathbf{V}_{\mathcal{I}}' \simeq \mathbf{V}_{\mathcal{I}}/\mathbb{W}$ ;
- (5)  $Y = \{(\phi, \mathbb{W})\}$ , where  $\phi \in E_{\mathbf{V},\mathcal{I}}$  and  $\mathbb{W}$  is an  $\sigma_{\mathcal{I}}(\phi)$ -stable subspace of  $\mathbf{V}_{\mathcal{I}}$  with dimension function  $\nu_{\mathcal{I}}''$ ;
- (6)  $X = \{(\phi, \mathbb{W}, R'', R')\}$ , where  $(\phi, \mathbb{W}) \in Y$ ,  $R'' : \mathbf{V}''_{\mathcal{I}} \simeq \mathbb{W}$  and  $R' : \mathbf{V}'_{\mathcal{I}} \simeq \mathbf{V}_{\mathcal{I}}/\mathbb{W}$ ;
- (7)  $\delta_1(\phi, \mathbf{W}) = (\phi, \mathbf{W}_{\mathcal{I}})$ , which is a bijection;
- (8)  $\gamma_1(\phi, \mathbf{W}, R'', R') = (\phi, \mathbf{W}_{\mathcal{I}}, R''_{\mathcal{I}}, R'_{\mathcal{I}})$ , where  $R''_{\mathcal{I}} : \mathbf{V}''_{\mathcal{I}} \simeq \mathbf{W}_{\mathcal{I}}$  and  $R'_{\mathcal{I}} : \mathbf{V}'_{\mathcal{I}} \simeq \mathbf{V}_{\mathcal{I}}/\mathbf{W}_{\mathcal{I}}$  are indeced by R'' and R';
- $(9) \ \delta_2(\phi, \mathbb{W}) = (\sigma_{\mathcal{I}}(\phi), \mathbb{W});$

(10)  $\gamma_2(\phi, \mathbb{W}, R'', R') = (\sigma_{\mathcal{I}}(\phi), \mathbb{W}, R'', R');$ 

- (11)  $\alpha_1 = p_1 \gamma_2$ ;
- (12)  $\alpha_2(\phi, \mathbb{W}, R'', R') = (\phi, \mathbb{W});$
- (13)  $\alpha_3(\phi, \mathbb{W}) = \phi$ .

Now, for any  $f \in \mathcal{F}_{G_{\mathbf{V}'_{\mathcal{I}}}}(E_{\mathbf{V}'_{\mathcal{I}}})$  and  $g \in \mathcal{F}_{G_{\mathbf{V}''_{\mathcal{I}}}}(E_{\mathbf{V}''_{\mathcal{I}}})$ , let  $A = \sigma_{\mathcal{I}}^*(f * g)$ . By definition, we have

$$A = \sigma_{\mathcal{I}}^* p_{3!} (p_2^*)^{-1} p_1^* (f \otimes g).$$

Since the commutative diagram

$$Y \xrightarrow{\alpha_3} E_{\mathbf{V},\mathcal{I}}$$

$$\downarrow^{\delta_2} \qquad \downarrow^{\sigma_{\mathcal{I}}}$$

$$E_2'' \xrightarrow{p_3} E_{\mathbf{V}_{\mathcal{I}}}$$

is a fiber product, we have

$$A = \alpha_{3!} \delta_2^* (p_2^*)^{-1} p_1^* (f \otimes g).$$

Then,

$$A = \alpha_{3!}(\alpha_2^*)^{-1} \gamma_2^* p_1^*(f \otimes g) = \alpha_{3!}(\alpha_2^*)^{-1} \alpha_1^*(f \otimes g).$$

Since  $\delta_1$  is a bijection, we have  $\delta_1^* = (\delta_{1!})^{-1}$  and

$$A = q_{3!} \delta_1^* (\alpha_2^*)^{-1} \alpha_1^* (f \otimes g).$$

Then,

$$A = q_{3!}(q_2^*)^{-1}\gamma_1^*\alpha_1^*(f \otimes g) = q_{3!}(q_2^*)^{-1}q_1^*(\sigma_{\mathcal{I}}^*(f) \otimes \sigma_{\mathcal{I}}^*(g)) = \sigma_{\mathcal{I}}^*(f) * \sigma_{\mathcal{I}}^*(g).$$

Hence, the map  $\sigma_{\mathcal{I}}^*$  is an isomorphism of algebras.

Let  $\mathbb{V}_{\mathcal{I}}$  be a  $Q_{\mathcal{I},0}$ -graded K-vector space such that  $\mathbb{V}_{\mathcal{I}}^F = \mathbf{V}_{\mathcal{I}}$ . Then, we have  $E_{\mathbb{V}_{\mathcal{I}}}^F = E_{\mathbf{V}_{\mathcal{I}}}$  and  $G_{\mathbb{V}_{\mathcal{I}}}^F = G_{\mathbf{V}_{\mathcal{I}}}$ . Consider the trace map

$$\chi_{\mathcal{I}}: K^b_{G_{\mathbb{V}_{\mathcal{I}}}}(E_{\mathbb{V}_{\mathcal{I}}}) \to \mathcal{F}_{G_{\mathbf{V}_{\mathcal{I}}}}(E_{\mathbf{V}_{\mathcal{I}}}) \to \mathcal{F}_{G_{\mathbf{V}}}(E_{\mathbf{V},\mathcal{I}}) \to \mathcal{F}_{G_{\mathbf{V}}}(E_{\mathbf{V}})$$

sending  $[\mathcal{L}]$  to  $\sigma_{\mathcal{I}}^*(\chi_{\mathcal{L}}^F)$ .

Proposition 4.5. Considering all dimension vectors, the map

$$\chi_{\mathcal{I}}:K_{Q_{\mathcal{I}}}\to\mathcal{F}_{A_{\mathbb{R}}}$$

is a homomorphism of  $\mathbb{Z}$ -algebras.

*Proof.* This result is direct by Lemma 4.4 and 4.2.

The homomorphism  $\chi_{\mathcal{I}}$  of  $\mathbb{Z}$ -algebras induces a homomorphism of  $\mathbb{C}$ -algebras

$$\chi_{\mathcal{I}}^{\mathbb{C}}: K_{Q_{\mathcal{I}}} \otimes_{\mathbb{Z}[v,v^{-1}]} \mathbb{C} \to \mathcal{F}_{A_{\mathbb{R}}}.$$

**4.3.** Let  $\mathcal{I}_1$  and  $\mathcal{I}_2$  be two partitions of  $\mathbb{R}$  such that the partition  $\mathcal{I}_2$  is a refinement of  $\mathcal{I}_1$ . Assume that

$$\mathcal{I}_1 = (I_1, I_2, \dots, I_n)$$

and

$$\mathcal{I}_2 = (I_{11}, I_{12}, \dots, I_{1s_1}, \dots, I_{n1}, I_{n2}, \dots, I_{ns_n})$$

such that  $I_i = \bigcup_{j=1}^{n_i} I_{ij}$ .

Let  $\hat{E}$  be the subset of  $E_{\mathbb{V}_{\mathcal{I}_2}}$  consisting of  $\phi$  such that  $\phi_{h_{ij}}$  are isomorphisms for all  $1 \leq j < n_i$ . For any  $\phi \in \hat{E}$  and  $1 \leq j < n_i$ , let  $\phi_{ij} = \phi_{h_{ij}}$  if  $I_{ij} \prec I_{ij+1}$  and  $\phi_{ij} = \phi_{h_{ij}}^{-1}$  if  $I_{ij+1} \prec I_{ij}$ .

Consider the following correspondence

$$(2) E_{\mathbb{V}_{\mathcal{I}_1}} \stackrel{r_1}{\longleftarrow} \hat{E} \stackrel{r_2}{\longrightarrow} E_{\mathbb{V}_{\mathcal{I}_2}} ,$$

where

$$r_1(\phi)_{h_i} = \begin{cases} \phi_{h_{in_i}} \phi_{in_i-1} \dots \phi_{i1}, & s(h_i) = I_i; \\ \phi_{i1}^{-1} \dots \phi_{in_i-1}^{-1} \phi_{h_{in_i}}, & s(h_i) = I_{i+1}; \end{cases}$$

for any  $\phi \in \hat{E}$  and  $r_2$  is the natural embedding.

The group  $G_{\mathbb{V}_{\mathcal{I}_2}}$  acts on  $\hat{E}$ . Note that  $G_{\mathbb{V}_{\mathcal{I}_2}} = G_{\mathbb{V}_{\mathcal{I}_1}} \times G_{\mathbb{V}_{\mathcal{I}_2 - \mathcal{I}_1}}$ , where

$$G_{\mathbb{V}_{\mathcal{I}_2 - \mathcal{I}_1}} = \prod_{i=1}^n \prod_{j=2}^{n_i} GL_K((\mathbb{V}_{\mathcal{I}_2})_{I_{ij}}).$$

The map  $r_1$  is a principal  $G_{\mathbb{V}_{\mathcal{I}_2-\mathcal{I}_1}}$ -bundle. Hence, there is an equivalence

$$r_1^*: \mathcal{D}^b_{G_{\mathbb{V}_{\mathcal{I}_1}}}(E_{\mathbb{V}_{\mathcal{I}_1}}) \to \mathcal{D}^b_{G_{\mathbb{V}_{\mathcal{I}_0}}}(\hat{E}).$$

The map  $r_2$  is  $G_{\mathbb{V}_{\mathcal{I}_2}}$ -equivariant, which induces a functor

$$r_{2!}: \mathcal{D}^b_{G_{\mathbb{V}_{\mathcal{I}_2}}}(\hat{E}) \to \mathcal{D}^b_{G_{\mathbb{V}_{\mathcal{I}_2}}}(E_{\mathbb{V}_{\mathcal{I}_2}}).$$

Then we can define a functor


$$\Phi_{\mathcal{I}_1,\mathcal{I}_2} = r_{2!}r_1^* : \mathcal{D}^b_{G_{\mathbb{V}_{\mathcal{I}_1}}}(E_{\mathbb{V}_{\mathcal{I}_1}}) \to \mathcal{D}^b_{G_{\mathbb{V}_{\mathcal{I}_2}}}(E_{\mathbb{V}_{\mathcal{I}_2}}).$$

Consider all dimension vectors, we get a map

$$\Phi_{\mathcal{I}_1,\mathcal{I}_2}: K_{Q_{\mathcal{I}_1}} \to K_{Q_{\mathcal{I}_2}}.$$

**Lemma 4.6.** For any partitions  $\mathcal{I}_1$  and  $\mathcal{I}_2$  of  $\mathbb{R}$  such that  $\mathcal{I}_2$  is a refinement of  $\mathcal{I}_1$ , the map  $\Phi_{\mathcal{I}_1,\mathcal{I}_2}: K_{Q_{\mathcal{I}_1}} \to K_{Q_{\mathcal{I}_2}}$  is a homomorphism of  $\mathbb{Z}[v,v^{-1}]$ -algebras.

*Proof.* Consider the following commutative diagram



Here,

- (1)  $E_1'' = \{(\phi, \mathbb{W})\}$ , where  $\phi \in E_{\mathbb{V}_{\mathcal{I}_1}}$  and  $\mathbb{W}$  is a  $\phi$ -stable subspace of  $\mathbb{V}_{\mathcal{I}_1}$  with dimension vector  $\nu_{\mathcal{I}_1}''$ ;
- (2)  $E_1' = \{(\phi, \mathbb{W}, R'', \tilde{R'})\}$ , where  $(\phi, \mathbb{W}) \in E_1''$ ,  $R'' : \mathbb{V}_{\mathcal{I}_1}'' \simeq \mathbb{W}$  and  $R' : \mathbb{V}_{\mathcal{I}_1}' \simeq \mathbb{W}$

$$\alpha_1 = p_1 \gamma_1;$$

(19) 
$$\alpha_2(\phi, \mathbb{W}, R'', R') = (\phi, \mathbb{W});$$

$$(20) \ \alpha_3(\phi, \mathbb{W}) = \phi.$$

(21) 
$$\beta_1 = p_1|_{X_2};$$

(22) 
$$\beta_2(\phi, \mathbb{W}, R'', R') = (\phi, \mathbb{W});$$

Now, for any 
$$\mathcal{L}_1 \in \mathcal{D}^b_{G_{\mathbb{V}'_{\mathcal{I}_1}}}(E_{\mathbb{V}'_{\mathcal{I}_1}})$$
 and  $\mathcal{L}_2 \in \mathcal{D}^b_{G_{\mathbb{V}''_{\mathcal{I}_1}}}(E_{\mathbb{V}''_{\mathcal{I}_1}})$ , let

$$A = \Phi_{\mathcal{I}_1, \mathcal{I}_2}(\mathcal{L}_1 * \mathcal{L}_2).$$

By definition, we have

$$A \cong r_{2!}r_1^*p_{3!}p_{2b}p_1^*(\mathcal{L}_1 \boxtimes \mathcal{L}_2).$$

Since the commutative diagram

$$Y_{1} \xrightarrow{\alpha_{3}} \hat{E}$$

$$\downarrow^{\delta_{1}} \qquad \downarrow^{r_{1}}$$

$$E_{1}^{"} \xrightarrow{p_{3}} E_{\mathbb{V}_{\mathcal{I}_{1}}}$$

is a fiber product, we have

$$A \cong r_{21}\alpha_{31}\delta_1^*p_{2h}p_1^*(\mathcal{L}_1 \boxtimes \mathcal{L}_2).$$

Since  $\delta_2$  is an isomorphism and  $\beta_3 = \alpha_3 \delta_2$ , we have

$$A \cong r_{2!}\beta_{3!}\delta_2^*\delta_1^*p_{2\flat}p_1^*(\mathcal{L}_1 \boxtimes \mathcal{L}_2).$$

Then we have

$$A \cong p_{3!}\delta_{3!}\delta_{2}^{*}\delta_{1}^{*}p_{2\flat}p_{1}^{*}(\mathcal{L}_{1}\boxtimes\mathcal{L}_{2})$$

$$\cong p_{3!}\delta_{3!}\delta_{2}^{*}\alpha_{2\flat}\gamma_{1}^{*}p_{1}^{*}(\mathcal{L}_{1}\boxtimes\mathcal{L}_{2})$$

$$\cong p_{3!}\delta_{3!}\beta_{2\flat}\gamma_{2}^{*}\gamma_{1}^{*}p_{1}^{*}(\mathcal{L}_{1}\boxtimes\mathcal{L}_{2})$$

$$\cong p_{3!}\delta_{2\flat}\gamma_{3!}\gamma_{2}^{*}\gamma_{1}^{*}p_{1}^{*}(\mathcal{L}_{1}\boxtimes\mathcal{L}_{2})$$

$$\cong p_{3!}p_{2\flat}\gamma_{3!}\gamma_{2}^{*}\alpha_{1}^{*}(\mathcal{L}_{1}\boxtimes\mathcal{L}_{2})$$

$$\downarrow^{\gamma_{3}} \qquad \downarrow^{r_{2} \times r_{2}}$$

$$E'_{2} \xrightarrow{p_{1}} E_{\mathbb{V}'_{\mathcal{I}_{2}}} \times E_{\mathbb{V}''_{\mathcal{I}_{2}}}$$

is a fiber product, we have

$$A \cong p_{3!}p_{2\flat}p_{1}^{*}(r_{2!}r_{1}^{*}(\mathcal{L}_{1}) \boxtimes r_{2!}r_{1}^{*}(\mathcal{L}_{2}))$$

$$\cong p_{3!}p_{2\flat}p_{1}^{*}(\Phi_{\mathcal{I}_{1},\mathcal{I}_{2}}(\mathcal{L}_{1}) \boxtimes \Phi_{\mathcal{I}_{1},\mathcal{I}_{2}}(\mathcal{L}_{2}))$$

$$\cong \Phi_{\mathcal{I}_{1},\mathcal{I}_{2}}(\mathcal{L}_{1}) * \Phi_{\mathcal{I}_{1},\mathcal{I}_{2}}(\mathcal{L}_{2}).$$

Hence, the map  $\Phi_{\mathcal{I}_1,\mathcal{I}_2}$  is a homomorphism of algebras.

Note that

$$\Phi_{\mathcal{I}_2,\mathcal{I}_3}\Phi_{\mathcal{I}_1,\mathcal{I}_2}=\Phi_{\mathcal{I}_1,\mathcal{I}_3}$$

for partitions  $\mathcal{I}_1$ ,  $\mathcal{I}_2$  and  $\mathcal{I}_3$  of  $\mathbb{R}$  such that  $\mathcal{I}_2$  is a refinement of  $\mathcal{I}_1$  and  $\mathcal{I}_3$  is a refinement of  $\mathcal{I}_2$ . Hence,

$$(K_{Q_{\mathcal{I}}},\Phi_{\mathcal{I}_1,\mathcal{I}_2})$$

is a direct system. Let

$$(K_{A_{\mathbb{D}}},\Phi_{\mathcal{I}})$$

be the direct limit of this direct system, where  $K_{A_{\mathbb{R}}}$  is an  $\mathbb{Z}[v,v^{-1}]$ -algebra and

$$\Phi_{\mathcal{I}}: K_{Q_{\mathcal{T}}} \to K_{A_{\mathbb{R}}}$$

is homomorphism of algebras.

Similarly, consider the following correspondence over  $\mathbb{F}_q$

$$E_{\mathbf{V}_{\mathcal{I}_1}} \stackrel{r_1}{\longleftarrow} \hat{E} \stackrel{r_2}{\longrightarrow} E_{\mathbf{V}_{\mathcal{I}_2}} ,$$

$$\Phi^{F}_{\mathcal{I}_{1},\mathcal{I}_{2}} = r_{2!}r_{1}^{*}: \mathcal{F}_{G_{\mathbf{V}_{\mathcal{I}_{1}}}}(E_{\mathbf{V}_{\mathcal{I}_{1}}}) \to \mathcal{F}_{G_{\mathbf{V}_{\mathcal{I}_{2}}}}(E_{\mathbf{V}_{\mathcal{I}_{2}}}).$$

Consider all dimension vectors, we get a map

$$\Phi^F_{\mathcal{I}_1,\mathcal{I}_2}:\mathcal{F}_{Q_{\mathcal{I}_1}}\to\mathcal{F}_{Q_{\mathcal{I}_2}}.$$

**Lemma 4.7.** For any partitions  $\mathcal{I}_1$  and  $\mathcal{I}_2$  of  $\mathbb{R}$  such that  $\mathcal{I}_2$  is a refinement of  $\mathcal{I}_1$ , the map  $\Phi^F_{\mathcal{I}_1,\mathcal{I}_2}$  is a homomorphism of algebras such that the following diagram is commutative

$$K_{Q_{\mathcal{I}_1}} \xrightarrow{\Phi_{\mathcal{I}_1,\mathcal{I}_2}} K_{Q_{\mathcal{I}_2}}$$

$$\chi_{Q_{\mathcal{I}_1}}^F \bigvee_{\Phi_{\mathcal{I}_1,\mathcal{I}_2}} \chi_{Q_{\mathcal{I}_2}}^F$$

$$\mathcal{F}_{Q_{\mathcal{I}_1}} \xrightarrow{\Phi_{\mathcal{I}_1,\mathcal{I}_2}} \mathcal{F}_{Q_{\mathcal{I}_2}}.$$

*Proof.* Similarly to the proof of Lemma 4.6, we can show that  $\Phi_{\mathcal{I}_1,\mathcal{I}_2}^F$  is a homomorphism of algebras. By the properties of sheaf-function correspondence ([12]), we get this commutative diagram.

On the relations between  $\Phi_{\mathcal{I}_1,\mathcal{I}_2}^F$  and  $(\tau_{\mathcal{I}_1,\mathcal{I}_2})_!$ , we have the following lemma.

**Lemma 4.8.** For any partitions  $\mathcal{I}_1$  and  $\mathcal{I}_2$  of  $\mathbb{R}$  such that  $\mathcal{I}_2$  is a refinement of  $\mathcal{I}_1$ , we have the following commutative diagram

Proof. Let  $V = (\mathbf{V}, \phi)$  be a representation of  $A_{\mathbb{R}}$  such that  $\phi \in E_{\mathbf{V},\mathcal{I}_1}$ . Let  $V_1 = (\mathbf{V}_{\mathcal{I}_1}, \sigma_{\mathcal{I}_1}(\phi))$  and  $V_2 = (\mathbf{V}_{\mathcal{I}_2}, \sigma_{\mathcal{I}_2}(\phi))$ . Let  $V_3 = (\mathbf{V}_{\mathcal{I}_2}, \psi)$  be a representation of  $Q_{\mathcal{I}_2}$  such that  $r_1(\psi) = \sigma_{\mathcal{I}_1}(\phi)$ .

Then, we have

$$(\sigma_{\mathcal{I}_2}^*)^{-1}(\tau_{\mathcal{I}_1,\mathcal{I}_2})_!(1_{\mathcal{O}_V}) = (\sigma_{\mathcal{I}_2}^*)^{-1}(1_{\mathcal{O}_V}) = 1_{\mathcal{O}_{V_2}}$$

and

$$\Phi^F_{\mathcal{I}_1,\mathcal{I}_2}(\sigma^*_{\mathcal{I}_1})^{-1}(1_{\mathcal{O}_V}) = \Phi^F_{\mathcal{I}_1,\mathcal{I}_2}(1_{\mathcal{O}_{V_1}}) = 1_{\mathcal{O}_{V_3}}.$$

Since  $V_2 \cong V_3$ , we have  $1_{\mathcal{O}_{V_2}} = 1_{\mathcal{O}_{V_3}}$  and

$$\Phi^F_{\mathcal{I}_1,\mathcal{I}_2}(\sigma^*_{\mathcal{I}_1})^{-1}(1_{\mathcal{O}_V}) = (\sigma^*_{\mathcal{I}_2})^{-1}(\tau_{\mathcal{I}_1,\mathcal{I}_2})_!(1_{\mathcal{O}_V}).$$


Hence, we have

$$\Phi_{\mathcal{I}_1,\mathcal{I}_2}^F(\sigma_{\mathcal{I}_1}^*)^{-1} = (\sigma_{\mathcal{I}_2}^*)^{-1}(\tau_{\mathcal{I}_1,\mathcal{I}_2})_!$$

and

$$\sigma_{\mathcal{I}_2}^*\Phi_{\mathcal{I}_1,\mathcal{I}_2}^F=(\tau_{\mathcal{I}_1,\mathcal{I}_2})_!\sigma_{\mathcal{I}_1}^*.$$

**Proposition 4.9.** For any partitions  $\mathcal{I}_1$  and  $\mathcal{I}_2$  of  $\mathbb{R}$  such that  $\mathcal{I}_2$  is a refinement of  $\mathcal{I}_1$ , we have the following commutative diagram



*Proof.* By Corollary 4.3, Lemmas 4.7 and 4.8, we get the desired commutative diagram.

**Theorem 4.10.** There is a homomorphism of  $\mathbb{Z}$ -algebras

$$\chi_{A_{\mathbb{R}}}:K_{A_{\mathbb{R}}}\to\mathcal{F}_{A_{\mathbb{R}}}.$$

*Proof.* Since  $K_{A_{\mathbb{R}}}$  is the direct limit of  $(K_{Q_{\mathcal{I}}}, \Phi_{\mathcal{I}_1, \mathcal{I}_2})$ , there is a homomorphism of  $\mathbb{Z}$ -algebras

$$\chi_{A_{\mathbb{R}}}:K_{A_{\mathbb{R}}}\to\mathcal{F}_{A_{\mathbb{R}}}$$

by Proposition 4.9.

The homomorphism  $\chi_{A_{\mathbb{R}}}$  of  $\mathbb{Z}$ -algebras induces a homomorphism of  $\mathbb{C}$ -algebras

$$\chi_{A_{\mathbb{R}}}^{\mathbb{C}}: K_{A_{\mathbb{R}}} \otimes_{\mathbb{Z}[v,v^{-1}]} \mathbb{C} \to \mathcal{F}_{A_{\mathbb{R}}}.$$

**Proposition 4.11.** The homomorphism  $\chi_{A_{\mathbb{D}}}^{\mathbb{C}}$  is an epimorphism of  $\mathbb{C}$ -algebras.

*Proof.* For any  $f \in \mathcal{F}_{A_{\mathbb{R}}}$ , we have  $f = c_1 1_{\mathcal{Q}_{V_1}} + c_2 1_{\mathcal{Q}_{V_2}} + \cdots + c_s 1_{\mathcal{Q}_{V_s}}$  with finitely generated representations  $V_i$  and real numbers  $c_i$  ( $1 \leqslant i \leqslant s$ ). For any  $1 \leqslant i \leqslant s$ , there is a partition  $\mathcal{I}_i$  of  $\mathbb{R}$  such that  $1_{\mathcal{Q}_{V_i}} \in \operatorname{Im}(\chi_{\mathcal{I}_i})$ . Then, we can construct a partition  $\mathcal{I}$  of  $\mathbb{R}$  such than  $\mathcal{I}$  is a refinement of all  $\mathcal{I}_i$ . Hence,  $1_{\mathcal{Q}_{V_i}} \in \operatorname{Im}(\chi_{\mathcal{I}})$  and  $f \in \operatorname{Im}(\chi_{\mathcal{I}}^{\mathbb{C}})$ . By the constructions of  $K_{A_{\mathbb{R}}}$  and  $\chi_{A_{\mathbb{R}}}^{\mathbb{C}}$ , we have  $f \in \operatorname{Im}(\chi_{A_{\mathbb{R}}}^{\mathbb{C}})$ . Hence, the  $\mathbb{C}$ -linear homomorphism  $\chi_{A_{\mathbb{R}}}^{\mathbb{C}}$  is an epimorphism.

The algebra  $K_{A_{\mathbb{R}}}$  is called the geometric version of Ringel-Hall algebra  $\mathcal{F}_{A_{\mathbb{R}}}$  of  $A_{\mathbb{R}}$ .

## **5.** Canonical basis for a completion of $K_{A_{\mathbb{R}}}$

**5.1.** Let  $A_{\mathbb{R}}$  be a continuous quiver. Fix a dimension function  $\nu$  and a  $\mathbb{R}$ -graded  $\mathbb{F}_q$ vector space V such that  $\underline{\dim} \mathbf{V} = \nu$ . Denote by  $\bar{\mathcal{F}}_{G_{\mathbf{V}}}(E_{\mathbf{V}})$  the set of  $G_{\mathbf{V}}$ -invariant  $\mathbb{C}$ -valued functions on  $E_{\mathbf{V}}$ . Let

$$\bar{\mathcal{F}}_{A_{\mathbb{R}}} = \bigoplus_{\nu} \bar{\mathcal{F}}_{G_{\mathbf{V}}}(E_{\mathbf{V}}).$$

Then  $\mathcal{F}_{A_{\mathbb{R}}}$  is a subspace of  $\bar{\mathcal{F}}_{A_{\mathbb{R}}}$  and the embedding is denoted by

$$\theta_{A_{\mathbb{R}}}:\mathcal{F}_{A_{\mathbb{R}}}\to \bar{\mathcal{F}}_{A_{\mathbb{R}}}.$$

Let  $\mathcal{I}_1$  and  $\mathcal{I}_2$  be two partitions of  $\mathbb{R}$  such that the partition  $\mathcal{I}_2$  is a refinement of  $\mathcal{I}_1$ . The embedding

$$\tau_{\mathcal{I}_1,\mathcal{I}_2}: E_{\mathbf{V},\mathcal{I}_1} \to E_{\mathbf{V},\mathcal{I}_2}$$

induces a linear map

$$\tau_{\mathcal{I}_1,\mathcal{I}_2}^*: \mathcal{F}_{G_{\mathbf{V}}}(E_{\mathbf{V},\mathcal{I}_2}) \to \mathcal{F}_{G_{\mathbf{V}}}(E_{\mathbf{V},\mathcal{I}_1}).$$

Note that

$$\tau_{\mathcal{I}_1,\mathcal{I}_2}^*\tau_{\mathcal{I}_2,\mathcal{I}_3}^* = \tau_{\mathcal{I}_1,\mathcal{I}_3}^*$$

for partitions  $\mathcal{I}_1$ ,  $\mathcal{I}_2$  and  $\mathcal{I}_3$  of  $\mathbb{R}$  such that  $\mathcal{I}_2$  is a refinement of  $\mathcal{I}_1$  and  $\mathcal{I}_3$  is a refinement of  $\mathcal{I}_2$ . Hence

$$(\mathcal{F}_{G_{\mathbf{V}}}(E_{\mathbf{V},\mathcal{I}}), \tau_{\mathcal{I}_1,\mathcal{I}_2}^*)$$

is an inverse system.

**Proposition 5.1.** It holds that  $(\bar{\mathcal{F}}_{G_{\mathbf{V}}}(E_{\mathbf{V}}), \tau_{\mathcal{T}}^*)$  is the inverse limit of the inverse system  $(\mathcal{F}_{G_{\mathbf{V}}}(E_{\mathbf{V},\mathcal{I}}), \tau_{\mathcal{I}_1,\mathcal{I}_2}^*)$ .

*Proof.* This result is obvious by definitions.

**5.2.** Let  $\mathcal{I}_1$  and  $\mathcal{I}_2$  be two partitions of  $\mathbb{R}$  such that the partition  $\mathcal{I}_2$  is a refinement of  $\mathcal{I}_1$ .

By the following correspondence (2) in Section 4.3

$$E_{\mathbb{V}_{\mathcal{I}_1}} \stackrel{r_1}{\longleftarrow} \hat{E} \stackrel{r_2}{\longrightarrow} E_{\mathbb{V}_{\mathcal{I}_2}}$$

there is a functor

$$\Psi_{\mathcal{I}_1,\mathcal{I}_2} = r_{1\flat}r_2^*: \mathcal{D}^b_{G_{\mathbb{V}_{\mathcal{I}_2}}}(E_{\mathbb{V}_{\mathcal{I}_2}}) \to \mathcal{D}^b_{G_{\mathbb{V}_{\mathcal{I}_1}}}(E_{\mathbb{V}_{\mathcal{I}_1}}),$$

where  $r_{1\flat}$  is the inverse of  $r_1^*$ . Consider all dimension vectors, we get a homomorphism of  $\mathbb{Z}[v, v^{-1}]$ -modules

$$\Psi_{\mathcal{I}_1,\mathcal{I}_2}:K_{Q_{\mathcal{I}_2}}\to K_{Q_{\mathcal{I}_1}}.$$

Note that  $\Psi_{\mathcal{I}_1,\mathcal{I}_2}\Phi_{\mathcal{I}_1,\mathcal{I}_2}=id$ .

Note that

$$\Psi_{\mathcal{I}_1,\mathcal{I}_2}\Psi_{\mathcal{I}_2,\mathcal{I}_3}=\Psi_{\mathcal{I}_1,\mathcal{I}_3}$$

for partitions  $\mathcal{I}_1$ ,  $\mathcal{I}_2$  and  $\mathcal{I}_3$  of  $\mathbb{R}$  such that  $\mathcal{I}_2$  is a refinement of  $\mathcal{I}_1$  and  $\mathcal{I}_3$  is a refinement of  $\mathcal{I}_2$ . Hence,

$$(K_{Q_{\mathcal{I}}}, \Psi_{\mathcal{I}_1, \mathcal{I}_2})$$

is an inverse system. Let

$$(\bar{K}_{A_{\mathbb{R}}},\Psi_{\mathcal{I}})$$

be the inverse limit of this inverse system, where  $\bar{K}_{A_{\mathbb{R}}}$  is a  $\mathbb{Z}[v, v^{-1}]$ -module and  $\Psi_{\mathcal{I}}: \bar{K}_{A_{\mathbb{R}}} \to K_{Q_{\mathcal{I}}}$  is a homomorphsim.

Similarly, by the following correspondence (3) over  $\mathbb{F}_q$  in Section 4.3

$$E_{\mathbf{V}_{\mathcal{I}_1}} \stackrel{r_1}{\longleftarrow} \hat{E} \stackrel{r_2}{\longrightarrow} E_{\mathbf{V}_{\mathcal{I}_2}}$$
,

we have a linear map

$$\Psi^{F}_{\mathcal{I}_{1},\mathcal{I}_{2}} = (r_{1}^{*})^{-1}r_{2}^{*}: \mathcal{F}_{G_{\mathbf{V}_{\mathcal{I}_{2}}}}(E_{\mathbf{V}_{\mathcal{I}_{2}}}) \to \mathcal{F}_{G_{\mathbf{V}_{\mathcal{I}_{1}}}}(E_{\mathbf{V}_{\mathcal{I}_{1}}}).$$

Consider all dimension vectors, we get a linear map

$$\Psi^F_{\mathcal{I}_1,\mathcal{I}_2}:\mathcal{F}_{Q_{\mathcal{I}_2}}\to\mathcal{F}_{Q_{\mathcal{I}_1}}.$$

**Lemma 5.2.** For any partitions  $\mathcal{I}_1$  and  $\mathcal{I}_2$  of  $\mathbb{R}$  such that  $\mathcal{I}_2$  is a refinement of  $\mathcal{I}_1$ , the following diagram is commutative

$$K_{Q_{\mathcal{I}_2}} \xrightarrow{\Psi_{\mathcal{I}_1,\mathcal{I}_2}} K_{Q_{\mathcal{I}_1}}$$

$$\chi_{Q_{\mathcal{I}_2}}^F \bigvee_{\Psi_{\mathcal{I}_1,\mathcal{I}_2}} \chi_{Q_{\mathcal{I}_1}}^F$$

$$\mathcal{F}_{Q_{\mathcal{I}_2}} \xrightarrow{\Psi_{\mathcal{I}_1,\mathcal{I}_2}} \mathcal{F}_{Q_{\mathcal{I}_1}}.$$

*Proof.* By the properties of sheaf-function correspondence ([12]), we can get this commutative diagram.

On the relations between  $\Psi^F_{\mathcal{I}_1,\mathcal{I}_2}$  and  $\tau^*_{\mathcal{I}_1,\mathcal{I}_2}$ , we have the following lemma.

**Lemma 5.3.** For any partitions  $\mathcal{I}_1$  and  $\mathcal{I}_2$  of  $\mathbb{R}$  such that  $\mathcal{I}_2$  is a refinement of  $\mathcal{I}_1$ , we have the following commutative diagram

$$\begin{split} \mathcal{F}_{Q_{\mathcal{I}_2}} & \xrightarrow{\Psi^F_{\mathcal{I}_1,\mathcal{I}_2}} \mathcal{F}_{Q_{\mathcal{I}_1}} \\ \downarrow^{\sigma^*_{\mathcal{I}_2}} & \bigvee^{\sigma^*_{\mathcal{I}_1}} \mathcal{F}_{\mathcal{A}_{\mathbb{R}},\mathcal{I}_2} \\ \mathcal{F}_{A_{\mathbb{R}},\mathcal{I}_2} & \xrightarrow{\tau^*_{\mathcal{I}_1,\mathcal{I}_2}} \mathcal{F}_{A_{\mathbb{R}},\mathcal{I}_1}. \end{split}$$

*Proof.* Let  $V = (\mathbf{V}, \phi)$  be a representation of  $A_{\mathbb{R}}$  such that  $\phi \in E_{\mathbf{V}, \mathcal{I}_2}$ . If  $\phi \notin E_{\mathbf{V}, \mathcal{I}_1}$ , then

$$\tau_{\mathcal{I}_1,\mathcal{I}_2}^*(1_{\mathcal{O}_V}) = 0$$

and

$$\Psi_{\mathcal{I}_1,\mathcal{I}_2}^F(\sigma_{\mathcal{I}_2}^*)^{-1}(1_{\mathcal{O}_V}) = 0.$$

Hence,

$$\Psi^F_{\mathcal{I}_1,\mathcal{I}_2}(\sigma^*_{\mathcal{I}_2})^{-1}(1_{\mathcal{O}_V}) = (\sigma^*_{\mathcal{I}_1})^{-1}\tau^*_{\mathcal{I}_1,\mathcal{I}_2}(1_{\mathcal{O}_V}).$$

Assume that  $\phi \in E_{\mathbf{V},\mathcal{I}_1}$ . Let  $V_1 = (\mathbf{V}_{\mathcal{I}_1}, \sigma_{\mathcal{I}_1}(\phi))$  and  $V_2 = (\mathbf{V}_{\mathcal{I}_2}, \sigma_{\mathcal{I}_2}(\phi))$ . Note that  $\sigma_{\mathcal{I}_2}(\phi) \in \hat{E}$  and let  $V_3 = (\mathbf{V}_{\mathcal{I}_1}, r_1\sigma_{\mathcal{I}_2}(\phi))$ . Then, we have

$$(\sigma_{\mathcal{I}_1}^*)^{-1}\tau_{\mathcal{I}_1,\mathcal{I}_2}^*(1_{\mathcal{O}_V}) = (\sigma_{\mathcal{I}_1}^*)^{-1}(1_{\mathcal{O}_V}) = 1_{\mathcal{O}_{V_1}}$$

and

$$\Psi^F_{\mathcal{I}_1,\mathcal{I}_2}(\sigma^*_{\mathcal{I}_2})^{-1}(1_{\mathcal{O}_V}) = \Psi^F_{\mathcal{I}_1,\mathcal{I}_2}(1_{\mathcal{O}_{V_2}}) = 1_{\mathcal{O}_{V_3}}.$$

Since  $V_1 \cong V_3$ , we have  $1_{\mathcal{O}_{V_1}} = 1_{\mathcal{O}_{V_3}}$  and

$$\Psi^F_{\mathcal{I}_1,\mathcal{I}_2}(\sigma^*_{\mathcal{I}_2})^{-1}(1_{\mathcal{O}_V}) = (\sigma^*_{\mathcal{I}_1})^{-1}\tau^*_{\mathcal{I}_1,\mathcal{I}_2}(1_{\mathcal{O}_V}).$$

Hence, we have

$$\Psi^{F}_{\mathcal{I}_{1},\mathcal{I}_{2}}(\sigma^{*}_{\mathcal{I}_{2}})^{-1} = (\sigma^{*}_{\mathcal{I}_{1}})^{-1}\tau^{*}_{\mathcal{I}_{1},\mathcal{I}_{2}}$$

and

$$\sigma_{\mathcal{I}_1}^* \Psi_{\mathcal{I}_1, \mathcal{I}_2}^F = \tau_{\mathcal{I}_1, \mathcal{I}_2}^* \sigma_{\mathcal{I}_2}^*.$$

**Proposition 5.4.** For any partitions  $\mathcal{I}_1$  and  $\mathcal{I}_2$  of  $\mathbb{R}$  such that  $\mathcal{I}_2$  is a refinement of  $\mathcal{I}_1$ , we have the following commutative diagram

$$K_{Q_{\mathcal{I}_2}} \xrightarrow{\Psi_{\mathcal{I}_1,\mathcal{I}_2}} K_{Q_{\mathcal{I}_1}}$$

$$\chi_{\mathcal{I}_2} \downarrow \qquad \qquad \downarrow \chi_{\mathcal{I}_1}$$

$$\mathcal{F}_{Q_{\mathcal{I}_2}} \xrightarrow{\tau_{\mathcal{I}_1,\mathcal{I}_2}^*} \mathcal{F}_{Q_{\mathcal{I}_1}}.$$

*Proof.* This result is implied by Lemmas 5.2 and 5.3.

**Theorem 5.5.** There is a  $\mathbb{Z}$ -linear map

$$\bar{\chi}_{A_{\mathbb{R}}}: \bar{K}_{A_{\mathbb{R}}} \to \bar{\mathcal{F}}_{A_{\mathbb{R}}}$$

such that the following diagram is commutative

*Proof.* By Proposition 5.1,  $(\bar{\mathcal{F}}_{A_{\mathbb{R}}}, (\sigma_{\mathcal{I}}^*)^{-1}\tau_{\mathcal{I}}^*)$  is the inverse limit of  $(\mathcal{F}_{Q_{\mathcal{I}}}, \Psi_{\mathcal{I}_1, \mathcal{I}_2}^F)$ . At the same time,  $(\bar{K}_{A_{\mathbb{R}}}, \Psi_{\mathcal{I}})$  is the inverse limit of  $(K_{Q_{\mathcal{I}}}, \Psi_{\mathcal{I}_1, \mathcal{I}_2})$ . By Proposition 5.4, there is a  $\mathbb{Z}$ -linear map

$$\bar{\chi}_{A_{\mathbb{R}}}: \bar{K}_{A_{\mathbb{R}}} \to \bar{\mathcal{F}}_{A_{\mathbb{R}}}$$

such that the diagram (4) is commutative.

Since  $\chi_{Q_{\mathcal{I}}}^F: K_{Q_{\mathcal{I}}} \otimes_{\mathbb{Z}[v,v^{-1}]} \mathbb{C} \to \mathcal{F}_{Q_{\mathcal{I}}}$  is surjective for all  $\mathcal{I}$ , the  $\mathbb{Z}$ -linear map  $\bar{\chi}_{A_{\mathbb{R}}}$  induces a surjective  $\mathbb{C}$ -linear map

$$\bar{\chi}_{A_{\mathbb{R}}}^{\mathbb{C}}: \bar{K}_{A_{\mathbb{R}}} \otimes_{\mathbb{Z}[v,v^{-1}]} \mathbb{C} \to \bar{\mathcal{F}}_{A_{\mathbb{R}}}.$$

**5.3.** For any  $A \in K_{A_{\mathbb{R}}}$  and a partition  $\mathcal{I}$ , there exists  $\mathcal{I}_1$  such that  $A \in \text{Im}(\Phi_{\mathcal{I}_1})$  and  $\mathcal{I}_1$  is a refinement of  $\mathcal{I}$ . Let  $A = \Phi_{\mathcal{I}_1}(A_1)$  and define

$$\Theta_{\mathcal{I}}(A) = \Psi_{\mathcal{I},\mathcal{I}_1}(A_1).$$

Let  $\mathcal{I}_2$  be another partition such that  $A \in \operatorname{Im}(\Phi_{\mathcal{I}_2})$  and  $\mathcal{I}_2$  is a refinement of  $\mathcal{I}$ . Assume that  $A = \Phi_{\mathcal{I}_1}(A_2)$ . Let  $\mathcal{I}_3$  be a partition such that  $\mathcal{I}_3$  is a refinement of  $\mathcal{I}_1$  and  $\mathcal{I}_2$ . Then,  $\Phi_{\mathcal{I}_1,\mathcal{I}_3}(A_1) = \Phi_{\mathcal{I}_2,\mathcal{I}_3}(A_2)$ . Since

$$\Psi_{\mathcal{I},\mathcal{I}_2}(A_2) = \Psi_{\mathcal{I},\mathcal{I}_2} \Psi_{\mathcal{I}_2,\mathcal{I}_3} \Phi_{\mathcal{I}_2,\mathcal{I}_3}(A_2) = \Psi_{\mathcal{I},\mathcal{I}_3} \Phi_{\mathcal{I}_2,\mathcal{I}_3}(A_2)$$

and

$$\Psi_{\mathcal{I},\mathcal{I}_1}(A_1) = \Psi_{\mathcal{I},\mathcal{I}_1}\Psi_{\mathcal{I}_1,\mathcal{I}_3}\Phi_{\mathcal{I}_1,\mathcal{I}_3}(A_1) = \Psi_{\mathcal{I},\mathcal{I}_3}\Phi_{\mathcal{I}_1,\mathcal{I}_3}(A_1),$$

we have  $\Psi_{\mathcal{I},\mathcal{I}_1}(A_1) = \Psi_{\mathcal{I},\mathcal{I}_2}(A_2)$ . Hence,  $\Theta_{\mathcal{I}}(A)$  is independent of the choice of  $\mathcal{I}_1$  and  $A_1$ , and we get a map

$$\Theta_{\mathcal{I}}: K_{A_{\mathbb{R}}} \to K_{Q_{\mathcal{I}}}.$$

By the definition of  $\bar{K}_{A_{\mathbb{R}}}$ , there is a map

$$\Theta_{A_{\mathbb{R}}}:K_{A_{\mathbb{R}}}\to \bar{K}_{A_{\mathbb{R}}}.$$

**Lemma 5.6.** For any partitions  $\mathcal{I}$  of  $\mathbb{R}$ , we have the following commutative diagram

$$K_{A_{\mathbb{R}}} \xrightarrow{\Theta_{\mathcal{I}}} K_{Q_{\mathcal{I}}}$$

$$\chi_{A_{\mathbb{R}}} \downarrow \chi_{Q_{\mathcal{I}}}^{F} \downarrow \chi_{Q_{\mathcal{I}}}^{F}$$

$$\mathcal{F}_{A_{\mathbb{R}}} \xrightarrow{(\sigma_{\mathcal{I}}^{*})^{-1}\tau_{\mathcal{I}}^{*}} \mathcal{F}_{Q_{\mathcal{I}}}.$$

*Proof.* For any  $A \in K_{A_{\mathbb{R}}}$ , there exists  $\mathcal{I}_1$  such that  $A \in \operatorname{Im}(\Phi_{\mathcal{I}_1})$  and  $\mathcal{I}_1$  is a refinement of  $\mathcal{I}$ . Let  $A = \Phi_{\mathcal{I}_1}(A_1)$ . By definition,  $\Theta_{\mathcal{I}}(A) = \Psi_{\mathcal{I},\mathcal{I}_1}(A_1)$ . Then, we have

$$\sigma_{\mathcal{I}}^*\chi_{Q_{\mathcal{I}}}^F\Theta_{\mathcal{I}}(A) = \sigma_{\mathcal{I}}^*\chi_{Q_{\mathcal{I}}}^F\Psi_{\mathcal{I},\mathcal{I}_1}(A_1) = \sigma_{\mathcal{I}}^*\Psi_{\mathcal{I},\mathcal{I}_1}^F\chi_{Q_{\mathcal{I}_1}}^F(A_1) = \tau_{\mathcal{I},\mathcal{I}_1}^*\sigma_{\mathcal{I}_1}^*\chi_{Q_{\mathcal{I}_1}}^F(A_1)$$

and

$$\tau_{\mathcal{I}}^* \chi_{A_{\mathbb{R}}}(A) = \tau_{\mathcal{I}}^* \chi_{A_{\mathbb{R}}} \Phi_{\mathcal{I}_1}(A_1) = \tau_{\mathcal{I},\mathcal{I}_1}^* \tau_{\mathcal{I}_1}^* (\tau_{\mathcal{I}_1})_! \sigma_{\mathcal{I}_1}^* \chi_{Q_{\mathcal{I}_1}}^F(A_1) = \tau_{\mathcal{I},\mathcal{I}_1}^* \sigma_{\mathcal{I}_1}^* \chi_{Q_{\mathcal{I}_1}}^F(A_1).$$

Hence, we have

$$\sigma_{\mathcal{I}}^* \chi_{Q_{\mathcal{I}}}^F \Theta_{\mathcal{I}}(A) = \tau_{\mathcal{I}}^* \chi_{A_{\mathbb{R}}}(A)$$

and get the desired result.

**Proposition 5.7.** The following diagram is commutative

 $K_{A_{\mathbb{R}}} \xrightarrow{\Theta_{A_{\mathbb{R}}}} \bar{K}_{A_{\mathbb{R}}}$   $\downarrow^{\bar{\chi}_{A_{\mathbb{R}}}} \qquad \qquad \downarrow^{\bar{\chi}_{A_{\mathbb{R}}}}$   $\mathcal{F}_{A_{\mathbb{R}}} \xrightarrow{\theta_{A_{\mathbb{R}}}} \bar{\mathcal{F}}_{A_{\mathbb{R}}}.$ 

*Proof.* For any  $A \in K_{A_{\mathbb{R}}}$ , let  $A_{\mathcal{I}} = \Theta_{\mathcal{I}}(A) \in K_{Q_{\mathcal{I}}}$ . Since  $\Psi_{\mathcal{I}_1,\mathcal{I}_2}\Psi_{\mathcal{I}_2} = \Psi_{\mathcal{I}_1}$ , we have

$$(5) A_{\mathcal{I}_1} = \Theta_{\mathcal{I}_1}(A) = \Psi_{\mathcal{I}_1}\Theta_{A_{\mathbb{R}}}(A) = \Psi_{\mathcal{I}_1,\mathcal{I}_2}\Psi_{\mathcal{I}_2}\Theta_{A_{\mathbb{R}}}(A) = \Psi_{\mathcal{I}_1,\mathcal{I}_2}(A_{\mathcal{I}_2}).$$

Let  $f_{\mathcal{I}} = \sigma_{\mathcal{I}}^* \chi_{Q_{\mathcal{I}}}^F(A_{\mathcal{I}})$ . By Proposition 5.4, Formula (5) implies that  $f_{\mathcal{I}_1} = \tau_{\mathcal{I}_1,\mathcal{I}_1}^*(f_{\mathcal{I}_2})$ . By Lemma 5.2, there exists  $f \in \bar{\mathcal{F}}_{A_{\mathbb{R}}}$  such that  $\tau_{\mathcal{I}}^*(f) = f_{\mathcal{I}}$ . Then, we have  $\bar{\chi}_{A_{\mathbb{R}}}\Theta_{A_{\mathbb{R}}}(A) = f$  by Theorem 5.5.

Let  $g = \theta_{A_{\mathbb{R}}} \chi_{A_{\mathbb{R}}}(A)$ . Then

$$\tau_{\mathcal{T}}^*(q) = \tau_{\mathcal{T}}^* \chi_{A_{\mathbb{P}}}(A) = \sigma_{\mathcal{T}}^* \chi_{O_{\mathcal{T}}}^F \Theta_{\mathcal{T}}(A) = f_{\mathcal{T}} = \tau_{\mathcal{T}}^*(f)$$

by Lemma 5.6.

Hence, we have f = g and get the desired result.

Since  $\bar{\mathcal{F}}_{A_{\mathbb{R}}}$  is the completion of  $\mathcal{F}_{A_{\mathbb{R}}}$ , the set  $\bar{K}_{A_{\mathbb{R}}}$  can be viewed as a completion of the geometric version  $K_{A_{\mathbb{R}}}$  of Ringel-Hall algebra  $\mathcal{F}_{A_{\mathbb{R}}}$ .

**5.4.** Let  $V = (\mathbf{V}, \phi)$  be a finitely generated representation of  $A_{\mathbb{R}}$ . Let  $\mathcal{I}_1$  and  $\mathcal{I}_2$  be partitions of  $\mathbb{R}$  such that  $\mathcal{I}_2$  is a refinement of  $\mathcal{I}_1$  and  $\phi \in E_{\mathbf{V}, \mathcal{I}_1}$ .

Let  $V_{\mathcal{I}_1} = (\mathbf{V}_{\mathcal{I}_1}, \sigma_{\mathcal{I}_1}(\phi))$  and  $V_{\mathcal{I}_2} = (\mathbf{V}_{\mathcal{I}_2}, \sigma_{\mathcal{I}_2}(\phi))$ . Denote by  $\mathcal{O}_{V_{\mathcal{I}_1}}$  the orbit in  $E_{\mathbf{V}_{\mathcal{I}_1}}$  corresponding to  $V_{\mathcal{I}_1}$  and  $\mathcal{O}_{V_{\mathcal{I}_2}}$  the orbit in  $E_{\mathbf{V}_{\mathcal{I}_2}}$  corresponding to  $V_{\mathcal{I}_2}$ . Denote by

$$j_{\mathcal{O}_{V_{\mathcal{I}_1}}}: \mathcal{O}_{V_{\mathcal{I}_1}} \to E_{\mathbf{V}_{\mathcal{I}_1}}, j_{\mathcal{O}_{V_{\mathcal{I}_2}}}: \mathcal{O}_{V_{\mathcal{I}_2}} \to E_{\mathbf{V}_{\mathcal{I}_2}} \text{ and } \hat{j}_{\mathcal{O}_{V_{\mathcal{I}_2}}}: \mathcal{O}_{V_{\mathcal{I}_1}} \to \hat{E}$$

the natural embeddings.

Consider the following commutative diagram

$$E_{\mathbf{V}_{\mathcal{I}_{1}}} \stackrel{r_{1}}{\longleftarrow} \hat{E} \stackrel{r_{2}}{\longrightarrow} E_{\mathbf{V}_{\mathcal{I}_{2}}}$$

$$\uparrow^{j_{\mathcal{O}_{V_{\mathcal{I}_{1}}}}} \uparrow^{j_{\mathcal{O}_{V_{\mathcal{I}_{2}}}}} \uparrow^{j_{\mathcal{O}_{V_{\mathcal{I}_{2}}}}}$$

$$\mathcal{O}_{V_{\mathcal{I}_{1}}} \stackrel{r_{1}}{\longleftarrow} \mathcal{O}_{V_{\mathcal{I}_{2}}} \stackrel{id}{\longrightarrow} \mathcal{O}_{V_{\mathcal{I}_{2}}}.$$

Now, we have

$$\begin{split} \Psi_{\mathcal{I}_{1},\mathcal{I}_{2}}(IC_{\mathcal{O}_{V_{\mathcal{I}_{2}}}}) &\;\cong\;\; r_{1\flat}r_{2}^{*}(j_{\mathcal{O}_{V_{\mathcal{I}_{2}}}})_{!*}(1_{\mathcal{O}_{V_{\mathcal{I}_{2}}}}) \\ &\;\cong\;\; r_{1\flat}(\hat{j}_{\mathcal{O}_{V_{2}}})_{!*}(1_{\mathcal{O}_{V_{\mathcal{I}_{1}}}}) \\ &\;\cong\;\; (\hat{j}_{\mathcal{O}_{V_{\mathcal{I}_{1}}}})_{!*}(1_{\mathcal{O}_{V_{\mathcal{I}_{1}}}}) = IC_{\mathcal{O}_{V_{\mathcal{I}_{1}}}}. \end{split}$$

Hence, it holds that

$$\Psi_{\mathcal{I}_1,\mathcal{I}_2}([IC_{\mathcal{O}_{V_{\mathcal{I}_2}}}]) = [IC_{\mathcal{O}_{V_{\mathcal{I}_1}}}].$$

By the definition of  $\bar{K}_{A_{\mathbb{R}}}$ , there exist  $[IC_{\mathcal{O}_{V}}] \in \bar{K}_{A_{\mathbb{R}}}$  such that

$$\Psi_{\mathcal{I}}([IC_{\mathcal{O}_V}]) = [IC_{\mathcal{O}_{V_{\tau}}}]$$

for any  $\mathcal{I}$  such that  $\phi \in E_{\mathbf{V},\mathcal{I}}$ .

Theorem 5.8. The set

$$B_{A_{\mathbb{R}}} = \{ [IC_{\mathcal{O}_{V}}[n](\frac{n}{2})] | V \in rep_{K}(A_{\mathbb{R}}), n \in \mathbb{Z} \}$$

is a  $\mathbb{Z}$ -basis of  $\bar{K}_{A_{\mathbb{R}}}$ .

*Proof.* This result is direct by the definition of  $\bar{K}_{A_{\mathbb{R}}}$  and Theorem 2.5.

The basis  $B_{A_{\mathbb{R}}}$  is called the canonical basis of  $\bar{K}_{A_{\mathbb{R}}}$ .
