How smooth is the drift of the mixed fractional Brownian motion?

ABSTRACT. The mixed fractional Brownian motion, the sum of independent fractional and standard Brownian motions, is known to be a semimartingale if the Hurst exponent H of its fractional component is greater than 3/4. The question in the title is motivated by recent findings in quantitative finance. In this note, we find that the drift in its Doob-Meyer decomposition has derivative which is γ -Hölder for any $\gamma < 2H - 3/2$.

1. The main result

The fractional Brownian motion (fBm) $B^H = (B_t^H, t \in \mathbb{R}_+)$ is the Gaussian process with continuous paths, zero mean and covariance function

$$\mathsf{Cov}(B^H_s, B^H_t) = \frac{1}{2} t^{2H} + \frac{1}{2} s^{2H} - \frac{1}{2} |t - s|^{2H},$$

where $H \in (0,1)$ is its Hurst exponent, [10], [17], [15]. While B^H is not a semi-martingale for $H \neq \frac{1}{2}$, it can become one if an independent Brownian motion $B = (B_t, t \in \mathbb{R}_+)$ is added to it. More precisely, the process

$$X_t = B_t^H + B_t, \quad t \in \mathbb{R}_+, \tag{1.1}$$

called mixed fBm, is a semimartingale if and only if $H \in \{\frac{1}{2}\} \cup (\frac{3}{4}, 1]$. This effect, discovered in [4], plays a role in financial applications, [5], [2]. Some other interesting features of this process were revealed in, e.g., [1], [20], [3], [7], [9], [8].

By the Doob-Meyer theorem, the continuous semimartingale X can be uniquely decomposed into the sum of a local martingale and a continuous process of locally finite variation, which we will refer to in this note as the drift. The analysis of the drift of the mixed fBm is motivated by recent findings in quantitative finance. Two key concepts in finance are the volatility, that is the intensity of price fluctuations, and the market impact, which is the magnitude of the average price return induced by a given volume of transactions, see [11], [14] for details. It has been recently

shown in [16] that the mixed fBm is a natural model for the signed flow of financial transactions, and therefore, its drift properties are of significant importance for understanding the nature of volatility and impact in financial markets.

The main result of this note is the exact value of its Hölder exponent.

THEOREM 1.1. The drift of the mixed fBm with H > 3/4 is differentiable and the derivative has a continuous modification which, with probability one, is locally γ -Hölder continuous for all $\gamma < 2H - 3/2$.

2. The proof

2.1. The drift process. The mixed fBm with $H \in (\frac{3}{4}, 1]$ defined in (1.1) is a semimartingale in it own filtration $\mathcal{F}_t^X = \sigma\{X_s, s \in [0, t]\}$ with the Doob-Meyer decomposition

$$X_t = \overline{B}_t - \int_0^t \varphi_s(X) ds, \quad t \in \mathbb{R}_+, \tag{2.1}$$

where \overline{B} is \mathcal{F}^X -Brownian motion defined by the stochastic integral

$$\overline{B}_t = \int_0^t \frac{dM_s}{g(s,s)}$$

with respect to the martingale

$$M_t = \int_0^t g(s,t)dX_s.$$

The function g(s,t) is the unique continuous solution to the integral equation

$$g(s,t) + \int_0^t g(r,t)c_H |s-r|^{2H-2} dr = 1, \quad 0 < s \le t,$$

where $c_H := H(2H - 1)$. The derivative of the drift in (2.1) is

$$\varphi_s(X) = \int_0^s L(r, s) dX_r, \tag{2.2}$$

where the function $L(r,s) = \partial_s g(r,s)/g(s,s)$ is the unique $L^2([0,s])$ solution to the integral equation

$$L(r,s) + \int_0^s L(\tau,s)c_H|r-\tau|^{2H-2}d\tau = -c_H|s-r|^{2H-2}, \quad 0 < r < s.$$
 (2.3)

The semimartingale decomposition (2.1) is, in fact, the canonical innovation representation, see [12], of the process X as its filtration coincides with that of \overline{B} , i.e., $\mathcal{F}_t^X = \mathcal{F}_t^{\overline{B}}$ for all $t \geq 0$. This representation can be deduced from the general result in [13]. The above formulation is taken from [3, Theorem 3.4(i)]. By the Girsanov theorem the measure induced by X is locally equivalent to the Wiener measure and the Radon-Nikodym density is given by the corresponding stochastic exponential. This equivalence also follows from the general theory in [19]. A detailed discussion of all these results can be found in [6].

REMARK 2.1. The assertion of Theorem 1.1 is obvious for H=1 since in this case the unique solution to equation (2.3) is L(s,t)=-1/(1+t). The process $\varphi_t=-X_t/(1+t)$ in (2.2) has the same Hölder exponent as the mixed fBm itself, which, for H=1, has the form $X_t=\xi t+B_t$ with the standard Gaussian random variable ξ independent of B. Thus, $\gamma<\frac{1}{2}$ as claimed. The case $H\in(\frac{3}{4},1)$ is more involved since (2.3) is no longer solvable in a closed form.

We will prove that for $H \in (\frac{3}{4}, 1)$,

$$\mathsf{E}(\varphi_t(X) - \varphi_s(X))^2 \le C_2 |t - s|^{4H - 3} \tag{2.4}$$

for some constant C_2 (possibly dependent on $t \vee s$). Since the process $\varphi(X)$ is Gaussian, this implies

$$|E|\varphi_t(X) - \varphi_s(X)|^{2m} \le C_m |t - s|^{(4H - 3)m}, \quad \forall m \ge 1,$$

with constants C_m . Then by Kolmogorov's continuity theorem, $\phi(X)$ has a continuous modification, which is a.s. locally γ -Hölder for all $\gamma < \frac{m(4H-3)-1}{2m}$. The assertion of Theorem 1.1 follows by arbitrariness of m.

2.2. Auxiliary estimates. To prove (2.4), we will need some estimates for the solutions to weakly singular equations such as (2.3). For brevity, define

$$\alpha = 2 - 2H \in (0, \frac{1}{2}), \quad b_{\alpha} := c_{1-\alpha/2} = (1 - \alpha/2)(1 - \alpha).$$

For a fixed t > 0, let f(t; r, s), $r, s \in [0, t]^2$ be a real valued function with finite $L^2([0, s])$ norm,

$$||f(t;\cdot,s)||_2^2 = \int_0^s f(t;r,s)^2 dr < \infty, \quad \forall s \in [0,t].$$

Consider the integral equation

$$Q(r,s) + \int_0^s Q(\tau,s)b_{\alpha}|r - \tau|^{-\alpha}d\tau = f(t;r,s), \quad 0 \le r,s \le t.$$
 (2.5)

For each fixed s and $r \in [0, s]$, it has the unique solution in $L^2([0, s])$, since, for $\alpha \in (0, \frac{1}{2})$, the kernel satisfies, see [18, Section 94],

$$\int_0^s \int_0^s |r-\tau|^{-2\alpha} dr d\tau < \infty.$$

Since the integral in (2.5) depends only on the values of Q(r,s) for r < s, this equation defines the function Q(r,s) for r > s directly. The following lemma establishes the relevant bounds on the solution to (2.5) for several types of the function $f(\cdot)$.

LEMMA 2.2.

(i) Assume $||f||_{\infty} := \sup_{s,r \in [0,t]} |f(t;r,s)| < \infty$, then there exists a constant $C_1(t)$ such that

$$|Q(s,r)| < C_1(t) ||f||_{\infty}, \quad \forall r,s \in [0,t].$$

(ii) Assume $|f(t;r,s)| \le C(s,t)|s-r|^{-\alpha}$ for some function C(s,t) which satisfies $\sup_{s\in[0,t]}C(s,t)<\infty$. Then there exists a constant $C_2(t)$ such that

$$|Q(r,s)| \le C_2(t)C(s,t)|s-r|^{-\alpha}, \quad \forall r,s \in [0,t].$$
 (2.6)

(iii) Let $f(t;r,s) = (s-r)^{-\alpha} - (t-r)^{-\alpha}$, then there exists a constant $C_3(t)$ such that

$$|Q(r,s)| \le C_3(t) |(s-r)^{-\alpha} - (t-r)^{-\alpha}|, \quad \forall r,s \in [0,t].$$

PROOF.

(i) Multiply both sides of (2.5) by Q(r,s) and integrate to obtain

$$\|Q(\cdot,s)\|_{2}^{2} + \int_{0}^{s} \int_{0}^{s} Q(r,s)Q(\tau,s)b_{\alpha}|r-\tau|^{-\alpha}d\tau dr = \int_{0}^{s} Q(r,s)f(t;r,s)dr.$$

The kernel $|r-\tau|^{-\alpha}$ is non-negative definite and hence

$$||Q(\cdot,s)||_2^2 \le \int_0^s |Q(r,s)||f(t;r,s)|dr \le ||f||_{\infty} ||Q(\cdot,s)||_2 \sqrt{t}.$$

This implies $||Q(\cdot,s)||_2 \le ||f||_{\infty} \sqrt{t}$ and, consequently,

$$|Q(r,s)| \leq ||f||_{\infty} + b_{\alpha} ||Q(\cdot,s)||_{2} \left(\int_{0}^{s} |r-\tau|^{-2\alpha} d\tau \right)^{1/2} \leq$$

$$||f||_{\infty} + ||f||_{\infty} \sqrt{t} \frac{1}{1-2\alpha} (r^{1-2\alpha} + (s-r)^{1-2\alpha})^{1/2} \leq \frac{2}{1-2\alpha} t^{1-\alpha} ||f||_{\infty},$$

which verifies the claimed bound.

(ii) The difference $\widetilde{Q}(r,s) := Q(r,s) - f(t;r,s)$ solves the equation

$$\widetilde{Q}(r,s) + b_{\alpha} \int_{0}^{s} \widetilde{Q}(\tau,s) |r - \tau|^{-\alpha} d\tau = -b_{\alpha} \int_{0}^{s} |r - \tau|^{-\alpha} f(t;\tau,s) d\tau. \tag{2.7}$$

For r < s, the expression in the right hand side satisfies the bound

$$\begin{split} \left| b_{\alpha} \int_{0}^{s} |r - \tau|^{-\alpha} f(t;\tau,s) d\tau \right| &\leq \\ C(s,t) \int_{0}^{s} |\tau - r|^{-\alpha} (s - \tau)^{-\alpha} d\tau = C(s,t) \int_{0}^{s} v^{-\alpha} |s - r - v|^{-\alpha} dv = \\ C(s,t) (s - r)^{1-2\alpha} \int_{0}^{s/(s-r)} \tau^{-\alpha} |1 - \tau|^{-\alpha} d\tau &= \\ C(s,t) (s - r)^{1-2\alpha} \left(\int_{0}^{s/(s-r)} \tau^{-\alpha} (|1 - \tau|^{-\alpha} - \tau^{-\alpha}) d\tau + \int_{0}^{s/(s-r)} \tau^{-2\alpha} d\tau \right) &\leq \\ C(s,t) (s - r)^{1-2\alpha} \left(\int_{0}^{\infty} \tau^{-\alpha} ||1 - \tau|^{-\alpha} - \tau^{-\alpha} |d\tau + \frac{1}{1-2\alpha} \left(\frac{s}{s-r} \right)^{1-2\alpha} \right) &\leq \\ C(s,t) \left(\left(\pi + \frac{2}{1-2\alpha} \right) (s-r)^{1-2\alpha} + \frac{1}{1-2\alpha} s^{1-2\alpha} \right) &\leq \\ \frac{8}{1-2\alpha} t^{1-2\alpha} C(s,t) &=: C(t) C(s,t). \end{split}$$

Similarly, the same bound holds for r > s. Thus by (i) that

$$|\widetilde{Q}(r,s)| \leq C_1(t)C(t)C(s,t)$$

and, consequently,

$$|Q(r,s)| \le |\widetilde{Q}(r,s)| + |f(t;r,s)| \le C_1(t)C(t)C(s,t) + C(s,t)|s-r|^{-\alpha} \le (C_1(t)C(t)t^{\alpha} + 1)C(s,t)|s-r|^{-\alpha} =: C_2(t)C(s,t)|s-r|^{-\alpha},$$

as claimed in (2.6).

(iii). In this case, the right hand side of (2.7) satisfies

$$\left| b_{\alpha} \int_{0}^{s} |r - \tau|^{-\alpha} f(t; \tau, s) d\tau \right| \leq
\int_{0}^{s} |r - \tau|^{-\alpha} \left((s - \tau)^{-\alpha} - (t - \tau)^{-\alpha} \right) d\tau =
\int_{0}^{s} |r - s + u|^{-\alpha} \left(u^{-\alpha} - (t - s + u)^{-\alpha} \right) du =
(t - s)^{1 - 2\alpha} \int_{0}^{A} |B - v|^{-\alpha} \left(v^{-\alpha} - (1 + v)^{-\alpha} \right) dv,$$
(2.8)

where we defined

$$A := s/(t-s) \in (0,\infty)$$
 and $B := (s-r)/(t-s) \in (0,A)$.

For B < 2,

$$\int_{0}^{A} |B-v|^{-\alpha} \left(v^{-\alpha} - (1+v)^{-\alpha}\right) dv \le \int_{0}^{\infty} |B-v|^{-\alpha} \left(v^{-\alpha} - (1+v)^{-\alpha}\right) dv \le \int_{0}^{2} |B-v|^{-\alpha} v^{-\alpha} dv + \int_{2}^{\infty} (v-2)^{-\alpha} \left(v^{-\alpha} - (1+v)^{-\alpha}\right) dv \le \int_{0}^{B} (B-v)^{-\alpha} v^{-\alpha} dv + \int_{B}^{2} (v-B)^{-2\alpha} dv + \frac{3}{1-2\alpha} = \pi B^{1-2\alpha} + \frac{1}{1-2\alpha} (2-B)^{1-2\alpha} + \frac{3}{1-2\alpha},$$

which verifies the bound

$$\sup_{A \ge 0} \sup_{0 \le B \le 2} \int_0^A |B - v|^{-\alpha} \left(v^{-\alpha} - (1 + v)^{-\alpha} \right) dv < \infty.$$
 (2.9)

For B > 2.

$$\int_0^A |B-v|^{-\alpha} \left(v^{-\alpha} - (1+v)^{-\alpha}\right) dv \le \int_0^\infty |B-v|^{-\alpha} \left(v^{-\alpha} - (1+v)^{-\alpha}\right) dv = B^{1-2\alpha} \left(\int_0^1 + \int_1^\infty \right) |\tau - 1|^{-\alpha} (\tau^{-\alpha} - (\tau + 1/B)^{-\alpha}) d\tau =: B^{1-2\alpha} (J_1(B) + J_2(B)).$$

The second term satisfies the bound

$$J_{2}(B) = \int_{1}^{\infty} (\tau - 1)^{-\alpha} (\tau^{-\alpha} - (\tau + 1/B)^{-\alpha}) d\tau =$$

$$\int_{1}^{\infty} (\tau - 1)^{-\alpha} \tau^{-\alpha} \left(1 - (1 + 1/(B\tau))^{-\alpha} \right) d\tau \le$$

$$\alpha B^{-1} \int_{1}^{\infty} (\tau - 1)^{-\alpha} \tau^{-\alpha - 1} d\tau \le \frac{1}{1 - \alpha} B^{-1},$$

and therefore

$$B^{1-2\alpha}J_2(B) \le \frac{1}{1-\alpha}B^{-2\alpha} \le \frac{2^{-2\alpha}}{1-\alpha}, \quad \forall B \ge 2.$$

To estimate the term $B^{1-2\alpha}J_1(B)$ as $B\to\infty$, let R:=1/B and write

$$B^{1-2\alpha}J_1(B) = R^{\alpha} \frac{1}{R^{1-\alpha}} \int_0^1 (1-\tau)^{-\alpha} (\tau^{-\alpha} - (\tau + R)^{-\alpha}) d\tau.$$

By the L'Hôpital rule,

$$\begin{split} &\lim_{R \to 0} \frac{1}{R^{1-\alpha}} \int_0^1 (1-\tau)^{-\alpha} (\tau^{-\alpha} - (\tau+R)^{-\alpha}) d\tau = \\ &\lim_{R \to 0} \frac{\alpha}{1-\alpha} \frac{1}{R^{-\alpha}} \int_0^1 (1-\tau)^{-\alpha} (\tau+R)^{-\alpha-1} d\tau = \\ &\frac{\alpha}{1-\alpha} \lim_{R \to 0} \frac{1}{R^{-\alpha}} \int_0^1 \left((1-\tau)^{-\alpha} - 1 \right) (\tau+R)^{-\alpha-1} d\tau + \\ &\frac{\alpha}{1-\alpha} \lim_{R \to 0} \frac{1}{R^{-\alpha}} \int_0^1 (\tau+R)^{-\alpha-1} d\tau = \frac{1}{1-\alpha}. \end{split}$$

It follows that $B^{1-2\alpha}J_1(B) \to 0$ as $B \to \infty$ and hence

$$\sup_{A \ge 0} \sup_{B \ge 2} \int_0^A |B - v|^{-\alpha} \left(v^{-\alpha} - (1 + v)^{-\alpha} \right) dv < \infty.$$
 (2.10)

By plugging (2.9) and (2.10) into (2.8), we obtain

$$\left| b_{\alpha} \int_{0}^{s} |r - \tau|^{-\alpha} f(t; \tau, s) d\tau \right| \le C_{\alpha} (t - s)^{1 - 2\alpha}$$

for some constant C_{α} . Applying (i) of Lemma 2.2 to equation (2.7) yields

$$|\widetilde{Q}(r,s)| \le C_1(t)C_{\alpha}t^{1-2\alpha}$$

and, in turn,

$$|Q(r,s)| \le |\widetilde{Q}(r,s)| + |f(t;r,s)| \le C_1(t)C_{\alpha}t^{1-2\alpha} + ||s-r|^{-\alpha} - |t-r|^{-\alpha}| \le C_1(t)C_{\alpha}t^{1-\alpha} + 1\Big) ||s-r|^{-\alpha} - |t-r|^{-\alpha}| := C_3(t)||s-r|^{-\alpha} - |t-r|^{-\alpha}|.$$

2.3. Proof of (2.4). For s < t,

$$\begin{split} & \mathsf{E}((\varphi_{t}(X) - \varphi_{s}(X))^{2} = \mathsf{E}\varphi_{t}(X)^{2} + \mathsf{E}\varphi_{s}(X)^{2} - 2\mathsf{E}\varphi_{s}(X)\varphi_{t}(X) = \\ & \int_{0}^{t} L(\tau,t) \left(L(\tau,t) + b_{\alpha} \int_{0}^{t} L(r,t) |\tau - r|^{-\alpha} dr \right) d\tau \\ & + \int_{0}^{s} L(\tau,s) \left(L(\tau,s) + b_{\alpha} \int_{0}^{s} L(r,s) |r - \tau|^{-\alpha} dr \right) d\tau \\ & - 2 \int_{0}^{s} L(\tau,s) \left(L(\tau,t) + b_{\alpha} \int_{0}^{t} L(r,t) |r - \tau|^{-\alpha} dr \right) d\tau = \\ & - \int_{0}^{t} L(\tau,t) b_{\alpha} |\tau - t|^{-\alpha} d\tau - \int_{0}^{s} L(\tau,s) b_{\alpha} |\tau - s|^{-\alpha} d\tau \\ & + 2 \int_{0}^{s} L(\tau,s) b_{\alpha} |\tau - t|^{-\alpha} d\tau = : -b_{\alpha} (I_{1} + I_{2} + I_{3}), \end{split}$$

where we defined

$$I_1 := \int_0^s \left(L(\tau, t) - L(\tau, s) \right) |\tau - t|^{-lpha} d au,$$
 $I_2 := \int_0^s L(\tau, s) \left(|\tau - s|^{-lpha} - |\tau - t|^{-lpha} \right) d au,$
 $I_3 := \int_s^t L(\tau, t) |\tau - t|^{-lpha} d au.$

We will estimate these terms using the bounds from Lemma 2.2. By (ii) the solution to (2.3) satisfies $|L(r,s)| \le b_{\alpha}C_2(t)|r-s|^{-\alpha}$ and hence

$$|I_3| \le C_2(t) \int_s^t (t-\tau)^{-2\alpha} d\tau = C_2(t) \frac{1}{1-2\alpha} (t-s)^{1-2\alpha}.$$
 (2.12)

Similarly,

$$|I_{2}| \leq C_{2}(t) \int_{0}^{s} (s-\tau)^{-\alpha} \left((s-\tau)^{-\alpha} - (t-\tau)^{-\alpha} \right) d\tau =$$

$$C_{2}(t) \int_{0}^{s} u^{-\alpha} \left(u^{-\alpha} - (t-s+u)^{-\alpha} \right) d\tau \leq$$

$$C_{2}(t)(t-s)^{1-2\alpha} \int_{0}^{\infty} v^{-\alpha} \left(v^{-\alpha} - (v+1)^{-\alpha} \right) dv \leq$$

$$C_{2}(t) \frac{1}{1-2\alpha} (t-s)^{1-2\alpha}.$$
(2.13)

To estimate I_1 , note that D(r,s) := L(r,t) - L(r,s) solves the equation, cf. (2.3),

$$D(r,s) + \int_0^s D(\tau,s)b_{\alpha}|r-\tau|^{-\alpha}d\tau =$$

$$b_{\alpha}(|s-r|^{-\alpha} - |t-r|^{-\alpha}) - \int_s^t L(\tau,t)b_{\alpha}|r-\tau|^{-\alpha}d\tau. \quad (2.14)$$

By (ii) of Lemma 2.2,

$$\begin{split} \left| \int_{s}^{t} L(\tau,t) b_{\alpha} |r - \tau|^{-\alpha} d\tau \right| &\leq C_{2}(t) \int_{s}^{t} (t - \tau)^{-\alpha} |r - \tau|^{-\alpha} d\tau = \\ C_{2}(t) \int_{0}^{t-s} u^{-\alpha} |t - r - u|^{-\alpha} d\tau &= C_{2}(t) (t-s)^{1-2\alpha} \int_{0}^{1} v^{-\alpha} \left(\frac{t-r}{t-s} - v \right)^{-\alpha} dv \leq \\ C_{2}(t) (t-s)^{1-2\alpha} \left(\frac{t-r}{t-s} - 1 \right)^{-\alpha} \int_{0}^{1} v^{-\alpha} dv = C_{2}(t) \frac{1}{1-\alpha} (t-s)^{1-\alpha} (s-r)^{-\alpha}, \end{split}$$

where † holds since $(t-r)/(t-s) \in [1,\infty)$ for $r \le s$. By linearity of (2.14) and uniqueness of its solution, it follows from (ii) and (iii) of Lemma 2.2 that

$$|L(r,t)-L(r,s)| \le C_3(t) ((s-r)^{-\alpha}-(t-r)^{-\alpha}) + C_2(t)^2 \frac{1}{1-\alpha} (t-s)^{1-\alpha} (s-r)^{-\alpha}.$$

Substitution of this bound yields

$$|I_{1}| \leq C_{3}(t) \int_{0}^{s} \left((s-\tau)^{-\alpha} - (t-\tau)^{-\alpha} \right) (t-\tau)^{-\alpha} d\tau + C_{2}(t)^{2} \frac{1}{1-\alpha} (t-s)^{1-\alpha} \int_{0}^{s} (s-\tau)^{-\alpha} (t-\tau)^{-\alpha} d\tau.$$
(2.15)

The first integral satisfies the bound

$$\int_{0}^{s} ((s-\tau)^{-\alpha} - (t-\tau)^{-\alpha})(t-\tau)^{-\alpha} d\tau \le \int_{0}^{s} (u^{-\alpha} - (t-s+u)^{-\alpha})(t-s+u)^{-\alpha} du \le (t-s)^{1-2\alpha} \int_{0}^{\infty} (v^{-\alpha} - (v+1)^{-\alpha})(v+1)^{-\alpha} dv \le \frac{1}{1-2\alpha} (t-s)^{1-2\alpha}$$

The second integral in (2.15) has a similar estimate:

$$(t-s)^{1-\alpha} \int_0^s (s-\tau)^{-\alpha} (t-\tau)^{-\alpha} d\tau \le (t-s)^{1-\alpha} \int_0^s (s-\tau)^{-2\alpha} d\tau = \frac{1}{1-2\alpha} (t-s)^{1-\alpha} s^{1-2\alpha} \le \frac{1}{1-2\alpha} t^{1-\alpha} (t-s)^{1-2\alpha}.$$

Thus we obtain

$$|I_1| \le \frac{1}{1 - 2\alpha} \left(C_3(t) + C_2(t)^2 \frac{1}{1 - 2\alpha} t^{1 - \alpha} \right) (t - s)^{1 - 2\alpha}.$$
 (2.16)

Substitution of (2.12), (2.13) and (2.16) into (2.11) yields (2.4), which completes the proof.
