An elimination forest F for a graph G = (V, E) is a rooted forest on the vertex set V such that for every edge  $uv \in E$ , u is an ancestor or descendant of v in F. The treedepth  $\mathrm{td}(G)$  of a graph G is defined as the minimum height of an elimination forest for G. Treedepth is monotone under taking minors, thus, the class  $\mathscr{G}_k$  of graphs with treedepth at most k is a minor-closed class. From the Graph-Minor-Theorem [4] it follows that there is a finite set  $\mathrm{Obs}_{\leq}(\mathscr{G}_k)$  of forbidden minors that characterize  $\mathscr{G}_k$ . Dvořák et al. [1] computed  $\mathrm{Obs}_{\leq}(\mathscr{G}_3)$ , and furthermore showed that for every k there exist obstructions for  $\mathscr{G}_k$  that contain  $2^k$  vertices. They conjecture that this is an upper bound, i.e., that every graph  $G \in \mathrm{Obs}_{\leq}(\mathscr{G}_k)$  has at most  $2^k$  vertices, as well as identical bounds for the set of forbidden subgraphs  $\mathrm{Obs}_{\subset}(\mathscr{G}_k)$  and forbidden induced subgraphs  $\mathrm{Obs}_{\subset}(\mathscr{G}_k)$ .

For a graph class  $\mathscr{G}$ , we define  $\mathscr{G}^{(n)}:=\{G\in\mathscr{G}: |V(G)|=n\}$  and  $\mathscr{G}^{(\leq n)}:=\{G\in\mathscr{G}: |V(G)|\leq n\}$ . We compute for each  $n\leq 16=2^4$ , the set of n-vertex obstructions for treedepth at most 4,  $\operatorname{Obs}_R^{(n)}(\mathscr{G}_4)$  with  $R\in\{\leq,\subseteq,\sqsubseteq\}$ . If the conjecture holds, these are the complete sets for treedepth at most 4.

## The Algorithm

We sketch an algorithm that for  $k, n \in \mathbb{N}$  computes  $\operatorname{Obs}_{R}^{(n)}(\mathscr{G}_{k})$  with  $R \in \{\leq, \subseteq, \sqsubseteq\}$ . We use the fact that  $\operatorname{Obs}_{\sqsubseteq}^{(n)}(\mathscr{G}_{k}) \supseteq \operatorname{Obs}_{\subseteq}^{(n)}(\mathscr{G}_{k}) \supseteq \operatorname{Obs}_{\leq}^{(n)}(\mathscr{G}_{k})$  to obtain the latter two sets by filtering the first set.

- 1. Recursively compute  $\mathcal{G}_k^{(i)}$  for  $1 \le i \le n-1$ .
- 2. Compute  $\operatorname{Obs}^{(n)}_{\sqsubseteq}(\mathscr{G}_k)$  as the set of graphs G satisfying:  $\operatorname{td}(G) = k+1$  and  $\forall v \in V(G) \colon G-v \in \mathscr{G}^{(n-1)}_k$ .
- 3. Compute  $\operatorname{Obs}^{(n)}_{\subseteq}(\mathscr{G}_k)$  as the set of graphs that are subgraph-minimal in  $\operatorname{Obs}^{(n)}_{\subseteq}(\mathscr{G}_k)$ .
- 4. Compute  $\operatorname{Obs}^{(n)}_{\leq}(\mathscr{G}_k)$  as the subset of graphs from  $\operatorname{Obs}^{(n)}_{\subseteq}(\mathscr{G}_k)$  that are minor-minimal in  $\operatorname{Obs}^{(n)}_{\subseteq}(\mathscr{G}_k) \cup \operatorname{Obs}^{(n-1)}_{\subseteq}(\mathscr{G}_k)$ .

In **Step 1** we initialize  $\mathcal{G}_k^{(1)} := \{K_1\}$ . Given  $\mathcal{G}_k^{(i-1)}$ , we compute  $\mathcal{G}_k^{(i)}$  as the union over all single-vertex extensions of graphs in  $\mathcal{G}_k^{(i-1)}$ : For each  $G = (V, E) \in \mathcal{G}_k^{(i-1)}$  and every set of vertices  $A \subseteq V$ , we define the graph  $G_A := (V \cup \{v\}, E \cup \{uv \mid u \in A\})$ . We may assume without loss of generality that v is a vertex of minimum degree in  $G_A$ , thereby greatly reducing the number of vertex sets A that need to be considered. We then test whether  $\operatorname{td}(G_A) \leq k$ , compute a canonical representation  $G_A^*$  of  $G_A$ , and store  $G_A^*$  in a hash-set, allowing us to eliminate duplicates.

**Step 2** is implemented similarly to step 1. For each extension  $G_A = (V, E)$  of a graph  $G \in \mathcal{G}_k^{(n-1)}$  we test that  $\operatorname{td}(G_A) > k$ , as well as testing that  $\forall v \in V : \operatorname{td}(G_A - v) \leq k$ . In our sequential algorithm we perform the latter test by a simple lookup in  $\mathcal{G}_k^{(n-1)}$ . The parallel algorithm recomputes the treedepth to save memory at the cost of runtime: Doing so allows us to discard graphs in  $\mathcal{G}_k^{(n-1)}$  as soon as they are no longer needed.

For **Step 3**, note that for a graph  $G = (V, E) \in \mathrm{Obs}^{(n)}_{\subseteq}(\mathscr{G}_k) \subseteq \mathrm{Obs}^{(n)}_{\subseteq}(\mathscr{G}_k)$  it holds that  $\forall e \in E \colon G - e \notin \mathrm{Obs}^{(n)}_{\subseteq}(\mathscr{G}_k)$ , since

 $\operatorname{td}(G-e) \leq k$ . Conversely, if this property holds for a graph  $G \in \operatorname{Obs}_{\sqsubseteq}^{(n)}(\mathscr{G}_k)$ , then any proper subgraph G' = (V', E') of G has treedepth at most k: If |V'| < |V|, then G' is also a subgraph of a proper induced subgraph of G, and thus, has treedepth at most k. If V' = V, |E'| = |E| - 1, then each proper induced subgraph of G' is a subgraph of a proper induced subgraph of G and, thus, has treedepth at most K. Since  $G' \notin \operatorname{Obs}_{\sqsubseteq}^{(n)}(\mathscr{G}_k)$ , it follows that  $\operatorname{td}(G') \leq K$ . Finally, if V' = V, |E'| < |E| - 1, then G' is a subgraph of G - e for some  $e \in E$ , which by the previous case already has treedepth at most K.

For **Step 4**, observe that for a graph  $G \in Obs_{\leq}^{(n)}(\mathscr{G}_k) \subseteq Obs_{\subseteq}^{(n)}(\mathscr{G}_k)$  it holds that  $\forall e \in E(G) \colon G/e \notin Obs_{\subseteq}^{(n-1)}(\mathscr{G}_k)$ , since  $td(G/e) \leq k$ . Once more, this property is also sufficient: Any minor of  $G \in Obs_{\subseteq}^{(n)}(\mathscr{G}_k)$  that is also a minor of a proper subgraph of G, has treedepth at most k. Any other minor G' of G is obtained by a series of edge contractions. In this case, as in step 3, the condition ensures that G' has treedepth at most k.

## **Implementation and Results**

We implemented the algorithm utilizing the nauty library for graph canonization [3] and the Bute library for treedepth computation [5]. Both the source code as well as the computation results are avaiable on Zenodo [2]. We computed  $Obs_{\sqsubseteq}^{(\leq 16)}(\mathcal{G}_4), Obs_{\subseteq}^{(\leq 16)}(\mathcal{G}_4)$  and  $Obs_{\leq}^{(\leq 16)}(\mathcal{G}_4)$  to be of size 12204, 1718 and 1546 respectively. Further computation confirms that  $Obs_{\sqsubseteq}^{(17)}(\mathcal{G}_4) = Obs_{\sqsubseteq}^{(18)}(\mathcal{G}_4) = \emptyset$ . However, we do not yet have a proof that for all n > 18 it holds that  $Obs_{\vdash}^{(n)}(\mathcal{G}_4) = \emptyset$ .




Figure 1: An induced subgraph obstruction for treedepth 3.

In testing the algorithm, we also computed  $Obs_{\sqsubseteq}(\mathscr{G}_3)$ . For this, Dvořák et al. [1] gave a set of 29 graphs. However, we found the forbidden induced subgraph shown in Figure 1, which was overlooked by them. As a result,  $|Obs_{\sqsubseteq}(\mathscr{G}_3)| = 30$ , rather than 29. The number of forbidden subgraphs and minors remains at 14 and 12 respectively.
