Global and local existence of solutions for a novel type of parabolic Kirchhoff system with singular term

Abstract

In this paper, we investigate solutions for a fractional system involving a novel class of Kirchhoff functions and logarithmic nonlinearity:

$$\begin{cases} u_t + \mathcal{K}\left([u]_p^s\right) \mathcal{L}_p^s u = |v|^{\sigma} |u|^{\sigma-2} u \log |uv|, & \text{in} & \mathcal{U} \times [0, T), \\ v_t + \mathcal{K}\left([v]_q^s\right) \mathcal{L}_q^s v = |u|^{\sigma} |v|^{\sigma-2} v \log |uv|, & \text{in} & \mathcal{U} \times [0, T), \\ u(x, t) = v(x, t) = 0, & \text{in} & \partial \mathcal{U} \times [0, T), \\ u(x, 0) = u_0(x), v(x, 0) = v_0(x), & \text{in} & \mathcal{U}, \end{cases}$$

where K is Kirchhoff function, and \mathcal{L}_p^s is the fractional p- Laplacian operator. We prove the existence of a weak solution using the Faedo-Galerkin method under suitable assumptions on the Kirchhoff function. We investigate the finite-time blow-up and global existence of solutions based on critical, subcritical, and supercritical initial energy levels. Subsequently, we establish the stabilization of the solution with positive initial energy by applying Komornik's integral inequality.

1. Introduction

In this work, we are concerned with study the local and global existence solution for parabolic system with Kirchhoff function and logarithmic nonlinearity. To be more precise, we study the following system:

$$\begin{cases} u_{t} + \mathcal{K}\left(\left[u\right]_{p}^{s}\right) \mathcal{L}_{p}^{s} u = |v|^{\sigma} |u|^{\sigma-2} u \log |uv|, & \text{in} & \mathcal{U} \times [0, T), \\ v_{t} + \mathcal{K}\left(\left[v\right]_{q}^{s}\right) \mathcal{L}_{q}^{s} v = |u|^{\sigma} |v|^{\sigma-2} v \log |uv|, & \text{in} & \mathcal{U} \times [0, T), \\ u(x, t) = v(x, t) = 0, & \text{in} & \partial \mathcal{U} \times [0, T), \\ u(x, 0) = u_{0}(x), v(x, 0) = v_{0}(x), & \text{in} & \mathcal{U}, \end{cases}$$

where $\mathcal{U} \subset \mathbb{R}^N$ being a bounded domain with Lipschitz boundary $\partial \mathcal{U}$, $s \in (0,1)$, p, q, and σ are three numbers positives verify some conditions that will be mentioned later. The main operator \mathcal{L}_p^s is the so-called the fractional p-Laplacian operator given by

$$\mathscr{L}_p^s \mathfrak{u} = 2 \lim_{\varepsilon \to 0^+} \int_{\mathcal{U} \setminus \mathfrak{R}_c(x)} \frac{|\mathfrak{u}(x) - \mathfrak{u}(y)|^{p-2} (\mathfrak{u}(x) - \mathfrak{u}(y))}{|x - y|^{N+sp}} \mathrm{d}y.$$

Furthermore, we consider the continuous function $\mathcal{K}:[0,\infty)\to(0,\infty)$ which satisfy the following assumptions:

- (\mathcal{H}_1) The function \mathcal{K} is non-decreasing and continuous on $(0,\infty)$.
- (\mathcal{H}_2) For a given a constant $\beta \geq 0$, $z \mapsto \frac{\mathcal{K}(z)}{z^{\beta}}$ is decreasing on $(0, \infty)$.

Below, we present several examples of models that satisfy our assumptions.

Example 1.1. • $K(t) = a + bt^c$, where a, b, c > 0.

• $\mathcal{K}(t) = \log(1+t)$.

Furthermore, we suppose numbers p, q, β and σ satisfy the following inequality:

with p_s^* and q_s^* are the criticals Sobolev exponent given by

$$p_s^* = \begin{cases} \frac{Np}{N-sp}, & \text{if } N > sp, \\ +\infty, & \text{if } N \le sp, \end{cases}$$

and

$$q_s^* = \begin{cases} \frac{Nq}{N-sq}, & \text{if } N > sq, \\ +\infty, & \text{if } N \leq sq. \end{cases}$$

For the sake of simplicite, we note

$$[\mathfrak{u}]_p^s = \frac{1}{p} \int_{q/\sqrt{q}} \frac{|\mathfrak{u}(x) - \mathfrak{u}(y)|^p}{|x - y|^{N+sp}} dxdy$$
, and $[\mathfrak{v}]_p^s = \frac{1}{q} \int_{q/\sqrt{q}} \frac{|\mathfrak{v}(x) - \mathfrak{v}(y)|^p}{|x - y|^{N+sq}} dxdy$.

As of late, great attention has been paid on the study of equations involving double phase operator and variational problems with growth conditions with variable exponent. This kind of problem arises in numerous applications, such as, population dynamics, phase transition phenomena, continuum mechanics, typical outcome of stochastically stabilization of Lévy processes, image processing, electro-rheological fluids and thermo-rheological fluids [4, 5, 6, 11, 13, 35]. Kirchhoff in [21] was first introduced the following model of elastic string

$$\rho h \mathbf{u}_{tt} + \delta \mathbf{u}_t = \left(p_0 + \frac{Eh}{L} \mathcal{K}(\mathbf{u}) \right) u_{xx} + f, \tag{3}$$

where $\mathcal{K}(\mathfrak{u}) = \int_0^L \mathfrak{u}_x^2 dx$, accounts for the effect of transversal oscillations. Additionally, Alembert in [19] developped the model (3), and he proposed the below equation for the free vibrations:

$$\varepsilon \mathfrak{u}_{tt}^{\varepsilon} + \mathfrak{u}_{t}^{\varepsilon} - \mathcal{K} \left(\int_{\mathcal{U}} |\nabla \mathfrak{u}^{\varepsilon}|^{2} d\mathbf{x} \right) \Delta \mathfrak{u}^{\varepsilon} = f(\mathbf{x}, t). \tag{4}$$

Setting $\epsilon = 0$ in equation (4) yields the Kirchhoff-type problem:

$$v_t - \mathcal{K} \left(\int_{\mathcal{U}} |\nabla v|^2 \, \mathrm{dy} \right) \Delta v = f(y, t).$$

These models have attracted significant research interest in recent years, as they encompass various physical phenomena. Before highlighting the novelty of this work, we provide a review of the existing literature. In [28], the authors studied the p-Kirchhoff type models describing motion of a non-stationary fluid given by

$$\mathfrak{u}_t - \mathcal{K}(\|\mathfrak{u}\|_p^p) \left(-\Delta_p\right)(\mathfrak{u}) = |\mathfrak{u}|^{\alpha-2}\mathfrak{u}.$$

For the degenerate case, authors in [31], have proved the solvability of the fractional version

$$\mathfrak{u}_t - \mathcal{K}([\mathfrak{u}]_{s,p}^p) \left(-\Delta_p^s\right)(\mathfrak{u}) = |\mathfrak{u}|^{\alpha-2}\mathfrak{u}.$$

A third fascinating aspect of our problem is the presence of a logarithmic nonlinearity term. Indeed, considering the following parabolic equation:

$$\mathfrak{u}_t = \nabla \mathfrak{u} + |\mathfrak{u}|^{q-2} \log |\mathfrak{u}|, \quad \mathfrak{u} : \mathbb{R}^n \times (0, \infty) \to \mathbb{R}, \quad q, n \ge 2,$$

which it shows up in a lot of physical applications, such as theory of superfluidity, nuclear physics, diffusion phenomena, and transport. See [40] for more details. Due to these reasons, the following model

$$\begin{cases} \mathbf{u}_t + (-\Delta)^s \mathbf{u} = |\mathbf{u}|^{r-2} u \log |\mathbf{u}|, & \text{in} & \mathcal{U} \times [0, T), \\ \mathbf{u}(\mathbf{x}, t) = 0, & \text{in} & \partial \mathcal{U} \times [0, T), \\ \mathbf{u}(\mathbf{x}, 0) = \mathbf{u}_0(\mathbf{x}), & \text{in} & \mathcal{U}, \end{cases}$$

has been studied quite extensively; for example, the authors in previous papers [32, 33, 15, 30, 39] studied the asymptotic behavior, global existence, and finite blow up of solutions. In this context, many authors has been studied the blow-up and global existence of solutions to the following problem:

$$\begin{cases} \mathbf{u}_t + (-\Delta)\mathbf{u} = g(\mathbf{u}), & \text{in} & \mathcal{U} \times [0, T), \\ \mathbf{u}(\mathbf{x}, t) = 0, & \text{in} & \partial \mathcal{U} \times [0, T), \\ \mathbf{u}(\mathbf{x}, 0) = \mathbf{u}_0(\mathbf{x}), & \text{in} & \mathcal{U}, \end{cases}$$

where g is a function satisfies some conditions. See the references [3, 8, 34, 38, 27] for more details. Inspired by previpously works, in this present paper, we study the effect of logarithmic nonlinearity term end a new class of Kirchhoff function that satsfies (\mathcal{H}_1) and (\mathcal{H}_2). For this, we use potentiel well method what introduced by Sattinger and Payne [37, 34] and Galerkin's method, we show the following parabolic system:

$$\begin{cases} u_t + \mathcal{K}\left([\mathfrak{u}]_p^s\right) \mathcal{L}_p^s u = |\mathfrak{v}|^{\sigma} |\mathfrak{u}|^{\sigma-2} u \log |\mathfrak{u}\mathfrak{v}|, & \text{in} \qquad \mathcal{U} \times [0, T), \\ \mathfrak{v}_t + \mathcal{K}\left([\mathfrak{v}]_q^s\right) \mathcal{L}_q^s \mathfrak{v} = |\mathfrak{u}|^{\sigma} |\mathfrak{v}|^{\sigma-2} \mathfrak{v} \log |\mathfrak{u}\mathfrak{v}|, & \text{in} \qquad \mathcal{U} \times [0, T), \\ \mathfrak{u}(x, t) = \mathfrak{v}(x, t) = 0, & \text{in} \qquad \partial \mathcal{U} \times [0, T), \\ \mathfrak{u}(x, 0) = \mathfrak{u}_0(x), \mathfrak{v}(x, 0) = \mathfrak{v}_0(x), & \text{in} \qquad \mathcal{U}, \end{cases}$$

has a weak solution. However, under some conditions on the intial data, we show the existence of global solution for system (1). An one of the main tools, Komormik's integral inequality. In addition, we show the global solution decays algebraically or exponentially depending on q, p, s, u_0 , and v_0 . Otherwise, we study blow-up phenomenna in subscritical initial energy case, and we give an upper bounded for the maximal existence time. The difficulty here is apparently the coupling term $\log(uv)$, in our problem, and the absence of logarithmic Sobolev inequality which seems not to exist logarithmic Sobolev inequality concerning the fractional p-Laplacian again.

The remainder of this paper is structured as follows. In Section 2, we give some preliminary results that will be used throughout the paper. In sections 3, 4, and 5, we will prove the main results.

2. Preliminaries

Fractional Sobolev spaces

In this subsection, we review key properties of fractional Sobolev spaces. For more details, see [9, 14]. Let $\mathcal{U} \subset \mathbb{R}^N$ be a bounded domain, and $\partial \mathcal{U}$ its boundary. For $s \in (0,1)$, and $p \in [1;+\infty)$, we define Sobolev space fractional $W^{s,p}(\mathcal{U})$ as follows:

$$W^{s,p}(\mathcal{U}) = \left\{ v \in L^p(\mathcal{U}) : \frac{|v(x) - v(y)|}{|x - x|^{\frac{n}{p} + s}} \in L^p(\mathcal{U} \times \mathcal{U}) \right\},\,$$

i.e, an intermediary Banach space between $L^p(\mathcal{U})$ and $W^{1,p}(\mathcal{U})$, endowed with the natural norm

$$\|\mathfrak{v}\|_{W^{s,p}(\mathcal{U})} = \left(\int_{\mathcal{U}} |\mathfrak{v}(\mathbf{x})|^p d\mathbf{x} + [\mathfrak{v}]_{W^{s,p}(\mathcal{U})}^p\right)^{\frac{1}{p}},$$

where $[\mathfrak{v}]_{W^{s,p}(\mathcal{U})}$ is the Gagliardo semi-norm given by

$$[\mathfrak{v}]_{W^{s,p}(\mathcal{U})} = \left(\iint_{\mathcal{U} \times \mathcal{U}} \frac{|\mathfrak{v}(x) - \mathfrak{v}(y)|^p}{|x - y|^{N+sp}} dx dy \right)^{\frac{1}{p}},$$

and the Banach space

$$\|\mathfrak{v}\|_{W_0^{s,p}(\mathcal{U})} := \left(\int_{\mathbb{R}^N} \int_{\mathbb{R}^N} \frac{|\mathfrak{v}(x) - \mathfrak{v}(y)|^p}{|x - y|^{N+sp}} dx dy\right)^{\frac{1}{p}},$$

endowed with the Gagliardo semi-norm:

$$\|\mathfrak{v}\|_{W_0^{s,p}(\mathcal{U})} := \left(\int_{\mathbb{R}^N} \int_{\mathbb{R}^N} \frac{|\mathfrak{v}(x) - \mathfrak{v}(y)|^p}{|x - y|^{N+sp}} dx dy\right)^{\frac{1}{p}}.$$

Theorem 2.1. (See [14, 17]) For $1 \le p < \infty$ and 0 < s < 1 with sp < N. We have the embedding

$$W^{s,p}\left(\mathcal{U}\right)\hookrightarrow L^{q}\left(\mathcal{U}\right) \ and \ W_{0}^{s,p}\left(\mathcal{U}\right)\hookrightarrow L^{q}\left(\mathcal{U}\right)$$

which are respectively continuous for $q \in [1, p_s^*)$, $q \in [1, p_s^*]$ and both compacts for $q \in [1, p_s^*)$.

$$W_0^{s,p}(\mathcal{U}) := \{ v \in W^{s,p}(\mathbb{R}^N), v = 0 \text{ a.e. in } \mathbb{R}^N \setminus \mathcal{U} \}$$

and the Banach norm in the space $W_0^{s,p}(\mathcal{U})$ is the Gagliardo semi-norm:

$$\|\mathfrak{v}\|_{W_0^{s,p}(\mathcal{U})} := \left(\int_{\mathbb{R}^N} \int_{\mathbb{R}^N} \frac{|\mathfrak{v}(x) - \mathfrak{v}(y)|^p}{|x - y|^{N + sp}} dx dy\right)^{\frac{1}{p}}.$$

Theorem 2.2. (See [14]: Poincaré inequality) Let $v \in W_0^{s,p}(\mathcal{U})$. Then, there exists a positive constant c > 0, such that

$$c^{-1}\|\mathfrak{v}\|_{W^{s,p}\left(\mathbb{R}^{N}\right)}\leq\|\mathfrak{v}\|_{W_{0}^{s,p}\left(\mathcal{U}\right)}\leq c\|\mathfrak{u}\|_{W^{s,p}\left(\mathbb{R}^{N}\right)},$$

Lemma 2.1. (See [10] If $1 < p_0 < p\mu < p_1 < \infty$. Then, we have

$$\|\mathfrak{v}\|_{p\mu} \leq \|\mathfrak{v}\|_{p_0}^{1-\mu} \|\mathfrak{v}\|_{p_1}^{\mu},$$

for any $v \in L^{p_1}(\mathcal{U})$ with $\mu \in (0,1)$ and $\frac{1}{\mu p} = \frac{1-\mu}{p_0} + \frac{\mu}{p_1}$.

Definition 2.1. (See [28]) (Maximal existence time)

The maximal existence time of a weak solution v to the system (1) is defined as:

- 1. If v exists for all $0 \le t < +\infty$, then $T_{\text{max}} = +\infty$.
- 2. If there exits a $t_0 \in (0, +\infty)$ such that v exists for $0 \le t < t_0$, but does not exist at $t = t_0$, then $T_{\text{max}} = t_0$.

Inequalities algebrics

Lemma 2.2. (See [24]) Let K be a positive function $K(t) \in C^2([0,T),\mathbb{R})$ which satisfies

$$K''(t)K(t) - \alpha (K'(t))^2 \ge 0$$
, for all $\alpha > 1$, and $0 < T \le \infty$.

If K(0) > 0, K'(0) > 0, then

$$T \leq \frac{K(0)}{(\alpha-1)K'(0)} < \infty \ and \ K(t) \to \infty \ as \ t \to T.$$

Lemma 2.3. (See [29])

Let us consider the non-increasing function $R:[0,+\infty)\to[0,+\infty)$. Suppose there exist constants $\eta\geq 0$ and C>0such that

$$\int_{t}^{\infty} R^{1+\eta}(\tau) d\tau \leq \frac{1}{C} R^{\eta}(0) R(t), \quad \text{for all} \quad t \geq 0.$$

Then, R satisfies the following decay estimates:

- 1) Exponential decay ($\eta = 0$): If $\eta = 0$, then $R(t) \le R(0)e^{1-Ct}$ for all $t \ge 0$.
- 2) **Polynomial decay** ($\eta > 0$): If $\eta > 0$, then $R(t) \le R(0) \left(\frac{1+\eta}{1+nCt}\right)^{1/\eta}$, for all $t \ge 0$.

3. Potential well theory

Lemma 3.1. For every $\eta > 0$, we get that

- (i) $\log(t) \le \frac{t^{\eta}}{\eta \exp(1)}$, for all $t \in (1, \infty)$.
- (ii) $t^{\eta} |\log(t)| \le \frac{1}{\eta} \frac{1}{\exp(1)}$, for all $t \in (0, 1]$.

Proof. Setting the function

$$g(t) = \left(\log(t) - \frac{t^{\eta}}{\eta \exp(1)}\right) \mathbf{1}_{(1,+\infty)},$$

where $\mathbf{1}_{(1,+\infty)}$ is an indicatrice function. It is evident that we prove that the function g achieves its maximum at $t_* =$ $\exp\left(\frac{1}{\eta}\right)$. Thus, $g(t) \leq g(t_*)$, for all $t \geq 1$. Now, we prove (ii). Considering that $t \to t^{\eta} |\log(t)|$ is a continuous on (0,1]with $\lim_{t\to 0} t^{\eta} |\log(t)| = 0$, which achieves the maximum at $t_* = \exp\left(-\frac{1}{n}\right)$, we can easily conclude. This completes the proof.

Henceforward, Y denotes the Cartesian product of two fractional Sobolev speaes $W^{s,p}(\mathcal{U})$ and $W^{s,q}(\mathcal{U})$, that is $Y = W^{s,p}(\mathcal{U}) \times W^{s,q}(\mathcal{U})$ equipped with the norm $\|(\mathfrak{u},\mathfrak{v})\|_Y = \|\mathfrak{u}\|_{W^{s,p}(\mathcal{U})} + \|\mathfrak{v}\|_{W^{s,q}(\mathcal{U})}$.

3.1. Potential well

In this section, we introduce several key lemmas that play a crucial role in establishing our main results.

Lemma 3.2. Under assumptions (\mathcal{H}_1) – (\mathcal{H}_2) , the following assertions hold:

- (1) $\mu^{\beta} \mathcal{K}(t) \leq \mathcal{K}(\mu t)$, for all $0 \leq \mu \leq 1, z \geq 0$.
- (2) $\mathcal{K}(\mu z) \leq \mu^{\beta} \mathcal{K}(z)$, for all $\mu \geq 1, z \geq 0$. (3) $\frac{\mathcal{K}(\mu)}{\mu^{\beta}} \min \left\{ \mu^{\beta}, z^{\beta} \right\} \leq \mathcal{K}(z) \leq \frac{\mathcal{K}(\mu)}{\mu^{\beta}} \max \left\{ \mu^{\beta}, z^{\beta} \right\}$.
- (4) $\mathcal{K}(z) > 0$, for all z > 0.
- (5) $\frac{1}{\beta+1}z\mathcal{K}(z) \leq \widehat{\mathcal{K}}(\mu z) \leq t\mathcal{K}(z)$, for all $z \geq 0$.
- (6) $\widehat{\mathcal{K}}(\mu z) \ge \mu^{\beta+1} \widehat{\mathcal{K}}(z)$, for all $0 \le \mu \le 1, z \ge 0$.
- (7) $\widehat{\mathcal{K}}(\mu z) \leq \mu^{\beta+1} \widehat{\mathcal{K}}(z)$, for all $\mu \geq 1, z \geq 0$.

Proof. Let $\mu \in (0, 1)$ and z > 0. Applying the condition (\mathcal{H}_2) . Then, we have

$$\frac{\mathcal{K}(z)}{z^{\beta}} \le \frac{\mathcal{K}(\mu z)}{(\mu z)^{\beta}}.$$

Clearly, we have (1). Identically, we establish (2). Combining (1) and (2) with condition (\mathcal{H}_1), we obtain (3). From (3) and the fact that $\mathcal{K} \neq 0$, we get (4). Since \mathcal{K} is non-decreasing, it follows that

$$\widehat{\mathcal{K}}(z) = \int_0^z \mathcal{K}(t)dt \le \int_0^z \mathcal{K}(z)dt = z\mathcal{K}(z).$$

Applying the condition (\mathcal{H}_2) , we get that

$$\widehat{\mathcal{K}}(z) = \int_0^z \frac{\mathcal{K}(t)}{t^{\beta}} t^{\beta} dt \ge \int_0^z \frac{\mathcal{K}(z)}{z^{\beta}} t^{\beta} dt = \frac{1}{\beta + 1} z \mathcal{K}(z).$$

Let $\mu \in [0, 1]$, we get that

$$\widehat{\mathcal{K}}(\mu z) = \int_0^{\mu z} \mathcal{K}(t) dt = \int_0^z \mu \mathcal{K}(\mu t) dt \ge \mu^{\beta + 1} \int_0^z \mathcal{K}(t) dt = \mu^{\beta + 1} \widehat{\mathcal{K}}(z).$$

Let us define the energy functional $\varphi:W^{s,p}(\mathcal{U})\to\mathbb{R}$ and Nehari functional $\psi:W^{s,p}(\mathcal{U})\to\mathbb{R}$ by:

$$\varphi(\mathfrak{u},\mathfrak{v}):=\frac{1}{p}\widehat{\mathcal{K}}\left([\mathfrak{u}]_p^s\right)+\frac{1}{q}\widehat{\mathcal{K}}\left([\mathfrak{v}]_q^s\right)+\frac{1}{\sigma^2}\int_{\mathcal{U}}|\mathfrak{u}|^\sigma|\mathfrak{v}|^\sigma\mathrm{d}\mathbf{x}-\frac{1}{\sigma}\int_{\mathcal{U}}|\mathfrak{u}|^\sigma|\mathfrak{v}|^\sigma\log|\mathfrak{u}\mathfrak{v}|\mathrm{d}\mathbf{x},$$

and

$$\psi(\mathfrak{u},\mathfrak{v}) := \mathcal{K}\left([\mathfrak{u}]_p^s\right) \int_{\mathcal{U} \times \mathcal{U}} \frac{|\mathfrak{u}(x) - \mathfrak{u}(y)|^p}{|x - y|^{N + sp}} \mathrm{d}x \mathrm{d}y + \mathcal{K}\left([\mathfrak{v}]_q^s\right) \int_{\mathcal{U} \times \mathcal{U}} \frac{|\mathfrak{v}(x) - \mathfrak{v}(y)|^q}{|x - y|^{N + sq}} \mathrm{d}x \mathrm{d}y - 2 \int_{\mathcal{U}} |\mathfrak{u}|^{\sigma + 1} |\mathfrak{v}|^{\sigma + 1} \log |\mathfrak{u}\mathfrak{v}| \mathrm{d}x.$$

Lemma 3.3. Let $(\mathfrak{u}, \mathfrak{v}) \in W^{s,p}(\mathcal{U}) \times W^{s,q}(\mathcal{U})$. Then, we have the following inequality:

$$\int_{\mathcal{U}} |\mathfrak{u}|^{\sigma} |\mathfrak{v}|^{\sigma} \log |\mathfrak{u} \mathbf{v}| d\mathbf{x} \leq \log [\mathfrak{u}]_{s,p} \int_{\mathcal{U}} |\mathfrak{u}(\mathbf{x})|^{\sigma} d\mathbf{x} + \log [\mathfrak{v}]_{s,q} \int_{\mathcal{U}} |\mathfrak{v}(\mathbf{x})|^{\sigma} d\mathbf{x} + S \left([\mathfrak{u}]_{s,p}^{p_{s}^{*}} + [\mathfrak{v}]_{s,p}^{p_{s}^{*}} + [\mathfrak{u}]_{s,q}^{q_{s}^{*}} + [\mathfrak{v}]_{s,q}^{\sigma} + [\mathfrak{v}]_{s,q}^{\sigma} \right).$$

Proof. Let $(\mathfrak{u}, \mathfrak{v}) \in W^{s,p}(\mathcal{U}) \times W^{s,q}(\mathcal{U}) \setminus \{(0,0)\}.$

$$\begin{split} \int_{\mathcal{U}} |\mathfrak{u}|^{\sigma} |\mathfrak{v}|^{\sigma} \log |\mathfrak{u}\mathfrak{v}| \mathrm{d} x & \leq \int_{\mathcal{U}} |\mathfrak{u}|^{\sigma} |\mathfrak{v}|^{\sigma} |\log |uv| \mathrm{d} x \\ & \leq \int_{\mathcal{U}} \frac{|\mathfrak{u}|^{2\sigma} + |\mathfrak{v}|^{2\sigma}}{2} (|\log |u|| + |\log |v||) \mathrm{d} x \\ & \leq 2^{\sigma-2} \Biggl(\int_{\mathcal{U}} |\mathfrak{u}|^{2\sigma} |\log |u|| + \int_{\mathcal{U}} |\mathfrak{u}|^{2\sigma} |\log |v|| + \int_{\mathcal{U}} |\mathfrak{v}|^{2\sigma} |\log |\mathfrak{u}| \left| + \int_{\mathcal{U}} \left| v \right|^{2\sigma} |\log |\mathfrak{v}| \right| \right) \mathrm{d} x \\ & = 2^{\sigma-2} \left(I_1 + I_2 + I_3 + I_4 \right). \end{split}$$

Now, we calculate the integrals I_i , for all $i \in \{1, 2, 3, 4\}$. Set $\mathcal{U}_1 := \{x \in \mathcal{U} : |\mathfrak{u}(x)| \le [\mathfrak{u}]_{s,p}\}$ and $\mathcal{U}_2 := \{x \in \mathcal{U} : |\mathfrak{u}(x)| > [\mathfrak{u}]_{s,p}\}$. It is easy to see that $\mathcal{U} = \mathcal{U}_1 \cup \mathcal{U}_2$ and $\mathcal{U}_1 \cap \mathcal{U}_2 = \emptyset$. So, we get that

$$\int_{\mathcal{U}} |\mathfrak{u}|^{\sigma} \left| \log \frac{\mathfrak{u}(x)}{[\mathfrak{u}]_{s,p}} \right| dx = \int_{\mathcal{U}_1} |\mathfrak{u}|^{\sigma} \left| \log \frac{\mathfrak{u}(x)}{[\mathfrak{u}]_{s,p}} \right| dx + \int_{\mathcal{U}_2} |\mathfrak{u}|^{\sigma} \left| \log \frac{\mathfrak{u}(x)}{[\mathfrak{u}]_{s,p}} \right| dx.$$

Using Lemma 3.1, we deduce that

$$\int_{\mathcal{U}_{1}} |\mathfrak{u}|^{\sigma} \left| \log \frac{u(x)}{[\mathfrak{u}]_{s,p}} \right| dx = [\mathfrak{u}]_{s,p}^{\sigma} \int_{\mathcal{U}_{1}} \left| \frac{u(x)}{[\mathfrak{u}]_{s,p}} \right|^{\sigma} \left| \log \frac{u(x)}{[\mathfrak{u}]_{s,p}} \right| dx$$

$$\leq \frac{2^{\sigma-2} [\mathfrak{u}]_{s,p}^{\sigma}}{\sigma \exp(1)}$$
(6)

From Lemma 3.1 with $\eta = p_s^* - \sigma$ and fractional Sobolev embedding inequality, we obtain that

$$\int_{U_{2}} |\mathfrak{u}|^{\sigma} \left| \log \frac{\mathfrak{u}(x)}{[\mathfrak{u}]_{s,p}} \right| dx \leq \frac{2^{\sigma}}{\exp(p_{s}^{*} - \sigma)[\mathfrak{u}]_{s,p}^{p_{s}^{*} - \sigma}} \int_{\mathcal{U}} |\mathfrak{u}|^{p_{s}^{*}} dx \\
\leq \frac{2^{\sigma}}{\exp(p_{s}^{*} - \sigma)[\mathfrak{u}]_{s,p}^{p_{s}^{*} - \sigma}} S_{p_{s}^{*}}^{p_{s}^{*}} [\mathfrak{u}]_{s,p}^{\sigma}, \tag{7}$$

with $S_{p_x^*}$ is the best constant of embedding from $W^{s,p}(\mathcal{U})$ to $L^{p_x^*}(\mathcal{U})$. From (6) and (7) follow that

$$\int_{\mathcal{U}} |\mathfrak{u}|^{\sigma} \left| \log \frac{\mathfrak{u}(x)}{[\mathfrak{u}]_{s,p}} \right| dx \le \left(\frac{|\mathcal{U}|}{\sigma \exp(1)} + \frac{S_{p_x}^{p_x^*}}{\exp(p_x^* - \sigma)} \right) [\mathfrak{u}]_{s,p}^{\sigma}. \tag{8}$$

Using (8), we deduce that

$$\begin{split} \int_{\mathcal{U}} |\mathfrak{u}|^{\sigma} |\log |\mathfrak{u}(\mathbf{x})| |\mathrm{d}\mathbf{x} &= \int_{\mathcal{U}} |\mathfrak{u}|^{\sigma} \left|\log \frac{|\mathfrak{u}(\mathbf{x})|}{[\mathfrak{u}]_{s,p}}\right| + \log[\mathfrak{u}]_{s,p} \int_{\mathcal{U}} |\mathfrak{u}|^{\sigma} \mathrm{d}\mathbf{x} \\ &\leq \left(\frac{|\mathcal{U}|}{\sigma \exp(1)} + \frac{S\frac{p_{x}^{*}}{p_{x}^{*}}}{\exp\left(p_{s}^{*} - \sigma\right)}\right) [\mathfrak{u}]_{s,p}^{\sigma} + \log[\mathfrak{u}]_{s,p} \int_{\mathcal{U}} |\mathfrak{u}|^{\sigma} \mathrm{d}\mathbf{x}. \end{split}$$

Similarly, we prove that

$$\int_{\mathcal{U}} |\mathfrak{v}|^{\sigma} |\log |\mathfrak{v}(\mathbf{x})| |\mathrm{d}\mathbf{x}| \leq \left(\frac{|\mathcal{U}|}{\sigma \exp(1)} + \frac{S_{q_s^*}^{q_s^*}}{\exp(q_s^* - \sigma)} \right) [\mathfrak{v}]_{s,q}^{\sigma\sigma} + \log[\mathfrak{v}]_{s,q} \int_{\mathcal{U}} |\mathfrak{v}|^{\sigma} \mathrm{d}\mathbf{x}$$

Now, we estimate I_3 . It is easy to show that $\log x \le x - 1$, for all x > 0. remembering the numerical inequality

$$ab \le \frac{a^2 + b^2}{2} \le a^2 + b^2$$
, for all $(a, b) \in \mathbb{R}^+ \times \mathbb{R}^+$.

Using this inequality, we obtain that

$$\begin{split} \int_{\mathcal{U}} |\mathfrak{u}^{\sigma}| \log |\mathfrak{v}(\mathbf{x})| \mathrm{d}\mathbf{x} &\leq \int_{\mathcal{U}} |\mathfrak{u}(\mathbf{x})|^{\sigma} (|\mathbf{v}(\mathbf{x})| - 1) \mathrm{d}\mathbf{x} \\ &\leq \int_{\mathcal{U}} |\mathfrak{u}(\mathbf{x})|^{\sigma} |\mathfrak{v}(\mathbf{x})| + \int_{\mathcal{U}} |\mathfrak{u}(\mathbf{x})|^{\sigma} \mathrm{d}\mathbf{x} \\ &\leq \int_{\mathcal{U}} \left(|\mathfrak{u}(\mathbf{x})|^{2\sigma} + |\mathfrak{v}(\mathbf{x})|^{2} + |\mathfrak{u}(\mathbf{x})|^{\sigma} \right) \mathrm{d}\mathbf{x} \\ &\leq C(\sigma, \mathcal{U}) \int_{\mathcal{U}} \left(|\mathfrak{u}(\mathbf{x})|^{p_{x}^{*}} + |\mathfrak{v}(\mathbf{x})|^{p_{x}^{*}} + |\mathfrak{u}(\mathbf{x})|^{p_{x}^{*}} \right) \mathrm{d}\mathbf{x} \\ &\leq C(\sigma, \mathcal{U}, p, s) S_{p_{x}^{*}}^{p_{x}^{*}} \left(|\mathfrak{u}|_{s,p}^{p_{x}^{*}} + [\mathfrak{v}|_{s,p}^{p_{x}^{*}}) \right). \end{split}$$

Similarly, we prove that

$$\int_{\mathcal{U}} |\mathfrak{v}(\mathbf{x})|^{\sigma} |\log |\mathfrak{u}(\mathbf{x})| \, \mathrm{d}\mathbf{x} \le C(\sigma, \mathcal{U}, q, s) S_{q_s^*}^{q_s^*} \left([\mathfrak{u}]_{s,q}^{q_s^*} + [\mathfrak{v}]_{s,q}^{q_s^*} \right). \tag{9}$$

Using (8)- (9), we deduce that

$$\int_{\mathcal{U}} |\mathfrak{u}|^{\sigma} |\mathfrak{v}|^{\sigma} \log |\mathfrak{u} v| \mathrm{d} x \leq \log [\mathfrak{u}]_{s,p} \int_{\mathcal{U}} |\mathfrak{u}(x)|^{\sigma} \mathrm{d} x + \log [\mathfrak{v}]_{s,q} \int_{\mathcal{U}} |\mathfrak{v}(x)|^{\sigma} \mathrm{d} x + S \left([\mathfrak{u}]_{s,p}^{p_s^*} + [\mathfrak{v}]_{s,p}^{p_s^*} + [\mathfrak{u}]_{s,q}^{q_s^*} + [\mathfrak{u}]_{s,p}^{\sigma} + [\mathfrak{u}]_{s,q}^{\sigma} \right),$$

$$\text{where } S := \max \left\{ C(\sigma, \mathcal{U}, q, s) S_{q_s^*}^{q_x^*}, C(\sigma, \mathcal{U}, p, s) S_{p_s^*}^{p_t^*}, \frac{|\mathcal{U}|}{\sigma \exp(1)} + \frac{s_{\psi_t^*}^{q_s^*}}{\exp(q_s^* - \sigma)}, \frac{|\mathcal{U}|}{\sigma \exp(1)} + \frac{s_{p_t^*}^{p_t^*}}{\exp(p_s^* - \sigma)} \right\}. \quad \Box$$

Lemma 3.4. Let (\mathcal{H}_1) – (\mathcal{H}_2) holds and $(u, v) \in W^{s,p}(\mathcal{U}) \times W^{s,q}(\mathcal{U}) \setminus \{(0, 0)\}$. Then following results hold.

- (1) There exists a unique constant $\varepsilon_* > 0$ such that $\psi(\varepsilon u, \varepsilon v) > 0$ for all $0 < \varepsilon < \varepsilon_*, \psi(\varepsilon_* v, \varepsilon_* v) = 0$, and $\psi(\varepsilon u, \varepsilon v) < 0$ for all $\varepsilon > \varepsilon_*$.
- (2) The function $\varepsilon \mapsto \varphi(\varepsilon u, \varepsilon v)$ strictly decreasing on (ε_*, ∞) , and it is strictly increasing on $(0, \varepsilon_*)$. Furthermore, we have $\lim_{\varepsilon \to 0^*} \varphi(\varepsilon u, \varepsilon v) = 0$, and $\lim_{\varepsilon \to +\infty} \varphi(\varepsilon u, \varepsilon v) = -\infty$.

Proof. For (1). From (2) in Lemma 3.2, we have, for all $\varepsilon > 1$,

$$\begin{split} &\psi(\varepsilon\mathfrak{u},\varepsilon\mathfrak{v})=\mathcal{K}\left(\left[\varepsilon\mathfrak{u}\right]_{p}^{s}\right)\int_{\mathcal{U}\times\mathcal{U}}\frac{\varepsilon^{p}|\mathfrak{u}(\mathbf{x})-\mathfrak{u}(\mathbf{y})|^{p}}{|\mathbf{x}-\mathbf{y}|^{N+sp}}\mathrm{d}\mathbf{x}\mathrm{d}\mathbf{y}+\mathcal{K}\left(\left[\varepsilon\mathfrak{v}\right]_{q}^{s}\right)\int_{\mathcal{U}\times\mathcal{U}}\frac{\varepsilon^{q}|\mathfrak{v}(\mathbf{x})-\mathfrak{v}(\mathbf{y})|^{q}}{|\mathbf{x}-\mathbf{y}|^{N+sq}}\mathrm{d}\mathbf{x}\mathrm{d}\mathbf{y}-\varepsilon^{2\sigma+2}\int_{\mathcal{U}}|\mathfrak{u}\mathbf{v}|^{\sigma+1}\log\left|\varepsilon^{2}\mathfrak{u}\mathbf{v}\right|\mathrm{d}\mathbf{x}\\ &\leq\varepsilon^{P(\beta+1)}\mathcal{K}\left(\left[\mathfrak{u}\right]_{p}^{s}\right)\int_{\mathcal{U}\times\mathcal{U}}\frac{|\mathfrak{u}(\mathbf{x})-\mathfrak{u}(\mathbf{y})|^{p}}{|\mathbf{x}-\mathbf{y}|^{N+sp}}\mathrm{d}\mathbf{x}\mathrm{d}\mathbf{y}+\varepsilon^{q(\beta+1)}\mathcal{K}\left(\left[\mathfrak{v}\right]_{q}^{s}\right)\int_{\mathcal{U}\times\mathcal{U}}\frac{|\mathfrak{v}(\mathbf{x})-\mathfrak{v}(\mathbf{y})|^{q}}{|\mathbf{x}-\mathbf{y}|^{N+sq}}\mathrm{d}\mathbf{x}\mathrm{d}\mathbf{y}-\varepsilon^{2\sigma+2}\int_{\mathcal{U}}|\mathfrak{u}\mathbf{v}|^{\sigma+1}\log\left|\varepsilon^{2}\mathfrak{u}\mathbf{v}\right|\mathrm{d}\mathbf{x}\\ &\leq\varepsilon^{\eta}\left[\mathcal{K}\left(\left[\mathfrak{u}\right]_{p}^{s}\right)\int_{\mathcal{U}\times\mathcal{U}}\frac{|\mathfrak{u}(\mathbf{x})-\mathfrak{u}(\mathbf{y})|^{p}}{|\mathbf{x}-\mathbf{y}|^{N+sp}}\mathrm{d}\mathbf{x}\mathrm{d}\mathbf{y}+\mathcal{K}\left(\left[\mathfrak{v}\right]_{q}^{s}\right)\int_{\mathcal{U}\times\mathcal{U}}\frac{|\mathfrak{v}(\mathbf{x})-\mathfrak{v}(\mathbf{y})|^{q}}{|\mathbf{x}-\mathbf{y}|^{N+sq}}\mathrm{d}\mathbf{x}\mathrm{d}\mathbf{y}\right]-\varepsilon^{2\sigma+2}\int_{\mathcal{U}}|\mathfrak{u}\mathbf{v}|^{\sigma+1}\log\left|\varepsilon^{2}\mathfrak{u}\mathbf{v}\right|\mathrm{d}\mathbf{x}, \end{split}$$

where $\eta := \max(p(\beta + 1), q(\beta + 1))$. Due to $\eta < 2(\sigma + 1)$, we have that

$$\lim_{\varepsilon \to \infty} \psi(\varepsilon \mathfrak{u}, \varepsilon \mathfrak{v}) = -\infty. \tag{10}$$

Using (i) in Lemma 3.2, for any $\varepsilon \in (0, 1)$, we obtain that

$$\begin{split} &\psi(\varepsilon\mathfrak{u},\varepsilon\mathfrak{v})=\mathcal{K}\left(\left[\varepsilon\mathfrak{u}\right]_{p}^{s}\right)\int_{\mathcal{U}\times\mathcal{U}}\frac{\varepsilon^{p}|\mathfrak{u}(\mathbf{x})-\mathfrak{u}(\mathbf{y})|^{p}}{|\mathbf{x}-\mathbf{y}|^{N+sp}}\mathrm{d}\mathbf{x}\mathrm{d}\mathbf{y}+\mathcal{K}\left(\left[\varepsilon\mathfrak{v}\right]_{q}^{s}\right)\int_{\mathcal{U}\times\mathcal{U}}\frac{\varepsilon^{q}|\mathfrak{v}(\mathbf{x})-\mathfrak{v}(\mathbf{y})|^{q}}{|\mathbf{x}-\mathbf{y}|^{N+sq}}\mathrm{d}\mathbf{x}\mathrm{d}\mathbf{y}-\varepsilon^{2\sigma+2}\int_{\mathcal{U}}|\mathfrak{u}\mathbf{v}|^{\sigma+1}\log\left|\varepsilon^{2}\mathfrak{u}\mathbf{v}\right|\mathrm{d}\mathbf{x}\\ &\geq\varepsilon^{p(\beta+1)}\mathcal{K}\left(\left[\mathfrak{u}\right]_{p}^{s}\right)\int_{\mathcal{U}\times\mathcal{U}}\frac{|\mathfrak{u}(\mathbf{x})-\mathfrak{u}(\mathbf{y})|^{p}}{|\mathbf{x}-\mathbf{y}|^{N+sp}}\mathrm{d}\mathbf{x}\mathrm{d}\mathbf{y}+\varepsilon^{q(\beta+1)}\mathcal{K}\left(\left[\mathfrak{v}\right]_{q}^{s}\right)\int_{\mathcal{U}\times\mathcal{U}}\frac{|\mathfrak{v}(\mathbf{x})-\mathfrak{v}(\mathbf{y})|^{q}}{|\mathbf{x}-\mathbf{y}|^{N+sq}}\mathrm{d}\mathbf{x}\mathrm{d}\mathbf{y}-\varepsilon^{2\sigma+2}\int_{\mathcal{U}}|\mathfrak{u}\mathbf{v}|^{\sigma+1}\log\left|\varepsilon^{2}\mathfrak{u}\mathbf{v}\right|\mathrm{d}\mathbf{x}\\ &\geq\varepsilon^{\eta}\left[\mathcal{K}\left(\left[\mathfrak{u}\right]_{p}^{s}\right)\int_{\mathcal{U}\times\mathcal{U}}\frac{|\mathfrak{u}(\mathbf{x})-\mathfrak{u}(\mathbf{y})|^{p}}{|\mathbf{x}-\mathbf{y}|^{N+sp}}\mathrm{d}\mathbf{x}\mathrm{d}\mathbf{y}+\mathcal{K}\left(\left[\mathfrak{v}\right]_{q}^{s}\right)\int_{\mathcal{U}\times\mathcal{U}}\frac{|\mathfrak{v}(\mathbf{x})-\mathfrak{v}(\mathbf{y})|^{q}}{|\mathbf{x}-\mathbf{y}|^{N+sq}}\mathrm{d}\mathbf{x}\mathrm{d}\mathbf{y}\right]-\varepsilon^{2\sigma+2}\int_{\mathcal{U}}|\mathfrak{u}\mathbf{v}|^{\sigma+1}\log\left|\varepsilon^{2}\mathfrak{u}\mathbf{v}\right|\mathrm{d}\mathbf{x}, \end{split}$$

where $\rho := \min\{q(\beta+1), p(\beta+1)\}$, which yields that $\psi(\varepsilon\mathfrak{u}, \varepsilon\mathfrak{v}) > 0$, for all $0 < \varepsilon < 1$. Thanks to the intermediate value theorem and (10), there exists a $\varepsilon_* > 0$ such that $\psi(\varepsilon_*\mathfrak{u}, \varepsilon_*\mathfrak{v}) = 0$. For any $\varepsilon > \varepsilon_*$, we get that $\frac{\varepsilon}{\varepsilon_*} > 1$. Using (2) in Lemma 3.2, we obtain that

$$\begin{split} &\psi(\varepsilon\mathbf{u},\varepsilon\mathbf{v}) = \mathcal{K}\left([\varepsilon\mathbf{u}]_p^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon^p |\mathbf{u}(\mathbf{x}) - \mathbf{u}(\mathbf{y})|^p}{|\mathbf{x} - \mathbf{y}|^{N+sp}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} + \mathcal{K}\left([\varepsilon\mathbf{v}]_q^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon^q |\mathbf{v}(\mathbf{x}) - \mathbf{v}(\mathbf{y})|^q}{|\mathbf{x} - \mathbf{y}|^{N+sq}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} - \varepsilon^{2\sigma+2} \int_{\mathcal{U}} |\mathbf{u}\mathbf{v}|^{\sigma+1} \log \left| \varepsilon^2 \mathbf{u}\mathbf{v} \right| \mathrm{d}\mathbf{x} \\ &= \mathcal{K}\left(\frac{\varepsilon}{\varepsilon_*}\right)^p \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^p |\mathbf{u}(\mathbf{x}) - \mathbf{u}(\mathbf{y})|^p}{|\mathbf{x} - \mathbf{y}|^{N+sp}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y}\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^p |\mathbf{u}(\mathbf{x}) - \mathbf{u}(\mathbf{y})|^p}{|\mathbf{x} - \mathbf{y}|^{N+sp}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} \\ &+ \mathcal{K}\left(\frac{\varepsilon}{\varepsilon_*}\right)^q \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^q |\mathbf{v}(\mathbf{x}) - \mathbf{v}(\mathbf{y})|^q}{|\mathbf{x} - \mathbf{y}|^{N+sq}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y}\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^q |\mathbf{v}(\mathbf{x}) - \mathbf{v}(\mathbf{y})|^q}{|\mathbf{x} - \mathbf{y}|^{N+sq}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} \\ &- \left(\frac{\varepsilon}{\varepsilon_*}\right)^{2\sigma+2} \int_{\mathcal{U}} |\varepsilon_*\mathbf{u}|^{\sigma+1} |\varepsilon_*\mathbf{v}|^{\sigma+1} \log \left| \varepsilon_*^2 \mathbf{u}\mathbf{v} \right| \left(\frac{\varepsilon}{\varepsilon_*}\right)^2 \right| \mathrm{d}\mathbf{x} \\ &\leq \left(\frac{\varepsilon}{\varepsilon_*}\right)^{p(\beta+1)} \mathcal{K}\left([\varepsilon_*\mathbf{u}]_p^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^p |\mathbf{u}(\mathbf{x}) - \mathbf{u}(\mathbf{y})|^p}{|\mathbf{x} - \mathbf{y}|^{N+sp}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} + \left(\frac{\varepsilon}{\varepsilon_*}\right)^{q(\beta+1)} \mathcal{K}\left([\varepsilon_*\mathbf{v}]_q^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^q |\mathbf{v}(\mathbf{x}) - \mathbf{v}(\mathbf{y})|^q}{|\mathbf{x} - \mathbf{y}|^{N+sq}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} \\ &\leq \left(\frac{\varepsilon}{\varepsilon_*}\right)^{\delta} \left[\mathcal{K}\left([\varepsilon_*\mathbf{u}]_p^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^p |\mathbf{u}(\mathbf{x}) - \mathbf{u}(\mathbf{y})|^p}{|\mathbf{x} - \mathbf{y}|^{N+sp}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} + \mathcal{K}\left([\varepsilon_*\mathbf{v}]_q^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^q |\mathbf{u}(\mathbf{x}) - \mathbf{v}(\mathbf{y})|^q}{|\mathbf{x} - \mathbf{y}|^{N+sq}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} \right] \\ &- \left(\frac{\varepsilon}{\varepsilon_*}\right)^{\delta} \left[\mathcal{K}\left([\varepsilon_*\mathbf{u}]_p^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^p |\mathbf{u}(\mathbf{x}) - \mathbf{u}(\mathbf{y})|^p}{|\mathbf{x} - \mathbf{y}|^{N+sp}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} + \mathcal{K}\left([\varepsilon_*\mathbf{v}]_q^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^q |\mathbf{u}(\mathbf{x}) - \mathbf{v}(\mathbf{y})|^q}{|\mathbf{x} - \mathbf{y}|^{N+sq}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} \right] \\ &- \left(\frac{\varepsilon}{\varepsilon_*}\right)^{\delta} \left[\mathcal{K}\left([\varepsilon_*\mathbf{v}]_p^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^p |\mathbf{u}(\mathbf{v}) - \mathbf{u}(\mathbf{v})|^p}{|\mathbf{v} - \mathbf{v}(\mathbf{v})|^p} \mathrm{d}\mathbf{v} + \mathcal{K}\left([\varepsilon_*\mathbf{v}]_q^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^q |\mathbf{v}|^p}{|\mathbf{v} - \mathbf{v}(\mathbf{v})|^q} \mathrm{d}\mathbf{v} \mathrm{d}\mathbf{v} \right] \\ &- \left(\frac{\varepsilon}{\varepsilon_*}\right)^{\delta} \left[\mathcal{K}\left([\varepsilon_*\mathbf{v}]_p^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^p |\mathbf{v}|^p}{|\mathbf{v} - \mathbf{v}|^p} \mathrm{d}\mathbf{v} + \mathcal{K}\left([\varepsilon_*\mathbf{v}]_p^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^q |\mathbf{v}|^p}{|\mathbf{v} - \mathbf{v}|^p}} \mathrm$$

where $\delta := \max\{p(\beta+1), q(\beta+1)\}$. Since $\frac{\varepsilon}{\varepsilon_*} > 1$ and $\delta < 2(\sigma+1)$, we get that $\psi(\varepsilon \mathfrak{u}, \varepsilon \mathfrak{v}) < 0$. Similarly, for any $0 < \varepsilon < \varepsilon_*$. Using (i) in Lemma 3.2, we get that

$$\begin{split} &\psi(\varepsilon\mathbf{u},\varepsilon\mathbf{v}) = \mathcal{K}\left([\varepsilon\mathbf{u}]_p^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon^p |\mathbf{u}(\mathbf{x}) - \mathbf{u}(\mathbf{y})|^p}{|\mathbf{x} - \mathbf{y}|^{N+sp}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} + \mathcal{K}\left([\varepsilon\mathbf{v}]_q^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon^q |\mathbf{v}(\mathbf{x}) - \mathbf{v}(\mathbf{y})|^q}{|\mathbf{x} - \mathbf{y}|^{N+sq}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} - \varepsilon^{2\sigma+2} \int_{\mathcal{U}} |\mathbf{u}\mathbf{v}|^{\sigma+1} \log |\varepsilon^2 \mathbf{u}\mathbf{v}| \, \mathrm{d}\mathbf{x} \\ &= \mathcal{K}\left(\frac{\varepsilon}{\varepsilon_*}\right)^p \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^p |\mathbf{u}(\mathbf{x}) - \mathbf{u}(\mathbf{y})|^p}{|\mathbf{x} - \mathbf{y}|^{N+sp}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y}\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon}{\varepsilon_*} \frac{\varepsilon_*^p |\mathbf{u}(\mathbf{x}) - \mathbf{u}(\mathbf{y})|^p}{|\mathbf{x} - \mathbf{y}|^{N+sp}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} \\ &+ \mathcal{K}\left(\frac{\varepsilon}{\varepsilon_*}\right)^q \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^q |\mathbf{v}(\mathbf{x}) - \mathbf{v}(\mathbf{y})|^q}{|\mathbf{x} - \mathbf{y}|^{N+sq}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y}\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon}{\varepsilon_*} \frac{\varepsilon_*^q |\mathbf{v}(\mathbf{x}) - \mathbf{v}(\mathbf{y})|^q}{|\mathbf{x} - \mathbf{y}|^{N+sq}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} \\ &- \left(\frac{\varepsilon}{\varepsilon_*}\right)^{2\sigma+2} \int_{\mathcal{U}} |\varepsilon_*\mathbf{u}|^{\sigma+1} |\varepsilon_*\mathbf{v}|^{\sigma+1} \log \left|\varepsilon_*^2\mathbf{v}\left(\frac{\varepsilon}{\varepsilon_*}\right)^2\right| \mathrm{d}\mathbf{x} \\ &\geq \left(\frac{\varepsilon}{\varepsilon_*}\right)^{p(\beta+1)} \mathcal{K}\left([\varepsilon_*\mathbf{u}]_p^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^p |\mathbf{u}(\mathbf{x}) - \mathbf{u}(\mathbf{y})|^p}{|\mathbf{x} - \mathbf{y}|^{N+sp}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} + \left(\frac{\varepsilon}{\varepsilon_*}\right)^{q(\beta+1)} \mathcal{K}\left([\varepsilon_*\mathbf{v}]_q^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^q |\mathbf{v}(\mathbf{x}) - \mathbf{v}(\mathbf{y})|^q}{|\mathbf{x} - \mathbf{y}|^{N+sq}} \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} \\ &\geq \left(\frac{\varepsilon}{\varepsilon_*}\right)^{2\sigma+2} \int_{\mathcal{U}} |\varepsilon_*\mathbf{u}|^{\sigma+1} |\varepsilon_*\mathbf{v}|^{\sigma+1} \log |\varepsilon_*^2\mathbf{u}| \, \mathrm{d}\mathbf{x} \\ &\geq \left(\frac{\varepsilon}{\varepsilon_*}\right)^\mu \left[\mathcal{K}\left([\varepsilon_*\mathbf{u}]_p^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^p |\mathbf{u}(\mathbf{x}) - \mathbf{u}(\mathbf{y})|^p}{|\mathbf{x} - \mathbf{y}|^{N+sp}} \, \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} + \mathcal{K}\left([\varepsilon_*\mathbf{v}]_q^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{\varepsilon_*^q |\mathbf{v}(\mathbf{v}) - \mathbf{v}(\mathbf{v})|^q}{|\mathbf{x} - \mathbf{y}|^{N+sq}} \, \mathrm{d}\mathbf{x} \mathrm{d}\mathbf{y} \right] \\ &- \left(\frac{\varepsilon}{\varepsilon_*}\right)^{2\sigma+2} \int_{\mathcal{U}} |\varepsilon_*\mathbf{u}|^{\sigma+1} |\varepsilon_*\mathbf{v}|^{\sigma+1} \log |\varepsilon_*^2\mathbf{u}| \, \mathrm{d}\mathbf{x} \\ &\geq \left(\frac{\varepsilon}{\varepsilon_*}\right)^\mu - \left(\frac{\varepsilon}{\varepsilon_*}\right)^{2\sigma+2} \int_{\mathcal{U}} |\varepsilon_*\mathbf{u}|^{\sigma+1} |\varepsilon_*\mathbf{v}|^{\sigma+1} \log |\varepsilon_*^2\mathbf{v}| \, \mathrm{d}\mathbf{x} + \left(\frac{\varepsilon}{\varepsilon_*}\right)^\mu \psi (\varepsilon_*\mathbf{u}, \varepsilon_*\mathbf{v}) \, , \end{split}$$

with $\mu := \min\{p(\beta+1), q(\beta+1)\}$. Since $\frac{\varepsilon}{\varepsilon_t} < 1$ and $\mu < 2(\sigma+1)$, we get that $\psi(\varepsilon \mathfrak{u}, \varepsilon \mathfrak{v}) > 0$. Now, we prove (2). According to the definition of φ , we get that

$$\varphi(\varepsilon\mathfrak{u},\varepsilon\mathfrak{v}) = \frac{1}{p}\widehat{\mathcal{K}}\left(\left[\varepsilon\mathfrak{u}\right]_p^s\right) + \frac{1}{q}\widehat{\mathcal{K}}\left(\left[\varepsilon\mathfrak{v}\right]_q^s\right) + \frac{1}{\sigma^2}\int_{\mathcal{U}} \left|\varepsilon\mathfrak{u}\right|^{\sigma} \left|\varepsilon\mathfrak{v}\right|^{\sigma} \mathrm{d}\mathbf{x} - \frac{1}{\sigma}\int_{\mathcal{U}} \left|\varepsilon\mathfrak{u}\right|^{\sigma} \left|\varepsilon\mathfrak{u}\right|^{\sigma} \left|\varepsilon\mathfrak{u}\right|^{\sigma} \log \left|\varepsilon\mathfrak{u}\varepsilon\mathfrak{v}\right| \mathrm{d}\mathbf{x}.$$

Then one can verify that

$$\frac{d}{d\varepsilon}\varphi(\varepsilon\mathfrak{u},\varepsilon\mathfrak{v}) = \frac{1}{\varepsilon}\psi(\varepsilon\mathfrak{u},\varepsilon\mathfrak{v}). \tag{11}$$

Combining (11) with (1) in Lemma 3.4, we deduce that the map $\varepsilon \mapsto \varphi(\varepsilon \mathfrak{u}, \varepsilon \mathfrak{v})$ attains its maximum at $\varepsilon = \varepsilon_*$, is strictly decreasing on (ε_*, ∞) , and is strictly increasing on $(0, \varepsilon_*)$. By using a similar discussion as (1) in Lemma 3.4, one can verify that $\lim_{\varepsilon \to 0^+} \varphi(\varepsilon \mathfrak{u}, \varepsilon \mathfrak{v}) = 0$, and $\lim_{\varepsilon \to +\infty} \varphi(\varepsilon \mathfrak{u}, \varepsilon \mathfrak{v}) = -\infty$.

Considering the following elliptic system:

$$\begin{cases} \mathcal{K}\left([\mathfrak{u}]_{p}^{s}\right) \mathcal{L}_{p}^{s} \mathfrak{u} = |\mathfrak{v}|^{\sigma} |\mathfrak{u}|^{\sigma-2} \mathfrak{u} \log |\mathfrak{v}\mathfrak{u}|, & \text{in} \quad \mathcal{U}, \\ \mathcal{K}\left([\mathfrak{v}]_{q}^{s}\right) \mathcal{L}_{q}^{s} \mathfrak{v} = |\mathfrak{u}|^{\sigma} |\mathfrak{v}|^{\sigma-2} \mathfrak{v} \log |\mathfrak{u}\mathfrak{v}|, & \text{in} \quad \mathcal{U}, \\ \mathfrak{u}(x) = \mathfrak{u}(x) = 0, & \text{in} \quad \partial \mathcal{U}, \end{cases}$$

$$(12)$$

By Lemma 3.4, the problem (12) has a weak solution in $W^{s,p}(\mathcal{U}) \times W^{s,q}(\mathcal{U})$.

Corollary 3.1. Let us define the Nehari manifold set

$$\mathcal{N}:=\{(\mathfrak{u},\mathfrak{v})\in W^{s,p}(\mathcal{U})\times W^{s,q}(\mathcal{U}): \psi(\mathfrak{u},\mathfrak{v})=0\}\neq\emptyset, \ and \ d:=\inf_{(\mathfrak{u},\mathfrak{v})\in\mathcal{N}}\varphi(\mathfrak{u},\mathfrak{v}).$$

The number d is called the depth of potential well.

In what follows, we prove an essential lemma for proving the strict positivity of depth of potential well.

Lemma 3.5. If Kirchhoff's function satisfies the conditions $(\mathcal{H}_1) - (\mathcal{H}_2)$ and the numbers q, p, σ satisfy the condition (2). Then, we obtain the following results:

$$2) \ \varphi(\mathfrak{u},\mathfrak{v}) - \frac{1}{\sigma}\psi(\mathfrak{u},\mathfrak{v}) \geq \left(\frac{1}{q(\beta+1)} - \frac{1}{\sigma}\right) \left[\mathcal{K}\left([\mathfrak{u}]_p^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{|\mathfrak{u}(\mathbf{x}) - \mathfrak{u}(\mathbf{y})|^p}{|\mathbf{x} - \mathbf{y}|^{N+sp}} d\mathbf{x} d\mathbf{y} + \mathcal{K}\left([\mathfrak{v}]_q^s\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{|\mathfrak{v}(\mathbf{x}) - \mathfrak{v}(\mathbf{y})|^q}{|\mathbf{x} - \mathbf{y}|^{N+sq}} d\mathbf{x} d\mathbf{y} \right],$$

$$\psi(\mathfrak{u},\mathfrak{v}) \geq \Big(1 - \varepsilon_*^{q(\beta+1)-2(\sigma+1)}\Big) \left[\mathcal{K}\Big([\mathfrak{u}]_p^s\Big) \int_{\mathcal{U}\times\mathcal{U}} \frac{|\mathfrak{u}(\mathbf{x}) - \mathfrak{u}(\mathbf{y})|^p}{|\mathbf{x} - \mathbf{y}|^{N+sp}} d\mathbf{x} d\mathbf{y} + \mathcal{K}\Big([\mathfrak{v}]_q^s\Big) \int_{\mathcal{U}\times\mathcal{U}} \frac{|\mathfrak{v}(\mathbf{x}) - \mathfrak{v}(\mathbf{y})|^q}{|\mathbf{x} - \mathbf{y}|^{N+sq}} d\mathbf{x} d\mathbf{y} \right].$$

Proof. According to φ and ψ 's definition, we get that

Theorem 3.1. If Kirchhoff's function satisfies the conditions (\mathcal{H}_1) – (\mathcal{H}_2) and the numbers q, p, σ satisfy the condition (2). Then, the potential well depth d is positive.

Proof. We assume that K(1) > 0. Using (1) and (3) in Lemma 3.2, we get that

From the Picardo iteration method, there exists $t_{0,m} > 0$ depending on $|\xi|$ and $|\zeta|$ such that the system (22) admits a local solution $(g_{im}, g_{im}) \in C^1([0, t_{0,m}]) \times C^1([0, t_{0,m}])$. The following is an attempt to obtain some a priori estimations of the approximate solutions. We multiply the first equation in (22) by g_{im} and the second equation by h_{im} , after that summing with respect to i, we get that

Case 1: $\|\mathfrak{u}_m\|_{W^{s,q}(\mathcal{U})} > 1$ and $\|\mathfrak{v}_m\|_{W^{s,q}(\mathcal{U})} \le 1$.

where ρ is chosen sufficiently such that $0 < \rho < \frac{s\sigma^2}{N}$ and $\sigma < \sigma + \rho < p_s^*$. Combining (26) with continuous embedding $W^{s,p}(\mathcal{U}) \hookrightarrow L^{p_s^*}(\mathcal{U})$, we get that

Similarly, we show that

- Case 3: $\|\mathfrak{u}_m\|_{W^{s,q}(\mathcal{U})} > 1$ and $\|\mathfrak{v}_m\|_{W^{s,q}(\mathcal{U})} > 1$.

From (25), we get that

\leq \varepsilon \left(1 + \min \left\{ \|\mathbf{u}_{m}\|_{W^{s,p}(\mathcal{U})}^{p}, \|\mathbf{u}_{m}\|_{W^{s,p}(\mathcal{U})}^{p(\beta+1)} \right\} + \min \left\{ \|\mathbf{v}_{m}\|_{W^{s,q}(\mathcal{U})}^{q}, \|\mathbf{v}_{m}\|_{W^{s,q}(\mathcal{U})}^{q(\beta+1)} \right\} \right) \\
+ C_{\varepsilon} \left(\|\mathbf{u}_{m}\|_{2}^{2} + \|\mathbf{v}_{m}\|_{2}^{2} \right)^{\lambda} \\
\leq \varepsilon \frac{p^{\beta}}{\mathcal{K}(1)} \left(\mathcal{K} \left([\mathbf{u}_{m}]_{s}^{p} \right) \int_{\mathcal{U} \times \mathcal{U}} \frac{\left|\mathbf{u}_{m}(\mathbf{x}, t) - \mathbf{u}_{m}(\mathbf{y}, t)\right|^{p}}{|\mathbf{x} - \mathbf{y}|^{N+sp}} d\mathbf{x} d\mathbf{y} \right) \\
+ \varepsilon \frac{q^{\beta}}{\mathcal{K}(1)} \left(\mathcal{K} \left([\mathbf{v}_{m}]_{s}^{q} \right) \int_{\mathcal{U} \times \mathcal{U}} \frac{\left|\mathbf{v}_{m}(\mathbf{x}, t) - \mathbf{v}_{m}(\mathbf{y}, t)\right|^{q}}{|\mathbf{x} - \mathbf{y}|^{N+sq}} d\mathbf{x} d\mathbf{y} \right) + C_{\varepsilon} \left(\|\mathbf{u}_{m}\|_{2}^{2} + \|\mathbf{v}_{m}\|_{2}^{2} \right)^{\lambda}.$$

From (24), (33), we have that

for all $(w_1, w_2) \in W^{s,p}(\mathcal{U}) \times W^{s,q}(\mathcal{U})$ and $t \in (0, T_0)$. We followed the same method appearing in Lemma 4.3 [3], we get that

$$\chi_{2} = \mathcal{K}\left(\left[\mathfrak{v}\right]_{s}^{q}\right) \int_{\mathcal{U} \times \mathcal{U}} \frac{\left|\mathfrak{v}(\mathbf{x}, t) - \mathfrak{v}(\mathbf{y}, t)\right|^{q-2} \left(\mathfrak{v}(\mathbf{x}, t) - \mathfrak{v}(\mathbf{y}, t)\right)}{|\mathbf{x} - \mathbf{y}|^{N+sq}} d\mathbf{x} d\mathbf{y}.$$

Hence, our system (1) admits solution $(\mathfrak{u}, \mathfrak{v}) \in Y$. Now we turn to show inequality (21). In view of (23), (44), and (45), we have

4. Global Existence and Asymptotic Behavior

Theorem 4.1. Let $(\mathcal{H}_1) - (\mathcal{H}_2)$ hold. if $\varphi(\mathfrak{u}_0, \mathfrak{v}_0) < d'_*$ and $\psi(\mathfrak{u}_0, \mathfrak{v}_0) \ge 0$. Then, we have

- 1) $T_{\text{max}} = +\infty$
- 2) the energy functional φ satisfies the following estimates

$$\varphi(\mathfrak{u}(t),\mathfrak{v}(t)) \leq \begin{cases} \varphi\left(\mathfrak{u}_0,\mathfrak{v}_0\right) \left(\frac{p(\beta+1)}{2+(p(\beta+1)-2)\alpha t}\right)^{\frac{p(\beta+1)}{p(\beta+1)-2}}, & \text{ if } q > \frac{2}{(\beta+1)} \\ \varphi\left(\mathfrak{u}_0,\mathfrak{v}_0\right) e^{1-\mu t}, & \text{ if } q \leq \frac{2}{(\beta+1)} \end{cases}$$

with α and μ are some positive constants.

Proof. Firstly, we prove that $\psi(\mathfrak{u}(t),\mathfrak{v}(t)) \geq 0$, for all $t \in [0,T_{\text{max}})$. Considering the following sets

Due to $\varphi(\mathfrak{u}_0,\mathfrak{v}_0) < d'_* < d$ and $\psi(\mathfrak{u}_0,\mathfrak{v}_0) > 0$, we have $(\mathfrak{u}_0,\mathfrak{v}_0) \in \mathcal{W}$. Using a contradiction for proving $(\mathfrak{u}(t),\mathfrak{v}(t)) \in \mathcal{W}$, for all $t \in [0,T_{\max})$. We suppose that there exist a $t_0 \in [0,T_{\max})$ such that $(\mathfrak{u}(t_0),\mathfrak{v}(t_0)) \in \partial \mathcal{W}$. Noticing that 0 is an interior of \mathcal{W} . So, we get that $\varphi(\mathfrak{u}(t_0),\mathfrak{v}(t_0)) = d$ or $\psi(\mathfrak{u}(t_0),\mathfrak{v}(t_0)) = 0$ and $(\mathfrak{u}(t_0),\mathfrak{v}(t_0)) \neq (0,0)$. Using (21), we obtain that $\varphi(\mathfrak{u}(t_0),\mathfrak{v}(t_0)) \leq (\mathfrak{u}_0,\mathfrak{v}_0) < d$, and hence $\psi(\mathfrak{u}(t_0),\mathfrak{v}(t_0)) = 0$. So, we deduce that $(\mathfrak{u}(t_0),\mathfrak{v}(t_0)) \in \mathcal{N}$. Using the definition of d, we have $\varphi(\mathfrak{u}(t_0),\mathfrak{v}(t_0)) \geq d$. We arrive that contradiction. Finally, we deduce that $\psi(\mathfrak{u}(t_0),\mathfrak{v}(t_0)) \geq 0$ for all $t \in [0,T_{\max})$. Now, we show that $T_{\max} = \infty$. Using Lemma 3.5, we get that

$$\geq \left(\frac{1}{q(\beta+1)} - \frac{1}{\sigma}\right) \left[\mathcal{K}\left(\left[\mathfrak{u}(t)\right]_{p}^{s}\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{|\mathfrak{u}(x,t) - \mathfrak{u}(y,t)|^{p}}{|x-y|^{N+sp}} dxdy + \mathcal{K}\left(\left[\mathfrak{v}(t)\right]_{q}^{s}\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{|\mathfrak{v}(x,t) - \mathfrak{v}(y,t)|^{q}}{|x-y|^{N+sq}} dxdy\right]$$

$$\geq \left(\frac{1}{q(\beta+1)} - \frac{1}{\sigma}\right) \left[\frac{\mathcal{K}(1)}{p^{\beta}} \min\left\{\left\|\mathfrak{u}\right\|_{W^{s,p}(\mathcal{U})}^{p}, \left\|\mathfrak{u}\right\|_{W^{s,p}(\mathcal{U})}^{p(\beta+1)}\right\} + \frac{\mathcal{K}(1)}{q^{\beta}} \min\left\{\left\|\mathfrak{v}\right\|_{W^{s,q}(\mathcal{U})}^{q}, \left\|\mathfrak{u}\right\|_{W^{s,q}(\mathcal{U})}^{q(\beta+1)}\right\}\right]$$

$$\geq \left(\frac{1}{q(\beta+1)} - \frac{1}{\sigma}\right) \frac{\mathcal{K}(1)}{q^{\beta}} \min\left\{\left\|\mathfrak{u}\right\|_{W^{s,p}(\mathcal{U})}^{q} + \left\|\mathfrak{v}\right\|_{W^{s,q}(\mathcal{U})}^{q}, \left\|\mathfrak{u}\right\|_{W^{s,q}(\mathcal{U})}^{q(\beta+1)} + \left\|\mathfrak{v}\right\|_{W^{s,q}(\mathcal{U})}^{q(\beta+1)}\right\}$$

$$\geq \left(\frac{1}{q(\beta+1)} - \frac{1}{\sigma}\right) \frac{\mathcal{K}(1)}{q^{\beta}} \min\left\{\left\|(\mathfrak{u},\mathfrak{v})\right\|_{Y}^{q}, \left\|(\mathfrak{u},\mathfrak{v})\right\|_{Y}^{q(\beta+1)}\right\},$$

$$(47)$$

which yields that

$$\|(\mathfrak{u},\mathfrak{v})\|_{Y} \le \max\left\{1, \left(\frac{d_{*}q^{\beta+1}(\beta+1)\sigma}{(\sigma-q(\beta+1))\mathcal{K}(1)}\right)^{\frac{1}{q}}\right\} := C_{1}.$$

$$(48)$$

In the other words, $(\mathfrak{u}(t), \mathfrak{v}(t))$ is uniformly bounded in time in $W^{s,p}(\mathcal{U}) \times W^{s,q}(\mathcal{U})$. So, we have $T_{\max} = +\infty$. Using (4) of Lemma 3.5, we get that

$$\geq \left(1 - \left(\frac{d_{*}}{\varphi(\mathfrak{u}_{0},\mathfrak{v}_{0})}\right)^{1 - \frac{2(\sigma+1)}{q(\beta+1)}}\right) \left[\mathcal{K}\left(\left[\mathfrak{u}(t)\right]_{p}^{s}\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{|\mathfrak{u}(\mathbf{x},t) - \mathfrak{u}(\mathbf{y},t)|^{p}}{|\mathbf{x} - \mathbf{y}|^{N+sp}} d\mathbf{x} d\mathbf{y} + \mathcal{K}\left(\left[\mathfrak{v}(t)\right]_{q}^{s}\right) \int_{\mathcal{U}\times\mathcal{U}} \frac{|\mathfrak{v}(\mathbf{x},t) - \mathfrak{v}(\mathbf{y},t)|^{q}}{|\mathbf{x} - \mathbf{y}|^{N+sq}} d\mathbf{x} d\mathbf{y}\right].$$

\leq \left(\frac{1}{p(\beta+1)} - \frac{1}{\sigma}\right) \left(1 - \left(\frac{d_{*}}{\varphi(\mathfrak{u}_{0},\mathfrak{v}_{0})}\right)^{1-\frac{2(\sigma+1)}{q(\beta+1)}}\right)^{-1} \psi\left(\mathfrak{u}(t),\mathfrak{u}(t)\right).$$

So, we get that

$$\varphi\left(\mathfrak{u}(t),\mathfrak{u}(t)\right) \le C_2 \psi\left(\mathfrak{u}(t),\mathfrak{u}(t)\right),\tag{54}$$

with $C_2 := \left(\frac{1}{p(\beta+1)} - \frac{1}{\sigma}\right) \left(1 - \left(\frac{d_*}{\varphi(\mathfrak{u}_0,\mathfrak{v}_0)}\right)^{1 - \frac{2(\sigma+1)}{q(\beta+1)}}\right)^{-1} > 0$. Now, our contribution is the decay estimates of the functional $\varphi(\mathfrak{u}(t),\mathfrak{u}(t))$. Using (47) and (48), we have that

$$\geq C_3 \|(\mathfrak{u},\mathfrak{v})\|_{Y}^{q(\beta+1)},\tag{56}$$

where $C_3 := \left(\frac{1}{q(\beta+1)} - \frac{1}{\sigma}\right) \frac{\mathcal{K}(1)}{q^{\beta}} C_1^{q\beta}$. Conversely, however. By using the embedding $W^{s,p}(\mathcal{U}) \times W^{s,q}(\mathcal{U}) \hookrightarrow L^2(\mathcal{U}) \times L^2(\mathcal{U})$, we have that

where $C_5 = C_3^{-\frac{2}{p^+(s+1)}}C_4^2 > 0$. Let be z a number such that t < z. Combining (54) with (58), we obtain that

$$\leq \frac{C_{2}C_{5}}{2} \left[\varphi(\mathfrak{u}(t), \mathfrak{u}(t)) \right]^{\frac{2}{q(\beta+1)}}$$
(59)

Letting $z \to \infty$, we obtain

$$\int_{t}^{\infty} \varphi\left(\mathfrak{u}(h), \mathfrak{v}(h)\right) \mathrm{d}h \le C_{6} \varphi\left(\mathfrak{u}(t), \mathfrak{u}(t)\right)^{\frac{2}{q(\beta+1)}},\tag{60}$$

where $C_6 = \frac{C_2C_5}{2} > 0$. It is easy yo show that $t \mapsto \varphi(\mathfrak{u}(t), \mathfrak{u}(t))$ is non-increasing with respect to t. Next, we separate the following two

Case 1: If $q \leq \frac{2}{\beta+1}$.

Using (21) and (60), we obtain that

Then using Lemma 2.3 to $G(t) = \varphi(\mathfrak{u}(t), \mathfrak{u}(t))$ and $\gamma = 0$, we obtain

5. Blow-up Phenomena

In this section, applying Nehari manifold and the potential well theory combined, we show that the local weak solution of system (1) exist Blow-up phenomena.

Theorem 5.1. Assume that the assumptions $(\mathcal{H}_1) - (\mathcal{H}_2)$ hold. If $\varphi(\mathfrak{u}_0, \mathfrak{v}_0) < d_*$ and $\psi(\mathfrak{u}_0, \mathfrak{v}_0) < 0$. Then, we have $T_{\text{max}} < +\infty$. Moreover, we also give an upper bound for the maximal existence time as follows

$$T_{\max} \le \frac{4(\sigma - 1) \left(\|\mathbf{u}_0\|_2^2 + \|\mathbf{v}_0\|_2^2 \right)}{\sigma \left(d_* - \varphi \left(\mathbf{u}_0, \mathbf{v}_0 \right) \right) (\sigma - 2)^2}$$

Proof. We show that $\psi(\mathfrak{u}(t),\mathfrak{v}(t))<0$ for all $t\in[0,T_{\max})$. Indeed, suppose by contradiction that, there exist $t_0\in(0,T_{\max})$ such that $\psi(\mathfrak{u}(t),\mathfrak{v}(t))<0$ for all $t\in[0,t_0)$ and $\psi(\mathfrak{u}(t_0),\mathfrak{v}(t_0))=0$. Testing by $(\mathfrak{u},\mathfrak{v})$ in (46), we get that

$$\frac{d}{dt} \|\mathbf{u}(t)\|_{2}^{2} + \frac{d}{dt} \|\mathbf{v}(t)\|_{2}^{2} = 2 \left(\langle \mathbf{u}_{t}, \mathbf{u} \rangle + \langle \mathbf{v}_{t}, \mathbf{v} \rangle \right)
= -2\psi \left(\mathbf{u}(t), \mathbf{v}(t) \right) > 0, \quad \text{for all } t \in [0, t_{0}).$$

So, the map $t \to \|\mathbf{u}(t)\|_2^2 + \|\mathbf{v}(t)\|_2^2$ is strictly increasing on $[0, t_0]$. Therefore, $\|\mathbf{u}(t_0)\|_2^2 + \|\mathbf{v}(t_0)\|_2^2$. So, we get that $(\mathbf{u}(t_0), \mathbf{v}(t_0)) \in \mathcal{N}$. Using the definition of d, we obtain

$$\varphi\left(\mathfrak{u}\left(t_{0}\right),\mathfrak{v}\left(t_{0}\right)\right)\geq d.\tag{61}$$

However, it follows from (21)

$$\varphi(\mathfrak{u}(t_0),\mathfrak{v}(t_0)) \le \varphi(\mathfrak{u}_0,\mathfrak{v}_0) < d_* \le d. \tag{62}$$

Using (61) and (62), we arrive at a contradiction. So, we have $\psi(\mathfrak{u}(t), \mathfrak{v}(t)) < 0$ for all $t \in [0, T_{\text{max}})$. Now, we give an upper bound of T_{max} . Fixing $T \in (0, T_{\text{max}})$ and considering the function L defined by

$$L(t) = \int_0^t \left(\|\mathbf{u}_s(s)\|_2^2 + \|\mathbf{v}_s(s)\|_2^2 \right) ds + (T - t) \left(\|\mathbf{u}_0\|_2^2 + \|\mathbf{v}_0\|_2^2 \right) + (at + b)^2, \text{ for all } t \in [0, T]$$

with a, b are positive constents. By a direct computation, we have

$$L'(t) = \|\mathbf{u}_s(s)\|_2^2 + \|\mathbf{v}_s(s)\|_2^2 - (\|\mathbf{u}_0\|_2^2 + \|\mathbf{v}_0\|_2^2) + 2a(at+b)$$

$$= 2\left[\int_0^t (\langle \mathbf{u}_s(s), \mathbf{u}(s) \rangle + \langle \mathbf{v}_s(s), \mathbf{v}(s) \rangle) \, ds + a(at+b)\right]$$

$$> 0.$$

and

$$L''(t) = 2\left(\langle \mathfrak{u}_s(s), \mathfrak{u}(s) \rangle + \langle \mathfrak{v}_s(s), \mathfrak{v}(s) \rangle + a^2\right)$$

= $2(-\psi(\mathfrak{u}(t), \mathfrak{v}(t))) + a^2 > 0.$ (63)

Thanks to Cauchy-Schwarz inequality, we get that

$$(L'(t))^{2} = 4 \left[\int_{0}^{t} (\langle u_{s}(s), u(s) \rangle + \langle v_{s}(s), v(s) \rangle) ds + a(at+b) \right]^{2}$$

$$\leq 4 \left[\sqrt{\int_{0}^{t} ||u_{s}(s)||_{2}^{2} ds} \sqrt{\int_{0}^{t} ||u(s)|_{2}^{2} ||ds} + \sqrt{\int_{0}^{t} ||v_{s}(s)||_{2}^{2} ds} \sqrt{\int_{0}^{t} ||v(s)||_{2}^{2} ds} + a(at+b) \right]^{2}$$

$$\leq 4 \left[\int_{0}^{t} (||u(s)||_{2}^{2} + ||v(s)||_{2}^{2}) ds + (at+b)^{2} \right] \left[\int_{0}^{t} (||u_{s}(s)||_{2}^{2} + ||v_{s}(s)||_{2}^{2}) ds + a^{2} \right]$$

$$= 4L(t) \left[\int_{0}^{t} (||u_{s}(s)||_{2}^{2} + ||v_{s}(s)||_{2}^{2}) ds + a^{2} \right].$$

$$(64)$$

On the other hand, using (3) of Lemma 3.5, we have

$$\varphi(\mathfrak{u}(t),\mathfrak{v}(t)) - \frac{1}{\sigma}\psi(\mathfrak{u}(t),\mathfrak{v}(t)) > d_*. \tag{65}$$

Using (21), (63), (64), and (65) we obtain that

$$L''(t) = 2\left(-2\psi(\mathfrak{u}(t),\mathfrak{v}(t)) + a^{2}\right)$$

$$\geq 2\left[\sigma\left(d_{*} - \varphi(\mathfrak{u}(t),\mathfrak{v}(t))\right) + a^{2}\right]$$

$$\geq 2\left[\sigma\int_{0}^{t}\left(\|\mathfrak{u}(s)\|_{2}^{2} + \|\mathfrak{v}(s)\|_{2}^{2}\right)ds + \sigma\left(d_{*} - \varphi\left(\mathfrak{u}_{0},\mathfrak{v}_{0}\right)\right) + a^{2}\right]$$

$$\geq \left[\sigma\left(\left(\frac{L'(t))^{2}}{4L(t)} - a^{2}\right) + \sigma\left(d_{*} - \varphi\left(\mathfrak{u}_{0},\mathfrak{v}_{0}\right)\right) + a^{2}\right].$$
(66)

Usin (66), we have that

$$L''(t)L(t) - \frac{\sigma}{2} \left(L'(t)\right)^2 \ge 2L(t) \left[\sigma \left(d_* - \varphi \left(\mathfrak{u}_0, \mathfrak{v}_0\right) + a^2\right]\right] \tag{67}$$

Putting

$$0 < a < \sqrt{\frac{\sigma(d_* - \varphi(\mathfrak{u}_0, \mathfrak{v}_0))}{\sigma}}.$$
(68)

Combining (67)) with (68), we have the above inequality

$$L''(t) - \frac{\sigma}{2} \left(L'(t) \right)^2 \ge 0$$

By a direct computation, we have L(0), L'(0) > 0. Using Lemma 2.2, we have that $T \leq \frac{L(0)}{\left(\frac{\sigma}{2}-1\right)L'(0)} = \frac{T\left(\|u_0\|_2^2 + \|v_0\|_2^2\right) + b^2}{ab\left(\frac{\sigma}{2}-1\right)}$, which implies that $T \leq \frac{b^2}{ab\left(\frac{\sigma}{2}-1\right) - \left(\|u_0\|_2^2 + \|u_0\|_2^2\right)} := \xi(b)$, for all $b \in \left(\frac{\|u_0\|_2^2 + \|v_0\|_2^2}{a\left(\frac{\sigma}{2}-1\right)}, \infty\right)$. Minimizing $\xi(b)$ for all $b \in \left(\frac{\|u_0\|_2^2 + \|v_0\|_2^2}{a\left(\frac{\sigma}{2}-1\right)}, \infty\right)$. So, we get that

$$T \leq \frac{4\left(\|\mathbf{u}_0\|_2^2 + \|\mathbf{v}_0\|_2^2\right)}{\left(a\left(\frac{\sigma}{2} - 1\right)\right)^2} := \varsigma(a), \text{ for all } 0 < a < \sqrt{\frac{\sigma\left(d_* - \varphi\left(\mathbf{u}_0, \mathbf{v}_0\right)\right)}{\sigma}}.$$

Minimizing $\varsigma(a)$ and letting $T \to T_{\text{max}}$, we deduce that

$$T_{\max} \le \frac{4(\sigma - 1) \left(\|\mathbf{u}_0\|_2^2 + \|\mathbf{v}_0\|_2^2 \right)}{\sigma \left(d_* - \varphi \left(\mathbf{u}_0, \mathbf{v}_0 \right) \right) (\sigma - 2)^2}$$
