QUIVER DOWN-UP ALGEBRAS

ABSTRACT. We present a generalization of down-up algebras, originally defined by Benkart and Roby. These quiver down-up algebras arise as quotients of the double of the extended Dynkin quiver of type A. Under a certain non-degeneracy condition, we show that quiver down-up algebras are noetherian piecewise domains. The \mathbb{N} -graded members of the family are proved to be, generically, twisted Calabi–Yau. Finally, we consider the isomorphism problem for graded quiver down-up algebras.

Throughout, let k be an algebraically closed field of characteristic zero. Down-up algebras were introduced by Benkart and Roby [1, 2]. They have drawn significant interest in representation theory [13], invariant theory [11], and the study of Hopf algebras [3]. In this paper, we realize a family of algebras which may reasonably be considered as a generalization of down-up algebras to quivers with many vertices.

Definition 0.1. Let Q be the following quiver:

$$(0.1) \qquad e_{1} \xrightarrow{u_{0}} e_{1} \xrightarrow{u_{0}} e_{2} \xrightarrow{u_{2}} \cdots \xrightarrow{u_{n-3}} e_{n-2} \xrightarrow{u_{n-2}} e_{n-1}$$

For $\alpha, \beta, \gamma \in \mathbb{k}^n$, the corresponding quiver down-up algebra $\mathcal{H}(\alpha, \beta, \gamma)$ is defined as the quotient of $\mathbb{k}Q$ by the relations

$$d_{i-1}u_{i-1}u_{i} = \alpha_{i}u_{i}d_{i}u_{i} + \beta_{i}u_{i}u_{i+1}d_{i+1} + \gamma_{i}u_{i}$$

$$d_i d_{i-1} u_{i-1} = \alpha_i d_i u_i d_i + \beta_i u_{i+1} d_{i+1} d_i + \gamma_i d_i,$$

for $i \in Q_0$. If $\gamma_i = 0$ for all $i \in Q_0$, then we write $\mathcal{H}(\alpha, \beta, 0)$.

The classical down-up algebras occur when n=1, so there is a single vertex and two loops $(u=u_0, d=d_0)$ with parameters $\alpha=\alpha_0$, $\beta=\beta_0$, and $\gamma=\gamma_0$. These algebras are known to be noetherian domains if and only if $\beta \neq 0$. When $\beta \neq 0$ and $\gamma=0$, they are cubic Artin–Schelter regular algebra of global dimension three. We generalize these results to the quiver down-up algebras from Definition 0.1.

In Section 1 we provide background on quivers and path algebras with relations, and establish a k-basis for the quiver down-up algebras. In Section 2, we show that quiver down-up algebras appear as generalized Weyl algebras over the algebra $\bigoplus_{i \in Q_0} R[x_i, y_i]$. This shows that the $H(\alpha, \beta, \gamma)$ are noetherian and piecewise

domains when $\beta_i \neq 0$ for all $i \in Q_0$. Section 3 realizes certain quiver down-up algebras as skew group rings of an Artin–Schelter regular algebra and provides the last pieces of proving the following theorem.

Theorem A (Theorem 3.6). Suppose $\beta_i \neq 0$ for all $i \in Q_0$. Then $\mathcal{H} = \mathcal{H}(\alpha, \beta, 0)$ is twisted-graded Calabi-Yau of global dimension three with Nakayama automorphism $\mu^{\mathcal{H}}$ given by $\mu^{\mathcal{H}}(u_i) = -\beta_{i-1}^{-1}u_i$ and $\mu^{\mathcal{H}}(d_i) = -\beta_{i-1}^{-1}d_i$ for all $i \in Q_0$.

The following theorem, which is analogous to [12, Theorem] in the single-vertex case, is proved in Section 4.

Theorem B (Theorem 4.2). Let $\alpha, \beta, \gamma \in \mathbb{k}^n$ and let $\mathcal{H} = \mathcal{H}(\alpha, \beta, \gamma)$. The following are equivalent.

- (1) $\beta_i \neq 0$ for all $i \in Q_0$,
- (2) \mathcal{H} is right (or left) noetherian,
- (3) $\mathbb{k}[u_i d_i, d_{i-1} u_{i-1}]$ is a polynomial ring in two variables for all $i \in Q_0$,
- (4) \mathcal{H} is a piecewise domain.

Finally, in Section 5 we consider the isomorphism problem for the graded quiver down-up algebras. This is related to recent work in [9] on isomorphisms of certain quantized preprojective algebras.

Theorem C (Theorem 5.2). Fix $n \geq 3$. Let $\alpha, \alpha' \in \mathbb{k}^n$ and $\beta, \beta' \in (\mathbb{k}^{\times})^n$. Then $\mathcal{H}(\alpha, \beta, 0) \cong \mathcal{H}(\alpha', \beta', 0)$ if and only if there exists $\lambda \in (\mathbb{k}^{\times})^n$ and $k \in Q_0$ such that one of the following hold:

(1)
$$\alpha'_{i} = \lambda_{i+k} \lambda_{i+k-1}^{-1} \alpha_{i+k}, \quad \beta'_{i} = \lambda_{i+k+1} \lambda_{i+k-1}^{-1} \beta_{i+k}, \text{ or }$$

$$(2) \ \alpha_i' = -\lambda_{n-i-k}^{-1} \lambda_{n-i-k-1} \beta_{n-i-k-1}^{-1} \alpha_{n-i-k-1}, \quad \beta_i' = \lambda_{n-i-k}^{-1} \lambda_{n-i-k-2}^{-1} \beta_{n-i-k-1}^{-1}.$$

In a companion piece [8], the authors show that certain graded quiver down-up algebras appear as normal extensions of preprojective algebras. This gives an alternate way to realize some of the results in this paper.

1. Quivers and a basis for quiver down-up algebras

A quiver Q is a directed graph. More precisely, it is a set Q_0 of vertices and a set Q_1 of edges along with maps $\mathfrak{s},\mathfrak{t}:Q_1\to Q_0$. For each $a\in Q_1$, $\mathfrak{s}(a)$ is the source and $\mathfrak{t}(a)$ is the target. A path in Q is a string $p=a_0a_1\ldots a_m$ with $\mathfrak{t}(a_i)=\mathfrak{s}(a_{i+1})$ for $i=0,\ldots,m-1$. The maps $\mathfrak{s},\mathfrak{t}$ then extend naturally to the set of paths with $\mathfrak{s}(p)=\mathfrak{s}(a_0)$ and $\mathfrak{t}(p)=\mathfrak{t}(a_m)$. Throughout, we assume that Q_0 and Q_1 are finite.

The set of paths in Q form a k-linear basis of the path algebra kQ. Multiplication in kQ is given by concatenation. That is, for paths p and q, $p \cdot q = pq$ if $\mathfrak{t}(p) = \mathfrak{s}(q)$ and $p \cdot q = 0$ otherwise. At each vertex $k \in Q_0$ there is a trivial path e_k which has the properties $e_k p = p$ (resp. $pe_k = p$) if $\mathfrak{s}(p) = k$ (resp. $\mathfrak{t}(p) = k$) and 0 otherwise.

There is a filtration on Q by path length, which extends naturally to kQ. An element $f \in kQ$ is homogeneous if f is the sum of elements of the same path length, source, and target. An ideal I in kQ is homogeneous if it is generated by homogeneous elements.

Proposition 1.1. Let $\mathcal{H} = \mathcal{H}(\alpha, \beta, \gamma)$ with $\alpha, \beta, \gamma \in \mathbb{k}^n$. A \mathbb{k} -basis for \mathcal{H} consists of paths of the form:

$$(1.1) (u_i u_{i+1} \cdots u_{i+k}) (d_{i+k} u_{i+k})^j (d_{i+k} d_{i+k-1} \cdots d_{i+k-\ell}),$$

with $j, k, \ell \geq 0$. (In particular, we can have $j, k, \ell > n$, so that the arrows repeat.)

Proof. Let Q be as in (0.1). We order the arrows of Q by

$$d_0 > d_1 > \dots > d_{n-1} > u_0 > u_1 > \dots > u_{n-1}.$$

The leading terms of the relations under this ordering are $d_i d_{i-1} u_{i-1}$ and $d_{i-1} u_{i-1} u_i$ for all i. The only overlaps between these terms are of the form $d_i d_{i-1} u_{i-1} u_i$. We claim that these overlap ambiguities resolve:

$$(d_{i}d_{i-1}u_{i-1})u_{i} - d_{i}(d_{i-1}u_{i-1}u_{i})$$

$$= (\alpha_{i}d_{i}u_{i}d_{i} + \beta_{i}u_{i+1}d_{i+1}d_{i} + \gamma_{i}d_{i})u_{i} - d_{i}(\alpha_{i}u_{i}d_{i}u_{i} + \beta_{i}u_{i}u_{i+1}d_{i+1} + \gamma_{i}u_{i})$$

$$= \beta_{i} (u_{i+1}(d_{i+1}d_{i}u_{i}) - (d_{i}u_{i}u_{i+1})d_{i+1})$$

$$= \beta_{i} (u_{i+1}(\alpha_{i+1}d_{i+1}u_{i+1}d_{i+1} + \beta_{i+1}u_{i+2}d_{i+2}d_{i+1} + \gamma_{i+1}d_{i+1})$$

$$- (\alpha_{i+1}u_{i+1}d_{i+1}u_{i+1} + \beta_{i+1}u_{i+1}u_{i+2}d_{i+2} + \gamma_{i+1}u_{i+1})d_{i+1}) = 0,$$

as claimed. Hence, a k-basis for \mathcal{H} consists of those paths which avoid the leading terms $d_i d_{i-1} u_{i-1}$ and $d_{i-1} u_{i-1} u_i$. It is easily seen that these are the paths (1.1).

Let Γ be an abelian monoid. An algebra A is Γ -graded if there is a vector space decomposition $A = \bigoplus_{k \in \Gamma} A_k$ such that $A_k \cdot A_\ell \subset A_{k+\ell}$. A graded algebra A is locally finite if $\dim_{\mathbb{R}} A_k < \infty$ for all k.

The quiver down-up algebras $H(\alpha, \beta, 0)$ are N-graded and locally finite via the path-length filtration $(\deg(u_i) = \deg(d_i) = 1 \text{ for all } i \in Q_0)$. This is the grading we use throughout, however there is also a \mathbb{Z} -grading on $\mathcal{H}(\alpha, \beta, \gamma)$ obtained by setting $\deg(u_i) = 1$ and $\deg(d_i) = -1$ for all $i \in Q_0$.

Given a quiver Q with $|Q_0| = n$, the associated adjacency matrix is $M_Q \in M_n(\mathbb{N})$ where $(M_Q)_{ij}$ denotes the number of arrows with source i and target j. Let I be a homogeneous ideal in $\mathbb{k}Q$ and set $A = \mathbb{k}Q/I$. For each $k \in \mathbb{N}$, let $H_k \in M_n(\mathbb{N})$ where $(H_k)_{ij}$ denotes the number of paths of length k (modulo relations) with source i and target j. Note if $I \subset (\mathbb{k}Q)^2$, then $H_1 = M_Q$. The matrix-valued Hilbert series of A is defined as

$$h_A(t) = \sum_{k=0}^{\infty} H_k t^k.$$

The total Hilbert series of A, $h_A^{\text{tot}}(t)$, is the infinite series in which the coefficient of t^k is the sum of the entries of H_k .

Example 1.2. Let Q be as in (0.1). Define the algebra

$$A = \mathbb{k}Q/(d_i u_i - u_{i+1} d_{i+1} : i \in Q_0).$$

The algebra A is a particular preprojective algebra, and it is well-known that A is graded Calabi–Yau algebra of dimension two. Thus, $h_A = (I - Mt + It^2)^{-1}$ [16, Theorem 1.2].

It is easy to see from the relations that a k-basis for A consists of paths of the form

$$(1.2) u_i u_{i+1} \cdots u_{i+k} d_{i+k} d_{i+k-1} \cdots d_{i+k-\ell}.$$

For each vertex $i \in Q_0$, there is a bijection between paths of the form (1.2) with source e_i and the monomial basis of $\mathbb{k}[a,b]$. It follows that $h_A^{\text{tot}} = n(1-t)^2$.

We now use a similar strategy to establish a basis for the graded quiver down-up algebras.

Corollary 1.3. Suppose $\gamma = 0$. Then the total Hilbert series of $\mathcal{H} = \mathcal{H}(\alpha, \beta, 0)$ is

$$h_{\mathcal{H}}^{\text{tot}} = n(1-t)^{-2}(1-t^2)^{-1}.$$

Proof. There is a bijection between paths of the form (1.1) with source vertex i and monomials $a^{k+1}b^jc^{\ell+1}$ in $\mathbb{k}[a,b,c]$ where b is given degree two. The Hilbert series of $\mathbb{k}[a,b,c]$ is $(1-t)^{-2}(1-t^2)^{-1}$.

In Lemma 3.5 we compute the matrix-valued Hilbert series of $\mathcal{H}(\alpha, \beta, 0)$.

2. Generalized Weyl algebras

In this section we establish several key properties of quiver down-up algebras by recognizing them as generalized Weyl algebras. It is well known that the single-vertex down-up algebras appear in this way [12].

Let R be a k-algebra and σ an automorphism of R. A σ -derivation of R is a k-linear map $\delta: R \to R$ satisfying $\delta(rr') = \sigma(r)\delta(r') + \delta(r)r'$ for all $r, r' \in R$. Given the above, the *Ore extension* $S = R[x; \sigma, \delta]$ is generated over R by x subject to the relations $xr = \sigma(r)x + \delta(r)$ for all $r \in R$. If R is twisted Calabi–Yau of dimension d, then S is twisted Calabi–Yau of dimension d + 1 [14, Theorem 3.3].

Suppose that $R = \mathbb{k}Q/I$ with $I \subset \mathbb{k}Q_{\geq 2}$ homogeneous. Further, suppose that σ and δ are graded. This implies that σ permutes the set of idempotents, so $\sigma(e_i) = e_{\sigma(i)}$, and σ commutes with the source and target maps. Hence, if $a \in Q_1$ with $\mathfrak{s}(a) = e_i$ and $\mathfrak{t}(a) = e_j$, then $\mathfrak{s}(\sigma(a)) = e_{\sigma(i)}$ and $\mathfrak{t}(\sigma(a)) = e_{\sigma(j)}$. Moreover, $\delta(a) \in e_{\sigma(i)}R_2e_j$. In $S = R[x; \sigma, \delta]$, we have $x = \sum x_i$ where $x_i = xe_i = e_{\sigma(i)}x$. Then for $a \in e_iRe_j$, $x_ia = \sigma(a)x_j + \delta(a)$ is a homogeneous relation from $e_{\sigma(i)}$ to e_j .

As above, let R be an algebra and σ an automorphism of R. Let h be a regular central element of R. The generalized Weyl algebra (GWA) $R(\sigma, h)$ is the algebra generated by R and X^+, X^- subject to the relations

$$X^{-}X^{+} = h,$$
 $X^{+}X^{-} = \sigma(h),$ $X^{+}r = \sigma(r)X^{+},$ $X^{-}\sigma(r) = rX^{-},$

for all $r \in R$.

Every GWA is (isomorphic to) a quotient of an iterated Ore extension. Let $S = R[X^-; \sigma][X^+; \sigma^{-1}, \delta]$ where $\delta(r) = 0$ for all $r \in R$ and $\delta(X^-) = \sigma(h) - h$. Then $R(\sigma, h) \cong S/(X^-X^+ - h)$, so $R(\sigma, h)$ is noetherian if R is.

Let $R = \bigoplus_{i \in Q_0} \mathbb{k}[x_i, y_i]$ and denote the identity in $\mathbb{k}[x_i, y_i]$ by e_i for each $i \in Q_0$. If $\beta_i \neq 0$ for all $i \in Q_0$, then the linear map given by

(2.1)
$$\sigma(e_i) = e_{i+1}, \quad \sigma(x_i) = y_{i+1}, \quad \sigma(y_i) = \alpha_i y_{i+1} + \beta_i x_{i+1} + \gamma_i,$$

defines an automorphism of R. Let $x = \sum x_i$ and define the GWA $T = R(\sigma, x)$. In T, the generators X_i^-, X_i^+ decompose as $X_i^- = X^- e_i = e_{i+1} X^-$ and $X_i^+ = e_i X^+ = X^+ e_{i+1}$. These satisfy the relations

$$X_i^- r = \sigma^{-1}(r)X_i^-, \quad X_i^+ r = \sigma(r)X_i^+, \quad X_i^- X_i^+ = x_i, \quad X_i^+ X_i^- = \sigma(x_i) = y_{i+1}.$$

Proposition 2.1. Keep the above setup and assume $\beta_i \neq 0$ for all $i \in Q_0$. Then $T \cong \mathcal{H}(\alpha, \beta, \gamma)$.

Proof. Set $\mathcal{H} = \mathcal{H}(\alpha, \beta, \gamma)$. Define a map $\theta : \mathcal{H} \to T$ by $\theta(u_i) = X_i^-$ and $\theta(d_i) = X_i^+$ for all $i \in Q_0$. Then

$$\begin{split} \theta(d_{i-1})\theta(u_{i}) - \alpha_{i}\theta(u_{i})\theta(d_{i})\theta(u_{i}) - \beta_{i}\theta(u_{i})\theta(u_{i+1})\theta(d_{i+1}) - \gamma_{i}\theta(u_{i}) \\ &= X_{i-1}^{+}X_{i-1}^{-}X_{i}^{-} - \alpha_{i}X_{i}^{-}X_{i}^{+}X_{i}^{-} - \beta_{i}X_{i}^{-}X_{i+1}^{-}X_{i+1}^{+} - \gamma_{i}X_{i}^{-} \\ &= y_{i}X_{i}^{-} - \alpha_{i}X_{i}^{-}X_{i}^{+}X_{i}^{-} - \beta_{i}X_{i}^{-}X_{i+1}^{-}X_{i+1}^{+} - \gamma_{i}X_{i}^{-} \\ &= X_{i}^{-}\sigma(y_{i}) - \alpha_{i}X_{i}^{-}X_{i}^{+}X_{i}^{-} - \beta_{i}X_{i}^{-}X_{i+1}^{-}X_{i+1}^{+} - \gamma_{i}X_{i}^{-} \\ &= X_{i}^{-}(\alpha_{i}y_{i+1} + \beta_{i}x_{i+1} + \gamma_{i}) - \alpha_{i}X_{i}^{-}X_{i}^{+}X_{i}^{-} - \beta_{i}X_{i}^{-}X_{i+1}^{-}X_{i+1}^{+} - \gamma_{i}X_{i}^{-} \\ &= X_{i}^{-}(\alpha_{i}y_{i+1} + \beta_{i}x_{i+1} + \gamma_{i}) - \alpha_{i}X_{i}^{-}X_{i}^{+}X_{i}^{-} - \beta_{i}X_{i}^{-}X_{i+1}^{-}X_{i+1}^{+} - \gamma_{i}X_{i}^{-} = 0, \\ \theta(d_{i})\theta(d_{i-1})\theta(u_{i-1}) - \alpha_{i}\theta(d_{i})\theta(d_{i}) - \beta_{i}\theta(u_{i+1})\theta(d_{i+1})\theta(d_{i}) + \gamma_{i}\theta(d_{i}) \\ &= X_{i}^{+}X_{i-1}^{+}X_{i-1}^{-} - \alpha_{i}X_{i}^{+}X_{i}^{-}X_{i}^{+} - \beta_{i}X_{i+1}^{-}X_{i+1}^{+}X_{i}^{+} - \gamma_{i}X_{i}^{+} \\ &= X_{i}^{+}y_{i} - \alpha_{i}X_{i}^{+}X_{i}^{-}X_{i}^{+} - \beta_{i}X_{i-1}^{-}X_{i+1}^{+}X_{i}^{+} - \gamma_{i}X_{i}^{+} \\ &= \sigma(y_{i})X_{i}^{+} - \alpha_{i}X_{i}^{+}X_{i}^{-}X_{i}^{+} - \beta_{i}X_{i-1}^{-}X_{i+1}^{+}X_{i}^{+} - \gamma_{i}X_{i}^{+} \\ &= (\alpha_{i}y_{i+1} + \beta_{i}x_{i+1} + \gamma_{i})X_{i}^{+} - \alpha_{i}X_{i}^{+}X_{i}^{-}X_{i}^{+} - \beta_{i}X_{i+1}^{-}X_{i+1}^{+}X_{i+1}^{+} - \gamma_{i}X_{i}^{+} = 0. \end{split}$$

Hence, θ extends to an algebra homomorphism.

Now define $\theta': T \to \mathcal{H}$ by

$$\theta'(X_i^-) = u_i, \quad \theta'(X_i^+) = d_i, \quad \theta'(x_i) = X_i^- X_i^+, \quad \theta'(y_i) = X_{i-1}^+ X_{i-1}^-.$$

One verifies similarly that θ' defines an algebra homomorphism, which is clearly inverse to θ .

Corollary 2.2. Suppose $\beta_i \neq 0$ for all $i \in Q_0$.

- (1) The quiver down-up algebra $\mathcal{H}(\alpha, \beta, \gamma)$ is noetherian.
- (2) The subalgebra $\mathbb{k}[u_i d_i, d_{i-1} u_{i-1}]$ is a polynomial ring in two variables for all $i \in Q_0$.

Proof. Property (1) is clear. For (2), let θ be as in Proposition 2.1, so $\theta(u_i d_i) = x_i$ and $\theta(d_{i-1}u_{i-1}) = y_i$. As x_i and y_i commute and are algebraically independent in R, the same is true of their preimages.

Let R be a ring with a complete set e_0, \ldots, e_{n-1} of orthogonal idempotents. For example, $R = \mathbb{k}Q$ with Q a finite quiver. Then R is a piecewise domain (PWD) if ab = 0 implies a = 0 or b = 0 for all $a \in e_i R e_k$ and $b \in e_k R e_j$ [10]. For example, the direct sum of domains is a piecewise domains, and a polynomial extension of a piecewise domain is a piecewise domain. We extend these examples below.

Proposition 2.3. Let R be a PWD with complete set e_0, \ldots, e_{n-1} of orthogonal idempotents. Let σ be an automorphism of R.

- (1) The Ore extension $R[x; \sigma, \delta]$ is a PWD.
- (2) The GWA $R(\sigma, h)$ is a PWD.

Proof. (1) Set $S = R[x; \sigma, \delta]$. Let $a \in e_i S e_k$ and $b \in e_k S e_j$ be nonzero. By definition of an Ore extension, $a = e_i \sum_{u=0}^{d} r_u x^u e_k$ and $b = e_k \sum_{v=0}^{d'} r_v x^v e_j$ with $r_u, r_v \in R$ for all u, v and $r_d, r_{d'} \neq 0$. Now the top degree term of ab is

$$(e_i r_d x^d e_k)(e_k r_{d'} x^{d'} e_i) = (e_i r_d \sigma^d(e_k))(\sigma^d(e_k) \sigma^d(r_{d'}) \sigma^{d+d'}(e_i))x^{d+d'} + (\text{lower degree terms}).$$

Note that $0 \neq e_i r_d x^d e_k = e_i r_d \sigma^d(e_k) x^d$. That is, $e_i r_d \sigma^d(e_k) \neq 0$. Similarly, $e_k r_{d'} \sigma^{d'}(e_j) \neq 0$. Thus,

$$0 \neq \sigma^d(e_k r_{d'} \sigma^{d'}(e_j)) = \sigma^d(e_k) \sigma^d(r_{d'}) \sigma^{d+d'}(e_j).$$

Because R is a PWD, then $(e_i r_d \sigma^d(e_k))(\sigma^d(e_k) \sigma^d(r_{d'}) \sigma^{d+d'}(e_j)) \neq 0$. Thus, $ab \neq 0$, so S is a PWD.

(2) This is similar and requires only minimal modification. Set $T = R(\sigma, h)$. Let $a \in e_i T e_k$ and $b \in e_k T e_j$. For $k \in \mathbb{Z}$, let $X^k = (X^+)^k$ if k > 0 and $X^k = (X^-)^{-k}$ if k < 0. Then $a = e_i \sum_{u=d_1}^{d_2} r_u X^u e_k$ and $b = e_k \sum_{v=d'_1}^{d'_2} r_v X^v e_j$ with $r_u, r_v \in R$ for all u, v and $r_{d_1}, r_{d_2}, r_{d'_1}, r_{d'_2} \neq 0$. The remainder of the proof follows similarly. In particular, the top degree term of ab is $(e_i r_{d_2} x^{d_2} e_k)(e_k r_{d'_2} x^{d'_2} e_j)$.

Corollary 2.4. Suppose $\beta_i \neq 0$ for all i. Then $\mathcal{H}(\alpha, \beta, \gamma)$ is a PWD.

Proof. This follows from Propositions 2.1 and 2.3.

3. Skew group algebras and twisted CY algebras

In this section we establish that the $\mathcal{H}(\alpha, \beta, 0)$ are twisted graded Calabi–Yau. The *enveloping algebra* of an algebra A is defined as $A^e = A \otimes_{\mathbb{k}} A^{\text{op}}$.

Definition 3.1. An algebra A is homologically smooth if A has a finite-length resolution by finitely generated projective A^e -modules. The algebra A is twisted Calabi-Yau of dimension d if it is homologically smooth and there exists an invertible (A, A)-bimodule U such that there are right A^e -module isomorphisms

$$\operatorname{Ext}_{A^e}^i(A, A^e) \cong \begin{cases} 0 & i \neq d \\ U & i = d. \end{cases}$$

If $U = {}^{1}A^{\mu}$ for an automorphism μ of A, then we call μ the Nakayama automorphism.

We will use μ^A to denote the Nakayama automorphism of the algebra A, and we will omit the superscript when the algebra is clear. Note that the Nakayama is unique up to composition with an inner automorphism. That is, ${}^1A^{\mu} \cong {}^1A^{\nu}$ if and only if $\mu\nu^{-1}$ is an inner automorphism [15, Lemma 1.7(d)].

One can also make appropriate adjustments to the above definition to obtain the definition of twisted graded Calabi–Yau algebras. For example, one can insist that the resolution is by graded A^e -modules. By [17, Theorem 4.2], a graded algebra A is twisted graded Calabi–Yau if and only if it is twisted Calabi–Yau. In this setting the Nakayama automorphism μ^A is necessarily graded, and we use the notation μ_0^A to denote the restriction of μ^A to A_0 . A connected graded algebra A is twisted Calabi–Yau if and only if it is Artin–Schelter regular [15, Lemma 1.2].

3.1. Superpotential algebras. Let η be an automorphism of $\mathbb{k}Q$. An η -twisted superpotential of $\mathbb{k}Q$ is a linear combination of paths of length d that is invariant under the linear map sending the path $a_1a_2\cdots a_d$ to $(-1)^{d+1}\eta(a_d)a_1\cdots a_{d-1}$. In the name of efficiency, we will often use the following shorthand to write superpotentials. Let $p=a_1a_2\cdots a_d$ be a summand of a superpotential ω . Let S denote the set of signed η -twists of p. Then the compact form of p is $[p]=\sum_{s\in S}s$.

For each $a \in Q_1$, there is a (linear) map δ_a sending the path $a_1a_2\cdots a_d$ to $a_2\cdots a_d$ if $a=a_1$ and 0 otherwise. Given an η -twisted superpotential ω and an integer $k \geq 0$, the corresponding derivation-quotient algebra is kQ/I where $I=(\partial_a\omega:a\in Q_1)$. Hence, I is generated by relations of the same degree r. Let A=kQ/I be twisted graded Calabi–Yau of dimension three. By [5, Theorem 6.8, Remark 6.9], A is a derivation-quotient algebra for some η -twisted superpotential ω .

The following is easy to verify.

Lemma 3.2. Suppose $\beta_i \neq 0$ for all $i \in Q_0$ and let Q be as in (0.1). Define $\eta \in \operatorname{Aut}_{\operatorname{gr}}(\mathbb{k}Q)$ by $\eta(u_i) = \beta_{i-1}u_i$ and $\eta(d_i) = \beta_{i-1}d_i$ for all $i \in Q_0$. Then the algebra $\mathcal{H} = \mathcal{H}(\alpha, \beta, 0)$ is the derivation-quotient algebra on $\mathbb{k}Q$ with η -twisted superpotential

$$\Omega = \sum_{i \in O_0} [d_i d_{i-1} u_{i-1} u_i] - \alpha_i [d_i u_i d_i u_i].$$

3.2. Skew group algebras. Skew group algebras over Artin–Schelter regular algebras provide a plethora of examples of twisted graded Calabi–Yau algebras.

Let R be a ring and G a finite group action on R via automorphism. As a vector space, the *skew group* $ring \ R \# \& G$ is $R \otimes \& G$ and multiplication is defined as

$$(r\#g)(s\#h) = rg(s)\#gh,$$

for all $r \# g, s \# h \in R \# \Bbbk G$, extended linearly.

Let R be a twisted graded Calabi–Yau of dimension d, generated by R_1 . Let G be a finite group acting homogeneously on R. Then A = R # & G is also twisted graded Calabi–Yau of dimension d, generated by A_0

and A_1 [15, Theorem 4.1(c)]. Let $e \in A_0$ be a full idempotent such that B = eAe is graded elementary with $B_0 = \mathbb{k}^m$ for some m. Then B is Morita equivalent to A and so B is also twisted graded Calabi–Yau of dimension d [16, Theorem 4.3, Lemma 6.2]. Furthermore, $B \cong \mathbb{k}Q/I$ where Q is the McKay matrix of the action of G on R_1 and $I \in \mathbb{k}Q_{\geq 2}$.

Let R be a twisted graded Calabi–Yau of dimension d, generated by R_1 . Let G be a finite group acting homogeneously on R. Then A = R # & G is also twisted graded Calabi–Yau of dimension d, generated by A_0 and A_1 [15, Theorem 4.1(c)]. Let $e \in A_0$ be a full idempotent such that B = eAe is graded elementary with $B_0 = \&^m$ for some m. Then B is Morita equivalent to A and so B is also twisted graded Calabi–Yau of dimension d [16, Theorem 4.3, Lemma 6.2]. Furthermore, $B \cong \& Q/I$ where Q is the McKay matrix of the action of G on R_1 and $I \in \& Q_{\geq 2}$.

Now let $R = \mathbb{k}\langle u, d \mid d^2u + ud^2, du^2 + u^2d \rangle$. The algebra R is a graded down-up algebra, which is Artin–Schelter regular (and Calabi–Yau) of global dimension three. In particular, R is a derivation-quotient algebra with potential $\Omega = [d^2u^2]$ and $\eta = \mathrm{id}_R$. Choose $n \geq 2$ and let $G = \mathbb{Z}_n = \langle g \rangle$ act on R by $g(u) = \xi u$ and $g(d) = \xi^{-1}d$, where ξ is a primitive nth root of unity. It is easy to see that the McKay quiver corresponding to the group action of G on R_1 is the adjacency matrix M of the quiver Q as in (0.1).

In R # & G, define the orthogonal idempotents $f_i = \frac{1}{n} \sum_{j=0}^{n-1} \xi^{ij} \# g^j$. Let $f = f_0 + \dots + f_{n-1}$, so that f is a full idempotent, and set B = f(R # & G)f. Then B is graded Calabi–Yau of dimension three and since $g(\Omega) = \Omega$, then hdet g = 1 and so B has type (M, I, 4). We claim that B is isomorphic to a quiver down-up algebra.

Lemma 3.3. Let B be as above. Then

$$h_B = (I - Mt + It^2)^{-1} (1 - t^2)^{-1}$$
$$h_B^{\text{tot}} = n(1 - t)^{-2} (1 - t^2)^{-1}.$$

Proof. Since B is twisted graded Calabi–Yau of global dimension three and of type (M, I, 4), and because $M = M^T$, then h_B is as stated by [16, Theorem 1.3]. It suffices to show that the matrix-valued Hilbert series corresponds to the total Hilbert series as stated.

We have $h_B = p(t)^{-1}$ where

$$p(t) = I - Mt + Mt^3 - It^4 = (1 - t^4)I - (t - t^3)M = (1 - t^2)(I - Mt + It^2).$$

We note that $(I - Mt + It^2)^{-1}$ is the Hilbert series of the algebra A in Example (1.2). By that example, the total Hilbert series of A is $n(1 - t^2)^{-1}$. It follows that $h_B^{\text{tot}} = n(1 - t^2)^{-1}(1 - t^2)^{-1}$.

Lemma 3.4. Keep the above setup. Set $\beta_i = 1$ for all $i \in Q_0$ and let $\mathcal{H} = \mathcal{H}(0, \beta, 0)$. Then $B \cong \mathcal{H}$.

Proof. In B, set $U_i = f_i(u \# f)$ and $D_i = (d \# f) f_i$ for all $i \in Q_0$. A calculation shows

$$U_i = f_i(u \# f) = \left(\frac{1}{n} \sum_{j=0}^{n-1} \xi^{ij} \# g^j\right) (u \# f) = \frac{1}{n} \sum_{j=0}^{n-1} \xi^{ij} (\xi^j u) \# g^j = (u \# f) \left(\frac{1}{n} \sum_{j=0}^{n-1} \xi^{(i+1)j} \# g^j\right) = (u \# f) f_{i+1}.$$

Similarly, $D_i = (d \# f) f_i = f_{i+1}(d \# f)$. Now

$$D_{i-1}U_{i-1}U_{i} + U_{i}U_{i+1}D_{i+1} = (d\#f)f_{i-1}f_{i-1}(u\#f)f_{i}(u\#f) + f_{i}(u\#f)f_{i+1}(u\#f)f_{i+2}(d\#f)$$

$$= f_{i}((d\#f)(u\#f)(u\#f) + (u\#f)(u\#f)(d\#f))$$

$$= f_{i}(du^{2} + u^{2}d)\#f = 0,$$

$$D_{i}D_{i-1}U_{i-1} + U_{i+1}D_{i+1}D_{i} = (d\#f)f_{i}(d\#f)f_{i-1}f_{i-1}(u\#f) + f_{i+1}(u\#f)(d\#f)f_{i+1}(d\#f)f_{i}$$

$$= f_{i+1}((d\#f)(d\#f)(u\#f) + (u\#f)(d\#f)(d\#f))$$

$$= f_{i+1}(du^{2} + u^{2}d)\#f = 0.$$

Thus, there is a surjective homomorphism $\phi: \mathcal{H} \to B$ given by $e_i \mapsto f_i$, $u_i \mapsto U_i$, and $d_i \mapsto D_i$ for all $i \in Q_0$. Since $h_{\mathcal{H}}^{\text{tot}} = h_B^{\text{tot}}$ (Corollary 1.3 and Lemma 3.3, respectively), then ϕ is an isomorphism.

Lemma 3.5. Let M be the adjacency matrix for Q as in (0.1). Let $\alpha, \beta \in \mathbb{R}^n$ and set $\mathcal{H} = \mathcal{H}(\alpha, \beta, 0)$. Then

$$h_{\mathcal{H}} = (I - Mt + Mt^3 - It^4)^{-1} = (I - Mt + It^2)^{-1}(1 - t^2)^{-1}.$$

Proof. Since B is graded Calabi–Yau of dimension three of type (M, I, 4), then by [16, Theorem 1.3] its Hilbert series is $h_B = (I - Mt + Mt^3 - It^4)^{-1}$. Thus, by Lemma 3.4, the result holds when $\alpha_i = 0$ and $\beta_i = 1$ for all i. However, the k-basis given in Proposition (1.1) does not depend on the choice of α and β .

We are now (almost) ready to prove that the $\mathcal{H}(\alpha, \beta, 0)$ are twisted graded Calabi–Yau. We first need one additional definition.

Let A be a locally finite graded algebra. The graded left socle of A is $soc_l(A) = \{x \in A \mid J(A)x = 0\}$ where J(A) is the graded Jacobson radical. Similarly, $soc_r(A) = \{x \in A \mid xJ(A) = 0\}$ is the graded right socle of A. If A = kQ/I for a homogeneous ideal I, then J(A) is the arrow ideal generated by Q_1 .

Theorem 3.6. Suppose $\beta_i \neq 0$ for all $i \in Q_0$. Then $\mathcal{H} = \mathcal{H}(\alpha, \beta, 0)$ is twisted-graded Calabi–Yau of global dimension three with Nakayama automorphism $\mu^{\mathcal{H}}$ given by $\mu^{\mathcal{H}}(u_i) = -\beta_{i-1}^{-1}u_i$ and $\mu^{\mathcal{H}}(d_i) = -\beta_{i-1}^{-1}d_i$ for all $i \in Q_0$.

Proof. Let M be the adjacency matrix for Q as in (0.1). By Lemma 3.5, $h_{\mathcal{H}} = (I - Mt + M^Tt^3 - It^4)^{-1}$. Since \mathcal{H} is a PWD by Corollary 2.4, then it has trivial graded left and right socle. Since the restriction of β to Q_0 is trivial, then by [16, Lemma 8.6], \mathcal{H} is twisted Calabi–Yau of dimension three.

By [5, Theorem 6.8], the Nakayama automorphism of \mathcal{H} is $\mu^{\mathcal{H}} = (-1)^{d+1}\eta^{-1}$. Note that our convention on composing paths is opposite from that reference, hence the inverse.

It follows from Theorem 3.6 that $H(\alpha, \beta, 0)$ is Calabi–Yau when $\beta_i = -1$ for all i. In this case, let Ω be the potential from Lemma 3.2 and let $\Omega' = \gamma_i [u_i d_i]$. Then $\Omega + \Omega'$ is an inhomogeneous potential and it follows from [4, Theorem 3.6] that $H(\alpha, \beta, \gamma)$ is Calabi–Yau. We conjecture that $H(\alpha, \beta, \gamma)$ is twisted Calabi–Yau in general.

4. Main proof

We need one additional result before we are ready to prove our main theorem. The following is analogous to [12, Lemma 4.3].

Lemma 4.1. Let $\mathcal{H} = \mathcal{H}(\alpha, \beta, \gamma)$. If $\beta_i = 0$ for some $i \in Q_0$, then \mathcal{H} is not noetherian.

Proof. Let $|Q_0| = n$. Suppose $\beta_i = 0$. We claim that A is not right noetherian. Since $A = \bigoplus_{j=0}^{n-1} e_j A$, it suffices to show that $e_i A$ is not noetherian as a right A-module.

We generalize the proof of [12, Lemma 4.3]. For any m = 0, ..., n-1, set $x_m = d_m u_m$. By Proposition 1.1, $e_i A$ has a k-basis of the form

$$(4.1) (u_i u_{i+1} \cdots u_{i+k}) x_{i+k}^j (d_{i+k} d_{i+k-1} \cdots d_{i+k-\ell})$$

with $k, j, \ell \geq 0$.

Since $\beta_i = 0$, the relations in Definition 0.1 yield

$$(\alpha_i u_i d_i + \gamma_i - x_{i-1}) u_i = d_i (\alpha_i u_i d_i + \gamma_i - x_{i-1}) = 0$$

Note that if $u_k \neq u_i$, then $(\alpha_i u_i d_i - x_{i-1})u_k = 0$ because of the source and target mismatch.

Set $U = u_i u_{i+1} \cdots u_{i-1+n}$. That is, U is the product of the distinct u_m , starting at u_i . Then for $u_k \neq u_i$,

$$U(\alpha_i u_i d_i + \gamma_i - x_{i-1})u_k = \gamma_i U u_k = 0.$$

Thus

$$(4.3) U(\alpha_i u_i d_i + \gamma_i - x_{i-1}) u_m = 0 \text{ for all } m \in \mathbb{Z}.$$

For each $s \geq 1$, define

$$I_s = \sum_{m=1}^{s} U^m (\alpha_i u_i d_i + \gamma_i - x_{i-1}) A.$$

By (4.3),

$$I_s = \sum_{m=1}^s \sum_{i,k>0} \mathbb{k} U^m (\alpha_i u_i d_i + \gamma_i - x_{i-1}) x_{i-1}^j d_{i-1} d_{i-2} \cdots d_{i-k}.$$

By (4.2), $d_i x_{i-1} = d_i \alpha_i u_i d_i + \gamma_i d_i = (\alpha_i x_i + \gamma_i) d_i$ and hence $d_i x_{i-1}^j = (\alpha_i x_i + \gamma_i)^j d_i$ for any $j \ge 0$. Thus I_s is contained in the k-span of the basis monomials

$$U^m x_{i-1}^{j+1} d_{i-1} d_{i-2} \cdots d_{i-k}, \qquad U^m u_i x_i^j d_i d_{i-1} d_{i-2} \cdots d_{i-k}$$

with $k, j \ge 0$ and $1 \le m \le s$. Thus no polynomial in I_s has $U^{s+1}x_{i-1}$ in its support, while I_{s+1} does contain the polynomial $U^{s+1}(\alpha_i u_i d_i + \gamma_i - x_{i-1})$.

Thus $I_s \subsetneq I_{s+1}$ for all $s \geq 0$ and so $e_i A$ is not noetherian. So A is not right noetherian. A similar proof shows that A is not left noetherian.

Theorem 4.2. Let $\alpha, \beta, \gamma \in \mathbb{k}^n$ and let $\mathcal{H} = \mathcal{H}(\alpha, \beta, \gamma)$. The following are equivalent.

- (1) $\beta_i \neq 0$ for all $i \in Q_0$,
- (2) \mathcal{H} is right (or left) noetherian,
- (3) $\mathbb{k}[u_i d_i, d_{i-1} u_{i-1}]$ is a polynomial ring in two variables for all $i \in Q_0$,
- (4) \mathcal{H} is a piecewise domain.

Proof. Suppose $\beta_i \neq 0$ for all i. Then (2) and (3) follow from Corollary 2.2, and (4) follows from Corollary 2.4.

Suppose $\beta_i = 0$ for some $i \in Q_0$. By Lemma 4.1, \mathcal{H} is not noetherian so (2) fails. Then we have

$$(4.4) (d_{i-1}u_{i-1} - \alpha_i u_i d_i - \gamma_i)u_i = 0,$$

$$(4.5) d_i(d_{i-1}u_{i-1} - \alpha_i u_i d_i - \gamma_i) = 0,$$

which shows that \mathcal{H} is not a piecewise domain, so (4) fails. Moreover, we have $(d_{i-1}u_{i-1} - \alpha_i u_i d_i - \gamma_i)u_i d_i = 0$, so $u_i d_i$ and $d_{i-1}u_{i-1}$ are algebraically dependent and (3) fails.

5. The isomorphism problem

In [9], the authors consider the isomorphism problem for quantum analogues of type A preprojective algebras. The following results are closely related because the algebras live on the same quivers. The isomorphisms of the next lemma correspond respectively to scaling, rotation, and reflection.

Lemma 5.1. Let $\alpha, \beta, \gamma \in \mathbb{k}^n$.

(1) Let $\lambda \in (\mathbb{K}^{\times})^n$. For all $i \in Q_0$, set $\alpha'_i = \lambda_i \lambda_{i-1}^{-1} \alpha_i$, $\beta'_i = \lambda_{i+1} \lambda_{i-1}^{-1} \beta_i$, and $\gamma'_i = \lambda_{i-1}^{-1} \gamma_i$. Then the linear map $\phi_{\lambda} : \mathcal{H}(\alpha, \beta, \gamma) \to \mathcal{H}(\alpha', \beta', \gamma')$ defined by

$$\phi_{\lambda}(e_i) = e_i, \qquad \phi_{\lambda}(u_i) = \lambda_i u_i, \qquad \phi_{\lambda}(d_i) = d_i,$$

extends to an isomorphism.

(2) For all $i \in Q_0$, set $\alpha'_i = \alpha_{i-1}$, $\beta'_i = \beta_{i-1}$, and $\gamma'_i = \gamma_{i-1}$. Then linear map $\psi : \mathcal{H}(\alpha, \beta, \gamma) \to \mathcal{H}(\alpha', \beta', \gamma')$ defined by

$$\psi(e_i) = e_{i+1}, \qquad \psi(u_i) = u_{i+1}, \qquad \psi(d_i) = d_{i+1},$$

extends to an isomorphism.

(3) Suppose $\beta_i \neq 0$ for all $i \in Q_0$. For all $i \in Q_0$, set $\alpha'_i = -\beta_{n-i-1}^{-1}\alpha_{n-i-1}$, $\beta'_i = \beta_{n-i-1}^{-1}$, and $\gamma'_i = -\beta_{n-i-1}^{-1}\gamma_{n-i-1}$. Then the linear map $\pi : \mathcal{H}(\alpha, \beta, \gamma) \to \mathcal{H}(\alpha', \beta', \gamma')$ defined by

$$\pi(e_i) = e_{n-i}, \qquad \pi(u_i) = d_{n-i-1}, \qquad \pi(d_i) = u_{n-i-1},$$

extends to an isomorphism.

Proof. The maps are all clearly bijective as linear maps. It suffices to show that each respects the relations on $\mathcal{H}(\alpha, \beta, \gamma)$. For ϕ_{α} :

$$\phi_{\lambda}(d_{i-1})\phi_{\lambda}(u_{i-1})\phi_{\lambda}(u_{i}) - \alpha_{i}\phi_{\lambda}(u_{i})\phi_{\lambda}(d_{i})\phi_{\lambda}(u_{i}) - \beta_{i}\phi_{\lambda}(u_{i})\phi_{\lambda}(u_{i+1})\phi_{\lambda}(d_{i+1}) - \gamma_{i}\phi_{\lambda}(u_{i})$$

$$= \lambda_{i}(\lambda_{i-1}d_{i-1}u_{i-1}u_{i} - \lambda_{i}\alpha_{i}u_{i}d_{i}u_{i} - \lambda_{i+1}\beta_{i}u_{i}u_{i+1}d_{i+1} - \gamma_{i}u_{i})$$

$$= \lambda_{i}\lambda_{i-1}(d_{i-1}u_{i-1}u_{i} - \alpha'_{i}u_{i}d_{i}u_{i} - \beta'_{i}u_{i}u_{i+1}d_{i+1} - \gamma'_{i}u_{i}) = 0$$

$$\phi_{\lambda}(d_{i})\phi_{\lambda}(d_{i-1})\phi_{\lambda}(u_{i-1}) - \alpha_{i}\phi_{\lambda}(d_{i})\phi_{\lambda}(u_{i})\phi_{\lambda}(d_{i}) - \beta_{i}\phi_{\lambda}(u_{i+1})\phi_{\lambda}(d_{i+1})\phi_{\lambda}(d_{i}) - \gamma_{i}\phi_{\lambda}(d_{i})$$

$$= \lambda_{i-1}d_{i}d_{i-1}u_{i-1} - \lambda_{i}\alpha_{i}d_{i}u_{i}d_{i} - \lambda_{i+1}\beta_{i}u_{i+1}d_{i+1}d_{i} - \gamma_{i}d_{i}$$

$$= \lambda_{i-1}(d_{i}d_{i-1}u_{i-1} - \alpha'_{i}d_{i}u_{i}d_{i} - \beta'_{i}u_{i+1}d_{i+1}d_{i} - \gamma'_{i}d_{i}) = 0.$$

For ψ :

$$\psi(d_{i-1})\psi(u_{i-1})\psi(u_{i}) - \alpha_{i}\psi(u_{i})\psi(d_{i})\psi(u_{i}) - \beta_{i}\psi(u_{i})\psi(u_{i+1})\psi(d_{i+1}) - \gamma_{i}\psi(u_{i})$$

$$= d_{i}u_{i}u_{i+1} - \alpha'_{i+1}u_{i+1}d_{i+1}u_{i+1} - \beta'_{i+1}u_{i+1}u_{i+2}d_{i+2} - \gamma'_{i+1}u_{i+1} = 0$$

$$\psi(d_{i})\psi(d_{i-1})\psi(u_{i-1}) - \alpha_{i}\psi(d_{i})\psi(u_{i})\psi(d_{i}) - \beta_{i}\psi(u_{i+1})\psi(d_{i+1})\psi(d_{i}) - \gamma_{i}\psi(d_{i})$$

$$= d_{i+1}d_{i}u_{i} - \alpha'_{i+1}d_{i+1}u_{i+1}d_{i+1} - \beta'_{i+1}u_{i+2}d_{i+2}d_{i+1} - \gamma'_{i+1}d_{i+1} = 0.$$

Finally, for π :

$$\pi(d_{i-1})\pi(u_{i-1})\pi(u_{i}) - \alpha_{i}\pi(u_{i})\pi(d_{i})\pi(u_{i}) - \beta_{i}\pi(u_{i})\pi(u_{i+1})\pi(d_{i+1}) - \gamma_{i}\pi(u_{i})$$

$$= u_{n-i}d_{n-i}d_{n-i-1} - \alpha_{i}d_{n-i-1}u_{n-i-1}d_{n-i-1} - \beta_{i}d_{n-i-1}d_{n-i-2}u_{n-i-2} - \gamma_{i}d_{n-i-1}$$

$$= -\beta_{i}(d_{n-i-1}d_{n-i-2}u_{n-i-2} - \alpha'_{n-i-1}d_{n-i-1}u_{n-i-1}d_{n-i-1})$$

$$- \beta'_{n-i-1}u_{n-i}d_{n-i}d_{n-i-1} - \gamma'_{n-i-1}d_{n-i-1}) = 0$$

$$\pi(d_{i})\pi(d_{i-1})\pi(u_{i-1}) - \alpha_{i}\pi(d_{i})\pi(u_{i})\pi(d_{i}) - \beta_{i}\pi(u_{i+1})\pi(d_{i+1})\pi(d_{i}) - \gamma_{i}\pi(d_{i})$$

$$= u_{n-i-1}u_{n-i}d_{n-i} - \alpha_{i}u_{n-i-1}d_{n-i-1}u_{n-i-1} - \beta_{i}d_{n-i-2}u_{n-i-2}u_{n-i-1} - \gamma_{i}u_{n-i-1}$$

$$= -\beta_{i}(d_{n-i-2}u_{n-i-2}u_{n-i-1} - \alpha'_{n-i-1}u_{n-i-1}d_{n-i-1}u_{n-i-1}) = 0.$$

Hence, each linear map extends to an isomorphism.

In general, we do not know the answer to the isomorphism problem for the quiver down-up algebras. However, in the graded case with $n \geq 3$ vertices, we obtain a complete classification of isomorphism classes.

Theorem 5.2. Fix $n \geq 3$. Let $\alpha, \alpha' \in \mathbb{k}^n$ and $\beta, \beta' \in (\mathbb{k}^{\times})^n$. Then $\mathcal{H}(\alpha, \beta, 0) \cong \mathcal{H}(\alpha', \beta', 0)$ if and only if there exists $\lambda \in (\mathbb{k}^{\times})^n$ and $k \in Q_0$ such that one of the following hold:

(1)
$$\alpha'_i = \lambda_{i+k} \lambda_{i+k-1}^{-1} \alpha_{i+k}, \quad \beta'_i = \lambda_{i+k+1} \lambda_{i+k-1}^{-1} \beta_{i+k}, \text{ or }$$

(2)
$$\alpha'_{i} = -\lambda_{n-i-k}^{-1}\lambda_{n-i-k-1}\beta_{n-i-k-1}^{-1}\alpha_{n-i-k-1}, \quad \beta'_{i} = \lambda_{n-i-k}^{-1}\lambda_{n-i-k-2}^{-1}\beta_{n-i-k-1}^{-1}.$$

Proof. If (1) holds for some $\lambda_i \in \mathbb{k}^{\times}$, then by Lemma 5.1, $\psi^{-k} \circ \phi_{\lambda}$ gives the intended isomorphism. If (2) holds for some $\lambda_i \in \mathbb{k}^{\times}$, then by Lemma 5.1, $\psi^{-k} \circ \pi \circ \phi_{\lambda}$ gives the intended isomorphism.

Set $\mathcal{H} = \mathcal{H}(\alpha, \beta, 0)$ and $\mathcal{H}' = \mathcal{H}(\alpha', \beta', 0)$. Assume $\Phi : \mathcal{H} \to \mathcal{H}'$ is an isomorphism. By [7, Theorem 8], we may assume that Φ is a graded isomorphism. Then Φ restricts to a permutation of the set of vertices $\{e_i\}$. Since u_i is an arrow from e_i to e_{i+1} , then this permutation preserves adjacency. Hence, Φ may be regarded as an element of the dihedral group on n vertices.

First, suppose that $\Phi(e_i) = e_i$ for all i. As we have assumed $n \geq 3$, then Q, as in (0.1), is schurian. Thus, there are scalars $\mu_i, \nu_i \in \mathbb{k}^{\times}$ such that $\Phi(u_i) = \mu_i u_i$ and $\Phi(d_i) = \nu_i d_i$ for all $i \in Q_0$. Then

$$\begin{split} 0 &= \Phi(d_{i-1}u_{i-1}u_i - \alpha_iu_id_iu_i - \beta_iu_iu_{i+1}d_{i+1}) \\ &= \mu_i(\mu_{i-1}\nu_{i-1}d_{i-1}u_{i-1}u_i - \alpha_i\mu_i\nu_iu_id_iu_i - \beta_i\mu_{i+1}\nu_{i+1}u_iu_{i+1}d_{i+1}) \\ &= \mu_i\mu_{i-1}\nu_{i-1}(d_{i-1}u_{i-1}u_i - \alpha_i(\mu_i\nu_i)(\mu_{i-1}\nu_{i-1})^{-1}u_id_iu_i - \beta_i(\mu_{i+1}\nu_{i+1})(\mu_{i-1}\nu_{i-1})^{-1}u_iu_{i+1}d_{i+1}) \\ 0 &= \Phi(d_id_{i-1}u_{i-1} - \alpha_id_iu_id_i - \beta_iu_{i+1}d_{i+1}d_i) \\ &= \nu_i(\mu_{i-1}\nu_{i-1}d_id_{i-1}u_{i-1} - \mu_i\nu_i\alpha_id_iu_id_i - \beta_i\mu_{i+1}\nu_{i+1}u_{i+1}d_{i+1}d_i) \\ &= \nu_i(d_id_{i-1}u_{i-1} - (\mu_i\nu_i)(\mu_{i-1}\nu_{i-1})^{-1}\alpha_id_iu_id_i - \beta_i(\mu_{i+1}\nu_{i+1})(\mu_{i-1}\nu_{i-1})^{-1}u_{i+1}d_{i+1}d_i). \end{split}$$

Setting $\lambda_i = \mu_i \nu_i$ gives (1) for k = 0.

Now assume that Φ corresponds to a (nontrivial) rotation, so $\Phi(e_i) = e_{i-k}$ for some k, 0 < k < n. Set $\alpha_i'' = \alpha_{i-k}'$ and $\beta_i'' = \beta_{i-k}'$ and let $\mathcal{H}'' = \mathcal{H}(\alpha'', \beta'', 0)$. Thus, $\psi^k : \mathcal{H}' \to \mathcal{H}''$ is an isomorphism. Then $\psi^k \circ \Phi : \mathcal{H} \to \mathcal{H}''$ is an isomorphism that fixes the vertices. Consequently, there are scalars $\lambda_i \in \mathbb{R}^\times$ such that $\alpha_i'' = \lambda_i \lambda_{i-1}^{-1} \alpha_i$ and $\beta_i'' = \lambda_{i+1} \lambda_{i-1}^{-1} \beta_i$. Thus,

$$\alpha'_{i-k} = \lambda_i \lambda_{i-1}^{-1} \alpha_i \Rightarrow \alpha'_i = \lambda_{i+k} \lambda_{i+k-1}^{-1} \alpha_{i+k}$$
$$\beta'_{i-k} = \lambda_{i+1} \lambda_{i-1}^{-1} \beta_i \Rightarrow \beta'_i = \lambda_{i+k+1} \lambda_{i+k-1}^{-1} \beta_{i+k}.$$

Finally, assume Φ corresponds to a reflection, so $\Phi(e_i) = e_{n-i-k}$ for some $k \in Q_0$. Define $\mathcal{H}'' = \mathcal{H}(\alpha'', \beta'', 0)$ as above with $\alpha_i'' = \alpha_{i-k}'$ and $\beta_i'' = \beta_{i-k}'$, so that $\psi^k : \mathcal{H}' \to \mathcal{H}''$ is an isomorphism. Set $\alpha_i''' = -(\beta_{n-i-1}'')^{-1}(\alpha_{n-i-1}'')$ and $\beta_i''' = (\beta_{n-i-1}'')^{-1}$ and let $\mathcal{H}''' = \mathcal{H}(\alpha''', \beta''', 0)$ so that $\pi : \mathcal{H}'' \to \mathcal{H}'''$ is an isomorphism. Then $\pi \circ \psi^k \circ \Phi$ is an isomorphism that fixes the vertices, so there exists scalars $\lambda_i \in \mathbb{R}^\times$ such that $\alpha_i''' = \lambda_i \lambda_{i-1}^{-1} \alpha_i$ and $\beta_i''' = \lambda_{i+1} \lambda_{i-1}^{-1} \beta_i$. Unwinding, we have

$$\begin{split} \beta_i' &= \beta_{i+k}'' = (\beta_{n-i-k-1}''')^{-1} = \lambda_{n-i-k}^{-1} \lambda_{n-i-k-2} \beta_{n-i-k-1}^{-1} \\ \alpha_i' &= \alpha_{i+k}'' = -(\beta_{n-i-k-1}''')^{-1} (\alpha_{n-i-k-1}''') \\ &= -\left(\lambda_{n-i-k}^{-1} \lambda_{n-i-k-2} \beta_{n-i-k-1}^{-1}\right) (\lambda_{n-i-k-1} \lambda_{n-i-k-2} \alpha_{n-i-k-1}) \\ &= -\lambda_{n-i-k}^{-1} \lambda_{n-i-k-1} \beta_{n-i-k-1}^{-1} \alpha_{n-i-k-1}. \end{split}$$

This gives the result.

The isomorphism problem for n = 1 is known (see [6, Proposition 3.14] translated to down-up algebras). We anticipate that Theorem 5.2 holds in the case n = 2. However, because the quiver in this case is not schurian, then more work is required. See [9, Proposition 3.12].
