# A note on degree conditions for Ramsey goodness of trees

#### Abstract

For given graphs  $G_1, G_2$  and G, let  $G \to (G_1, G_2)$  denote that each red-bluecoloring of E(G) yields a red copy of  $G_1$  or a blue copy of  $G_2$ . Aragão, Marciano and Mendonça [L. Aragão, J. Pedro Marciano and W. Mendonça, Degree conditions for Ramsey goodness of paths, European Journal of Combinatorics, **124** (2025), 104082] proved the following. Let G be a graph on  $N \ge (n-1)(m-1)+1$  vertices. If  $\delta(G) \ge N - \lceil n/2 \rceil$ , then  $G \to (P_n, K_m)$ , where  $P_n$  is a tree on n vertices. In this note, we generalize  $P_n$  to any tree  $T_n$  with n vertices, and improve the lower bound of  $\delta(G)$ . We further improve the lower bound when  $T_n \ne K_{1,n-1}$ , which partially confirms their conjecture.

**Keywords:** Schelp problem; Ramsey goodness; tree.

#### 1 Introduction

For graphs  $G_1, \ldots, G_t$  and G, let  $G \to (G_1, \ldots, G_t)$  denote that any t-coloring of E(G) yields a monochromatic copy of  $G_i$  in color i for some  $i \in [t]$ . The Ramsey number  $r(G_1, \ldots, G_t)$  is the minimum positive integer N such that  $K_N \to (G_1, \ldots, G_t)$ . Let v(G)

and  $\chi(G)$  be the number of vertices and the chromatic number of G, respectively. Let s(G) be the surplus of G, which is the size of a minimum color class taken over all proper colorings of G with  $\chi(G)$  colors. Let  $T_n, K_{1,n-1}$  and  $P_n$  denote a tree, a star and a path on n vertices, respectively.

In 1981, Burr [3] observed the following. For a connected graph G and a graph H with  $v(G) \geq s(H)$ ,  $r(G, H) \geq (v(G) - 1)(\chi(H) - 1) + s(H)$  (let G' be a red copy of the complete  $\chi(H)$ -partite graph such that all parts have sizes v(G) - 1 except one with size s(H) - 1. Moreover, color all edges in each part by blue. The resulting graph contains neither a red copy of G nor a blue copy of H). We say that G is H-good if the equality holds. There is a classical result from Chvátal [4] showing that  $T_n$  is  $K_m$ -good for all positive integers n and m, that is,  $r(T_n, K_m) = (n-1)(m-1) + 1$ . Recently, a similar question has attracted a lot of attention, which originated from Schelp [6]. Let G be a graph on  $N \geq r(G_1, G_2)$  vertices, what minimum degree condition guarantees that  $G \to (G_1, G_2)$ ? Recently, Aragão, Pedro Marciano and Mendonça studied  $P_n$  versus  $K_m$ .

Theorem 1.1 (Aragão, Pedro Marciano and Mendonça [1]) Let G be a graph on  $N \ge r(P_n, K_m) = (n-1)(m-1) + 1$  vertices. If  $\delta(G) \ge N - \lceil n/2 \rceil$ , then  $G \to (P_n, K_m)$ . Moreover, they conjectured the following and showed that their conjecture holds for m = 3.

Conjecture 1.2 (Aragão, Pedro Marciano and Mendonça [1]) For given positive integers n, m, N and a non-negative integer t, assume that  $(t+1)(n-1)(m-1)+1 \le N \le (t+2)(n-1)(m-1)$ . Let G be a graph on N vertices with  $\delta(G) \ge N - \left\lceil \frac{t+1}{t+2} \left\lceil \frac{N}{m-1} \right\rceil \right\rceil$ . Then  $G \to (P_n, K_m)$ .

If Conjecture 1.2 is true, then the lower bound of  $\delta(G)$  in Conjecture 1.2 is tight as evidenced by the following construction.

Construction I. Assume that  $(t+1)(n-1)(m-1)+1 \leq N \leq (t+2)(n-1)(m-1)$ . Let G' be a complete almost balanced (m-1)-partite graph (the size of each part differs by at most one) on N vertices whose edges are colored by blue. Moreover, in each part, we embed a red copy of the graph consisting of the union of t+2 cliques such that the sizes of each clique differ by at most one. Denote the resulting graph by G. Note that  $G \not\to (P_n, K_m)$  (in fact,  $G \not\to (T_n, K_m)$ ) and  $\delta(G) = N - \lceil \frac{N}{m-1} \rceil + \lfloor \frac{1}{t+2} \lceil \frac{N}{m-1} \rceil \rfloor - 1$ .

In this note, we generalize  $P_n$  to  $T_n$ , improve the lower bound of  $\delta(G)$  in Theorem 1.1 for all m and  $t \geq 1$ , and partially confirm Conjecture 1.2. We first show the following result.

**Theorem 1.3** For given positive integers n, m, N and a non-negative integer t, assume that  $(t+1)(n-1)(m-1)+1 \le N \le (t+2)(n-1)(m-1)$ . Let G be a graph on N vertices with  $\delta(G) \ge N - t(n-1) - 1$ . Then  $G \to (T_n, K_m)$ .

Let  $\Delta = \Delta(T_n)$ . We remark that the lower bound on  $\delta(G)$  in Conjecture 1.2 is not tight for  $T_n$  when  $\Delta > \lfloor \frac{1}{t+2} \lceil \frac{N}{m-1} \rceil \rfloor$  and n is even as evidenced by the following construction.

Construction II. Let G' be a complete almost balanced (m-1)-partite graph on N vertices whose edges are colored by blue. In each part, we embed a red copy of a  $(\Delta - 1)$ -regular graph or a red copy of an almost  $(\Delta - 1)$ -regular graph (all vertices with degree  $\Delta - 1$  except one vertex with degree  $\Delta - 2$ ). Denote the resulting graph by H. Note that  $H \not\to (T_n, K_m)$  and  $\delta(H) = N - \lceil \frac{N}{m-1} \rceil + \Delta - \epsilon$ , where  $\epsilon = 1$  if we can replace it with a  $(\Delta - 1)$ -regular graph, and otherwise  $\epsilon = 2$ .

Conjecture 1.4 For given positive integers n, m, N and a non-negative integer t, assume that  $(t+1)(n-1)(m-1)+1 \le N \le (t+2)(n-1)(m-1)$ . Let G be a graph on N vertices with  $\delta(G) \ge N - \lceil \frac{N}{m-1} \rceil + \max\{\Delta - \epsilon + 1, \lfloor \frac{1}{t+2} \lceil \frac{N}{m-1} \rceil \rfloor\}$ . Then  $G \to (T_n, K_m)$ .

By Construction I and Construction II, if Conjecture 1.4 is true, then the lower bound of  $\delta(G)$  on Conjecture 1.4 is tight. Applying Theorem 1.3, Conjecture 1.4 holds for n even,  $T_n = K_{1,n-1}$  and  $(t+1)(n-1)(m-1)+1 \leq N \leq (t+1)(n-1)(m-1)+m-1$ .

In Section 2, we will prove Theorem 1.3 by determining the Ramsey number  $r(K_{1,\ell}, T_n, K_m)$  for  $\ell = t(n-1)+1$ . In Section 3, we strengthen Theorem 1.3 if  $T_n \neq K_{1,n-1}$ . A result in Section 3 implies that Conjecture 1.2 holds for  $3 \leq n \leq t+4, m-2 \not\equiv 0 \pmod{n-1}$  and  $(t+1)(n-1)(m-1)+1 \leq N \leq (t+1)(n-1)(m-1)+m-1$ .

### 2 Proof of Theorem 1.3

We will prove Theorem 1.3 by establishing the following result on the Ramsey number.

**Theorem 2.1** If  $\ell = t(n-1) + 1$ , then

$$r(K_{1,\ell}, T_n, K_m) = (\ell + n - 2)(m - 1) + 1 = (t + 1)(n - 1)(m - 1) + 1.$$

We will prove Theorem 2.1 later. Let us first apply Theorem 2.1 to prove Theorem 1.3.

Proof of Theorem 1.3. Let  $(t+1)(n-1)(m-1)+1 \leq N \leq (t+2)(n-1)(m-1)$ , and let G be a graph on N vertices with  $\delta(G) \geq N - t(n-1) - 1$ . We need to show that  $G \to (T_n, K_m)$ . Color E(G) arbitrarily by blue and green and color  $E(\overline{G})$  by red. Then we get a red-blue-green edge-colored  $K_N$ . By Theorem 2.1,  $N \geq r(K_{1,\ell}, T_n, K_m)$ , where  $\ell = t(n-1)+1$ . Consequently,  $K_N \to (K_{1,\ell}, T_n, K_m)$ . Note that  $\Delta(\overline{G}) \leq N - 1 - \delta(G) \leq t(n-1) < \ell$ . Thus, there is no red copy of  $K_{1,\ell}$ . Consequently,  $G \to (T_n, K_m)$ .

In what follows, we divide the proof of Theorem 2.1 into two parts.

**Theorem 2.2** Let  $r' = r(K_{1,\ell}, T_n)$ . Then

$$r(K_{1,\ell}, T_n, K_m) \ge (r'-1)(m-1) + 1.$$

Proof: Let G' be a red-blue edge-colored  $K_{r'-1}$  such that  $G' \not\to (K_{1,\ell}, T_n)$  and let G'' be a green copy of  $K_{m-1}$ . Replace each vertex of G'' with a copy of G'. Each edge of G'' expands into a green copy of  $K_{r'-1,r'-1}$ . Denote the resulting graph by G. Note that G is a red-blue-green edge-colored  $K_{(r'-1)(m-1)}$  such that  $G \not\to (K_{1,\ell}, T_n, K_m)$ . Consequently,  $r(K_{1,\ell}, T_n, K_m) \ge (r'-1)(m-1) + 1$ .

We still need a result from Burr to complete the proof of Theorem 2.1.

**Theorem 2.3 (Burr [2])** If 
$$\ell = t(n-1) + 1$$
, then  $r(K_{1,\ell}, T_n) = \ell + n - 1$ .

Proof of Theorem 2.1: Let  $N=(\ell+n-2)(m-1)+1$ . We only need to show that  $r(K_{1,\ell},T_n,K_m)\leq N$  by Theorem 2.2 and Theorem 2.3. Color  $E(K_N)$  arbitrarily by red, blue and green, and denote the resulting graph by H. Moreover, let  $H_r,H_b$  and  $H_g$  be the graph induced by all edges in red, blue and green, respectively. We will show that  $H\to (K_{1,\ell},T_n,K_m)$  using induction on m. It is true for m=2 since  $r(K_{1,\ell},T_n,K_2)=r(K_{1,\ell},T_n)=\ell+n-1$  by Theorem 2.3. If  $\Delta(H_g)\geq (\ell+n-2)(m-2)+1$ , then we are done since  $r(K_{1,\ell},T_n,K_{m-1})=(\ell+n-2)(m-2)+1$  by the induction hypothesis. Consequently, we may assume that  $\Delta(H_g)\leq (\ell+n-2)(m-2)$ , and thus,  $\delta(H_r\cup H_b)\geq \ell+n-2$ . If  $\Delta(H_r)\geq \ell$ , then we are done. Consequently, we may assume that  $\Delta(H_r)\leq \ell-1$ , and thus,  $\delta(H_b)\geq n-1$ . Consequently, we can embed  $T_n$  into  $H_b$  greedily since  $\Delta(T_n)\leq n-1$  and  $T_n$  is 1-degenerate (we can label  $V(T_n)$  as  $\{v_1,\ldots,v_n\}$  such that  $|N(v_i)\cap \{v_1,\ldots,v_{i-1}\}|\leq 1$  for each  $i\in [n]\setminus[1]$ .

#### 3 Beyond Theorem 1.3

In fact, we can improve the lower bound on  $\delta(G)$  in Theorem 1.3 when  $T_n$  is not a star. In 1995, Guo and Volkmann proved a result similar to Theorem 2.3 as follows.

Theorem 3.1 (Guo and Volkmann [5]) If  $\ell = t(n-1) + 2$  and  $T_n \neq K_{1,n-1}$ , then  $r(K_{1,\ell}, T_n) = \ell + n - 2$ .

The core of the proof of Theorem 3.1 is the following.

**Lemma 3.2 (Guo and Volkmann [5])** Let G be a connected graph on at least n vertices with  $\delta(G) \geq n-2$ . If  $T_n \neq K_{1,n-1}$ , then we can embed  $T_n$  into G.

Similar to the proof of Theorem 2.1, applying Lemma 3.2, we can prove the following.

**Theorem 3.3** If 
$$\ell = t(n-1) + 2$$
,  $m-2 \not\equiv 0 \pmod{n-1}$  and  $T_n \not= K_{1,n-1}$ , then 
$$r(K_{1,\ell}, T_n, K_m) = (\ell + n - 3)(m-1) + 1 = (t+1)(n-1)(m-1) + 1.$$

Similar to the proof of Theorem 1.3, the following is true by applying Theorem 3.3.

**Theorem 3.4** For given positive integers n, m, N and a non-negative integer t, assume that  $(t+1)(n-1)(m-1)+1 \le N \le (t+2)(n-1)(m-1)$ . Let G be a graph of N vertices with  $\delta(G) \ge N - t(n-1) - 2$ . If  $m-2 \not\equiv 0 \pmod{n-1}$  and  $T_n \not\equiv K_{1,n-1}$ , then  $G \to (T_n, K_m)$ .

**Remark 3.5** Applying Theorem 3.4 and direct calculations, we can obtain that Conjecture 1.2 holds for  $3 \le n \le t+4, m-2 \not\equiv 0 \pmod{n-1}$  and  $(t+1)(n-1)(m-1)+1 \le N \le (t+1)(n-1)(m-1)+m-1$ .

In fact, Yan and Peng [7] strengthened Lemma 3.2 (Theorem 1.2 in [7]). They showed that if G is a connected graph on at least n vertices with  $\delta(G) \geq n-3$ , then all except some special trees with n vertices can be embedded into G (see Theorem 1.2 in [7]). Applying this result and the same discussion as before, we can confirm Conjecture 1.2 for more values of n, m and N. Moreover, Conjecture 1.2 may be verified by determining all the values of  $r(K_{1,\ell}, P_n, K_m)$ .
