Geophysical intensity problems: the axisymmetric case

Abstract

Considering the earth or any other celestial body the main sources of the gravitational as well as of the magnetic field lie inside the body. Above the surface both fields are in good approximation harmonic vector fields determined by their values at the body's surface or any other surface enclosing the body. The intensity problem seeks to determine harmonic vector fields vanishing at infinity and with prescribed intensity of the field at the surface. This problem constitutes a nonlinear boundary value problem, whose general solvability is not yet established. From a practical point of view uniqueness of solutions is the even more urgent problem: intensity data can often be obtained with greater accuracy and at less cost than field directions. So, when modelling the (especially magnetic) field of the earth the question arises whether intensity data are sufficient to obtain a reliable field model.

In this paper axisymmetric harmonic fields \mathbf{H} outside the unit sphere $S^2 \subset \mathbb{R}^3$ are studied and, given an axisymmtric Hölder continuous intensity function $I \neq 0$ on S^2 , the existence of infinitely many solutions of the intensity problem is proved. These solutions can more precisely be characterized as follows: fix a number $\delta \in \mathbb{N} \setminus \{1\}$ and a meridional plane M through the symmetry axis SA, and in M a unit circle S^1 (symmetric with respect to SA) and, furthermore, $2N, N \in \mathbb{N}_0$, points $z_n \in M$ (symmetric with respect to SA, avoiding SA, and outside S^1), then the existence of an (up to a sign) unique harmonic field \mathbf{H} is established that vanishes at (the axisymmetric circles piercing M at) z_n and nowhere else, that has intensity I at S^2 and (exact) decay order δ at infinity.

The proof is based on the solution of a nonlinear elliptic equation with discontinuous coefficients, which are, moreover, singular at the symmetry axis. Its combination with fixed boundary conditions was the basis of a recent treatment of the "geomagnetic direction problem" [1]. Here we have instead natural boundary conditions, which provide less information, and which require, therefore, in part new solution techniques and sharper estimates.

1. Introduction

In the theory of harmonic vector fields the standard decomposition of the field vector at the boundary in tangential and normal components, which each lead to well posed boundary value problems, is not always the best choice, especially not in geophysical applications. Considering measurement devices the distinction between direction and intensity makes in fact a better choice, since these are the quantities that are for historical, technical, or economical reasons quite differently available. Concerning the magnetic field of the earth, most of the time in the history of magnetic field measurements only directions could be detected [2]. Meanwhile the complete field vector can be determined; however, measuring only the intensity of the magnetic field can be easier and cheaper than determining the complete field vector. In situations, where the attitude of the magnetometer is difficult to control, intensity data are the only or the more reliable magnetic data. Early satellite surveys, for example, provided only intensity data, and even nowadays directional information is still susceptible to errors in determining the attitude of the satellite in orbit. Similar problems arise at sea when the field is measured by magnetometers towed far behind oceanographic ships to escape the ship's own magnetic field (for more information about the significance of the intensity problem we refer to [3, 4, 5, 6] and references therein). Concerning the gravitational field of the earth, which is dominated by its monopole contribution, measuring directions is obviously not the most sensitive way to uncover the field's fine structure. Intensity data from satellite measurements, however, as in the magnetic case are nowadays widely available and the corresponding intensity problem is known as the "fixed geodetic boundary value problem" [7, 8]. This problem has to be distinguished from the more general (and more ambitious) geodetic boundary value problem that seeks to determine both the gravity field and the shape of the earth from the complete field vector and the gravitational potential at the earth's surface (for more information we refer to [9, 10]).




Figure 1: Illustration of an axisymmetric intensity function on a sphere with intensity coded by color.

Here we consider an ideal situation, where the intensity data are known all over a spherical surface S^2 of radius 1 and where the effects of rotation or of additional sources of the harmonic field in the exterior space $E \subset \mathbb{R}^3$ of the unit ball are neglected. Given a positive continuous function $I: S^2 \to \mathbb{R}_+$ (the "intensity function", see Fig. 1 for an example) and $\delta \in \mathbb{N} \setminus \{1\}$ (the "decay order" of the harmonic field at infinity) the **intensity problem** P_I asks for all vector fields $\mathbf{H} \in C^1(E) \cap C(\overline{E})$ satisfying the conditions

$$\nabla \times \mathbf{H} = 0, \quad \nabla \cdot \mathbf{H} = 0 \quad \text{in } E,$$

$$|\mathbf{H}(\mathbf{x})| = O(|\mathbf{x}|^{-\delta}) \quad \text{for } |\mathbf{x}| \to \infty,$$

$$|\mathbf{H}| = I \quad \text{on } S^{2}.$$
(1.1)

The magnetic and gravitational problems differ in that magnetic fields have no monopole part, a condition that can be taken into account by the choice $\delta = 3$, whereas gravitational fields (due to the positive mass density) are only admissible if

$$\mathbf{H} \cdot \mathbf{x} \neq 0 \qquad \text{on } S^2, \tag{1.2}$$

which requires $\delta = 2$ in $(1.1)_2$.

For the intensity problem there is obviously no linear relation between solution and boundary data, which means that the usual solution techniques for the standard boundary value problems such as integral equation or Hilbert space methods are not applicable. In consequence there are so far only a few results concerning existence and uniqueness: in the geodetic case, when condition (1.2) holds additionally, a simple argument based on maximum principles proves uniqueness [3]; in the general (magnetic) case non-uniqueness is known by example [11]. Adding some directional information, such as the knowledge of the "dip equators" (loci on S^2 , where the normal component of the field vector vanishes), can, however,

restore uniqueness [12]. Concerning existence there are in the geodetic case results for small data, i.e. here data close in some norm to those of the monopole field [13, 14, 15]; in the general case there are viscosity solutions for a related problem inspired by the intensity problem [16]. These solutions are simultaneously solutions of the intensity problem if they happen to satisfy condition (1.2) (which is conjectured by the authors of [16]). In general, however, this is not the case as we will see below.

In the following we will present an (almost) complete solution of the axisymmetric intensity problem. The method is inspired by the solution of the two-dimensional version of this problem [3], which used methods of complex analysis. Axisymmetry leads - in cylindrical coordinates ρ , ζ in a meridional plane $\theta = const$ - likewise to a two-dimensional problem, which, although complicated by the coordinate singularity at $\rho = 0$, is amenable to a complex formulation. With (H_{ζ}, H_{ρ}) representing the nonvanishing components of an axisymmetric harmonic field we make the ansatz

$$H_{\zeta}(\zeta,\rho) + i H_{\rho}(\zeta,\rho) = h(\zeta + i\rho) \exp\left(\frac{1}{2} \left(p(\zeta,\rho) + i q(\zeta,\rho)\right)\right)$$
(1.3)

with a given complex analytic function h representing the zeroes and the asymptotic behaviour of the harmonic field, and "correction functions" p and q. This ansatz is the same as in [1] for the solution of the axisymmetric direction problem, where we derived an elliptic boundary value problem for the direction-related variable q. An analogous boundary value problem for the intensity related variable p does not exist. Instead, we derive for a modified variable p

the following boundary value problem in $A_{\infty} := \{(\zeta, \rho) \in \mathbb{R}^2 : \zeta^2 + \rho^2 > 1\} \subset \mathbb{R}^2$:

$$-\Delta q' = -\partial_{\zeta} \left(\frac{1}{\rho} \cos(q' - \Omega) \right) + \partial_{\rho} \left(\frac{1}{\rho} \sin(q' - \Omega) \right) \quad \text{in } A_{\infty},$$

$$\mathbf{n} \cdot \nabla q' = \frac{n_{\zeta}}{\rho} \left(\cos(q' - \Omega) - 1 \right) - \frac{n_{\rho}}{\rho} \sin(q' - \Omega) \quad \text{on } S^{1},$$

$$(1.4)$$

where **n** denotes the exterior normal at the unit circle S^1 , and the "data function" Ω depends on h and the intensity function I. Problem (1.4) differs from the corresponding direction problem only in the "natural" boundary condition $(1.4)_2$. In a weak formulation this is implemented by test functions, which are free at the boundary in contrast to test functions vanishing at the boundary in the direction problem. It is this loss of information at the boundary that requires additional measures in the solution strategy for problem (1.4), which is in principle the same as for the direction problem: the general solution of a linearized version of (1.4) by applying a Lax-Milgram-type solution criterion and, subsequently, setting up a suitable iteration procedure in L^p -spaces, to which Schauder's fixed point principle can be applied. At the linear level it was a major problem in [1] to obtain control by the left-hand side over the second term on the right-hand side in $(1.4)_1$, which is not small and which behaves near the symmetry axis $\{\rho=0\}$ like a second order term. By the use of Hardy-type inequalities, weighted by some power of the distance to the symmetry axis, and by introducing further parameters, exploiting the fine structure of the right-hand side in $(1.4)_1$, a subtle balance of these parameters allowed, finally, to gain this control.

For the intensity problem the above mentioned loss of information is not complete. Solutions and test functions are antisymmetric with respect to the symmetry axis and hence vanish there. A formulation of the problem in polar coordinates is now more appropriate (section 2); it introduces, however, additional (lower order) terms, which are not small and which change the problem to one of Fredholm-type. Uniqueness of the homogeneous problem is now essential (section 3) and proves together with a careful choice of (an enlarged set of) parameters existence in the linearized problem (section 4).

At the nonlinear level the same iteration, which worked in the direction problem, works here as well (section 5), since the essential Hardy-type estimates continue to hold in the present situation with less boundary information though with different constants (appendix A). Another essential ingredient for the working of the iteration is a global bound on the solution, which in the direction problem was a byproduct of the coercivity estimates for Lax-Milgram. Here, additionally, Fredholm constants are involved, which require spectral estimates of the associated Fredholm operator (appendix C).

Regularity of the solution follows in principle as in the direction problem; only in two respects additional effort is necessary: at the boundary it needs some care to recover the prescribed intensity from the free boundary condition (section 6) and at the axis the evaluation of some condition on the intensity function requires some non-standard Hölder-type estimates (appendix B).

The solution procedure explained so far works in bounded regions. In the unbounded case we solve the intensity problem in a sequence of bounded regions with artificial intensity function at the exterior boundary. The global bound and a "diagonal argument" as in [1] are then the crucial ingredients to justify the passage to the unbounded region establishing thus the solution of the intensity problem in exterior space.

Finally, we have a look on the related problem [16] mentioned above and show by example the difference of both problems (section 7).




Figure 2: Various coordinates in the meridional cross section A_R .

2. Mathematical setting and results

This section provides the mathematical setting for our treatment of the intensity problem, derives the system (1.4), and presents our results in the theorems 2.1 - 2.4. Where this section overlaps with the corresponding section in [1] it is a condensed version stressing the differences and omitting most of the motivations and comments given in [1].

Axisymmetric harmonic vector fields \mathbf{H} , expressed in cylindrical coordinates (ρ, θ, ζ) , have just two nontrivial components H_{ρ} and H_{ζ} , depending on ρ and ζ , which satisfy the system

$$\frac{\partial_{\zeta} H_{\rho} - \partial_{\rho} H_{\zeta} = 0,}{\partial_{\zeta} H_{\zeta} + \partial_{\rho} H_{\rho} + \frac{1}{\rho} H_{\rho} = 0.}$$
(2.1)

For the time being **H** is defined on the half-plane $\mathbb{H} = \{(\zeta, \rho) \in \mathbb{R}^2 : \rho > 0\}$ bounded by the symmetry axis $\{\rho = 0\}$ but can be extended to \mathbb{R}^2 by (anti)symmetric continuation:

$$\left. \begin{array}{l} H_{\zeta}(\zeta, -\rho) := H_{\zeta}(\zeta, \rho), \\ H_{\rho}(\zeta, -\rho) := -H_{\rho}(\zeta, \rho), \end{array} \right\} \qquad (\zeta, \rho) \in \mathbb{H}.$$
(2.2)

Note that $(2.1)_2$ implies (if defined) $H_{\rho}(\zeta,0) = 0$. On \mathbb{R}^2 also polar coordinates $(r,\varphi) \in (0,\infty) \times (-\pi,\pi]$ with basis vectors \mathbf{e}_r and \mathbf{e}_{φ} are useful. They are related to (ζ,ρ) by

$$\zeta = r\cos\varphi \,, \quad \rho = r\sin\varphi \tag{2.3}$$

(see Fig. 2). In these coordinates condition (2.2) takes the form

$$\widetilde{H}_{\zeta}(r, -\varphi) = \widetilde{H}_{\zeta}(r, \varphi),
\widetilde{H}_{\rho}(r, -\varphi) = -\widetilde{H}_{\rho}(r, \varphi),$$
(2.4)

where $\mathbf{H}(r\cos\varphi,r\sin\varphi)=:\widetilde{\mathbf{H}}(r,\varphi)$. Finally, to take advantage of the exponential mapping in complex analysis relating Cartesian and polar coordinates, a complex formulation is useful. With the identifications

$$\Re z := \zeta, \qquad \Im z := \rho, \qquad \Re f := H_{\zeta}, \qquad \Im f := -H_{\rho}, \tag{2.5}$$

eqs. (2.1) then take the form

$$\partial_{\overline{z}}f - \frac{1}{2}\frac{f - \overline{f}}{z - \overline{z}} = 0 \tag{2.6}$$

and the symmetry condition (2.2) amounts to

$$f(z,\overline{z}) = \overline{f}(\overline{z},z). \tag{2.7}$$

We made there use of the Wirtinger derivatives $\partial_z := \frac{1}{2}(\partial_{\zeta} - i\partial_{\rho})$ and $\partial_{\overline{z}} := \frac{1}{2}(\partial_{\zeta} + i\partial_{\rho})$ acting on functions $f : \mathbb{C} \times \mathbb{C} \to \mathbb{C}$, $(z, \overline{z}) \mapsto f(z, \overline{z})$.

Intensity functions $I: S_1 \to \mathbb{R}_+$, parametrized by the polar angle $\varphi \in (-\pi, \pi]$, are called symmetric, if $I(\varphi) = I(-\varphi)$, and fields H, \widetilde{H} , and complex functions f are called symmetric, if they satisfy (2.2), (2.4), and (2.7), respectively.¹ The *axisymmetric* intensity problem now reads:

Problem $P_I(A_\infty)$. Let $I \in C(S_1, \mathbb{R}_+)$ be a positive symmetric function and $\delta \in \mathbb{N} \setminus \{1\}$. Determine all symmetric solutions $\mathbf{H} \in C^1(A_\infty) \cap C(\overline{A_\infty})$ of (2.1) with decay order δ and boundary condition $|\mathbf{H}|\big|_{S_1} = I$.

Introducing an additional intensity function \widehat{I} on the circle S_R of radius R > 1 the analogous problem in the bounded region $A_R := \{(\zeta, \rho) \in \mathbb{R}^2 : 1 < \zeta^2 + \rho^2 < R^2\}$ reads:

Problem $P_{I,\widehat{I}}(A_R)$. Let $I \in C(S_1, \mathbb{R}_+)$ and $\widehat{I} \in C(S_R, \mathbb{R}_+)$ be positive symmetric functions. Determine all symmetric solutions $\mathbf{H} \in C^1(A_R) \cap C(\overline{A_R})$ of (2.1) satisfying the boundary conditions $|\mathbf{H}|\big|_{S_1} = I$ and $|\mathbf{H}|\big|_{S_R} = I_0\widehat{I}$, where the positive constant I_0 is part of the solution.

Note that in the bounded case the second boundary condition is assumed only up to a positive factor I_0 . This is comparable to the standard boundary value problem with prescribed normal component of the field at the boundary. In the case of constant normal component at both boundaries the monopole field is the unique solution, whose amplitude can be fixed only once for both boundaries.

The zeroes of harmonic fields play a crucial role in our solution ansatz. The following facts are well known: Axisymmetric harmonic fields \mathbf{H} have only a finite number of isolated zeroes with finite negative indices ("x-points") in A_{∞} . Let these zeroes be contained in the annulus $A_R \subset A_{\infty}$, then its number $\nu(\mathbf{H}, A_R)$ can be computed by

$$\nu = \nu(\mathbf{H}, A_R) = m - \widehat{m}, \qquad (2.8)$$

where m and \widehat{m} mean the rotation numbers of \mathbf{H} along the circles S_1 and S_R , respectively. The rotation number $m \in \mathbb{Z}$ counts the number of turns, the field vector makes when circling

once around S_1 . The number ν counts a zero as often as indicated by its index. Equation (2.8) is clearly an analogue of the argument principle in complex analysis and it has likewise some invariance properties with respect to continuous deformations (see section 10 in [1]); in particular, \widehat{m} is constant in the limit $R \to \infty$, which yields for A_{∞} the relation

$$\nu = \nu(\mathbf{H}, A_{\infty}) = m - \tilde{\delta} + 1, \qquad (2.9)$$

where $\tilde{\delta}$ denotes the *exact* decay order of \mathbf{H} , i.e. $|\mathbf{H}(\mathbf{x})| = O(|\mathbf{x}|^{-\tilde{\delta}})$ but not $|\mathbf{H}(\mathbf{x})| = O(|\mathbf{x}|^{-(\tilde{\delta}+1)})$ for $|\mathbf{x}| \to \infty$.

The basic idea to solve the intensity problem is the same as for the direction problem: expressing a two-dimensional vector field via the exponential mapping by argument and modulus, i.e. direction and intensity, and to derive from eq. (2.6) corresponding equations for these quantities. The zeroes of the harmonic field, whose number by (2.8) is related to the rotation numbers at the boundaries, must be treated separately. This leads to the ansatz

$$f(z,\overline{z}) = h(z) e^{g(z,\overline{z})}$$
(2.10)

with the analytic function

$$h(z) := \prod_{n=1}^{\infty - \widehat{w}} (z - z_n) z^{-w}.$$
 (2.11)

Inserting (2.10) into (2.6) one obtains

$$-\partial_{\overline{z}}g = \frac{1}{2} \frac{1}{z - \overline{z}} \left(\frac{\overline{h}}{h} e^{-2i\Im g} - 1 \right). \tag{2.12}$$

Introducing the angle-type variable Ψ by $\overline{h}/h =: \exp(i\Psi)$, writing 2g =: p + iq, and using the real variables (ζ, ρ) in A_R , eq. (2.12) takes the real form

$$\partial_{\zeta} p - \partial_{\rho} q - \frac{1}{\rho} \sin(q - \Psi) = 0,$$

$$\partial_{\rho} p + \partial_{\zeta} q - \frac{1}{\rho} \left(\cos(q - \Psi) - 1 \right) = 0.$$
(2.13)

The symmetry condition (2.7) is satisfied by the choice of a symmetric set S of zeroes in (2.11), i.e. $z \in S$ implies $\overline{z} \in S$, and by the following symmetries of p and q:

$$p(\zeta, -\rho) = p(\zeta, \rho), \qquad q(\zeta, -\rho) = -q(\zeta, \rho).$$
 (2.14)

The boundary conditions on $f \triangleq \mathbf{H}$ translate into ones for p:

$$p|_{S_1} := 2\left(\ln I - \sum_{n=1}^{m-\widehat{m}} \ln|z - z_n|\Big|_{S_1}\right),$$
 (2.15)

$$p\big|_{S_R} := 2\left(\ln \widehat{I} - \sum_{n=1}^{m-\widehat{m}} \ln|z - z_n|\big|_{S_R} + p_0\right),$$
 (2.16)

where p_0 combines the constants $\ln I_0$ and $m \ln R$. The system (2.13) allows the reduction to a semilinear elliptic equation in the direction-related variable q alone, which was the basis of

the solution of the direction problem in [1]. An analogous reduction to the intensity-related variable p seems not to be possible. Instead, we transform to zero boundary conditions in p, which induce "natural" boundary conditions for a new direction-related variable u: let (p_l, q_l) be the solution of the linear auxiliary boundary value problem (see appendix B)

$$p_l|_{S_1} := p|_{S_1}, \qquad p_l|_{S_R} := p|_{S_R},$$
 (2.18)

where $p|_{S_1}$ and $p|_{S_R}$ are given by eqs. (2.15) and (2.16), respectively. In the variables $\wp := p - p_l$ and $u := q - q_l$ and with $\Omega := \Psi - q_l$, the system (2.13) now takes the form

$$\frac{\partial_{\zeta}\wp - \partial_{\rho}u - \frac{1}{\rho}\sin(u - \Omega)}{\partial_{\rho}\wp + \partial_{\zeta}u - \frac{1}{\rho}\left(\cos(u - \Omega) - 1\right)} = 0,$$
(2.19)

with boundary condition

$$\wp|_{\partial A_{\mathcal{R}}} = 0. \tag{2.20}$$

Note that the data of the problem, viz., positions of the zeroes of the solution and intensity values at the boundary, are now represented by the "data function" Ω . Eliminating the variable \wp from (2.19) yields

$$\Delta u + \partial_{\zeta} \left(\frac{1}{\rho} \left(1 - \cos(u - \Omega) \right) \right) + \partial_{\rho} \left(\frac{1}{\rho} \sin(u - \Omega) \right) = 0$$
 (2.21)

or

$$\nabla \cdot \left(\nabla u + \mathbf{a}[u - \Omega] \frac{u}{\rho}\right) = \nabla \cdot \left(\mathbf{a}[u - \Omega] \frac{\Omega}{\rho}\right)$$
 (2.22)

with

$$a_{\zeta}[x] := \frac{1 - \cos x}{x}, \qquad a_{\rho}[x] := \frac{\sin x}{x},$$
 (2.23)

which is formally the same equation as in [1]. To obtain boundary conditions for u we evaluate condition (2.20) in the form $\mathbf{t} \cdot \nabla \wp|_{\partial A_R} = 0$ by (2.19) to obtain

$$0 = -\mathbf{t} \cdot \nabla \wp \big|_{\partial A_R} = (n_\rho \partial_\zeta - n_\zeta \partial_\rho) \wp \big|_{\partial A_R}$$

$$= \left[n_\zeta \Big(\partial_\zeta u + \frac{1}{\rho} \big(1 - \cos(u - \Omega) \big) \Big) + n_\rho \Big(\partial_\rho u + \frac{1}{\rho} \sin(u - \Omega) \Big) \right]_{\partial A_R}$$

$$= \mathbf{n} \cdot \Big[\nabla u + \mathbf{a} [u - \Omega] \frac{u - \Omega}{\rho} \Big]_{\partial A_R},$$
(2.24)

where $\mathbf{n} = (n_{\zeta}, n_{\rho})$ and $\mathbf{t} = (-n_{\rho}, n_{\zeta})$ denote unit normal and tangential vectors, respectively, at ∂A_R . It is this Neumann-type nonlinear boundary condition in contrast to a zero boundary condition, which makes the difference between intensity and direction problem.

The symmetry requirements on \wp , u, and Ω follow by (2.14)-(2.18) (see also appendix B):

$$\wp(\zeta, -\rho) = \wp(\zeta, \rho), \quad u(\zeta, -\rho) = -u(\zeta, \rho), \quad \Omega(\zeta, -\rho) = -\Omega(\zeta, \rho). \tag{2.25}$$

Equation (2.22) suggests a weak formulation: let

$$C_{as}^1(\overline{A_R}) := \{ \psi \in C^1(\overline{A_R}) : \psi(\zeta, -\rho) = -\psi(\zeta, \rho) \}$$

and

$$H_{as}^1(A_R) := \operatorname{clos}\left(C_{as}^1(\overline{A_R}), \|\nabla \cdot \|_{L^2(A_R)}\right)$$

be antisymmetric versions of the usual spaces of C^1 -test-functions and H^1 -functions. A function $u \in H^1_{as}(A_R)$ is then called weak solution of the boundary value problem (2.22)–(2.25), if u satisfies

$$\int_{A_R} \nabla u \cdot \nabla \psi \, d\zeta d\rho + \int_{A_R} \frac{u}{\rho} \, \mathbf{a}[u - \Omega] \cdot \nabla \psi \, d\zeta d\rho = \int_{A_R} \frac{\Omega}{\rho} \, \mathbf{a}[u - \Omega] \cdot \nabla \psi \, d\zeta d\rho \qquad (2.26)$$

for all test functions $\psi \in C^1_{as}(\overline{A_R})$. Obviously, by integrating by parts eq. (2.26) is equivalent to eqs. (2.22) and (2.24) on functions $u \in C^2(A_R) \cap C^1(\overline{A_R})$.

Antisymmetry allows us to reduce the problem to the half-annulus $A_R^+ := A_R \cap \{\rho > 0\}$, bounded by the half-circles S_1^+ , S_R^+ , and (parts of) the symmetry-axis SA. Solution and test functions vanish by antisymmetry on the symmetry-axis, which makes the essential difference between the boundary components $S_{1,R}^+$ and SA of A_R^+ . Polar coordinates (r,φ) are here more appropriate to take into account this difference. They map A_R^+ on the rectangle $Q_R := (1,R) \times (0,\pi)$ with side walls $\{\varphi = 0\}$ and $\{\varphi = \pi\}$, at which solution and test functions vanish; this allows the application of Hardy-type inequalities, a crucial ingredient of our solution procedure.

Equation (2.22) now takes the form³

Equations (2.27), (2.28) with given data function $\widetilde{\Omega}$ constitute **problem** $P_{\widetilde{\Omega}}(Q_R)$, for which the following theorem holds.

Theorem 2.1. Let R > 1 and $\widetilde{\Omega} \in L^{\infty}(Q_R)$ with bound

with $\beta = 1/5$, $\eta = 10^{-3}$, and C denoting some constant that depends on K, but does not depend on R.

In (2.31), $\widetilde{\nabla}$ denotes the gradient in polar coordinates and $\widehat{\varphi}$ the "tent function" (see appendix A).

In the unbounded case a function $u \in \mathcal{H}_0^{loc}(Q_\infty)$ with $Q_\infty := (1, \infty) \times (0, \pi)$ is called weak solution of eqs. (2.27), (2.28), if \tilde{u} satisfies eq. (2.29) (with Q_R replaced by Q_∞) for all functions $\psi \in \mathcal{C}^1(\overline{Q_\infty})$, where

Based on these results the following both theorems answer the original problems $P_{I,\widehat{I}}(A_R)$ and $P_I(A_\infty)$. Hölder continuity of the data I and \widehat{I} is here sufficient to ensure continuity of the solution up to the boundary; only at the symmetry axis we need some more regularity, viz.,

with some $0 < \tilde{\alpha} < 1$, to ensure conditions (2.30), (2.32).

Theorem 2.3. Let I and \widehat{I} be Hölder continuous, symmetric intensity functions satisfying conditions (2.34), let $\widehat{w} \in \mathbb{N}$, and let $\{z_1, \ldots, z_{2N}\}$, $N \in \mathbb{N}_0$, be a symmetric set of points (avoiding the symmetry axis) in A_R . Then, problem $P_{I,\widehat{I}}(A_R)$ has a (up to a sign) unique solution \mathbf{H} with rotation number \widehat{w} at S_R and vanishing at z_1, \ldots, z_{2N} and nowhere else.

Theorem 2.4. Let I be a Hölder continuous, symmetric intensity function satisfying conditions (2.34), let $\tilde{\delta} \in \mathbb{N} \setminus \{1\}$, and let $\{z_1, \ldots, z_{2N}\}$, $N \in \mathbb{N}_0$, be a symmetric set of points (avoiding the symmetry axis) in A_{∞} . Then, problem $P_I(A_{\infty})$ has a (up to a sign) unique solution \mathbf{H} with exact decay order $\tilde{\delta}$ and vanishing at z_1, \ldots, z_{2N} and nowhere else.

We close this section with two comments:

- 1. The restriction to an even number of zeroes in the theorems 2.3 and 2.4 is clearly not optimal, since axisymmetric harmonic fields with an odd number of zeroes (and necessarily at least one of them on the symmetry axis) are well known. The same restriction appeared provisionally in the direction problem [1], where, however, it could be removed in the unbounded case by taking suitable linear combinations of "even solutions" to generate an odd solution; a method, which obviously does not work in the intensity problem. So, for the present it is a conjecture that theorem 2.4 holds for an odd number of zeroes as well.⁵
- 2. Without further information theorem 2.4 predicts for a given intensity function I an infinite set of solutions characterized by the exact decay order and positions of an (even) number of zeroes. Applying the theorem to the gravitational field of the earth we have additionally condition (1.2), which clearly implies a rotation number m=1 and by (2.9) $\tilde{\delta}=2$ and no zeroes, hence uniqueness in agreement with [3]. Concerning the geomagnetic field the present situation is characterized by a dominating dipole-field, which means m=2, $\tilde{\delta}=3$ and hence again no zeroes and uniqueness. In earlier epochs, however, especially during pole reversals, m>2 is possible, while a (however small) dipole part always implies $\tilde{\delta}=3$, which implies by (2.9) zeroes of the magnetic field and hence nonuniqueness. In that case the reconstruction of the magnetic field from intensity data alone is in principle not possible.

3. Uniqueness in the problems $P_{\Omega}(Q_R)$ and $P_{\Omega}(Q_{\infty})$

The function Ω is a functional of the intensity function I (and \widehat{I} in the bounded problem) and the set of zeroes parametrizing the nonuniqueness of the original problems $P_I(A_\infty)$ and $P_{I,\widehat{I}}(A_R)$. Starting with the bounded case, $\Omega:Q_R\to\mathbb{R}$ is in this section a fixed function with property (2.30) and u_1 , u_2 are two weak solutions of eq. (2.21) in polar coordinates, i.e. u_1 satisfies⁶

with test function $\psi \in \mathcal{C}^1(\overline{Q_R})$, and analogously for u_2 . The "perturbation" $\delta u := u_1 - u_2$ then satisfies the equation

The three terms in the bracket on the right-hand side of (3.5) can further be estimated by (3.2), (2.30), and (A.2):

Similarly, by

By Levi's theorem we conclude convergence in the sequence $\left(\ln(1+n\,\delta u^+)\right)_{n\in\mathbb{N}}$, which in turn implies $\delta u^+=0$ a.e. The argument applies verbatim to $-\delta u^-=-\min\{\delta u,0\}$, hence $\delta u=0$ a.e. We summarize this result in the following proposition.

Proposition 3.1. Let $u_1, u_2 \in \mathcal{H}_0(Q_R)$ be weak solutions of problem $P_{\Omega}(Q_R)$ with $1 < R < \infty$ and $\Omega \in L^{\infty}(Q_R)$ satisfying the bound (2.30). Then u_1 and u_2 coincide a.e. in Q_R .

In the unbounded case we deal with solutions $u \in \mathcal{H}^{loc}_{\beta}(Q_{\infty})$ of problem $P_{\Omega}(Q_{\infty})$ that satisfy a bound of the form

In Q_{∞} the weights, especially $r^{-\eta}$, cannot be neglected. In order to incorporate the weights into the governing equation (3.1) we replace u by the variable $v := \widehat{\varphi}^{\beta} r^{\eta} u$ to obtain

+ \int_{1}^{\infty} \frac{1}{r^{2}} \left(\int_{0}^{\pi/2} \left(\frac{a_{\varphi}'}{\sin \varphi} - \frac{\beta}{\widehat{\varphi}} \right) \delta v \, \partial_{\varphi} \psi \, \widehat{\varphi}^{-\beta} d\varphi \right)
+ \int_{\pi/2}^{\pi} \left(\frac{a_{\varphi}'}{\sin \varphi} + \frac{\beta}{\widehat{\varphi}} \right) \delta v \, \partial_{\varphi} \psi \, \widehat{\varphi}^{-\beta} d\varphi \right) r^{1-\eta} dr = 0$$
(3.9)

with $d\mu_{\beta}^{\eta} = \widehat{\varphi}^{-\beta} d\varphi \, r^{1-\eta} dr$ and \mathbf{a}' given as before by (3.2). Using now as test functions the sequence

the arguments follow closely those in the bounded case; we skip thus the details. Inserting ψ_n into (3.9), estimating and rearranging the various terms as in the bounded case, one obtains instead of (3.5):

- \int_{\pi/2}^{\pi} \left(\frac{1}{\sin \varphi} - \frac{\beta}{\widehat{\varphi}} \right) \frac{\delta v^{+} \partial_{\varphi} \delta v^{+}}{(\delta v^{+} + 1/n)^{2}} \widehat{\varphi}^{-\beta} d\varphi \right) r^{1-\eta} dr \\
\leq \left[\left(\int_{Q_{\infty}} \left(\frac{a'_{r}}{r \sin \varphi} - \frac{\eta}{r} \right)^{2} d\mu_{\beta}^{\eta} \right)^{\frac{1}{2}} + \left(\int_{1}^{\infty} \int_{0}^{\pi/2} \left(\frac{a'_{\varphi} - 1}{r \sin \varphi} \right)^{2} \widehat{\varphi}^{-\beta} d\varphi r^{1-\eta} dr \right)^{\frac{1}{2}} \right. \\
+ \left(\int_{1}^{\infty} \int_{\pi/2}^{\pi} \left(\frac{a'_{\varphi} + 1}{r \sin \varphi} \right)^{2} \widehat{\varphi}^{-\beta} d\varphi r^{1-\eta} dr \right)^{\frac{1}{2}} \right] \times \left(\int_{Q_{\infty}} \frac{|\nabla \delta v^{+}|^{2}}{(\delta v^{+} + 1/n)^{2}} d\mu_{\beta}^{\eta} \right)^{\frac{1}{2}}. \tag{3.10}$$

The three terms in the bracket on the right-hand side of (3.10) are estimated by (2.32), (2.33), and (A.2) along the lines of the bounded case. We just present the estimate of the first term:

The second term on the left-hand side of (3.10) is again nonnegative. In fact, by (3.6), (3.7), and integration by parts one obtains

$$= -\int_{0}^{\pi/2} g'(\widehat{\varphi}) \, f(n \, \delta v^{+}) \, \mathrm{d}\varphi - \int_{\pi/2}^{\pi} g'(\widehat{\varphi}) \, f(n \, \delta v^{+}) \, \mathrm{d}\varphi$$

$$+ 2g(\pi/2) \, f(n \delta v^{+}) \big|_{\varphi = \pi/2} \ge 0$$

with

$$g(y) := \left(\frac{1}{\sin y} - \frac{\beta}{y}\right) y^{-\beta}$$

and

$$-g'(y) = \left(\frac{\cos y}{\sin^2 y} + \frac{\beta}{y \sin y} - \frac{\beta(1+\beta)}{y^2}\right) y^{-\beta},$$

which is nonnegative for $0 < y \le \pi/2$ and $0 < \beta < 1/2$.

The rest of the argument is as in the bounded case with the result $\delta u = 0$ a.e. in Q_R for any R > 1.

Proposition 3.2. Let $u_1, u_2 \in \mathcal{H}^{loc}_{\beta}(Q_{\infty})$ be weak solutions of problem $P_{\Omega}(Q_{\infty})$ with bound (2.33) and $\Omega \in L^{\infty}(Q_{\infty})$ satisfying the bound (2.32). Then u_1 and u_2 coincide a.e. in Q_{∞} .

Finally, we prove uniqueness in a linearized, homogeneous version of eq. (2.22), relevant for the solution of the linearized problem in section 4. Starting point is the weak formulation (2.29) in polar coordinates with vanishing right-hand side and the variable u in the vector field **a** replaced by a fixed function w. Using the Cartesian components a_{ζ} and a_{ρ} of the vector field **a**, one obtains (cf. eq. (4.2) below):

The sequence of test functions is now

and estimating and rearranging as in the bounded case leads now to:

+ 2 \left(\int_{Q_R} \frac{1}{r^2} d\mu \right)^{\frac{1}{2}} \times \left(\int_{Q_R} \frac{|\nabla u^+|^2}{(u^+ + 1/n)^2} d\mu \right)^{\frac{1}{2}}.$$
(3.12)

The estimate (3.12) resembles (3.5), but differs in the vector field \mathbf{a} instead of \mathbf{a}' , in the trigonometric function $\tan \varphi$ instead of $\sin \varphi$ and in an additional (unproblematic) term on the right-hand side. Nevertheless, the second term on the left-hand side in (3.12) is again nonnegative since by (3.6) and integration by parts we have

We conclude as above that u = 0 a.e. in Q_R , which yields the following proposition:

Proposition 3.3. Let $u \in \mathcal{H}_0(Q_R)$, $1 < R < \infty$ be a solution of eq. (3.11) with given $w \in \mathcal{H}_0(Q_R)$ and $\Omega \in L^{\infty}(Q_R)$ satisfying the bound (2.30). Then u = 0 a.e. in Q_R .

4. The linearized problem

The linearized problem consists in the solution of eq. (2.29) neglecting the u-dependence of the vector field \mathbf{a} . Thus, by (2.23), a_{ρ} and a_{ζ} denote here arbitrary measurable functions with bounds

 and $|a_{\zeta}| < 0.73$ on \mathbb{R} . (4.1)

Inserting the abbreviations (2.28), eq. (2.29) may be arranged as follows:

where $\nabla = \mathbf{e}_r \partial_r + \mathbf{e}_{\varphi} \frac{1}{r} \partial_{\varphi}$ and $\mathrm{d}\mu = \mathrm{d}\varphi \, r \mathrm{d}r$. The method of choice to prove the existence of a solution of eq. (4.2) under quite general conditions is the application of the Lax-Milgram criterion, which requires, however, some coercivity property of the left-hand side in (4.2). By Hardy's inequality the second term on the left-hand side in (4.2) turns out as a (pseudo-) second-order term, which has to be controlled by the first term. A lot of the work in [1] was devoted to establish this control by the combined effect of three measures: a change of variables leads to an effective quantity a_{ρ} with bound better than 1, the introduction of a ρ -dependent weight leads to an improved constant in Hardy's inequality, and a weighted gradient allows better to exploit the asymmetry in the bounds of a_{ρ} and a_{ζ} . All these measures – adapted to polar coordinates – will again be necessary to gain control over the second term on the left-hand side in (4.2). Moreover, the third (lower order) term, not present in [1], requires an additional measure, viz., the consideration of an extended bilinear form, which allows the reformulation of (4.2) as a Fredholm-type problem, to which Fredholm's alternative can be applied.

Let us start with rewriting eq. (4.2) in the variable $v := \widehat{\varphi}^{\alpha} r^{\eta} u$, $\alpha \in \mathbb{R}$, $\eta \in \mathbb{R}$, where the factor $\widehat{\varphi}^{\alpha}$ serves to shift a_{ρ} by α and the factor r^{η} to assure convergence in Q_{∞} . $\widehat{\varphi}$ denotes

the tent function (see appendix A). We obtain

+ \int_{1}^{R} \left[\int_{0}^{\pi/2} \frac{v}{\tan \widehat{\varphi}} \left(a_{\zeta} \partial_{r} \psi + a_{\rho} \frac{1}{r} \partial_{\varphi} \psi \right) \widehat{\varphi}^{-\alpha} d\varphi \right] r^{-\eta} dr
- \int_{\pi/2}^{\pi} \frac{v}{\tan \widehat{\varphi}} \left(a_{\zeta} \partial_{r} \psi + a_{\rho} \frac{1}{r} \partial_{\varphi} \psi \right) \widehat{\varphi}^{-\alpha} d\varphi \right] r^{-\eta} dr
+ \int_{1}^{R} \int_{0}^{\pi} v \left(a_{\rho} \partial_{r} \psi - a_{\zeta} \frac{1}{r} \partial_{\varphi} \psi \right) \widehat{\varphi}^{-\alpha} d\varphi r^{-\eta} dr
= \int_{1}^{R} \int_{0}^{\pi} \frac{\Omega}{\sin \varphi} \left(a_{r} \partial_{r} \psi + a_{\varphi} \frac{1}{r} \partial_{\varphi} \psi \right) d\varphi dr.$$

Rearranging the first two terms and using the notation introduced in appendix A, eq. (4.2) takes the form

+ \int_{Q_R} \frac{v}{r} \left(a_{\rho} \partial_r \psi - a_{\zeta} \frac{1}{r} \partial_{\varphi} \psi \right) d\mu_{\alpha}^{\eta}
= \int_{Q_R} \frac{\Omega}{r \sin \varphi} \left(a_r \partial_r \psi + a_{\varphi} \frac{1}{r} \partial_{\varphi} \psi \right) d\mu.$$
(4.3)

The effect of the $(\widehat{\varphi}$ -part of the) transformation shows up in an improved a_{ρ} -estimate. By (4.1) one finds the optimal estimate

The bilinear form on the left-hand side of (4.3) is abbreviated by $B[v, \psi]$ with its three components (in this order) B_0 , B_1 , and B_2 , and the linear form on the right-hand side by $L[\psi]$; thus (4.3) reads for short:

Solving eq. (4.3) in weighted spaces, especially when the variables v and ψ lie in different spaces, require a generalized version of the Lax-Milgram criterion. The following proposition presents a suitable version, whose proof can be found in [1].

Then, the equation

with $\tilde{l} \in \widetilde{\mathcal{B}}'$ has a unique solution $u \in \mathcal{B}$ with bound

To make use of the criterion we set (see appendix A)⁷

Condition (4.8) is the easy part under the requirements of proposition 4.1 and may be checked term by term. Just by Cauchy-Schwarz's inequality one obtains for B_0 :

$$\leq \|a_{\rho}^{\alpha}\|_{\infty} \int_{1}^{R} \int_{0}^{\pi} \left| \frac{v}{r \,\widehat{\varphi}} \right| \widehat{\varphi}^{-\beta_{+}} r^{-3\eta/2}$$

$$\times \left(\frac{\|a_{\zeta}\|_{\infty} + \eta \, \pi/2}{\|a_{\rho}^{\alpha}\|_{\infty}} |\partial_{r}\tilde{v}| + \left| \frac{1}{r} \partial_{\varphi}\tilde{v} \right| \right) \widehat{\varphi}^{-\beta_{-}} r^{\eta/2} d\varphi \, r dr$$

$$\leq \sqrt{2} \|a_{\rho}^{\alpha}\|_{\infty} \left\| \frac{1}{r} \, \frac{v}{\widehat{\varphi}} \right\|_{(2\beta_{+},3\eta)} \|\nabla_{e}\tilde{v}\|_{(2\beta_{-},-\eta)}$$




Figure 3: Graphs of the lower bounds $\gamma \mapsto LB(0.39, \gamma, 10^{-3}, 0.1, 1.2)$ (solid thin line), $\gamma \mapsto LB(0.39, \gamma, 0, 0.1, 1.2)$ (dashed line), and the comparison function $CF(0.39, \gamma)$ (solid thick line).

The variational problem on the right-hand side of (4.30) and the bound (4.31) closely resemble those in [1]. They differ in the additional parameters η and ε , which, however, both can be chosen to be small, and the additional variational variable τ . The minimization of F is again elementary and the result in terms of graphs of $\gamma \mapsto LB(\alpha, \gamma, \eta, d, e)$ and of the "comparison function" $\gamma \mapsto CF(\alpha, \gamma)$ is shown in Fig. 3. The parameters α and η have already been fixed in (4.14) and e = 1.2 is the minimal value compatible with (4.1), (4.4), and (4.23). d = 0.1 turns out to be suitable as in [1]. Fig. 3 shows again a window of γ -values around $\gamma \approx 0.6$, where LB exceeds CF thus providing (for suitable $\varepsilon > 0$) positive coercivity constants in proposition 4.1. To be definite let us fix $\gamma = 0.6$; we then have

$$\Delta := LB(0.39, 0.6, 10^{-3}, 0.1, 1.2) - CF(0.39, 0.6) \ge 0.023 > 0, \tag{4.32}$$

and by taking $\varepsilon := \Delta$, $\Delta/2$ is an allowed constant in (4.20). For comparison Fig. 3 also shows the slightly better lower bound from [1], which is just $LB(0.39, \gamma, 0, 0.1, 1.2)$. A closer inspection shows that minimum F is always obtained at $\tau = 0$, so that the τ -minimization does in fact not contribute to the minimum; the minimizing values of s and t, however, depend on γ as in [1].

So far proposition 4.1 guarantees the existence of a unique solution $v_{ex} \in \mathcal{H}_{\alpha+\gamma}$ of the

Equation (4.33) defines a linear and by (4.34) bounded operator

where $\mathcal{H}'_{\alpha-\gamma}$ denotes the dual space of $\mathcal{H}_{\alpha-\gamma}$. Defining the weighted L^2 -space

The equation to be solved, eq. (4.3), reads in the notation (4.5)-(4.7):

The multiplication by $1/r^2$ is a bounded operator on Q_R and $\mathcal{K}_M r^{-2}$ is thus compact, too. The operator $\mathcal{I} - M\mathcal{K}_M r^{-2} =: \mathcal{F}_M$ on the Hilbert space $\mathcal{L}^2_{\alpha+\gamma}$ is then of Fredholm type, and Fredholm's alternative yields a unique solution of eq. $(4.37)_b$ for any $\mathcal{L}^2_{\alpha+\gamma}$ -right-hand side, provided that the homogeneous equation admits only the trivial solution. This is guaranteed by proposition 3.3, which proves triviality of the solution in the homogeneous version of eq. (4.2).

An $\mathcal{L}^2_{\alpha+\gamma}$ -bound on this solution v is easily obtained by recalling that \mathcal{F}_M has a bounded inverse (see, e.g., [17], p. 83f.):

A weak solution $u \in \mathcal{H}_0(Q_R)$ of problem $P_{\Omega}(Q_R)$ corresponds by (A.4) to a solution $v \in \mathcal{H}_{2\alpha}(Q_R)$ of eq. (4.3). As $\gamma \geq \alpha$ the above solution is of this kind.

Note that for the solution of eq. (4.33) no other properties of the vector field **a** have been used than the bounds (4.1). The solution of eq. (4.36), however, relied on the uniqueness result of proposition 3.3, which made use of the particular form (2.23) of the vector field.

Concerning the various parameters the choice

$$(\alpha, \gamma, \eta, d, e, \Delta) = (0.39, 0.6, 10^{-3}, 0.1, 1.2, 0.023)$$
 (4.42)

satisfies all prerequisites of the above described solution procedure, in particular, conditions (4.4), (4.15), (4.23), (4.31), and (4.32). M is given by $M = C(\alpha, \gamma, \eta, d)/\Delta$ with $C(\alpha, \gamma, \eta, d)$ defined in (4.25). So, proposition 4.1 may be applied to obtain a solution v_{ex} of eq. (4.33) and subsequent application of Fredholm's theory yields the desired solution v of eq. (4.36). We summarize this result in the following proposition.

Proposition 4.2. Let the vector field $\mathbf{a} = a_{\zeta} \mathbf{e}_{\zeta} + a_{\rho} \mathbf{e}_{\rho}$ be as in (2.23) with argument $w - \Omega$, where $w \in \mathcal{H}_0(Q_R)$ is fixed and the data function Ω satisfies the bound $\|\Omega/(r \sin \varphi)\|_{(\gamma - \alpha, \eta)} < \infty$. Let furthermore, the parameters α , γ , η , d, e, and Δ be fixed according to (4.42). Then eq. (4.3) has a unique solution $v \in \mathcal{H}_{\alpha+\gamma}(Q_R) \subset \mathcal{H}_{2\alpha}(Q_R)$ satisfying the bound (4.40).

Remark: The bounding constant C_1 as defined by (4.41) does not explicitly depend on the particular form of the vector field **a** (and hence on its arguments) nor on the domain Q_R ;

implicitly, however, it can depend on these quantities via the Fredholm constant \widetilde{C}_F commonly introduced by a non-constructive argument. In appendix C it is shown that this is not the case: based on spectral estimates of the Fredholm operator $\widetilde{\mathcal{F}}$ we derive a bound on \widetilde{C}_F that only depends on upper and lower bounds on \mathbf{a} and that does not depend on R.

5. Proofs of theorems 2.1 and 2.2

The proof of theorem 2.1 is based on Schauder's fixed point principle in a version due to Schaefer (cf. [18], p. 504, Theorem 4), viz.,

Proposition 5.1 (fixed point principle). Let $\mathcal{T}: \mathcal{B} \to \mathcal{B}$ be a continuous, compact mapping of the Banach space \mathcal{B} into itself and let the set

be bounded. Then, \mathcal{T} has a fixed point.

The basic ingredients of the proof are the the same as those employed in [1]: The mapping is obtained by solution of the linearized problem with fixed argument in the vector field $\mathbf{a}[\ldots]$ according to proposition 4.2. The Banach space is a weighted L^p -space, where weight and integration exponent have to be carefully chosen to ensure the mapping to be a continuous endomorphism. Here the lemmata A.2 and A.3 play a crucial role, which are shown to remain valid in the present situation with less boundary control. Boundedness of the set (5.1) depends on the global bound (4.40) and compactness is in fact a standard result. The details of the proof differ, however, from those in [1] due to the use of polar coordinates and the necessity of an additional weight. Moreover, the governing equation (4.3) is now more complicated and bounds on its solution involve, additionally, Fredholm-type estimates.

Let $\mathcal{B} := \mathcal{L}^p_{\delta}(Q_R)$ with

(4.3), where we have set $w := \widehat{\varphi}^{-\alpha} r^{-\eta} v_0$ for some $v_0 \in \mathcal{L}^p_{\delta}(Q_R)$ and where Ω satisfies condition (2.30). By (4.40), (2.30) and appendix C this solution satisfies the global bound

Compactness of the mapping $\mathcal{T}: \mathcal{L}^p_{\delta}(Q_R) \to \mathcal{L}^p_{\delta}(Q_R)$ is implied by the compactness of the embedding (5.5), which is in fact a standard result for any bounded region $\subset \mathbb{R}^2$ and any $1 \leq p < \infty$.

Boundedness of the set (5.1) is an immediate consequence of (5.3) and (5.4):

With all prerequisites fulfilled proposition 5.1 provides a fixed point $v = v_0$ of eq. (4.3) with $\mathbf{a} = \mathbf{a}[\widehat{\varphi}^{-\alpha}r^{-\eta}v_0 - \Omega]$. Substituting $u = \widehat{\varphi}^{-\alpha}r^{-\eta}v$ we end up with a solution of eq. (4.2), equivalently eq. (2.29), as claimed in theorem 2.1.

The estimate (2.31) follows by (5.3), (4.42), and the norm equivalence

is based on solutions of a suitable sequence of bounded problems $(P_{\Omega}(Q_n))_{n\in\mathbb{N}\setminus\{1\}}$: Let $\Omega\in L^{\infty}(Q_{\infty})$ with bound (2.32) and $\Omega_n:=\Omega|_{Q_n}$. By theorem 2.1 we have a sequence of solutions $(u_n)\subset\mathcal{H}_0(Q_n)$ with bound

$$\|\nabla u_n\|_{(\beta,\eta)} \le \sqrt{C}, \quad n \in \mathbb{N} \setminus \{1\},$$

where the constant C does not depend on n. Considering u_n on Q_m , $1 < m \le n$ we construct as in [1] a sequence of nested subsequences and choose finally the diagonal sequence $(u^{(k)})_{k \in \mathbb{N}}$. This sequence has the favourable property that $u^{(k+1)}$ extends $u^{(k)}$ defined on Q_k onto Q_{k+1} . Thus $(u^{(k)})_{k \in \mathbb{N}}$ allows the unique definition of a function u on Q_{∞} that satisfies the bound (2.33) and that is in fact a weak solution of $P_{\Omega}(Q_{\infty})$ (cf. [1]). Together with proposition 3.2 this proves theorem 2.2.

6. Proofs of theorems 2.3 and 2.4

Theorems 2.3 and 2.4 answer the axisymmetric intensity problems as formulated in the problems $P_{I,\hat{I}}(A_R)$ and $P_I(A_\infty)$, corresponding to spherical shells and exterior space in \mathbb{R}^3 , respectively. The existence of weak solutions to both problems follows essentially by theorems 2.1/2.2 and the results gathered in appendix B. Higher interior regularity then follows by standard arguments, whereas boundary regularity, especially continuous assumption of the boundary values, requires more subtle arguments, which differ in parts from those applied to the direction problem. We present the bounded case in some detail; the unbounded case then follows by obvious modifications.

The essential prerequisite of theorem 2.1 is the bound (2.30) on the data function Ω comprising the zero-positions angle Ψ and the boundary value function q_l . Fixing R > 1, $\widehat{m} \in \mathbb{N}$, and a (possibly empty) set of points $\{z_1, \ldots, z_{2N}\} \subset A_R \setminus SA, N \in \mathbb{N}_0$, this bound is satisfied by Ψ according to lemma B.1. Fixing, furthermore, Hölder continuous, symmetric intensity functions I and \widehat{I} , satisfying the axis condition (2.34), the boundary functions $p|_{S_1}$ and $p|_{S_R}$, given by (2.15) and (2.16), respectively, then satisfy Hölder conditions of type (B.12) and (B.13). Here the constant $p_0 =: p_{l,0}$ is fixed by condition (B.24). According to lemma B.3 the function q_l , which is part of the solution (p_l, q_l) of the boundary value problem (2.17), (2.18), then satisfies the above bound as well. Theorem 2.1 thus provides a weak solution $u \in \mathcal{H}_0(Q_R)$ of eq. (2.27) corresponding – in cylindrical coordinates – to a solution $u \in H^1_{as}(A_R)$ of eq. (2.22). The conjugate variable $\wp \in H^1(A_R)$ then is obtained from system (2.19) as in [1] with eq. (2.22) representing the associated integrability condition. Note that a constant \wp_0 is here still free. With $p = \wp + p_l$, $q = u + q_l$ system (2.19) is equivalent to (2.13), which in turn takes by g = (p + iq)/2 the complex form (2.12). Finally, cancelling the substitution (2.10), we obtain a weak solution f of eq. (2.6), equivalent – in cylindrical coordinates – to a solution \mathbf{H} of eq. (2.1). As in [1] higher interior regularity is most easily seen by changing once more coordinates. Using Cartesian coordinates in \mathbb{R}^3 each Cartesian component of ${\bf H}$ turns out to be weakly harmonic, hence harmonic, and thus a smooth function in the spherical shell $B_R \setminus B_1$.

Different boundary conditions make the essential difference between the direction and the intensity problem. The crucial boundary condition is here (2.20), which we have exploited in the form (2.24), resulting in the weak formulation (2.26), or (2.29) when using polar coordinates. The following proposition recovers a weak version of the \wp -boundary condition from (2.29).

Proposition 6.1. Let $u \in \mathcal{H}_0(Q_R)$ be a solution of eq. (2.29) for all $\psi \in C^1(\overline{Q_R})$ and let $\wp \in H^1(A_R)$ be determined by system (2.19), then

trace
$$\wp|_{\partial A_{\mathcal{B}}} = const.$$

PROOF: Let us start with writing eq. (2.29) in the form

$$\int_{1}^{R} \int_{-\pi}^{\pi} \left[\left(\partial_{r} u + a_{r} [u - \Omega] \frac{u - \Omega}{r \sin \varphi} \right) \partial_{r} \psi + \left(\frac{1}{r} \partial_{\varphi} u + a_{\varphi} [u - \Omega] \frac{u - \Omega}{r \sin \varphi} \right) \frac{1}{r} \partial_{\varphi} \psi \right] d\varphi \, r dr ,$$
(6.1)

where we made use of the antisymmetric continuations of the variables u, Ω , and ψ . On the other hand system (2.19) takes in polar coordinates and by (2.23) the form

$$\partial_{r}\wp = \frac{1}{r}\partial_{\varphi}u + a_{\varphi}[u - \Omega]\frac{u - \Omega}{r\sin\varphi},$$

$$-\frac{1}{r}\partial_{\varphi}\wp = \partial_{r}u + a_{r}[u - \Omega]\frac{u - \Omega}{r\sin\varphi}.$$
(6.2)

Considering the inner boundary component S_1 first, for the test function ψ we make the ansatz:

$$\psi(r,\varphi) = \psi_{\varepsilon}(r) \,\psi_0(\varphi) \,, \quad 0 < \varepsilon < R \,,$$
(6.3)

where ψ_0 is a C^1 -function on S_1 and ψ_{ε} is given by

$$\psi_{\varepsilon} := \begin{cases} 1 - (r - 1)/\varepsilon & \text{for } 1 < r < 1 + \varepsilon, \\ 0 & \text{for } 1 + \varepsilon \le r < R. \end{cases}$$

$$(6.4)$$

We then have $\psi \in H^1(A_R)$, which is admissible in (6.1). Inserting (6.2)₂ into the first parantheses in (6.1), abbreviating the second parantheses by $A[u,\Omega]$, and using (6.3) we obtain after integration by parts:

$$\int_{1}^{R} \int_{-\pi}^{\pi} \left(\wp \, \partial_r \psi_{\varepsilon} \, \partial_{\varphi} \psi_0 + A[u, \Omega] \, \psi_{\varepsilon} \, \partial_{\varphi} \psi_0 \right) \mathrm{d}\varphi \, \mathrm{d}r = 0 \,.$$

Using (6.4) in the first term and estimating the second by Cauchy-Schwarz we further obtain:

$$\left| \frac{1}{\varepsilon} \int_{1}^{1+\varepsilon} \left(\int_{-\pi}^{\pi} \wp \, \partial_{\varphi} \psi_{0} \, \mathrm{d}\varphi \right) \mathrm{d}r \right| \leq \int_{1}^{1+\varepsilon} \int_{-\pi}^{\pi} \left| A \frac{1}{r} \partial_{\varphi} \psi_{0} \right| \mathrm{d}\varphi \, r \mathrm{d}r
\leq \left(\int_{1}^{1+\varepsilon} \int_{-\pi}^{\pi} A^{2} \, \mathrm{d}\varphi \, r \mathrm{d}r \right)^{1/2} \left(\int_{1}^{1+\varepsilon} \int_{-\pi}^{\pi} \left(\frac{1}{r} \partial_{\varphi} \psi_{0} \right)^{2} \mathrm{d}\varphi \, r \mathrm{d}r \right)^{1/2}
\leq \sqrt{2} \left(\int_{Q_{R}} A^{2} \, \mathrm{d}\mu \right)^{1/2} \sqrt{\varepsilon} \left(\int_{-\pi}^{\pi} \left(\partial_{\varphi} \psi_{0} \right)^{2} \, \mathrm{d}\varphi \right)^{1/2}.$$
(6.5)

The first factor on the right-hand side is bounded by (A.2), (B.5), and (B.21):

$$\left(\int_{Q_R} A^2 \, \mathrm{d}\mu \right)^{1/2} \le \left\| \frac{1}{r} \partial_{\varphi} u + a_{\varphi} [u - \Omega] \frac{u - \Omega}{r \sin \varphi} \right\|_{(0,0)}
\le \|\nabla u\|_{(0,0)} + \sqrt{2} \left(\left\| \frac{u}{r \sin \varphi} \right\|_{(0,0)} + \left\| \frac{\Omega}{r \sin \varphi} \right\|_{(0,0)} \right)
\le \left(1 + \sqrt{2} \, \pi \right) \|\nabla u\|_{(0,0)} + \sqrt{\pi} \, K \, R \,,$$

and the second factor represents a normalization of ψ_0 assumed to be fixed:

$$\int_{-\pi}^{\pi} \left(\partial_{\varphi} \psi_0 \right)^2 d\varphi = 1. \tag{6.6}$$

⁸Recall that only in section 2 variables written in polar coordinates are marked by a tilde. In this section we make free use of polar and cylindrical coordinates without further indication.




Figure 4: $A_{R,\varepsilon}^+$ and the curved boundary components $S_{1,\varepsilon}^+$ and $S_{R,\varepsilon}^+$.

Letting $\varepsilon \to 0$ in (6.5) then yields

$$\int_{-\pi}^{\pi} \operatorname{trace} \wp \big|_{r=1} \, \partial_{\varphi} \psi_0 \, \mathrm{d}\varphi = 0$$

for all antisymmetric $\psi_0 \in C^1(S_1)$ with normalization (6.6), which in turn means

trace
$$\wp|_{S_1} = const.$$

With an obviously modified sequence of test functions we obtain trace $\wp|_{S_R} = const$ as well.

Note that in general these constants may be different from zero and different from one another; however, by adding a suitable constant in (2.19) we can achieve that

trace
$$\wp|_{S_1} = 0$$
, trace $\wp|_{S_R} =: \wp_0$. (6.7)

Higher boundary regularity then follows as in [1], however, with interchanged variables \wp and u: the second-order equation for the variable \wp ,

$$\Delta \wp = \partial_{\zeta} \left(\frac{1}{\rho} \sin(u - \Omega) \right) + \partial_{\rho} \left(\frac{1}{\rho} \left(\cos(u - \Omega) \right) - 1 \right) =: \partial_{\zeta} F_{\zeta} + \partial_{\rho} F_{\rho},$$

follows from (2.19). On the regularized domain $A_{R,\varepsilon}^+$ (see Fig. 4) the vector field **F** is bounded by

$$|F_{\zeta}| < \frac{1}{\varepsilon}, \quad |F_{\rho}| < \frac{2}{\varepsilon},$$

and theorem 14.1 in [19] applied to $\wp \in H^1(A_R)$ then yields $\wp \in C^{0,\alpha}(\overline{A_{R,\varepsilon}^+})$ for some $0 < \alpha \le 1$ (depending on ε , R, and $\|\wp\|_{(0,0)}$). This implies, in particular, continuous assumption of the

boundary values (6.7) on $S_{1,\varepsilon}^+ \cup S_{R,\varepsilon}^+$ for any $\varepsilon > 0$, hence on $S_1^+ \cup S_R^+$, and by symmetric continuation on $\partial A_R = S_1 \cup S_R$.

Finally, assume $I \in C^{0,\alpha}(S_1)$, $\widehat{I} \in C^{0,\alpha}(S_R)$, then $p|_{\partial A_R} \in C^{0,\alpha}(\partial A_R)$ by (2.15), (2.16), and for the solution p_l (and q_l) of the boundary value problem (2.17), (2.18) holds $p_l \in C^{0,\alpha}(\overline{A_R})$. Therefore, $p = \wp + p_l$ assumes continuously its boundary values, satisfies (2.15) at the inner boundary, and (2.16) in the form

$$p|_{S_R} = p_l|_{S_R} + \wp|_{S_R} = 2\left(\ln \widehat{I} - \sum_{n=1}^{m-\widehat{m}} \ln|z - z_n|\Big|_{S_R} + p_{l,0}\right) + \wp_0$$

at the outer boundary. The constant I_0 in problem $P_{L\widehat{I}}(A_R)$ is thus determined by the relation

$$\ln I_0 + m \ln R = p_0 = p_{l,0} + \wp_0/2.$$

This argument does not apply to q since in the weak formulation this variable is free at the boundary. Instead, we make use of an argument based on Privaloff's theorem [20] and a representation theorem due to Bers and Nirenberg [21]. The former theorem guarantees uniform Hölder continuity of both components of a complex analytic function in a disc if only one component takes continuously boundary values that are in some Hölder class at the boundary; the other theorem represents solutions of system (2.13) as sum of a complex analytic function and a uniformly Hölder continuous function. Details of the argument can be found in [1] (where the variables p and q have to be interchanged). By (2.5), (2.10) this establishes $\mathbf{H} \in C(\overline{A_R})$.

Concerning uniqueness recall that fixed outer rotation number \widehat{w} , fixed set of zeroes, and fixed intensity functions I and \widehat{I} mean a fixed data function Ω . Hence uniqueness of the weak solution as stated in theorem 2.1 implies uniqueness as claimed in theorem 2.3. Of course, a sign always remains free in problem $P_{L\widehat{I}}(A_R)$. This concludes the proof of theorem 2.3.

With obvious modifications all these arguments work in the unbounded case as well: a unique weak solution $u \in \mathcal{H}_0^{loc}(A_{\infty})$ is provided by theorem 2.2, lemma B.1 (where \widehat{v} is replaced by $\widetilde{\delta} - 1$), and lemma B.2; the conjugate variable \wp is again determined by system (2.19); the inner boundary condition (2.15) follows as in the bounded case, whereas the outer boundary condition (2.16) is no longer present; the regularity arguments, local in character, can be taken over without any change. This proves theorem 2.4.

7. A related intensity problem

In [16] the authors introduce "an oblique boundary value problem related to the Backus problem in geodesy". Starting point is the intensity problem (1.1) reformulated in terms of a potential u for the gravitational field \mathbf{H} in the exterior space E:

$$\Delta u = 0 \qquad \text{in } E,$$

$$|\nabla u| = I \qquad \text{on } S^2,$$

$$u(\mathbf{x}) \to 0 \qquad \text{for } |\mathbf{x}| \to \infty.$$

$$(7.1)$$

By the Kelvin transformation

$$\mathbf{x} \to \mathbf{x}^* := \frac{\mathbf{x}}{|\mathbf{x}|^2}, \quad u(\mathbf{x}) \to v(\mathbf{x}^*) := \frac{1}{|\mathbf{x}^*|} u\left(\frac{\mathbf{x}^*}{|\mathbf{x}^*|^2}\right)$$

the exterior problem (7.1) can equivalently be formulated as interior problem in the unit ball B_1 :

$$\Delta v = 0 \qquad \text{in } B_1, (v + \mathbf{n} \cdot \nabla v)^2 + |\nabla_t v|^2 = I^2 \qquad \text{on } \partial B_1,$$
(7.2)

where $\mathbf{n} := \mathbf{x}/|\mathbf{x}|$ denotes the exterior unit normal at ∂B_1 and $\nabla_t := \nabla - \mathbf{n} \, \mathbf{n} \cdot \nabla$ the tangential gradient at ∂B_1 .

Under the condition

$$v + \mathbf{n} \cdot \nabla v \ge 0$$
 on ∂B_1 , (7.3)

which is equivalent to

$$\mathbf{n} \cdot \nabla u \le 0 \quad \text{on } S^2 \tag{7.4}$$

in the exterior problem, the boundary condition $(7.2)_2$ can equivalently be expressed by

$$v + \mathbf{n} \cdot \nabla v = \left(I^2 - |\nabla_t v|^2\right)^{1/2},\tag{7.5}$$

which implies, in particular,

$$|\nabla_t v| \le I \quad \text{on } \partial B_1. \tag{7.6}$$

Without condition (7.6) the modified boundary condition⁹

$$v + \mathbf{n} \cdot \nabla v = \left(\left(I^2 - |\nabla_t v|^2 \right)_+ \right)^{1/2}$$

still makes sense, and the boundary value problem

$$\Delta v = 0 \qquad \text{in } B_1, \\ v + \mathbf{n} \cdot \nabla v = \left(\left(I^2 - |\nabla_t v| \right)_+ \right)^{1/2} \qquad \text{on } \partial B_1$$
 (7.7)

is of oblique type with corresponding solution theory (see, e.g., [22]). The authors first solve problem (7.7) with a regularized boundary condition, viz.,

$$v + \mathbf{n} \cdot \nabla v = \left(\left(I^2 - |\nabla_t v|^2 \right)_+ + \varepsilon^2 \right)^{1/2}, \quad \varepsilon > 0,$$

and find for $I \geq 0$, satisfying some Lipschitz condition on ∂B_1 , a unique solution v_{ε} of class $C^2(B_1) \cap C^{1,\beta}(\overline{B_1})$ for some $\beta > 0$. Subsequently, letting $\varepsilon \to 0$, they prove a subsequence to converge to some function $v \in C^{\alpha}(\overline{B_1})$ for some $\alpha \in (0,1]$, which is, moreover, a viscosity solution of problem (7.7) (see [23]). Concerning regularity and connection to the intensity problem they formulate the following conjecture:

Conjecture (3.1 in [16]). Problem (7.7) has a unique solution $v \in C^2(B_1) \cap C^1(\overline{B_1})$, which satisfies, moreover, condition (7.6), i.e., v is also solution of the intensity problem (7.2) and satisfies condition (7.3).

We refute this conjecture by an axisymmetric counterexample that is the *unique* solution of the intensity problem but violates condition (7.3). This counterexample, formulated in the exterior space E, is based on (the uniqueness part of) Theorem 2.4 and (the existence part of) Theorem 2.4 in ref. [1]. The latter theorem answers the (signed) direction problem $P_{\mathbf{D}}(A_{\infty})$, which is here reproduced for the reader's convenience:

 $^{^{9}(}f)_{+}$ denotes the nonnegative part $\max_{\partial B_{1}}\{f,0\}$ of a function $f:\partial B_{1}\to\mathbb{R}$.

Problem $P_{\mathbf{D}}(A_{\infty})$. Let $\mathbf{D} \in C(S_1, \mathbb{R}^2)$ be a symmetric direction field and $\delta \in \mathbb{N} \setminus \{1\}$. Determine all symmetric solutions $\mathbf{H} \in C^1(A_{\infty}) \cap C(\overline{A_{\infty}})$ of system (2.1) with decay order δ and boundary condition

$$\exists a \in C(S_1, \mathbb{R}_+) : \mathbf{H}|_{S_1} = a \mathbf{D}.$$
 (7.8)

Theorem (2.4 in [1]). Let **D** be a Hölder continuous, symmetric direction field with rotation number $m \in \mathbb{N}$ and satisfying condition

$$D_{\rho}(\varphi) = O(\varphi) \quad \text{for } \varphi \to 0, \qquad D_{\rho}(\varphi) = O(\pi - \varphi) \quad \text{for } \varphi \nearrow \pi$$
 (7.9)

at the symmetry axis. Let, furthermore, $\tilde{\delta} \in \mathbb{N} \setminus \{1\}$, $\tilde{\delta} \leq m+1$, and $\{z_1, \ldots, z_{m-\tilde{\delta}+1}\}$ be a symmetric set of points in A_{∞} . Then, problem $P_{\mathbf{D}}(A_{\infty})$ has a (up to a positive constant factor) unique solution \mathbf{H} with exact decay order $\tilde{\delta}$ vanishing at $z_1, \ldots, z_{m-\tilde{\delta}+1}$ and nowhere else.

The formulation of problem and theorem here differs from that in [1] by the inclusion of the case m=1, $\tilde{\delta}=2$, which refers to the gravitational case, whereas in [1] exclusively the magnetic problem had been considered. The theorem, however, applies to this case as well as can easily be checked.

Counterexample (in the exterior space). Let **D** be a Hölder continuous, symmetric direction field satisfying condition (7.9) with rotation number m = 1 that violates condition (7.4), i.e. $\mathbf{n} \cdot \mathbf{D}$ is changing sign along S_1 . According to the theorem above there is a unique solution $\mathbf{H}_0 \in C^1(A_\infty) \cap C(\overline{A_\infty})$ of Problem $P_{\mathbf{D}}(A_\infty)$ with exact decay order $\tilde{\delta} = 2$, no zeroes in A_∞ , and boundary condition

$$\mathbf{H}_0|_{S_1} = a \mathbf{D}$$
 for some $a \in C(S_1, \mathbb{R}_+)$.

Obviously, \mathbf{H}_0 is as well a solution of the intensity problem $P_I(A_\infty)$ with $I := |\mathbf{H}_0||_{S_1}$ and rotation number m = 1. The condition m = 1 implies by relation (2.9) the decay order $\tilde{\delta} = 2$ and no zeroes in A_∞ for any solution \mathbf{H} of $P_I(A_\infty)$. Hence, by theorem 2.4, \mathbf{H}_0 is the only solution that fits to I at S_1 and this solution violates by construction condition (7.4). Solutions with m > 1 violate condition (7.4) in any case. Note that regularity conditions on I (such as condition (2.34)) do not matter when only appealing to the uniqueness part of theorem 2.4.

Remark: This example prescribes a direction field, not an intensity function. Therefore, the counterexample only demonstrates that there are intensity functions for which problems (7.2) and (7.7) differ. To read off a given intensity function if it allows "gravitational solutions", i.e., solutions satisfying condition (7.4), is an interesting open problem. On the other hand theorem 2.4 guarantees always the existence of "nongravitational solutions" of the intensity problem for a given intensity function (just by prescribing zeroes in A_{∞}).

A. Hardy-type inequalities

Weighted Hardy-type inequalities in L^2 and, more generally, in L^p -spaces are the essential tool to get to grips the singularity at the symmetry axis. We collect here those inequalities from [1], which are needed in the present context, adapted to polar coordinates and free boundary conditions. We prove only those parts that have changed and rely otherwise on the proofs given in [1].




Figure 5: Graph of the tent function $\widehat{\varphi}: [0, \pi] \to [0, \pi/2]$.

Using polar coordinates (r, φ) on the rectangle $Q_R = (1, R) \times (0, \pi)$ the following notation is convenient to describe weighted L^p -norms:

$$\|\cdot\|_{p,(\gamma,\eta)} := \left(\int_{Q_R} |\cdot|^p \,\mathrm{d}\mu_\gamma^\eta\right)^{1/p}, \qquad \mathrm{d}\mu_\gamma^\eta := \widehat{\varphi}^{-\gamma} \,\mathrm{d}\varphi \, r^{1-\eta} \,\mathrm{d}r$$

with $p \geq 1, \ \gamma \in \mathbb{R}, \ \eta \in \mathbb{R},$ and $\widehat{\varphi}$ denoting the "tent function" (see Fig. 5)

$$\widehat{\varphi} := \left\{ \begin{array}{ll} \varphi & \text{for } 0 < \varphi < \pi/2, \\ \pi - \varphi & \text{for } \pi/2 \le \varphi < \pi. \end{array} \right.$$

For $\gamma = \eta = 0$ we use the simplified notation $d\mu_0^0 =: d\mu$, for p = 2 we use: $\|\cdot\|_{2,(\gamma,\eta)} =: \|\cdot\|_{(\gamma,\eta)}$, and for $p = \infty$: $\|\cdot\|_{\infty,(0,0)} =: \|\cdot\|_{\infty}$. With the weighted gradient

$$\nabla_c := \mathbf{e}_r c \, \partial_r + \mathbf{e}_\varphi \frac{1}{r} \partial_\varphi \,, \quad c > 0$$

and the test function space

$$\mathcal{C}^1(\overline{Q_R}) := \left\{ \psi \in C^1(\overline{Q_R}) : \psi(\cdot, 0) = \psi(\cdot, \pi) = 0 \right\}$$

we define

$$\mathcal{H}_{p,\gamma} := \mathcal{H}_{p,\gamma}(Q_R) := clos\left(\mathcal{C}^1(\overline{Q_R}), \|\nabla_c \cdot\|_{p,(\gamma,\eta)}\right)$$

with the abbreviation $\mathcal{H}_{2,\gamma} =: \mathcal{H}_{\gamma}$. Note that on the bounded domain Q_R norms with different weights η or c > 0 are equivalent. With respect to p we have the well-known inclusion

$$\mathcal{H}_{p,\gamma}(Q_R) \subset \mathcal{H}_{q,\gamma}(Q_R)$$
 for $p \ge q$,

and with respect to γ we have:

$$\mathcal{H}_{p,\gamma}(Q_R) \subset \mathcal{H}_{p,\beta}(Q_R) \quad \text{for } \gamma \geq \beta.$$

On Q_{∞} we define

$$\mathcal{H}^{loc}_{p,\gamma}(Q_{\infty}):=\left\{f:Q_{\infty}\to\mathbb{R}\,:f|_{Q_R}\in\mathcal{H}_{p,\gamma}(Q_R)\text{ for any }R>1\right\}.$$

In $\mathcal{H}_{p,\gamma}$ the following Hardy-type inequalities hold:

Lemma A.1. Let $f \in \mathcal{H}_{p,\gamma}(Q_R)$ or $\in \mathcal{H}^{loc}_{p,\gamma}(Q_\infty)$ with $\gamma \neq 1-p$ and $p \geq 1$. Then, the following inequalities hold:

$$\left\| \frac{f}{\widehat{\varphi}} \right\|_{p,(\gamma,\eta)} \le \frac{p}{|p+\gamma-1|} \left\| \partial_{\varphi} f \right\|_{p,(\gamma,\eta)} \tag{A.1}$$

and, especially for p = 2,

$$\left\| \frac{f}{\widehat{\varphi}} \right\|_{(\gamma,\eta)} \le \frac{2}{|1+\gamma|} \left\| \partial_{\varphi} f \right\|_{(\gamma,\eta)}. \tag{A.2}$$

PROOF: We split the domain Q_R into subdomains $(1, R) \times (0, \pi/2)$ and $(1, R) \times (\pi/2, \pi)$ and map the latter subdomain by the substitution $\varphi \mapsto \pi - \varphi$ onto the former. On $(1, r) \times (0, \pi/2)$ the proof proceeds as for proposition 3.1 in [1]. Note that no boundary condition is necessary at the right side wall $\{\varphi = \pi/2\}$.

By (A.1) we obtain immediately the Poincaré-type inequalities:

$$||f||_{p,(\gamma,\eta)} \le \frac{\pi}{2} \frac{p}{|p+\gamma-1|} ||\partial_{\varphi} f||_{p,(\gamma,\eta)} \le R \frac{\pi}{2} \frac{p}{|p+\gamma-1|} ||\nabla_{c} f||_{p,(\gamma,\eta)}. \tag{A.3}$$

Let $H^1(Q_R)$ be the usual Sobolev space $\operatorname{clos}(C^1(Q_R), \|\cdot\|_{H^1})$ with H^1 -norm

$$||f||_{H^1}^2 = \int_{Q_R} (|f|^2 + |\nabla f|^2) d\varphi r dr,$$

then by (A.3) we have the norm equivalence $\|\cdot\|_{H^1} \sim \|\nabla_c \cdot\|_{(0,\eta)}$ and by definition of \mathcal{H}_0 the alternative characterization

$$\mathcal{H}_0(Q_R) = \left\{ f \in H^1(Q_R) : \operatorname{trace} f|_{\varphi=0} = \operatorname{trace} f|_{\varphi=\pi} = 0 \right\}.$$

By (A.2) follows for $\gamma \neq -1$ the further equivalence

$$\|\nabla_c \cdot\|_{(\gamma,\eta)} \sim \|\nabla_c(\widehat{\varphi}^{-\gamma/2} \cdot)\|_{(0,\eta)} \tag{A.4}$$

and hence

$$\mathcal{H}_{\gamma}(Q_R) = \operatorname{clos}\left(\mathcal{C}^1(\overline{Q_R}), \|\nabla_c(\widehat{\varphi}^{-\gamma/2} \cdot)\|_{(0,\eta)}\right)$$

$$= \left\{f : \widehat{\varphi}^{-\gamma/2} f \in \mathcal{H}_0(Q_R)\right\}. \tag{A.5}$$

Crucial for our solution procedure are two inequalities of type

$$\left\| \frac{f}{\widehat{\varphi}^{\delta}} \right\|_{p,(0,\eta)} \le C \left\| \nabla_c f \right\|_{(\beta,\eta)} \tag{A.6}$$

for "large" and "small" p and as large as possible δ for given β .

Lemma A.2 (large-p-case). Let c > 0, $\eta > 0$, $p \ge 2$, $\beta > -2/p$, $\delta < \beta/2 + 1/p$, $R \ge 2$, and $f \in \mathcal{H}_{\beta}(Q_R)$, then inequality (A.6) holds with a constant $C = C_>$ depending on c, η , p, β , δ , and R.

Proof: Starting point are two one-dimensional inequalities, viz.,

$$\sup_{0 < \varphi < \pi} \left\{ |h(\varphi)| \, \widehat{\varphi}^{-\gamma} \right\} \le \int_0^{\pi} |\partial_{\varphi} h| \, \widehat{\varphi}^{-\gamma} \, \mathrm{d}\varphi \tag{A.7}$$

and

$$\sup_{1 < r < R} \left\{ |g(r)| \right\} \le \int_{1}^{R} |\partial_{r} g| \, \mathrm{d}r + \frac{1}{R - 1} \int_{1}^{R} |g| \, \mathrm{d}r \,. \tag{A.8}$$

Inequality (A.7) holds for functions $h \in H^1((0,\pi))$ with $h(0) = h(\pi) = 0$ and corresponds to inequality (3.18) in [1]. The mean-value version (A.8) differs from the corresponding inequality in [1] since no boundary conditions are available in the radial direction. It holds for $g \in H^1((1,R))$ and follows by

$$g(r) = \frac{1}{R-1} \int_{1}^{R} (g(r) - g(s)) ds + \frac{1}{R-1} \int_{1}^{R} g(s) ds$$
$$= \frac{1}{R-1} \int_{1}^{R} \int_{s}^{r} \partial_{t} g(t) dt ds + \frac{1}{R-1} \int_{1}^{R} g(s) ds$$
$$\leq \int_{1}^{R} |\partial_{t} g(t)| dt + \frac{1}{R-1} \int_{1}^{R} |g(s)| ds.$$

Let now $f \in \mathcal{H}_{1,\gamma}(Q_R)$. By (A.7), (A.8) one obtains

$$\int_{Q_R} f^2 \,\widehat{\varphi}^{-\gamma} \,\mathrm{d}\mu_{\gamma}^{\eta} = \int_1^R \int_0^{\pi} \frac{f}{r} \,\widehat{\varphi}^{-\gamma} \times rf \,\widehat{\varphi}^{-\gamma} \,\mathrm{d}\varphi \, r^{1-\eta} \,\mathrm{d}r$$

$$\leq \int_1^R \frac{1}{r} \sup_{\varphi} \left\{ |f(r,\varphi)| \,\widehat{\varphi}^{-\gamma} \right\} r^{1-\eta} \,\mathrm{d}r \times \int_0^{\pi} \sup_{r} \left\{ |rf(r,\varphi)| \right\} \,\widehat{\varphi}^{-\gamma} \,\mathrm{d}\varphi$$

$$\leq \int_1^R \frac{1}{r} \int_0^{\pi} |\partial_{\varphi} f| \,\widehat{\varphi}^{-\gamma} \,\mathrm{d}\varphi \, r^{1-\eta} \,\mathrm{d}r \times \left[\int_0^{\pi} \int_1^R |\partial_r (rf)| \,\mathrm{d}r \,\widehat{\varphi}^{-\gamma} \,\mathrm{d}\varphi$$

$$+ \frac{1}{R-1} \int_0^{\pi} \int_1^R r|f| \,\mathrm{d}r \,\widehat{\varphi}^{-\gamma} \,\mathrm{d}\varphi$$

The first factor can immediately be estimated by

$$\int_{Q_R} |\nabla_c f| \,\mathrm{d}\mu_{\gamma}^{\eta} \,,$$

whereas for the second we apply once more (A.7) to obtain

$$\int_{1}^{R} \int_{0}^{\pi} |\partial_{r} f| \, \widehat{\varphi}^{-\gamma} d\varphi \, r dr + \int_{1}^{R} \int_{0}^{\pi} \left(\frac{1}{R-1} + \frac{1}{r} \right) |f| \, \widehat{\varphi}^{-\gamma} d\varphi \, r dr
\leq \frac{R^{\eta}}{c} \int_{Q_{R}} |\nabla_{c} f| \, d\mu_{\gamma}^{\eta} + \pi \int_{1}^{R} \int_{0}^{\pi} \left(\frac{r}{R-1} + 1 \right) \frac{1}{r} |\partial_{\varphi} f| \, \widehat{\varphi}^{-\gamma} d\varphi \, r dr
\leq (3\pi + c^{-1}) \, R^{\eta} \int_{Q_{R}} |\nabla_{c} f| \, d\mu_{\gamma}^{\eta}.$$

In summary we have

$$\int_{Q_R} f^2 \,\widehat{\varphi}^{-\gamma} \,\mathrm{d}\mu_{\gamma}^{\eta} \le (3\pi + c^{-1}) \,R^{\eta} \bigg(\int_{Q_R} |\nabla_c f| \,\mathrm{d}\mu_{\gamma}^{\eta} \bigg)^2,$$

which corresponds to eq. (3.23) in [1]. The rest of the proof proceeds as in [1].

Lemma A.3 (small-p-case). Let c > 0, $\eta > 0$, $\beta > -1$, $2 \le p \le 4$, $\delta = \beta/2 + (6-p)/(2p)$, $R \ge 2$, and $f \in \mathcal{H}_{\beta}(Q_R)$, then inequality (A.6) holds with a constant $C = C_{<}$ depending on c, η , β , p, and R.

Proof: Starting point are again one-dimensional inequalities, viz.,

$$\sup_{0 < \varphi < \pi} \left\{ |h(\varphi)|^2 \, \widehat{\varphi}^{-(1+\beta)} \right\} \le (1+\beta)^{-1} \int_0^{\pi} |\partial_{\varphi} h|^2 \, \widehat{\varphi}^{-\beta} \, \mathrm{d}\varphi \,, \tag{A.9}$$

which corresponds to inequality (3.17) in [1], and

$$\sup_{1 < r < R} \left\{ |rg(r)|^2 \right\} \le 2 \left(\int_1^R |\partial_r g| \, r \, dr \right)^2 + 18 \left(\int_1^R |g| \, dr \right)^2, \tag{A.10}$$

which follows from (A.8). An analogous calculation as in the preceding lemma yields by (A.9), (A.10):

$$\begin{split} \int_{Q_R} f^4 \, \widehat{\varphi}^{-(1+\beta)} \, \mathrm{d} \mu_{\beta}^{\eta} &= \int_1^R \int_0^\pi \left| \frac{f}{r} \right|^2 \widehat{\varphi}^{-(1+\beta)} \times |rf|^2 \, \widehat{\varphi}^{-\beta} \mathrm{d} \varphi \, r^{1-\eta} \mathrm{d} r \\ &\leq \int_1^R \frac{1}{r^2} \, \sup_{\varphi} \left\{ |f(r,\varphi)|^2 \, \widehat{\varphi}^{-(1+\beta)} \right\} r^{1-\eta} \mathrm{d} r \times \int_0^\pi \sup_r \left\{ |rf(r,\varphi)|^2 \right\} \widehat{\varphi}^{-\beta} \mathrm{d} \varphi \\ &\leq (1+\beta)^{-1} \int_1^R \frac{1}{r^2} \int_0^\pi |\partial_{\varphi} f|^2 \, \widehat{\varphi}^{-\beta} \mathrm{d} \varphi \, r^{1-\eta} \mathrm{d} r \\ &\qquad \times \left[2 \int_0^\pi \left(\int_1^R |\partial_r f| \, \mathrm{d} r \right)^2 \widehat{\varphi}^{-\beta} \mathrm{d} \varphi + 18 \int_0^\pi \left(\int_1^R |f| \, \mathrm{d} r \right)^2 \widehat{\varphi}^{-\beta} \mathrm{d} \varphi \right]. \end{split}$$

The first factor is estimated by

$$(1+\beta)^{-1} \int_{Q_R} |\nabla_c f|^2 d\mu_\beta^{\eta},$$

the first term of the second factor using Hölders's inequality is estimated by

$$(R^2 - 1) \int_1^R \int_0^{\pi} |\partial_r f|^2 \widehat{\varphi}^{-\beta} d\varphi \, r dr \le \frac{R^{2+\eta}}{c^2} \int_{Q_R} |\nabla_c f|^2 d\mu_{\beta}^{\eta},$$

and the second term using once more (A.7) by

$$18\pi \left(\int_{1}^{R} \int_{0}^{\pi} |\partial_{\phi} f| \, \widehat{\varphi}^{-\beta/2} \, \mathrm{d}\varphi \, \mathrm{d}r \right)^{2}$$

$$\leq 9\pi^{2} (R^{2} - 1) \int_{1}^{R} \int_{0}^{\pi} \left| \frac{1}{r} \partial_{\phi} f \right|^{2} \, \widehat{\varphi}^{-\beta} \, \mathrm{d}\varphi \, r \, \mathrm{d}r \leq 9\pi^{2} R^{2+\eta} \int_{Q_{R}} |\nabla_{c} f|^{2} \, \mathrm{d}\mu_{\beta}^{\eta} \, .$$

In summary we have

$$\int_{Q_R} f^4 \, \widehat{\varphi}^{-(1+\beta)} \, \mathrm{d}\mu_{\beta}^{\eta} \le \left(9 \, \pi^2 + c^{-2}\right) \frac{R^{2+\eta}}{1+\beta} \left(\int_{Q_R} |\nabla_c f|^2 \, \mathrm{d}\mu_{\beta}^{\eta}\right)^2,$$

and interpolation with (A.2) then yields as in [1] the proposition.

B. Estimates of the data function Ω

The data function $\Omega = \Psi + q_l$ comprises the zero-positions angle Ψ and the boundary value function q_l . The estimates of Ψ have already been done in [1] and we report here just the results in a slightly different notation, whereas the estimates of q_l are new and are given with full proof.

Let us write the analytic function (2.11) in the form

$$h(z) = z^{-n} \prod_{n=1}^{N} (z - z_n)(z - \overline{z}_n) = z^{-\widehat{n}} \prod_{n=1}^{N} \left(1 - \frac{z_n}{z}\right) \left(1 - \frac{\overline{z}_n}{z}\right),$$

$$m - \widehat{n} = 2N, \ N \in \mathbb{N}_0$$
(B.1)

with points $\{z_1, \ldots, z_N\} \subset A_{\infty}^+$, which satisfy, in particular, $\Im z_n > 0$. Decomposing \overline{h}/h into real and imaginary parts and introducing polar coordinates (r, φ) one obtains

$$\frac{\overline{h(z)}}{h(z)} =: v(r,\varphi) + i w(r,\varphi), \qquad (r,\varphi) \in Q_{\infty}$$
(B.2)

with

$$v = \frac{\overline{h}^2 + h^2}{2|h|^2}, \qquad w = \frac{\overline{h}^2 - h^2}{2i|h|^2}, \qquad v^2 + w^2 = 1.$$
 (B.3)

We then define

$$\Psi(r,\varphi) := \arctan \frac{w(r,\varphi)}{v(r,\varphi)},$$
(B.4)

where arctan means the principal branch of the inverse tan function with $\arctan 0 = 0$. This definition resolves the ambiguity in the choice of Ψ and fixes the discontinuities of Ψ at the zeroes of v.

Lemma B.1. Let Ψ be as given by (B.1) – (B.4). Then the following inequalities hold:

$$|\Psi(\cdot,\varphi)| \le K \sin \varphi \qquad in \ Q_{\infty} \tag{B.5}$$

and

$$\int_{Q_{\infty}} \left(\frac{\Psi}{r \sin \varphi} \right)^2 d\mu_{\beta}^{\eta} \le \left(\frac{\pi}{2} \right)^{1-\beta} \frac{2K^2}{\eta(1-\beta)}, \qquad 0 \le \beta < 1, \quad \eta > 0$$
 (B.6)

for some constant K > 0 that depends on the positions of the zeroes.

The function q_l is part of a conjugate pair (p_l, q_l) satisfying the system (2.17) in the annulus A_R and with boundary conditions (2.18) for the function p_l . The goal of the subsequent treatment of this well-known boundary value problem is to find suitable conditions on the boundary values of p_l such that q_l satisfies an estimate of type (B.5).

The bounded and the unbounded cases have to be treated separately; the case A_{∞} turns out to be simpler and is treated first. Using complex notation $f := p_l + iq_l$, $z = \zeta + i\rho$ and switching from A_{∞} to the unit disk $D := \{z : |z| < 1\}$, solutions f of problem (2.17), $(2.18)_a$ with continuous boundary data are well-known to be complex analytic in D and continuous in \overline{D} . Cauchy-Schwarz' formula provides in this situation an explicit representation of q_l in terms of the boundary values of p_l (see e.g. [24], p. 135):

$$q_l(z) = \frac{1}{2\pi} \int_0^{2\pi} \Im\left\{ \frac{e^{i\theta} + z}{e^{i\theta} - z} \right\} p_l(e^{i\theta}) \,\mathrm{d}\theta + q_l(0) \,, \quad z \in D \,. \tag{B.7}$$

The last term in (B.7) vanishes by antisymmetry of q_l , so that a corresponding formula for the exterior domain A_{∞} may be obtained by the inversion $z \mapsto 1/\overline{z}$. Switching to polar coordinates (r, φ) one obtains

$$\widetilde{q}_{l}(r,\varphi) = -\frac{r}{\pi} \int_{0}^{2\pi} \frac{\sin(\theta - \varphi)}{1 - 2r\cos(\theta - \varphi) + r^{2}} \, \widetilde{p}_{l}(\theta) \, d\theta
= \frac{r}{\pi} \int_{0}^{2\pi} \frac{\sin(\theta + \varphi)}{1 - 2r\cos(\theta + \varphi) + r^{2}} \, \widetilde{p}_{l}(-\theta) \, d\theta , \quad (r,\varphi) \in (1,\infty) \times (-\pi,\pi] ,$$
(B.8)

where we have set $z = re^{i\varphi}$, $q_l(z) = \tilde{q}_l(r,\varphi)$, and $p_l(e^{i\theta}) = \tilde{p}_l(\theta)$. The change of variable

$$s := \frac{2r}{1+r^2} \tag{B.9}$$

maps A_{∞} back onto D while simplifying the denominator under the integral:

$$\overline{q}_l(s,\varphi) = \frac{s}{2\pi} \int_0^{2\pi} \frac{\sin(\theta + \varphi)}{1 - s\cos(\theta + \varphi)} \, \widetilde{p}_l(-\theta) \, \mathrm{d}\theta \,, \quad (s,\varphi) \in (0,1) \times (-\pi,\pi]$$
 (B.10)

with $\overline{q}_l(s,\cdot) = \widetilde{q}_l(r,\cdot)$. Finally, exploiting the symmetries of the problem, viz.,

$$\widetilde{p}_l(-\theta) = \widetilde{p}_l(\theta)$$
 and $\overline{q}_l(\cdot, -\varphi) = -\overline{q}_l(\cdot, \varphi)$,

the integral may be restricted onto the interval $[0, \pi]$:

$$\overline{q}_{l}(s,\varphi) = \frac{s}{2\pi} \int_{0}^{\pi} \left(\frac{\sin(\theta + \varphi)}{1 - s\cos(\theta + \varphi)} - \frac{\sin(\theta - \varphi)}{1 - s\cos(\theta - \varphi)} \right) \widetilde{p}_{l}(\theta) d\theta
= \frac{s}{\pi} \sin\varphi \int_{0}^{\pi} \frac{\cos\theta - s\cos\varphi}{\left(1 - s\cos(\theta + \varphi)\right) \left(1 - s\cos(\theta - \varphi)\right)} \widetilde{p}_{l}(\theta) d\theta
= \frac{s}{\pi} \sin\varphi \int_{0}^{\pi} \frac{\cos\theta - s\cos\varphi}{\left(\cos\theta - s\cos\varphi\right)^{2} + \left(1 - s^{2}\right)\sin^{2}\theta} \widetilde{p}_{l}(\theta) d\theta.$$
(B.11)

To obtain bounds on q_l of the desired type we need more regularity of \tilde{p}_l than just continuity. Let us assume Hölder continuity of \tilde{p}_l in the form

$$|\widetilde{p}_l(\theta) - \widetilde{p}_l(\widetilde{\theta})| \le C |\theta - \widetilde{\theta}|^{\alpha}, \qquad \theta, \widetilde{\theta} \in [0, \pi]$$
 (B.12)

for some C > 0 and some $0 < \alpha < 1$, and, moreover, at the symmetry axis $\{\theta = 0\} \cup \{\theta = \pi\}$ the condition

$$|\widetilde{p}_{l}(\theta) - \widetilde{p}_{l}(0)| \leq \widetilde{C} \, \theta^{1+\widetilde{\alpha}}$$

$$|\widetilde{p}_{l}(\theta) - \widetilde{p}_{l}(\pi)| \leq \widetilde{C} \, (\pi - \theta)^{1+\widetilde{\alpha}}$$

$$, \quad \theta \in [0, \pi]$$
(B.13)

for some $\widetilde{C}>0$ and some $0<\widetilde{\alpha}<1$. To take advantage of the Hölder conditions we rewrite (B.11) in the form

$$\overline{q}_l(s,\varphi) = -\frac{s}{\pi} \sin \varphi \int_0^{\pi} \frac{\cos \theta - s \cos \varphi}{(\cos \theta - s \cos \varphi)^2 + (1 - s^2) \sin^2 \theta} \left(\widetilde{p}_l(\theta) - \widetilde{p}_l(\varphi) \right) d\theta,$$
 (B.14)

which follows by (B.10), (B.11) setting $\tilde{p}_l \equiv 1$:

$$2\sin\varphi \int_0^\pi \frac{\cos\theta - s\cos\varphi}{(\cos\theta - s\cos\varphi)^2 + (1 - s^2)\sin^2\theta} d\theta = \int_0^{2\pi} \frac{\sin(\theta + \varphi)}{1 - s\cos(\theta + \varphi)} d\theta$$
$$= \frac{1}{s} \ln\left(1 - s\cos(\theta + \varphi)\right)\Big|_0^{2\pi} = 0.$$

We prove next the upper bound on the integrand in (B.14):

$$\frac{|\cos \theta - s\cos \varphi|}{(\cos \theta - s\cos \varphi)^2 + (1 - s^2)\sin^2 \theta} \le \frac{2}{|\cos \theta - \cos \varphi|}, \quad s \in [1/2, 1]. \tag{B.15}$$

Setting $\cos \theta =: x, \cos \varphi =: y$, inequality (B.15) is equivalent to

$$|x^2 + sy^2 - (1+s)xy| \le 2s\left(sx^2 + sy^2 - 2xy + \frac{1}{s} - s\right)$$
 (B.16)

on the square $[-1,1] \times [-1,1]$ with side condition $s \in [1/2,1]$. We distinguish the cases (i) $xy \le 0$ and (ii) xy > 0. In case (i) the left-hand side in (B.16) satisfies

$$0 \le x^2 + sy^2 - (1+s)xy \le sx^2 + (1-s) + sy^2 - 2xy,$$

and hence (B.16). In case (ii) the left-hand side satisfies the upper bound

$$x^{2} + s y^{2} - (1+s) xy \leq s x^{2} + (1-s) + s y^{2} - 2xy + (1-s)$$
$$\leq s x^{2} + s y^{2} - 2xy + (1-s) + \left(\frac{1}{s} - 1\right),$$

and hence one half of (B.16). The other half requires a lower bound on the left-hand side. By

$$(1+s) xy \le x^2 + \left(\frac{1+s}{2}\right)^2 y^2$$

one obtains

$$-(x^{2} + sy^{2} - (1+s)xy) \leq \left[\left(\frac{1+s}{2}\right)^{2} - s\right]y^{2} \leq 2(1-s)^{2}y^{2}$$

$$\leq 2s\left[(1-s)\left(\frac{1}{s} - 1\right)y^{2} + (x-y)^{2}\right]$$

$$\leq 2s\left[\left(\frac{1-s}{s} - (1-s)\right)y^{2} + x^{2} + y^{2} - 2xy\right]$$

$$\leq 2s\left(sx^{2} + sy^{2} - 2xy + (1-s)x^{2} + \frac{1-s}{s}y^{2}\right)$$

$$\leq 2s\left(sx^{2} + sy^{2} - 2xy + (1-s) + \frac{1-s}{s}\right),$$

which completes the proof of (B.16). Finally we prove

$$\frac{2}{\pi} \int_0^{\pi} \frac{|\widetilde{p}_l(\theta) - \widetilde{p}_l(\varphi)|}{|\cos \theta - \cos \varphi|} d\theta < K, \quad \varphi \in [0, \pi]$$
(B.17)

with some constant K depending on the parameters that characterize the Hölder conditions (B.12) and (B.13). We distinguish again several cases, viz., (i) $\varphi = \pi/2$, (ii) $\varphi \in [0, \pi/2)$, and (iii) $\varphi \in (\pi/2, \pi]$. Case (i) is easily done by (B.12):

$$\int_0^{\pi} \frac{|\widetilde{p}_l(\theta) - \widetilde{p}_l(\pi/2)|}{|\cos \theta|} d\theta \le C \int_0^{\pi} \frac{|\theta - \pi/2|^{\alpha}}{|\sin(\theta - \pi/2)|} d\theta \le 2C \int_0^{\pi} |\theta - \pi/2|^{\alpha - 1} d\theta$$
$$= \frac{4C}{\alpha} \left(\frac{\pi}{2}\right)^{\alpha},$$

where we made use of $\sin x \ge x/2$ for $x \in [0, \pi/2]$.

Case (ii) requires a balance between Hölder conditions (B.12) and (B.13) in the form

$$\int_{0}^{\pi} \frac{|\widetilde{p}_{l}(\theta) - \widetilde{p}_{l}(\varphi)|}{|\cos \theta - \cos \varphi|} d\theta = \frac{1}{2} \int_{0}^{\pi} \frac{|\widetilde{p}_{l}(\theta) - \widetilde{p}_{l}(0) - \widetilde{p}_{l}(\varphi) + \widetilde{p}_{l}(0)|^{1-\varepsilon}}{\sin ((\varphi + \theta)/2)} \times \frac{|\widetilde{p}_{l}(\theta) - \widetilde{p}_{l}(\varphi)|^{\varepsilon}}{|\sin ((\varphi - \theta)/2)|} d\theta$$

$$\leq \frac{1}{2} \widetilde{C}^{1-\varepsilon} C^{\varepsilon} \int_{0}^{\pi} \frac{(\theta^{1+\widetilde{\alpha}} + \varphi^{1+\widetilde{\alpha}})^{1-\varepsilon}}{(\theta + \varphi)/8} \times \frac{|\theta - \varphi|^{\alpha\varepsilon}}{|\theta - \varphi|/4} d\theta,$$

where we made use of $\sin x \ge x/4$ for $x \in [0, 3\pi/4]$. The first factor under the integral is further estimated by

$$\frac{(\theta^{1+\widetilde{\alpha}}+\varphi^{1+\widetilde{\alpha}})^{1-\varepsilon}}{\theta+\varphi} \leq \frac{(\theta+\varphi)^{(1+\widetilde{\alpha})(1-\varepsilon)}}{\theta+\varphi} \leq (\theta+\varphi)^{(1+\widetilde{\alpha})(1-\varepsilon)-1} \leq \left(\frac{3\pi}{2}\right)^{\widetilde{\alpha}(1-\varepsilon)-\varepsilon},$$

provided that ε is chosen such that

$$\widetilde{\alpha}(1-\varepsilon) > \varepsilon > 0$$
.

The integral is then easily done with the result

$$\int_0^{\pi} \frac{|\widetilde{p}_l(\theta) - \widetilde{p}_l(\varphi)|}{|\cos \theta - \cos \varphi|} d\theta \le 16 \, \widetilde{C}^{1-\varepsilon} C^{\varepsilon} \left(\frac{3\pi}{2}\right)^{\widetilde{\alpha}(1-\varepsilon)-\varepsilon} \int_0^{\pi} |\theta - \varphi|^{\alpha\varepsilon - 1} d\theta$$
$$\le 32 \, \widetilde{C}^{1-\varepsilon} C^{\varepsilon} \left(\frac{3\pi}{2}\right)^{\widetilde{\alpha}(1-\varepsilon)-\varepsilon} \frac{\pi^{\alpha\varepsilon}}{\alpha\varepsilon} .$$

Case (iii) is treated along the lines of case (ii) with $\tilde{p}_l(0)$ replaced by $\tilde{p}_l(\pi)$ and using the estimate $\sin x \ge (\pi - x)/4$ for $x \in [\pi/4, \pi]$:

$$\int_{0}^{\pi} \frac{|\widetilde{p}_{l}(\theta) - \widetilde{p}_{l}(\varphi)|}{|\cos \theta - \cos \varphi|} d\theta \leq \frac{1}{2} \widetilde{C}^{1-\varepsilon} C^{\varepsilon} \int_{0}^{\pi} \frac{\left((\pi - \theta)^{1+\widetilde{\alpha}} + (\pi - \varphi)^{1+\widetilde{\alpha}}\right)^{1-\varepsilon}}{\sin\left((\theta + \varphi)/2\right)} \times \frac{|\theta - \varphi|^{\alpha\varepsilon}}{|\sin(\theta - \varphi)/2|} d\theta$$

$$\leq \frac{1}{2} \widetilde{C}^{1-\varepsilon} C^{\varepsilon} \int_{0}^{\pi} \frac{(2\pi - \theta - \varphi)^{(1+\widetilde{\alpha})(1-\varepsilon)}}{(2\pi - \theta - \varphi)/8} \times \frac{|\theta - \varphi|^{\alpha\varepsilon}}{|\theta - \varphi|/4} d\theta$$

$$\leq 32 \widetilde{C}^{1-\varepsilon} C^{\varepsilon} \left(\frac{3\pi}{2}\right)^{\widetilde{\alpha}(1-\varepsilon)-\varepsilon} \frac{\pi^{\alpha\varepsilon}}{\alpha\varepsilon},$$

which is the same bound as in case (ii). This proves (B.17). Summarizing (B.14) (B.15), and (B.17) we arrive at the bound

$$|\overline{q}_l(s,\varphi)| \le K \sin \varphi, \quad (s,\varphi) \in [1/2,1) \times [0,\pi].$$
 (B.18)

Note that

$$\frac{|\widetilde{p}_l(\theta) - \widetilde{p}_l(\varphi)|}{|\cos \theta - \cos \varphi|}$$

represents by (B.15), (B.17) an integrable bound on the integrand in (B.14). Thus, Lebesgue's theorem allows the passage $s \to 1$ in (B.14), which then holds for s = 1 as well:

$$\overline{q}_l(1,\varphi) = \frac{\sin \varphi}{\pi} \int_0^{\pi} \frac{|\widetilde{p}_l(\theta) - \widetilde{p}_l(\varphi)|}{|\cos \theta - \cos \varphi|} d\theta.$$

The other restriction, viz., $s \ge 1/2$, introduced in (B.15), can be removed by the observation that the denominator in (B.14) is strictly positive for $0 \le s \le 1/2$:

$$\geq \frac{3}{4} - \frac{1}{2} = \frac{1}{4} > 0.$$
(B.20)

Thus (B.18) holds for all $s \in [0,1]$ and undoing the substitution (B.9) yields the desired bound on $\widetilde{q}_l(r,\varphi)$ in Q_{∞} .

Lemma B.2. Let (p_l, q_l) be a solution of the system (2.17), $(2.18)_a$ in A_{∞} with boundary function $p(\theta)$ satisfying the Hölder conditions (B.12), (B.13). Then the following inequalities hold: ¹⁰

and

 (B.22)

for some constant K > 0.

The bound (B.22) is an immediate consequence of the basic estimate (B.21).

Remark: The mere Hölder condition (B.12) still allows a bound of type

$$\sin \varphi \int_0^{\pi} \frac{|\widetilde{p}_l(\theta) - \widetilde{p}_l(\varphi)|}{|\cos \theta - \cos \varphi|} \, \mathrm{d}\theta < \widetilde{K}, \quad \varphi \in [0, \pi]$$

instead of (B.17). This is enough to establish existence of q_l up to and on the boundary but not enough for the bound (B.21). Generally it is well known that Hölder continuity of the boundary data, which are continuously assumed by one variable of the conjugate pair, is enough to guarantee existence (and Hölder continuity) of the other variable up to and on the boundary (see, e.g., Privaloff's theorem [20]).

¹⁰The tilde on q_l in (B.8) is here omitted.

In the bounded domain A_R the boundary conditions at S_1 and S_R are not completely independent. Writing the system (2.17) in polar coordinates,

$$\frac{\partial_r p_l - \frac{1}{r} \partial_\varphi q_l}{\frac{1}{r} \partial_\varphi p_l + \partial_r q_l} = 0,$$
(B.23)

we find by integration of (B.23)₁ over $[-\pi, \pi]$ that $\partial_r \int_{-\pi}^{\pi} p_l \, d\varphi = 0$ and hence

$$\int_{-\pi}^{\pi} p_l(1,\varphi) \,\mathrm{d}\varphi = \int_{-\pi}^{\pi} p_l(R,\varphi) \,\mathrm{d}\varphi. \tag{B.24}$$

Inserting the boundary conditions (2.15) and (2.16), condition (B.24) can be met by a suitable choice of $p_0 =: p_{l,0}$.

A representation of q_l , analogous to (B.7), is given by (see [24], p. 398f.)

$$q_l(z) = \frac{1}{2\pi} \int_0^{2\pi} \Im\left\{ \frac{R e^{i\theta} + z}{R e^{i\theta} - z} - H(R e^{i\theta}, z) \right\} p_l(R e^{i\theta}) d\theta$$
$$-\frac{1}{2\pi} \int_0^{2\pi} \Im\left\{ \frac{e^{i\theta} + z}{e^{i\theta} - z} - H(e^{i\theta}, z) \right\} p_l(e^{i\theta}) d\theta,$$

where H(w,z) has the series representation

$$H(w,z) = 2\sum_{k=1}^{\infty} \left(\frac{w}{R^{2k}z - w} - \frac{z}{R^{2k}w - z} \right) = 2\sum_{k=1}^{\infty} \frac{1}{R^{2k} - 1} \left(\left(\frac{w}{z} \right)^k - \left(\frac{z}{w} \right)^k \right).$$

The series are absolutely converging for $1/R^2 < |z/w| < R^2$ and continuous on $\partial A_R \times \overline{A_R}$. By $z = re^{i\varphi}$, $q_l(z) =: \widetilde{q}_l(r,\varphi)$, $p_l(e^{i\theta}) = \widetilde{p}_l(\theta)$, and $p_l(Re^{i\theta}) = \widehat{p}_l(\theta)$ one obtains in polar coordinates (r,φ) :

$$\widetilde{q}_{l}(r,\varphi) = \frac{1}{\pi} \int_{0}^{2\pi} \left[\frac{r}{R} \frac{\sin(\varphi - \theta)}{1 - 2(r/R)\cos(\varphi - \theta) + (r/R)^{2}} + \sum_{k=1}^{\infty} \frac{1}{R^{2k} - 1} \left(\left(\frac{r}{R} \right)^{k} + \left(\frac{R}{r} \right)^{k} \right) \sin k(\varphi - \theta) \right] \widehat{p}_{l}(\theta) d\theta \\
- \frac{1}{\pi} \int_{0}^{2\pi} \left[r \frac{\sin(\varphi - \theta)}{1 - 2r\cos(\varphi - \theta) + r^{2}} + \sum_{k=1}^{\infty} \frac{1}{R^{2k} - 1} (r^{k} + r^{-k}) \sin k(\varphi - \theta) \right] \widetilde{p}_{l}(\theta) d\theta .$$
(B.25)

The first terms under the integrals are analogous to (B.8) and corresponding estimates can by and large be taken over; the second terms represent harmonic functions, which much simpler can be estimated. Let us consider the first term in the second integral first. By the substitution (B.9) and by reducing the integral as in (B.11) to the interval $(0,\pi)$ we arrive precisely at (B.14). Thus the bound (B.18) applies and in the case that

$$s_R := \frac{2\,R}{1+R^2} \ge \frac{1}{2}$$

applies, we are done; otherwise the argument based on (B.20) applies and we are done, too. Undoing the substitution (B.9) we arrive at (B.21) with a constant K depending on the constants that characterize the Hölder conditions (B.12), (B.13).

When applying the substitution

$$\widehat{s} := \frac{2r/R}{1 + (r/R)^2}$$

to the first term of the first integral in (B.25) and performing the reduction to the interval $(0,\pi)$ we arrive again at an integral of type (B.14) with \tilde{p}_l , however, replaced by \hat{p}_l . Under the conditions (B.12), (B.13) for \hat{p}_l one obtains as before the bound (B.18) and then (B.21).

The second terms under the integrals in (B.25) allow sufficient estimates just by (B.12). We demonstrate this for the term in the second integral. Reducing the integral to the interval $(0, \pi)$ and taking advantage of the zero-mean property of the integrand one obtains:

$$\frac{1}{\pi} \int_{0}^{2\pi} \left[\sum_{k=1}^{\infty} \frac{r^{k} + r^{-k}}{R^{2k} - 1} \sin k(\varphi - \theta) \right] \widetilde{p}_{l}(\theta) d\theta$$

$$= \frac{1}{\pi} \sum_{k=1}^{\infty} \frac{r^{k} + r^{-k}}{R^{2k} - 1} \int_{0}^{\pi} \left(\sin k(\varphi - \theta) + \sin k(\varphi + \theta) \right) \left(\widetilde{p}_{l}(\theta) - \widetilde{p}_{l}(\varphi) \right) d\theta$$

$$= \frac{2}{\pi} \sum_{k=1}^{\infty} \frac{r^{k} + r^{-k}}{(R^{k} - 1)(R^{k} + 1)} \int_{0}^{\pi} \sin k\varphi \cos k\theta \left(\widetilde{p}_{l}(\theta) - \widetilde{p}_{l}(\varphi) \right) d\theta . \tag{B.26}$$

Thus by $|\sin k\varphi| \le k \sin \varphi$ on $[0, \pi]$ and by

$$\sum_{k=1}^{\infty} \frac{k}{R^k - 1} \le \frac{1}{R - 1} \sum_{k=1}^{\infty} \frac{k}{R^{k - 1}} = \frac{1}{R - 1} \frac{1}{(1 - 1/R)^2} = \frac{R^2}{(R - 1)^3},$$

(B.26) allows the estimate:

$$|(B.26)| \le \frac{2}{\pi} \sin \varphi \left(\sum_{k=1}^{\infty} \frac{k}{R^k - 1} \right) C \int_0^{\pi} |\theta - \varphi|^{\alpha} d\theta$$

$$\le 2 C \pi^{\alpha} \frac{R^2}{(R - 1)^3} \sin \varphi \le 8 C \pi^{\alpha} \sin \varphi \quad \text{for } R \ge 2.$$

The following lemma summarizes these estimates in the bounded domain A_R .

Lemma B.3. Let (p_l, q_l) be a solution of the system (2.17), (2.18) in A_R with boundary function $p(\theta)$ satisfying condition (B.24) and the Hölder conditions (B.12), (B.13) at ∂A_R . Then q_l satisfies the estimates (B.21) and (B.22) (with Q_{∞} replaced by Q_R) for some constant K that depends on the Hölder constants but does not depend on $R \geq 2$.

C. Estimate of the Fredholm constant \widetilde{C}_F

The purpose of this appendix is to present a bound on \widetilde{C}_F that is independent of the radius R in Q_R and independent of properties of the coefficient \mathbf{a} other than the bounds (4.1). To this end we estimate the spectrum of $\widetilde{\mathcal{F}}$ from below by a positive constant. The idea of

proof is to consider the parabolic problem associated to the (adjoint) eigenvalue problem and to construct a suitable supersolution, whose decay constant provides the desired spectral constant.

The spectrum $\Sigma_{\mathcal{K}}$ of a compact operator \mathcal{K} is well known: it consists of a countable set of eigenvalues $\mu \in \mathbb{C}$ with finite multiplicity clustering at most at zero, which in our case is not an eigenvalue (cf. proposition 3.3). Let now \mathcal{K}_M be as defined by eq. (4.35) on the Hilbert space $\mathcal{L}_{\alpha+\gamma}$, let $\widetilde{\mathcal{K}} := \frac{1}{r} \mathcal{K}_M \frac{1}{r}$ and $\widetilde{\mathcal{F}}_M = \mathcal{I} - M \widetilde{\mathcal{K}}_M$. With

$$\widetilde{\mathcal{K}}_M w = \mu w \qquad \Longleftrightarrow \qquad \widetilde{\mathcal{F}}_M w = (1 - M\mu) w$$
 (C.1)

we find for the constant \widetilde{C}_F according to (4.38)

$$\widetilde{C}_F^{-1} = \inf_{\mu \in \Sigma_{\widetilde{K}_M}} \left\{ |1 - \mu M| \right\}. \tag{C.2}$$

By inversion and with $\lambda =: \mu^{-1}$ (C.1)_a takes the form

$$r \, \mathcal{K}_M^{-1} r \, w = \lambda \, w \,,$$

or, with v =: r w,

$$\mathcal{K}_M^{-1}v = \lambda \, v/r^2 \,,$$

which corresponds in a weak formulation to eq. (4.3) with right-hand side replaced by

With $u \in \mathcal{H}_0(Q_R)$, $\psi \in C^1(\overline{Q_R})$ this is the weak formulation (cf. section 2) of the boundary value problem

$$\left(\partial_{r}u + b_{r}\frac{u}{r}\right)\Big|_{r=1,R} = 0, \qquad u\Big|_{\varphi=0,\pi} = 0,$$
(C.3)

where we have introduced the abbreviations

$$b_r := \frac{a_{\zeta}}{\tan \varphi} + a_{\rho} , \qquad b_{\varphi} := \frac{a_{\rho}}{\tan \varphi} - a_{\zeta} .$$
 (C.4)

It turns out that the adjoint problem is easier to handle: let $L_c^2(Q_R)$ be the complex Hilbert space with scalar product $\langle u, w \rangle := \int_{Q_R} u \, \overline{w} \, r \mathrm{d}r \mathrm{d}\varphi$, then

denotes the adjoint boundary value problem with eigenvalue $\overline{\lambda}$.

Next we embed the elliptic problem (C.5) trivially in a parabolic setting by $W(r, \varphi, t) := w(r, \varphi) e^{-(\overline{\lambda} - M)t}$, which is a solution of the problem

$$\partial_t W - r \partial_r (r \partial_r W) - \partial_\varphi^2 W + r b_r \partial_r W + b_\varphi \partial_\varphi W = 0,$$

$$\partial_r W \big|_{r=1,R} = 0, \quad W \big|_{\varphi=0,\pi} = 0, \quad W \big|_{t=0} = w$$
(C.6)

in the cylinder $Q_R \times [0, T)$, T > 0. (C.6) is a real equation, thus with $\lambda - M =: \varrho + i\sigma$ the real part of W,

$$\mathcal{R} := \Re W = \Re \left(\left(\Re w + i \Im w \right) e^{-(\varrho - i\sigma)t} \right)$$

= $e^{-\varrho t} \left(\Re w \cos \sigma t - \Im w \sin \sigma t \right),$ (C.7)

is a solution of problem (C.6) as well, whose temporal decay is governed by the real part ϱ of the eigenvalue $\lambda - M$. A positive lower bound D on ϱ ,

$$\varrho \ge D \iff \Re \lambda \ge M + D$$

then yields the desired positive lower bound in (C.2):

$$\left|1 - \frac{M}{\lambda}\right| \ge 1 - \frac{M}{|\lambda|} \ge 1 - \frac{M}{\Re \lambda} \ge 1 - \frac{M}{M+D} = \frac{D}{M+D} > 0. \tag{C.8}$$

The idea for a lower bound on ϱ lies in the construction of a suitable supersolution¹¹ \overline{F} with decay constant D, which, by means of a parabolic maximum principle, bounds \mathcal{R} for all time once it does so for t=0 and if boundary values are under control. This clearly implies that \overline{F} cannot shrink faster than \mathcal{R} and hence $\varrho \geq D$.

The maximum principle must be applicable to weak solutions of equations with merely bounded coefficients. We refer here to theorem 6.25 and corollary 6.26 in [25], which apply to the following setting adapted to our situation:

Let $Q_{\varepsilon,R}$ be the restricted rectangle $(1,R) \times (\varepsilon,\pi-\varepsilon)$ for some $0 < \varepsilon < \pi/2$, where the coefficients (C.4) are then obviously bounded, and let $Q_{\varepsilon,R}^T$ be the restricted cylinder $Q_{\varepsilon,R} \times [0,T)$. Let

be the set of space-time test functions and

$$\mathcal{V} := \left\{ \mathcal{R} \in L^2(Q_{\varepsilon,R}^T) : \|\mathcal{R}\|_V < \infty \right\}$$

with

$$\|\mathcal{R}\|_V^2 := \int_{Q_{\varepsilon,R}^T} |\nabla \mathcal{R}|^2 d\mu dt + \sup_{t \in (0,T)} \int_{Q_{\varepsilon,R} \times \{t\}} |\mathcal{R}|^2 d\mu$$

be the set of admissible solutions of the following weak formulation of eq. (C.6):

$$-\int_{Q_{\varepsilon,R}^{T}} \mathcal{R} \, \partial_{t} \Psi \, \mathrm{d}\mu \mathrm{d}t + \int_{Q_{\varepsilon,R}} \mathcal{R}(\cdot,\cdot,T) \, \Psi(\cdot,\cdot,T) \, \mathrm{d}\mu$$

$$+ \int_{Q_{\varepsilon,R}^{T}} \left(\partial_{r} \mathcal{R} \, \partial_{r} \Psi + \frac{1}{r^{2}} \, \partial_{\varphi} \mathcal{R} \, \partial_{\varphi} \Psi + \frac{1}{r} \, b_{r} \, \partial_{r} \mathcal{R} \, \Psi + \frac{1}{r^{2}} \, b_{\varphi} \, \partial_{\varphi} \mathcal{R} \, \Psi \right) \mathrm{d}\mu \mathrm{d}t \qquad (C.9)$$

$$= \int_{Q_{\varepsilon,R}} \mathcal{R}w \, \Psi(\cdot,\cdot,0) \, \mathrm{d}\mu \, .$$

¹¹A supersolution of eq. $(C.6)_1$ is a solution of the inequality that arises from $(C.6)_1$ by replacing "=" by " \leq ".

Equation (C.9) corresponds to the weak formulation in ([25], p. 100 above) with coefficients $b^i = c^0 = 0$. In this situation we have (see [25], p. 128):

Proposition C.1 (weak parabolic maximum principle). Let $\mathcal{R} \in \mathcal{V}$ be a solution of (C.9) as inequality, i.e. "=" is replaced by " \leq ", for any nonnegative $\Psi \in C_0^1(Q_{\varepsilon,R}^T)$, then

$$\sup_{Q_{\varepsilon,R}^T} \mathcal{R} \le \sup_{\partial Q_{\varepsilon,R}^T} \mathcal{R}, \tag{C.10}$$

where $\partial Q_{\varepsilon,R}^T$ denotes the parabolic boundary $Q_{\varepsilon,R} \times \{t=0\} \cup \partial Q_{\varepsilon,R} \times [0,T)$.

To apply proposition C.1 to our situation let us note that by assumption w is a weak solution of eq. (C.5) in Q_R . In the restricted domain $Q_{\varepsilon,R}$, however, standard elliptic regularity theory can be applied, which yields (at least) H^2 -regularity of w and hence \mathcal{R} . Moreover, applying theorem 15.1 in [19] we obtain Hölder-continuity (up to the boundary) of \mathcal{R} and its derivarives for some $0 < \alpha < 1$:

$$\mathcal{R} \in H^2(Q_{\varepsilon,R}) \cap C^{1,\alpha}(\overline{Q_{\varepsilon,R}}). \tag{C.11}$$

This implies $\mathcal{R} \in \mathcal{V}$ and eq. (C.9) can be obtained from eq. (C.6) by multiplying with Ψ/r^2 and integration by parts. Note, moreover, that (C.11) implies boundary conditions (including the Neumann condition) to hold in the classical sense.

The choice of the supersolution \overline{F} has to be made with some care to guarantee the boundary control, i.e. $|\mathcal{R}| \leq \overline{F}$ on $\partial Q_{\varepsilon,R} \times [0,T)$, which then by (C.10) can be extended to all of $Q_{\varepsilon,R}^T$. The (spatial) boundary components $(\{r=1\} \cup \{r=R\}) \times (\varepsilon,\pi-\varepsilon) =: \Gamma_R$ and $(1,R) \times (\{\varphi=\varepsilon\} \cup \{\varphi=\pi-\varepsilon\}) =: \Gamma_\varepsilon$ cause different problems, which affect the construction of the radial part f(r) and of the angular part $g(\varphi)$ in the ansatz for \overline{F} :

$$\overline{F}(r,\varphi,t) = A f(r) g(\varphi) e^{-Dt}, \qquad A, D > 0.$$
 (C.12)

The solution \mathcal{R} of problem (C.6) satisfies a (zero-) boundary condition on Γ_0 but not on Γ_{ε} , $\varepsilon > 0$; however, it exhibits a certain asymptotic behaviour for $\varphi \to 0$, π governed by the singular part in the coefficient b_{φ} . The function $g(\varphi)$ is constructed such that it exhibits a "better" asymptotics, which allows then control at Γ_{ε} for small $\varepsilon > 0$. Likewise at Γ_R the Neumann boundary condition does not yield an obvious boundary control. Here we choose a slightly convex radial function f(r) that has the property that any boundary point $\varepsilon \cap \Gamma_R$ with $\overline{F} = \mathcal{R}$ contradicts the maximum principle.

To be useful, $-\overline{F}$ has to be a solution of eq. (C.9) as inequality in the sense of proposition C.1. In terms of classical functions it is sufficient to construct a piecewise- C^2 supersolution of eq. (C.6)₁ that is globally C^1 ; integration by parts is then allowed and yields the weak formulation (C.9).

Inserting the ansatz (C.12) into $(C.6)_1$ leads to the inequality

$$Dfg + r^2 \left(\frac{1}{r} \partial_r (r \partial_r f) - \frac{b_r}{r} \partial_r f\right) g + f \left(\partial_\varphi^2 g - b_\varphi \partial_\varphi g\right) \le 0,$$

which suggests to consider the following two 1-dimensional subproblems:

$$f'' + \frac{1 - b_r}{r} f' - \frac{d_r}{r^2} f \le 0$$
 on $(1, R)$ (C.13)

and

$$g'' - b_{\varphi} g' + d_{\varphi} g \le 0$$
 on $(0, \pi)$, (C.14)

where we have assumed that

$$D = d_{\varphi} - d_r, \quad d_r, d_{\varphi} > 0, \quad f, g \ge 0.$$
 (C.15)

Let us consider inequality (C.14) first. Note that further estimate of b_{φ} has to observe the sign of g' and, as described above, we would like to keep the singular part of b_{φ} on $(0, \pi)$. So, by (C.4) and (4.1) we make use of

$$-b_{\varphi} = -\frac{a_{\rho}}{\tan \varphi} + a_{\zeta} \le \frac{0.22}{\varphi} + 0.73 \le \frac{1}{2\varphi} + 1 \quad \text{on } \left(0, \frac{\pi}{2}\right),$$

$$-b_{\varphi} \ge -\frac{0.22}{\widehat{\varphi}} - 0.73 \ge -\frac{1}{2\widehat{\varphi}} - 1 \quad \text{on } \left(\frac{\pi}{2}, \pi\right)$$
(C.16)

and look for solutions of the problem

$$g_1'' + \left(1 + \frac{1}{2\varphi}\right)g_1' + d_{\varphi}g_1 = 0, \quad g_1' \ge 0 \quad \text{ on } \left(0, \frac{\pi}{2}\right),$$

$$g_1(0) = 0.$$

An analytic solution can be given in terms of Kummer's function $M(\cdot,\cdot,\cdot)$ (see [26], p. 504):

$$g_1(\varphi) = e^{-(1+\kappa)\varphi/2} \varphi^{1/2} M\left(\frac{3}{4} + \frac{1}{4\kappa}, \frac{3}{2}, \kappa \varphi\right)$$
 (C.17)

with $\kappa = (1 - 4d_{\varphi})^{1/2}$. The condition $g'_1(\pi/2) = 0$ fixes d_{φ} at




Figure 6: Graphs of the functions $f_1:(1,R_0)\to\mathbb{R}_+$ with $R_0=5, c_\varepsilon=10, d_r=0.09$ and $g_1:(0,\pi/2)\to\mathbb{R}_+$ with $d_\varphi=0.1945$.

$$d_{\varphi} \approx 0.1945 \,, \tag{C.18}$$

and we have clearly $g_1' \geq 0$ on $(0, \pi/2)$ (see Fig. 6). By reflection at $\varphi = \pi/2$ we obtain a function $g_2(\varphi) := g_1(\pi - \varphi) = g_1(\widehat{\varphi})$ on $(\pi/2, \pi)$ satisfying the problem

$$g_2'' - \left(1 + \frac{1}{2\widehat{\varphi}}\right)g_2' + d_{\varphi} g_2 = 0, \quad g_2' \le 0 \quad \text{on } \left(\frac{\pi}{2}, \pi\right),$$
$$g_2(\pi) = g_2'\left(\frac{\pi}{2}\right) = 0.$$

Thus by (C.16), the function

$$g := \begin{cases} g_1 & \text{on } (0, \pi/2) \\ g_2 & \text{on } (\pi/2, \pi) \end{cases}$$

is a C^1 -solution of inequality (C.14), vanishing at the boundaries, and with decay constant (C.18).

Concerning the radial part f(r) we make use of the estimate

$$|b_r| = \left| \frac{a_{\zeta}}{\tan \varphi} + a_{\rho} \right| \le \frac{1}{\varepsilon} + 1 =: c_{\varepsilon} \quad \text{on } Q_{\varepsilon,R}$$
 (C.19)

and look for solutions of the problem

$$f_1'' + \frac{1 - c_{\varepsilon}}{r} f_1' - \frac{d_r}{r^2} f_1 = 0, \quad f_1' \le 0 \quad \text{on } (1, R_0),$$

$$f_1(R_0) = 1, \quad f_1'(R_0) = 0,$$
(C.20)

where R_0 is some radius with $1 < R_0 < R$. The solution of the initial value problem (C.20) is elementary:

$$f_1 = \frac{\alpha_+ (r/R_0)^{\alpha_-} - \alpha_- (r/R_0)^{\alpha_+}}{\alpha_+ - \alpha_-}, \qquad \alpha_{\pm} = \frac{1}{2} \left(c_{\varepsilon} \pm (c_{\varepsilon}^2 + 4d_r)^{1/2} \right)$$

with

$$f_1'(r) = \frac{\alpha_+ \alpha_-}{\alpha_+ - \alpha_-} \frac{1}{r} \left(\left(\frac{R_0}{r} \right)^{-\alpha_-} - \left(\frac{r}{R_0} \right)^{\alpha_+} \right) \le 0$$

and, in particular, $f'_1(1) < 0$ (see Fig. 6). Analogously we find $f_2(r)$ as solution of the problem

$$f_1''(1) < 0$$
 (see Fig. 6). Analogously we find $f_2(r)$ as solution $f_2'' + \frac{1 + c_{\varepsilon}}{r} f_2' - \frac{d_r}{r^2} f_2 = 0$, $f_2' \ge 0$ on (R_0, R) ,
$$f_2(R_0) = 1$$
, $f_2'(R_0) = 0$.

 f_1 and f_2 constitute a convex C^1 -function f on (1,R) satisfying inequality (C.13) and

$$f'(1) < 0, f'(R) > 0.$$
 (C.21)

Note that d_r is here a free constant and by the choice $d_r := 0.09$ and by (C.18) we find

$$D = d_{\varphi} - d_r > 0.1 > 0. \tag{C.22}$$

The following lemma proves D to be a lower bound on the eigenvalues of problem (C.6) or, equivalently, (C.5).

Lemma C.1. Let w be a weak solution of the eigenvalue problem (C.5) on Q_R with eigenvalue $\overline{\lambda} - M$, and with coefficients \mathbf{b} given by (C.4). Then, the real part ϱ of the eigenvalue has a positive lower bound D given by (C.22), which especially holds for any R > 1 and for any vector field \mathbf{a} satisfying the bounds (4.1).

PROOF: Let us fix Q_R with some R > 1 and assume that

$$D > \varrho$$
, (C.23)

which means that the supersolution \overline{F} shrinks faster than the (time-dependent) eigenfunction \mathcal{R} on Q_R . Let us further assume that \mathcal{R} has a positive maximum on Q_R (otherwise \mathcal{R} has a negative minimum and the proof works for $-\mathcal{R}$ instead of \mathcal{R}). Let us fix an amplitude A in (C.12) such that

$$\mathcal{R} < \overline{F}$$
 on $Q_R \times \{t = 0\}$ (C.24)

and choose by (C.23) T > 0 such that

$$\mathcal{R} > \overline{F}$$
 at some point $p \in Q_R^T$. (C.25)

At the boundary component $(1,R) \times (\{\varphi=0\} \cup \{\varphi=\pi\}) \times [0,T)$ both functions \mathcal{R} and \overline{F} vanish, however, with different asymptotics. With $M(\cdot,\cdot,0)=1$ the asymptotic bahaviour of \overline{F} can directly be read off the representation (C.17):

$$\overline{F} \sim \varphi^{1/2} \quad \text{for } \varphi \to 0.$$
 (C.26)

On the other hand an asymptotic analysis of eq. $(6.6)_1$ yields the equation

$$\mathcal{R}_0'' - \frac{a_\rho}{\varphi} \mathcal{R}_0' \approx 0 \quad \text{for } \varphi \to 0$$
 (C.27)

for the variable $\mathcal{R}_0 := \mathcal{R}(r_0, \varphi, t_0)$ with $r = r_0$, $t = t_0$ fixed. Equation (C.27) implies the asymptotic behaviour for $\varphi \to 0$:

$$|\mathcal{R}| \lesssim \varphi^{\delta} \quad \text{with } \delta \ge 1 - 0.22 > 3/4.$$
 (C.28)

Comparing (C.26) with (C.28) one finds $\varepsilon_0 > 0$ such that for any $0 < \varepsilon \le \varepsilon_0$ we have the desired control:

$$|\mathcal{R}| \le \overline{F}$$
 on $(1, R) \times (\{\varphi = \varepsilon\} \cup \{\varphi = \pi - \varepsilon\}) \times [0, T)$. (C.29)

The argument works analogously in the case $\varphi \to \pi$, which we have included into (C.29).

At the other boundary component $(\{r=1\} \cup \{r=R\}) \times (\varepsilon, \pi-\varepsilon) \times [0,T)$ we distinguish two cases. In the first case we assume

$$|\mathcal{R}| < \overline{F}$$
 on $(\{r = 1\} \cup \{r = R\}) \times (\varepsilon, \pi - \varepsilon) \times [0, T)$,

which implies together with (C.24) and (C.29) at the parabolic boundary:

$$\mathcal{R} - \overline{F} \le 0$$
 on $\partial Q_{\varepsilon,R}^T$. (C.30)

Applying proposition C.1 on $\mathcal{R} - \overline{F}$ then yields $\mathcal{R} \leq \overline{F}$ on $Q_{\varepsilon,R}^T$ for any $\varepsilon \leq \varepsilon_0$ in contradiction to (C.25). Otherwise we have by continuity (see (C.11)) boundary points p with (say) r = 1 such that

$$\mathcal{R} = \overline{F}$$
 at $p \in \{r = 1\} \times (\varepsilon, \pi - \varepsilon) \times (0, T)$.

Let $p_0 = (1, \varphi_0, T_0)$ be the earliest (i.e., with minimal $T =: T_0$) such point, then inequality (C.30) holds on the "shorter" boundary $\partial Q_{\varepsilon,R}^{T_0}$ and by proposition C.1 on $Q_{\varepsilon,R}^{T_0}$. This, however, is again a contradiction: the boundary condition (C.6)_{2a} for \mathcal{R} and property (C.21) of \overline{F} imply obviously $\mathcal{R} > \overline{F}$ in a neighbourhood of p_0 in $Q_{\varepsilon,R}^{T_0}$.

In conclusion the initial assumption $D > \varrho$ has to be dropped, which proves the lemma.

By (C.2) and (C.8) lemma C.1 implies the desired bound on the Fredholm constant \widetilde{C}_F .
