## SOME COMPUTATIONS IN THE HEART OF THE HOMOTOPY T-STRUCTURE ON LOGARITHMIC MOTIVES

ABSTRACT. In this note we will illustrate a method for computing the  $\pi_0$  of the effective log motive of a smooth and proper variety over a perfect field k and show that it is  $\mathbf{A}^1$ -invariant. We will apply this to compute the first homotopy groups of  $\mathbf{P}^1$  to show that the stripping functor from log motivic sheaves to (usual) Nisnevich sheaves with transfers is fully faithful.

#### 1. Introduction

Since their introduction in [BPØ22], log motives have proved to be very useful to compute non- $\mathbf{A}^1$ -invariant cohomologies using methods from motivic homotopy theory. The main motivic technique is the analogue of Morel-Voevodsky purity of [BPØ23, Theorem 3.2.21], which we now recall. Let  $S \in \mathbf{Sch}$  and  $X = (\underline{X}, \partial X)$  a log scheme log smooth over S with  $\underline{X}$  smooth over S and  $\partial X$  supported on a simple normal crossing divisor  $D_1 + \ldots D_n$ . Let Z be a smooth closed subscheme of  $\underline{X}$  having strict normal crossing with  $D_1 + \ldots D_n$ . Then there is a cofiber sequence functorial in  $Z \subseteq X$ 

$$M^{\text{eff}}(Bl_Z(X), E) \to M^{\text{eff}}(X) \to \text{Th}(N_Z X),$$

where  $\operatorname{Th}(N_Z X)$  is the Thom space of the normal bundle of  $Z \subseteq \underline{X}$ , with an appropriate log structure.

If  $X = (\underline{X}, \text{triv})$  is affine and with trivial log structure and we choose  $Z = D_1$  a smooth divisor, the sequence above gives

$$M^{\text{eff}}(X, D_1) \to M^{\text{eff}}(X, \text{triv}) \xrightarrow{\text{Gys}} M^{\text{eff}}(Z \times \mathbf{P}^1, \text{triv}) / M^{\text{eff}}(Z, \text{triv}),$$

and the terms in the middle and on the right have trivial log structure: this raises the question on whether one can compute recursively  $M^{\text{eff}}(X)$  using only data coming from classical (non-logarithmic) schemes. The obstacle to this is that the map Gys above is induced by a zig-zag of maps of log schemes with non-trivial log structures (as in [BPØ23, Theorem 3.2.21]).

Let k be a perfect field. In [BM21] it was shown that the categories of effective logarithmic motives over a field  $\log \mathcal{DM}^{\mathrm{eff}}(k,\mathbb{Z})$  and  $\log \mathcal{DA}^{\mathrm{eff}}(k,\mathbb{Z})$  admit a homotopy t-structure, whose hearts are the category of strictly  $\Box$ -invariant Nisnevich sheaves with and without transfers, respectively, i.e. sheaves such that the projection induces an equivalence  $H^q_{\mathrm{dNis}}(X,F) \cong H^q_{\mathrm{dNis}}(X \times \overline{\Box},F)$  fo all  $q \geq 0$ . The lifting problem above in this situation is more treatable, indeed if  $\omega_{\sharp}$  denotes the functor that sends a sheaf F on log schemes to the sheaf on (usual) schemes

$$X \in \mathbf{Sm}_k \mapsto F(X, \mathrm{triv}),$$

then this restriction to the hearts of the *t*-structure is faithful and exact, and in [Mer25, Theorem 3.26] the precise obstruction to its fullness has been computed (see Theorem 2.7 for the explicit condition).

In this note we show that in the heart of the homotopy t-structure  $\log \mathbf{CI}^{\mathrm{ltr}}(k,\mathbb{Z}) = \log \mathcal{DM}^{\mathrm{eff}}(k,\mathbb{Z})^{\heartsuit}$ , the obstruction is an empty condition (see Theorem 4.3):

**Theorem 1.1.** Let  $F, G \in \mathbf{logCI}^{\mathrm{ltr}}(k, \mathbb{Z})$ , and let  $\varphi : \omega_{\sharp} F \to \omega_{\sharp} G$  be a map in  $\mathbf{Shv}^{\mathrm{tr}}_{\mathrm{Nis}}(k, \mathbb{Z})$ . Then  $\varphi$  lifts uniquely to a map  $F \to G$  in  $\mathbf{logCI}^{\mathrm{ltr}}(k, \mathbb{Z})$ . In particular the functor  $\mathbf{logCI}^{\mathrm{ltr}}(k, \mathbb{Z}) \xrightarrow{\omega_{\sharp} \iota} \mathbf{Shv}^{\mathrm{tr}}_{\mathrm{Nis}}(k, \mathbb{Z})$  is fully faithful and exact.

This result was first announced in in [BM21, Section 7] assuming resolutions of singularities, but the proof contained a gap pointed out in [BM22]: then this was formulated as a conjecture in [BM22, Conjecture 0.2].

The main input of this is a method to compute  $h_0^{\square}(\underline{X}, D)$  with  $\underline{X}$  smooth and proper over k, and we deduce (without any assumption on resolution of singularities) that it is  $\mathbf{A}^1$ -invariant. With this assumption, this was proved in a more general version in [BPØ22, Proposition 8.2.8]. We use this to compute  $\pi_1 M^{\text{eff}}(\mathbf{P}^1)$ , which will be crucial to show that in the case with transfers the obstruction is an empty condition, and so deduce [BM22, Conjecture 0.2] from [Mer25, Theorem 3.26]. This corrects the gap in [BM21, Section 7].

In the  $\mathbf{P}^1$ -stable situation, we expect this result to be useful in the comparison of log motivic spectra with the  $\mathbf{P}^1$ -spectra of Annala-Hoyois-Iwasa [AHI25]: in this context the Gysin maps are contained in a work in progress by Longke Tang (see [AHI24]).

### 2. Recollections on log motives

We recall the construction of logarithmic motives over a perfect field of [BPØ22] and some properties. The standard reference for log schemes is [Ogu18]. For a log scheme X, we denote by  $\underline{X}$  the underlying scheme of X, by  $\partial X$  the log structure and by  $|\partial X|$  its support, seen as a reduced closed subscheme of X.

We denote by  $\mathbf{SmlSm}(k)$  the category of fs log smooth log schemes over the log scheme (Spec(k), triv) such that  $\underline{X}$  is smooth over k. By e.g. [BPØ22, Lemma A.5.10], then in this case  $\partial X$  is supported on a strict normal crossing divisor on  $\underline{X}$  and  $\partial X$  is isomorphic to the compactifying log structure associated to the open embedding  $\underline{X} - |\partial X| \hookrightarrow \underline{X}$ . If D is a strict normal crossing divisor on  $\underline{X}$ , we will often write  $(\underline{X}, D) \in \mathbf{SmlSm}(k)$  meaning the log scheme with compactifying log structure associated to  $\underline{X} - |D| \hookrightarrow \underline{X}$ .

Following [BPØ22], we denote by  $\mathbf{lCor}(k)$  the category of finite log correspondences over k. It is a variant of the Suslin-Voevodsky category of finite correspondences  $\mathbf{Cor}(k)$ . It has the same objects as  $\mathbf{SmlSm}(k)^1$ , and morphisms are given by the free abelian group generated by elementary correspondences  $V^o \subset (X - \partial X) \times (Y - \partial Y)$  such that the closure  $V \subset \underline{X} \times \underline{Y}$  is finite and surjective over (a component of)  $\underline{X}$  and such that there exists a morphism of log schemes  $V^N \to Y$ , where  $V^N$  is the fs log scheme whose underlying scheme is the normalization of V and whose log structure is given by the inverse image log structure along the composition  $\underline{V}^N \to \underline{X} \times \underline{Y} \to \underline{X}$ . See [BPØ22, 2.1] for more details, and for the proof that this definition gives indeed a category.

This category is equipped with a Grothendieck topology, called the *dividing Nisnevich* topology, generated as a cd-topology by the following:

• strict Nisnevich squares, i.e. pullbacks  $\begin{array}{c} U_1 \times_X U_2 \longrightarrow U_1 \\ & \downarrow \\ U_2 \longrightarrow X \end{array} \text{ such that } \{\underline{U_i} \to \underline{X}\}$ 

is a Nisnevich square and  $\partial U_i = \partial X_{|U_i|}$ 

étale monomorphism.

See [BPØ23, Remark 2.2.4] for more details on this.

We denote by  $\mathbf{PSh}^{\mathrm{ltr}}(k,\mathbb{Z})$  the category of abelian presheaves on  $\mathbf{lCor}(k)$ : such presheaves are called *presheaves with log transfers*, and we denote by  $\mathbb{Z}_{\mathrm{ltr}}(X)$  the representable object. We let  $\mathbf{Shv}^{\mathrm{ltr}}_{\mathrm{dNis}}(k,\mathbb{Z}) \subseteq \mathbf{PSh}^{\mathrm{ltr}}(k,\mathbb{Z})$  the category of dividing Nisnevich sheaves with log transfers, and for  $U \in \mathbf{SmlSm}(k)$  we let  $\mathbb{Z}_{\mathrm{ltr}}(U)$  be the representable sheaf. Analogously to the case of Voevodsky's finite correspondences, it has the structure of a Grothendieck abelian category [BPØ22, Theorem 4.5.7 and §4.2], so we let  $\mathcal{D}(\mathbf{Shv}^{\mathrm{ltr}}_{\mathrm{dNis}}(k,\mathbb{Z}))$ , be its derived category.

Finally (see [BPØ22, §5.2]), let  $\overline{\square} := (\mathbf{P}^1, \infty)$ . We denote  $\log \mathcal{DM}^{\text{eff}}(k, \mathbb{Z})$  the localization of  $\mathcal{D}(\mathbf{Shv}^{\text{ltr}}_{\text{dNis}}(k, \mathbb{Z}))$ ) with respect to the class of maps

$$\mathbb{Z}_{\mathrm{ltr}}(\overline{\square} \times X)[n] \to \mathbb{Z}_{\mathrm{ltr}}(X))[n]$$

for all  $X \in \mathbf{SmlSm}(k)$  and  $n \in \mathbb{Z}$ . We let  $L_{(\mathrm{dNis},\overline{\square})}$  be the localization functor and for  $X \in \mathbf{SmlSm}(k)$ , we will let  $M^{\mathrm{eff}}(X) = L_{(\mathrm{dNis},\overline{\square})}(\mathbb{Z}_{\mathrm{ltr}}(X))$ .

We recall the following result [BM21, Theorem 5.7]:

**Theorem 2.1.** The standard t-structure of  $\mathcal{D}(\mathbf{Shv}_{\mathrm{dNis}}^{\mathrm{ltr}}(k,\mathbb{Z}))$  induces an accessible t-structure on  $\mathbf{log}\mathcal{DM}^{\mathrm{eff}}(k,\mathbb{Z})$  compatible with filtered colimits in the sense of [Lur17, Definition 1.3.5.20], called the homotopy t-structure.

We denote by  $\mathbf{logCI}^{\mathrm{ltr}}(k, \mathbb{Z})$  its heart, which is then identified with the full subcategory of  $\mathbf{Shv}_{\mathrm{dNis}}^{\mathrm{ltr}}(k, \mathbb{Z})$  of sheaves F such that for all  $X \in \mathbf{SmlSm}$ , the projection induces an isomorphism  $R\Gamma(X, F) \simeq R\Gamma(X \times \overline{\square}, F)$  and it is a Grothendieck abelian category. The inclusion

$$\iota \colon \mathbf{logCI}^{\mathrm{ltr}}(k, \mathbb{Z}) \hookrightarrow \mathbf{Shv}^{\mathrm{ltr}}_{\mathrm{dNis}}(k, \mathbb{Z})$$

admits a left adjoint  $h_0^{\overline{\square}}$ , given by the formula  $F \mapsto \pi_0(L_{(\mathrm{dNis},\overline{\square})}(F[0]))$ , and a right adjoint  $h_{\overline{\square}}^0$  (see [BM21, Proposition 5.8]), in particular  $\iota$  preserves all limits and colimits. In general, we let  $h_i^{\overline{\square}}(F) := \pi_i(L_{(\mathrm{dNis},\overline{\square})}(F[0])) \in \mathbf{logCI}^{\mathrm{ltr}}(k,\mathbb{Z})$ .

We have the following purity result [BM21, Theorem 5.10]:

**Theorem 2.2.** Let  $X \in \mathbf{SmlSm}(k)$  and let  $\underline{U} \subseteq \underline{X}$ ,  $\partial U := \partial X_{\underline{U}}$  and  $U := (\underline{U}, \partial U)$ . Then for all  $F \in \mathbf{logCI}^{ltr}(k, \mathbb{Z})$  the restriction  $F(X) \to F(U)$  is injective.

Recall from [BPØ22, (4.3.4)] that the functor  $\omega: X \mapsto X^{\circ}$  induces an adjunction

(2.2.1) 
$$\mathbf{Shv}_{d\mathrm{Nis}}^{\mathrm{tr}}(k,\mathbb{Z}) \xrightarrow{\omega_{\sharp}} \mathbf{Shv}_{\mathrm{Nis}}(k,\mathbb{Z})$$

where the right hand side is Voevodsky's category of Nisnevich sheaves with transfers. These functors are very explicit: for  $Y \in \mathbf{SmlSm}(k)$ ,  $\omega_{\sharp} F(Y) = F(Y, \mathrm{triv})$  and for  $X \in \mathbf{Sm}(k)$ ,  $\omega^* F(X) = F(\underline{X} - |\partial X|)$ . Since  $\omega$  is monoidal by construction,  $\omega_{\sharp}$  is monoidal, and it has a left adjoint  $\omega^{\sharp}$  given by the formula  $\omega^{\sharp} \mathbb{Z}_{\mathrm{tr}}(X) = \mathbb{Z}_{\mathrm{ltr}}(X, \mathrm{triv})$  and extended

by colimits. By construction, the functors  $\omega^{\sharp}$  and  $\omega_{\sharp}$  are exact so we will also call denote their derived functor  $\omega^{\sharp}$  and  $\omega_{\sharp}$  without confusion.

Let  $F \in \mathbf{logCI}^{\mathrm{ltr}}(k,\mathbb{Z})$ : by purity, Theorem 2.2, the unit of the adjunction gives an injective map

$$(2.2.2) \iota F \hookrightarrow \omega^* \omega_{\sharp} \iota F$$

By construction, the map above is an isomorphism if and only if  $\omega_{\sharp}\iota F$  is (strictly)  $\mathbf{A}^1$ -invariant in the sense of Voevodsky. In particular, let  $\mathbf{HI}(k,\mathbb{Z})$  be the category of (strictly)  $\mathbf{A}^1$ -invariant Nisnevich sheaves with transfers: we have that if  $F \in \mathbf{HI}(k,\mathbb{Z})$  if and only if  $\omega^* F \in \mathbf{logCI}^{ltr}(k,\mathbb{Z})$ .

Combining all these properties, we obtain that (see [BM22, Proposition 0.1]:

**Theorem 2.3.** The functor  $\omega_{\sharp}\iota: \mathbf{logCI}^{ltr}(k,\mathbb{Z}) \to \mathbf{Shv}^{tr}(k,\mathbb{Z})$  is faithful and exact, in particular it is conservative.

We will use several time the following immediate corollary of the theorem above:

Corollary 2.4. Let  $f: F \to G$  be a map in  $\log CI^{ltr}(k, \mathbb{Z})$ . Then  $\omega_{\sharp} f$  is injective (resp. surjective) if and only if f is injective (resp. surjective)

*Proof.* Let Q be the kernel (resp. cokernel) of f: then Q is in the essential image of  $\iota$  as  $\log \mathbf{CI}^{\mathrm{ltr}}(k,\mathbb{Z})$  is closed under kernels and cokernels. Since  $\omega_{\sharp}$  is exact,  $\omega_{\sharp}Q$  is the kernel (resp. cokernel) of  $\omega_{\sharp}f$ . Then f is injective (resp. surjective) if and only if  $\omega_{\sharp}Q = 0$ . Since  $\omega_{\sharp}\iota$  is conservative, we conclude that  $\omega_{\sharp}Q = 0$  if and only if Q = 0, which concludes the proof.

The goal of this paper is to improve Theorem 2.3 and prove that  $\omega_{\sharp}\iota$  is indeed fully faithful. To do so, we will use some techniques from [Mer25, §3], that we now recall. The first useful result is the following (see [Mer25, Lemma 3.1]):

**Lemma 2.5.** Let  $F \in \mathbf{logCI}^{\mathrm{ltr}}(k,\mathbb{Z})$ , K a function field over k and  $U \subseteq \mathbf{A}_K^1$  open. Then  $H^q(U,F) = 0$  for q > 0.

As recalled in the introduction,  $\log \mathcal{DM}^{\text{eff}}(k,\mathbb{Z})$  has Gysin triangles. For K a function field over  $k, \underline{U} \subseteq \mathbf{P}^1_K$  affine open containing 0, the following commutative square

(2.5.1) 
$$\mathbb{Z}_{ltr}(U,0) \longrightarrow a_{dNis}\mathbb{Z}_{ltr}(U,triv)$$

$$\downarrow j \qquad \qquad \downarrow \underline{j}$$

$$\mathbb{Z}_{ltr}(\mathbf{P}_{K}^{1},0) \longrightarrow \mathbb{Z}_{ltr}(\mathbf{P}_{K}^{1},triv),$$

becomes cartesian in  $\log \mathcal{DM}^{\mathrm{eff}}(k,\mathbb{Z})$  after applying  $L_{(\mathrm{dNis},\overline{\square})}$  by [BPØ23, Proposition 2.4.8], hence the Gysin map for  $0 \subseteq U$  is equivalent (after applying  $L_{(\mathrm{dNis},\overline{\square})}$ ) to the composition

$$(2.5.2) \mathbb{Z}_{ltr}(U, triv) \to \mathbb{Z}_{ltr}(U, triv) / \mathbb{Z}_{ltr}(U, 0) \to \mathbb{Z}_{ltr}(\mathbf{P}_K^1, triv) / \mathbb{Z}_{ltr}(\mathbf{P}_K^1, 0).$$

From the construction of [Mer25, (3.16)], the Gysin maps above equip  $F \in \log \mathbf{CI}^{ltr}(k, \mathbb{Z})$  with residue maps  $F(\eta_x) \to F(\mathbf{A}^1_{k(x)})/F(k(x))$  for every trait essentially smooth over k with generic point  $\eta_x$  and residue field k(x) (see the proof of Proposition 3.2 where the construction is recalled and used), then the obstruction is the encoded by these residue maps (see [Mer25, Proposition 3.19]):

**Proposition 2.6.** For  $F, G \in \mathbf{logCI}^{ltr}(k, \mathbb{Z})$ , any map  $\varphi \colon \omega_{\sharp}F \to \omega_{\sharp}G$  that respects the residues lifts uniquely to a map of log sheaves  $\varphi \colon F \to G$ .

Let  $F \in \mathbf{logCI}^{\mathrm{ltr}}(k, \mathbb{Z})$  and K a function field over k. By [Mer25, Lemma 3.1], we have that  $H^q_{\mathrm{dNis}}(U, F) = 0$  for q > 0 and  $U \subseteq \mathbf{A}^1_K$  dense open. The Gysin map above gives for all  $U \subseteq \mathbf{A}^1_K$  open containing 0 a map

compatible with open embeddings  $V \subseteq U$ . Let  $i : \{0\} \hookrightarrow \mathbf{A}_K^1$ : then the map (2.6.1) gives a map in  $\mathcal{D}(\mathbf{Shv}((\mathbf{A}_K^1)_{\mathbf{Zar}}), \mathbb{Z})$ 

$$\operatorname{Gys}_0^F : i_*H^1(\mathbf{P}_K^1, \omega_{\sharp}F) \to F_{\mathbf{A}_K^1}[1],$$

where  $H^1(\mathbf{P}_K^1, \omega_{\sharp} F)$  on the left hand side is seen as a (constant) sheaf on the small site of  $\{0\}$ . As an element of  $\operatorname{Ext}^1_{\mathbf{Shv}((\mathbf{A}_K^1)_{\operatorname{Zar}})}(i_*H^1(\mathbf{P}_K^1, \omega_{\sharp} F), F_{\mathbf{A}_K^1})$ , the map  $\operatorname{Gys}_0^F$  above corresponds to the extension:

$$(2.6.2) 0 \to \omega_{\sharp} F_{\mathbf{A}_{K}^{1}} \to F_{(\mathbf{A}_{K}^{1},0)} \to i_{*} H^{1}(\mathbf{P}_{K}^{1},\omega_{\sharp} F) \to 0$$

We have the following theorem (see [Mer25, Theorem 3.26]):

**Theorem 2.7.** Let  $F, G \in \mathbf{logCI}^{ltr}(k, \mathbb{Z})$ , and let  $\varphi \colon \omega_{\sharp} F \to \omega_{\sharp} G$  be a map of sheaves with transfers. If the Gysin maps defined above induce a commutative diagram in  $\mathcal{D}(\mathbf{Shv}((\mathbf{A}_K^1)_{Zar}))$ 

$$\begin{split} i_*H^1(\mathbf{P}_K^1,\omega_{\sharp}F) & \xrightarrow{\operatorname{Gys}_0^F} F_{\mathbf{A}_K^1}[1] \\ i_*H^1(\varphi_{\mathbf{P}_K^1}) \bigg\downarrow & & & & & & & & \\ i_*H^1(\mathbf{P}_K^1,\omega_{\sharp}G) & \xrightarrow{\operatorname{Gys}_0^G} G_{\mathbf{A}_K^1}[1], \end{split}$$

for all function fields K/k, then  $\varphi$  respects the residues, and so there is a (unique) map  $\widetilde{\varphi} \colon F \to G$  that lifts  $\varphi$ .

The proof of Theorem 1.1 will reduce to show that the map  $\operatorname{Gys}_0^F$  agrees with the map induced by the composition in  $\mathcal{D}(\operatorname{\mathbf{Shv}}_{\operatorname{Nis}}^{\operatorname{tr}}(k,\mathbb{Z}))$ 

$$\mathbb{Z}_{\mathrm{tr}}(U)[-1] \xrightarrow{\underline{j}} \mathbb{Z}_{\mathrm{tr}}(\mathbf{P}^1)[-1] \xrightarrow{\tau} \mathbf{G}_m,$$

where the first map is the open immersion and the second map corresponds to the map given by the tautological bundle in  $\text{Pic}(\mathbf{P}^1)$  (see Lemma 4.2): this is indeed a map in  $\mathcal{D}(\mathbf{Shv}^{\text{tr}}_{\text{Nis}}(k,\mathbb{Z}))$ , so it is functorial for maps  $\omega_{\sharp}F \to \omega_{\sharp}G$  in  $\mathbf{Shv}^{\text{tr}}_{\text{Nis}}(k,\mathbb{Z})$ .

### 3. A COMPUTATION OF MOTIVIC LOCALIZATION

In this section, we will show a general method to compute  $h_0^{\square}(-)$  and we will apply it to compute  $h_i^{\square}(\mathbf{P}^1, \text{triv})$  for i = 0, 1, without any assumption on the perfect field k.

Construction 3.1. Let  $S \in \mathbf{Shv}^{\mathrm{ltr}}_{\mathrm{dNis}}(k,\mathbb{Z})$  and let  $T \in \mathbf{logCI}^{\mathrm{ltr}}(k,\mathbb{Z})$  with  $f \colon S \to T$  such that  $\omega_{\sharp}(f)$  is surjective. Then we have a commutative diagram

$$\omega_{\sharp}S \longrightarrow \omega_{\sharp}T$$

$$\downarrow \qquad \qquad \qquad \parallel$$

$$\omega_{\sharp}h_{0}^{\overline{\square}}(S) \xrightarrow{\omega_{\sharp}h_{0}^{\overline{\square}}(f)} \omega_{\sharp}h_{0}^{\overline{\square}}(T)$$

In particular  $\omega_{\sharp}h_0^{\square}(f)$  is surjective, so by Corollary 2.4 the map  $h_0^{\square}(f)$  is surjective.

Let  $L: S \to h_0^{\square}(S)$  be the localization map, given by the unit of the adjunction  $h_0^{\square} \dashv \iota$ , and let E (resp. E') be the kernel of f (resp.  $h_0^{\square}(f)$ ). We fix the notation in the following commutative diagram, where the rows are by definition exact sequences:

$$(3.1.1) 0 \longrightarrow E \xrightarrow{q} S \xrightarrow{f} T$$

$$\downarrow L_0 \qquad \downarrow L \qquad \parallel$$

$$0 \longrightarrow E' \xrightarrow{q'} h_0^{\overline{\square}}(S) \xrightarrow{h_0^{\overline{\square}}(f)} T \longrightarrow 0$$

Let K be a function field and for each  $t \in K$  consider  $i_t \colon (K, \operatorname{triv}) \to \overline{\square}_K$  given by the inclusion of [1:t] in  $\mathbf{P}^1_K$ . Notice that for all  $F \in \mathbf{logCI}^{\mathrm{ltr}}(k, \mathbb{Z})$  and  $t \in K$ , the map  $i_t^* \colon F(\overline{\square}_K) \to F(K, \operatorname{triv})$  is an isomorphism inverse of  $F(K, \operatorname{triv}) \to F(\overline{\square}_K)$  given by the structural map, so for  $t, t' \in K$ ,  $i_t^* = i_{t'}^*$ . We have the following commutative diagram:

(3.1.2) 
$$S(\overline{\square}_K) \xrightarrow{i_0^* - i_1^*} S(K, \operatorname{triv}) \\ \downarrow \\ h_0^{\overline{\square}}S(\overline{\square}_K) \xrightarrow{i_0^* - i_1^* = 0} h_0^{\overline{\square}}S(K, \operatorname{triv})$$
In the same way, if  $S \in \operatorname{\mathbf{Shv}}^{\operatorname{ltr}}_{\operatorname{dNis}}(k, \mathbb{Z})$ ,  $T \in \operatorname{\mathbf{logCI}}^{\operatorname{ltr}}(k, \mathbb{Z})$ 

In the same way, if  $S \in \mathbf{Shv}^{\mathrm{ltr}}_{\mathrm{dNis}}(k,\mathbb{Z})$ ,  $T \in \mathbf{logCI}^{\mathrm{ltr}}(k,\mathbb{Z})$  and f preserves transfers, we have a diagram

$$0 \longrightarrow E \xrightarrow{q} S \xrightarrow{f} T$$

$$\downarrow^{L_0} \qquad \downarrow^{L} \qquad \parallel$$

$$0 \longrightarrow E' \xrightarrow{q'} h_0^{\square}(S) \xrightarrow{h_0^{\square}(f)} T \longrightarrow 0$$

and a diagram

(3.1.3) 
$$S(\overline{\square}_{K}) \xrightarrow{i_{0}^{*} - i_{1}^{*}} S(K, \operatorname{triv}) \downarrow L_{K} \\ h_{0}^{\overline{\square}}S(\overline{\square}_{K}) \xrightarrow{i_{0}^{*} - i_{1}^{*} = 0} h_{0}^{\overline{\square}}S(K, \operatorname{triv})$$

Let us consider the following condition:

$$(\star) q_K(E(K, \text{triv})) \subseteq \text{Im}(i_0^* - i_1^*)$$

**Proposition 3.2.** In the situation of Construction 3.1, if  $(\star)$  is satisfied for every function field K, then  $h_0^{\square}(S) \cong T$ .

Proof. We need to show that for all  $g \colon S \to C$  with  $C \in \mathbf{logCI}^{\mathrm{ltr}}(k, \mathbb{Z})$  there is a unique map  $\overline{g} \colon T \to C$  that factors g via f. Notice that if  $\overline{g}, \overline{g}'$  such that  $\overline{g} \circ f = \overline{g}' \circ f$ , by the universal property of  $h_0^{\square}(S)$  we have  $\overline{g} \circ h_0^{\square}(f) = \overline{g}' \circ h_0^{\square}(f)$ , and since  $h_0^{\square}(f)$  is surjective we get  $\overline{g} = \overline{g}'$ . We are then left to show that such  $\overline{g}$  exists: to do so, we will show that there exists a map  $T \to h_0^{\square}(S)$  that factors  $S \to h_0^{\square}(S)$ . The condition  $(\star)$  implies that for all function fields K

$$q_K' \circ (L_0)_K(E(K, \operatorname{triv})) \stackrel{\text{(3.1.1)}}{=} L_K \circ q_K E(K, \operatorname{triv}) \stackrel{(\star)}{\subseteq} L_K((i_0^* - i_1^*)(S(\overline{\square}_K))) \stackrel{\text{(3.1.2)}}{=} 0.$$

Since  $q'_K$  is injective by definition (see (3.1.1)), we have that the map  $(L_0)_K$  is the zero map.

By purity, Theorem 2.2, for all  $X \in \mathbf{SmlSm}(k)$  with fraction field K,  $h_0^{\square}(S)(X) \hookrightarrow h_0^{\square}(S)(K, \text{triv})$ , so  $E'(X) \hookrightarrow E'(K, \text{triv})$ , which implies that  $L_0$  is the zero map. So, we have that  $E = \ker(L)$ , hence the map L factors through a map  $p \colon S/E \to h_0^{\square}(S)$ . By the universal property of L, for all  $C \in \mathbf{logCI}^{ltr}(k, \mathbb{Z})$  and  $g \colon S \to C$ , we have a unique map g' such that  $g = g' \circ L$ , so the following diagram commutes:

$$S \xrightarrow{g} C$$

$$S/E \xrightarrow{p} h_0^{\square}(S)$$

Moreover, the map  $u: (S/E) \to T$  induces an isomorphism  $\omega_{\sharp}(S/E) \cong \omega_{\sharp}T$  since  $\omega_{\sharp}f$  is surjective by assumption and  $\omega_{\sharp}S/E = \omega_{\sharp}S/\ker(\omega_{\sharp}f)$ , so we get a map

(3.2.1) 
$$\varphi = \omega_{\sharp} p \circ (\omega_{\sharp} u)^{-1} \colon \omega_{\sharp} T \to \omega_{\sharp} h_0^{\square}(S).$$

Let  $\underline{X} \in \mathbf{Sm}(k)$  and let  $x \in \underline{X}$  of codimension one,  $\underline{X}_x^h$  its henselization with generic point  $\eta_x^h$  and residue field k(x). Since  $(S/E)_{\mathbf{A}_{k(x)}^1} = T_{\mathbf{A}_{k(x)}^1}$ , we have by Lemma 2.5 that

$$R\Gamma(\mathbf{A}^1_{k(x)},S/E)=R\Gamma(\mathbf{A}^1_{k(x)},T)=S/E(\mathbf{A}^1_{k(x)})[0].$$

Recall (see [BM21, Theorem 4.1, (ii)]) that there is a formally étale map  $e: \underline{X_x^h} \to \mathbf{P}_{k(x)}^1$  inducing a strict (pro-)Nisnevich square:

$$(3.2.2) \qquad (\underline{\mathcal{X}_{x}^{h}}, \operatorname{triv}) \longrightarrow (\underline{X_{x}^{h}}, \operatorname{triv})$$

$$\downarrow (e^{\circ}) \qquad \qquad \downarrow \underline{e}$$

$$(\mathbf{A}_{k(x)}^{1}, \operatorname{triv}) \longrightarrow (\mathbf{P}_{k(x)}^{1}, \operatorname{triv})$$

giving for all  $F \in \mathbf{Shv}^{\mathrm{ltr}}_{\mathrm{dNis}}(k\mathbb{Z})$  a map

$$F(\eta_x^h)[(0)] \to F(\eta_x^h)[(0)]/R\Gamma(X_x^h, F) \cong R\Gamma(\mathbf{A}_{k(x)}^1, F)/R\Gamma(\mathbf{P}_{k(x)}^1, F).$$

functorial in F, therefore the maps u and p defined above give a commutative diagram (we omit the "triv")

$$T(\eta_x) \xleftarrow{u_{\eta_x}} S/E(\eta_x) \xrightarrow{p_{\eta_x}} h_0^{\square}(S)(\eta_x)$$
 
$$\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow$$
 
$$T(\mathbf{A}^1_{k(x)})/R\Gamma(\mathbf{P}^1_{k(x)},T) \xleftarrow{\simeq} S/E(\mathbf{A}^1_{k(x)})/R\Gamma(\mathbf{P}^1_{k(x)},S/E) \xrightarrow{p_{\eta_x}} h_0^{\square}(S)(\mathbf{A}^1_{k(x)})/R\Gamma(\mathbf{P}^1_{k(x)},h_0^{\square}(S))$$

By composing with the maps  $\operatorname{Spec}(k) \xrightarrow{i_0} \overline{\square} \to (\mathbf{P}^1, \operatorname{triv})$ , the maps u and p give a commutative diagram

$$T(\mathbf{A}_{k(x)}^{1})/R\Gamma(\mathbf{P}_{k(x)}^{1},T) \xleftarrow{\simeq} S/E(\mathbf{A}_{k(x)}^{1})/R\Gamma(\mathbf{P}_{k(x)}^{1},S/E) \longrightarrow h_{0}^{\square}(S)(\mathbf{A}_{k(x)}^{1})/R\Gamma(\mathbf{P}_{k(x)}^{1},h_{0}^{\square}(S))$$

$$\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow$$

$$T(\mathbf{A}_{k(x)}^{1})/R\Gamma(\overline{\square}_{k(x)},T) \longleftarrow S/E(\mathbf{A}_{k(x)}^{1})/R\Gamma(\overline{\square}_{k(x)},S/E) \longrightarrow h_{0}^{\square}(S)(\mathbf{A}_{k(x)}^{1})/R\Gamma(\overline{\square}_{k(x)},h_{0}^{\square}(S))$$

$$\downarrow^{\simeq} \qquad \qquad \downarrow \qquad \qquad \downarrow^{\simeq}$$

$$T(\mathbf{A}_{k(x)}^{1})/T(k(x)) \xleftarrow{u_{\mathbf{A}_{k(x)}^{1}}/u_{k(x)}}{\simeq} S/E(\mathbf{A}_{k(x)}^{1})/S/E(k(x)) \xrightarrow{p_{\mathbf{A}_{k(x)}^{1}}/p_{k(x)}}{h_{0}^{\square}(S)(\mathbf{A}_{k(x)}^{1})/h_{0}^{\square}(S)(k(x)).$$

where the vertical isomorphisms come from the fact that  $h_0^{\square}(S)$  and T are strictly  $\overline{\square}$ -invariant and the horizontal isomorphism from the fact that  $\omega_{\sharp}u$  is an isomorphism.

By taking inverses of  $u_{\eta_x}$  and  $u_{\mathbf{A}_{k(x)}^1}/u_{k(x)}$  as above, we conclude that the map  $\varphi$  of (3.2.1) induces a commutative diagram

$$T(\eta_x) \xrightarrow{\varphi_{\eta_x}} h_0^{\overline{\square}}(S)(\eta_x)$$

$$\downarrow \qquad \qquad \downarrow$$

$$T(\mathbf{A}_{k(x)}^1)/T(k(x)) \xrightarrow{\varphi_{\mathbf{A}_{k(x)}^1}/\varphi_{k(x)}} h_0^{\overline{\square}}(S)(\mathbf{A}_{k(x)}^1)/h_0^{\overline{\square}}(S)(k(x)),$$

which implies that  $\varphi$  respects the residues, so by Proposition 2.6, it lifts uniquely to a map  $\varphi' \colon T \to h_0^{\square}(S)$ . We need to show that  $\varphi' \circ f = L$ : let  $X \in \mathbf{SmlSm}(k)$  and let  $X^{\circ} := \underline{X} - |\partial X|$  be the open with trivial log structure. Since the map  $h_0^{\square}(S)(X) \hookrightarrow h_0^{\square}(S)(X^{\circ}, \text{triv})$  is injective by purity, Theorem 2.2, (see [Mer25, (3.20) and (3.21)] for a similar argument) it is enough to check the commutativity on  $(X^{\circ}, \text{triv})$ , which follows automatically by the commutativity of

$$S/E(X^{\circ}) \xrightarrow{p_{X^{\circ}}} h_{0}^{\square}(S)(X^{\circ})$$

$$\simeq \downarrow u_{X^{\circ}}^{-1}$$

$$T(X^{\circ})$$

Remark 3.3. The proof works verbatim for the heart of the t-structure of  $\log \mathcal{DA}^{\text{eff}}(k,\mathbb{Z})$  (see [BM21]).

For  $X \in \mathbf{SmlSm}(k)$ , we let  $X^{\circ} := X - |\partial X| \in \mathbf{Sm}(k)$  and  $h_i^{\mathbf{A}^1}(X^{\circ})$  the *i*-th Suslin homology sheaf. We also write  $h_i^{\overline{\square}}(X)$  for  $h_i^{\overline{\square}}(\mathbb{Z}_{\mathrm{ltr}}(X))$ . We apply the proposition above to prove the following:

**Proposition 3.4.** Let  $X \in \mathbf{SmlSm}(k)$  such that  $\underline{X}$  is proper. Then  $h_0^{\overline{\square}}(X) \cong \omega^* h_0^{\mathbf{A}^1}(X^\circ)$ .

*Proof.* The map  $f: \mathbb{Z}_{ltr}(X) \to \omega^* h_0^{\mathbf{A}^1}(X^\circ)$  induced by adjunction from the map

$$\omega_{\sharp} \mathbb{Z}_{\mathrm{ltr}}(X) = \mathbb{Z}_{\mathrm{tr}}(X^{\circ}) \to h_0^{\mathbf{A}^1}(X^{\circ})$$

satisfies the fact that  $\omega_{\sharp} f$  is surjective, hence by Proposition 3.2, it is enough to show that  $(\star)$  holds in this case. Notice that we have the following commutative diagram

(3.4.1) 
$$\begin{array}{c} \mathbf{lCor}(\overline{\square}_{K}, X) \xrightarrow{i_{0}^{*} - i_{1}^{*}} & \mathbb{Z}_{\mathrm{ltr}}(X)(K) \\ \downarrow & \qquad \qquad \parallel \\ \mathbf{Cor}(\mathbf{A}_{K}^{1}, X^{\circ}) \xrightarrow{(i_{0}^{\mathbf{A}^{1}})^{*} - (i_{1}^{\mathbf{A}^{1}})^{*}} \mathbb{Z}_{\mathrm{tr}}(X^{\circ})(K) \end{array}$$

Recall that by [MVW06, Theorem 13.8]

$$h_0^{\mathbf{A}^1}(X^\circ) = \pi_0(C_*^{\mathbf{A}^1}(X^\circ)),$$

where  $C_*^{\mathbf{A}^1}(X^\circ)$  is the normalized Suslin complex of [MVW06, Definition 2.14], so we have a right exact sequence

$$\mathbf{Cor}(\mathbf{A}_K^1, X^\circ) \xrightarrow{(i_0^{\mathbf{A}^1})^* - (i_1^{\mathbf{A}^1})^*} \mathbb{Z}_{\mathrm{tr}}(X^\circ)(K) \to h_0^{\mathbf{A}^1}(X^\circ)(K) \to 0$$

which implies that

$$q_K(E(K, \operatorname{triv})) \subseteq \operatorname{Im}((i_0^{\mathbf{A}^1})^* - (i_1^{\mathbf{A}^1})^*)$$

We will conclude by showing that left the vertical map in (3.4.1) is a bijection: if this holds, then  $\operatorname{Im}((i_0^{\mathbf{A}^1})^* - (i_1^{\mathbf{A}^1})^*) = \operatorname{Im}(i_0^* - i_1^*)$  and  $(\star)$  holds. This map sends a correspondence Z to the correspondence  $\omega(Z)$ , so it is clearly injective. Let  $Y \in \mathbf{Sm}(k)$  with fraction field X, so that  $\operatorname{Spec}(X) = \varprojlim_{i \in I} Y_i$  with  $Y_i \subseteq Y$  open, so that

$$\mathbf{lCor}(\overline{\square}_K, X) = \varinjlim_{i \in I} \mathbf{lCor}(\overline{\square}_{Y_i}, X) \quad \text{and} \quad \mathbf{Cor}(\mathbf{A}^1_K, X) = \varinjlim_{i \in I} \mathbf{Cor}(\mathbf{A}^1_{Y_i}, X).$$

Let  $Z \in \mathbf{Cor}(\mathbf{A}_{Y_i}^1, X^\circ)$ . By e.g. [KMSY21a, Theorem 1.6.2], there is a proper birational morphism  $S \to \mathbf{P}_{Y_i}^1$  which is an isomorphism on  $\mathbf{A}_{Y_i}^1$  and a finite correspondence  $Z' \colon S \to X$  that restricts to Z. By [Liu02, Corollary 4.4.3(b)], the map  $S \to \mathbf{P}_{Y_i}^1$  is an isomorphism outside a closed subscheme  $Q \subseteq \mathbf{P}_{Y_i}^1$  of codimension 2. Let  $Q' = \infty_{Y_i} \cap Q$ : since Q has codimension 2,  $\infty_{Y_i} - Q'$  is dense in  $\infty_{Y_i}$ , so there is an open subscheme  $Y_j$  of  $Y_i$  such that  $S \times_{\mathbf{P}_{Y_i}^1} \mathbf{P}_{Y_j}^1 \to \mathbf{P}_{Y_j}^1$  is an isomorphism, which implies that the restriction of Z' induces a finite correspondence  $Z'' \colon \mathbf{P}_{Y_j}^1 \to X$  that restricts to the pullback of Z to  $\mathbf{A}_{Y_j}^1$ . In particular, the pullback of  $|\partial X|$  to Z'' is contained in the pullback of  $\infty_{Y_j}$ , so  $Z'' \in \mathbf{lCor}(\overline{\square}_{Y_j}, X)$  that maps to Z in  $\mathbf{Cor}(\mathbf{A}_{Y_j}^1, X^\circ)$ , so by passing to the limit this concludes the proof.

Remark 3.5. Notice that  $(\star)$  is a very strong condition to verify, and indeed Proposition 3.4 is false if  $X = (\underline{X}, \text{triv})$  with  $\underline{X}$  affine: indeed in that case the map  $\iota$  is not surjective, as  $\mathbf{lCor}(\overline{\square}_K, X) = \mathbf{Cor}(\mathbf{P}_K^1, \underline{X}) = \mathbf{Cor}(K, \underline{X})$ , therefore  $i_0^* - i_1^* = 0$ , but E(K, triv) is in general not zero (e.g. if  $X = \mathbf{A}^1$ ). The correct replacement for this should be coming from the proper modulus pairs as in [KMSY21b]. In fact, we would like to use the method explained in Proposition 3.2 to the map considered in [RSY22]:

$$\mathbf{G}_a \otimes^{\operatorname{ltr}} \mathbf{G}_m \to \Omega^1 \qquad (a,b) \mapsto a \cdot \operatorname{dlog}(b).$$

We conjecture that this map is an isomorphism, but at the moment we are not able to verify  $(\star)$  in this case. We remark that the methods of [RSY22] do not apply here since  $\mathbb{Z}_{\mathrm{ltr}}(\mathbf{A}^1)(\overline{\square}_K) = \mathbb{Z}_{\mathrm{ltr}}(\mathbf{A}^1)(K)$ : in order to make it work we need a replacement for the modulus pair  $(\mathbf{P}^1, 2\infty)$ . This is a work in progress.

We can now compute the first homotopy groups of  $M^{\text{eff}}(\mathbf{P}^1, \text{triv})$  without any assumptions on resolutions of singularities. The square

$$(\mathbf{P}^{1},0+\infty) \longrightarrow (\mathbf{P}^{1},0)$$

$$\downarrow \qquad \qquad \downarrow$$

$$(\mathbf{P}^{1},\infty) \longrightarrow (\mathbf{P}^{1},\mathrm{triv}),$$

induces a cartesian square in  $\log \mathcal{DM}^{\text{eff}}(k,\mathbb{Z})$  (see [BPØ23, Proposition 2.4.9]) giving a long exact sequence

$$h_{1}^{\square}(\mathbf{P}^{1},0) \underset{h_{1}^{\square}(\mathbf{P}^{1},\infty)}{\oplus} \to h_{1}^{\square}(\mathbf{P}^{1},\mathrm{triv}) \to h_{0}^{\square}(\mathbf{P}^{1},0+\infty) \to h_{0}^{\square}(\mathbf{P}^{1},0) \underset{h_{0}^{\square}(\mathbf{P}^{1},\infty)}{\oplus} \to h_{0}^{\square}(\mathbf{P}^{1},\mathrm{triv}) \to 0$$

Since the inclusion of the point [1:1] in  $\mathbf{P}^1$  induces equivalences in  $\log \mathcal{DM}^{\mathrm{eff}}(k,\mathbb{Z})$ :

$$\mathbb{Z}[0] \simeq M^{\mathrm{eff}}(\mathrm{Spec}(k)) \simeq M^{\mathrm{eff}}(\mathbf{P}^1, 0) \simeq M^{\mathrm{eff}}(\mathbf{P}^1, \infty)$$

we conclude that  $h_0^{\square}(\mathbf{P}^1, \operatorname{triv}) \simeq h_0^{\square}(\operatorname{Spec}(k)) = \mathbb{Z}$ . Consider the map  $\tau \colon \mathbb{Z}_{\operatorname{tr}}(\mathbf{P}^1)[-1] \to \mathbf{G}_m$  given by the tautological bundle in  $\operatorname{Pic}(\mathbf{P}^1)$ : by applying  $\omega^{\sharp}$  it gives a composition in  $\mathcal{D}(\operatorname{\mathbf{Shv}}_{\operatorname{dNis}}^{\operatorname{tr}}(k, \mathbb{Z}))$ :

(3.5.2) 
$$\tilde{\tau} : \mathbb{Z}_{ltr}(\mathbf{P}^1, triv)[-1] \xrightarrow{\omega^{\sharp} \tau} \omega^{\sharp} \mathbf{G}_m \to \omega^* \mathbf{G}_m,$$

Since  $\omega^* \mathbf{G}_m \in \mathbf{logCI}^{\mathrm{ltr}}(k, \mathbb{Z})$ , the map factors through a map  $M^{\mathrm{eff}}(\mathbf{P}^1, \mathrm{triv})[-1] \to \omega^* \mathbf{G}_m$ , and by taking  $\pi_0$  we get a map

$$(3.5.3) h_1^{\overline{\square}}(\mathbf{P}^1, \operatorname{triv}) \to \omega^* \mathbf{G}_m.$$

**Proposition 3.6.** The map (3.5.3) is an isomorphism.

*Proof.* By e.g. [BM21, Proposition 5.12], the map above factors through  $\omega^* h_1^{\mathbf{A}^1}(\mathbf{P}^1) \to \omega^* \mathbf{G}_m$ , which is an isomorphism by [MVW06, Lecture 4], hence it is enough to prove that  $h_1^{\overline{\square}}(\mathbf{P}^1, \text{triv}) \cong \omega^* h_1^{\mathbf{A}^1}(\mathbf{P}^1)$ . By the long exact sequences induced by Mayer–Vietoris we have a commutative diagram where the rows are exact sequences:

$$0 \longrightarrow h_{1}^{\square}(\mathbf{P}^{1}, \operatorname{triv}) \longrightarrow h_{0}^{\square}(\mathbf{P}^{1}, 0 + \infty) \longrightarrow h_{0}^{\square}(\overline{\square})^{\times 2}$$

$$\downarrow^{(*1)} \qquad \qquad \downarrow^{(*2)} \qquad \qquad \parallel$$

$$0 \longrightarrow \omega^{*}h_{1}^{\mathbf{A}^{1}}(\mathbf{P}^{1}) \longrightarrow \omega^{*}h_{0}^{\mathbf{A}^{1}}(\mathbf{A}^{1} - \{0\}) \longrightarrow \omega^{*}h_{0}^{\mathbf{A}^{1}}(\mathbf{A}^{1})^{\times 2}.$$

By [MVW06, Lemma 4.1], we have  $h_1^{\mathbf{A}^1}(\mathbf{A}^1 - \{0\}) = 0$ , so by Proposition 3.4 we conclude that the map (\*2) above is an isomorphism, so (\*1) is an isomorphism too.

Remark 3.7. One would be tempted to generalize the result above to the case without transfers: we have by [Mor12, Theorem 3.37] that  $h_1^{\mathbf{A}^1}(\mathbf{P}^1) \cong \mathcal{K}_1^{\mathrm{MW}}$ , where the right hand side is the Milnor–Witt K-theory sheaf. On the other hand  $\mathbb{Z}(\mathbf{A}^1 - \{0\}) \to \mathcal{K}_1^{\mathrm{MW}}$  is not surjective, so the result does not immediately follow in this case. We leave this (apparently much harder) computation to a future work.

# 4. Proof of [BM22, Conjecture 0.2] in the case with transfers

In this section, we will deduce the aforementioned conjecture from [Mer25, Theorem 3.26] (see Theorem 2.7). The key point is to show that in this situation the map  $\operatorname{Gys}_0$  is already defined in  $\operatorname{\mathbf{Shv}}^{\operatorname{tr}}_{\operatorname{Nis}}(k,\mathbb{Z})$ . We fix the map  $\tau\colon \mathbb{Z}_{\operatorname{tr}}(\mathbf{P}^1)[-1]\to \mathbf{G}_m$  induced by the tautological bundle and the associated map  $\tilde{\tau}\colon \mathbb{Z}_{\operatorname{ltr}}(\mathbf{P}^1,\operatorname{triv})\to \omega^*\mathbf{G}_m$ .

**Lemma 4.1.** Let  $F \in \log \mathbb{CI}^{ltr}(k, \mathbb{Z})$ . The maps  $\tau$  and  $\tilde{\tau}$  induce isomorphism

$$\underline{\operatorname{Hom}}_{\mathbf{Shv}_{\mathrm{Nis}}^{\mathrm{tr}}}(\mathbf{G}_{m},\omega_{\sharp}F) \cong a_{\mathrm{Nis}}H^{1}(\mathbf{P}^{1}\times -,\omega_{\sharp}F) \cong \omega_{\sharp}\,\underline{\operatorname{Hom}}_{\mathbf{Shv}_{\mathrm{dNis}}^{\mathrm{ltr}}}(\omega^{*}\mathbf{G}_{m},F).$$

*Proof.* Let  $X \in \mathbf{Sm}(k)$ . Then we have

$$\underline{\operatorname{Hom}}_{\mathbf{Shv}_{\mathrm{Nis}}^{\mathrm{tr}}}(\mathbf{G}_{m}, \omega_{\sharp}F)(X) = \operatorname{Hom}_{\mathbf{Shv}_{\mathrm{Nis}}^{\mathrm{tr}}}(\mathbf{G}_{m}, \underline{\operatorname{Hom}}_{\mathbf{Shv}_{\mathrm{Nis}}^{\mathrm{tr}}}(\mathbb{Z}_{\mathrm{tr}}(X), \omega_{\sharp}F))$$

$$= \operatorname{Hom}_{\mathbf{Shv}_{\mathrm{Nis}}^{\mathrm{tr}}}(\mathbf{G}_{m}, \omega_{\sharp} \underline{\operatorname{Hom}}_{\mathbf{Shv}_{\mathrm{Nis}}^{\mathrm{ltr}}}(\mathbb{Z}_{\mathrm{ltr}}(X, \mathrm{triv}), F))$$

and

$$\omega_{\sharp} \underline{\operatorname{Hom}}_{\mathbf{Shv}_{\mathrm{dNis}}^{\mathrm{ltr}}}(\omega^{*}\mathbf{G}_{m}, F)(X) = \operatorname{Hom}_{\mathbf{Shv}_{\mathrm{dNis}}^{\mathrm{ltr}}}(\omega^{*}\mathbf{G}_{m}, \underline{\operatorname{Hom}}_{\mathbf{Shv}_{\mathrm{dNis}}^{\mathrm{ltr}}}(\mathbb{Z}_{\mathrm{ltr}}(X, \mathrm{triv}), F)).$$

Since  $\underline{\operatorname{Hom}}_{\mathbf{Shv}_{\mathrm{dNis}}^{\mathrm{ltr}}}(\mathbb{Z}_{\mathrm{ltr}}(X,\mathrm{triv}),F) \in \mathbf{logCI}^{\mathrm{ltr}}(k,\mathbb{Z})$  (see e.g. [BM21, Lemma 2.10]) and every map  $\omega_{\sharp}F \to \omega_{\sharp}G$  induces a map

$$\omega_{\sharp} \underline{\operatorname{Hom}}_{\mathbf{Shv}_{\mathrm{dNis}}^{\mathrm{tr}}}(\mathbb{Z}_{\mathrm{ltr}}(X, \mathrm{triv}), F) = \underline{\operatorname{Hom}}_{\mathbf{Shv}_{\mathrm{Nis}}^{\mathrm{tr}}}(\mathbb{Z}_{\mathrm{tr}}(X), \omega_{\sharp} F)$$

$$\to \underline{\operatorname{Hom}}_{\mathbf{Shv}_{\mathrm{Nis}}^{\mathrm{tr}}}(\mathbb{Z}_{\mathrm{tr}}(X), \omega_{\sharp} G) = \omega_{\sharp} \underline{\operatorname{Hom}}_{\mathbf{Shv}_{\mathrm{dNis}}^{\mathrm{ltr}}}(\mathbb{Z}_{\mathrm{ltr}}(X, \mathrm{triv}), G),$$

up to replacing F with  $\underline{\mathrm{Hom}}_{\mathbf{Shv}^{\mathrm{tr}}_{\mathrm{Mz}}}(\mathbb{Z}_{\mathrm{ltr}}(X,\mathrm{triv}),F)$ , we are left to prove that the maps

$$(4.1.1) \qquad \operatorname{Hom}_{\mathbf{Shv}_{\mathrm{Nis}}^{\mathrm{tr}}}(\mathbf{G}_{m}, \omega_{\sharp}F) \to H^{1}(\mathbf{P}^{1}, \omega_{\sharp}F) \leftarrow \operatorname{Hom}_{\mathbf{Shv}_{\mathrm{dNis}}^{\mathrm{ltr}}}(\omega^{*}\mathbf{G}_{m}, F)$$

are isomorphisms.

The map  $\tilde{\tau}$  is in fact composition  $\mathbb{Z}_{ltr}(\mathbf{P}^1, triv)[-1] \xrightarrow{\omega^{\sharp} \tau} \omega^{\sharp} \mathbf{G}_m \to \omega^* \mathbf{G}_m$  of (3.5.2). For all  $F \in \mathbf{Shv}_{dNis}^{ltr}(k, \mathbb{Z})$  it induces a commutative diagram functorial in F:

$$H^{1}(\mathbf{P}^{1}, \omega_{\sharp} F) \leftarrow (*2) \qquad \qquad \operatorname{Hom}_{\mathbf{Shv}^{\mathrm{tr}}_{\mathrm{Nis}}}(\mathbf{G}_{m}, \omega_{\sharp} F)$$

$$\operatorname{Hom}_{\mathbf{Shv}^{\mathrm{ltr}}_{\mathrm{dNis}}}(\omega^{*}\mathbf{G}_{m}, F)$$

We first prove that the map (\*1) is an isomorphism. Indeed by Proposition 3.6 we have that the truncation of the map (3.5.2) induces an isomorphism

$$\psi \colon \operatorname{Hom}_{\mathbf{Shv}_{\mathbf{dNis}}^{\operatorname{Itr}}}(\omega^* \mathbf{G}_m, F) \cong \operatorname{Hom}_{\mathbf{Shv}_{\mathbf{dNis}}^{\operatorname{Itr}}}(h_1^{\square}(\mathbf{P}^1, \operatorname{triv}), F).$$

Moreover, we have the spectral sequence

$$E_2^{ij} = \operatorname{Ext}^i_{\mathbf{Shv}^{\operatorname{dr}}_{\operatorname{ANie}}}(h_j^{\overline{\square}}(\mathbf{P}^1, \operatorname{triv}), F) \Rightarrow H^{i+j}(\mathbf{P}^1, \omega_{\sharp} F)$$

that gives the exact sequence

$$0 \to \operatorname{Ext}^1(h_0^{\square}(\mathbf{P}^1, \operatorname{triv}), F) \to H^1(\mathbf{P}^1, \omega_{\sharp} F) \xrightarrow{\theta} \operatorname{Hom}(h_1^{\square}(\mathbf{P}^1, \operatorname{triv}), F) \to \operatorname{Ext}^2(h_0^{\square}(\mathbf{P}^1, \operatorname{triv}), F)$$

We have that  $h_0^{\square}(\mathbf{P}^1, \text{triv}) = \mathbb{Z}$  and  $\mathbb{Z}[0] = M^{\text{eff}}(\text{Spec}(k))$ , so

$$\operatorname{Ext}^{i}(h_{0}^{\overline{\square}}(\mathbf{P}^{1},\operatorname{triv}),F)(X) = H^{i}(\operatorname{Spec}(k),F) = 0$$
 for  $i \geq 1$ ,


which implies that the map  $\theta$  above is an isomorphism given by the truncation, so the composition  $\theta^{-1} \circ \psi$  gives (\*1).

This implies that in order to show that (\*2) above is an isomorphism it is enough to check that it is injective.

Let  $h^0_{\square}\omega^*$  be the right adjoint of  $\omega_{\sharp}\iota$ :  $\log \mathbf{CI}^{\mathrm{ltr}}(k,\mathbb{Z}) \to \mathbf{Shv}^{\mathrm{ltr}}_{\mathrm{Nis}}(k,\mathbb{Z})$  (see Section 2 for notation): for all  $F \in \log \mathbf{CI}^{\mathrm{ltr}}(k,\mathbb{Z})$  the map  $F \to h^0_{\square}\omega^*\omega_{\sharp}\iota F$  is injective, as  $\iota F \to \omega^*\omega_{\sharp}\iota F$  is injective, see (2.2.2),  $h^0_{\square}$  is left exact and  $h^0_{\square}\iota = \mathrm{Id}$  since  $\iota$  is fully faithful. Let

$$F_n := (h_{\overline{\square}}^0 \omega^* \omega_{\sharp} \iota)^{\circ n} F.$$

we have that  $F \to F_n$  is injective, so we have a commutative diagram where the vertical maps are injective:



In order to check that (\*2) is injective, it is enough to check that the map (\*5) above is an isomorphism: indeed, if (\*5) is an isomorphism then (\*4) is an isomorphism too, so since all the vertical arrows are injective we conclude that (\*2) is injective too. On the other hand, we have that the map

$$\operatorname{Hom}_{\mathbf{Shv}_{\mathrm{Nis}}^{\mathrm{tr}}}(\omega^{*}\mathbf{G}_{m}, F_{n}) \to \operatorname{Hom}_{\mathbf{Shv}_{\mathrm{Nis}}^{\mathrm{tr}}}(\mathbf{G}_{m}, \omega_{\sharp}F_{n})$$

equals by adjunction the composition

$$\operatorname{Hom}_{\mathbf{Shv}_{\mathrm{dNis}}^{\mathrm{ltr}}}(\omega^{*}\mathbf{G}_{m}, F_{n}) \to \operatorname{Hom}_{\mathbf{Shv}_{\mathrm{dNis}}^{\mathrm{ltr}}}(\omega^{*}\mathbf{G}_{m}, h_{\square}^{0}\omega^{*}\omega_{\sharp}\iota F_{n}) = \operatorname{Hom}_{\mathbf{Shv}_{\mathrm{Nis}}^{\mathrm{tr}}}(\mathbf{G}_{m}, \omega_{\sharp}F_{n}),$$

therefore the map is just the boundary map  $\operatorname{Hom}_{\mathbf{Shv}^{\operatorname{ltr}}_{\operatorname{dNis}}}(\omega^*\mathbf{G}_m, F_n) \to \operatorname{Hom}_{\mathbf{Shv}^{\operatorname{ltr}}_{\operatorname{dNis}}}(\omega^*\mathbf{G}_m, F_{n+1}),$  which by taking colimits on n is an isomorphism.

We are now ready to prove our key result:

**Lemma 4.2.** Let  $F \in \mathbf{logCI}^{\mathrm{ltr}}(k,\mathbb{Z})$  and  $U \subseteq \mathbf{A}_K^1$  be a neighborhood of  $\{0\}$ , with  $x \in \underline{X} \in \mathbf{Sm}(k)$ . After the identification of Lemma 4.1, the map  $\mathrm{Gys}_0^F \colon H^1(\mathbf{P}_K^1, \omega_\sharp F) \to \omega_\sharp F(U)[1]$  agrees with the map

$$\operatorname{Hom}(\mathbf{G}_m \otimes \mathbb{Z}_{\operatorname{tr}}(K), \omega_{\sharp} F) \to \operatorname{map}(\mathbf{G}_m \otimes \mathbb{Z}_{\operatorname{tr}}(K), \omega_{\sharp} F) \to \operatorname{map}(\mathbf{P}^1_{m,K}, \omega_{\sharp} F)[1] \to \omega_{\sharp} F(U)[1]$$

where the first map is the canonical map on co-truncated objects, the second map is induced by  $\tau$  and the last map by the open immersion  $\underline{j} \colon \mathbb{Z}_{tr}(U)[-1] \subseteq \mathbb{Z}_{tr}(\mathbf{P}_K^1)[-1]$ . In particular,  $\operatorname{Gys}_0$  is functorial for maps  $\omega_{\sharp} F \to \omega_{\sharp} G$ .

*Proof.* Recall (2.6.1) that for  $U \subseteq \mathbf{A}^1$  the map  $\operatorname{Gys}_0^F$  is defined via the compositions

$$\begin{split} H^1(\mathbf{P}_K^1, \omega_{\sharp} F) &\simeq \mathrm{map}(\mathbb{Z}_{\mathrm{ltr}}(\mathbf{P}_K^1, \mathrm{triv}) / \mathbb{Z}_{\mathrm{ltr}}(\mathbf{P}_K^1, 0)[-1], F) \simeq \\ &\mathrm{map}(\mathbb{Z}_{\mathrm{ltr}}(U, \mathrm{triv}) / \mathbb{Z}_{\mathrm{ltr}}(U, 0)[-1], F) \to \mathrm{map}(\mathbb{Z}_{\mathrm{ltr}}(U, \mathrm{triv})[-1], F) = F_{\mathbf{A}_K^1}(U)[1]. \end{split}$$

By the choice of a trivialization of the tautological bundle on  $\mathbf{P}^1 - \{0\}$ , the map  $\tau$  factors through

$$\delta \colon \mathbb{Z}_{\mathrm{tr}}(\mathbf{P}^1)/\mathbb{Z}_{\mathrm{tr}}(\mathbf{P}^1 - \{0\})[-1] \to \mathbf{G}_m,$$

and we have a commutative diagram

$$\omega^{\sharp} \mathbb{Z}_{tr}(\mathbf{P}^{1}) \longrightarrow \omega^{\sharp} \mathbb{Z}_{tr}(\mathbf{P}^{1})/\omega^{\sharp} \mathbb{Z}_{tr}(\mathbf{P}^{1} - \{0\})$$


$$\parallel \qquad \qquad \downarrow$$

$$\mathbb{Z}_{ltr}(\mathbf{P}^{1}, triv) \longrightarrow \mathbb{Z}_{ltr}(\mathbf{P}^{1}, triv)/\mathbb{Z}_{ltr}(\mathbf{P}^{1}, 0)$$

Then the truncated maps together with the isomorphisms of Lemma 4.1 fit in the following commutative diagram.

$$\underline{\operatorname{Hom}}(\mathbf{G}_{m}, \omega_{\sharp}F) \longrightarrow \underline{\operatorname{map}}(\mathbf{G}_{m}, \omega_{\sharp}F) \\
\underline{\underline{\operatorname{map}}}(\mathbb{Z}_{\operatorname{tr}}(\mathbf{P}^{1})/\mathbb{Z}_{\operatorname{tr}}(\mathbf{P}^{1} - \{0\})[-1], \omega_{\sharp}F) \\
\uparrow \\
a_{\operatorname{Nis}}H^{1}(\mathbf{P}^{1} \times -, \omega_{\sharp}F) \longrightarrow \omega_{\sharp}\underline{\operatorname{map}}(\mathbb{Z}_{\operatorname{ltr}}(\mathbf{P}^{1}, \operatorname{triv})/\mathbb{Z}_{\operatorname{ltr}}(\mathbf{P}^{1}, 0)[-1], F),$$

We have the commutative diagram obtained by applying  $\omega^{\sharp}\omega_{\sharp}$  to (2.5.1):



so by putting everything together we conclude that the composition giving  $\mathrm{Gys}_0^F$  agrees with the composition

$$\operatorname{Hom}(\mathbf{G}_m \otimes \mathbb{Z}_{\operatorname{tr}}(K), \omega_{\sharp} F) \to \operatorname{map}(\mathbf{G}_m \otimes \mathbb{Z}_{\operatorname{tr}}(K), \omega_{\sharp} F) \to \operatorname{map}(\mathbb{Z}_{\operatorname{tr}}(\mathbf{P}_K^1) / \mathbb{Z}_{\operatorname{tr}}(\mathbf{P}_K^1 - \{0\})[-1], \omega_{\sharp} F) \to \operatorname{map}(\mathbb{Z}_{\operatorname{tr}}(U) / \mathbb{Z}_{\operatorname{tr}}(U - \{0\})[-1], \omega_{\sharp} F) \to \operatorname{map}(\mathbb{Z}_{\operatorname{tr}}(U)[-1], \omega_{\sharp} F) = F(U)[1],$$

which in turns agrees with the desired composition. Then the functoriality for the maps  $\omega_{\sharp}F \to \omega_{\sharp}G$  is then clear, as j and  $\tau$  are maps in  $\mathcal{D}(\mathbf{Shv}^{\mathrm{tr}}_{\mathrm{Nis}}(k,\mathbb{Z}))$ .

We are ready to settle [BM22, Conjecture 0.2] in the case with transfers:

**Theorem 4.3.** Let  $F, G \in \mathbf{logCI}^{\mathrm{ltr}}(k, \mathbb{Z})$ , and let  $\varphi \colon \omega_{\sharp} F \to \omega_{\sharp} G$  be a map in  $\mathbf{Shv}^{\mathrm{tr}}_{\mathrm{Nis}}$ . Then  $\varphi$  lifts uniquely to a map  $F \to G$  in  $\mathbf{logCI}^{\mathrm{ltr}}(k, \mathbb{Z})$ . In particular the functor  $\mathbf{logCI}^{\mathrm{ltr}}(k, \mathbb{Z}) \xrightarrow{\omega_{\sharp} \iota} \mathbf{Shv}^{\mathrm{tr}}_{\mathrm{Nis}}$  is fully faithful and exact and, for all  $F \in \mathbf{logCI}^{\mathrm{ltr}}(k, \mathbb{Z})$ , we have  $h_{\square}^{\square} \omega^{\sharp} \omega_{\sharp} \iota_F F \cong F$ .

*Proof.* The faithfulness and exactness is [BM22, Proposition 0.1]. By Lemma 4.2, the maps  $\operatorname{Gys}_0$  are functorial for all maps  $\varphi \colon \omega_{\sharp} F \to \omega_{\sharp} G$ , therefore by Theorem 2.7  $\varphi$  is in the image of  $\omega_{\sharp}$ , therefore the functor  $\operatorname{logCI}^{\operatorname{ltr}}(k,\mathbb{Z}) \xrightarrow{\omega_{\sharp} \iota} \operatorname{Shv}_{\operatorname{Nis}}^{\operatorname{tr}}(k)$  is fully faithful and exact. Finally,  $\omega_{\sharp} \iota$  has a left adjoint given by  $h_0^{\square} \omega^{\sharp}$ , so the last part follows from fully faithfulness.
