# A VOLTERRA EQUATION APPROACH TO THE LOCAL LIMIT OF NONLOCAL TRAFFIC MODELS

ABSTRACT. We consider a class of nonlocal conservation laws modeling traffic flow, given by  $\partial_t u_\varepsilon + \partial_x (V(u_\varepsilon * \gamma_\varepsilon) u_\varepsilon) = 0$  with  $\gamma_\varepsilon(\cdot) := \varepsilon^{-1} \gamma(\cdot/\varepsilon)$  for a suitable convex convolution kernel  $\gamma$ . Since the work of Colombo et al. (Arch. Ration. Mech. Anal., 2023), thanks to uniform  $L^\infty$ -and TV-estimates, it is known that  $w_\varepsilon := u_\varepsilon * \gamma_\varepsilon$  converges to the entropy solution of the local scalar conservation law  $\partial_t u + \partial_x (V(u) u) = 0$  as  $\varepsilon \searrow 0$ . However, the convergence of  $\{u_\varepsilon\}_{\varepsilon>0}$  itself has not been fully addressed so far. In this direction, a known result applies specifically to the case of an exponential kernel, where the identity  $\varepsilon \partial_x w_\varepsilon = w_\varepsilon - u_\varepsilon$  is fundamental. In this work, we address this gap in the literature and prove that  $\{u_\varepsilon\}_{\varepsilon>0}$  converges to the same limit u under the mild additional assumption that the initial datum belongs to  $L^1(\mathbb{R})$ . Our analysis exploits, through a Fourier approach, the stability properties of the more general Volterra-type equation  $\partial_x w_\varepsilon = \gamma'_\varepsilon * u_\varepsilon - \gamma_\varepsilon(0) u_\varepsilon$ , thereby deducing the convergence of  $u_\varepsilon$  from that of  $w_\varepsilon$ .

### 1. Introduction

We study the following Cauchy problem for a class of nonlocal conservation laws modeling traffic flows:

(1.1) 
$$\begin{cases} \partial_t u_{\varepsilon}(t,x) + \partial_x \left( V\left( (u_{\varepsilon} * \gamma_{\varepsilon})(t,x) \right) u_{\varepsilon}(t,x) \right) = 0, & t > 0, \ x \in \mathbb{R}, \\ u_{\varepsilon}(0,x) = u_0(x), & x \in \mathbb{R}, \end{cases}$$

with a parameter  $\varepsilon > 0$ , an initial datum

$$(1.2) u_0 \in L^{\infty}(\mathbb{R}), 0 \leq u_0 \leq 1, TV(u_0) < +\infty,$$

with  $\mathrm{TV}(u_0)$  denoting the total variation of  $u_0$  on  $\mathbb{R}$ , a velocity function  $V:\mathbb{R}\to\mathbb{R}_+$  satisfying

(1.3) 
$$V \in \text{Lip}([0,1]), \quad V'(\xi) \leq 0 \text{ for } \xi \in [0,1],$$

and a nonlocal impact

$$w_{\varepsilon} := u_{\varepsilon} * \gamma_{\varepsilon},$$

affecting the velocity, given by a weighted average (with respect to the space variable) of the downstream density with kernel  $\gamma_{\varepsilon}(\cdot) := \varepsilon^{-1} \gamma(\cdot/\varepsilon)$ , such that

(1.4) 
$$\gamma \in \mathrm{BV}(\mathbb{R}), \quad \mathrm{supp} \, \gamma \subset ]-\infty, 0], \quad \int_{-\infty}^{0} \gamma(z) \, \mathrm{d}z = 1, \qquad \int_{-\infty}^{0} |z| \gamma(z) \, \mathrm{d}z < +\infty,$$

$$\gamma \geqslant 0, \quad \gamma \text{ convex and non-decreasing in } ]-\infty, 0].$$

The nonlocal impact  $w_{\varepsilon}$  satisfies the following evolution equation (in the strong sense):

$$(1.5) \partial_t w_{\varepsilon} + \partial_x (V(w_{\varepsilon})w_{\varepsilon}) = \partial_x (V(w_{\varepsilon})w_{\varepsilon} - (V(w_{\varepsilon})u_{\varepsilon}) * \gamma_{\varepsilon}),$$

i. e., a conservation law with a local flux and a nonlocal source (in divergence form) that acts as a regularization term.

Under assumptions (1.2)–(1.4), problem (1.1) admits a unique weak solution  $u_{\varepsilon} \in L^{\infty}(\mathbb{R}_{+} \times \mathbb{R}) \cap C(\mathbb{R}_{+}, L^{1}_{loc}(\mathbb{R}))$  and it satisfies  $0 \leq u_{\varepsilon} \leq 1$  (see, e. g., [KP17; BS20; Coc+22]).

The singular limit of (1.1) as  $\varepsilon \searrow 0$  has attracted considerable attention, while most positive results in this direction addressed convergence of the nonlocal impact  $w_{\varepsilon}$  rather than the solution  $u_{\varepsilon}$  as the former enjoys better regularity and stability properties. For example, under assumptions (1.2)–(1.4), [Col+23] established the uniform total variation bound

$$\mathrm{TV}(w_{\varepsilon}(t,\cdot)) \leqslant \mathrm{TV}(u_0)$$
 for all  $t \geqslant 0$  and  $\varepsilon > 0$ ,

and the convergence of  $w_{\varepsilon}$  to the (unique) entropy solution u of the (local) scalar conservation law

(1.6) 
$$\begin{cases} \partial_t u(t,x) + \partial_x \left( V(u(t,x)) u(t,x) \right) = 0, & t > 0, \ x \in \mathbb{R}, \\ u(0,x) = u_0(x), & x \in \mathbb{R}, \end{cases}$$

strongly in  $L^1_{loc}(\mathbb{R}_+ \times \mathbb{R})$  as  $\varepsilon \searrow 0$ . Under the same assumptions, in [DH25], an asymptotically compatible Godunov-type numerical scheme was built.

More recently, the assumptions on the total variation of the initial datum and on the convexity of the kernel have been relaxed in [CDH25] by relying on the theory of compensated compactness.

However, the convergence of  $u_{\varepsilon}$  in the singular limit has only been addressed in special cases, e. g., with the exponential kernel  $\gamma(\cdot) := \mathbb{1}_{]-\infty,0]}(\cdot) \exp(\cdot)$  (see [Coc+23, Theorems 3.2 and 4.2]), leveraging the identity

$$(1.7) \varepsilon \partial_x w_\varepsilon = w_\varepsilon - u_\varepsilon.$$

In this case, the combination of (1.7) and the TV-estimate on  $w_{\varepsilon}$  further allows one to deduce the convergence of the family  $\{u_{\varepsilon}\}_{\varepsilon>0}$  to the same limit as  $\{w_{\varepsilon}\}_{\varepsilon>0}$  (see [Coc+23, Corollary 4.1]) as  $\varepsilon \searrow 0$ .

Under more restrictive assumptions on the initial datum, uniform TV-bounds on  $\{u_{\varepsilon}\}_{\varepsilon>0}$  can also be established directly: namely, when the initial datum  $u_0$  is monotone, as in [KP19]; when  $u_0$  is bounded away from zero and the kernel is exponential (see [BS20; BS21]); or when  $u_0$  is bounded away from zero, one-sided Lipschitz continuous, and the kernel grows super-exponentially (see [Col+21]). In more general cases, uniform TV-bounds for  $\{u_{\varepsilon}\}_{\varepsilon>0}$  are challenging (or false; see [Col+21] for some counterexamples).

In this work, we address this gap in the literature. Under the additional assumption

$$(1.8) u_0 \in L^1(\mathbb{R}),$$

we deduce the convergence of  $u_{\varepsilon}(t,\cdot)$  to  $u(t,\cdot)$  in  $L^{2}(\mathbb{R})$  for a.e. t>0 from the convergence of  $w_{\varepsilon}(t,\cdot)$  to  $u(t,\cdot)$ .

**Theorem 1.1** (Convergence of  $\{u_{\varepsilon}\}_{{\varepsilon}>0}$ ). Let us assume that the initial datum  $u_0$  satisfies (1.2) and (1.8), the velocity function V satisfies (1.3), and the kernel  $\gamma$  satisfies (1.4). Let  $u_{\varepsilon}$  be the (unique) weak solution of (1.1) and  $w_{\varepsilon} := u_{\varepsilon} * \gamma_{\varepsilon}$  the corresponding nonlocal impact that satisfies (1.5). Then, for a. e. t > 0,  $u_{\varepsilon}(t, \cdot)$  converges to  $u(t, \cdot)$  in  $L^2(\mathbb{R})$  as  $\varepsilon \searrow 0$ , where u is the entropy solution of (1.6).

As a by-product of the proof of Lemma 1.1, we also obtain an explicit L<sup>2</sup>-convergence rate (thereby yielding convergence in  $L^1_{loc}(\mathbb{R}_+ \times \mathbb{R})$  as well); see Lemma 2.1.

# 2. Proof of the main result

The main idea for the proof of Lemma 1.1 is to rely on the Volterra-type equation (of the second kind):

$$\partial_x w_{\varepsilon}(t,x) = (\gamma_{\varepsilon}' * u_{\varepsilon})(t,x) - \gamma_{\varepsilon}(0)u_{\varepsilon}(t,x) = -\gamma_{\varepsilon}(0)u_{\varepsilon}(t,x) + \int_x^{\infty} u_{\varepsilon}(t,y)\gamma_{\varepsilon}'(x-y)\,\mathrm{d}y,$$

which generalizes the identity (1.7). We exploit stability properties of this Volterra-type equation through a Fourier approach (a strategy previously used in [DT18; HD22]).

*Proof of Lemma 1.1.* Owing to [Col+23, Theorem 1.3], under the assumptions (1.2)-(1.4), we have

$$w_{\varepsilon} \to u$$
 in  $L^1_{loc}(\mathbb{R}_+ \times \mathbb{R})$  as  $\varepsilon \searrow 0$ ,

where  $\{w_{\varepsilon}\}_{{\varepsilon}>0}$  is the family of solutions to (1.5) (with initial datum  $u_0 * \gamma_{\varepsilon}$ ) and u is the unique entropy solution of (1.6). We aim to prove that, under the additional assumption (1.8),  $\{u_{\varepsilon}\}_{{\varepsilon}>0}$  converges to the same limit in  $L^2([0,T]\times\mathbb{R})$  for any fixed T>0.

Step 1. Energy estimate for  $u_{\varepsilon}$ . From the identity  $w_{\varepsilon} = \gamma_{\varepsilon} * u_{\varepsilon}$ , we deduce that

(2.1) 
$$\partial_x w_{\varepsilon} = \gamma_{\varepsilon}' * u_{\varepsilon} - \gamma_{\varepsilon}(0) u_{\varepsilon},$$

and thus,  $\|\partial_x w_{\varepsilon}\|_{L^{\infty}} \leq \gamma_{\varepsilon}(0)$ . Then, the estimate

$$\frac{\mathrm{d}}{\mathrm{d}t} \int_{\mathbb{R}} |u_{\varepsilon}(t,x)|^2 \, \mathrm{d}x = -\int_{\mathbb{R}} |u_{\varepsilon}(t,x)|^2 \, V'(w_{\varepsilon}(t,x)) \, \partial_x w_{\varepsilon}(t,x) \, \mathrm{d}x$$

$$\leq \|V'\|_{L^{\infty}} \, \gamma_{\varepsilon}(0) \int_{\mathbb{R}} |u_{\varepsilon}(t,x)|^2 \, \mathrm{d}x,$$

gives that  $u_{\varepsilon}(t,\cdot) \in L^2(\mathbb{R})$  for any  $t \geq 0$ , and consequently  $w_{\varepsilon}(t,\cdot) \in L^2(\mathbb{R})$  for any  $t \geq 0$ . This allows us to consider the singular limit problem in the Fourier domain.

Step 2. A Fourier approach. Applying the Fourier transform (in L<sup>2</sup>( $\mathbb{R}$ )) on  $w_{\varepsilon} = \gamma_{\varepsilon} * u_{\varepsilon}$ , we get  $\hat{w}_{\varepsilon}(t,\cdot) = \hat{\gamma}_{\varepsilon} \cdot \hat{u}_{\varepsilon}(t,\cdot)$  for all  $t \geq 0$ , where

$$\hat{\gamma}_{\varepsilon}(\xi) = \int_{-\infty}^{0} e^{-i\varepsilon\xi z} \gamma(z) dz = a_{\varepsilon}(\xi) + i b_{\varepsilon}(\xi),$$
with  $a_{\varepsilon}(\xi) := \int_{-\infty}^{0} \cos(\varepsilon\xi z) \gamma(z) dz$  and  $b_{\varepsilon}(\xi) := -\int_{-\infty}^{0} \sin(\varepsilon\xi z) \gamma(z) dz.$ 

The assumption (1.4) yields that

$$b_{\varepsilon}(\xi) = \frac{1}{\varepsilon \xi} \int_{-\infty}^{0} (1 - \cos(\varepsilon \xi z)) \gamma'(z) \, dz > 0 \quad \text{for all } \varepsilon > 0, \xi \neq 0.$$

When  $\xi = 0$ ,  $b_{\varepsilon}(\xi) = 0$  but  $a_{\varepsilon}(\xi) = 1$ . Thus, we have  $\hat{\gamma}_{\varepsilon}(\xi) \neq 0$  for all  $\varepsilon > 0$  and  $\xi \in \mathbb{R}$ . Moreover, we have

$$\hat{\gamma}_{\varepsilon}(\xi) = 1 + i\varepsilon\xi \int_{-\infty}^{0} \frac{1 - e^{-i\varepsilon\xi z}}{i\varepsilon\xi z} \cdot |z|\gamma(z) dz \sim 1 + i\varepsilon\xi \int_{-\infty}^{0} |z|\gamma(z) dz \to 1 \quad \text{as } \varepsilon\xi \to 0.$$

Therefore, we deduce the following pointwise convergence from the L<sup>2</sup>-convergence of  $\hat{w}_{\varepsilon}$  to  $\hat{u}$ :

$$\hat{u}_{\varepsilon}(t,\xi) = \frac{\hat{w}_{\varepsilon}(t,\xi)}{\hat{\gamma}_{\varepsilon}(\xi)} \to \hat{u}(t,\xi)$$
 as  $\varepsilon \searrow 0$  for a. e.  $t \geqslant 0, \ \xi \in \mathbb{R}$ .

We need, however, to estimate the L<sup>2</sup>-distance  $||u_{\varepsilon}(t,\cdot) - u(t,\cdot)||_{L^{2}(\mathbb{R})}$ . To this end, using Plancherel's theorem and splitting into high and low frequencies, we compute as follows (for a given  $\delta > 0$  to be chosen later):

$$\begin{aligned} \|u_{\varepsilon}(t,\cdot) - u(t,\cdot)\|_{\mathbf{L}^{2}(\mathbb{R})}^{2} &= \int_{\mathbb{R}} |\hat{u}_{\varepsilon}(t,\xi) - \hat{u}(t,\xi)|^{2} \, \mathrm{d}\xi \\ &= \int_{|\varepsilon\xi| < \delta} \left| \frac{1}{\hat{\gamma}_{\varepsilon}(\xi)} \hat{w}_{\varepsilon}(t,\xi) - \hat{u}(t,\xi) \right|^{2} \, \mathrm{d}\xi + \int_{|\varepsilon\xi| \geqslant \delta} |\hat{u}_{\varepsilon}(t,\xi) - \hat{u}(t,\xi)|^{2} \, \mathrm{d}\xi \\ &\leqslant \int_{|\varepsilon\xi| < \delta} \frac{1}{|\hat{\gamma}_{\varepsilon}(\xi)|^{2}} |\hat{w}_{\varepsilon}(t,\xi) - \hat{u}(t,\xi)|^{2} \, \mathrm{d}\xi + \int_{|\varepsilon\xi| < \delta} \left| \frac{1}{\hat{\gamma}_{\varepsilon}(\xi)} - 1 \right|^{2} |\hat{u}(t,\xi)|^{2} \, \mathrm{d}\xi \\ &+ 2 \int_{|\varepsilon\xi| \geqslant \delta} |\hat{u}_{\varepsilon}(t,\xi)|^{2} \, \mathrm{d}\xi + 2 \int_{|\varepsilon\xi| \geqslant \delta} |\hat{u}(t,\xi)|^{2} \, \mathrm{d}\xi \\ &=: \mathcal{T}_{1} + \mathcal{T}_{2} + \mathcal{T}_{3} + \mathcal{T}_{4}. \end{aligned}$$

Step 3. Estimating the low frequencies (terms  $\mathcal{I}_1$  and  $\mathcal{I}_2$ ). Using the fact that  $\hat{\gamma}_{\varepsilon}(\xi) \sim 1 + i\varepsilon\xi \int_{-\infty}^{0} |z|\gamma(z) dz$  as  $\varepsilon\xi \to 0$ , by taking  $\delta$  small enough, we have  $|\hat{\gamma}_{\varepsilon}(\xi)| \ge \frac{1}{2}$  when  $|\varepsilon\xi| < \delta$  and

$$\sup_{|\varepsilon\xi|<\delta} \left| \frac{1}{\hat{\gamma}_{\varepsilon}(\xi)} - 1 \right| \leqslant C_0 \delta,$$

where the constant  $C_0 > 0$  depends only on  $\gamma$ . Thus, using Plancherel's theorem and the uniform bounds  $0 \le w_{\varepsilon}, u \le 1$ , we deduce that

$$\mathcal{I}_{1} \leqslant 4 \int_{|\varepsilon\xi| < \delta} |\hat{w}_{\varepsilon}(t,\xi) - \hat{u}(t,\xi)|^{2} d\xi \leqslant 4 \|w_{\varepsilon}(t,\cdot) - u(t,\cdot)\|_{L^{2}(\mathbb{R})}^{2} \leqslant 4 \|w_{\varepsilon}(t,\cdot) - u(t,\cdot)\|_{L^{1}(\mathbb{R})}^{2},$$

$$\mathcal{I}_{2} \leqslant C_{0}^{2} \delta^{2} \int_{|\varepsilon\xi| < \delta} |\hat{u}(t,\xi)|^{2} d\xi \leqslant C_{0}^{2} \delta^{2} \|u(t,\cdot)\|_{L^{2}(\mathbb{R})}^{2} \leqslant C_{0}^{2} \delta^{2} \|u(t,\cdot)\|_{L^{1}(\mathbb{R})} = C_{0}^{2} \delta^{2} \|u_{0}\|_{L^{1}(\mathbb{R})}.$$

Step 4. Estimating the high frequencies (terms  $\mathcal{I}_3$  and  $\mathcal{I}_4$ ). To estimate the terms  $\mathcal{I}_3$  and  $\mathcal{I}_4$ , we derive further estimates on the family  $\{\hat{u}_{\varepsilon}\}_{{\varepsilon}>0}$ . Multiplying (2.1) by  $u_{\varepsilon}$  and integrating it over  $x \in \mathbb{R}$ , we obtain

$$\int_{\mathbb{R}} u_{\varepsilon}(t,x) \partial_{x} w_{\varepsilon}(t,x) dx = \int_{-\infty}^{0} \left( \int_{\mathbb{R}} u_{\varepsilon}(t,x) u_{\varepsilon}(t,x-s) - u_{\varepsilon}(t,x)^{2} dx \right) \gamma_{\varepsilon}'(s) ds$$

$$= -\frac{1}{2} \int_{-\infty}^{0} \left( \int_{\mathbb{R}} \left( u_{\varepsilon}(t,x-s) - u_{\varepsilon}(t,x) \right)^{2} dx \right) \gamma_{\varepsilon}'(s) ds,$$

for all  $t \ge 0$ . Letting

$$\rho_\varepsilon(t,s) := \int_{\mathbb{R}} \left( u_\varepsilon(t,x-s) - u_\varepsilon(t,x) \right)^2 \, \mathrm{d}x \quad \text{for all } t \geqslant 0, \ s \in \mathbb{R}, \text{ and } \varepsilon > 0,$$

we deduce that

$$(2.2) 0 \leqslant \int_{-\infty}^{0} \rho_{\varepsilon}(t,s) \gamma_{\varepsilon}'(s) \, \mathrm{d}s \leqslant 2 \left| \int_{\mathbb{R}} u_{\varepsilon}(t,x) \partial_{x} w_{\varepsilon}(t,x) \, \mathrm{d}x \right| \leqslant 2 \, \mathrm{TV}(w_{\varepsilon}(t,\cdot)) \leqslant 2 \, \mathrm{TV}(u_{0}),$$

for all  $t \ge 0$  and  $\varepsilon > 0$ .

On the other hand, in the Fourier domain, we have

$$\rho_{\varepsilon}(t,s) = \int_{\mathbb{R}} \left| e^{-is\xi} - 1 \right|^2 \left| \hat{u}_{\varepsilon}(t,\xi) \right|^2 d\xi = \int_{\mathbb{R}} 2(1 - \cos(s\xi)) \left| \hat{u}_{\varepsilon}(t,\xi) \right|^2 d\xi,$$

which yields

$$\int_{-\infty}^{0} \rho_{\varepsilon}(t,s) \gamma_{\varepsilon}'(s) \, \mathrm{d}s = \int_{\mathbb{R}} \left( \int_{-\infty}^{0} 2(1 - \cos(s\xi)) \gamma_{\varepsilon}'(s) \, \mathrm{d}s \right) \left| \hat{u}_{\varepsilon}(t,\xi) \right|^{2} \, \mathrm{d}\xi$$
$$= \frac{1}{\varepsilon} \int_{\mathbb{R}} \left( \int_{-\infty}^{0} 2(1 - \cos(\varepsilon s\xi)) \gamma'(s) \, \mathrm{d}s \right) \left| \hat{u}_{\varepsilon}(t,\xi) \right|^{2} \, \mathrm{d}\xi.$$

We define

$$h(z) := \int_{-\infty}^{0} 2(1 - \cos(zs))\gamma'(s) ds \quad \text{for } z \in \mathbb{R}.$$

Noting that  $\gamma' \ge 0$  and  $\int_{-\infty}^{0} \gamma'(z) dz = \gamma(0) > 0$ , we have h(z) > 0 for all  $z \ne 0$ . When  $z \to 0$ , the mean value theorem yields

$$2(1-\cos(zs)) = \cos(\zeta(zs))(zs)^2$$
 for  $\zeta(zs)$  between 0 and  $zs$ ,

thus

$$\left| \frac{2(1 - \cos(zs))}{z^2} \right| \le s^2$$
 and  $\lim_{z \to 0} \frac{2(1 - \cos(zs))}{z^2} = s^2$  for all  $s < 0$ .

Therefore, by Lebesgue's dominated convergence theorem, we have

$$\lim_{z \to 0} \frac{h(z)}{z^2} = \int_{-\infty}^0 s^2 \gamma'(s) \, \mathrm{d}s = 2 \int_{-\infty}^0 |s| \gamma(s) \, \mathrm{d}s \in ]0, +\infty[.$$

Moreover, Riemann-Lebesgue's lemma yields that

$$\lim_{|z| \to \infty} h(z) = 2 \int_{-\infty}^{0} \gamma'(s) \, \mathrm{d}s = 2 \gamma(0) \in ]0, +\infty[.$$

By continuity of h and the two limits established above, there exist  $\delta_{\gamma}, \eta_{\gamma} > 0$ , depending only on  $\gamma$ , such that

$$h(z) \geqslant \eta_{\gamma} z^2 \geqslant \eta_{\gamma} \delta^2 \text{ for } |z| \geqslant \delta \text{ whenever } 0 < \delta < \delta_{\gamma}.$$

Then we take  $z = \varepsilon \xi$  and obtain from (2.2) that

$$2 \operatorname{TV}(u_0) \geqslant \frac{1}{\varepsilon} \int_{\mathbb{R}} h(\varepsilon \xi) \left| \hat{u}_{\varepsilon}(t, \xi) \right|^2 d\xi \geqslant \frac{\eta_{\gamma} \delta^2}{\varepsilon} \int_{|\varepsilon \xi| \geqslant \delta} \left| \hat{u}_{\varepsilon}(t, \xi) \right|^2 d\xi,$$

and thus

(2.3) 
$$\int_{|\varepsilon\xi| \ge \delta} |\hat{u}_{\varepsilon}(t,\xi)|^2 d\xi \le \frac{2\varepsilon}{\eta_{\gamma}\delta^2} TV(u_0) =: C_1 TV(u_0) \frac{\varepsilon}{\delta^2},$$

for any  $\delta \in ]0, \delta_{\gamma}[$ . This estimates  $\mathcal{I}_3$ .

For the term  $\mathcal{I}_4$ , we use the TV-estimate  $\mathrm{TV}(u(t,\cdot)) \leqslant \mathrm{TV}(u_0)$  for all  $t \geqslant 0$  to deduce that

$$\int_{|\varepsilon\xi|\geqslant \delta} |\hat{u}(t,\xi)|^2 \;\mathrm{d}\xi \leqslant \int_{|\varepsilon\xi|\geqslant \delta} \left(\frac{\mathrm{TV}(u(t,\cdot))}{|\xi|}\right)^2 \;\mathrm{d}\xi = 2(\mathrm{TV}(u_0))^2 \,\frac{\varepsilon}{\delta}.$$

Step 5. Conclusion of the proof. Combining the estimates in Steps 3-4, we obtain

(2.4) 
$$||u_{\varepsilon}(t,\cdot) - u(t,\cdot)||_{L^{2}(\mathbb{R})}^{2} \leq 4 ||w_{\varepsilon}(t,\cdot) - u(t,\cdot)||_{L^{1}(\mathbb{R})} + C_{0}^{2} \delta^{2} ||u_{0}||_{L^{1}(\mathbb{R})} + C_{1} \operatorname{TV}(u_{0}) \frac{\varepsilon}{\delta^{2}} + 2(\operatorname{TV}(u_{0}))^{2} \frac{\varepsilon}{\delta}.$$

Letting  $\varepsilon \searrow 0$  and  $\delta = \varepsilon^{1/4}$ , we have  $\|w_{\varepsilon}(t,\cdot) - u(t,\cdot)\|_{L^{1}(\mathbb{R})} \to 0$  and  $\delta^{2}$ ,  $\varepsilon/\delta^{2}$ ,  $\varepsilon/\delta \searrow 0$ , giving  $\|u_{\varepsilon}(t,\cdot) - u(t,\cdot)\|_{L^{2}(\mathbb{R})} \to 0$ .

Remark 2.1 (Convergence rate). In [Col+23], the convergence rate

(2.5) 
$$||w_{\varepsilon}(t,\cdot) - u(t,\cdot)||_{L^{1}(\mathbb{R})} \leq C(\gamma, V) \operatorname{TV}(u_{0}) \left(\varepsilon + \sqrt{\varepsilon t}\right)$$

was established. By taking  $\delta = \varepsilon^{1/4}$  in (2.4) and using (2.5), we deduce

$$\|u_{\varepsilon}(t,\cdot) - u(t,\cdot)\|_{\mathrm{L}^{2}(\mathbb{R})} \le C(\gamma, V) \|u_{0}\|_{\mathrm{BV}(\mathbb{R})}^{\frac{1}{2}} (\varepsilon(1+t))^{\frac{1}{4}},$$

provided  $0 < \varepsilon < \varepsilon_0 := (1 + TV(u_0))^{-2}$ , where  $||u_0||_{BV(\mathbb{R})} := ||u_0||_{L^1(\mathbb{R})} + TV(u_0)$  and the constant  $C(\gamma, V) > 0$  depends only on the kernel  $\gamma$  and the velocity function V. We leave the question of the sharpness of this rate (as well as the search for optimal exponents) for future investigation.
