# Stability of Superposition of Viscous Contact Wave and Rarefaction Waves for Compressible Navier-Stokes System with Degenerate Heat-Conductivity and Large-Data

#### Abstract

This paper is concerned with the large-time behavior of solutions for the compressible Navier-Stokes system with degenerate heat-conductivity describing the one-dimensional motion of a viscous heat-conducting perfect polytropic gas. We proved that for the one-dimensional compressible system with temperature-dependent heat conductivity, the combination of viscous contact wave with rarefaction waves for the non-isentropic polytropic gas is asymptotically stable under large initial perturbation, provided the strength of the combination waves is suitably small.

Key words and phrases: Compressible Navier-Stokes system, Viscous Contact Discontinuity, Degenerate Heat-Conductivity, Large Initial Perturbation, Stability

### 1 Introduction

The one-dimensional compressible Navier-Stokes system describing the motion of a viscous heat-conducting perfect polytropic gas has the form in Lagrangian coordinates(see[1, 31]):

$$\begin{cases}
v_t - u_x = 0, \\
u_t + p_x = \mu \left(\frac{u_x}{v}\right)_x, \\
\left(e + \frac{u^2}{2}\right)_t + (pu)_x = \left(\kappa \frac{\theta_x}{v} + \mu \frac{uu_x}{v}\right)_x
\end{cases}$$

for  $x \in \mathbb{R} = (-\infty, +\infty)$ , t > 0, where v(x,t) > 0, u(x,t),  $\theta(x,t) > 0$ , e(x,t) > 0 and p(x,t) are the specific volume, fluid velocity, absolute temperature, internal energy and pressure, respectively, while the positive constants  $\mu$  and  $\kappa$  denote the viscosity and heat conduction coefficients, respectively. Here we study the ideal polytropic fluids so that p and e are given by the state equations

$$p = \frac{R\theta}{v} = Av^{-\gamma} \exp\left(\frac{\gamma - 1}{R}s\right), \quad e = c_{\nu}\theta + \text{const},$$

where s is the entropy,  $\gamma > 1$  is the adiabatic exponent,  $c_{\nu} = \frac{R}{\gamma - 1}$  is the specific heat, A and R are both positive constants. For  $\mu$  and  $\kappa$ , we consider the case where  $\mu$  and  $\kappa$  are proportional to (possible different) powers of  $\theta$ :

$$\mu = \tilde{\mu}\theta^{\alpha}, \quad \kappa = \tilde{\kappa}\theta^{\beta}, \tag{1.3}$$

where  $\tilde{\mu}, \tilde{\kappa} > 0$  and  $\alpha, \beta \geq 0$  are constants.

Then we impose the Cauchy problem to the system (1.1) supplement with the following initial and far field conditions:

$$\begin{cases} (v, u, \theta)(x, 0) = (v_0, u_0, \theta_0)(x), & x \in \mathbb{R}, \\ (v, u, \theta)(\pm \infty, t) = (v_{\pm}, u_{\pm}, \theta_{\pm}), & t > 0, \end{cases}$$
(1.4)

where  $v_{\pm}(>0)$ ,  $u_{\pm}$  and  $\theta_{\pm}(>0)$  are given constants, and we assume  $\inf_{\mathbb{R}} v_0 > 0$ ,  $\inf_{\mathbb{R}} \theta_0 > 0$ , and  $(v_0, u_0, \theta_0)(\pm \infty) = (v_{\pm}, u_{\pm}, \theta_{\pm})$  as compatibility conditions.

When the far field states are the same ( $v_+ = v_-$ ,  $u_+ = u_-$ ,  $\theta_+ = \theta_-$ ), a large number of literatures have been devoted to some researches on the global existence of solutions to the system (1.1) has advanced substantially since 1977, see [17, 18, 20, 21, 22] and the reference therein. In particular, Jiang [17, 18] first obtained uniformly bounded for specific volume, while Li and Liang [22] subsequently extended this framework by proving the uniformly estimates for temperature, thus completing the large-time behavior of solutions.

It is interesting to study the global solutions in time of system (1.1) and their large time behavior for different end states, which is more complicated than the same states. Notably, if the dissipation effects are neglected ( $\mu = \kappa = 0$ ), the system (1.1) is reduced to the compressible Euler equations, which is one of the most important hyperbolic system of conservation laws. It is well known that the Euler system contains three basic wave patterns (see [32]), two nonlinear waves: shock and rarefaction wave, and a linearly degenerate wave: contact discontinuity. When we consider the Riemann initial data ,the solutions consist of the above three wave patterns and their superpositions, called by Riemann solutions, and govern both the local and large time asymptotic behavior of general solutions of the Euler system. It is of great importance and interest to study the large-time behavior of the viscous version of these basic wave patterns and their superpositions to the compressible Navier-Stokes system (1.1).

Extensive literature has been devoted to the stability analysis of viscous wave patterns in the system (1.1). These works encompass the studies of [9, 19, 26] for shock waves, [25, 27, 28, 29] for rarefaction waves, and the reference therein. For the subtler case where the Riemann solution consists of contact discontinuity (referred to as viscous contact wave), Huang et al. in [11, 13] obtained the stability of viscous contact wave and convergence rate, and further related studies about stability of viscous contact wave can be found in [10, 14, 15]. Subsequently, Huang-Li-Matsumura in [8] proved the combination wave of a viscous contact wave with rarefaction waves is asymptotically stable in the one-dimensional compressible Navier-Stokes system. Building on this, Huang-Wang [12] succeeded in removing the non-physical condition of the adiabatic exponent  $\gamma$ , which means these basic wave patterns and their linear superpositions are stable even for large perturbation.

It is noted that the above mentioned literature has only considered cases where  $\mu$  and  $\kappa$  are constants, whereas according to the Chapman-Enskog expansion for the first level of approximation in kinetic theory, the viscosity  $\mu$  and heat conductivity  $\kappa$  are functions of temperature alone [2, 3]. When concerning the case where  $\alpha, \beta > 0$ , the research becomes more challenging due to the potential degeneracy and strong nonlinearity on viscosity and heat diffusion. For the existence of solutions, Jenssen-Karper [16] showed the global existence of weak solutions when  $\alpha = 0$  and  $\beta \in (0, 3/2)$  on the bounded domain. Later on, for  $\alpha = 0$  and  $\beta > 0$ , Pan-Zhang[30] (also cf.[4, 7])obtained the global strong solution. When the domain is unbounded, Li-Shu-Xu [23] proved the existence of global strong solutions under the initial conditions. For the large-time behavior of strong solutions with  $\alpha = 0$ ,  $\beta > 0$ , when the domain is bounded, Huang-Shi [6] showed that the solution is nonlinearly exponentially stable as time tends to infinity. Recently, for the case of unbounded domains, Li-Xu [24] made studies on the large-time behavior of the global strong solutions. However, the above literature has focused only on cases where the far field states are the same, whereas the cases of different far field states with temperature-dependent heat conductivity are still open.

The main aim of this paper is to prove the asymptotic stability of linear combination wave of viscous contact wave and the rarefaction waves of one-dimensional compressible system (1.1)-(1.2) with temperature-dependent heat conductivity, provided the strength of combination waves is suitably small.

*Notations.* Throughout this paper, generic positive constants are denoted by c and C without confusion.

 $L^p(\Omega)$  denotes the usual Lebesgue space on  $\Omega \subset \mathbb{R} = (-\infty, \infty)$  with its norm given by

$$\|f\|_{L^p(\Omega)} := \left( \int_{\Omega} |f(x)|^p dx \right)^{\frac{1}{p}}, \quad 1 \le p < \infty.$$

$$\|f\|_{L^{\infty}(\Omega)} := \operatorname{ess.sup}_{\Omega} |f(x)|, \qquad p = \infty.$$

 $H^k(\Omega)$  denotes the  $k^{th}$  order Sobolev space with its norm

$$||f||_{H^k(\Omega)} := \left(\sum_{j=0}^k ||\partial_x^j f||^2 (\Omega)\right)^{\frac{1}{2}}, \text{ when } ||\cdot|| = ||\cdot||_{L^2(\Omega)}.$$

The domain  $\Omega$  will be often abbreviated without confusion.

## 2 Main Result

Prior to state the main results, we first recall the viscous contact wave  $(V, U, \Theta)$  for the compressible Navier-Stokes system (1.1) defined in [13]. For the Euler system

$$\begin{cases} v_t - u_x = 0, \\ u_t + p_x = 0, \\ \left(e + \frac{u^2}{2}\right)_t + (pu)_x = 0, \end{cases}$$
 (2.5)

with Riemann problem

$$(v, u, \theta)(x, 0) = \begin{cases} (v_-, u_-, \theta_-), & x < 0, \\ (v_+, u_+, \theta_+), & x > 0, \end{cases}$$
 (2.6)

it is known that the contact discontinuity solution takes the form

$$(\tilde{V}, \tilde{U}, \tilde{\Theta})(x, t) = \begin{cases} (v_{-}, u_{-}, \theta_{-}), & x < 0, t > 0, \\ (v_{+}, u_{+}, \theta_{+}), & x > 0, t > 0, \end{cases}$$
(2.7)

provide that

$$u_{-} = u_{+}, \quad p_{-} \triangleq \frac{R\theta_{-}}{v_{-}} = p_{+} \triangleq \frac{R\theta_{+}}{v_{+}}.$$
 (2.8)

We assume that  $u_- = u_+ = 0$  without loss of generality. Due to the dissipation effect, the corresponding wave  $(V, U, \Theta)$  to the contact discontinuity  $(\tilde{V}, \tilde{U}, \tilde{\Theta})$  is smoothed and behaves as a diffusion wave, which is called a "viscous contact wave". The viscous contact wave  $(V, U, \Theta)$  can be constructed as follows. Since the pressure for the profile  $(V, U, \Theta)$  is expected to be constant asymptotically, we set

$$\frac{R\Theta}{V} = p_+,$$

which indicates the leading part of the energy equation  $(1.1)_3$  is

$$c_{\nu}\Theta_{t} + p_{+}U_{x} = \kappa_{1} \left(\frac{\Theta_{x}}{V}\right)_{x}, \tag{2.9}$$

where  $\kappa_1 = \tilde{\kappa}\Theta^{\beta}$ . The equation (2.9) and (1.1)<sub>1</sub> lead to a nonlinear diffusion equation,

$$\Theta_t = a \left( \Theta_x / \Theta \right)_x, \quad \Theta(\pm \infty, t) = \theta_\pm, \quad a = \frac{\kappa_1 (\gamma - 1) p_+}{\gamma R^2} > 0,$$
(2.10)

which has a unique self-similar solution  $\Theta(x,t) = \Theta(\xi)$ ,  $\xi = \frac{x}{\sqrt{1+t}}$  due to [5]. Furthermore, on the one hand,  $\Theta(\xi)$  is a monotone function, increasing if  $\theta_+ > \theta_-$  and decreasing if  $\theta_+ < \theta_-$ ; On the other hand, there exists some positive constant  $\delta$ , such that for  $\delta = |\theta_+ - \theta_-|$ ,  $\Theta$  satisfies

$$(1+t)|\Theta_{xx}| + (1+t)^{\frac{1}{2}}|\Theta_x| + |\Theta - \theta_{\pm}| = O(1)\delta e^{-\frac{c_1 x^2}{1+t}} \quad \text{as } |x| \to \infty,$$
 (2.11)

where  $c_1$  is positive constant depending only on  $\theta_{\pm}$ . Once  $\Theta$  is determined, the contact wave profile  $(V, U, \Theta)(x, t)$  is then defined as follows:

$$V = \frac{R\Theta}{p_{+}}, \quad U = \frac{\kappa_{1}(\gamma - 1)\Theta_{x}}{\gamma R\Theta}, \quad \Theta = \Theta.$$
 (2.12)

The contact wave  $(V, U, \Theta)(x, t)$  solves the compressible Navier-Stokes system (1.1) time asymptotically, that is,

$$\begin{cases}
V_t - U_x = 0, \\
U_t + \left(\frac{R\Theta}{V}\right)_x = \mu\left(\frac{U_x}{V}\right)_x + R_1, \\
c_\nu \Theta_t + p(V, \Theta)U_x = \left(\kappa_1 \frac{\Theta_x}{V}\right)_x + \mu \frac{U_x^2}{V} + R_2,
\end{cases}$$
(2.13)

where

$$\widetilde{R}_1 = U_t - \mu \left(\frac{U_x}{V}\right)_x, \quad \widetilde{R}_2 = -\mu \frac{U_x^2}{V}.$$
 (2.14)

For the single viscous contact wave  $(V, U, \Theta)$  with arbitrary  $\gamma > 1$ , let the perturbation  $(\phi, \psi, \zeta)(x, t)$  by

$$(\phi, \psi, \zeta)(x, t) = (v - V, u - U, \theta - \Theta)(x, t). \tag{2.15}$$

Then our first main result is as follows:

### Theorem 2.1 (Viscous contact wave) Suppose that

$$\alpha = 0, \beta > 0.$$

For any given left end state  $(v_-, u_-, \theta_-)$ , suppose that the right end state  $(v_+, u_+, \theta_+)$  satisfies (2.8). Let  $(V, U, \Theta)$  be the viscous contact wave defined in (2.12) with strength  $\delta = |\theta_+ - \theta_-|$ . There exist a function  $m(\delta)$  satisfying  $m(\delta) \to +\infty$ , as  $\delta \to 0$  and a small constant  $\delta_0$  such that if  $\delta < \delta_0$  and the initial data satisfies

$$\begin{cases}
 v_0(x), \theta_0(x) \ge m_0^{-1}, & m_0 =: m(\delta_0), \\
 \|(v_0(x) - V(x, 0), u_0(x) - U(x, 0), \theta_0(x) - \Theta(x, 0))\|_{H^1(\mathbb{R})} \le m_0,
\end{cases}$$
(2.16)

then the Cauchy problem (1.1)-(1.4) admits a unique global solution  $(v, u, \theta)$  satisfying

$$(v - V, u - U, \theta - \Theta)(x, t) \in C((0, +\infty); H^1(\mathbb{R}));$$
$$(v - V)_x(x, t) \in L^2(0, +\infty; L^2(\mathbb{R}));$$
$$(u - U, \theta - \Theta)_x(x, t) \in L^2(0, +\infty; H^1(\mathbb{R})).$$

Furthermore,

$$\lim_{t \to +\infty} \sup_{x \in \mathbb{R}} |(v - V, u - U, \theta - \Theta)(x, t)| = 0.$$
(2.17)

**Remark 1** Theorem 1.1 can be regarded as a natural generalization of Huang-Wang's result([12]) where they considered the constant viscosity case ( $\alpha = \beta = 0$ ) to the degenerate and nonlinear one that  $\alpha = 0, \beta > 0$ . It is interesting to study the case that  $\alpha > 0, \beta > 0$ , which will be left for future.

When the relation (2.8) fails, the basic theory of hyperbolic systems of conservation laws implies that for any given constant state  $(v_-, u_-, \theta_-)$  with  $v_- > 0$ ,  $\theta_- > 0$  and  $u_- \in \mathbb{R}$ , there exists a suitable neighborhood  $\Omega(v_-, u_-, \theta_-)$  of  $(v_-, u_-, \theta_-)$  such that for any  $(v_+, u_+, \theta_+) \in \Omega(v_-, u_-, \theta_-)$ , the Riemann problem of the Euler system (2.5), (2.6) has a unique solution. In this paper, we only consider the stability of the superposition of the viscous contact wave and rarefaction waves. In this situation, we assume that

$$(v_+, u_+, \theta_+) \in R_1 C R_3(v_-, u_-, \theta_-) \subset \Omega(v_-, u_-, \theta_-), \tag{2.18}$$

where

$$u \ge u_{-} - \int_{v_{-}}^{e^{\frac{\gamma-1}{R\gamma}(s_{-}-s)}v} \lambda_{-}(\eta, s_{-})d\eta, u \ge u_{-} - \int_{e^{\frac{\gamma-1}{R\gamma}(s_{-}-s)}v_{-}}^{v} \lambda_{+}(\eta, s)d\eta \right\},$$

$$s = \frac{R}{\gamma - 1} \ln \frac{R\theta}{A} + R \ln v,$$

$$s_{\pm} = \frac{R}{\gamma - 1} \ln \frac{R\theta_{\pm}}{A} + R \ln v_{\pm},$$

$$\lambda_{\pm}(v,s) = \pm (A\gamma v^{-\gamma - 1} e^{\frac{\gamma - 1}{R}s})^{1/2},$$

and

$$R_1CR_3(v_-,u_-,\theta_-) \triangleq \left\{ (v,u,\theta) \in \Omega(v_-,u_-,\theta_-) \middle| s \neq s_-. \right.$$

By the standard argument, there exists a unique pair of points  $(v_-^m, u^m, \theta_-^m)$  and  $(v_+^m, u^m, \theta_+^m)$  in  $\Omega(v_-, u_-, \theta_-)$  satisfying

$$\frac{R\theta_-^m}{v_-^m} = \frac{R\theta_+^m}{v_\perp^m} \triangleq p^m,$$

such that the points  $(v_-^m, u^m, \theta_-^m)$  and  $(v_+^m, u^m, \theta_+^m)$  belong to the 1-rarefaction wave curve  $R_-(v_-, u_-, \theta_-)$  and the 3-rarefaction wave curve  $R_+(v_+, u_+, \theta_+)$ , respectively, where

$$R_{\pm}(v_{\pm}, u_{\pm}, \theta_{\pm}) = \left\{ (v, u, \theta) \in \Omega(v_{-}, u_{-}, \theta_{-}) \middle| s = s_{\pm}, u = u_{\pm} - \int_{v_{\pm}}^{v} \lambda_{\pm}(\eta, s_{\pm}) d\eta, v > v_{\pm} \right\}.$$

We assume  $u^m=0$  in what follows without loss of generality. The 1-rarefaction wave  $(v_-^r, u_-^r, \theta_-^r)(\frac{x}{t})$  (respectively the 3-rarefaction wave  $(v_+^r, u_+^r, \theta_+^r)(\frac{x}{t})$ ) connecting  $(v_-, u_-, \theta_-)$  and  $(v_-^m, 0, \theta_-^m)$  (respectively  $(v_+^m, 0, \theta_+^m)$  and  $(v_+, u_+, \theta_+)$ ) is the weak solution of the Riemann problem of the Euler system (2.5) with the following initial Riemann data

$$(v_{\pm}, u_{\pm}, \theta_{\pm})(x, 0) = \begin{cases} (v_{\pm}^{m}, 0, \theta_{\pm}^{m}), & \pm x < 0, \\ (v_{+}, u_{+}, \theta_{+}), & \pm x > 0. \end{cases}$$
 (2.19)

Since the rarefaction wave  $(v_{\pm}^r, u_{\pm}^r, \theta_{\pm}^r)$  are not smooth enough solutions, it is convenient to construct approximate rarefaction wave which is smooth. Motivated by [27], the smooth solutions of Euler system (2.5),  $(V_{\pm}^r, U_{\pm}^r, \Theta_{\pm}^r)$ , which approximate  $(v_{\pm}^r, u_{\pm}^r, \theta_{\pm}^r)$ , are given by

$$\begin{cases}
\lambda_{\pm}(V_{\pm}^{r}(x,t), s_{\pm}) = w_{\pm}(x,t), \\
U_{\pm}^{r} = u_{\pm} - \int_{v_{\pm}}^{V_{\pm}^{r}(x,t)} \lambda_{\pm}(\eta, s_{\pm}) d\eta, \\
\Theta_{\pm}^{r} = \theta_{\pm}(v_{\pm})^{\gamma-1} (V_{\pm}^{r})^{1-\gamma},
\end{cases} (2.20)$$

where  $w_{-}$  (respectively  $w_{+}$ ) is the solution of the initial problem for the typical Burgers equation:

$$\begin{cases} w_t + ww_x = 0, & (x,t) \in \mathbb{R} \times (0,\infty), \\ w(x,0) = \frac{w_r + w_l}{2} + \frac{w_r - w_l}{2} \tanh x, \end{cases}$$
 (2.21)

with  $w_l = \lambda_-(v_-, s_-)$ ,  $w_r = \lambda_-(v_-^m, s_-)$  (respectively  $w_l = \lambda_+(v_+^m, s_+)$ ,  $w_r = \lambda_+(v_+, s_+)$ ).

Let  $(V^{cd}, U^{cd}, \Theta^{cd})(x, t)$  be the viscous contact wave constructed in (2.10) and (2.12) with  $(v_{\pm}, u_{\pm}, \theta_{\pm})$  replaced by  $(v_{\pm}^{m}, 0, \theta_{\pm}^{m})$ , respectively.

For subsequent use, we define the strengths of the viscous contact wave and rarefaction waves as follow:

$$\delta^{r_1} = |v_-^m - v_-| + |0 - u_-| + |\theta_-^m - \theta_-|,$$

$$\delta^{cd} = |\theta_+^m - \theta_-^m|,$$

$$\delta^{r_3} = |v_+^m - v_+| + |0 - u_+| + |\theta_+^m - \theta_+|$$

and  $\delta = \min(\delta^{r_1}, \delta^{cd}, \delta^{r_3})$ . If

$$\delta^{r_1} + \delta^{cd} + \delta^{r_3} \le C\delta$$
, as  $\delta^{r_1} + \delta^{cd} + \delta^{r_3} \to 0$  (2.22)

holds for a positive constant C, we call the strengths of the wave patterns "small with the same order". In this case, we have

$$\delta^{r_1} + \delta^{cd} + \delta^{r_3} \le C|(v_+ - v_-, u_+ - u_-, \theta_+ - \theta_-)|. \tag{2.23}$$

Henceforth, we assume (2.22) holds throughout. We define

$$\begin{pmatrix} V \\ U \\ \Theta \end{pmatrix} (x,t) = \begin{pmatrix} V^{cd} + V_{-}^{r} + V_{+}^{r} \\ U^{cd} + U_{-}^{r} + U_{+}^{r} \\ \Theta^{cd} + \Theta^{r}_{-} + \Theta^{r}_{+} \end{pmatrix} (x,t) - \begin{pmatrix} v_{-}^{m} + v_{+}^{m} \\ 0 \\ \theta_{-}^{m} + \theta_{+}^{m} \end{pmatrix}, \tag{2.24}$$

and

$$(\phi, \psi, \zeta)(x, t) = (v - V, u - U, \theta - \Theta)(x, t).$$

Then our second main result is as follows:

#### Theorem 2.2 (Composite waves) Suppose that

$$\alpha = 0, \beta > 0.$$

For any given left end state  $(v_-, u_-, \theta_-)$ , let  $(V, U, \Theta)$  be defined in (2.24) with strength satisfying (2.22). Then there exists a function  $m(\delta)$  satisfying  $m(\delta) \to +\infty$ , as  $\delta \to 0$  and a small constant  $\delta_0$ , such that if  $|(v_+ - v_-, u_+ - u_-, \theta_+ - \theta_-)| < \delta_0$  and the initial data satisfies

$$\begin{cases}
 v_0(x), \theta_0(x) \ge m_0^{-1}, & m_0 =: m(\delta_0), \\
 \|(v_0(x) - V(x, 0), u_0(x) - U(x, 0), \theta_0(x) - \Theta(x, 0))\|_{H^1(\mathbb{R})} \le m_0,
\end{cases}$$
(2.25)

then the Cauchy problem (1.1)-(1.4) admits a unique global solution  $(v, u, \theta)$  satisfying

$$(v - V, u - U, \theta - \Theta)(x, t) \in C((0, +\infty); H^1(\mathbb{R}));$$
$$(v - V)_x(x, t) \in L^2(0, +\infty; L^2(\mathbb{R}));$$

$$(u - U, \theta - \Theta)_x(x, t) \in L^2(0, +\infty; H^1(\mathbb{R})),$$

and

$$\lim_{t \to +\infty} \sup_{x \in \mathbb{R}} |(v - V, u - U, \theta - \Theta)(x, t)| = 0, \tag{2.26}$$

where the  $(v_-^r, u_-^r, \theta_-^r)(x, t)$  and  $(v_+^r, u_+^r, \theta_+^r)(x, t)$  are the 1-rarefaction and 3-rarefaction waves uniquely determined by (2.5), (2.19), respectively.

Remark 2 By (iv) of Lemma 3.5, Theorem 2.2 implies

$$\lim_{t \to +\infty} \sup_{x \in \mathbb{R}} \left( \begin{array}{c} |(v - v_-^r - V^{cd} - v_+^r + v_-^m + v_+^m)(x,t)| \\ |(u - U^{cd} - u_-^r - u_+^r)(x,t)| \\ |(\theta - \theta_-^r - \Theta^{cd} - \theta_+^r + \theta_-^m + \theta_+^m)(x,t)| \end{array} \right) = 0.$$

We now explain the main analysis of this paper. Compared with the constant viscosity case  $(\alpha = \beta = 0)([12])$ , the main difficulty comes from the degeneracy and nonlinearity of the heat conductivity due to the fact that  $\beta > 0$ . To overcome this difficulty, we utilize the structure of wave patterns to essentially control the terms involving the derivative of perturbation around the wave patterns. Firstly, we make some slight modifications to the ideas in [24, 17] to get the time-independent lower and upper bounds of v, provided the strengths of the waves are suitably small. Next, combining the uniform bound of v, the basic energy estimate(see (4.4)) and cut-off techniques, we are just motivated by [24] to consider the cases  $\beta \in (0,1)$  and  $\beta \in (1,+\infty)$  separately. This approach yields the key issue of  $\psi_x$  and  $\theta^{1/2}\zeta_x$  on the  $L^2(\mathbb{R}\times(0,T))$ -norm (see (4.41) and (4.79)). Then, we modify some ideas of [24, 12] to obtain the estimates on the  $L^2(\mathbb{R}\times(0,T))$ -norm of  $\zeta_x, \phi_x$  and  $\psi_{xx}^2$  with suitably small  $\delta_0$  (see lemma 4.7). Finally, to resolve the difficulty arising from cross term, we observe the simple but crucial fact (see (4.117))

$$\int \left(\frac{\theta^{\beta} \zeta_x}{v}\right)_x \theta^{\beta} \zeta_t dx = \int \left(\frac{\theta^{\beta} \zeta_x}{v}\right) \left((\theta^{\beta} \zeta_x)_t + \beta \theta^{\beta - 1} (\zeta_t \Theta_x - \zeta_x \Theta_t)\right) dx,$$

which combined with (4.115)-(4.123), (4.4), (4.90) and the Gronwall's inequality leads to the  $L^{\infty}(0, T; L^{2}(\mathbb{R}))$ norm of  $\theta^{\beta}\zeta_{x}$ . With these weighted estimates on the perturbation around the wave patterns at hand, we
derive the upper and lower bounds of  $\theta$ . These are the key to the proof, and the whole procedure will be
carried out in the next section.

This paper is organized as follows. In the next section, we collect some useful lemmas and fundamental facts concerning the viscous contact wave as well as rarefaction waves. The main proof of Theorem 2.1 and 2.2 are completed in Section 4 and Section 5, respectively.

## 3 Preliminaries

In this section, we first consider a lemma for the properties of the viscous contact wave  $(V, U, \Theta)$  defined by (2.12) are useful in the following sections.

**Lemma 3.1** (lemma2.1 in [12]) Assume that  $\delta = |\theta_+ - \theta_-| \le \delta_0$  for a small positive constant  $\delta_0$ . Then the viscous contact wave  $(V, U, \Theta)$  has the following properties:

The next two lemmas play important roles to obtain the basic energy estimate.

**Lemma 3.2** (Lemma 1 in [8]) For  $0 < T \le +\infty$ , suppose that h(x,t) satisfies

and  $\langle \cdot, \cdot \rangle$  denotes the dual product between  $H^{-1}$  and  $H^{1}$ .

**Lemma 3.3** (lemma 5 in[8]) For  $\alpha \in (0, \frac{c_1}{4}]$  and w defined by (3.3), there exists some positive constant C depending on  $\alpha$  such that the following estimate holds

$$\int_0^t \int (\phi^2 + \psi^2 + \zeta^2) w^2 dx ds \le C \left( 1 + \int_0^t \int (\phi_x^2 + \psi_x^2 + \zeta_x^2) dx ds \right). \tag{3.4}$$

Next, we brevity state the following properties of the solution to the problem (2.21), the proofs can be found in [27].

**Lemma 3.4** For given  $w_l \in \mathbb{R}$  and  $\bar{w} > 0$ , let  $w_r \in \{0 < \tilde{w} \triangleq w - w_l < \bar{w}\}$ . Then the problem (2.21) has a unique smooth global solution in time satisfying the following properties.

- (1)  $w_l < w(x,t) < w_r, w_x > 0 \ (x \in \mathbb{R}, t > 0).$

**Lemma 3.5** (lemma 2.5 in [12]) For any given left end state  $(v_-, u_-, \theta_-)$ , suppose that (2.18) and (2.22) hold. Then the smooth rarefaction waves  $(V_{\pm}^r, U_{\pm}^r, \Theta_{\pm}^r)$  constructed in (2.20) and the viscous contact wave  $(V^{cd}, U^{cd}, \Theta^{cd})$  constructed in (2.12) satisfying the following:

- (1)  $(U_+^r)_x \ge 0$ ,  $(x \in \mathbb{R}, t > 0)$ .
- (2) For  $p \in [1, \infty]$ , there exists a positive constant  $C = C(v_-, u_-, \theta_-, \delta)$  such that for  $\delta$  satisfying (2.22),

(4) For the rarefaction waves  $(v_{\pm}^r, u_{\pm}^r, \theta_{\pm}^r)(x/t)$  determined by (2.5) and (2.19), it holds that

$$\lim_{t\to +\infty} \sup_{x\in\mathbb{R}} \left| (V^r_\pm, U^r_\pm, \Theta^r_\pm,)(x,t) - (v^r_\pm, u^r_\pm, \theta^r_\pm,)(x/t) \right| = 0.$$

## 4 Proof of Theorem 2.1

For equations (2.13), we consider Cauchy problem (1.1) and (1.4) yields

For the solution  $(\phi, \psi, \zeta)$ , we define the solution space  $X([0, +\infty))$ ,

$$X([0,T]) = \left\{ (\phi, \psi, \zeta) \middle| v, \ \theta \ge M^{-1}, \quad \sup_{0 \le t \le T} \| (\phi, \psi, \zeta) \|_{H^1} \le M \right\}$$

for some  $0 < T \le +\infty$ , where the constants M will be determined later. Since the local existence of the solution is well known (see [10]), we can prove the global existence part of Theorem 2.1 by the following a priori estimates.

**Proposition 4.1** (A priori estimates) Assume that the conditions of Theorem 2.1 hold, then there exists a positive constant  $\delta_0$  such that if  $\delta < \delta_0$  and  $(\phi, \psi, \zeta) \in X([0, T])$ ,

$$\sup_{0 \le t \le T} \|(\phi, \psi, \zeta)(t)\|_{H^1}^2 + \int_0^T (\|\phi_x\|^2 + \|(\psi_x, \zeta_x)\|_{H^1}^2) ds \le C_0, \tag{4.2}$$

where  $C_0$  denotes a constant depending only on  $\tilde{\mu}$ ,  $\tilde{\kappa}$ , R,  $c_{\nu}$ ,  $v_{\pm}$ ,  $u_{\pm}$ ,  $\theta_{\pm}$  and  $m_0$ .

Once Proposition 4.1 is proved, we can extend the unique local solution  $(u, v, \theta)$  which can be obtained as in [10] to  $T = \infty$ . Estimate (4.2) and the equations (4.1) (respectively (5.1)) imply that

**Lemma 4.1** There exist some positive constant  $C_0$  and  $\delta_0$  such that if  $\delta < \delta_0$ , it holds that

+ C(M) \int_0^t \int (\phi^2 + \zeta^2) (U_x^2 + \Theta_x^2) dx ds.$$
(4.17)

By Lemma 3.3, (4.11) and choosing  $\delta$  suitable small, we have

$$\int \frac{\phi_x^2}{v^2} dx + \int_0^t \int \frac{\theta \phi_x^2}{v^3} dx ds \le C_0 + C(M) \int_0^t \int \left(\frac{\psi_x^2}{\theta v} + \frac{\theta^\beta \zeta_x^2}{\theta^2 v}\right) dx ds. \tag{4.18}$$

Putting (4.18) into (4.11) and choosing  $\delta$  suitable small, the proof of Lemma 4.1 is completed.

Lemma 4.1 utilizes the smallness of  $\delta$  to ensure that the basic energy (4.4) only depends on the initial data. Building upon the basic energy estimate, we shall establish uniform upper and lower bounds for both the specific volume v and the absolute temperature  $\theta$ . This determines the requisite smallness of the parameter  $\delta$ . That is why need the initial condition (2.16).

To obtain the uniform lower and upper bounds of the specific volume v(x,t), we present the following two lemmas, whose proofs can be found in [12](lemma 3.2) and [17](lemma2.3)

**Lemma 4.2** Let  $\alpha_1$ ,  $\alpha_2$  be the two positive roots of the equation  $y - \ln y - 1 = C_0$  and the constant  $C_0$  be the same in (4.4). Then

$$\alpha_1 \le \int_k^{k+1} \tilde{v}(x,t) dx, \quad \int_k^{k+1} \tilde{\theta}(x,t) dx \le \alpha_2, \quad t \ge 0, \tag{4.19}$$

and for each  $t \geq 0$  there are points  $a_k(t), b_k(t) \in [k, k+1]$  such that

$$\alpha_1 \le \tilde{v}(a_k(t), t), \tilde{\theta}(b_k(t), t) \le \alpha_2, \quad t \ge 0,$$

$$(4.20)$$

where  $\tilde{v} = \frac{v}{V}$ ,  $\tilde{\theta} = \frac{\theta}{\Theta}$ , and  $k = 0, \pm 1, \pm 2, \cdots$ .

**Lemma 4.3** For each  $x \in [k, k+1]$ ,  $k = 0, \pm 1, \pm 2, \cdots$ , it follows from  $(1.1)_2$  that

$$v(x,t) = B(x,t)Y(t) + \frac{R}{\tilde{\mu}} \int_0^t \frac{B(x,t)Y(t)}{B(x,s)Y(s)} \theta(x,s)ds, \tag{4.21}$$

where

$$B(x,t) = v_0(x) \exp\left(\frac{1}{\tilde{\mu}} \int_x^{+\infty} \left(u_0(y) - u(y,t)\right) D(y) dy\right),\tag{4.22}$$

$$Y(t) = \exp\left(\frac{1}{\tilde{\mu}} \int_0^t \int_{k+1}^{k+2} \sigma(y, s) dy ds\right), \tag{4.23}$$

$$\sigma(x,t) = \left(\tilde{\mu}\frac{u_x}{v} - R\frac{\theta}{v}\right)(x,t),\tag{4.24}$$

and

$$D(x) = \begin{cases} 1, & x \le k+1, \\ k+2-x, & k+1 \le x \le k+2, \\ 0, & x \ge k+2. \end{cases}$$
 (4.25)

By Cauchy's inequality and (4.4), we have

$$\underline{B}(C_0) \le B(x,t) \le \overline{B}(C_0), \quad \forall x \in [k,k+1], \quad t \ge 0, \tag{4.26}$$

where  $\underline{B}(C_0)$ ,  $\overline{B}(C_0)$  are two constants depending on  $C_0$ .

With lemma 4.2 and lemma 4.3 at hand, we are in a position to prove the time-independent upper and lower bounds of v.

**Lemma 4.4** There are two positive constants  $\underline{v}(C_0)$ ,  $\overline{v}(C_0)$  such that

$$\underline{v}(C_0) \le v(x,t) \le \bar{v}(C_0), \quad \forall x \in \mathbb{R}, \quad t \ge 0, \tag{4.27}$$

where  $\underline{v}(C_0)$ ,  $\overline{v}(C_0)$  depending on  $C_0$ , independent of x, t.

**Proof**: From now on, we always assume that  $\theta_- < \theta_+$  for convenient. So from the properties of viscous contact wave, we have  $\theta_- < \Theta(x,t) < \theta_+$  and  $v_- < V(x,t) < v_+$ .

It follows from Jensen's inequality, (4.19), (4.20) and choose  $\delta$  suitable small, we see that for  $t \geq s \geq 0$ ,

$$\begin{split} &-\int_{s}^{t}\int_{k+1}^{k+2}\frac{\theta}{v}dxd\tau \leq -C\int_{s}^{t}\int_{k+1}^{k+2}\frac{\tilde{\theta}}{\tilde{v}}dxd\tau \\ &\leq C\int_{s}^{t}\int_{k+1}^{k+2}\left(\left(-\tilde{\theta}+\tilde{\theta}(b_{k}(t),t)\right)_{+}-\tilde{\theta}(b_{k}(t),t)\right)\frac{1}{\tilde{v}}dxd\tau \\ &\leq C\int_{s}^{t}\left(\max_{x\in[k+1,k+2]}(\tilde{\theta}^{\beta/2}(b_{k}(t),t)-\tilde{\theta}^{\beta/2})_{+}-\tilde{\theta}(b_{k}(t),t)\right)\left(\int_{k+1}^{k+2}\tilde{v}dx\right)^{-1}d\tau \\ &\leq C\int_{s}^{t}\left(\int_{k+1}^{k+2}\tilde{\theta}^{\beta/2-1}|\tilde{\theta}_{x}|dx-2C^{-1}\right)d\tau \\ &\leq C\int_{s}^{t}\left(\int_{k+1}^{k+2}\left(\frac{\theta^{\beta/2-1}\zeta_{x}}{\Theta^{\beta/2}}-\frac{\theta^{\beta/2-1}\Theta_{x}\zeta}{\Theta^{\beta/2+1}}\right)dx-2C^{-1}\right)d\tau \\ &\leq C\int_{s}^{t}\left(\left(\int_{k+1}^{k+2}\frac{\theta^{\beta}\zeta_{x}^{2}}{v\theta^{2}}+\frac{\theta^{\beta}\Theta_{x}^{2}\zeta^{2}}{\theta^{2}\Theta^{2}v}dx\right)^{1/2}\left(\int_{k+1}^{k+2}\frac{v}{\Theta^{\beta}}dx\right)^{1/2}-2C^{-1}\right)d\tau \\ &\leq C\int_{s}^{t}\left(C(\varepsilon)\int_{k+1}^{k+2}\frac{\theta^{\beta}\zeta_{x}^{2}}{v\theta^{2}}+\frac{\theta^{\beta}\Theta_{x}^{2}\zeta^{2}}{\theta^{2}\Theta^{2}v}dx+C\varepsilon(v_{+}\alpha_{2})-2C^{-1}\right)d\tau \\ &\leq C+C(M)\int_{s}^{t}\int_{k+1}^{k+2}\zeta^{2}\Theta_{x}^{2}dxd\tau-\frac{t-s}{C_{0}}\\ &\leq C_{0}-\frac{t-s}{C_{0}}. \end{split}$$

Integrating (4.24) over  $(k+1, k+2) \times (s, t)$  gives

$$\int_{s}^{t} \int_{k+1}^{k+2} \sigma(x,\tau) dx d\tau = \int_{s}^{t} \int_{k+1}^{k+2} \left( \tilde{\mu} \frac{\psi_{x}}{v} - R \frac{\theta}{v} + \tilde{\mu} \frac{U_{x}}{v} \right) (x,\tau) dx d\tau 
\leq C \int_{s}^{t} \int_{k+1}^{k+2} \frac{\psi_{x}^{2}}{\theta v} dx d\tau - \frac{R}{2} \int_{s}^{t} \int_{k+1}^{k+2} \frac{\theta}{v} dx d\tau + \tilde{\mu} \int_{s}^{t} \int_{k+1}^{k+2} \frac{U_{x}}{v} dx d\tau 
\leq C - \frac{R}{2} \int_{s}^{t} \int_{k+1}^{k+2} \frac{\theta}{v} dx d\tau + C(M) \int_{s}^{t} \int_{k+1}^{k+2} |U_{x}| dx d\tau 
\leq C + \frac{R}{2} (C_{0} - \frac{t-s}{C_{0}}) + C(M) \delta 
\leq C_{0} - \frac{t-s}{C_{0}}, \tag{4.29}$$

where in the third inequality we have used (4.28). Combining (4.29) and the definition of Y(t) gives

$$0 \le Y(t) \le C_0 e^{-t/C_0}, \quad \frac{Y(t)}{Y(s)} \le C_0 e^{-(t-s)/C_0}, \tag{4.30}$$

which together with (4.21) and (4.26) gives

$$v(x,t) \le C_0 e^{-(t-s)/C_0} + C_0 \int_0^t \theta(x,s) e^{-(t-s)/C_0} ds.$$
(4.31)

Then, it follows from (4.4) yields

$$\begin{split} |\tilde{\theta}^{\frac{1}{2}}(x,t) - \tilde{\theta}^{\frac{1}{2}}(b_{k}(t),t)| &\leq C|\tilde{\theta}^{\frac{\beta+1}{2}}(x,t) - \tilde{\theta}^{\frac{\beta+1}{2}}(b_{k}(t),t)| \leq \int_{k}^{k+1} \tilde{\theta}^{\frac{\beta-1}{2}}|\tilde{\theta}_{x}| dx \\ &\leq \int_{k}^{k+1} \left(\frac{\theta}{\Theta}\right)^{\frac{\beta-1}{2}} \left(\left|\frac{\zeta_{x}}{\Theta}\right| + \left|\frac{\zeta\Theta_{x}}{\Theta^{2}}\right|\right) dx \\ &\leq C\left(\int_{k}^{k+1} \frac{\theta^{\beta}\zeta_{x}^{2}}{\theta^{2}v} dx\right)^{\frac{1}{2}} \left(\int_{k}^{k+1} \frac{\theta v}{\Theta^{\beta+1}} dx\right)^{\frac{1}{2}} + C(M) \left(\int_{k}^{k+1} \zeta^{2}\Theta_{x}^{2} dx\right)^{\frac{1}{2}} \\ &\leq C\left(\int_{k}^{k+1} \frac{\theta^{\beta}\zeta_{x}^{2}}{\theta^{2}v} dx\right)^{\frac{1}{2}} \left(\int_{k}^{k+1} \theta dx\right)^{\frac{1}{2}} \max_{x \in [k,k+1]} v^{\frac{1}{2}}(\cdot,t) + C(M) \left(\int_{k}^{k+1} \zeta^{2}\Theta_{x}^{2} dx\right)^{\frac{1}{2}} \\ &\leq CV^{\frac{1}{2}}(t) \max_{x \in [k,k+1]} v^{\frac{1}{2}}(\cdot,t) + C(M) \left(\int_{k}^{2} \zeta^{2}\Theta_{x}^{2} dx\right)^{\frac{1}{2}} \end{split} \tag{4.32}$$

for  $x \in [k, k+1], k = 0, \pm 1, \pm 2, \cdots$ , which along with (4.20) leads to

$$\frac{\alpha_1}{8} - CV(t) \max_{x \in \mathbb{R}} v(\cdot, t) - C(M) \int_{\mathbb{R}} \zeta^2 \Theta_x^2 dx \le \theta(x, t) 
\le C_0 + CV(t) \max_{x \in \mathbb{R}} v(\cdot, t) + C(M) \int_{\mathbb{R}} \zeta^2 \Theta_x^2 dx, \tag{4.33}$$

for any  $x \in \mathbb{R}$ . Putting this into (4.31) and applying Gronwall's inequality and (4.4) shows that for any  $t \in [0, +\infty)$ ,

$$v(x,t) \le C_0. \tag{4.34}$$

Then, integrating (4.21) in x over [k, k+1], we obtain after using (4.19) that

$$v_{-}\alpha_{1} \leq C_{0}e^{-t/C_{0}} + C_{0}\int_{0}^{t} \frac{Y(t)}{Y(s)} \int_{k}^{k+1} \theta(x,s)dxds$$

$$\leq C_{0}e^{-t/C_{0}} + C_{0}\int_{0}^{t} \frac{Y(t)}{Y(s)}ds,$$
(4.35)

which directly yields that

$$\int_{0}^{t} \frac{Y(t)}{Y(s)} ds \ge C_0 - C_0 e^{-t/C_0}.$$
(4.36)

From (4.4),(4.21),(4.33),(4.34) and (4.36), and choosing  $\delta$  suitable small, we have

$$v(x,t) \geq C_{0} \int_{0}^{t} \frac{Y(t)}{Y(s)} \theta(x,s) ds$$

$$\geq C_{0} \int_{0}^{t} \frac{Y(t)}{Y(s)} ds - C_{0} \int_{0}^{t} \frac{Y(t)}{Y(s)} V(s) dx ds - C(C_{0}, M) \int_{0}^{t} \int_{0}^{t} \zeta^{2} \Theta_{x}^{2} dx ds$$

$$\geq C_{0} - C_{1}(C_{0}) e^{-t/C_{0}} - C_{0} e^{-t/2C_{0}} \int_{0}^{t/2} V(s) dx ds - C_{0} \int_{t/2}^{t} V(s) dx ds$$

$$\geq C_{0}/2$$

$$(4.37)$$

for any  $x \in \mathbb{R}$ , provided  $t \geq T_0$ . Here  $C_1(C_0)$  is some positive constant depending on  $C_0$ , while  $T_0$ ,  $C_0$  are positive constants independent of t.

Finally, it follows from [20] that for any  $x \in [k, k+1], k = 0, \pm 1, \pm 2, \cdots$ ,

$$v(x,t) = \frac{1}{\widetilde{Y}(t)\widetilde{B}(x,t)} \left( v_0(x) + \frac{R}{\widetilde{\mu}} \int_0^t \widetilde{Y}(s)\widetilde{B}(x,s)\theta(x,s)ds \right), \tag{4.38}$$

where

$$\widetilde{Y}(t) = \frac{v_0(a_k(t))}{v(a_k(t), t)} \exp\left(\frac{R}{\widetilde{\mu}} \int_0^t \frac{\theta}{v}(a_k(t), s) ds\right)$$

and

$$\widetilde{B}(x,t) = \exp\left(\frac{1}{\widetilde{\mu}} \int_{a_k(t)}^x \left(u_0(y) - u(y,t)\right) dy\right)$$

with  $a_k(t)$  is the same as in (4.20). It follows from (4.38) that

$$\widetilde{Y}(t)v(x,t) = \frac{1}{\widetilde{B}(x,t)} \left( v_0(x) + \frac{R}{\widetilde{\mu}} \int_0^t \widetilde{Y}(s)\widetilde{B}(x,s)\theta(x,s)ds \right). \tag{4.39}$$

Integrating (4.39) over [k, k+1] with respect to x, we obtain

$$\alpha_1 v_{-} \widetilde{Y}(t) \le C_0 + C_0 \int_0^t \widetilde{Y}(s) ds, \tag{4.40}$$

which together with the Gronwall's inequality shows that

$$\widetilde{Y}(t) < C(C_0, T).$$

From (4.38), one has

$$v(x,t) \ge \frac{v_0(x)}{\widetilde{Y}(t)\widetilde{B}(x,t)} \ge C(C_0,T), \quad \forall x \in \mathbb{R}.$$

which together with (4.37) and (4.34), completes the proof of Lemma 4.4.

To obtain the uniform bound of  $\theta$  from below and above with respect to space and time, motivated by [22] and [24], we state the following two lemmas which show the  $L^2$ -norm (in both space and time) bound of  $\psi_x$  and  $\theta^{-1/2}/\zeta_x$ .

**Lemma 4.5** For  $\beta \in (0,1)$ , there exists some positive constants  $C_0$  such that for any given T > 0,

$$\sup_{0 \le t \le T} \int (\zeta^2 + \psi^4) dx + \int_0^T \int ((1 + \theta + \psi^2)\psi_x^2 + (\theta^{-1} + \theta^\beta)\zeta_x^2) dx dt \le C_0.$$
 (4.41)

**Proof**: First, for  $t \ge 0$ , and a > 1, denoting

$$\Omega_a(t) \triangleq \left\{ x \in \mathbb{R} \middle| \frac{\theta}{\Theta}(x, t) > a \right\} = \left\{ x \in \mathbb{R} \middle| \zeta(x, t) > (a - 1)\Theta(x, t) \right\}. \tag{4.42}$$

We derive from (4.4) that  $\Omega_a$  is bounded since

$$a|\Omega_a| < \sup_{0 \le t \le T} \int_{\Omega_a} \frac{\theta}{\Theta} dx \le C(a) \sup_{0 \le t \le T} \int \Phi\left(\frac{\theta}{\Theta}\right) dx \le C(a, C_0), \tag{4.43}$$

and that

$$\sup_{0 \le t \le T} \left( \left| \left( \frac{\theta}{\Theta} > a \right)(t) \right| + \left| \left( \frac{\theta}{\Theta} < a^{-1} \right)(t) \right| \right) \le C(a, C_0). \tag{4.44}$$

Next, we divide this proof into three steeps.

Step 1. Multiplying  $(4.1)_3$  by  $(\zeta - \Theta)_+ = \max\{\zeta - \Theta, 0\}$ , then integrating the resulted equation over  $\mathbb{R} \times [0, t]$ , one has

$$\begin{split} &\frac{c_{\nu}}{2}\int(\zeta-\Theta)_{+}^{2}dx+\tilde{\kappa}\int_{0}^{t}\int_{\Omega_{2}}\frac{\theta^{\beta}\zeta_{x}^{2}}{v}dxds=\frac{c_{\nu}}{2}\int(\zeta_{0}(x)-\Theta(x,0))_{+}^{2}dx\\ &-\int_{0}^{t}\int\frac{R\zeta+R\Theta}{v}\psi_{x}(\zeta-\Theta)_{+}dxds-\int_{0}^{t}\int\frac{R\zeta-p_{+}\phi}{v}U_{x}(\zeta-\Theta)_{+}dxds\\ &+\tilde{\kappa}\int_{0}^{t}\int_{\Omega_{2}}\frac{\Theta^{\beta}\zeta_{x}\Theta_{x}}{V}dxds-\tilde{\kappa}\int_{0}^{t}\int_{\Omega_{2}}\frac{(\Theta^{\beta}v-\theta^{\beta}V)\Theta_{x}^{2}}{vV}dxds+\tilde{\mu}\int_{0}^{t}\int\frac{\psi_{x}^{2}}{v}(\zeta-\Theta)_{+}dxds\\ &+2\tilde{\mu}\int_{0}^{t}\int\frac{\psi_{x}U_{x}}{v}(\zeta-\Theta)_{+}dxds-\tilde{\mu}\int_{0}^{t}\int\frac{\phi U_{x}^{2}}{vV}(\zeta-\Theta)_{+}dxds\\ &-\int_{0}^{t}\int\widetilde{R}_{2}(\zeta-\Theta)_{+}dxds-c_{\nu}\int_{0}^{t}\int\partial_{t}\Theta(\zeta-\Theta)_{+}dxds. \end{split} \tag{4.45}$$

To estimate the right hand side of (4.45), We multiply (4.1)<sub>2</sub> by  $2\psi(\zeta-\Theta)_+$ , and integrate the resulting equation over  $\mathbb{R} \times [0,t]$  to get

$$\begin{split} &\int \psi^2(\zeta-\Theta)_+ dx + 2\tilde{\mu} \int_0^t \int \frac{\psi_x^2}{v} (\zeta-\Theta)_+ dx ds = \int \psi_0^2(x) (\zeta_0(x)-\Theta(x,0))_+ dx \\ &+ 2\int_0^t \int \frac{R\zeta-p_+\phi}{v} \psi_x (\zeta-\Theta)_+ dx ds + 2\int_0^t \int_{\Omega_2} \frac{R\zeta-p_+\phi}{v} \psi \zeta_x dx ds \\ &- 2\int_0^t \int_{\Omega_2} \frac{R\zeta-p_+\phi}{v} \psi \Theta_x dx ds + 2\tilde{\mu} \int_0^t \int \frac{\phi U_x}{vV} \psi_x (\zeta-\Theta)_+ dx ds \\ &- 2\tilde{\mu} \int_0^t \int_{\Omega_2} \frac{\psi \psi_x \zeta_x}{v} dx ds + 2\tilde{\mu} \int_0^t \int_{\Omega_2} \frac{\phi \psi U_x}{vV} \zeta_x dx ds \\ &+ 2\tilde{\mu} \int_0^t \int_{\Omega_2} \frac{\psi \psi_x \Theta_x}{v} dx ds - 2\tilde{\mu} \int_0^t \int_{\Omega_2} \frac{\phi \psi}{vV} U_x \Theta_x dx ds \\ &- 2\int_0^t \int \psi \tilde{R}_1(\zeta-\Theta)_+ dx ds + \int_0^t \int_{\Omega_2} \psi^2 \partial_t \zeta dx ds - \int_0^t \int_{\Omega_2} \psi^2 \partial_t \Theta dx ds. \end{split} \tag{4.46}$$

Adding (4.46) into (4.45), we obtain after using  $(4.1)_3$  that

$$\begin{split} \frac{1}{b+2} \int \psi^{b+2} dx + (b+1) \widetilde{\mu} \int_0^t \int \frac{|\psi|^b \psi_x^2}{v} dx ds &= \frac{1}{b+2} \int \psi_0^{b+2} dx + (b+1) R \int_0^t \int \frac{\zeta |\psi|^b \psi_x}{v} dx ds \\ &- (b+1)) p_+ \int_0^t \int \frac{\phi |\psi|^b \psi_x}{v} dx ds + (b+1) \widetilde{\mu} \int_0^t \int \frac{\phi U_x}{vV} |\psi|^b \psi_x dx ds - \int_0^t \int \widetilde{R}_1 |\psi|^b \psi dx ds \\ &\leq C + C \int_0^t \int \left( \frac{|\zeta|}{v} \mathbf{1}_{(\zeta < 3\Theta)} + \frac{|\phi|}{v} \right) |\psi|^b |\psi_x| dx ds + C \int_0^t \int_{\Omega_3} \frac{\zeta}{v} |\psi|^b |\psi_x| dx ds \\ &+ C \int_0^t \int \frac{\phi U_x}{vV} |\psi|^b \psi_x dx ds - \int_0^t \int \widetilde{R}_1 |\psi|^b \psi dx ds \end{split}$$

$$\leq \frac{1}{2} \int_{0}^{t} \int \left| (\theta^{\beta} \zeta_{x})_{x} \right|^{2} dx ds + C \int_{0}^{t} \max_{x \in \mathbb{R}} (\theta^{\beta} \zeta_{x})^{2} ds + C.$$

$$(4.137)$$

We get by (4.113) that

$$\int_{0}^{t} \max_{x \in \mathbb{R}} (\theta^{\beta} \zeta_{x})^{2} ds \leq \int_{0}^{t} \max_{x \in \mathbb{R}} \left( -2 \int_{x}^{\infty} (\theta^{\beta} \zeta_{x}) (y) (\theta^{\beta} \zeta_{x})_{x} (y) dy \right) ds 
\leq C \int_{0}^{t} (\|\theta^{\beta} \zeta_{x}\|_{L^{2}} \|(\theta^{\beta} \zeta_{x})_{x}\|_{L^{2}}) ds 
\leq C(\varepsilon) \int_{0}^{t} \int (\theta^{\beta} \zeta_{x})^{2} dx ds + \varepsilon \int_{0}^{t} \int |(\theta^{\beta} \zeta_{x})_{x}|^{2} dx ds,$$

which together with (4.137), (4.113) and (4.97) implies

## 5 Proof of Theorem 2.2

It is sufficient to show the same a priori estimate as Proposition 4.1. Noticing that  $(V_{\pm}^r, U_{\pm}^r, \Theta_{\pm}^r)$  satisfies Euler system (2.5) and  $(V^{cd}, U^{cd}, \Theta^{cd})$  satisfies (1.1)<sub>1</sub> (2.9), we rewrite the Cauchy problem (1.1)(1.4) as

where

and

Like Lemma 4.1, we have the following key estimate.

**Lemma 5.1** For  $(\phi, \psi, \zeta) \in X([0,T])$ , we assume (2.22) holds, then there exist some positive constants  $C_0$  and  $\delta_0$  such that if  $\delta < \delta_0$ , it follows that for  $t \in [0,T]$ ,

Thus we can finish the proof of Lemma 5.1 in the similar way as in Lemma 4.1.

It is straightforward to verify that the estimates for a single viscous contact wave remain valid for composite waves combining viscous contact waves with rarefaction waves. Thus, the proof of Proposition 4.1 is completed, and Theorem 2.2 is consequently finished.
