# MobileFineTuner: A Unified End-to-End Framework for Fine-Tuning LLMs on Mobile Phones

#### Abstract

Mobile phones are the most ubiquitous end devices, generating vast amounts of human-authored data and serving as the primary platform for end-side applications. As highquality public data for large language models (LLMs) approaches exhaustion, on-device fine-tuning provides an opportunity to leverage private user data while preserving privacy. However, existing approaches are predominantly simulation-based or rely on IoT devices and PCs, leaving commodity mobile phones largely unexplored. A key gap is the absence of an open-source framework that enables practical LLM fine-tuning on mobile phones. We present MobileFine-Tuner, a unified open-source framework that enables end-toend LLM fine-tuning directly on commodity mobile phones. MobileFineTuner is designed for efficiency, scalability, and usability, supporting full-parameters fine-tuning (Full-FT) and parameter-efficient fine-tuning (PEFT). To address the memory and energy limitations inherent to mobile phones, we introduce system-level optimizations including parameter sharding, gradient accumulation, and energy-aware computation scheduling. We demonstrate the practicality of MobileFineTuner by fine-tuning GPT-2, Gemma 3, and Qwen 2.5 on real mobile phones. Extensive experiments and ablation studies validate the effectiveness of the proposed optimizations and establish MobileFineTuner as a viable foundation for future research on on-device LLM training.

#### 1 Introduction

Large language models (LLMs), such as GPT [20], LLama [30] and Gemma [10], have achieved remarkable success by training on massive public datasets. Nevertheless, recent analyses suggest a growing concern that the supply of high-quality human-generated public data may be exhausted between 2026 and 2032 [32]. Early signs of this scarcity are already apparent: rather than actively collecting or generating new data, an increasing number of studies rely on repackaging existing datasets [35] or on synthetic corpora generated by LLMs themselves [36]. This trend highlights a looming bottleneck for LLM development, as scaling laws indicate that model performance continues to improve with access to larger and higher-quality training data [14], which synthetic data may not fully replace.

Meanwhile, enormous amounts of valuable private-domain data reside on end devices, especially on the billions of mobile phones that people use in daily life [1]. This data - such as personal communication logs, notes, and app interactions - is highly relevant for personalization and downstream adaptation of LLMs [17]. However, transmitting such sensitive data directly to a central server for fine-tuning raises severe privacy concerns [12]. Such practices may conflict with data protection regulations such as the General Data Protection Regulation (GDPR) [7] and often contradict user expectations, particularly in domains such as finance [39] and healthcare [29].

To leverage private data while preserving privacy, recent work has explored on-device federated LLM fine-tuning [16, 42] and personalized LLM fine-tuning [24, 33]. These approaches ensure that data remains on end devices during training [9]. However, existing implementations are mostly simulation-based, or they run on Internet-of-Things (IoT) devices such as NVIDIA developer boards, or on personal

computers (PCs). In contrast, commodity mobile phones, which generate vast amounts of human-authored data, are rarely used as practical platforms for LLM fine-tuning.

From a systems perspective, the main obstacle to enabling LLM fine-tuning on mobile phones is the lack of a framework that supports flexible and scalable training in mobile environments. Popular LLM fine-tuning frameworks—such as PyTorch or Hugging Face Transformers—rely heavily on Python and native Linux/Windows runtimes [21, 38], making them incompatible with mobile operating systems. Moreover, Mobile phones, in contrast, do not natively support Python [23], which prevents these mature LLM fine-tuning frameworks from being used on mobile devices, creating a critical gap in the infrastructure necessary for on-device LLM fine-tuning.

To bridge this gap, we present **MobileFineTuner**, a unified open-source framework that enables practical LLM finetuning directly on commodity mobile phones. MobileFine-Tuner provides an end-to-end system that supports experimentation with both algorithmic innovations and systems-level challenges in on-device LLM training. MobilefineTuner is designed around three key properties: **efficiency**, **scalability**, and **usability**.

Efficiency. MobileFineTuner is developed entirely in C++ with a modular operator design that implements automatic differentiation and full backpropagation natively on mobile hardware. By avoiding Python runtimes, virtual machines (VM), and external ML frameworks, the system achieves substantially lower runtime and memory overhead, enabling practical LLM fine-tuning under the tight resource constraints of mobile phones.

Scalability. MobileFineTuner supports multiple mainstream LLM architectures and can be easily extended to new models or downstream tasks through its modular operator interface. The system enables both full-parameter fine-tuning (Full-FT) and parameter-efficient fine-tuning (PEFT, e.g., LoRA), and provides flexible interfaces for integrating custom training strategies such as federated fine-tuning. This design makes the framework scalable across model families, training algorithms, and deployment settings.

**Usability.** MobilefineTuner is distributed as a standalone package with simple high-level APIs that abstract away low-level operator management and system complexity. This design allows both researchers and developers to fine-tune LLMs on mobile phones with minimal integration effort, facilitating rapid prototyping and practical mobile AI application development.

While these properties make MobileFineTuner broadly applicable, enabling LLM fine-tuning on mobile devices requires addressing two fundamental hardware constraints: limited memory capacity and strict energy budgets. These constraints shape both the feasibility and performance

of on-device training and therefore motivate several systemlevel optimizations in MobileFineTuner.

**Memory optimization.** MobileFineTuner combines two complementary techniques to reduce peak RAM usage. First, it uses a ZeRO-inspired parameter sharding mechanism that offloads inactive parameters to disk. Second, it adopts gradient accumulation to divide large batches into micro-batches, enabling stable forward and backward computation under tight memory budgets.

**Energy optimization.** To handle mobile energy constraints, MobileFineTuner includes an energy-aware computation scheduler that adjusts computation frequency according to battery level, reducing power draw during sustained finetuning.

In summary, MobileFineTuner fills a critical gap in the current on-device LLM ecosystem by enabling practical, privacy-preserving, and resource-aware fine-tuning directly on commodity mobile devices. Our contributions are as follows:

- A unified framework for LLM fine-tuning on mobile phones. We develop MobileFineTuner, an open-source framework that enables practical end-to-end Full-FT and PEFT of mainstream LLMs on commodity mobile phones. We opensourse our framework at: https://github.com/AndyLu666/MobileFineTuner.
- System-level techniques for overcoming mobile memory and energy constraints. We design and integrate optimizations-including ZeRO-inspired parametern sharding, gradient accumulation, and an energy-aware computation scheduler-that make LLM finetuning feasible on mobile hardware.
- A comprehensive empirical study across models, devices and data tasks. We validate MobilefineTuner through extensive experiments and ablations, demonstrating its effectiveness and performing ablations to quantify the impact of the proposed memory and energy optimizations.




Figure 1: MobileFineTuner overview.

**Roadmap:** The roadmap of this paper is shown in Fig.1. In Section 2, we discuss the background and related works. In Section 3, we introduce MobileFineTuner, including its framework and APIs, the processes for using Full-FT and PEFT, and a comparison between MobileFineTuner and existing mature LLM implementation frameworks. In Section 4, we present the built-in optimizations, including memory optimization and energy optimization. Sections 5 and 6 present experimental validation.

# 2 Related Work

In this section, we review prior work related to LLM finetuning from two perspectives. First, we discuss methods that leverage private-domain data for on-device LLM fine-tuning, examine the implementation setups they rely on, and analyze

why they do not typically adopt mobile phones as target platforms. Second, we review recent efforts that attempt to enable LLM fine-tuning on mobile phones, analyzing their implementation strategies and inherent limitations.

# 2.1 Leveraging Private-Domain Data for on-device LLM Fine-Tuning

To leverage private-domain data for LLM fine-tuning, recent works have proposed several approaches that allow data on end devices to participate in the fine-tuning process while preserving privacy by ensuring the data never leaves the device. These methods can be broadly categorized into two groups. The first is on-device federated LLM fine-tuning, where models trained on multiple clients are aggregated by a federated server to obtain a globally fine-tuned model. The second is on-device personalized LLM fine-tuning, which focuses on adapting LLMs to achieve better personalization on a specific end device.

For on-device federated LLM fine-tuning, methods such as FedIT [42], FLoRA [37], HeLoRA [8], HetLoRA [5], and PCFT-LLM [33] investigate federated LoRA-based techniques to enable PEFT of LLMs across heterogeneous client devices. Similarly, ME-SFL [4] and FlexP-SFL [41] explore split learning-based solutions for federated LLM fine-tuning across distributed and heterogeneous edge systems.

For on-device personalized LLM fine-tuning, methods such as MobiLLM [16] and PAE-MobiLLM [40] adopt side-tuning strategies, where server-side resources assist mobile

or edge devices in adapting LLMs to local data distributions. PocketLLM [22] proposes a memory-efficient fine-tuning technique that relies only on forward propagation to significantly reduce device memory usage. XPerT [34] studies personalized LLM selection to better adapt models for different devices. SP-LLM [24] focuses on selecting the most representative local data samples for efficient on-device fine-tuning. Crayon [2] introduces an adapter-pool mechanism that enables effective personalization with minimal additional computing overhead.

We summarize these works in Tab. 1, highlighting the frameworks, implementation setups, and open-source availability. The comparison reveals a notable gap: although all of these methods aim at enabling on-device LLM fine-tuning, among the 13 surveyed works, 7 works (over half) rely on simulation-based experiments, 4 works employ NVIDIA developer boards, SoCs, Raspberry Pis or PCs, while only 2 works (PocketLLM and XPerT) actually evaluate their methods on mobile phones. This raises a critical question: given that mobile phones are the most ubiquitous end devices in daily life, generating massive amounts of human-generated data and serving as the primary target platform for most end-side applications, why are they rarely used the mobile phones as the actual implementation setup?

To answer this question, we first examine the implementation frameworks on which these works are based. Except for two studies that utilize mobile phones (which will be discussed in Section 2.3), the remaining works rely on mature

frameworks such as PyTorch [21], Hugging Face Transformers [38], Hugging Face PEFT [18], and Flower [3]. A common characteristic of these frameworks is that they are all Pythonbased. These frameworks can be conveniently deployed on operating systems that support Python, such as Linux and Windows, and they have streamlined the LLM fine-tuning process, allowing researchers and developers to readily reuse packages for algorithmic development with minimal coding effort.

However, mobile phones, such as those running Android, do not natively support Python [23], which means the aforementioned frameworks cannot be directly deployed. Currently, there is no unified framework for LLM fine-tuning on mobile phones. As a result, implementing real-world LLM fine-tuning on mobile phones requires significant effort from researchers to develop thousands of lines of custom code. This is why many studies opt for simulations or use devices running Linux or Windows, rather than mobile phones. Consequently, a significant portion of mobile phone scenarios has been largely overlooked in practical implementations. This gap motivated us to develop MobileFineTuner, a unified open-source framework for LLM fine-tuning on mobile phones, providing researchers and developers with a flexible platform for experimentation and further development.

# 2.2 Limitations of Existing Efforts on LLM Fine-Tuning on Mobile Phones

Although some recent efforts such as PocketLLM and XPerT have attempted to enable LLM fine-tuning on mobile phones, they still face significant limitations:

 PocketLLM [22], proposed by OPPO, demonstrates on-device LLM fine-tuning through forward-only propagation, but it relies on Termux, a virtual machine (VM) for Android. This means that Python code executed on Termux must first be translated by the Termux environment before it can run on the mobile phone

- system. This introduces additional computational overhead and leads to low efficiency under the constrained resources of mobile phones.
- XPerT [34] achieves mobile LLM fine-tuning by first converting models to ONNX and then using the ONNX Python API to integrate them into an Android application via Java. This workflow requires significant offline development effort, and each new model or task necessitates building a separate application, making it inconvenient, inflexible, and difficult to scale. Additionally, this approach demands that researchers or developers possess multi-language development skills, such as proficiency in both Python and Java.

Additionally, the implementation processes of both PocketLLM and XPerT lack a unified framework and have not been open-sourced, hindering other researchers from easily reusing or extending them. As a result, the absence of a unified open-source framework to support LLM fine-tuning on mobile phones creates a critical gap, which MobileFineTuner is designed to address.

#### 3 MobilFineTuner Framework

In this section, we first introduce the four-layer architecture of MobileFineTuner, its functionalities, and corresponding API interfaces in Section 3.1. Then, we describe its usage process for full-parameter fine-tuning (Full-FT) and parameter-efficient fine-tuning (PEFT) in Section 3.2.

#### 3.1 Framemwork Details and APIs

To achieve high efficiency and fine-grained control suitable for mobile phones, MobileFineTuner is implemented entirely in C++. The framework employs a four-layer hierarchical architecture, which separates low-level computational primitives from high-level application logic. This design allows higher-level modules to automatically invoke lower-layer

functionalities, while also enabling researchers and developers to directly call specific APIs for algorithm prototyping, experimental exploration, or system-level customization. The functionality and interfaces of each layer are as follows:

- Basic Layer: The Basic Layer constitutes the computational foundation of the MobileFineTuner framework. It provides core infrastructure including a unified tensor system tensor.h/cpp, operator implementations ops.h/cpp, automatic differentiation support backward\_functions.h/cpp, data type definitions dtype.h, device management device.h, and utility functions utils.h/cpp. This layer ensures efficient tensor operations and abstracts underlying hardware functions, forming the essential building blocks upon which all higher-level components rely.
- Intermediate Layer: Built atop the Basic Layer, the Intermediate Layer implements commonly used neural network components and PEFT extensions. - **Abstract Layer**: The Abstract Layer defines high-level interfaces and abstractions for neural network modeling. It includes module and layer interfaces *module.h*, *layers.h* that standardize component behavior, enabling modularity and extensibility across the framework. This layer also encompasses optimizer implementations *optimizer.h*, *adam.h*, and related files in *optim/* and *optimizers/*, responsible for parameter updates based on gradient information during training. By providing these abstractions, the Abstract Layer bridges the gap between low-level computation and complete model construction.
- Application Layer: The Application Layer represents the highest level of the framework, responsible for constructing LLM architectures and executing end-to-end tasks. It includes core Transformer components transformer\_block.h, autoregressive\_ops.h/cpp, kv\_cache.h, components.h/cpp and model definition/loading utilities {model\_name}.h, model\_loader.h under model/ and models/. By leveraging modules from the lower layers, this layer enables complete model training, fine-tuning, and inference.

# 3.2 Usage Process for Full-FT and PEFT

In terms of fine-tuning capabilities, MobileFineTuner supports both Full-FT and PEFT. Full-FT enables research on novel fine-tuning paradigms, such as secondary development for implementing federated split fine-tuning. For PEFT, we support LoRA fine-tuning, which is currently the most widely used parameter-efficient method for LLM fine-tuning. Users can invoke these functionalities via high-level APIs, in a manner similar to PyTorch. The usage processes for Full-FT and PEFT (LoRA) are illustrated below.

- Full-FT process: During the Full-FT process, users can invoke MobileFineTuner through a concise high-level API, as shown in Listing 1. The process begins by defining a DataLoader that provides training batches, initializing the model and optimizer objects, and then executing the train() function. Within each training iteration, the framework sequentially performs the forward pass model\_→forward(), loss computation model\_→compute\_loss(), backward propagation loss→backward(), and parameter update optimizer\_→step(). This design enables researchers to conduct on-device LLM fine-tuning using a PyTorch-like interface.
- PEFT (LoRA) process: MobileFineTuner defines a modular LoRA-based architecture that replaces standard layers within the self-attention module and constructs corresponding components, including LoRALinear, Lo-RAAttention, and LoRATransformerBlock. Users can conveniently perform LoRA fine-tuning by specifying a configuration object LoRAFinetuneConfig, loading pretrained LLM parameters, and invoking the unified LoRAFinetune interface to enable PEFT.

MobileFineTuner supports both input and output in down-loadable model formats from Hugging Face, such as ".bin" and ".safetensor". This allows researchers and developers to directly download pretrained LLMs without the need for format conversion. Furthermore, the fine-tuned model

is also output in ".bin" or ".safetensor" format, enabling direct integration with libraries such as PyTorch and Hugging Face Transformers. This ensures compatibility with existing frameworks and facilitates seamless integration for joint use.

# 3.3 Comparison with Mature Frameworks for LLM Implementation

In this section, we compare our MobileFineTuner with existing mature frameworks. In the context of LLM implementation, widely recognized frameworks include PyTorch, Hugging Face Transformers, Hugging Face PEFT, Flower, and Llama.cpp. These frameworks have gained popularity due to their efficiency, scalability, multi-model support, and ease of use for development and research. Their key characteristics and technical details are summarized as follows:

- PyTorch [21]: A Python-based deep learning framework that provides flexible tensor computation and automatic differentiation. PyTorch supports general model training and inference but does not natively provide mobile phone deployment or built-in system-level optimizations.
- Hugging Face Transformers [38]: Built on top of PyTorch, this Python library specializes in transformerbased models, offering pre-trained LLMs and streamlined pipelines for both inference and fine-tuning. It simplifies model handling and supports multiple LLM architectures, but it is limited to environments that support Python, such as Linux or Windows servers.
- Hugging Face PEFT [18]: A Python-based library focused on PEFT for LLMs, such as LoRA and adapters.
   While it reduces the computational cost of fine-tuning and enables flexible algorithmic experimentation, it is designed for server-side execution and does not support mobile devices directly.
- Flower<sup>1</sup> [3]: A Python-based federated learning framework that orchestrates federated model training across

- multiple clients. Flower enables federated LLM training on server and edge devices that support Python, but it does not natively provide on-device LLM finetuning for mobile phones or built-in optimizations.
- Llama.cpp [11]: A C++ framework designed for efficient inference of LLMs on edge devices such as mobile phones. It integrates quantization and other deviceside optimizations, achieving high efficiency without relying on Python. However, Llama.cpp focuses exclusively on inference and does not support LLM finetuning.

The features of these mature frameworks are summarized in Tab. 2. It is evident that none of them support LLM fine-tuning directly on mobile phones. In contrast, MobileFine-Tuner not only enables fine-tuning on mobile devices but also integrates the functionalities provided by existing frameworks, including support for multiple LLM architectures, inference on both servers and mobile phones, server-side fine-tuning, PEFT support, and built-in system optimizations such as memory optimization, and energy optimization. By combining these features into a streamlined package, Mobile-FineTuner allows researchers and developers to implement LLMs with minimal overhead and reduced development effort, facilitating both experimentation and practical deployment.

#### 4 Built-in Optimizations

MobileFineTuner identifies two central challenges for LLM fine-tuning on mobile phones: **memory limitations (RAM)** and **energy constraints**. On the memory side, a "rule-of-thumb" estimate suggests that 16 GB of RAM is required per 1 billion parameters for FP16 training [19], with the requirement doubling for FP32 training . In contrast, typical mobile phones in 2025 are equipped with only 4-16 GB of RAM [31], making memory capacity a major bottleneck for LLM fine-tuning on mobile phones. On the energy side, continuous forward and backward passes over large models impose sustained computational loads, resulting in significant power consumption and accelerated battery drain. Since mobile devices typically rely on relatively small battery packs




Figure 2: ZeRO-inspired parameters sharding.

(e.g., 3000–5000 mAh) and must simultaneously support regular user activities, performing LLM fine-tuning on mobile phones without energy optimization would severely degrade the overall user experience.

In this section, we propose several built-in optimizations specifically designed for fine-tuning LLMs on mobile phones, which can be directly invoked by users. Section 4.1 presents our memory optimization techniques, covering parameters sharding and gradients accumulation, while Section 4.2 introduces our energy optimization strategy.

# 4.1 Memory Optimization

4.1.1 ZeRO-inspired parameters sharding. Considering the limited RAM on mobile phones and the relatively large disk storage available (often in the hundreds of GBs), it is crucial to offload some of the fine-tuning process to disk to alleviate the pressure on RAM. Therefore, MobileFineTuner implements a parameter sharding mechanism to optimize RAM usage during the fine-tuning process.

The core design is inspired by the ZeRO-3 (Zero Redundancy Optimizer) principle [26], but is re-engineered for single-device execution on mobile phones. Instead of maintaining a complete copy of all parameters in RAM, Mobile-FineTuner partitions the model parameters into multiple contiguous segments and loads only the active segment required for the current forward or backward pass, as shown in Fig. 2. Once a segment becomes inactive, it is promptly offloaded to disk storage to release RAM resources.

Furthermore, we have developed a real-time memory management module to dynamically clear memory redundancy caused by reading or offloading parameter shards<sup>2</sup>. During computation, MobileFineTuner also maintains an efficient mapping table that tracks the physical location and state of each parameter shard, ensuring seamless parameter swapping and uninterrupted model training without redundant recomputation.




Figure 3: Energy-aware dynamic computation scheduling.

4.1.2 Gradients accumulation. During fine-tuning, both forward activations and backward gradients consume a significant amount of memory. While smaller batch sizes reduce memory usage, they also result in gradient updates derived from fewer samples, leading to higher noise and greater fluctuations during training. Conversely, larger batch sizes lead to more stable model updates but increase memory usage [15].

To address this, MobileFineTuner incorporates gradient accumulation, which effectively balances memory usage and training stability. The approach works by breaking a single large-batch update into multiple micro-batches for forward and backward propagations. Gradients are accumulated, and a single optimizer update is performed afterward, achieving training stability similar to that of a large batch with the memory requirements of a micro-batch.

# 4.2 Energy Optimization

MobileFineTuner proposes an energy-aware dynamic computation scheduling method to optimize energy consumption during fine-tuning of LLMs on mobile phones. Given the typical usage patterns of smartphones, this method aims to reduce the computation frequency of LLM fine-tuning under conditions of low battery, thereby alleviating the computational load on the phone and ensuring a better user experience.

We have integrated a *PowerMonitor* that tracks the mobile phone's battery percentage during fine-tuning. The *PowerMonitor* performs checks every K fine-tuning steps. As shown in Fig. 3, when the battery percentage drops below a user-defined threshold  $\mu$ , the computation frequency is dynamically adjusted, reducing it by a percentage  $\rho$ . Both K,  $\mu$  and  $\rho$  are configurable hyperparameters, allowing the system to be adapted to various use cases. The frequency adjustment is implemented by introducing a sleep delay at each fine-tuning step, ensuring that the computational process is dynamically managed to balance energy efficiency with system performance.

# 5 Implementation

In this section, we provide the implementation details of MobileFineTuner for our common evaluation, including device setup, models support, and data tasks.

# 5.1 Device Setup

- 5.1.1 Framework compilation. MobileFineTuner supports all mobile devices running Android 10+ (API level 29+). The framework offers two compilation methods<sup>3</sup>: the first involves server-side NDK compilation followed by uploading the compiled project to the mobile device via ADB (Android Debug Bridge<sup>4</sup>); the second method places the source code directly on the mobile device and compiles it on mobile phone via ADB. Once the compilation is complete, users can upload the model and dataset, configure the necessary runtime parameters, and execute the compiled binary to initiate the fine-tuning process. This entire workflow eliminates the need for additional development efforts from the user.
- 5.1.2 Metrics observer. MobileFineTuner includes a built-in metrics observer that logs key statistics at each step, including step number, training loss, testing loss, testing perplexity (PPL) / accuracy, RSS (Resident Set Size), and power consumption. Below is an explanation of the observers for RSS and power consumption:
  - RSS is a crucial memory metric that indicates the actual amount of RAM used by a process. It is calculated by summing the private memory used by the process and the memory occupied by shared libraries. RSS represents the total physical memory consumed by a process, including its code, data, heap, and stack. MobileFineTuner retrieves RSS information by calling the dumpsys procstats command, which provides memory usage statistics for running processes.
  - Power consumption is measured using the built-in PowerMonitor, which interacts with Android's BatteryStatsService. Our PowerMonitor acquires power consumption data by reading the Android kernel's power configuration files, power\_profile.xml.

#### 5.1.3 Device specifications for our common evaluation.

5.1.4 Device specifications for our common evaluation. For our common evaluation, we selected four devices, including three Android smartphones and one laptop, as listed in Tab.3. The specifications are summarized as follows:




Figure 4: Loss of Full-FT on GPT2-127M@WikiText-2.

- Google Pixel 8: The Pixel 8 runs Android 14.0 and is equipped with the Google Tensor G3 processor. It features 8 GB of RAM and 128 GB of internal storage.
- Google Pixel 7 Pro: The Pixel 7 Pro operates on Android 13.0 and is powered by the Google Tensor G2 chipset. It includes 12 GB of RAM and 256 GB of storage, offering higher memory capacity suitable for more demanding workloads.
- Google Pixel 8 Pro: The Pixel 8 Pro runs Android 14.0 and is also built with the Google Tensor G3 processor. With 12 GB of RAM and 256 GB of storage, it serves as a high-performance Android platform for computation-intensive evaluation tasks.
- MacBook Air 2023: The MacBook Air is equipped with macOS Sequoia 15.6.1 and the Apple M2 processor. It features 16 GB of RAM and a 512 GB SSD. We include this device to evaluate the one-server finetuning capability and cross-platform adaptability of Mobile-FineTuner. In addition, the MacBook Air can effectively support the finetuning of relatively large-scale models due to its ability to extend usable memory through ROM virtualization as supplementary RAM.

#### 5.2 Models

Unlike inference, fine-tuning requires significantly more memory and computational resources—often several times more than inference. Consequently, large models with extensive parameters are impractical on mobile devices, as they would exceed the capabilities of most mobile phones.

Thus, we have focused on models specifically designed for deployment on resource-constrained devices. The models selected for our evaluation include: GPT2-small-124M, GPT2-medium-355M [25], Qwen2.5-0.5B [28], Gemma3-270M, and Gemma3-1B [27]. The fine-tuning processes for these models have already been integrated as examples within MobileFine-Tuner, enabling users to run them directly without additional development. For other models, we plan to gradually update the examples. For user-defined models, users can also make adjustments as needed, requiring only minor modifications to the high-level functions (such as adjusting the tokenizer to suit their specific model).

5.3 Datasets

For our common evaluation, we validate the effectiveness of MobileFineTuner under two types of data tasks:

- Text Generation Task: We use the WikiText-2 dataset [6] which consists of approximately 2 million tokens, sourced from a subset of Wikipedia articles. We fine-tune the large models on this dataset and observe their PPL, which measures the model's ability to predict the next word in a sequence.
- Text-based Question Answering Task: We use the MMLU (Massive Multitask Language Understanding) dataset [13], a comprehensive benchmark designed to evaluate models on 57 diverse tasks across various domains, including history, science, literature, and more. For this task, we input both the question and answer options into the model, and the model generates a response. The predicted answer is then extracted from the model's output, and the model's accuracy is evaluated by comparing the predicted answer to the correct answer.

# 6 Framework Evaluation

In this section, we present the common evaluation of MobileFineTuner, which is divided into two parts. The first part is the base evaluation, which evaluates Full-FT and PEFT (LoRA) on mainstream LLMs. The second part focuses on

validating the built-in optimizations through ablation studies.

#### 6.1 Base Evaluation

#### 6.1.1 Full-FT.

**Settings.** To evaluate the feasibility of MobileFineTuner's Full-FT capability, we conduct full finetuning on GPT2-small-124M using the WikiText-2 dataset. We choose this compact model because Full-FT imposes substantial memory pressure, and only such small models can be executed on mobile phones. All experiments are performed on a Google Pixel 8 Pro device. In our configuration, we set the sequence length to 128, use a batch size of 8, and adopt a learning rate of 1e-5 to ensure stable optimization under mobile resource constraints.

Results. The results are presented in Figure 4, where we compare the loss trajectories and PPL values produced by MobileFineTuner with those obtained from the PyTorch implementation. As finetuning progresses, the loss curve of MobileFineTuner decreases steadily until convergence, consistent with the behavior observed in PyTorch. Likewise, the PPL values also exhibit a monotonic decline during the training process. It is important to note that this comparison with PyTorch is not intended to demonstrate performance superiority; PyTorch runs on a server-side Python environment, whereas MobileFineTuner executes Full-FT directly on mobile phones. Instead, the alignment between the




Figure 5: Loss of PEFT on Different Tasks.

results serves to validate the correctness and reliability of our Full-FT implementation.

### 6.1.2 PEFT(LoRA).

**Settings.** We evaluate PEFT performance on five models across two datasets, resulting in a total of ten tasks. For each task, we apply a unified configuration, setting the sequence length to 128 and the batch size to 8. The LoRA hyperparameters are fixed as follows: a rank of 8, an alpha of 32, and a dropout rate of 0.1. We adopt a learning rate of 2e-4 for all experiments. To ensure a fair comparison, both the PyTorch baseline and MobileFineTuner are executed under identical experimental settings. We attempt to run all finetuning tasks

on all available devices to assess cross-device consistency and robustness.

Results 1 – System Metrics. Tables 4 and 5 report the system metrics of each device while executing MobileFineTuner on tasks from WikiText-2 and MMLU, respectively. For each model-task combination, we record the Peak RSS and Average RSS during fine-tuning. A dash ("-") indicates that the task could not be executed due to insufficient memory, resulting in a crash or termination.

As observed, the ability to perform a task is determined primarily by the Peak RSS relative to the available memory of the device. On Android devices, system processes occupy a portion of the RAM, so even if the recorded Peak RSS is




Figure 6: PPL of PEFT on Different Tasks.

below the total physical memory, tasks may still fail. For instance, the Qwen2.5-0.5B model on WikiText-2 exhibits a Peak RSS of 6111 MB; however, this exceeds the available memory on the Pixel 8 (8 GB), causing the process to crash. In contrast, the MacBook Air 2023, equipped with macOS and support for virtual memory, can execute all tasks regardless of model size.

Results 2 – Fine-tuning Metrics. For each task, we report the average fine-tuning metrics across all devices that were able to complete the full fine-tuning process. The results are presented in Table 6. We focus on the final fine-tuning loss, as well as the model's accuracy after convergence (for MMLU) and perplexity (PPL, for WikiText-2). For comparison, we also report results obtained using the same parameters on PyTorch running on a server.

As shown in Table 6, MobileFineTuner achieves fine-tuning results that are comparable to PyTorch, demonstrating that on-device LoRA fine-tuning on mobile phones can produce outcomes similar to server-side training. This validates the effectiveness and correctness of MobileFineTuner for practical on-device fine-tuning. For instance, the PPL and final loss values for WikiText-2 and the accuracy metrics for MMLU are closely aligned with those obtained using PyTorch, indicating that MobileFineTuner can faithfully replicate standard training behavior on mobile phones.

We further illustrate the fine-tuning process in Figures 5 and 6, which show the evolution of the model's fine-tuning loss and PPL over training steps. While the convergence speed occasionally varies—sometimes MobileFineTuner converges faster, other times PyTorch does—the overall trends




Figure 7: Average RSS w/ or w/o Parameters Sharding.

and the final converged values are nearly identical. This consistency provides additional evidence of the reliability and effectiveness of our framework.

# 6.2 Evaluation of Built-in Optimizations

#### 6.2.1 Parameters Sharding.

**Settings.** To evaluate the effectiveness of *parameter sharding* in reducing memory consumption, we conduct experiments on the WikiText-2 dataset with GPT2-small, GPT2-medium, Gemma3-270M, and Gemma3-1B for PEFT. The experimental settings includes a batch size of 8, sequence length of 128, LoRA rank of 8, LoRA alpha of 16, and a learning rate of 2e-4. For each model, we measure the average RSS during fine-tuning with and without parameter sharding.

**Results.** Figure 7 presents the average RSS observed during PEFT for GPT2-small, GPT2-medium, Gemma3-270M, and

Gemma3-1B, both with and without parameters sharding. As shown, parameters sharding consistently reduces memory usage across all models. For instance, the average RSS for GPT2-small decreases from 1,945 MB without sharding to 1,631 MB with sharding, and GPT2-medium decreases from 3,603 MB to 3,462 MB. Similarly, Gemma3-270M reduces from 5,060 MB to 4,719 MB, and Gemma3-1B from 11,448 MB to 10,782 MB. These results demonstrate that the parameters sharding effectively mitigates memory consumption during fine-tuning.

#### 6.2.2 Gradients Accumulation.

**Settings.** To evaluate the effectiveness of *gradient accumulation*, we perform PEFT fine-tuning with the Gemma3-270M model on the WikiText-2 dataset. The experimental settings include a total batch size of 8, sequence length of 128, LoRA rank of 8, LoRA alpha of 16, and a learning rate of 2e-4. We vary the gradient accumulation steps across 2, 4, and 8, corresponding to splitting the total batch size of 8 into micro-batches of sizes 4, 2, and 1, respectively. These configurations are denoted as b4a2, b2a4, and b1a8, where "b" indicates the micro-batch size and "a" indicates the number of accumulation steps.

**Results.** The results of gradient accumulation are illustrated in Fig. 8, with the corresponding convergence steps, final loss, and final PPL reported in Table 7. As shown in the figure, increasing the number of gradient accumulation steps significantly reduces memory usage (as reflected in the peak and average RSS) while maintaining training stability. Importantly, the total number of steps required for convergence remains essentially unchanged across configurations, and the final loss and PPL show negligible differences. These




Figure 9: Loss with Computation Scheduling.

results demonstrate that gradient accumulation effectively mitigates memory pressure without compromising model performance or training efficiency on mobile devices.

# 6.2.3 Computation Scheduling.

**Settings.** We perform PEFT to validate the energy-aware computation scheduling mechanism using Qwen 2.5-0.5 on the WikiText-2 dataset. The experimental settings include a batch size of 8, sequence length of 128, LoRA rank of 8, LoRA alpha of 16, and a learning rate of 2e-4. Experiments were conducted on the Pixel 8 Pro, with wall-clock time recorded at each step. We set K=1,  $\mu=60\%$  and  $\rho=50\%$ .

**Results.** The experimental results are shown in Fig.9. At step 53, approximately 4 hours in, the battery level dropped below the 60% threshold. As a result, the computation frequency was reduced from 0.081 hour/step to 0.164 hour/step, thereby extending the smartphone's usage time.

#### 7 Conclusion

In this paper, we presented MobileFineTuner, the first unified open-source framework that enables practical large language model (LLM) fine-tuning directly on commodity mobile phones. MobileFineTuner addresses fundamental system challenges—particularly limited memory capacity and strict energy budgets-through a set of novel system-level optimizations, including parameter sharding, gradient accumulation, and energy-aware computation scheduling. Our design demonstrates that on-device LLM fine-tuning is not only feasible but can be performed efficiently across multiple model architectures and training configurations. Beyond its implementation, MobileFineTuner provides new insights into the behavior of large-model training under mobile hardware constraints and establishes a foundation for future research on resource-aware, privacy-preserving on-device learning. Looking forward, we plan to extend MobileFineTuner to support heterogeneous mobile platforms and hardware accelerators, and to explore integrating federated and collaborative LLM fine-tuning across mobile devices. We believe Mobile-FineTuner opens a promising new direction for mobile systems research by enabling large-scale learning capabilities to move closer to user data and end devices.
