# FINDING ALL BOUNDED-LENGTH SIMPLE CYCLES IN A DIRECTED GRAPHS - REVISITED

#### **ABSTRACT**

In 2021, Gupta and Suzumura proposed a novel algorithm for enumerating all bounded-length simple cycles in directed graphs [1]. In this work, we present concrete examples demonstrating that the proposed algorithm fails to enumerate certain valid cycles. Via these examples, we perform a detailed analysis pinpointing the specific points at which the proofs in [1] exhibit logical gaps. Furthermore, we propose a corrected formulation that resolves these issues while preserving the desirable property that the algorithm's computational complexity remains  $O((c+1) \cdot k \cdot (n+e))$  where c is the number of simple cycles of a specified maximum length k, and n and e the number of graph nodes and edges respectively.

**Keywords** Graph Algorithms · Cycle Enumeration · Algorithm Analysis

# 1 Introduction

**Literature Review.** The problem of enumerating all *simple cycles* (cycles without repeated vertices) in a graph is fundamental in graph theory, with applications in areas such as chemistry, circuit analysis, and network science. Early work by Tiernan [2] proposed a backtracking-based algorithm for finding elementary circuits, but it suffered from redundancy and exponential runtime in dense graphs. Johnson [3] later introduced the most influential algorithm for directed graphs, combining depth-first search with a blocking/unblocking mechanism to efficiently avoid revisiting fruitless paths.

His algorithm runs in O((n+e)(c+1)) time, where n is the number of vertices, e the number of edges, and e the number of simple cycles. Tarjan [4] contributed foundational work on strongly connected components, which remains an essential preprocessing step in many cycle-enumeration methods. Subsequent improvements, such as those by Szwarcfiter and Lauer [5], refined Tiernan's approach for better practical performance. More recent studies, such as those by Birmelé et al. [6] and Conte et al. [7], focus on output-sensitive and parallel algorithms to handle large-scale networks.

The most recent algorithm for Finding All Bounded-Length Simple Cycles in a Directed Graph is due to Anshul Gupta and Toyotaro Suzumura [1]. Their algorithm builds upon ideas of Johnson's algorithm. But, instead of using a binary lock value for each node as in Johnson's algorithm, the new algorithm uses a numeric lock value for each node, which is designed to prevent futile searches when a cycle search gets too deep.

In an experimental investigation of a GIS problem, we examined the Gupta-Suzumura algorithm. During initial testing, one of the expected cycles in a benchmark graph was not detected, leading us to suspect a possible flaw in our

implementation. After carefully verifying the correctness of our code - which was a line-by-line translation of the pseudocode provided in [1] into Python - we proceeded to conduct a detailed analysis of the specific test case.

This analysis revealed that the proof outlined in [1] exhibits logical gaps, and that the published pseudocode, when executed on the identified graph, indeed fails to enumerate one valid simple cycle in the test case, and possibly more in the general case.

In this paper, we present a concrete counter-example to the algorithm of Gupta and Suzumura [1]. We provide a step-by-step examination of the algorithm's execution on this instance (see section 4), analyze the underlying reasons for the omission of certain cycles (section 5), and identify the precise points in the original proofs where inconsistencies or omissions occur. In section 6, we propose a corrected algorithm and establish its correctness. As we then show in section 7, the algorithm preserves the desired property of being sensitive to the number of simple cycles of a specified length.

## 2 Terminology

A directed graph G is defined as an ordered pair (V, E), where  $V = (v_1, v_2, \dots, v_n)$  denotes the set of nodes (or vertices) and  $E \subseteq V \times V$  denotes the set of directed edges, represented as ordered pairs of nodes.

A node  $v_i \in V$  is said to be *connected* to a node  $v_j \in V$  by an edge  $v_i v_j$  if and only if the ordered pair  $(v_i, v_j)$  belongs to E.

A path in G is a finite sequence of nodes  $(v_{i_1}, v_{i_2}, \dots, v_{i_m})$  such that  $(v_{i_j}, v_{i_{j+1}}) \in E$  for all  $1 \leq j < m$ .

A *simple path* is a path in which all nodes are distinct.

A simple cycle is a path  $(v_{i_1}, v_{i_2}, \dots, v_{i_m})$  with  $m \geq 2$  such that  $(v_{i_1}, v_{i_2}, \dots, v_{i_{m-1}})$  is a simple path and  $v_{i_1} = v_{i_m}$ .

The *length* of a path or cycle is defined as the number of edges it contains.




Figure 1: Directed graph G = (V, E)

For brevity, edges, paths, and cycles are denoted by concatenating their node sequences. In the graph G from Figure 1 for example, AD is an edge, ADB is a path, and ADA is a cycle.

#### 3 The original Algorithm from [1]

The original algorithm from [1] consists of three functions:

- LC\_CYCLES(G, k): The outer loop that initializes data structures and iteratively calls the cycle search function for each node s in the graph G.
- $CYCLE\_SEARCH(G^s, s, k, flen)$ : A modified depth-first search function that explores paths starting from a given node s in a subgraph  $G^s$  of G, looking for cycles of length up to k.
- $RELAX\_LOCKS(u, k, blen)$ : A helper function that updates the lock values of nodes after a cycle is found, allowing them to be revisited in future searches.

For the sake of self-completeness, Appendix A presents the functions  $CYCLE\_SEARCH$  and  $RELAX\_LOCKS$  from [1], translated into Python to demonstrate the counter-example. Function  $LC\_CYCLES$  mainly manages an outer loop for finding more cycles not containing the first start node s, and is not further relevant here.

## 4 A Counter-Example to [1]

Consider the directed graph G = (V, E) with

- node set  $V = \{A, B, C, D, E\}$  and
- edge set  $E = \{AD, AE, BD, BE, CA, CB, DA, DB, EC\}$

The graph G is depicted in Figure 1.

In an internal computer representation of the graph using an adjacency list, the edges are stored in the order shown above. This ordering affects the sequence in which nodes are explored during depth-first searches. In theory, the ordering should not affect the set of cycles found, but here it does, as will be clear later.

It is straightforward to see that graph G contains the following simple cycles starting at the first node A:

- ADA (length 2)
- AECA (length 3)
- ADBECA (length 5)
- AECBDA (length 5)

Let the function  $LC\_CYCLES(G, k)$  from [1], the outer loop, be called with the above graph G and k=5 as the length bound parameter.

Function  $LC\_CYCLES$  starts with initializing for each node v in G

- lock[v] to infinity and
- Blist[v] to an empty set.

The locks are numeric values designed to block nodes from being revisited during the search under certain conditions. The Blists are of no importance here, as they will remain empty throughout the algorithm execution in this example, but are needed in the general case.

After initialization, the first call to  $CYCLE\_SEARCH(Gs, s, k, 0)$  is made in line 9 of  $LC\_CYCLES$  with the parameters s = A (the first node of graph G), Gs = G, and k = 5.

In the following sub-sections, a commented trace of the execution of  $CYCLE\_SEARCH(G, A, 5, 0)$  is given.

#### 4.1 Finding Cycle ADA

The search starts as follows:




Figure 2: Graph G after first DFS in  $CYCLE\_SEARCH(G,A,5,0)$  found cycle ADA.

The result is depicted in Figure 2.

## **4.2** Finding Cycle *ADBECA*

After backtracking to D, the next cycle ADBECA is found when the depth-first-search continues:




Figure 3: Graph G after second DFS in  $CYCLE\_SEARCH(G,A,5,0)$  found cycle ADBECA.

see Figure 3.

During the search from D, the locks of the visited nodes B, E, and C are set to their index (depth) in the search stack. All other locks remain unchanged.

Backtracking finally returns to A, thereby calling  $RELAX\_LOCKS(u, k, blen)$  for each node visited, in backtracking order.




Figure 4: Graph G after backtracking to A in  $CYCLE\_SEARCH(G,A,5,0)$ .

In these calls, the blen parameter is representing the backward distance to A along the cycle found. Since all Blist are still empty sets,  $RELAX\_LOCK$  does never recurse to itself.  $RELAX\_LOCKS$  will possibly increase a lock value of a node when blen is sufficiently small. After backtracking to A, graph G will look as shown in Figure 4.

#### 4.3 Finding Cycle AECA

Now, the depth-first search finds cycle AECA. The locks of nodes E and C are set to their index (depth) in the third search stack.




Figure 5: Graph G after third DFS in  $CYCLE\_SEARCH(G,A,5,0)$  found cycle AECA.

The other nodes are not affected, see Figure 5.

## **4.4** Missing Cycle AECBDA

After cycle AECA was found, but before node C is completely explored, node B is considered in the search. But, as the lock of node B has a value of 3 (see steps 17, 18), according to line 9 of the pseudocode, the search does *not* recurse to B.

As a consequence, the proposed search algorithm misses cycle AECBDA.




Figure 6: Graph G after backtracking to A in  $CYCLE\_SEARCH(G,A,5,0)$ .

After missing that cycle, the search backtracks from C via E to A, thereby updating (relaxing) the locks along the way. The final result is shown in Figure 6.

Finally,  $CYCLE\_SEARCH(G, A, 5, 0)$  completes and returns to  $LC\_CYCLES$ . In  $LC\_CYCLES$ , the outer loop, the first start node s = A will now be removed from the graph and in all further calls to  $CYCLE\_SEARCH$ , node A is no longer contained. Thus, cycle AECBDA cannot be found anymore.

This example demonstrates that the proposed algorithm does not always find all cycles of specified length k in a directed graph.

#### 4.5 Remarks

This counter-example was the first identified through a systematic search of small, strongly connected directed graphs. An arbitrary number of additional counter-examples can be generated by introducing further nodes and edges connected to G exclusively via edges outgoing from D and edges incoming to A, adding more instances of the above construct, etc..

Although modifying the order of edges in the adjacency list - that is, the internal representation of the graph - may enable the algorithm to enumerate all cycles, this does not constitute a valid solution. A correct algorithm must identify all cycles independently of the order in which edges are presented in the input graph. (Trying all orders is obviously infeasible.)

## 5 Analysis of the Proof

The interesting part in the correctness proof in [1], chapter 4, is Lemma 2: Function  $CYCLE\_SEARCH$  outputs every cycle of length k or less in subgraph  $G^s$ .

The first valid (length k bound) cycle that is not detected by the algorithm is AECBDA.

In terms of the original paper, edge CB is the first so called *blocked* edge. Search stack AEC is not the first visit to node B, and the last visit before was with search stack AD during the second depth-first search yielding cycle ADBECA. Since this last visit before did successfully find a cycle, the second possibility in the proof of Lemma 2 applies. In that case, at the end of page 7 of [1], it is concluded that the path from  $v_{i+1}$  to s (BDA) of length 2 must have been successfully traversed during that last visit. But, this is not true, as node D was at this time already on the search stack AD and therefore blocked when the last visit hit B.

This establishes that Lemma 2 of [1] contains gaps.

#### 6 Our Revised Algorithm

Our corrected algorithm does not employ parameter blen in RELAX\_LOCKS of [1], but instead relaxes all locks immediately to infinity, as shown in the modified pseudocode below. We will show that this leads to a correct solution

and, subsequently, that it maintains the same order of time complexity. For ease of notation, we will use  $v_j$  to denote  $v_{i_j}$ .

To establish the correctness of our approach, we focus on function  $CYCLE\_SEARCH$  in a graph  $G^s$  with a given origin s and length bound k, and re-prove Lemma 2 of [1]. This is the only lemma affected by the change of blen in  $RELAX\_LOCKS$ .

**Lemma 2.** Function  $CYCLE\_SEARCH$  outputs every cycle of length k or less in sub-graph  $G^s$  starting at node s.

*Proof.* By contradiction, initially guided by ideas from [1].

**Assumption** (Minimality): Assume that the lemma is not true. Then, among all valid cycles, there is a first one, in execution order of the algorithm, missed during  $CYCLE\_SEARCH(G^s, s, k, 0)$ .

Let that cycle be  $C_v = (s = v_0, v_1, v_2, \dots, v_l, s)$  which has a length of l + 1.

Because  $C_v$  is a valid cycle, it holds that

$$l+1 \le k. \tag{1}$$

In a call  $CYCLE\_SEARCH(G^s, s, v, k, flen)$  the recursion to a descendant w of v is blocked, if and only if the condition on line 9 of  $CYCLE\_SEARCH$  is not met.

Assume that  $(v_i, v_{i+1})$  is the first (smallest index) blocking edge in  $C_v$ , i.e. the search with search stack  $S_v = (s = v_0, v_1, v_2, \dots, v_i)$  arrives at  $v_i$ , but does not recurse to  $v_{i+1}$ . Node  $v_{i+1}$  cannot be s, because for s the if-condition in line 6 of  $CYCLE\_SEARCH$  is true and the cycle would have been found immediately and not missed.

Therefore,

$$0 < i < l. \tag{2}$$

Consider the call  $CYCLE\_SEARCH(G^s, v_i, k, flen)$  which led to the blocking edge. Parameter flen is the recursion depth, which has for the current search stack  $S_v$  the value i.

Using Equation 1 and Equation 2, one gets i < l < k and therefore the second clause (flen + 1) < k of the blocking condition in line 9 of  $CYCLE\_SEARCH$  is true. Thus, the first clause must be false and from that it follows that

$$i+1 \ge Lock(v_{i+1}). \tag{3}$$

This means that  $Lock(v_{i+1})$  is finite at search stack  $S_v$ , and, because all locks are initialized to infinity, node  $v_{i+1}$  must have been visited before.

Let  $S_u = (s = u_0, u_1, \dots, u_j, v_{i+1})$  be the previous search stack which visited  $v_{i+1}$  last, before the current search stack  $S_v$  arrives at the blocking edge. Both stacks are not identical, but their node sets may overlap.




Figure 8: Search stacks  $S_v$  and  $S_u$ .

The situation is depicted in Figure 8.

**Observation**: the entire search rooted in  $S_u$  does not find any valid cycle. Otherwise, that visit to  $v_{i+1}$  would have called  $RELAX\_LOCKS(v_{i+1},k)$  when finally backtracking to  $v_{i+1}$ , which would have reset  $Lock(v_{i+1})$  back to infinity.

But, the previous search stack  $S_u$  has set  $Lock(v_{i+1})$  to the finite value j, and by Equation 3 it follows that

$$i+1 >= j. (4)$$

Now, consider the concatenation of that previous search stack  $S_u$  with the tail of the first cycle missed:

 $C_{uv} = (s = u_0, u_1, \dots, u_j, v_{i+1}, \dots, v_l, s).$ 

 $C_{uv}$  is a cycle in  $G^s$  of length j + (l - i). Using Equation 1 we get

$$j + (l - i) \le i + 1 + (l - i) = l + 1 \le k. \tag{5}$$

and thus  $C_{uv}$  has a valid length not greater than k.

If  $C_{uv}$  is a simple cycle, we have an immediate contradiction to the minimality of  $C_v$  and we are done. Therefore, we now assume that  $C_{uv}$  is not simple.

This means, there is some node  $u_h(0 < h \le j)$  which is identical to some  $v_m(i+1 < m \le l)$ . If there is more than one such  $u_h$ , we choose the one with minimal index h and the corresponding m.

Then, during  $CYCLE\_SEARCH$  at  $v_{m-1}$  along  $C_{uv}$ , the search did not recurse to  $v_m$ , because  $v_m$  is  $u_h$  and that node is already on the stack.

No cycle was found at  $v_{m-1}$ , and thus  $v_{m-1}$  was put on  $Blist(v_m)$  in line 16 of  $CYCLE\_SEARCH$ . In the same manner, while further backtracking along  $C_{uv}$ , every node  $v_{g-1}$  was put on the Blist of its successor  $v_g$  as long as the cycle search rooted at node  $v_g$  did not find a valid cycle.

By the observation from above, found must be false at least until the backtracking along  $C_{uv}$  reaches node  $v_{i+1}$  and  $v_{i+1}$  is put on the Blist of its successor.

But, found was true when the search further backtracked to node  $u_h$ , since the shortcut  $(s = u_0, u_1, \dots, u_h = v_m, v_{m+1}, \dots, v_l, s)$  is a valid cycle, which is, by minimality of  $C_v$ , found by the algorithm.

As a consequence,  $RELAX\_LOCKS(u_h, k)$  was called when  $u_h$  was popped from the stack. Thus,  $RELAX\_LOCKS(u_h, k)$  eventually sets  $Lock[v_{i+1}]$  back to infinity, possibly via recursive calls to itself along the Blist path from  $u_h = v_m$  back to  $v_{i+1}$ .

Node  $u_h$  must be popped from the stack before the search stack  $S_v$  reaches  $v_i$  again, because  $u_h$  is  $v_m$  and  $C_v$  is simple.

Thus,  $Lock[v_{i+1}]$  is back at infinity when the search stack  $S_v$  considers edge  $(v_i, v_{i+1})$ , and, contrary to the assumptions, that edge cannot be a blocking edge.

Summarizing, in either case we have a contradiction to the assumption that there is a first valid cycle which is not found during  $CYCLE\_SEARCH(G^s, s, k, 0)$ , respectively, that there is a first blocking edge in that cycle.

Therefore, the lemma holds.

## 7 Complexity Analysis

The time complexity analysis of the revised algorithm remains similar to that of the original algorithm presented in [1].

The lock of a node is relaxed to infinity at most once when a cycle is found. Later on, finite lock values are set to flen (the length of the current search stack) which is always smaller than k. Finite lock values are possibly further decreased for each time the node is re-visited by another depth-first search with a smaller flen, but before the next cycle is found and the lock is relaxed again. Therefore, each lock can be decreased at most k times between two relaxations to infinity, i.e. at most k times per cycle found.

Thus, the overall time complexity of the revised algorithm is  $O((c+1) \cdot k \cdot (n+e))$ , where n is the number of nodes, e is the number of edges, and c is the number of simple cycles of length at most k in the directed graph G.

Finally, the important efficient application to sparse graphs with maximum node degree d remains the same as in the original algorithm.

#### 8 Conclusions

We have demonstrated that the algorithm proposed in [1] does not reliably enumerate all bounded-length simple cycles in a directed graph. Additionally, we have identified the specific weaknesses in the proof provided in that work. Finally, we present a corrected algorithm that preserves the desirable property of having computational complexity sensitive to the specified cycle length.
