# CONSTRUCTION AND PERFORMANCE OF KINETIC SCHEMES FOR LINEAR SYSTEMS OF CONSERVATION LAWS

Résumé. We describe a methodology to build vectorial kinetic schemes, targetting the numerical solution of linear symmetric-hyperbolic systems of conservation laws – a minimal application case for those schemes. Precisely, we fully detail the construction of kinetic schemes that satisfy a discrete equivalent to a convex extension (an additional non-trivial conservation law) of the target system – the (linear) acoustic and elastodynamics systems, specifically –. Then, we evaluate numerically the convergence of various possible kinetic schemes toward smooth solutions, in comparison with standard finite-difference and finite-volume discretizations on Cartesian meshes. Our numerical results confirm the interest of ensuring a discrete equivalent to a convex extension, and show the influence of remaining parameter variations in terms of error magnitude, both for "first-order" and "second-order" kinetic schemes: the parameter choice with largest CFL number (equiv., smallest spurious diffusion in the equivalent equation analysis) has the smallest discretization error.

#### 1. Introduction

Systems of Conservation Laws (SCL) with smooth fluxes  $F_a(q) \in \mathbb{R}^L$ ,  $1 \le a \le d$ ,

(1) 
$$\partial_t q^l + \sum_{a=1}^d \partial_a F_a^l(q) = 0 \quad 1 \le l \le L$$

that satisfy an additional non-trivial conservation law

(2) 
$$\partial_t \eta(q) + \sum_{a=1}^d \partial_a G_a(q) = 0$$

where  $\eta(q)$  is a scalar  $C^2(\mathbb{R}^L)$  functional strictly convex in q and  $G_a$  are smooth "entropy" fluxes, are widely spread in the physical sciences. They have a symmetric-hyperbolic formulation so solutions  $q \in C_t^0\left([0,T),[H^s(\mathbb{R}^d)]^L\right)$  are unequivocally defined on small times T given initial conditions  $q(t=0)=q^0\in[H^s(\mathbb{R}^d)]^L$ ,  $s>1+\frac{d}{2}$  [12, 5]. The particular case of linear symmetric-hyperbolic systems  $F_a^l(q)=\sum_{m=1}^L A_a^{lm}q_m, A_a^{lm}=A_a^{ml}$ , where  $\eta(q)=\frac{1}{2}|q|^2$  and  $G_a(q)=\frac{1}{2}\sum_{m,l=1}^L A_a^{lm}q_mq_l$ , is a minimal benchmark to evaluate the accuracy of numerical approximations to  $q(t\equiv x_0,x_1,\ldots,x_d)$ . Noticeably, solutions are then well-defined whatever T>0 and whatever  $s\in\mathbb{R}$ . The same remarkable properties extend to Friedrichs symmetrizable linear systems i.e. linear systems (1) for which a symmetric, positive-definite

matrix  $S_0$  exists so that  $S_0A_a = A_a^TS_0$  ( $S_0^{\frac{1}{2}}q$  is solution to a symmetric-hyperbolic system then, with  $\eta(q) = q^TS_0q/2$ ). Friedrichs symmetrizable linear systems are physically relevant: here, we concentrate on the linear flux case having in mind the evaluation of discretization methods for linear elastodynamics.

Many numerical methods have been proposed to compute solutions  $q(t, x_1, \ldots, x_d)$  to (1). Various Finite-Difference (FD) [19] and Finite-Volume (FV) methods [23, 18] have proved able to approximate well solutions. Yet, as demonstrated e.g. in [21], standard techniques leave room to reach accuracy at a reasonable computational price, especially for multidimensional solutions to nonlinear systems. See also [9] for a recent study of Discontinuous Galerkin (DG) methods toward solutions to linear (symmetric-hyperbolic) systems, or [22] for the long-time behaviour of FV schemes (the particular DG-0 case).

In this work, we study the construction and numerical performance of vector(ial)  $kinetic\ schemes$  as defined in Section 2, for linear symmetric-hyperbolic systems of conservation laws, with a view to founding the development of the kinetic approach to further cases. After recalling some elements of analysis about vectorial kinetic schemes in Section 2, we develop in Section 3 a construction method for the paradigmatic (linear) acoustics and elastodynamics systems. Finally, the construction method is first based on ensuring a discrete equivalent to a convex extension of the SCL at, as well as preserving some (rotational) symmetries of the SCL. Next, it leaves one with various choices for parameters. In Section 4, we numerically evaluate the performance of specific schemes (with specific parameter values) in comparison with standard FD and FV schemes.

Our numerical results first confirm the interest of ensuring a discrete equivalent to a convex extension, both for "first-order" and "second-order" kinetic schemes: ensuring a discrete equivalent to a convex extension through adequate parameter choices appears as a sufficient and necessary condition of stability in our numerical tests. Moreover, both first and second order schemes do have first and second order convergence rates. Last, the remaining parameter choices (within the numerical stability region) show a strong influence on the magnitude of the discretization error. The parameter choice with largest CFL number (equiv., the one with smallest spurious diffusion in the equivalent equation analysis) has the smallest discretization error, smaller than standard second order FD and FV schemes.

Our numerical results are an incentive to further studies about the convergence and the error of kinetic schemes for (symmetric-hyperbolic) SCL

# 2. Vectorial kinetic schemes

Kinetic schemes use Q kinetic variables  $f_{\zeta}$ ,  $\zeta \in \{0, 1, ..., Q-1\}$ , which are solutions to (discretized) Boltzmann-BGK equations with speeds  $c_{\zeta} \in \mathbb{R}^d$  and a relaxation time  $\varepsilon \ll T$ . Here we consider *vectorial* (or vector) kinetic schemes, with vectorial unknown  $f_{\zeta} \in \mathbb{R}^L$  solutions to Boltzmann-BGK equations

(3) 
$$\partial_t f_{\zeta,l} + \sum_{c=1}^d c_{\zeta}^a \partial_a f_{\zeta,l} = \frac{\bar{f}_{\zeta,l}(Mf) - f_{\zeta,l}}{\varepsilon}$$

for  $l \in \{1, \dots, L\}$ , using "Maxwellians"  $\bar{f}_{\zeta, l}$  functions of moments of  $f_{\zeta, l}$  like

$$(4) M_0 f_l := \sum_{\zeta} f_{\zeta,l} \,.$$

Here, we consider  $Q \geq d$  such that the speeds  $c_{\zeta} \in \mathbb{R}^d$  define *lattices* of  $\mathbb{R}^d$  parametrized by a uniform time-step k = T/N > 0  $(N \in \mathbb{N}^*)$ : for all  $\zeta = 0 \dots Q - 1$  it holds  $\mathbf{a}_{ij} + kc_{\zeta} = \mathbf{a}_{i'j'}$  for some  $i', j' \in \mathbb{Z}$ . Such (vectorial) kinetic schemes are sometimes referred to as (vector) "Lattice Boltzmann Methods" (LBMs).

In this work, we consider square lattices equiv. Cartesian grids with  $c_0 = 0$ 

(5) 
$$\Delta = \inf_{ij \neq i'j'} |\boldsymbol{a}_{ij} - \boldsymbol{a}_{i'j'}| = k \min_{\zeta > 0} |c_{\zeta}|,$$

 $a_{ij}$  has coordinates  $(i\Delta, j\Delta)$ . Denoting  $f_{\zeta,l}^n(a_{ij})$  the kinetic variables for computing  $q_{ij}^n \approx q(kn, a_{ij}), n = 1...N$ , we are interested in kinetic schemes as e.g. [10, 2], which read on 2D grids of points  $a_{ij}$  with coordinates  $(\Delta i, \Delta j)$ 

(6) 
$$f_{\zeta,l}^{n+1}(\boldsymbol{a}_{ij} + kc_{\zeta}) = (1 - \omega)f_{\zeta,l}^{n}(\boldsymbol{a}_{ij}) + \omega \bar{f}_{\zeta,l}(M_{0}f^{n}(\boldsymbol{a}_{ij}))$$

where for all  $\zeta$  and ij,  $\mathbf{a}_{i'j'} = \mathbf{a}_{ij} + kc_{\zeta}$  is uniquely defined on the lattice, while  $\omega \in (1,2)$  ranges for "first-order" schemes when  $\omega = 1$  to "second-order" schemes when  $\omega = 2$ . The latter schemes coincide with a two-step time-integration of (3):

(7) 
$$f_{\zeta,l}^{n+\frac{1}{2}}(\boldsymbol{a}_{ij}) = (1-\omega)f_{\zeta,l}^{n}(\boldsymbol{a}_{ij}) + \omega \bar{f}_{\zeta,l}(M_0 f^{n}(\boldsymbol{a}_{ij}))$$

(8) 
$$f_{\zeta,l}^{n+1}(\boldsymbol{a}_{ij} + kc_{\zeta}) = f_{\zeta,l}^{n+\frac{1}{2}}(\boldsymbol{a}_{ij})$$

resulting from a Projection-Transport operator-splitting on  $t \in [nk, (n+1)k)$ .

The approximation of (1) by (6) is not yet fully understood, even in the case of (smooth) solutions to linear SCL, to our knowledge. Various stability conditions have been proposed in the literature [7, 20], as well as elements of error analysis (i.e. heuristics for a future rigorous proof) [14, 26, 4, 3], which presently guide the construction of a kinetic scheme. But we are not aware of sufficient conditions, about finitely-many kinetic speeds or "celerities"  $c_{\zeta}$  and associated vector Maxwellians  $\bar{f}_{\zeta}$ , that guarantee a priori the convergence of (6) to (1). That is why here, focusing on the most simple SCL, the linear acoustics/elastodynamics systems in particular, we explore some sensible choices of speeds and Maxwellians numerically (see Section 4). To that aim, let us first recall what are sensible choices presently.

First, the (moments  $M_0 f^n$  of the) solutions to (6) are known to solve equivalent equations consistent with (1) provided the Maxwellians  $\bar{f}$  satisfy

$$(9) M_0 \bar{f}(q) = q$$

$$(10) M_a \bar{f}(q) = F_a(q)$$

for all  $q \in \mathbb{R}^L$ , on denoting  $M_0$  the operator defined in (4), and  $M_a : \mathbb{R}^{Q \times L} \to \mathbb{R}^L$ 

(11) 
$$M_a f_l := \sum_{\zeta=0}^{Q-1} c_{\zeta}^a f_{\zeta,l}$$

see e.g. [3] for a recent statement of that result. Thus, (9) and (10) are standardly required in the construction of kinetic schemes for (1). Choosing speeds and Maxwellians that satisfy (9) and (10) is sensible, it provides one with (d+1)L equations for QL unknowns  $\bar{f}$ . But (9) and (10) are not enough in general to define uniquely the Maxwellians  $\bar{f}$  (e.g. when using standard lattices with Q>d+1 celerities and linear Maxwellians). Moreover, letting alone the fact that (9) and (10) are not enough to guarantee convergence a priori, (9) and (10) do also not obviously provide one with a (simple, pointwise) error analysis in the case of smooth solutions – unlike standard FD and FV schemes as Yee's scheme or the upwind scheme (see

Sections 4, A.1 and A.2). Now, an error analysis is one important step in proving convergence, independent of stability, which still needs studying [4]. So, with a view to complementing (9) and (10) here, let us now provide some elements for a detailed error analysis in the case of smooth solutions, inspired by the heuristics [7, Proposition 2.1] leading to an equivalent equations when  $\omega = 1$ .

**Proposition 1.** Given  $\{c_{\zeta}, \zeta = 0 \dots Q - 1\}$  consider Maxwellians  $\bar{f}_{\zeta} : \mathbb{R}^L \to \mathbb{R}^L$ linear, that satisfy (9)–(10) and

(\*) 
$$\sum_{\zeta=0}^{Q} \max_{\|q\|_{\infty}=1} |\bar{f}_{\zeta,l}(q)| \le 1 \quad \forall l = 1 \dots L.$$

Then, for any smooth solution

$$(12) \quad q \in C_t^0\left([0,T), [H^2(\mathbb{R}^d)]^L\right) \cap C_t^1\left([0,T), [H^1(\mathbb{R}^d)]^L\right) \cap C_t^2\left([0,T), [H^0(\mathbb{R}^d)]^L\right)$$

to linear conservations laws (1) with initial condition  $q(t=0) = q^0 \in [H^2(\mathbb{R}^d)]^L$ , there exists  $C_T > 0$  such that it holds  $\forall k = T/N, N \in \mathbb{N}^*$ :

(13) 
$$||q(T) - M_0 f^N||_0 := \sqrt{\int_{\mathbb{R}^d} d\boldsymbol{a} \sum_{l=1}^L |q_l(T, \boldsymbol{a}) - M_0 f_l^N(\boldsymbol{a})|^2} \le kC_T$$

when, for each lattice  $\{a_{ij}\}$ ,  $f_{\zeta,l}^n(a_{ij})$  is computed by (6) with  $\omega = 1$ , and

(14) 
$$f^0 = \bar{f}(q^0).$$

Denoting  $F_a^l(q) = \sum_{m=1}^L A_a^{lm} q_m$  the flux, the constant  $C_T$  can be chosen as follows:

$$C_T = 2T \left( \max_{\zeta} |c_{\zeta}| + \max_{a} ||A_a||_{\infty} \right)^2 \max_{a,b} \sup_{s \in (0,T)} ||\partial_{ab}^2 q||_{0}(s).$$

Démonstration. First, for  $\omega = 1$  the "transport-projection" scheme (6) rewrites

(15) 
$$f_{\zeta,l}^{n+1}(\boldsymbol{a}) = \bar{f}_{\zeta,l}(M_0\{f_{\zeta}^n(\boldsymbol{a} - kc_{\zeta})\})$$

whatever k>0. Then, since  $M_0f^0=q^0\in H^2(\mathbb{R}^d)$ , one can establish by recurrence for  $n=1\dots N$  that  $M_0f^n=\sum_\zeta \bar{f}_\zeta(M_0\{f_\zeta^{n-1}(\cdot-kc_\zeta)\})\in H^2(\mathbb{R}^d)$ , and  $\max_{a,b}\|\partial_{ab}^2M_0f^n\|_0\leq \max_{a,b}\|\partial_{ab}^2q^0\|_0$  by assumptions on  $\bar{f}_\zeta$ . Moreover,  $f_{\zeta,l}^{n+1}(\boldsymbol{a}')$  in (8) is equivalently  $f_{\zeta,l}(t^{n+1},\boldsymbol{a}')$  the solution to

(16) 
$$(\partial_t + c_{\zeta} \cdot \nabla) f_{\zeta,l} = 0 \quad \forall t \in (t^n, t^{n+1}), \boldsymbol{a} \in \mathbb{R}^d \quad ; f_{\zeta,l}(t^n, \boldsymbol{a}) = f_{\zeta,l}^{n+\frac{1}{2}}(\boldsymbol{a})$$

which possesses the regularity (12) because  $f_{\zeta,l}^{n+\frac{1}{2}} = \bar{f}_{\zeta,l}(M_0f^n) \in H^2(\mathbb{R}^d)$ . Then, using (16) to Taylor expand  $f_{\zeta,l}^{n+1}(\boldsymbol{a}) \equiv f_{\zeta,l}(t^n+k,\boldsymbol{a})$  implies whatever  $\boldsymbol{a} \in \mathbb{R}^d$ 

(17) 
$$f_{\zeta,l}^{n+1}(\boldsymbol{a}) = f_{\zeta,l}^{n+\frac{1}{2}}(\boldsymbol{a}) - k(c_{\zeta} \cdot \nabla) f_{\zeta,l}^{n+\frac{1}{2}}(\boldsymbol{a}) + \int_{t^n}^{t^{n+1}} (t^{n+1} - s) \partial_{tt}^2 f_{\zeta,l}(s, \boldsymbol{a}) ds$$

thus, using (9)–(10) and recalling the projection step  $f_{\zeta,l}^{n+\frac{1}{2}}(\boldsymbol{a}) = \bar{f}_{\zeta,l}(M_0 f^n(\boldsymbol{a})),$ 

(18) 
$$M_0 f_l^{n+1}(\boldsymbol{a}) = M_0 f_l^n(\boldsymbol{a}) - k \sum_{a=1}^d \partial_a F_a^l(M_0 f^n(\boldsymbol{a})) + \int_{t^n}^{t^{n+1}} (t^{n+1} - s) \partial_{tt}^2 M_0 f_l(s, \boldsymbol{a}) ds.$$

Eq. (18) can be compared with a Taylor expansion of  $q(nk + k, \mathbf{a})$  using (1) i.e.

(19) 
$$q_l((n+1)k, \boldsymbol{a}) = q_l(nk, \boldsymbol{a}) - k \sum_{a=1}^d \partial_a F_a^l(q(nk, \boldsymbol{a})) + \int_{t^n}^{t^{n+1}} (t^{n+1} - s) \partial_{tt}^2 q_l(s, \boldsymbol{a}) ds$$

where  $\partial_{tt}^2 q_l = \sum_{a,b=1}^d \sum_{m,m'=1}^L A_a^{lm} A_b^{mm'} \partial_{ab}^2 q_{m'}$  here in the linear flux case. Subtracting (19) from (18), moreover using (16) we obtain

$$(20) \quad q_l((n+1)k, \boldsymbol{a}) - M_0 f_l^{n+1}(\boldsymbol{a})$$

$$= q_l(nk, \boldsymbol{a}) - M_0 f_l^{n}(\boldsymbol{a}) - k \sum_{a=1}^{d} \sum_{m=1}^{L} \partial_m F_a^l(\partial_a q_m(nk, \boldsymbol{a}) - \partial_a M_0 f_m^n(\boldsymbol{a})) + R_l^n(\boldsymbol{a})$$

with a remainder  $R_l^n(\boldsymbol{a})$  that satisfies by Minkowski's inequality

(21)

$$||R^n||_0 \le k^2 \max_{a,b} \left( \max_{\zeta} |c_{\zeta}|^2 ||\partial_{ab}^2 M_0 f^n||_0 + \max_{a} ||A_a||_{\infty}^2 \sup_{s \in (t^n, t^{n+1})} ||\partial_{ab}^2 q||_0(s) \right).$$

Using also Minkowski's inequality with (20) yields

(22) 
$$\|q((n+1)k,\cdot) - M_0 f^{n+1}(\cdot)\|_0 \le \|q(nk,\cdot) - M_0 f^n(\cdot)\|_0$$
  
  $+ k \max_{a,l,m} |\partial_m F_a^l| \sum_{a=1}^d \|\partial_a q(nk,\cdot) - \partial_a M_0 f^n(\cdot)\|_0 + \|R^n\|_0.$ 

On the other hand, the following Taylor expansions

(23) 
$$M_0 f_l^{n+1}(\mathbf{a}) = M_0 f_l^n(\mathbf{a}) + \int_{t^n}^{t^{n+1}} \partial_t M_0 f_l(s, \mathbf{a}) ds$$

(24) 
$$q_l((n+1)k, \boldsymbol{a}) = q_l(nk, \boldsymbol{a}) + \int_{t^n}^{t^{n+1}} \partial_t q_l(s, \boldsymbol{a}) ds$$

yield, using differentiation by  $\partial_a$ , subtraction and Minkowski's inequality

$$(25) \quad \|\partial_{a}q(nk,\cdot) - \partial_{a}M_{0}f^{n}(\cdot)\|_{0} \leq \|\partial_{a}q((n-1)k,\cdot) - \partial_{a}M_{0}f^{n-1}(\cdot)\|_{0}$$

$$+ k \max_{b} \left( \max_{\zeta} |c_{\zeta}| \|\partial_{ab}^{2}M_{0}f^{n-1}\|_{0} + \max_{\alpha} \|A_{\alpha}\|_{\infty} \sup_{s \in (t^{n-1},t^{n})} \|\partial_{ab}^{2}q\|_{0}(s) \right).$$

Using (25) in (22) and iterating for  $n = N - 1 \dots 0$  yields

(26) 
$$\|q(T,\cdot) - M_0 f^N(\cdot)\|_0 \le \|q(0,\cdot) - M_0 f^0(\cdot)\|_0$$
  
  $+ (kN \equiv T) \max_a \|A_a\|_\infty \sum_{i=1}^d \|\partial_a q(0,\cdot) - \partial_a M_0 f^0(\cdot)\|_0 + C_T k$ 

that is (13), since (14) and (9) imply  $M_0 f^0 = q^0$ .

The proof above shows the consistency of kinetic schemes under the assumption (\*) to ensure the "luxurious"  $H^s$  stability (s=2) of the schemes (namely  $\max_{a,b} \|\partial_{ab}^2 M_0 f^n\|_0 \leq \max_{a,b} \|\partial_{ab}^2 q^0\|_0$ ). That condition (\*) is too strong: combined with (9) it leads to  $\bar{f}_{\zeta,l}(q) = \sum_m \Omega_{\zeta,m}^l q_m$  with  $\sum_\zeta \sum_m |\Omega_{\zeta,m}^l| \in (0,1)$  for all l which strongly limits the fluxes captured by (10). That is why we do not claim here to have proved any (interesting) convergence result about kinetic scheme and we do not proceed to a (cumbersome) extension of Prop. 1 to the case  $\omega=2$ . However, the analysis above can guide one further in the construction of kinetic schemes. Indeed note that the approximation of (24) by (23) is in fact one order higher than (25) (one can Taylor expand one order higher (24) and (23), next get further cancellation using (10)). Thus, a higher-order approximation than the first-order rate (13) can be reached when  $\omega=1$ : it suffices that the  $\frac{d(d+1)}{2}$  conditions

(27) 
$$M_{ab}\bar{f}_l(q) := \sum_{\zeta=0}^{Q-1} c^a_{\zeta} c^b_{\zeta} \bar{f}_{\zeta,l}(q) = \sum_{m,m'=1}^{L} A^{lm}_a A^{mm'}_b q_{m'} \quad \forall a,b = 1 \dots d$$

be satisfied so as to cancel the first remaining term in the difference of the Taylor expansions (19) and (18). Then one may want to require the  $\frac{d(d+1)}{2}$  conditions in the construction of convergent kinetic schemes. In fact, satisfying the  $\frac{d(d+1)}{2}$  conditions is impossible in general : see e.g. the next Section 3 where a practical application case is investigated. From the analysis of the main error term, a sensible choice to construct a kinetic scheme is then : minimize

(28) 
$$B_{ab,l}(q) := M_{ab}\bar{f}_l(q) - \sum_{m,m'=1}^{L} A_a^{lm} A_b^{mm'} q_{m'}$$

in some norm on  $\mathbb{R}^{\frac{d(d+1)}{2}}$ . Such a requirement for the construction of kinetic schemes seems new to us in the literature, although the matrix  $B(q) \in \mathbb{R}^{d \times L, d \times L}$  has already appeared (for instance, in [1, Prop. 1], the positivity of B(q) is shown a sufficient condition for the diffusivity of the equation formally satisfied by the approximation  $M_0f$  of q). In Section 4, we next investigate numerically the interest of such a requirement.

On the other hand, to construct kinetic schemes, one would also like to ensure sufficient stability conditions for the scheme (6) to converge. Now, other stability conditions less strong than (\*) can be found in the literature e.g. [6, 7, 8, 15, 16] which have already proved useful numerically in the case of nonlinear fluxes (even though rigorous convergence has not yet been proved to our knowledge), and which turn out compatible with (9) and (10). Precisely, denoting  $\eta^*(\varphi) := \sup_q (\varphi^T q - \eta(q))$  the Legendre transform of  $\eta$ , a  $C^2(\mathbb{R}^l)$  strictly convex functional of the entropy variable  $\varphi^l(q) := \partial_{q^l} \eta(q)$  while  $\partial_{q^l} \eta$  is a bijection onto  $\mathbb{R}^L$ , a "H-theorem" can further constrain  $\bar{f}$  [6, 7]:

**Proposition 2.** Assume there exist  $C^1$  convex functionals  $h_{\zeta}^*$  of  $\varphi$  such that

(29) 
$$\sum_{\zeta=0}^{Q-1} h_{\zeta}^{*}(\varphi) = \eta^{*}(\varphi) \quad \sum_{\zeta=0}^{Q-1} c_{\zeta}^{a} h_{\zeta}^{*}(\varphi) = G_{a}^{*}(\varphi)$$

hold, using  $G_a^*(\varphi) := \varphi^l F_a^l(q(\varphi)) - G_a(q(\varphi))$ . Then (9)–(10) hold on requiring

(30) 
$$\bar{f}_{\zeta,l}(q) = \frac{\partial h_{\zeta}^*}{\partial \varphi^l} \left( \varphi(q) \right) ,$$

as well as, on denoting  $h_{\zeta}(f_{\zeta}) = \sup_{\varphi} \left( \varphi^l f_{\zeta,l} - h_{\zeta}^*(\varphi) \right)$  for solutions to (3):

(31) 
$$\partial_t \left( \sum_{\zeta=0}^{Q-1} h_{\zeta}(f) \right) + \sum_{a=1}^d \partial_a \left( \sum_{\zeta=0}^{Q-1} c_{\zeta}^a h_{\zeta}(f) \right) \le 0.$$

The proof of Prop. 2 is straightforward by direct computations, follow e.g. [16] (in the present smooth case). The key point in (31) is that whatever  $\zeta$ , for all l it holds  $\partial_{f_{\zeta,l}} h_{\zeta}(f) = \varphi^l$  for all  $\zeta$ , with  $\varphi$  such that  $f_{\zeta,l} = \partial_{\varphi_l} h_{\zeta}^*(\varphi)$ , in particular  $\partial_{f_{\zeta,l}} h_{\zeta}(\bar{f}(q)) = \varphi^l(q) \equiv \partial_{q^l} \eta(q)$  whatever q.

The importance of requiring (a discrete equivalent to) Prop. 2 for numerical stability does not seem well established yet. But it can quite easily enforced here, see Section 3, and we shall therefore consider it here for the practical construction of kinetic schemes. Precisely, for linear symmetric-hyperbolic systems of conservation laws (1) such that  $q \in \mathbb{R}^L$  are actually the variables after symmetrization (i.e.  $F_a^l(q) = A_a^{lm} q_m$  with  $A_a^{lm} = A_a^{ml}$  for all  $a = 1 \dots d$ ,  $1 \le m, l \le L$ ) in particular, we require linear Maxwellians  $\bar{f}_{\zeta,l}(q) = \sum_{m=1}^L \Omega_{\zeta,l}^m q_m$  that satisfy (9) and (10) with symmetric positive matrices  $\Omega_\zeta \in \mathbb{R}^{L \times L}$  for all  $\zeta = 0 \dots Q - 1$ , further denoting  $[\Omega_\zeta]_{lm} = \Omega_{\zeta,l}^m$  their entries. On noting (30), this is equivalent to require  $h_\zeta(f_\zeta) = \frac{1}{2} \sum_{l,m=1}^L f_{\zeta,l} [\Omega_\zeta^{-1}]_{lm} f_{\zeta,m}$  where  $\Omega_\zeta^{-1}$  denotes the matrix inverse of  $\Omega_\zeta$  (standard inverse if  $\Omega_\zeta$  is strictly positive equiv. positive definite, or generalized well-defined by e.g. SVD in the semi-definite case). Then indeed, the following discrete version of Prop. 2 holds:

**Proposition 3.** Assume  $h_{\zeta}(f_{\zeta}) = \frac{1}{2} f_{\zeta,l}[\Omega_{\zeta}^{-1}]_{lm} f_{\zeta,m}$  then it holds for the kinetic scheme (6) if  $\omega = 1$ , or with equality if  $\omega = 2$ :

$$\sum_{\zeta=0}^{Q-1} h_{\zeta}(f_{\zeta}^{n+1}) + \int_{t^{n}}^{t^{n+1}} \sum_{a=1}^{d} \partial_{a} \left( \sum_{\zeta=0}^{Q-1} c_{\zeta}^{a} h_{\zeta}(f_{\zeta}) \right) ds \leq \sum_{\zeta=0}^{Q-1} h_{\zeta}(f_{\zeta}^{n})$$

where  $f_{\zeta}$  is the solution to the transport step of  $f^{n+\frac{1}{2}}$  to  $f^{n+1}$ 

Démonstration. The transport step of  $f^{n+\frac{1}{2}}$  to  $f^{n+1}$  satisfies

$$\partial_t h_{\zeta}(f_{\zeta}) + \sum_{a=1}^d \partial_a \left( c_{\zeta}^a h_{\zeta}(f_{\zeta}) \right) = 0$$

thus

$$h_{\zeta}(f_{\zeta}^{n+1}) + \int_{t^n}^{t^{n+1}} \sum_{a=1}^{d} \partial_a \left( c_{\zeta}^a h_{\zeta}(f_{\zeta}) \right) ds = h_{\zeta}(f_{\zeta}^{n+\frac{1}{2}})$$

while, using the convexity of  $h_{\zeta}$  and  $f_{\zeta,l}^{n+\frac{1}{2}} = \sum_{m'=1}^{L} [\Omega_{\zeta}]_{lm'} M_0 f_{m'}^n$ , it holds:

$$(32) \quad h_{\zeta}(f_{\zeta}^{n+\frac{1}{2}}) - h_{\zeta}(f_{\zeta}^{n}) \leq \partial_{f_{\zeta}} h_{\zeta}(f_{\zeta}^{n+\frac{1}{2}}) \cdot (f_{\zeta}^{n+\frac{1}{2}} - f_{\zeta}^{n})$$

$$= \sum_{m=1}^{L} f_{\zeta,l}^{n+\frac{1}{2}} [\Omega_{\zeta}^{-1}]_{lm} \left( \sum_{m'=1}^{L} [\Omega_{\zeta}]_{mm'} M_{0} f_{m'}^{n} - f_{\zeta,m}^{n} \right) = \sum_{m=1}^{L} M_{0} f_{m}^{n} \left( \sum_{m'=1}^{L} [\Omega_{\zeta}]_{mm'} M_{0} f_{m'}^{n} - f_{\zeta,m}^{n} \right)$$

where the last term in (32) satisfies

(33) 
$$\sum_{\zeta} \left( \sum_{m'=1}^{L} [\Omega_{\zeta}]_{mm'} M_0 f_{m'}^n - f_{\zeta,m}^n \right) = 0$$

which concludes the case  $\omega = 1$ . On the other hand, using  $x^2 - y^2 = (x+y)(x-y)$  and  $f_{\zeta,l}^{n+\frac{1}{2}} + f_{\zeta,l}^n = 2\sum_{m'=1}^L [\Omega_{\zeta}]_{lm'} M_0 f_{m'}^n$ , it holds when  $\omega = 2$ :

$$(34) \quad h_{\zeta}(f_{\zeta}^{n+\frac{1}{2}}) - h_{\zeta}(f_{\zeta}^{n}) = \frac{1}{2}\Omega_{\zeta}^{-1}(f_{\zeta,l}^{n+\frac{1}{2}} + f_{\zeta,l}^{n}) \cdot (f_{\zeta}^{n+\frac{1}{2}} - f_{\zeta}^{n})$$

$$= \sum_{m=1}^{L} M_{0} f_{m}^{n} \left( \sum_{m'=1}^{L} [\Omega_{\zeta}]_{mm'} M_{0} f_{m'}^{n} - f_{\zeta,m}^{n} \right)$$

and one again finishes the proof on noting that the last term in (34) satisfies (33).

A similar entropy stability as in Prop. 3 is proved in [20, Chapter 6] for the D1Q2 kinetic scheme applied to the scalar transport equation with  $\omega \in (1, 2)$ .

## 3. Construction of kinetic schemes for 2D elastodynamics

The 2-dimensional linear (Hookean) elastodynamics system reads

(35) 
$$\begin{cases} \partial_t \mathbb{F}_a^m - \partial_a u^m = 0\\ \partial_t u^m - c^2 \partial_a \mathbb{F}_a^m = 0 \end{cases}.$$

It governs the position  $\sum_{m=1}^2 x_m(t, \sum_{a=1}^2 \mathbf{a}_a E^a) e^m$  of a 2-dimensional body, in the Euclidean physical space equipped with a Cartesian coordinate system  $\{e^1, e^2\}$ , using Lagrangian coordinates in a Cartesian system  $\{E^1, E^2\}$  equipping a reference configuration of the body, assuming  $\mathbb{F}_a^m = \partial_a x^m$ ,  $u^m = \partial_t x^m$ .

It is a paradigmatic Friedrichs symmetrizable linear system of conservation laws:

$$q = (\sqrt{c}\mathbb{F}_1^1, \sqrt{c}\mathbb{F}_2^1, u^1/\sqrt{c}, \sqrt{c}\mathbb{F}_1^2, \sqrt{c}\mathbb{F}_2^2, u^2/\sqrt{c})$$

is solution to a symmetric-hyperbolic system of conservation laws. Noticeably, the linear homogeneous system (35), symmetrized in q, can be interpreted as a vectorial version of the (symmetrized) 2D linear acoustics system for  $r = (v, w, p) \in \mathbb{R}^3$ 

$$\partial_t r + A_1 \partial_1 r + A_2 \partial_2 r = 0$$

that governs velocities  $\sum_{a=1}^2 \sqrt{c} F_a^m E^a \sim v E^1 + w E^2$  and pressures  $u^m/\sqrt{c} \sim p$  in two fluids m=1,2 with (same) sound celerity c>0 parametrizing

$$A_1 = \left(\begin{array}{ccc} 0 & 0 & -c \\ 0 & 0 & 0 \\ -c & 0 & 0 \end{array}\right) \quad A_2 = \left(\begin{array}{ccc} 0 & 0 & 0 \\ 0 & 0 & -c \\ 0 & -c & 0 \end{array}\right).$$

Here, we develop our construction methodology of a kinetic scheme (based on elements from the previous sections) specifically for the symmetric system on 2D Cartesian grids with grid-size  $\Delta > 0$ . We consider either D2Q5 or D2Q9 sets of speeds  $c_{\zeta}$  (see details below). We require linear Maxwellians  $\bar{f}_{\zeta,l}(q) = \Omega^m_{\zeta,l}q_m$  satisfying (9), (10) and (29), which is natural insofar as  $\eta^*, G_1^*, G_2^*$  are quadratic functionals of  $\varphi$ . Moreover we require that the kinetic scheme preserves the spatial

isotropy of the 2D elastodynamics (i.e.  $(F_1^2, F_2^2, u^2)$  satisfies exactly the same dynamics as  $(F_1^1, F_2^1, u^1)$  when initial conditions are the same). So we look only for decompositions (29) of the form

(37) 
$$\partial_{\varphi^l} h_{1,\zeta}^{\star}(\varphi) = \begin{pmatrix} \Omega_{\zeta} & 0 \\ 0 & \Omega_{\zeta} \end{pmatrix} q^T$$

using symmetric-positive matrices  $\Omega_{\zeta} \in \mathbb{R}^{3\times 3}$  which obviously ensure :

**Proposition 4.** The numerical approximation  $\sum_{\zeta} f_{\zeta,l}$ ,  $l \in \{1,2,3\}$ , to  $(cF_1^1, cF_2^1, u^1/c)$  satisfies the same dynamics as the numerical approximation  $\sum_{\zeta} f_{\zeta,l}$ ,  $l \in \{4,5,6\}$ , to  $(cF_1^2, cF_2^2, u^2/c)$  when initial conditions are the same, and (37) holds.

We consider classical sets of kinetic speeds: either the standard D2Q5 case:

$$c_0 = (0,0);$$
  $c_1 = \lambda(1,0);$   $c_2 = \lambda(0,1);$   $c_3 = \lambda(-1,0);$   $c_4 = \lambda(0,-1)$ 

with Q = 5 speeds, or the standard D2Q9 case with four additional speeds:

$$c_5 = \lambda(1,1);$$
  $c_6 = \lambda(-1,1);$   $c_7 = \lambda(-1,-1);$   $c_8 = \lambda(1,-1)$ 

which both use grids with step size  $\Delta = k\lambda$ . Both cases possess symmetries: given one speed  $c_1$  in the material space  $\mathbb{R}^2$  equipped with the Cartesian basis  $\{E^1, E^2\}$ ,

$$c_{\zeta} = R_{\pi/2}^{\zeta - 1} c_1$$

holds for  $\zeta \in \{2, 3, 4\}$ , and

$$c_{\zeta} = R_{\pi/2}^{\zeta - 5} c_5$$

for  $\zeta \in \{6,7,8\}$  when Q = 9 and  $c_5 = c_1 + c_2$ , denoting

$$(38) R_{\pi/2} = \begin{pmatrix} 0 & -1 \\ 1 & 0 \end{pmatrix}$$

the (matrix representation of)  $\pi/2$ -rotation of  $\mathbb{R}^2$ . Now, for the numerical simulation on a *Cartesian* grid of homogeneous physics characterized by a uniform constant  $c^2$ , we naturally also require the preservation of the ambiant-space symmetries when possible at discrete level, e.g. the  $\pi/2$ -rotation.

Precisely, still denoting  $R_{\pi/2}$  the 3 × 3 matrix with 2 × 2 upper-left block (38) complemented by identity (and  $R_{-\pi/2}$  its inverse), we require that  $f_{\zeta}$  should satisfy exactly the same dynamics as  $R_{\pi/2}^{\zeta-1} f_{\zeta}$  when initial conditions are also rotated:

(39) 
$$\Omega_{\zeta} = R_{\pi/2}^{\zeta - 1} \Omega_1 R_{-\pi/2}^{\zeta - 1}$$

for  $\zeta \in \{2, 3, 4\}$  and

$$\Omega_{\zeta} = R_{\pi/2}^{\zeta-5} \Omega_5 R_{-\pi/2}^{\zeta-5}$$

for  $\zeta \in \{6, 7, 8\}$  when Q = 9.

**Proposition 5.** The numerical approximations  $(\sum_{\zeta} f_{\zeta,l})$  to  $(cF_1^1, cF_2^1, u^1/c)$  (with  $l \in \{1, 2, 3\}$ ) and to  $(cF_1^2, cF_2^2, u^2/c)$  (with  $l \in \{4, 5, 6\}$ ) are exactly the same as  $R_{-\pi/2}(\sum_{\zeta} f_{\zeta,l})$  after rotating the initial conditions similarly.

3.1. **D2Q5** scheme. Applying the contruction principles above to approximate linear elastodynamics with D2Q5 speeds, it remains to specify

$$\Omega_1 = \left(\begin{array}{ccc} \alpha & x & y \\ x & \beta & z \\ y & z & \gamma \end{array}\right)$$

insofar as  $\Omega_{2,3,4}$  can next be computed from  $\Omega_1$  using (39):

$$\Omega_2 = \begin{pmatrix} \beta & -x & -z \\ -x & \alpha & y \\ -z & y & \gamma \end{pmatrix}, \ \Omega_3 = \begin{pmatrix} \alpha & x & -y \\ x & \beta & -z \\ -y & -z & \gamma \end{pmatrix}, \ \Omega_4 = \begin{pmatrix} \beta & -x & z \\ -x & \alpha & -y \\ z & -y & \gamma \end{pmatrix}.$$

The consistency relations (29), equivalent to (9–10) with linear Maxwellians, impose

$$\lambda (\Omega_1 - \Omega_3) = \begin{pmatrix} 0 & 0 & -c \\ 0 & 0 & 0 \\ -c & 0 & 0 \end{pmatrix} \quad \lambda (\Omega_2 - \Omega_4) = \begin{pmatrix} 0 & 0 & 0 \\ 0 & 0 & -c \\ 0 & -c & 0 \end{pmatrix}$$

i.e.

$$y = -\frac{c}{2\lambda} \quad z = 0 \,,$$

and

(42) 
$$\Omega_0 = \begin{pmatrix} 1 - 2(\alpha + \beta) & 0 & 0 \\ 0 & 1 - 2(\alpha + \beta) & 0 \\ 0 & 0 & 1 - 4\gamma \end{pmatrix}.$$

So there remain infinitely many choices for a scheme like (6).

To ensure numerical stability, we moreover require Prop. 3, that is: all the matrices  $\Omega_{\zeta}$  should be positive. Here, in view of (41) we need only check that  $\Omega_{1}$  and  $\Omega_{0}$  are positive, i.e. all their principal minors are positive:

$$(43) \quad \alpha\beta \geq x^2, \quad \alpha\gamma \geq \frac{c^2}{4\lambda^2}, \quad \alpha, \beta, \gamma \geq 0, \qquad \alpha + \beta \leq 1/2, \quad \gamma \leq 1/4.$$

It is remarkable that here, for a  $3 \times 3$  SCL in two dimensions, the "(kinetic) entropy" conditions (43) imply the positivity of the symmetric matrix B(q) defined in (28), which specifically reads in  $\mathbb{R}^6$  here as

$$\begin{bmatrix} M_{11}\bar{f} - A_1A_1 & -A_1A_2 \\ -A_2A_1 & M_{22}\bar{f} - A_2A_2 \end{bmatrix}.$$

Indeed, our conditions (43) imply

$$\alpha \gamma \ge \frac{c^2}{4\lambda^2}, \frac{1}{4\gamma} \ge 1 \Rightarrow \alpha \ge \frac{c^2}{\lambda^2}$$

and

$$\alpha \gamma \ge \frac{c^2}{4\lambda^2}, \frac{1}{2\alpha} \ge 1 \Rightarrow \gamma \ge \frac{c^2}{2\lambda^2}$$

i.e.  $B(q) \ge 0$ . Now, although established for (discrete velocity) kinetic approximations of scalar equations [1, 20], that implication has not yet been proved generically, for kinetic approximations of any (symmetric-hyperbolic, multidimensional) SCL. Recall that one consequence of the positivity of B(q) is that the Chapman-Enskog expansion of the (discrete velocity) kinetic scheme is actually a diffusive approximation of the target SCL, which is a desired stability requirement, see [1].

One noticeable choice then corresponds to optimizing the accuracy of the scheme on aiming at (27) as "second-order" consistency conditions (equivalent to minimum numerical diffusion in the standard analysis by equivalent equations), where

$$\begin{split} M_{11}\bar{f} &\equiv \lambda^2(\Omega_1 + \Omega_3) = 2\lambda^2 \begin{pmatrix} \alpha & x & 0 \\ x & \beta & 0 \\ 0 & 0 & \gamma \end{pmatrix} \quad M_{12}\bar{f} = 0 = M_{21}\bar{f} \\ M_{22}\bar{f} &\equiv \lambda^2(\Omega_2 + \Omega_4) = 2\lambda^2 \begin{pmatrix} \beta & -x & 0 \\ -x & \alpha & 0 \\ 0 & 0 & \gamma \end{pmatrix} \quad A_1A_1 = \begin{pmatrix} c^2 & 0 & 0 \\ 0 & 0 & 0 \\ 0 & 0 & c^2 \end{pmatrix} \\ A_2A_2 &= \begin{pmatrix} 0 & 0 & 0 \\ 0 & c^2 & 0 \\ 0 & 0 & c^2 \end{pmatrix} \quad A_1A_2 = \begin{pmatrix} 0 & c^2 & 0 \\ 0 & 0 & 0 \\ 0 & 0 & 0 \end{pmatrix} \quad A_2A_1 = \begin{pmatrix} 0 & 0 & 0 \\ c^2 & 0 & 0 \\ 0 & 0 & 0 \end{pmatrix} . \end{split}$$

The "second-order" conditions (27) cannot be fully fullfilled, because  $M_{12}\bar{f}=0=M_{21}\bar{f}$ . But one can minimize numerical diffusion using  $\beta=0=x$  and e.g.

$$\underset{\{0 \leq \alpha \leq 1/2 \quad 0 \leq \gamma \leq 1/4 \quad \lambda^2 \geq \frac{c^2}{4\alpha\gamma}\}}{\operatorname{argmin}} J(\alpha,\gamma,\lambda) := \left(|2\lambda^2\alpha - c^2|^2 + |2\lambda^2\gamma - c^2|^2\right)$$

that is,

(44) 
$$\gamma = \frac{1}{4} \quad \alpha = \frac{1}{2} \quad \lambda = \sqrt{2}c$$

on noting J is smooth, coercive, constrained on bounded compact domain, with extremas reached on boundaries  $\alpha = \frac{1}{2}$ ,  $\gamma = \frac{1}{4}$  using "Lagrange multiplyers"  $\mu, \nu$ 

$$\gamma \lambda^2 = \frac{c^2}{2} + \frac{c^2 \mu}{\lambda^2} \quad \alpha \lambda^2 = \frac{c^2}{2} + \frac{c^2 \nu}{\lambda^2}$$

compatible with  $\lambda \geq \sqrt{2}c$ . In the sequel, we shall compare (44) with a more standard CFL  $\frac{1}{2}$ , i.e.  $\lambda = 2c$  (so  $\alpha \gamma \geq 1/16$ ), and three extremal values for  $\alpha, \gamma$ :

$$\gamma = \frac{1}{4} \quad \alpha = \frac{1}{2},$$
 or 
$$\gamma = \frac{1}{4} \quad \alpha = \frac{1}{4},$$
 and also 
$$\gamma = \frac{1}{8} \quad \alpha = \frac{1}{2}.$$

Note that when  $\gamma = \frac{1}{4}$ ,  $\alpha = \frac{1}{2}$ , the D2Q5 scheme is in fact a D2Q4 since  $\Omega_0 = 0$ .

3.2. **D2Q9 scheme.** Applying the contruction principles above with D2Q9 speeds, we have only to specify

$$\Omega_1 = \begin{pmatrix} \alpha & x & y \\ x & \beta & z \\ y & z & \gamma \end{pmatrix} \quad \Omega_5 = \begin{pmatrix} \tilde{\alpha} & \tilde{x} & \tilde{y} \\ \tilde{x} & \tilde{\beta} & \tilde{z} \\ \tilde{y} & \tilde{z} & \tilde{\gamma} \end{pmatrix}$$

but not less since it does not seem obvious to link  $\Omega_1$  and  $\Omega_5$  through symmetries of the Cartesian grid. The consistency relations (29) (or (9) and (10)) impose

$$(45) \quad \lambda \left(\Omega_{1} - \Omega_{3}\right) + \sqrt{2}\lambda \left(\Omega_{5} - \Omega_{6} - \Omega_{7} + \Omega_{8}\right) = \begin{pmatrix} 0 & 0 & -c \\ 0 & 0 & 0 \\ -c & 0 & 0 \end{pmatrix}$$
$$\lambda \left(\Omega_{2} - \Omega_{4}\right) + \sqrt{2}\lambda \left(\Omega_{5} + \Omega_{6} - \Omega_{7} - \Omega_{8}\right) = \begin{pmatrix} 0 & 0 & 0 \\ 0 & 0 & -c \\ 0 & -c & 0 \end{pmatrix}$$

i.e.

$$(46) 2\lambda(y + \sqrt{2}\tilde{y} - \sqrt{2}\tilde{z}) = -c$$

(47) 
$$2\lambda(z + \sqrt{2}\tilde{z} + \sqrt{2}\tilde{y}) = 0$$

(48) 
$$2\lambda(y + \sqrt{2}\tilde{z} - \sqrt{2}\tilde{y}) = -c$$

(49) 
$$2\lambda(z + \sqrt{2}\tilde{y} + \sqrt{2}\tilde{z}) = 0$$

SO

$$\tilde{y} = \tilde{z} = 0 = z$$
  $y = -\frac{c}{2\lambda}$ 

and

(50) 
$$\Omega_{0} = \begin{pmatrix} 1 - 2(\alpha + \beta + \tilde{\alpha} + \tilde{\beta}) & 0 & 0 \\ 0 & 1 - 2(\alpha + \beta + \tilde{\alpha} + \tilde{\beta}) & 0 \\ 0 & 0 & 1 - 4(\gamma + \tilde{\gamma}) \end{pmatrix}.$$

Furthermore, the positivity of  $\Omega_0, \Omega_1$  and  $\Omega_5$  requires :

(51) 
$$\alpha\beta \geq x^2$$
,  $\alpha\gamma \geq \frac{c^2}{4\lambda^2}$ ,  $\tilde{\alpha}\tilde{\beta} \geq \tilde{x}^2$ ,  $\tilde{\alpha}\tilde{\gamma} \geq 0$ ,  
 $\tilde{\alpha}, \tilde{\beta}, \tilde{\gamma} > 0, \alpha, \beta, \gamma > 0, \alpha + \beta + \tilde{\alpha} + \tilde{\beta} < 1/2, \gamma + \tilde{\gamma} < 1/4$ .

Finally, on computing

$$\begin{split} M_{11}\bar{f} &\equiv \lambda^2(\Omega_1 + \Omega_3) + 2\lambda^2(\Omega_5 + \Omega_6 + \Omega_7 + \Omega_8) = 2\lambda^2 \left( \begin{array}{ccc} \alpha + 2(\tilde{\alpha} + \tilde{\beta}) & x & 0 \\ x & \beta + 2(\tilde{\alpha} + \tilde{\beta}) & 0 \\ 0 & 0 & \gamma + 2\tilde{\gamma} \end{array} \right) \\ M_{12}\bar{f} &= M_{21}\bar{f} &\equiv 2\lambda^2(\Omega_5 - \Omega_6 + \Omega_7 - \Omega_8) = 2\lambda^2 \left( \begin{array}{ccc} 2(\tilde{\alpha} - \tilde{\beta}) & 4\tilde{x} & 0 \\ 4\tilde{x} & 2(\tilde{\beta} - \tilde{\alpha}) & 0 \\ 0 & 0 & 0 \end{array} \right) \\ M_{22}\bar{f} &\equiv \lambda^2(\Omega_2 + \Omega_4) + 2\lambda^2(\Omega_5 + \Omega_6 + \Omega_7 + \Omega_8) = 2\lambda^2 \left( \begin{array}{ccc} \beta + 2(\tilde{\alpha} + \tilde{\beta}) & -x & 0 \\ -x & \alpha + 2(\tilde{\alpha} + \tilde{\beta}) & 0 \\ 0 & 0 & \gamma + 2\tilde{\gamma} \end{array} \right) \end{split}$$

minimizing numerical diffusion leads, using (51), to

$$\beta = x = 0 = \tilde{\alpha} = \tilde{\beta} = \tilde{\gamma} = \tilde{x}, \ \lambda^2 = 2c^2, \ \gamma = \frac{1}{4}, \ \alpha = \frac{1}{2}$$

that is the D2Q5 scheme already constructed in the previous section! Nevertheless, to see the effect of a few additional celerities (i.e. kinetic directions), we could also

do the following choice:

(52) 
$$\beta = 0 \quad \gamma = \frac{1}{4} \quad \tilde{\alpha} = \tilde{\beta} = \tilde{x} = \frac{c^2}{16\lambda^2} \quad \lambda = \frac{3c}{2} \quad \text{and } \alpha = \frac{4}{9}.$$

#### 4. Numerical evaluation

Here we evaluate numerically our vectorial kinetic schemes built in Section 3, for the approximation in  $L^2(\mathcal{D})$ ,  $\mathcal{D} := \{\|\mathbf{a}\| \leq R\}$ , at t = T of solutions to (35) computed on  $\mathcal{D}_T \supset \{\|\mathbf{a}\| \leq R + cT\}$ ,  $t \in (0,T)$ . Note that the conditions used at the boundary  $\partial \mathcal{D}_T$  are not influential insofar as the simulation domain  $\mathcal{D}_T$  contains the dependence domain of  $\mathcal{D}$  at t = T. Simulations can be thus compared on  $\mathcal{D}$  with smooth analytical solutions to (35) on  $\mathbb{R}^d$ , which can be defined e.g. from

(53) 
$$(\partial_{tt}^2 - c^2 \sum_{\alpha=1}^d) u^m = 0 \text{ for } m = 1, 2$$

complemented with  $u^m|_{t=0}$  and  $\partial_t u^m|_{t=0} = c^2 \sum_{\alpha=1}^d \partial_\alpha F_\alpha^m|_{t=0}$ , also computable as

$$(54) \quad u^{m}(t, \boldsymbol{a}) = \partial_{t} \frac{1}{2\pi} \int_{D_{t, \boldsymbol{a}}} \frac{u^{m}|_{t=0}(\boldsymbol{b})}{\sqrt{c^{2}t^{2} - |\boldsymbol{a} - \boldsymbol{b}|^{2}}} d\boldsymbol{b} - \frac{1}{2\pi} \int_{D_{t, \boldsymbol{a}}} \frac{\partial_{t} u^{m}|_{t=0}(\boldsymbol{b})}{\sqrt{c^{2}t^{2} - |\boldsymbol{a} - \boldsymbol{b}|^{2}}} d\boldsymbol{b}$$

where  $D_{t,a} := \{ b, c^2 t^2 \ge |a - b|^2 \}$  is the domain of influence on the solution at (t,a). Focusing here on axisymmetric solutions (that depend only on r > 0 the distance to the origin), let us introduce the (zero-order) Hankel transform of  $u^m$ 

$$\widetilde{u^m}(k,t) = \int_0^\infty r J_0(kr) u^m(r,t) dr$$

where  $J_0$  is zero-order Bessel function, also often denoted  $\mathcal{H}_0(u^m)(k,t)$ . It satisfies

$$\int_0^\infty \partial_r \left( r \partial_r u^m(r,t) \right) J_0(kr) dr = -k^2 \tilde{u}^m(k,t)$$

so one can also compute solutions to (53) by

(55) 
$$u^m(t,r) = \int_0^\infty \left( \widetilde{u^m}|_{t=0}(k) \cos(ckt) + \partial_t \widetilde{u^m}|_{t=0}(k) \frac{\sin(ckt)}{c} \right) J_0(kr)kdk.$$

For instance, recalling  $r^2 = ||\boldsymbol{a}||^2$ , choosing  $\partial_t u^m|_{t=0} = 0 = \sum_{\alpha=1}^d \partial_\alpha F_\alpha^m|_{t=0}$  and  $u^m|_{t=0}(r) = \kappa e^{-\mu r^2}$  yields [13, Chap.7]  $u^m|_{t=0}(k) = \frac{\kappa}{2\mu} e^{-\frac{k^2}{4\mu}}$  so

(56) 
$$u^{m}(t,r) = \frac{\kappa}{2\mu} \int_{0}^{+\infty} e^{-\frac{k^{2}}{4\mu}} \cos(ckt) J_{0}(kr) k dk = \mathcal{H}_{0}\left(\frac{\kappa}{2\mu} e^{-\frac{k^{2}}{4\mu}} \cos(ckt)\right) (t,r).$$




FIGURE 1. Solution (56) for  $\kappa=1, \mu=2$  computed at  $t\in\{0;0.5;1;2\}$  as a function of r using gsl.

The latter analytic solution can be numerically computed with high precision given r, see e.g. the solution plot in Fig. 1 using the open-source  $gsl^{1}$ .

For benchmarking purposes, we also compute numerical approximations using other discretization methods on the same uniform Cartesian grid of  $\mathcal{D}_T$ , with square cells  $\Delta \times \Delta$  centered at  $a_{ij}$ ,  $ij \in \mathcal{I} := \{-I, -I+1, \ldots, I\}$   $(I \in \mathbb{N})$ , ensuring a finite propagation speed of the information through time-explicit schemes. We impose as initial condition  $u_0(r) = \kappa e^{-\mu r^2}$  for  $\kappa = 1, \mu = 2$ , with  $r = \sqrt{x_i^2 + y_j^2}$  at cell centers  $(x_i, y_j) \in \mathcal{D}_T := (-4, 4)^2$  in the FV case (i.e. simply grid points in the FD case).

A mesh convergence study is plotted on Fig. 2 when R=2,  $c=\frac{1}{\sqrt{2}}$  at T=1. Our proposed D2Q5 vectorial kinetic schemes are compared one another, when  $\omega=1$  and when  $\omega=2$ , with first and second order FV schemes detailed in Appendix A.2.

First, our numerical experiments show the convergence of the vectorial kinetic schemes, at rates  $O(\Delta)$  and  $O(\Delta^2)$  respectively when  $\omega=1$  and when  $\omega=2$ , whenever the parameters  $\lambda,\alpha,\gamma$  satisfy (43). It is remarkable that when only the less stringent conditions  $\alpha\geq\frac{c^2}{\lambda^2},\,\gamma\geq\frac{c^2}{2\lambda^2}$  (so  $B(q)\geq0$ ) are satisfied strictly (i.e.  $\lambda< c\sqrt{2}$  and (43) are not all satisfied) then we observe numerical instabilities. For instance, our D2Q5 schemes all blow up with  $\Delta=2^{-9}\equiv.001953125$  when  $\lambda=c(\sqrt{2}-.1)$  whatever  $\omega\in(1,2)$ , and for  $\omega\geq1.9$  when  $\lambda=c(\sqrt{2}-.01)$ . Such numerical results are not surprising in view of previous results [1, 20]. A full rigorous theory regarding the necessary/sufficient conditions for convergence of the kinetic schemes toward SCL however remains needed.

Second, we observe that the kinetic schemes with largest  $CFL=1/\sqrt{2}$ , i.e. using  $\lambda=\sqrt{2}c,\ \gamma=1/4,\ \alpha=1/2$  are the most accurate at both first and second order  $(\omega=1,\ \omega=2)$ . That parameter choice was motivated by minimizing the numerical diffusion when  $\omega=1$  (recall the proof of Prop. 1). The D2Q9 schemes using a slightly more diffusive CFL coefficient  $\lambda=3c/2$  from (52) are second best, next come the cases  $\lambda=2c$  corresponding to a 1/2 CFL condition. Moreover, when simulated with  $\omega=1$  or 2 in the stability region of Prop. 3, different (admissible) values of  $\alpha,\gamma$  have remarkable impact on the accuracy of numerical solution. This also call for further studies (of the discretization error), theoretically and numerically (note that  $\beta\neq 0,\ x\neq 0$  in the Maxwellians has not been tested here.)

Interestingly, we observe that the convergences of the first order FV scheme and that of the first order kinetic scheme with  $\lambda = 2c, \gamma = 1/4 = \alpha$  are superimposed,

which is not surprising insofar as, recalling  $\lambda = \frac{\Delta}{k}$ , the scheme

$$q_{i,j}^{n+\frac{1}{2}} = \Omega_0 q_{i,j}^{n-\frac{1}{2}} + \Omega_1 q_{i-1,j}^{n-\frac{1}{2}} + \Omega_2 q_{i,j-1}^{n-\frac{1}{2}} + \Omega_3 q_{i+1,j}^{n-\frac{1}{2}} + \Omega_4 q_{i,j+1}^{n-\frac{1}{2}}$$

that results from LBM for the first-order moments when  $\lambda=2c$  i.e.

$$\Omega_1 = \begin{pmatrix} \frac{1}{4} & 0 & -\frac{1}{4} \\ 0 & 0 & 0 \\ -\frac{1}{4} & 0 & \frac{1}{4} \end{pmatrix} \quad \Omega_0 = \begin{pmatrix} \frac{1}{4} & 0 & 0 \\ 0 & \frac{1}{4} & 0 \\ 0 & 0 & 0 \end{pmatrix}$$

then exactly coincides with the first-order FV scheme at CFL  $\frac{1}{2}$ , see (62–63–64) in Appendix A.2. Similarly, the second-order numerical results for the Yee scheme look very much like those for the kinetic scheme with  $\lambda = 2c, \gamma = 1/8, \alpha = 1/2$ .




FIGURE 2. Errors in  $L_2(\{\|\mathbf{a}\| \leq 2\})$  of approximations of (56) at t=1 when  $\kappa=1, \ \mu=2, \ c=\frac{1}{\sqrt{2}},$  by (i) various D2Q5, D2Q9 kinetic schemes, with various values of parameters  $\alpha, \gamma, \lambda, \omega$ , and (ii) the FD, FV schemes with CFL = 1/2 – on  $\mathcal{D}_T=(-4,4)^2$  –.

#### Annexe A. Finite Difference and Finite Volume schemes

A.1. Finite-Difference scheme. Each "acoustic" sub-system  $(cF_1^m, cF_2^m, u^m) \equiv (v, w, p)$  for m = 1, 2 can be numerically simulated using a standard (leap-frog, centered) Finite-Difference scheme, often named after Yee [25]. Denoting staggered nodal approximations

$$p^n_{ij} \approx p(t^n, i\Delta, j\Delta) \quad w^{n+\frac{1}{2}}_{ij+\frac{1}{2}} \approx w(t^n + \frac{k}{2}, i\Delta, j\Delta + \frac{\Delta}{2}) \quad v^{n+\frac{1}{2}}_{i+\frac{1}{2}, j} \approx w(t^n + \frac{k}{2}, i\Delta + \frac{\Delta}{2}, j\Delta)$$

the following Yee scheme writes

(57) 
$$v_{i+\frac{1}{2},j}^{n+\frac{1}{2}} = v_{i+\frac{1}{2},j}^{n-\frac{1}{2}} + \frac{ck}{\Lambda} (p_{i+1,j}^n - p_{ij}^n)$$

(58) 
$$w_{ij+\frac{1}{2}}^{n+\frac{1}{2}} = w_{ij+\frac{1}{2}}^{n-\frac{1}{2}} + \frac{ck}{\Lambda} (p_{ij+1}^n - p_{ij}^n)$$

$$(59) p_{ij}^{n+1} = p_{ij}^n + \frac{ck}{\Delta} \left( v_{i+\frac{1}{2},j}^{n+\frac{1}{2}} - v_{i-\frac{1}{2},j}^{n+\frac{1}{2}} + w_{ij+\frac{1}{2}}^{n+\frac{1}{2}} - w_{ij-\frac{1}{2}}^{n+\frac{1}{2}} \right)$$

yields approximations such as the space-continuous reconstructions

$$\sum_{ij\in\mathcal{I}} p_{ij}^n \psi_{ij} \approx p(t^n) \quad \sum_{ij\in\mathcal{I}} w_{ij+\frac{1}{2}}^n \psi_{ij+\frac{1}{2}} \approx w(t^n) \quad \sum_{ij\in\mathcal{I}} v_{i+\frac{1}{2},j}^n \psi_{i+\frac{1}{2},j} \approx v(t^n)$$

using the tensor-product  $\mathbb{Q}_{1,2}$  Finite-Element basis functions  $\psi_{ij}, \psi_{i+\frac{1}{2},j}, \psi_{i+\frac{1}{2},j}$ . The latter converges in  $L^2(\mathcal{D})$  to smooth  $(v, w, p) \in H^2(\mathbb{R}^2)$  with an error rate  $O(\Delta^2)$  as  $\Delta = ck \to 0$  [24]. A proof for p consists in bounding above the RHS of

(60) 
$$\|p(t^n) - \sum_{ij \in \mathcal{I}} p_{ij}^n \psi_{ij}\|_{L^2(\mathcal{D})} \le \|p(t^n) - \sum_{ij \in \mathcal{I}} p(t^n, i\Delta, j\Delta) \psi_{ij}\|_{L^2(\mathcal{D})}$$
  
  $+ \sup_{ij \in \mathcal{I}} \|\psi_{ij}\|_{L^2(\mathcal{D})} \sqrt{\sum_{ij \in \mathcal{I}} |p(t^n, i\Delta, j\Delta) - p_{ij}^n|^2}$ 

by the sum of an upper-bound for each term : the first term in RHS of (60) can be bounded above by  $C_1\Delta^2\|p(t^n)\|_{H^2(\mathcal{D})}$  with a constant  $C_1$  function of p but independent of  $\Delta$  using a standard interpolation result and the second term in RHS of (60) can be bounded above by  $C_2\Delta^2\sup_{t\in[0,t^n]}\|p(t)\|_{H^2(\mathcal{D})}$  using a standard a priori analysis for the pointwise errors like  $p(t^n,i\Delta,j\Delta)-p_{ij}^n$  which are solution to (57–58–59) with additional error terms due to Taylor approximation (the bound holds thanks to the discrete  $\ell^2$  stability of the scheme and the consistency of the initial conditions). Smoothness of the reference solution is key to the error estimation.

A.2. **Finite-Volume methods.** Explicit-in-time Finite-Volume (FV) methods (using time discretization like the Euler forward method) are also standardly used to discretize (35). Unlike the FD method above, they provide one with *co-located* cell-averaged approximations  $q_{ij}^n$  for  $q(t^n, x, y) = (F_1^m, F_2^m, u^m)$  over the control volumes  $C_{ij} = (i\Delta \pm \frac{\Delta}{2}, j\Delta \pm \frac{\Delta}{2})$  defined by

$$q_{ij}^n \approx \frac{1}{\Delta^2} \int_{C_{ij}} q(t^n, x, y) dx dy.$$

The generic FV scheme writes

(61) 
$$q_{ij}^{n+1} = q_{ij}^n + \frac{k}{\Lambda} (\mathcal{F}_{i,j-\frac{1}{2}} + \mathcal{F}_{i-\frac{1}{2},j} - \mathcal{F}_{i,j+\frac{1}{2}} - \mathcal{F}_{i+\frac{1}{2},j})$$

which requires formulas for the numerical fluxes  $\mathcal{F}_{i\pm\frac{1}{2},j}$  and  $\mathcal{F}_{i,j\pm\frac{1}{2}}$  approximating the fluxes  $F_a(q)$  of the conservation laws (1) at cell faces

$$\begin{split} \mathcal{F}_{i\pm\frac{1}{2},j} &\simeq \frac{1}{k\Delta} \int_{t^n}^{t^{n+1}} \int_{y_{j-\frac{1}{2}}}^{y_{j+\frac{1}{2}}} F_1(q(x_{i\pm\frac{1}{2}},y,t)) dy dt, \\ \mathcal{F}_{i,j\pm\frac{1}{2}} &\simeq \frac{1}{k\Delta} \int_{t^n}^{t^{n+1}} \int_{x_{i-\frac{1}{2}}}^{x_{i+\frac{1}{2}}} F_2(q(x,y_{j\pm\frac{1}{2}},t)) dx dt. \end{split}$$

A standard Two-Points (TP) flux is the *upwind* flux which yields for each "acoustic" sub-system with variable  $(F_1^m, F_2^m, u^m) \equiv (v, w, p), m \in \{1, 2\}$ 

(62) 
$$v_{ij}^{n+1} = v_{ij}^{n} + \frac{kc}{2\Delta} (p_{i+1,j}^{n} - p_{i-1,j}^{n} - 2v_{ij}^{n} + v_{i+1,j}^{n} + v_{i-1,j}^{n})$$

$$(63) \qquad w_{ij}^{n+1} = w_{ij}^{n} + \frac{kc}{2\Delta} (p_{ij+1}^{n} - p_{ij-1}^{n} - 2w_{ij}^{n} + w_{ij+1}^{n} + w_{ij-1}^{n})$$

$$p_{ij}^{n+1} = p_{ij}^{n} + \frac{kc}{2\Delta} (v_{i+1,j}^{n} - v_{i-1,j}^{n} + w_{ij+1}^{n} - w_{ij-1}^{n} - 4p_{ij}^{n} + p_{ij+1}^{n} + p_{ij-1}^{n} + p_{i-1,j}^{n} + p_{i-1,j}^{n})$$

$$(64) \qquad (64)$$

where, in comparison with the "staggered" scheme (57–59), new terms appear that are not obviously consistent but can be interpreted as artificial diffusion, small as  $O(\Delta^2)$  noticeably. Now, as is well-known, the latter "non-consistent" terms do not prevent convergence : in the case of smooth solutions, the  $O(\Delta^2)$  scaling of those terms even preserves for (62–64) the convergence rate observed for (57–59). A proof is as follows: Consistency errors  $V^n_{ij} = v^n_{ij} - v(kn, \Delta i, \Delta j)$ ,  $W^n_{ij} = w^n_{ij} - w(kn, \Delta i, \Delta j)$ ,  $P^n_{ij} = p^n_{ij} - p(kn, \Delta i, \Delta j)$  satisfy

(65) 
$$V_{ij}^{n+1} = V_{ij}^n + \frac{kc}{2\Delta} (P_{i+1,j}^n - P_{i-1,j}^n - 2V_{ij}^n + V_{i+1,j}^n + V_{i-1,j}^n) + RV_{ij}^n$$

$$(66) W_{ij}^{n+1} = W_{ij}^n + \frac{kc}{2\Delta} (P_{ij+1}^n - P_{ij-1}^n - 2W_{ij}^n + W_{ij+1}^n + W_{ij-1}^n) + RW_{ij}^n$$

(67) 
$$P_{ij}^{n+1} = P_{ij}^{n} + \frac{kc}{2\Delta} (V_{i+1,j}^{n} - V_{i-1,j}^{n} + W_{ij+1}^{n} - W_{ij-1}^{n} - 4P_{ij}^{n} + P_{ij+1}^{n} + P_{ij-1}^{n} + P_{i+1,j}^{n} + P_{i-1,j}^{n}) + RP_{ij}^{n}$$

using Taylor formulas, with remainder terms  $O(k^2) + O(\Delta^2)$ 

$$(68) \quad RV_{ij}^{n} = -\int_{t^{n}}^{t^{n+1}} (t^{n+1} - t) \partial_{tt}^{2} v(t, i\Delta, j\Delta) dt$$

$$+ \frac{kc}{2\Delta} \int_{i\Delta}^{(i+1)\Delta} ((i+1)\Delta - x) \partial_{xx}^{2} p(kn, x, j\Delta) dx - \frac{kc}{2\Delta} \int_{i\Delta}^{(i-1)\Delta} ((i-1)\Delta - x) \partial_{xx}^{2} p(kn, x, j\Delta) dx$$

$$+ \frac{kc}{2\Delta} \int_{i\Delta}^{(i+1)\Delta} ((i+1)\Delta - x) \partial_{xx}^{2} v(kn, x, j\Delta) dx + \frac{kc}{2\Delta} \int_{i\Delta}^{(i-1)\Delta} ((i-1)\Delta - x) \partial_{xx}^{2} v(kn, x, j\Delta) dx$$

$$(69) \quad RW_{ij}^{n} = -\int_{t^{n}}^{t^{n+1}} (t^{n+1} - t) \partial_{tt}^{2} w(t, i\Delta, j\Delta) dt$$

$$+ \frac{kc}{2\Delta} \int_{(i\Delta)}^{(j+1)\Delta} ((j+1)\Delta - y) \partial_{yy}^{2} p(kn, i\Delta, y) dy + \frac{kc}{2\Delta} \int_{(i\Delta)}^{(j-1)\Delta} ((j-1)\Delta - y) \partial_{yy}^{2} p(kn, i\Delta, y) dy$$

as long as (v,w,p) are  $C^2$  smooth solutions. Then, on a square domain  $[0,1]^2$  with periodic boundary conditions say (for the sake of simplicity : see our numerical Section 4 for an illustration when that situation applies), one can study convergence using the Fourier modes  $\hat{Q}^n_{gh}$  of the error vector  $Q^n_{ij} = \sum_{g,h \in \mathbb{N}^2} \hat{Q}^n_{gh} e^{2i\pi(ig+hj)} \in \mathbb{R}^3$  with components  $V^n_{ij} = v^n_{ij} - v(kn, \Delta i, \Delta j), \ W^n_{ij} = w^n_{ij} - w(kn, \Delta i, \Delta j), \ P^n_{ij} = p^n_{ij} - p(kn, \Delta i, \Delta j)$  following Von Neumann. The Fourier modes satisfy

$$\hat{Q}_{gh}^{n+1} = C(g,h)\hat{Q}_{gh}^{n} + \hat{R}_{gh}^{n}$$

with C(g,h) the amplification matrix of the linear scheme (65–66–68), and C(g,h) is power-bounded as long as  $k \in (\epsilon_0, \frac{2}{c})\Delta$  see e.g. [17, 11]: then the upwind scheme is  $\ell^2$  stable and convergence to smooth solutions holds at "first order" i.e.

$$\sqrt{\sum_{ij}|Q_{ij}^N|^2 = \sum_{gh}|\hat{Q}_{ij}^N|^2} \le \mathcal{C}_N \Delta$$

with  $C_N$  independent of  $\Delta$ , insofar as  $R_{gh}^n = O(k^2 + \Delta^2)$  and  $\sum_{ij} |Q_{ij}^0|^2 = O(\Delta^2)$ . To improve the convergence rate, one classically considers

(71) 
$$q_{ij}^{(1)} = q_{ij}^n + \frac{k}{\Delta} (\mathcal{F}_{i,j-\frac{1}{2}} + \mathcal{F}_{i-\frac{1}{2},j} - \mathcal{F}_{i,j+\frac{1}{2}} - \mathcal{F}_{i+\frac{1}{2},j}),$$

(72) 
$$q_{ij}^{n+1} = \frac{q_{ij}^n}{2} + \frac{q_{ij}^{(1)}}{2} + \frac{k}{2\Delta} (\mathcal{F}_{i,j-\frac{1}{2}}^{(1)} + \mathcal{F}_{i-\frac{1}{2},j}^{(1)} - \mathcal{F}_{i,j+\frac{1}{2}}^{(1)} - \mathcal{F}_{i+\frac{1}{2},j}^{(1)})$$

based on a second-order time-integrator like RK2 method instead of (61), with numerical fluxes  $\mathcal{F}_{i,j\pm\frac{1}{2}}^{/(1)}$ ,  $\mathcal{F}_{i\pm\frac{1}{2},j}^{/(1)}$  consistently improved, i.e. using at cell faces a piecewise bilinear reconstruction of the fields q. Precisely, the numerical fluxes are computed from the value of reconstructed variables  $\tilde{q}$  evaluated at cell faces rather

than the cell value q. A linear reconstruction  $\tilde{q}$  on a cell  $C_{ij}$  has the form

(73) 
$$\tilde{q}(x,y) = c_0 + c_1 \varphi_1(x,y) + c_2 \varphi_2(x,y)$$

with  $c_0, c_1, c_2$  coefficients to be determinated, using basis functions with zero mean:

$$\varphi_1 = \frac{x - x_i}{\Lambda}, \quad \varphi_2 = \frac{y - y_j}{\Lambda}.$$

The coefficients  $c_k$  are typically defined such that  $\tilde{q}$  conserves exactly cell-averaged value  $q_0 = q_{ij}^n$  on the central cell  $C_0 = C_{ij}$ , so  $c_0 = q_0$ , while it matches some averaged state for a given set  $\{C_l\}_l$  of neighbour cells in a *least-square sense*:

$$\tilde{q} = \arg\min \sum_{C_l} \left( q_l - \frac{1}{\Delta^2} \int_{C_l} \tilde{q} dx dy \right)^2.$$

Consequently, the coefficients  $c_1$  and  $c_2$  are least-square solution of the (overdeterminated) linear system

$$\sum_{k=1}^{2} c_k \bar{\varphi}_{kl} = q_l - q_0$$

with  $\bar{\varphi}_{kl} = \frac{1}{\Delta^2} \int_{C_l} \varphi_k dx dy$ , i.e. the averaged value of the basis function  $\varphi_k$  over  $C_l$ . Introducing the matrix  $\mathbf{A}$  whose coefficients are  $A_{kl} = \bar{\varphi}_{kl}$  and denoting  $\mathbf{B} = (\mathbf{A}^T \mathbf{A})^{-1} \mathbf{A}^T$  (easily pre-computed for the case of Cartesian mesh) one obtains

(74) 
$$c_k = \sum_{l} B_{kl} (q_l - q_0).$$

In the D2Q5 case with neighbour cells  $\{C_l\}_l = \{C_1, C_2, C_3, C_4\}$  we obtain

$$\mathbf{A} = \begin{pmatrix} 1 & 0 \\ 0 & 1 \\ -1 & 0 \\ 0 & -1 \end{pmatrix}, \quad \mathbf{B} = \begin{pmatrix} \frac{1}{2} & 0 & -\frac{1}{2} & 0 \\ 0 & \frac{1}{2} & 0 & -\frac{1}{2} \end{pmatrix},$$
$$c_1 = \frac{q_1 - q_3}{2}, \quad c_2 = \frac{q_2 - q_4}{2}.$$

The resulting linear reconstruction  $\tilde{q}$  is none other than the classical centered discretization of gradient in each direction.
