

Asymptotics for the number of domino tilings of L-shaped Aztec domains

Abstract

We obtain precise asymptotics for the weighted number of domino tilings of an L-shaped subset of the Aztec diamond, obtained by removing an approximate rectangle in a corner of the Aztec diamond. By tuning the size of the removed corner, we observe different types of asymptotics. For a small removed corner, the number of tilings is close to that of the full Aztec diamond. Enlarging the removed corner to a critical size, a phase transition described in terms of the Tracy-Widom distribution occurs. Further increasing the size of the removed region, we observe a sharp decrease of the number of tilings, until it is finally approximated by the number of tilings of two smaller disjoint Aztec diamonds. We obtain uniform asymptotics for the number of domino tilings which fully describe these transitions.

1 Introduction and main results

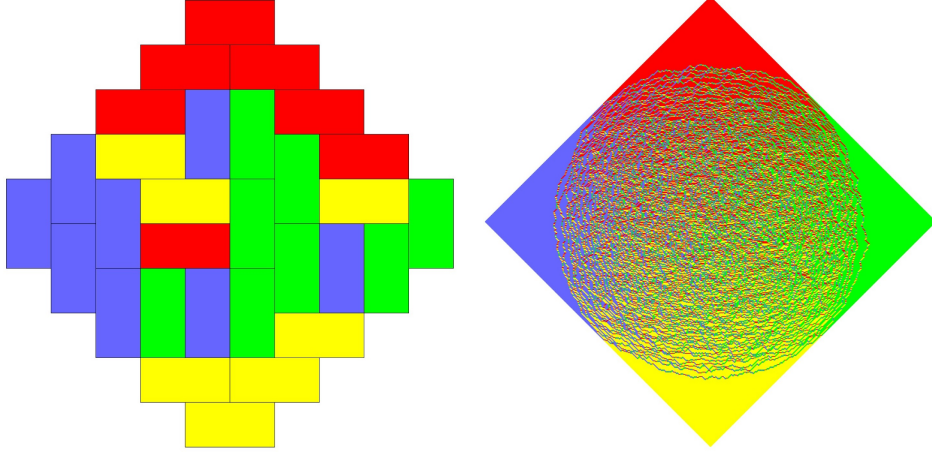


Figure 1: Left: a domino tiling of A_5 . The north, south, east and west dominoes are shown in red, yellow, green and blue, respectively. Right: a domino tiling of A_{300} chosen uniformly at random.

Domino tilings of L-shaped domains. The Aztec diamond A_N of order N is a two-dimensional region consisting of the union of all $2N(N+1)$ squares $S_{j,k} := [j, j+1] \times [k, k+1] \subset \mathbb{R}^2$ for which $j, k \in \mathbb{Z}$ and $S_{j,k} \subset \{(x, y) \in \mathbb{R}^2 : |x| + |y| \leq N+1\}$. A domino is a rectangle covering two adjacent unit squares: vertical dominoes have the form $[j, j+1] \times [k, k+2]$, while horizontal dominoes have the form $[j, j+2] \times [k, k+1]$. A horizontal domino is called a north or south domino depending on whether $j+k+N$ is even or odd, respectively. Similarly, a vertical domino is called an east or west domino depending on whether $j+k+N$ is even or odd, respectively. A domino tiling T of A_N consists of a collection of dominoes covering exactly the region A_N while the interiors of the dominoes are disjoint, see Figure 1.

Domino tilings of the Aztec diamond as well as lozenge tilings of hexagons have been investigated intensively over the past decades because of their intriguing large N asymptotic behavior and their connections with statistical physics models and random matrix theory, see e.g. [3, 7, 21, 31, 27, 28]. Determinantal structures underlying the tiling models have provided a powerful framework to study their asymptotics and to identify phase transitions.

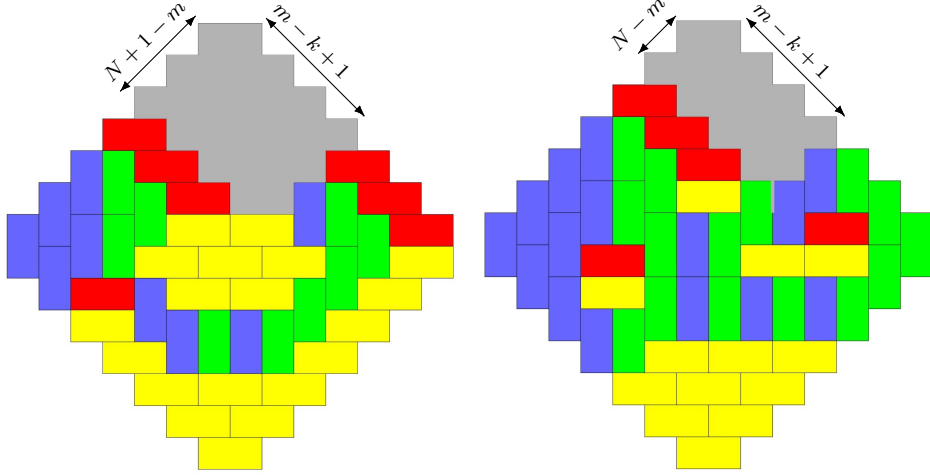


Figure 2: Left: a domino tiling of $A_7^{5,2}$. Right: a domino tiling of $\tilde{A}_7^{5,2}$.

In the present work, we consider domino tilings of reduced, approximately L-shaped, Aztec diamonds, of the form illustrated in Figure 2. More precisely, for $m = 1, \dots, N$ and $k = 1, \dots, m+1$, $A_N^{m,k}$ is the union of all unit squares $S_{i,j}$ for which $i, j \in \mathbb{Z}$ and

$$S_{i,j} \subset \{(x, y) \in \mathbb{R}^2 : |x| + |y| \leq N+1 \text{ and } y \leq \max\{2m-1-N-x, x-2m-1+N+2k\}\}.$$

We also consider a slightly modified domain $\tilde{A}_N^{m,k}$ as

$$\tilde{A}_N^{m,k} = \begin{cases} A_N^{m+1,k+1} \setminus v^{m,k}, & \text{if } m \in \{0, 1, \dots, N-1\}, \\ A_N, & \text{if } m = N, \end{cases}$$

where $v^{m,k}$ is the vertical segment from $(2m+k-N-1, k-1)$ to $(2m+k-N-1, k)$.

A domino tiling of $A_N^{m,k}$ or $\tilde{A}_N^{m,k}$, i.e., a collection of dominoes covering exactly the domain while the interiors of the dominoes are disjoint, can be canonically extended to a domino tiling of A_N by completing it with north dominoes.

Colomo and Pronko [13, 14] initiated the study of this model in order to compute the free energy of the fermionic six-vertex model on an L-shaped domain. Domino tilings of a different type of perturbations of Aztec diamonds have been studied in [16, 20, 33]. Our objective is to understand the large N asymptotics for

$$F_N^{m,k}(a; \epsilon) := \begin{cases} \sum_{T \in \mathcal{T}(A_N^{m,k})} a^{v(T)}, & \text{if } \epsilon = 1, \\ \sum_{T \in \mathcal{T}(\tilde{A}_N^{m,k})} a^{v(T)}, & \text{if } \epsilon = 0, \end{cases} \quad 0 < a \leq 1, \quad (1.1)$$

when m is proportional to N , uniformly for $k \in \{1, \dots, m\}$. (For $k \leq 0$, the domains $A_N^{m,k}$ and $\tilde{A}_N^{m,k}$ are not tileable [10, Remark 2.2], whereas for $k \geq m+1$ the removed region is empty.)

For $a = 1$, $F_N^{m,k}(1; \epsilon)$ is equal to the number of domino tilings of the domain $A_N^{m,k}$ if $\epsilon = 1$ and of the domain $\tilde{A}_N^{m,k}$ if $\epsilon = 0$. For $0 < a < 1$, it can be seen as the generating function for the number of domino tilings with a prescribed number of vertical dominoes. For the full Aztec diamond A_N , a celebrated result of Elkies, Kuperberg, Larsen, and Propp [23] states that this generating function is explicitly given by

$$F_N(a) := \sum_{T \in \mathcal{T}(A_N)} a^{v(T)} = (1 + a^2)^{\frac{N(N+1)}{2}}, \quad 0 < a \leq 1, \quad (1.2)$$

such that in particular, the number of domino tilings of A_N is $2^{N(N+1)/2}$. Observe for $k = m+1$ that $F_N(a; \epsilon) = F_N^{m,m+1}(a; \epsilon)$ for any $m \in \{1, \dots, N\}$ and $\epsilon \in \{0, 1\}$.

Another degenerate situation arises when $k = 1$: as shown in [10, Equation (1.3) and Remark 2.2], we have the explicit expression

$$F_N^{m,1}(a; \epsilon) = F_{m-\epsilon}(a; \epsilon) F_{N-m}(a; \epsilon) = (1 + a^2)^{\frac{N(N+1)}{2} - m(N+\epsilon-m)}, \quad (1.3)$$

which reveals that the weighted number of domino tilings is equal to that of two smaller disjoint Aztec diamonds. It is worth recalling that the domains $A_N^{m,k}$ and $\tilde{A}_N^{m,k}$ corresponding to non-positive integers $k \leq 0$ cannot be tiled with dominoes, see also [10, Remark 2.2].

Probability of a large frozen region. Let us introduce a probability measure on the set of domino tilings of A_N : to a domino tiling $T \in \mathcal{T}(A_N)$, we assign the probability

$$\mathbb{P}(T) = \frac{a^{v(T)}}{(1 + a^2)^{\frac{N(N+1)}{2}}}, \quad 0 < a \leq 1, \quad (1.4)$$

where $v(T)$ is the number of vertical dominoes in T . For $a = 1$, this is the uniform measure, while for $a < 1$, domino tilings with fewer vertical dominoes are more likely to occur than tilings with more vertical dominoes. For large N , it is well-known that the vast majority of domino tilings of A_N exhibits regions with qualitatively different behavior: near the four corners of the Aztec diamond, we observe a frozen region where only one type of dominoes is present, while a rough region containing a mixture of all types of dominoes is present in the middle of the Aztec diamond. For all values of a , the rough and frozen regions are separated by the so-called *arctic curve*. When $a = 1$, this curve is a circle (see Figure 1 on the right), while for $a < 1$, it is an ellipse [30].

For $\epsilon = 1$, the quantity

$$P_N^{m,k}(a; \epsilon) := \frac{F_N^{m,k}(a; \epsilon)}{F_N(a)}, \quad m = 1, \dots, N, \quad k = 1, \dots, m+1, \quad (1.5)$$

is the probability that a random domino tiling of the full Aztec diamond A_N contains only north dominoes in the region $A_N \setminus A_N^{m,k}$, or equivalently that it has a frozen region containing $A_N \setminus A_N^{m,k}$.

For $\epsilon = 0$, it is the probability that the region $A_N \setminus \tilde{A}_N^{m,k}$ contains only north dominoes, but with the additional constraint that the segment $v^{m,k}$ cannot be covered by a south domino. Henceforth, we will refer to $A_N \setminus \tilde{A}_N^{m,k}$ (for $\epsilon = 1$) or $A_N \setminus \tilde{A}_N^{m,k}$ (for $\epsilon = 0$) as the *removed corner*.

Naturally, for large N , one expects that $P_N^{m,k}(a; \epsilon)$ will be close to 1 if the removed corner lies entirely outside the arctic curve. When the removed corner intrudes the arctic curve, one can expect however a dramatic decrease in the number of domino tilings of the domain, such that $P_N^{m,k}(a; \epsilon)$ will decay rapidly as $N \rightarrow \infty$. In order to capture this transition, we need to scale m, k with N . We therefore introduce the variables

$$\mu = \frac{m}{N} \in [0, 1], \quad \kappa = \frac{k}{N} \in [0, 1]. \quad (1.6)$$

Given $m \in \mathbb{N} \cap (\frac{a^2}{1+a^2}N, N)$, this transition where the removed region crosses the arctic curve will take place for $k \in \mathbb{N}$ around the value $\kappa_2 N$, with

$$\kappa_2 = \kappa_2(\mu) = \frac{a^2(2\mu - 1) + 2a\sqrt{\mu(1-\mu)}}{1+a^2}, \quad \mu = m/N. \quad (1.7)$$

Observe that for $\mu = \frac{a^2}{1+a^2}$, we have $\kappa_2 = \mu$; this corresponds to the point where the arctic curve touches the boundary of the Aztec diamond. Accordingly, for $m \in \mathbb{N} \cap (0, \frac{a^2}{1+a^2}N)$, a removed corner would immediately cross the rough region, such that the transition described above does not take place. As k/N decreases further, the number of domino tilings continues to decrease smoothly. Another phase transition, caused by an almost frozen region in the south corner, occurs when k/N approaches 0, or in other words when the removed corner hits the horizontal line dividing the Aztec diamond into halves.

Statement of results. As explained before, the L-shaped Aztec regions $A_N^{m,k+1}$ and $\tilde{A}_N^{m,k+1}$ can only be tiled by dominoes if k is non-negative. For $k = 0$, we have the largest possible removed corner such that our domain is still tileable. If k is a fixed non-negative integer (independent of N), we will say that the removed corner is *almost maximal*. Our first result describes the large N asymptotics for $F_N^{m,k+1}(a; \epsilon)$ (or equivalently of $P_N^{m,k+1}(a; \epsilon)$) in such a situation.

Theorem 1.1. (Almost maximal removed corner). *Let $\epsilon \in \{0, 1\}$, $a \in (0, 1]$ be fixed. As in (1.6), we write $\mu = m/N$ with $m \in \{1, \dots, N\}$ and $N \in \mathbb{N}$. Let k be a non-negative integer. As $N \rightarrow \infty$, we have*

$$\log F_N^{m,k+1}(a; \epsilon) = F_2(\mu)N^2 + F_1(k, \mu)N - \frac{k^2}{2} \log N + F_0(k, \mu) + \mathcal{O}(N^{-1/2}), \quad (1.8)$$

uniformly in $\delta \leq \mu \leq 1 - \delta$ and in $0 \leq k \leq M$, for any fixed $M \in \mathbb{N}$ and $\delta > 0$, where

$$F_2(\mu) = \left(\frac{1}{2} - \mu + \mu^2 \right) \log(1 + a^2), \quad (1.9)$$

$$F_1(k, \mu) = k\varphi_0(x_0) + \left(\frac{1}{2} - \epsilon\mu \right) \log(1 + a^2), \quad (1.10)$$

$$F_0(k, \mu) = \log \mathcal{G}(k+1) - \frac{k^2}{2} \log(|x_0|^2 \varphi_0''(x_0)) + \epsilon k \log(1 - ax_0) - \frac{k}{2} \log(2\pi), \quad (1.11)$$

where \mathcal{G} is Barnes' G -function and

$$x_0 = \frac{-a - \sqrt{a^2 + 4\mu(1-\mu)}}{2(1-\mu)} < -a, \quad \varphi_0(z) = (1-\mu) \log(1 - az) + \mu \log\left(\frac{z}{z+a}\right). \quad (1.12)$$

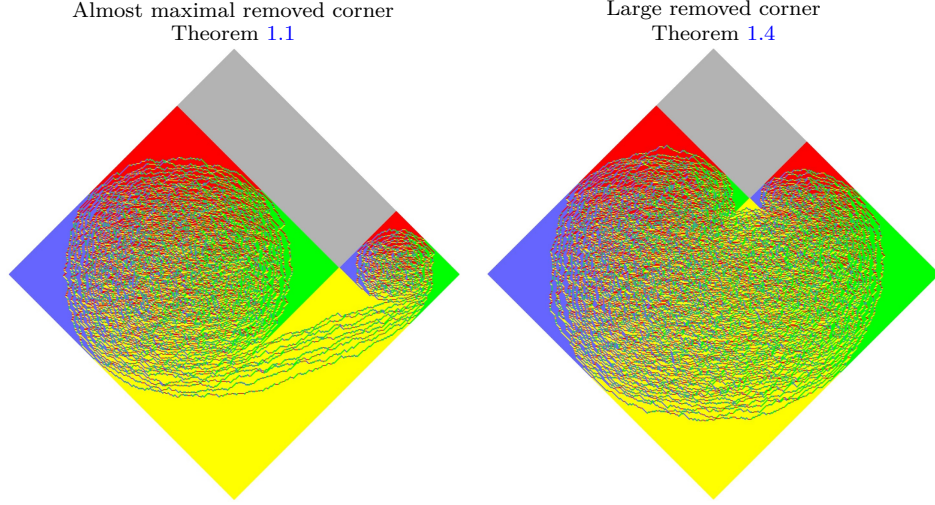


Figure 3: Left: a domino tiling of $A_{300}^{225,10}$ taken uniformly at random. Right: a domino tiling of $A_{300}^{225,102}$ taken uniformly at random.

Remark 1.2. Observe that for $k = 0$, we have $F_0(0, \mu) = 0$ and $F_1(0, \mu) = (\frac{1}{2} - \epsilon\mu) \log(1 + a^2)$, such that we have

$$F_N^{m,1}(a; \epsilon) = (1 + a^2)^{(\frac{1}{2} - \mu + \mu^2)N^2 + (\frac{1}{2} - \epsilon\mu)N} (1 + \mathcal{O}(N^{-1/2})),$$

as $N \rightarrow \infty$, which is in agreement with (1.3). For $k \geq 0$ fixed, we can write the above result alternatively as

$$F_N^{m,k+1}(a; \epsilon) = F_{m-\epsilon}(a; \epsilon) F_{N-m}(a; \epsilon) e^{k\varphi_0(x_0)N} N^{-\frac{k^2}{2}} \\ \times \mathcal{G}(k+1) (|x_0|^2 \varphi_0''(x_0))^{-\frac{k^2}{2}} (1 - ax_0)^{\epsilon k} (2\pi)^{-\frac{k}{2}} (1 + \mathcal{O}(N^{-1/2})),$$

as $N \rightarrow \infty$. In this expression, we see how the number of tilings, equal to the number of tilings of two disjoint Aztec diamonds for $k = 0$, rapidly increases with k , since $\varphi_0(x_0) > 0$. The simulation in Figure 3 (left) suggests that the increasing number of tilings as k grows, corresponds to the presence of k apparent paths of unfrozen dominoes connecting the two smaller Aztec diamonds. To the best of our knowledge, it is the first time that such a phenomenon of unfreezing, via a small number of paths over a long distance, is observed and quantified, although there are some similarities with a transition in a model of overlapping Aztec diamonds studied in [1, 2]. It would be interesting to understand not only the number of tilings, but also the locations and correlations of the unfrozen paths.

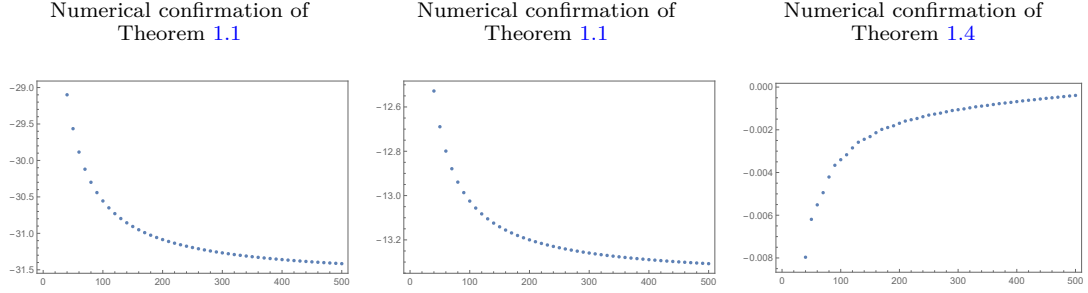


Figure 4: Let $\log \mathcal{F}_N^1$ be the right-hand side of (1.8) without the \mathcal{O} -term. The left and middle figures represent $N \mapsto N(\log F_N^{m,k+1}(a; \epsilon) - \log \mathcal{F}_N^1)$ with $a = 0.7845$, $k = 3$, $m = \{0.7N\}$, $\mu = \mu_N = m/N \approx 0.7$, and with $\epsilon = 1$ (left) and $\epsilon = 0$ (middle). Here $\{x\}$ denotes the nearest integer to x (in case x is exactly halfway between two integers, then $\{x\}$ is the nearest even integer to x). Right: Let $\log \mathcal{F}_N^2$ be the right-hand side of (1.14) without the \mathcal{O} -term and without the $o(1)$ -term. The right figure represents $N \mapsto \log F_N^{m,k+1}(a; \epsilon) - \log \mathcal{F}_N^2$ with $a = 0.7845$, $m = \{0.7N\}$, $\mu = \mu_N = m/N \approx 0.7$, $k = \{0.25N\}$, $\kappa = \kappa_N = k/N \approx 0.25$, and $\epsilon = 1$.

Remark 1.3. We verified Theorem 1.1 numerically for some choices of the parameters. In fact, the numerical results suggest that the $\mathcal{O}(N^{-1/2})$ -term in (1.8) can be improved to $\mathcal{O}(N^{-1})$, see Figure 4 (left and middle).

Our next result is concerned with a removed corner which is slightly smaller, but still has a large overlap with the rough region. (This case is the most involved out of the four regimes considered in this paper.) The number of tilings is then bigger than in the regime described above, but still much smaller than the number of tilings of the full Aztec diamond. This corresponds to $\mu = m/N \in (0, 1)$ and $\kappa = k/N \in (0, \kappa_2)$, with $\kappa_2 = \kappa_2(\mu) \in (0, \mu)$ given by (1.7). In this regime, Colomo and Pronko established the leading order term of order N^2 (the free energy) in the large N asymptotic expansion

of $\log F_N^{m,k+1}(a; \epsilon)$ [13, 14]. We confirm and strengthen their result by computing the subleading terms proportional to N and to $\log N$ as well as the term of order 1, and by extending the uniformity range.

The constants $C_2(\kappa, \mu)$, $C_1(\kappa, \mu)$, $C_0(\kappa, \mu)$ appearing in Theorem 1.4 below are very involved, but in essence they only depend on κ, μ and on the unique $z_0 = z_0(\kappa; \mu)$ in the complex upper half plane which satisfies

$$\begin{cases} \frac{1 - \mu}{|z_0 - \frac{1}{a}|} + \frac{\mu - \kappa}{|z_0|} - \frac{\mu}{|z_0 + a|} = 0, \\ \kappa + 1 - \mu - \frac{a\mu}{|z_0 + a|} - \frac{1 - \mu}{a|z_0 - \frac{1}{a}|} = 0. \end{cases} \quad (1.13)$$

This quantity is analyzed in Section 6 and Proposition 6.2 below; in particular we will show that z_0 can be expressed in terms of a root of a degree four polynomial equation.

Theorem 1.4. (Large removed corner). *Let $\epsilon \in \{0, 1\}$, $a \in (0, 1]$ be fixed. We write $\mu = m/N$ and $\kappa_+ = \frac{2k+1}{2N}$ with $k \leq m \in \{1, \dots, N\}$ and $N \in \mathbb{N}$. There exists $M > 0$ such that for any $\delta > 0$, we have*

$$\log F_N^{m,k+1}(a; \epsilon) = C_2(\kappa_+, \mu)N^2 + C_1(\kappa_+, \mu)N - \frac{1}{12} \log N + C_0(\kappa_+, \mu) + \mathcal{O}\left(\frac{1}{N(\kappa_2 - \kappa)^2}\right) + o(1), \quad (1.14)$$

as $N \rightarrow \infty$, uniformly for $\delta \leq \mu \leq 1 - \delta$ and for $\frac{M}{N} \leq \kappa \leq \min\{\kappa_2 - MN^{-2/3}, \mu - \delta\}$. The functions $C_2(\kappa_+, \mu)$, $C_1(\kappa_+, \mu)$ and $C_0(\kappa_+, \mu)$ are smooth for $\mu \in (0, 1)$ and $\kappa_+ \in (0, \kappa_2)$. Their explicit forms are given in equations (6.77), (6.78) and (6.80) below, and depend on the functions $G(\kappa, \mu)$, $H(\kappa, \mu)$, $F(\kappa, \mu)$ given by (6.62), (6.61) and (6.63), respectively.

As $\kappa_+ \rightarrow 0$, they satisfy the asymptotics

$$C_2(\kappa_+, \mu) = \left(\frac{1}{2} - \mu + \mu^2\right) \log(1 + a^2) + \kappa_+ \varphi_0(x_0) + \frac{\kappa_+^2}{2} \log \kappa_+$$

$$-\frac{\kappa_+^2}{4} (3 + 2 \log(|x_0|^2 \varphi_0''(x_0))) + \mathcal{O}(\kappa_+^3), \quad (1.15a)$$

$$C_1(\kappa_+, \mu) = -\frac{\varphi_0(x_0)}{2} + \left(\frac{1}{2} - \epsilon\mu\right) \log(1 + a^2) - \frac{\kappa_+}{2} \log \kappa_+ \\ + \frac{\kappa_+}{2} (1 + \log(|x_0|^2 \varphi_0''(x_0)) + 2\epsilon \log(1 - ax_0)) + \mathcal{O}(\kappa_+^2), \quad (1.15b)$$

$$C_0(\kappa_+, \mu) = \frac{1}{24} \log \kappa_+ - \frac{3}{24} \log(|x_0|^2 \varphi_0''(x_0)) - \frac{\epsilon}{2} \log(1 - ax_0) + \zeta'(-1) + \mathcal{O}(\kappa_+), \quad (1.15c)$$

uniformly in $\delta \leq \mu \leq 1 - \delta$, where x_0 and φ_0 are defined in (1.12), and ζ is Riemann's zeta function.

Remark 1.5. The condition $k \leq \min\{N\kappa_2 - MN^{1/3}, N(\mu - \delta)\}$ means that the corner of the removed region lies inside the arctic ellipse, at least at a distance $MN^{1/3}$ away from the ellipse and at least at distance δN away from the point where the ellipse touches the border of the Aztec diamond. Note also that the error terms in (1.14) are small if $k \rightarrow \infty$ and $N^{-1/2}(N\kappa_2 - k) \rightarrow \infty$.

Remark 1.6. Barnes' G -function satisfies the asymptotic expansion

$$\log \mathcal{G}(k+1) = \frac{k^2}{2} \log \left(k + \frac{1}{2}\right) - \frac{3k^2}{4} - \frac{k}{4} + \frac{k}{2} \log(2\pi) - \frac{1}{12} \log \left(k + \frac{1}{2}\right) + \frac{1}{16} + \zeta'(-1) + \mathcal{O}\left(\frac{1}{k}\right) \quad (1.16)$$

as $k \rightarrow \infty$. Substituting this in Theorem 1.1, we obtain that the asymptotics from Theorem 1.1 are compatible as $k \rightarrow \infty$ with those from Theorem 1.4; more precisely, they match with the expansion (1.14) with $\kappa_+ = \frac{2k+1}{2N}$ and in which we substitute the small κ_+ asymptotic expansions (1.15).

Remark 1.7. Figure 4 (right) supports the validity of Theorem 1.4 with $\epsilon = 1$. We also verified Theorem 1.4 numerically for $\epsilon = 0$, although we decided not to include a graph for that case.

Remark 1.8. The simulation in Figure 3 (right) indicates several interesting asymptotic features, in particular it shows an arctic curve separating frozen and rough regions with two cusp points. This arctic curve has been computed explicitly in [15]. Finer statistics like local correlation functions have not been analyzed so far. Like in the full Aztec diamond, one expects behavior described in terms of the Airy process near the arctic curve [32], except near the cusp points. There, one would rather expect a behavior related to the cusp-Airy process [22, 34].

For $\mu > \frac{a^2}{1+a^2}$ and k near $N\kappa_2$, $P_N^{m,k}(a; \epsilon) = F_N^{m,k}(a; \epsilon)/F_N(a)$ is the probability to have a frozen region that extends to a point near the arctic curve. It is well-known that the fluctuations near the arctic curve are described by the Airy process [32] and the Tracy-Widom distribution. We recall [36] that the Tracy-Widom distribution $F^{\text{TW}}(s)$ is given by

$$F^{\text{TW}}(s) = \exp \left(- \int_s^{+\infty} (x-s)u(x)^2 dx \right), \quad (1.17)$$

where $u(x)$ is the Hastings-McLeod solution of the Painlevé II equation, i.e.,

$$u''(x) = xu(x) + 2u(x)^3, \quad u(x) \sim \text{Ai}(x) \text{ as } x \rightarrow +\infty,$$

where Ai is the Airy function. As $s \rightarrow +\infty$, $\log F^{\text{TW}}(s)$ converges rapidly (faster than exponentially) to 0,

$$\log F^{\text{TW}}(s) = \frac{e^{-\frac{4}{3}s^{3/2}}}{16\pi s^{3/2}} (1 + o(1)), \quad \text{as } s \rightarrow +\infty, \quad (1.18)$$

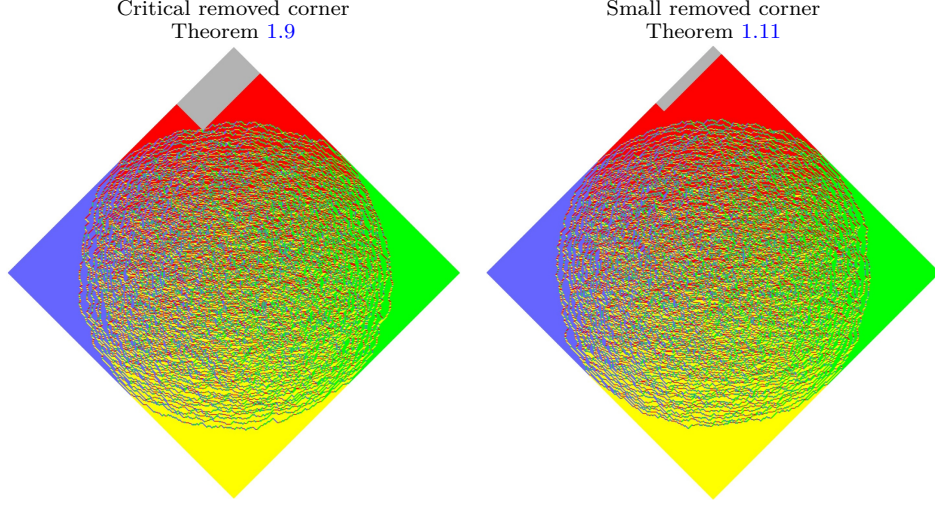


Figure 5: Left: a domino tiling of $A_{300}^{225,191}$ taken uniformly at random. Right: a domino tiling of $A_{300}^{225,215}$ taken uniformly at random.

while its tail as $s \rightarrow -\infty$ is described by [4, 17]

$$\log F^{\text{TW}}(s) = -\frac{|s|^3}{12} - \frac{1}{8} \log |s| + \frac{1}{24} \log 2 + \zeta'(-1) + \mathcal{O}(|s|^{-3/2}), \quad \text{as } s \rightarrow -\infty, \quad (1.19)$$

where ζ is the Riemann zeta function.

The next result is an improvement of existing results [32] describing convergence to the Tracy-Widom distribution. Compared to [32], we obtain uniform convergence for (m, k) in a slightly bigger neighborhood of the arctic curve, and with more control over the error term.

Theorem 1.9. (Critical removed corner). *Let $\epsilon \in \{0, 1\}$, $a \in (0, 1]$ be fixed. For any $\delta > 0$ and $c < 2/5$, we have*

$$F_N^{m,k}(a; \epsilon) = F_N(a) F^{\text{TW}}\left(\frac{N^{2/3}(\kappa - \kappa_2)}{(c^*)^{1/3}}\right) (1 + \mathcal{E}_N), \quad N \rightarrow \infty,$$

uniformly for $\frac{a^2}{1+a^2}(1+\delta)N \leq m \leq (1-\delta)N$ and for $N\kappa_2 - N^c \leq k \leq N(\kappa_2 + \delta)$. Here $c^ = c^*(\mu, a) > 0$, with $\mu = \frac{m}{N}$, is given by*

$$c^* = \mu - \kappa_2 + \frac{a^3(1-\mu)}{(1/x^* - a)^3} - \frac{\mu}{(1+a/x^*)^3} > 0, \quad x^* = \frac{a - (1+a^2)\sqrt{\mu(1-\mu)}}{(1+a^2)\mu - 1} \in (0, 1/a),$$

and \mathcal{E}_N satisfies the following asymptotics as $N \rightarrow \infty$:

$$\mathcal{E}_N = \begin{cases} \mathcal{O}(N^{-1/3}), & \text{if } N^{\frac{2}{3}}(\kappa - \kappa_2) \text{ is bounded,} \\ \mathcal{O}\left(\frac{e^{-c'N(\kappa - \kappa_2)^{3/2}}}{N^{1/2}(\kappa - \kappa_2)^{1/4}}\right), & \text{if } N^{\frac{2}{3}}(\kappa - \kappa_2) \rightarrow +\infty, \\ \mathcal{O}(N^3(\kappa - \kappa_2)^5), & \text{if } N^{\frac{2}{3}}(\kappa - \kappa_2) \rightarrow -\infty, \end{cases}$$

for any fixed $c' \in (0, \frac{2}{3}(c^*)^{-1/2})$. In particular, by (1.19), as $N \rightarrow \infty$ such that $M := N^{\frac{2}{3}}(\kappa_2 - \kappa) \rightarrow +\infty$ and $M/N^{1/15} \rightarrow 0$,

$$\log F_N^{m,k}(a; \epsilon) = \log F_N(a) - \frac{M^3}{12c^*} - \frac{1}{8} \log M + \frac{1}{24} \log(2c^*) + \zeta'(-1) + \mathcal{O}\left(\frac{1}{M^{3/2}} + \frac{M^2}{N^{1/3}}\right). \quad (1.20)$$

Remark 1.10. Note that there is an interval $k \in [N\kappa_2 - N^{c_1}, N\kappa_2 - N^{c_2}]$, for any $\frac{5}{15} < c_2 < c_1 < \frac{6}{15}$, in which the results of Theorem 1.4 and Theorem 1.9 both hold. The compatibility of both results in that case suggest the following asymptotics as $\kappa_+ \rightarrow \kappa_2$ for C_2 and C_1 ,

$$C_2(\kappa_+, \mu) = \frac{1}{2} \log(1 + a^2) - \frac{1}{12c^*}(\kappa_2 - \kappa_+)^3 + \mathcal{O}((\kappa_2 - \kappa_+)^4), \quad (1.21a)$$

$$C_1(\kappa_+, \mu) = \frac{1}{2} \log(1 + a^2) + \mathcal{O}((\kappa_2 - \kappa_+)^2). \quad (1.21b)$$

We will prove these asymptotics in Subsection 6.10.

Finally, for $\mu > \frac{a^2}{1+a^2}(1 + \delta)$ and $\kappa > \kappa_2 + \delta$, the removed corner lies entirely north of the arctic curve. Hence, we expect $F_N^{m,k}(a; \epsilon)$ to be very close to 1. The next theorem confirms this expectation.

Theorem 1.11. (Small removed corner). Let $\epsilon \in \{0, 1\}$, $a \in (0, 1]$ be fixed. There exists $c > 0$ such that, for any $\delta > 0$,

$$F_N^{m,k}(a; \epsilon) = (1 + O(e^{-cN(\kappa - \kappa_2)^{3/2}}))F_N(a), \quad \text{as } N \rightarrow +\infty,$$

uniformly for $\frac{a^2}{1+a^2}(1 + \delta) \leq \mu \leq 1 - \delta$ and for $\kappa_2 + \delta \leq \kappa \leq \mu$.

Outline. The starting point of our asymptotic analysis is a characterization of the quantity $\frac{F_N^{m,k+1}(a; \epsilon)}{F_N^{m,k}(a; \epsilon)}$ in terms of a 2×2 Riemann-Hilbert (RH) problem established in [10] using a discrete version of Fourier techniques developed in [8] combined with classical Its-Izergin-Korepin-Slavnov theory [29]. We recall this characterization in Section 2. In Section 3, we perform the large N asymptotic analysis of the RH problem in the situation of a small removed corner. This asymptotic analysis requires the inspection of a phase function and a suitable deformation of jump contours, but no construction of parametrices, and it will allow us to prove Theorem 1.11. In Section 4, we continue with the asymptotic RH analysis in the critical regime where the removed corner hits the arctic curve. Here, we will need to construct a local parametrix related to the Painlevé II equation, which will lie at the basis of the proof of the Tracy-Widom asymptotics in Theorem 1.9. In Section 5, we will complete the asymptotic analysis for an almost maximal removed corner and prove Theorem 1.1. Here we will need to construct a local parametrix in terms of Hermite polynomials. In Section 6, we finally analyze the RH problem asymptotically for a large removed corner. In that case, we will need to construct a suitable g -function and at a later stage local Airy parametrices and a global parametrix. This will lead us to the proof of Theorem 1.4.

2 Ratio identity and RH problem

The starting point of our analysis is a characterization of $F_N^{m,k}(a; \epsilon)$ in terms of a 2×2 matrix RH problem, obtained recently in [10]. By [10, Proposition 3.2, Remark 4.1 and Theorem 4.2], we have

$$\frac{F_N^{m,k+1}(a; \epsilon)}{F_N^{m,k}(a; \epsilon)} = U_{11}(0), \quad (2.1)$$

where U is the unique solution of the following RH problem, which depends on the parameters $\epsilon \in \{0, 1\}$, $a \in (0, 1]$, $N \in \mathbb{N}$, $m \in \{1, \dots, N\}$, $k \in \{1, \dots, m\}$.

RH problem for U

- (a) $U : \mathbb{C} \setminus (\gamma_0 \cup \gamma_1) \rightarrow \mathbb{C}^{2 \times 2}$ is analytic, where γ_0 is a simple positively oriented closed contour around a but not enclosing $-1/a$, and γ_1 is a simple positively oriented contour encircling γ_0 and 0.
- (b) U admits continuous boundary values $U_{\pm}(z)$ as $z \in \gamma_0 \cup \gamma_1$ is approached from the left (+) or right (−) according to the orientation of the contour, and they are related by $U_+(s) = U_-(z)J_U(z)$ for $z \in \gamma_0 \cup \gamma_1$, with

$$J_U(z) = \begin{cases} \begin{pmatrix} 1 & \frac{z^{N-m+k+\epsilon-1}}{(z-a)^{N-m+\epsilon}(1+az)^m} \\ 0 & 1 \end{pmatrix}, & z \in \gamma_0, \\ \begin{pmatrix} 1 & 0 \\ -\frac{(z-a)^{N-m+\epsilon}(1+az)^m}{z^{N-m+k+\epsilon-1}} & 1 \end{pmatrix}, & z \in \gamma_1. \end{cases}$$

- (c) As $z \rightarrow \infty$, $U(z) = I + \mathcal{O}(z^{-1})$, where I is the 2×2 identity matrix.

It follows from standard complex analysis arguments that $\det U(z) \equiv 1$. Moreover, the RH solution U depends on the choice of contours γ_0, γ_1 , but the value $U_{11}(0)$ does not, provided that γ_0 and γ_1 satisfy the conditions described in the above RH problem.

Remark 2.1. *It is well known that domino tilings of the Aztec diamond are connected to discrete orthogonal polynomials with respect to a Krawtchouk weight, see [31], and this connection can be used to characterize $\frac{F_N^{m,k+1}(a;\epsilon)}{F_N^{m,k}(a;\epsilon)}$ in terms of a discrete RH problem, characterizing orthogonal polynomials with respect to a truncated Krawtchouk weight. In principle, one could attempt to analyze this discrete RH problem asymptotically using the techniques of [6]. It would however be highly challenging to obtain subleading terms and uniform error terms in this way. The above RH problem for U is simpler in the sense that it is a continuous RH problem with simple (rational) jump matrices, which greatly simplifies asymptotic analysis. We emphasize that the RH problem for U is not directly related to orthogonal polynomials; it can in fact be interpreted as a RH problem in Fourier space rather than in position space, and its solution can be expressed in terms of Padé approximants, see [10] for details.*

In view of asymptotic analysis, it will be convenient to change variable $z \mapsto 1/z$ in this RH problem. To that end, we define

$$Y(z) = \sigma_3 U(0)^{-1} U(1/z) \sigma_3, \quad \sigma_3 = \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}. \quad (2.2)$$

Under the map $z \mapsto 1/z$, the contour γ_1 is sent to a closed negatively oriented loop Σ_0 enclosing 0 but not enclosing $1/a$, while γ_0 is sent to a closed loop Σ_1 lying in the exterior of Σ_0 and not passing through $1/a$. If γ_0 encloses 0, then Σ_1 is oriented negatively and encloses $-a, 0$ but not $1/a$; if γ_0 does not enclose 0, then Σ_1 is oriented positively and encloses $1/a$ but not $-a, 0$; if γ_0 passes through 0, then Σ_1 closes at infinity. While all these choices are admissible, below we will always assume that γ_0 surrounds 0, so that Σ_1 surrounds $-a, 0$ but not $1/a$. After changing the orientation of the contours Σ_0 and Σ_1 , we obtain the following RH problem for Y .

RH problem for Y

- (a) $Y : \mathbb{C} \setminus (\Sigma_0 \cup \Sigma_1) \rightarrow \mathbb{C}^{2 \times 2}$ is analytic, with Σ_0 positively oriented and enclosing 0, and Σ_1 either positively oriented and enclosing Σ_0 and $-a$ without enclosing $1/a$, or negatively oriented and enclosing $1/a$ without enclosing nor intersecting Σ_0 and without enclosing $-a$.

(b) $Y_+(z) = Y_-(z)J_Y(z)$ for $z \in \Sigma_0 \cup \Sigma_1$, with

$$J_Y(z) = \begin{cases} \begin{pmatrix} 1 & \frac{z^{m-k+1}}{(1-az)^{N-m+\epsilon}(z+a)^m} \\ 0 & 1 \end{pmatrix}, & z \in \Sigma_1, \\ \begin{pmatrix} 1 & 0 \\ -\frac{(1-az)^{N-m+\epsilon}(z+a)^m}{z^{m-k+1}} & 1 \end{pmatrix}, & z \in \Sigma_0. \end{cases} \quad (2.3)$$

(c) As $z \rightarrow \infty$, $Y(z) = I + \mathcal{O}(z^{-1})$.

Using (2.2), (2.1) and the fact that $U(z) = I + \mathcal{O}(z^{-1})$ as $z \rightarrow \infty$, the ratio identity in terms of Y reads

$$\frac{F_N^{m,k+1}(a; \epsilon)}{F_N^{m,k}(a; \epsilon)} = Y_{22}(0) \det U(0) = Y_{22}(0). \quad (2.4)$$

Let us parametrize $m \in \{1, \dots, N\}$ and $k \in \{1, \dots, m\}$ as follows:

$$k = \kappa N, \quad m = \mu N, \quad \text{such that} \quad \mu \in (0, 1], \quad \kappa \in (0, \mu]. \quad (2.5)$$

In a large part of our analysis, we will fix $\mu \in (\frac{a^2}{1+a^2}, 1]$. Later on, we will argue that our results are valid uniformly for $\mu \in (\frac{a^2}{1+a^2}(1+\delta), 1-\delta]$. On the other hand, we will treat $\kappa \in (0, \mu]$ as a varying parameter throughout our analysis. This is needed in particular because the ratio identity (2.4) involves two different values of κ . For this reason, in our notations below, we will omit the dependence on μ of several quantities, while we do indicate the dependence on κ .

For $z \in \mathbb{C} \setminus ((-\infty, 0] \cup [\frac{1}{a}, +\infty))$, we write

$$\phi(z; \kappa) = (\kappa - \mu) \log z + (1 - \mu) \log(1 - az) + \mu \log(z + a), \quad (2.6)$$

where the principal branch is used for the logarithms, such that the jump matrix J_Y can be rewritten as

$$J_Y(z) = \begin{cases} \begin{pmatrix} 1 & \frac{z}{(1-az)^\epsilon} e^{-N\phi(z; \kappa)} \\ 0 & 1 \end{pmatrix}, & z \in \Sigma_1, \\ \begin{pmatrix} 1 & 0 \\ -\frac{(1-az)^\epsilon}{z} e^{N\phi(z; \kappa)} & 1 \end{pmatrix}, & z \in \Sigma_0. \end{cases} \quad (2.7)$$

3 Small removed corner

We assume in this section that $\mu \in (\frac{a^2}{1+a^2}, 1)$ and that $\kappa \in [\kappa_2, \mu]$, with κ_2 given by (1.7). For $\kappa \in (\kappa_2, \mu]$ and with ϕ given by (2.6), the discriminant of the saddle point equation $\phi'(z; \kappa) = 0$ is positive, so that we have two real saddle points

$$x_1(\kappa) = \frac{\kappa + a^2(2\mu - \kappa - 1) - \sqrt{-a^2(1 + 4\kappa\mu - 2\kappa - 2\kappa^2 - (2\mu - 1)^2) + \kappa^2 + a^4(\kappa - 2\mu + 1)^2}}{2a(1 + \kappa - \mu)},$$

$$x_2(\kappa) = \frac{\kappa + a^2(2\mu - \kappa - 1) + \sqrt{-a^2(1 + 4\kappa\mu - 2\kappa - 2\kappa^2 - (2\mu - 1)^2) + \kappa^2 + a^4(\kappa - 2\mu + 1)^2}}{2a(1 + \kappa - \mu)}.$$

For $\kappa = \kappa_2$, these two saddle points coincide, such that there is a double saddle point at

$$x^* := \frac{\kappa_2 + a^2(2\mu - \kappa_2 - 1)}{2a(1 + \kappa_2 - \mu)}. \quad (3.1)$$

Note also that $x_1(\mu) = 0$ and

$$0 < x_1(\kappa) < x_2(\kappa) < \frac{1}{a}, \quad \text{for all } \mu \in \left(\frac{a^2}{1+a^2}, 1\right), \quad \kappa \in (\kappa_2, \mu).$$

By (2.6), we can rewrite $\phi'(z; \kappa)$ as follows,

$$\phi'(z; \kappa) = (\kappa + 1 - \mu) \frac{(z - x_1(\kappa))(z - x_2(\kappa))}{z(z + a)(z - 1/a)}.$$

We can use the theory of critical trajectories of quadratic differentials [35] to understand the behavior of $\Re\phi(z; \kappa)$ as a function of $z \in \mathbb{C}$. An object of the form $\phi'(z; \kappa)^2 dz^2$ with $\phi'(z; \kappa)^2$ rational, is called a quadratic differential. A curve is called a (vertical) trajectory of this quadratic differential if $\phi'(z; \kappa)^2 dz^2 < 0$ for z on the curve, or equivalently if $\Re(\phi'(z; \kappa) dz) = 0$, i.e.

$$\Re \left(\frac{(z - x_1(\kappa))(z - x_2(\kappa))}{z(z + a)(z - 1/a)} dz \right) = 0.$$

By the fundamental theorem of calculus, the real part of $\phi(z; \kappa)$ is constant along such trajectories. There is an extensive literature on the local and global structure of trajectories of quadratic differentials, see e.g. [35]. We limit ourselves to recalling the main results that we will need for our specific quadratic differential which has two double zeros $x_1(\kappa), x_2(\kappa)$ if $\kappa > \kappa_2$ and three double poles $-a, 0, 1/a$. Trajectories going through one of the zeros $x_1(\kappa), x_2(\kappa)$ are called critical trajectories. These critical trajectories consist locally near that zero of two orthogonal curves making angles $\pm\pi/4$ with the real line. Other, non-critical trajectories, are smooth curves without self-intersections. If $\kappa = \kappa_2$ such that $x_1(\kappa) = x_2(\kappa)$, the critical trajectory through this point consists of three curves making angles $-\pi/6, \pi/6, \pi/2$ with the real line. Moreover, a trajectory of $\phi'(z; \kappa)^2 dz^2$ can only contain a closed loop if it encloses at least one of the poles $-a, 0, 1/a$; otherwise the maximum and minimum principles applied to the harmonic function $\Re\phi(z; \kappa)$ would imply that $\Re\phi(z; \kappa)$ is constant in the interior of the closed loop, which is impossible. We denote the trajectory of level h as

$$\mathcal{T}_h := \{z \in \mathbb{C} : \Re\phi(z; \kappa) = h\}.$$

Of course, trajectories corresponding to different levels cannot intersect, and they are invariant under complex conjugation since $\phi'(\bar{z}; \kappa) = \overline{\phi'(z; \kappa)}$. It will be useful to observe that

$$\Re\phi(\infty, \kappa) = \Re\phi(0, \kappa) = +\infty, \quad \Re\phi(-a, \kappa) = \Re\phi\left(\frac{1}{a}, \kappa\right) = -\infty. \quad (3.2)$$

The next result summarizes the global structure of the critical trajectories, both for $\kappa > \kappa_2$ and for $\kappa = \kappa_2$. We don't need the latter in this section, but we will need it later when studying the transition where $\kappa \approx \kappa_2$.

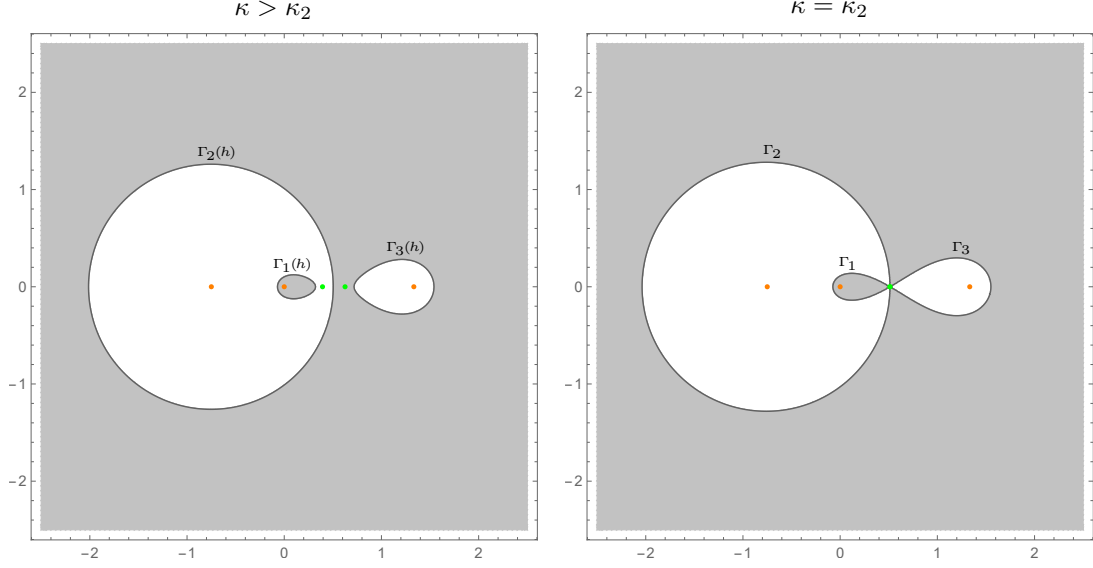


Figure 6: In all images, the shaded regions correspond to $\{z : \Re\phi(z; \kappa) > h\}$ and the white regions to $\{z : \Re\phi(z; \kappa) < h\}$. The orange dots are $-a, 0, 1/a$, and the green dots are $x_1(\kappa), x_2(\kappa)$. Left: $a = 0.75$, $\mu = 0.808 \in (\frac{a^2}{1+a^2}, 1)$, $\kappa = 0.95\kappa_2 + 0.05\mu > \kappa_2$, $h = (h_1 + h_2)/2$. Right: $a = 0.75$, $\mu = 0.808 \in (\frac{a^2}{1+a^2}, 1)$, $\kappa = \kappa_2$, $h = \Re\phi(x^*; \kappa_2)$.

Proposition 3.1. *1. Let $\kappa > \kappa_2$. Denote $h_1 = \Re\phi(x_1(\kappa); \kappa)$ and $h_2 = \Re\phi(x_2(\kappa); \kappa)$. For $h_1 < h < h_2$, the trajectory $\mathcal{T}_h = \Gamma_1(h) \cup \Gamma_2(h) \cup \Gamma_3(h)$ consists of three disjoint simple closed curves $\Gamma_1(h), \Gamma_2(h), \Gamma_3(h)$, symmetric under complex conjugation; $\Gamma_1(h)$ encloses 0 but neither of the points $-a, x_1(\kappa), x_2(\kappa), 1/a$; $\Gamma_2(h)$ encloses $-a, 0, x_1(\kappa)$ but does not enclose $x_2(\kappa), 1/a$; $\Gamma_3(h)$ encloses $1/a$ but neither of the points $-a, 0, x_1(\kappa), x_2(\kappa)$. See Figure 6 (left).*

2. Let $\kappa = \kappa_2$. Denote $h = \Re\phi(x^; \kappa_2)$. The critical trajectory $\mathcal{T}_h = \Gamma_1 \cup \Gamma_2 \cup \Gamma_3$ is the union of three simple closed curves intersecting only at x^* ; Γ_1 encloses 0 but neither of the points $-a, 1/a$; Γ_2 encloses Γ_1 and $-a, 0$ but not $1/a$; Γ_3 encloses $1/a$ but neither of the points $-a, 0$. See Figure 6 (right).*

Proof. For h large and positive, we easily conclude from (3.2) that \mathcal{T}_h consists of a small closed curve $\mathcal{C}_1(h)$ around 0 and a large closed curve $\mathcal{C}_2(h)$ enclosing all of the points $-a, 0, x_1(\kappa), x_2(\kappa), 1/a$. As h decreases, $\mathcal{C}_1(h), \mathcal{C}_2(h)$ are homotopically deformed in $\mathbb{C} \setminus \{-a, 0, x_1(\kappa), x_2(\kappa), 1/a\}$, until $h = \Re\phi(x_2(\kappa); \kappa)$.

Suppose first that $\kappa > \kappa_2$, such that $h_1 < h_2$. Since \mathcal{T}_{h_2} contains two orthogonal curves going through $x_2(\kappa)$ and since it can only contain a closed loop if it encloses at least one of the poles $-a, 0, 1/a$, necessarily $x_2(\kappa)$ belongs to $\mathcal{C}_2(h_2)$ which turns from a simple closed loop into an eight-shaped contour as $h \rightarrow h_2$. As h decreases further, $\mathcal{C}_2(h)$ splits into two disjoint simple closed loops, the right one going around $1/a$ and the left one going around $\mathcal{C}_1(h)$ and $-a$. (As $h \rightarrow h_1$, the left one connects with $\mathcal{C}_1(h)$, and for $h < h_1$, they become one closed curve around $-a$ not enclosing 0.)

Next, suppose that $\kappa = \kappa_2$, such that $h_1 = h_2$. Then, the critical trajectory \mathcal{T}_h consists locally near x^* of three curves. Since closed loops in $\mathcal{T}(h)$ need to enclose a pole, this can only happen if x^* belongs to both of the components $\mathcal{C}_1(h), \mathcal{C}_2(h)$. In other words, $\mathcal{C}_2(h) = \Gamma_2 \cup \Gamma_3$ is eight-shaped with intersection at x^* , and $\mathcal{C}_1(h) = \Gamma_1$ also contains x^* while it lies inside the leftmost loop Γ_2 of $\mathcal{C}_2(\kappa_2)$. \square

Corollary 3.2. 1. There exists $c > 0$ such that for any $\kappa \in (\kappa_2, \mu]$, there exist $h \in \mathbb{R}$ and disjoint contours Σ_0 and Σ_1 , with Σ_0, Σ_1 as specified in the RH problem for Y , such that

$$\begin{aligned} \Re\phi(z; \kappa) - h &\geq c(\kappa - \kappa_2)^{3/2}, & z \in \Sigma_1, \\ \Re\phi(z; \kappa) - h &\leq -c(\kappa - \kappa_2)^{3/2}, & z \in \Sigma_0. \end{aligned}$$

2. Let $\kappa = \kappa_2$. There exist contours Σ_0, Σ_1 intersecting only at x^* , with Σ_0, Σ_1 as specified in the

RH problem for Y , such that the following holds: for any $\delta > 0$, there exists $c > 0$ such that

$$\begin{aligned} \Re\phi(z; \kappa_2) - \Re\phi(x^*; \kappa_2) &> c, & z \in \Sigma_1 \setminus \{|z - x^*| \leq \delta\}, \\ \Re\phi(z; \kappa_2) - \Re\phi(x^*; \kappa_2) &< -c, & z \in \Sigma_0 \setminus \{|z - x^*| \leq \delta\}. \end{aligned}$$

Proof. For $\kappa = \kappa_2$, we take Σ_0 in the region between Γ_1 and Γ_2 (thus Σ_0 passes through x^*). Since $-a$ lies in that region and since $\Re\phi(-a; \kappa_2) = -\infty$, we then have $\Re\phi(z; \kappa_2) < \Re\phi(x^*; \kappa_2)$ on $\Sigma_0 \setminus \{x^*\}$. Further, we take Σ_1 outside Γ_2 and going around Γ_3 (thus Σ_1 also passes through x^*). Since $\Re\phi(\infty; \kappa_2) = +\infty$, we have $\Re\phi(z; \kappa_2) > \Re\phi(x^*; \kappa_2)$ on $\Sigma_1 \setminus \{x^*\}$.

For $\kappa > \kappa_2$, we use the notations of Proposition 3.1 and let $h_1 < h' < h < h'' < h_2$. Since $h_2 - h_1 \geq 3c(\kappa - \kappa_2)^{3/2}$ for some $c > 0$, we can take h', h'' moreover such that $h - h', h'' - h \geq c(\kappa - \kappa_2)^{3/2}$. We take $\Sigma_0 = \Gamma_1(h')$ and $\Sigma_1 = \Gamma_3(h'')$. Then we have

$$\begin{aligned} \Re\phi(z; \kappa) - h &= h'' - h \geq c(\kappa - \kappa_2)^{3/2}, & z \in \Sigma_1, \\ \Re\phi(z; \kappa) - h &= h' - h \leq -c(\kappa - \kappa_2)^{3/2}, & z \in \Sigma_0. \end{aligned}$$

This proves the result. \square

We will now prove that the RH problem for Y is equivalent to a small-norm RH problem for $\kappa \in (\kappa_2, \mu]$, with jump matrices exponentially close to identity as $N \rightarrow \infty$.

In the remaining part of this section, we let $\kappa > \kappa_2 + \delta$ for some $\delta > 0$ and we choose Σ_1, Σ_0 such that they satisfy the inequalities in Corollary 3.2, part 1, for some $h \in \mathbb{R}$. We define

$$T(z) = e^{\frac{N}{2}h\sigma_3} Y(z) e^{-\frac{N}{2}h\sigma_3}. \quad (3.3)$$

Then T solves the following RH problem, whose jumps are exponentially close to the identity.

RH problem for T

- (a) $T : \mathbb{C} \setminus (\Sigma_0 \cup \Sigma_1) \rightarrow \mathbb{C}^{2 \times 2}$ is analytic.
- (b) $T_+(z) = T_-(z)J_T(z)$ for $z \in \Sigma_0 \cup \Sigma_1$, with

$$J_T(z) = \begin{cases} \begin{pmatrix} 1 & \frac{z}{(1-az)^\epsilon} e^{-N(\phi(z; \kappa) - h)} \\ 0 & 1 \end{pmatrix}, & z \in \Sigma_1, \\ \begin{pmatrix} 1 & 0 \\ -\frac{(1-az)^\epsilon}{z} e^{N(\phi(z; \kappa) - h)} & 1 \end{pmatrix}, & z \in \Sigma_0. \end{cases} \quad (3.4)$$

- (c) As $z \rightarrow \infty$, $T(z) = I + \mathcal{O}(z^{-1})$.

We obtain from Corollary 3.2 that, for sufficiently small $c > 0$,

$$J_T(z) = I + \mathcal{O}(e^{-cN(\kappa - \kappa_2)^{3/2}}), \quad \text{as } N \rightarrow +\infty,$$

uniformly for $z \in \Sigma_0 \cup \Sigma_1$. It then follows from general RH theory [18, 19] that

$$T(z) = I + \mathcal{O}(e^{-cN(\kappa - \kappa_2)^{3/2}}), \quad \text{as } N \rightarrow +\infty,$$

uniformly for $z \in \mathbb{C} \setminus (\Sigma_0 \cup \Sigma_1)$. In particular, we obtain that

$$T_{22}(0) = Y_{22}(0) = 1 + \mathcal{O}(e^{-cN(\kappa - \kappa_2)^{3/2}}), \quad \text{as } N \rightarrow +\infty,$$

such that (2.4) implies the following result.

Proposition 3.3. *There exists $c > 0$ such that, for any $\delta > 0$,*

$$\frac{F_N^{m,k+1}(a; \epsilon)}{F_N^{m,k}(a; \epsilon)} = 1 + O(e^{-cN(\kappa - \kappa_2)^{3/2}}), \quad N \rightarrow \infty,$$

uniformly for $N(\kappa_2 + \delta) < k \leq N$.

It is straightforward to verify that all the error terms appearing above are uniform for $\frac{a^2}{1+a^2}(1+\delta) \leq \mu \leq 1 - \delta$, for any fixed $\delta > 0$. We now easily prove Theorem 1.11 by taking a telescoping product of the ratios $\frac{F_N^{m,\ell+1}(a; \epsilon)}{F_N^{m,\ell}(a; \epsilon)}$ for $\ell = k, \dots, m$, since $F_N^{m,m+1}(a; \epsilon) = F_N(a; \epsilon) = (1 + a^2)^{\frac{N(N+1)}{2}}$.

4 Critical removed corner

In this section, we let $\mu = m/N \in (\frac{a^2}{1+a^2}, 1)$ and $\kappa = k/N \in [\kappa_2 - N^{c-1}, \kappa_2 + \delta]$ for some $c \in (0, 2/5)$ and for some small but fixed $\delta > 0$.

4.1 Transformation $Y \mapsto T$

We denote

$$x^* := \frac{\kappa_2 + a^2(2\mu - \kappa_2 - 1)}{2a(1 + \kappa_2 - \mu)}, \quad \phi^* := \phi(x^*; \kappa_2).$$

In other words, x^* is the double saddle point of ϕ for $\kappa = \kappa_2$ (recall the discussion around (3.1)), and ϕ^* is the value of ϕ at this double saddle point. We define T as in (3.3) with $h = \phi(x^*; \kappa)$, such that it satisfies the following RH problem.

RH problem for T

- (a) $T : \mathbb{C} \setminus (\Sigma_0 \cup \Sigma_1) \rightarrow \mathbb{C}^{2 \times 2}$ is analytic.
- (b) $T_+(z) = T_-(z)J_T(z)$ for $z \in \Sigma_0 \cup \Sigma_1$, with

$$J_T(z) = \begin{cases} \begin{pmatrix} 1 & \frac{z}{(1-az)^\epsilon} e^{-N(\phi(z; \kappa) - \phi(x^*; \kappa))} \\ 0 & 1 \end{pmatrix}, & z \in \Sigma_1, \\ \begin{pmatrix} 1 & 0 \\ -\frac{(1-az)^\epsilon}{z} e^{N(\phi(z; \kappa) - \phi(x^*; \kappa))} & 1 \end{pmatrix}, & z \in \Sigma_0. \end{cases} \quad (4.1)$$

- (c) As $z \rightarrow \infty$, $T(z) = I + \mathcal{O}(z^{-1})$.

Recall from Corollary 3.2 (part 2) that for $\kappa = \kappa_2$, we can choose the jump contours Σ_0, Σ_1 such that they intersect at x^* , with Σ_0 enclosing 0, Σ_1 enclosing $1/a$ but not enclosing $-a$ nor Σ_0 , and moreover such that

$$J_T(z) = I + \mathcal{O}(e^{-cN}), \quad z \in (\Sigma_0 \cup \Sigma_1) \setminus \{|z - x^*| \leq \delta\}, \quad (4.2)$$

as $N \rightarrow +\infty$. For $\kappa = \kappa_2$, we have

$$\phi(z; \kappa_2) = \phi^* + \frac{\phi'''(x^*; \kappa_2)}{6}(z - x^*)^3 + \mathcal{O}((z - x^*)^4), \quad z \rightarrow x^*, \quad (4.3)$$

which implies that we can choose these curves Σ_0, Σ_1 such that they intersect each other and the real line at x^* with angles, for instance, $\pm\pi/3$. If we take κ sufficiently close to κ_2 , then we easily see that there exists $\delta > 0$ such that the estimate (4.2) remains valid, uniformly in z and κ .

By (2.6) and (4.3), we have

$$\phi(z; \kappa) - \phi(x^*; \kappa) = \frac{\phi'''(x^*; \kappa_2)}{6}(z - x^*)^3 + (\kappa - \kappa_2) \log \frac{z}{x^*} + \mathcal{O}((z - x^*)^4), \quad z \rightarrow x^*. \quad (4.4)$$

(Note that x^* remains bounded away from 0 when μ remains bounded away from $\frac{a^2}{1+a^2}$.) This implies cubic exponential behavior of the jump matrix J_T near x^* for κ close to κ_2 . Analogies with similar situations in e.g. [5, 9, 11, 12] suggest that we need to construct a local parametrix near x^* built out of a model RH problem associated to the Painlevé II equation, which we describe next.

4.2 Painlevé II model RH problem

The general RH problem characterizing solutions to the Painlevé II equation

$$u''(s) = su(s) + 2u^3(s) \quad (4.5)$$

depends on four parameters s, a_1, a_2, a_3 and is as follows, see [25, 26].

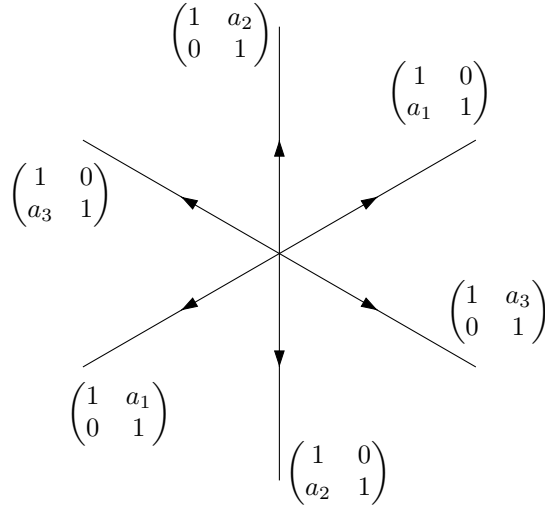


Figure 7: The jump contour $\Sigma = \bigcup_{j=0}^5 \{x e^{i(\frac{\pi}{6} + j\frac{\pi}{3})} : x > 0\}$, together with the corresponding jump matrices.

RH problem for $\Phi = \Phi(\cdot; s, a_1, a_2, a_3)$

- (a) $\Phi : \mathbb{C} \setminus \Sigma \rightarrow \mathbb{C}^{2 \times 2}$ is analytic, and Σ consists of 6 semi-infinite rays starting at the origin, as shown in Figure 7.
- (b) Φ has the jump relation $\Phi_+ = \Phi_- J_\Phi$ on Σ , with J_Φ as shown in Figure 7.

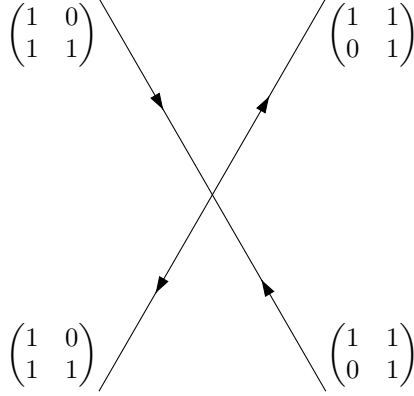


Figure 8: The jump contour $\Sigma_\Psi = \bigcup_{\alpha_j = \frac{\pi}{3}, \frac{2\pi}{3}} \{xe^{i\alpha_j} : x \in \mathbb{R}\}$. The orientations are indicated by arrows, and the matrices along the rays are the corresponding jump matrices.

(c) As $\zeta \rightarrow \infty$, we have

$$\Phi(\zeta) = \left(I + \frac{1}{\zeta} \begin{pmatrix} -\frac{1}{2i}q(s) & \frac{1}{2i}u(s) \\ -\frac{1}{2i}u(s) & \frac{1}{2i}q(s) \end{pmatrix} + \mathcal{O}(\zeta^{-2}) \right) e^{-i(\frac{4}{3}\zeta^3 + s\zeta)\sigma_3}, \quad (4.6)$$

where

$$q(s) = \int_{\infty}^s u^2(s') ds', \quad (4.7)$$

and where u is a solution to the Painlevé II equation (4.5).

As $\zeta \rightarrow 0$, we have

$$\Phi(\zeta) = \mathcal{O}(1). \quad (4.8)$$

If

$$a_1 a_2 a_3 + a_1 + a_2 + a_3 = 0, \quad (4.9)$$

this RH problem is solvable for $s \in \mathbb{C}$, except at isolated singularities which are poles of the relevant Painlevé II solution u . The Painlevé II solution depends on the values of the Stokes parameters a_1, a_2, a_3 .

The Hastings-McLeod solution $u(s)$ of the Painlevé II equation is characterized by its rapid decay $u(s) \sim \text{Ai}(s)$ as $s \rightarrow +\infty$, and it corresponds to $a_1 = 1, a_2 = 0, a_3 = -1$. It has no poles on the real line. It is the RH problem corresponding to this solution that we will use to construct a local parametrix. We define

$$\Psi(\zeta; s) = \sigma_3 \sigma_1 \Phi(\zeta e^{\frac{i\pi}{2}}; s, a_1 = 1, a_2 = 0, a_3 = -1) \sigma_1 \sigma_3, \quad (4.10)$$

where $\sigma_1 = \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}$ is the first Pauli matrix. Then, Ψ solves the following RH problem.

RH problem for Ψ

(a) $\Psi : \mathbb{C} \setminus \Sigma_\Psi \rightarrow \mathbb{C}^{2 \times 2}$ is analytic, and Σ_Ψ consists of 4 semi-infinite rays as shown in Figure 8.

(b) Ψ has the jump relation $\Psi_+ = \Psi_- J_\Psi$ on Σ_Ψ , with J_Ψ as shown in Figure 8 (note that we have reversed the orientation of two rays).

(c) As $\zeta \rightarrow \infty$, we have

$$\Psi(\zeta) = \left(I + \frac{1}{\zeta} \begin{pmatrix} -\frac{1}{2}q(s) & -\frac{1}{2}u(s) \\ \frac{1}{2}u(s) & \frac{1}{2}q(s) \end{pmatrix} + \Psi_2(s)\zeta^{-2} + \mathcal{O}(\zeta^{-3}) \right) e^{(\frac{4}{3}\zeta^3 - s\zeta)\sigma_3}, \quad (4.11)$$

where $\Psi_2(s)$ is a 2×2 matrix depending on s .

As $\zeta \rightarrow 0$, we have

$$\Psi(\zeta) = \mathcal{O}(1). \quad (4.12)$$

Observe that, by (1.17) and (4.7), we have

$$\partial_s \log F^{\text{TW}}(s) = -q(s). \quad (4.13)$$

The asymptotic analysis of the RH problem for Φ as $s \rightarrow \pm\infty$ has been carried out in [26] (with [26, Chapter 11] being particularly relevant to our setting). However, the specific estimates required for our purposes do not appear to be directly available in the literature. We will therefore perform two nonlinear steepest descent analyses on Ψ , inspired by [26]: first in the regime $s \rightarrow +\infty$, and then in the regime $s \rightarrow -\infty$.

4.2.1 Asymptotic analysis for Ψ as $s \rightarrow +\infty$

As $s \rightarrow +\infty$, not only the Painlevé II solution $u(s)$ decays rapidly (faster than exponentially), but the same is true for the functions $q(s)$ and $\Psi_2(s)$ in the expansion (4.11). To show this, we first consider $\Psi_b(\zeta) = \Psi(\sqrt{s}\zeta)e^{-s^{3/2}(\frac{4}{3}\zeta^3 - \zeta)\sigma_3}$. We then apply the transformation

$$\Psi_c(\zeta) = \Psi_b(\zeta) \begin{cases} \begin{pmatrix} 1 & e^{2s^{3/2}(\frac{4}{3}\zeta^3 - \zeta)} \\ 0 & 1 \end{pmatrix}, & \text{if } \zeta \in \Omega_r, \\ \begin{pmatrix} 1 & 0 \\ e^{-2s^{3/2}(\frac{4}{3}\zeta^3 - \zeta)} & 1 \end{pmatrix}, & \text{if } \zeta \in \Omega_l, \\ I, & \text{otherwise,} \end{cases} \quad (4.14)$$

where

$$\Omega_r = \{z = re^{i\theta} : r \in (0, 1), \theta \in (-\frac{\pi}{3}, \frac{\pi}{3}), \Re z \in (0, \frac{1}{2})\}, \quad \Omega_l = -\Omega_r.$$

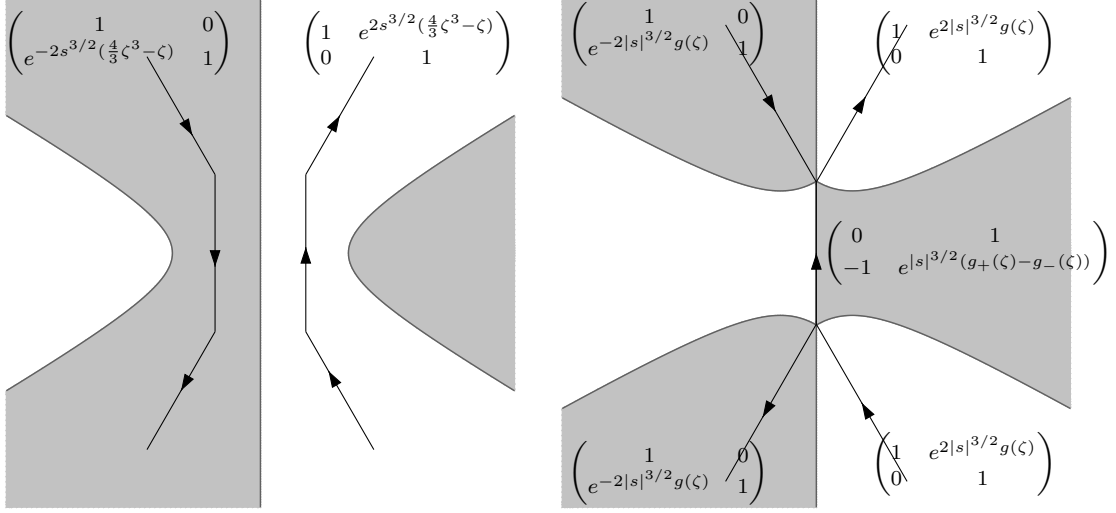


Figure 9: Left: The shaded regions correspond to $\{\zeta : \Re(\frac{4}{3}\zeta^3 - \zeta) > 0\}$ and the white regions to $\{\zeta : \Re(\frac{4}{3}\zeta^3 - \zeta) < 0\}$. The jump matrices for Ψ_c are uniformly close to I on the contour as $s \rightarrow +\infty$. The vertical segments pass through $\pm\frac{1}{2}$. Right: The shaded regions correspond to $\{\zeta : \Re g(\zeta) > 0\}$ and the white regions to $\{\zeta : \Re g(\zeta) < 0\}$. The jump matrices for $\tilde{\Psi}_c$ are uniformly close to I on the contour as $s \rightarrow -\infty$, except on the vertical segment $[\frac{-i}{\sqrt{2}}, \frac{i}{\sqrt{2}}]$ and in small neighborhoods of $\pm\frac{i}{\sqrt{2}}$.

The jump contour for Ψ_c is shown in Figure 9 (left). The jump matrices for Ψ_c satisfy

$$I + \mathcal{O}(e^{-2s^{3/2}|\Re(\frac{4}{3}\zeta^3 - \zeta)|}), \quad \text{as } s \rightarrow +\infty$$

uniformly for ζ on the contour Σ_{Ψ_c} . It is also easy to check that $|\Re(\frac{4}{3}\zeta^3 - \zeta)| \geq \frac{1}{3}$ for all $\zeta \in \Sigma_{\Psi_c}$. It then follows from standard theory for small norm RH problems [19, 18] that

$$\Psi_c(\zeta) = I + \mathcal{O}\left(\frac{\int_{\Sigma_{\Psi_c}} e^{-2s^{3/2}|\Re(\frac{4}{3}z^3 - z)|} |dz|}{1 + |\zeta|}\right) = I + \mathcal{O}\left(\frac{s^{-3/4}e^{-\frac{2}{3}s^{3/2}}}{1 + |\zeta|}\right), \quad \text{as } s \rightarrow +\infty,$$

uniformly for $\zeta \in \mathbb{C} \setminus \Sigma_{\Psi_c}$. Since $\Psi(\zeta) = \Psi_c(\zeta/\sqrt{s})e^{(\frac{4}{3}\zeta^3 - s\zeta)\sigma_3}$ for all $|\zeta| > \sqrt{s}$, we conclude that

$$\Psi(\zeta) = \left(I + \mathcal{O}\left(\frac{s^{-1/4}}{\zeta} e^{-\frac{2}{3}s^{3/2}}\right) \right) e^{(\frac{4}{3}\zeta^3 - s\zeta)\sigma_3}, \quad \text{as } s \rightarrow +\infty \quad (4.15)$$

uniformly for $|\zeta| > \sqrt{s}$. Comparing (4.15) with (4.11), we conclude that

$$u(s) = \mathcal{O}\left(s^{-1/4}e^{-\frac{2}{3}s^{3/2}}\right), \quad q(s) = \mathcal{O}\left(s^{-1/4}e^{-\frac{2}{3}s^{3/2}}\right), \quad \Psi_2(s) = \mathcal{O}\left(s^{1/4}e^{-\frac{2}{3}s^{3/2}}\right), \quad (4.16)$$

as $s \rightarrow +\infty$.

4.2.2 Asymptotic analysis for Ψ as $s \rightarrow -\infty$

The expansion (4.11) does not hold uniformly as $s \rightarrow -\infty$. This is connected to the fact that q, u, Ψ_2 and further terms in the expansion blow up in this limit. The goal of this subsection is to obtain an expansion for $\Psi(\zeta)$ as $\zeta \rightarrow \infty$ that is valid uniformly for large negative s . We first define $\tilde{\Psi}(\zeta) = \Psi(\sqrt{-s}\zeta)$. Then, we analytically continue $\tilde{\Psi}$ from each of the 4 sectors, in order to construct a new function $\tilde{\Psi}_b$ with jumps on the contour shown in Figure 9 (right - note that the jump matrices shown in the figure are not the ones for $\tilde{\Psi}_b$; they correspond to $\tilde{\Psi}_c$ defined below). The transformation $\tilde{\Psi} \mapsto \tilde{\Psi}_b$ can be made explicit in a similar way as in (4.14), but since this explicit transformation will not play any role for us, we omit it here. By (4.11), as $\zeta \rightarrow \infty$ we have

$$\tilde{\Psi}_b(\zeta) = \left(I + \frac{1}{\zeta\sqrt{-s}} \begin{pmatrix} -\frac{1}{2}q(s) & -\frac{1}{2}u(s) \\ \frac{1}{2}u(s) & \frac{1}{2}q(s) \end{pmatrix} + \Psi_2(s)\zeta^{-2}|s|^{-1} + \mathcal{O}(\zeta^{-3}) \right) e^{(-s)^{3/2}(\frac{4}{3}\zeta^3 + \zeta)\sigma_3}. \quad (4.17)$$

Define $g(\zeta) = \frac{4}{3}(\zeta^2 + \frac{1}{2})^{3/2}$, where the branch cut is chosen so that g is analytic in \mathbb{C} except on the vertical segment $[-\frac{i}{\sqrt{2}}, \frac{i}{\sqrt{2}}]$, and such that

$$g(\zeta) = \frac{4}{3}\zeta^3 + \zeta + \frac{1}{8\zeta} + \mathcal{O}(\zeta^{-3}), \quad \text{as } \zeta \rightarrow \infty. \quad (4.18)$$

Let us orient $[-\frac{i}{\sqrt{2}}, \frac{i}{\sqrt{2}}]$ upwards. We directly verify that

$$g_+(\zeta) + g_-(\zeta) = 0, \quad g_+(\zeta) - g_-(\zeta) < 0, \quad \text{for all } \zeta \in (-\frac{i}{\sqrt{2}}, \frac{i}{\sqrt{2}}).$$

We next apply the transformation

$$\tilde{\Psi}_c(\zeta) = \tilde{\Psi}_b(\zeta)e^{-(s)^{3/2}g(\zeta)\sigma_3}.$$

By (4.17)–(4.18), we have

$$\tilde{\Psi}_c(\zeta) = I + \frac{1}{\zeta} \left(-\frac{|s|^{3/2}}{8}\sigma_3 + \frac{1}{|s|^{1/2}} \begin{pmatrix} -\frac{q(s)}{2} & -\frac{u(s)}{2} \\ \frac{u(s)}{2} & \frac{q(s)}{2} \end{pmatrix} \right) + \mathcal{O}(\zeta^{-2}) \quad \text{as } \zeta \rightarrow \infty. \quad (4.19)$$

The jump matrices for $\tilde{\Psi}_c$ are shown in Figure 9 (right); they are uniformly close to I on the contour as $s \rightarrow -\infty$, except on the vertical segment $[-\frac{i}{\sqrt{2}}, \frac{i}{\sqrt{2}}]$ and in small neighborhoods of $\pm \frac{i}{\sqrt{2}}$. To handle the jump matrix on $(-\frac{i}{\sqrt{2}}, \frac{i}{\sqrt{2}})$, we use the global parametrix

$$Q^\infty(\zeta) = \begin{pmatrix} 1 & -1 \\ -i & -i \end{pmatrix} \left(\frac{\zeta + \frac{i}{\sqrt{2}}}{\zeta - \frac{i}{\sqrt{2}}} \right)^{\sigma_3/4} \begin{pmatrix} 1 & -1 \\ -i & -i \end{pmatrix}^{-1}, \quad \text{for } \zeta \in \mathbb{C} \setminus [-\frac{i}{\sqrt{2}}, \frac{i}{\sqrt{2}}], \quad (4.20)$$

where the branches are chosen so that Q^∞ is analytic on $\mathbb{C} \setminus [-\frac{i}{\sqrt{2}}, \frac{i}{\sqrt{2}}]$ and behaves as

$$Q^\infty(\zeta) = I + \frac{1}{2\sqrt{2}\zeta} \begin{pmatrix} 0 & -1 \\ 1 & 0 \end{pmatrix} + \mathcal{O}(\zeta^{-2}) \quad \text{as } \zeta \rightarrow \infty. \quad (4.21)$$

It is easy to verify that

$$Q_+^\infty(\zeta) = Q_-^\infty(\zeta) \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, \quad \zeta \in (-\frac{i}{\sqrt{2}}, \frac{i}{\sqrt{2}}),$$

so that $\tilde{\Psi}_c(\zeta)Q^\infty(\zeta)^{-1}$ has uniformly small jumps, except near $\pm \frac{i}{\sqrt{2}}$. To handle the jumps of $\tilde{\Psi}_c$ for ζ close to $\frac{i}{\sqrt{2}}$, we construct a local parametrix $Q^{(\frac{i}{\sqrt{2}})}(\zeta)$, defined for $|\zeta - \frac{i}{\sqrt{2}}| \leq \frac{1}{10}$ such that $P^{(\frac{i}{\sqrt{2}})}$ has the same jumps as $\tilde{\Psi}_c$ on this disk, and such that

$$Q^{(\frac{i}{\sqrt{2}})}(\zeta)Q^\infty(\zeta)^{-1} = I + \mathcal{O}(|s|^{-3/2}), \quad \text{as } s \rightarrow -\infty$$

uniformly for $|\zeta - \frac{i}{\sqrt{2}}| = \frac{1}{10}$. $Q^{(\frac{i}{\sqrt{2}})}$ can be constructed in terms of Airy function as in [18], but since this expression will not play any role for us, we do not provide details here. We then define

$$\tilde{R}(\zeta) = \begin{cases} \tilde{\Psi}_c(\zeta)Q^\infty(\zeta)^{-1}, & \text{if } |\zeta - \frac{i}{\sqrt{2}}| > \frac{1}{10} \text{ and } |\zeta + \frac{i}{\sqrt{2}}| > \frac{1}{10}, \\ \tilde{\Psi}_c(\zeta)Q^{(\frac{i}{\sqrt{2}})}(\zeta)^{-1}, & \text{if } |\zeta - \frac{i}{\sqrt{2}}| < \frac{1}{10}, \\ \overline{\tilde{\Psi}_c(\zeta)Q^{(\frac{i}{\sqrt{2}})}(\bar{\zeta})}^{-1}, & \text{if } |\zeta + \frac{i}{\sqrt{2}}| < \frac{1}{10}. \end{cases}$$

The jumps for \tilde{R} are $I + \mathcal{O}(|s|^{-3/2}e^{-|\zeta|})$ as $s \rightarrow -\infty$ uniformly for ζ on the contour, and therefore, by standard theory for small norms RH problems [19, 18],

$$\tilde{R}(\zeta) = I + \mathcal{O}\left(\frac{1}{(1+|\zeta|)|s|^{3/2}}\right), \quad \text{as } s \rightarrow -\infty, \quad (4.22)$$

uniformly for $\zeta \in \mathbb{C}$. Since $\tilde{\Psi}_c(\zeta) = \tilde{R}(\zeta)Q^\infty(\zeta)$ for all $|\zeta| \geq 1$, (4.19), (4.21) and (4.22) imply that

$$u(s) = \sqrt{-s/2} + \mathcal{O}(s^{-1}), \quad q(s) = -\frac{s^2}{4} + \mathcal{O}(1/s), \quad \text{as } s \rightarrow -\infty. \quad (4.23)$$

In fact, by [26, Theorem 10.2 (part 3 with $s_2 = 0$)], the first formula in (4.23) can be improved, while by (4.13) and (1.19), the second formula in (4.23) can be improved (more precisely, we need to use here the fact that the s -derivative of the \mathcal{O} -term in (1.19) is $\mathcal{O}(s^{-5/2})$, which follows from the analysis in [4, 17]). This gives

$$u(s) = \sqrt{-s/2} + \mathcal{O}(s^{-5/2}), \quad q(s) = -\frac{s^2}{4} + \frac{1}{8s} + \mathcal{O}(s^{-5/2}), \quad \text{as } s \rightarrow -\infty. \quad (4.24)$$

Inverting the transformations $\Psi \rightarrow \tilde{\Psi} \rightarrow \tilde{\Psi}_b \rightarrow \tilde{\Psi}_c \rightarrow \tilde{R}$, we obtain

$$\Psi(\zeta) = \tilde{\Psi}_c\left(\frac{\zeta}{|s|^{1/2}}\right)e^{|s|^{3/2}g(\zeta/|s|^{1/2})\sigma_3} = \tilde{R}\left(\frac{\zeta}{|s|^{1/2}}\right)Q^\infty\left(\frac{\zeta}{|s|^{1/2}}\right)e^{|s|^{3/2}g(\zeta/|s|^{1/2})\sigma_3}$$

for all $|\zeta| \geq \sqrt{|s|}$. By (4.22), we thus have

$$\Psi(\zeta) = \left(I + \mathcal{O}\left(\frac{1}{|s|^{3/2}\zeta}\right)\right) Q^\infty\left(\frac{\zeta}{|s|^{1/2}}\right)e^{\frac{4}{3}(\zeta^2 - s/2)^{3/2}\sigma_3}, \quad \text{as } s \rightarrow -\infty \quad (4.25)$$

uniformly for $|\zeta| \geq \sqrt{|s|}$. By expanding $(\zeta^2 - s/2)^{3/2}$ and $Q^\infty(\frac{\zeta}{|s|^{1/2}})$ as $\zeta/|s|^{1/2} \rightarrow \infty$, and by using the asymptotics (4.24) for $u(s)$ and $q(s)$, we can also rewrite (4.25) as

$$\Psi(\zeta) = \left(I + \frac{1}{\zeta} \begin{pmatrix} -\frac{1}{2}q(s) & -\frac{1}{2}u(s) \\ \frac{1}{2}u(s) & \frac{1}{2}q(s) \end{pmatrix} + \mathcal{O}\left(\frac{1}{|s|^{3/2}\zeta}\right) + \mathcal{O}\left(\frac{s^4}{\zeta^2}\right)\right) e^{\left(\frac{4}{3}\zeta^3 - s\zeta\right)\sigma_3}, \quad (4.26)$$

uniformly as $\zeta \rightarrow \infty$ and $s \rightarrow -\infty$ such that $s^2/\zeta \rightarrow 0$. In fact, the above asymptotics can be shown to hold as $s \rightarrow \infty$ such as $|\arg s - \pi| < \delta$, see e.g. [26, Chapter 11].

4.3 Local parametrix near x^*

We need to construct a local parametrix P near x^* satisfying the following conditions. We denote \mathcal{D} for the open disk centered at x^* with sufficiently small radius $\eta > 0$.

RH problem for P

- (a) $P : \mathcal{D} \setminus (\Sigma_0 \cup \Sigma_1) \rightarrow \mathbb{C}^{2 \times 2}$ is analytic.
- (b) $P_+(z) = P_-(z)J_T(z)$ for $z \in (\Sigma_0 \cup \Sigma_1) \cap \mathcal{D}$.
- (c) $P(z) = I + \mathcal{O}(N^{-1/3})$ as $N \rightarrow +\infty$ uniformly for $z \in \partial\mathcal{D}$.

We construct P of the form

$$P(z) = \left(\frac{(1-az)^\epsilon}{z}\right)^{-\frac{\sigma_3}{2}} \Psi\left(N^{\frac{1}{3}}f(z); N^{\frac{2}{3}}s(z; \kappa)\right) e^{\frac{N}{2}(\phi(z; \kappa) - \phi(x^*; \kappa))\sigma_3} \left(\frac{(1-az)^\epsilon}{z}\right)^{\frac{\sigma_3}{2}}. \quad (4.27)$$

Here f is a conformal map in a sufficiently small disk $\mathcal{D} := \{z \in \mathbb{C} : |z - x^*| < \eta\}$, given by

$$f(z) = \left(\frac{3}{8}\right)^{1/3} (\phi^* - \phi(z; \kappa_2))^{1/3}.$$

It satisfies

$$f(z) = f^*(z - x^*)(1 + \mathcal{O}(z - x^*)), \quad \text{as } z \rightarrow x^*, \quad (4.28)$$

by (4.3), with

$$f^* = \left(-\frac{1}{16} \phi'''(x^*; \kappa_2) \right)^{1/3} > 0. \quad (4.29)$$

Note that f (and therefore also f^*) is independent of κ . We choose, a posteriori, the jump contours Σ_0 and Σ_1 for T locally near x^* in such a way that $z \mapsto N^{\frac{1}{3}} f(z)$ maps $(\Sigma_0 \cup \Sigma_1) \cap \mathcal{D}$ to a subset of the jump contour Σ_Ψ for Ψ . By this choice, P has exactly the same jump relation as T on $(\Sigma_0 \cup \Sigma_1) \cap \mathcal{D}$, such that condition (b) of the RH problem for P is satisfied. The function s is defined by

$$s(z; \kappa) = \frac{\phi(z; \kappa) - \phi(x^*; \kappa) - (\phi(z; \kappa_2) - \phi^*)}{2f(z)} = (\kappa - \kappa_2) \frac{\log z - \log x^*}{2f(z)}. \quad (4.30)$$

Note that $\frac{s(z; \kappa)}{\kappa - \kappa_2}$ is independent of κ and satisfies

$$\frac{s(z; \kappa)}{\kappa - \kappa_2} = s^* + \mathcal{O}(z - x^*), \quad \text{as } z \rightarrow x^*, \quad s^* = \frac{1}{2x^* f^*}. \quad (4.31)$$

Hence, using also (4.30), we can (and do) choose η sufficiently small so that

$$\frac{9}{10} s^* |\kappa - \kappa_2| \leq |s(z; \kappa)| \leq \frac{11}{10} s^* |\kappa - \kappa_2| \quad \text{for all } z \in \partial \mathcal{D}.$$

As $N \rightarrow +\infty$, the RH problem for Ψ , more specifically (4.11) together with the strengthened versions (4.15)-(4.16) as $s \rightarrow +\infty$ and (4.26) as $s \rightarrow -\infty$, implies that

$$\begin{aligned} P(z) &= I + \frac{1}{N^{\frac{1}{3}} f(z)} \left(\frac{(1 - az)^\epsilon}{z} \right)^{-\frac{\sigma_3}{2}} \begin{pmatrix} -\frac{1}{2} q(N^{\frac{2}{3}} s(z; \kappa)) & -\frac{1}{2} u(N^{\frac{2}{3}} s(z; \kappa)) \\ \frac{1}{2} u(N^{\frac{2}{3}} s(z; \kappa)) & \frac{1}{2} q(N^{\frac{2}{3}} s(z; \kappa)) \end{pmatrix} \left(\frac{(1 - az)^\epsilon}{z} \right)^{\frac{\sigma_3}{2}} \\ &+ 1_{\{|\kappa - \kappa_2| \leq N^{-2/3}\}} \mathcal{O}(N^{-2/3}) + 1_{\{\kappa < \kappa_2\}} \mathcal{O}(N^2 s(z; \kappa)^4) + 1_{\{\kappa \geq \kappa_2\}} \mathcal{O}(N^{-\frac{1}{2}} s(z; \kappa)^{1/4} e^{-\frac{2}{3} N s(z; \kappa)^{3/2}}), \end{aligned}$$

as $N \rightarrow \infty$, which can be rewritten as

$$\begin{aligned} P(z) &= I + \frac{1}{N^{\frac{1}{3}} f(z)} \left(\frac{(1 - az)^\epsilon}{z} \right)^{-\frac{\sigma_3}{2}} \begin{pmatrix} -\frac{1}{2} q(N^{\frac{2}{3}} s(z; \kappa)) & -\frac{1}{2} u(N^{\frac{2}{3}} s(z; \kappa)) \\ \frac{1}{2} u(N^{\frac{2}{3}} s(z; \kappa)) & \frac{1}{2} q(N^{\frac{2}{3}} s(z; \kappa)) \end{pmatrix} \left(\frac{(1 - az)^\epsilon}{z} \right)^{\frac{\sigma_3}{2}} \\ &+ 1_{\{|\kappa - \kappa_2| \leq N^{-2/3}\}} \mathcal{O}(N^{-2/3}) + 1_{\{\kappa < \kappa_2\}} \mathcal{O}(N^2 (\kappa_2 - \kappa)^4) + 1_{\{\kappa \geq \kappa_2\}} \mathcal{O}\left(\frac{(\kappa - \kappa_2)^{1/4}}{N^{1/2}} e^{-c' N (\kappa - \kappa_2)^{3/2}} \right). \end{aligned} \quad (4.32)$$

for any fixed $0 < c' < \frac{2}{3} (s^*)^{3/2}$. This expansion is uniform in $z \in \partial \mathcal{D}$ and the error terms are uniformly small for $\frac{a^2}{1+a^2} (1 + \delta) \leq \mu \leq 1 - \delta$ and for $\kappa \in [\kappa_2 - \frac{1}{N^\epsilon}, \kappa_2 + \delta]$ for $\delta > 0$ sufficiently small and for $\epsilon > 1/2$.

4.4 Small norm RH problem

Define

$$R(z) = \begin{cases} T(z), & z \in \mathbb{C} \setminus \overline{\mathcal{D}}, \\ T(z) P(z)^{-1}, & z \in \mathcal{D}. \end{cases} \quad (4.33)$$

R satisfies the following RH problem.

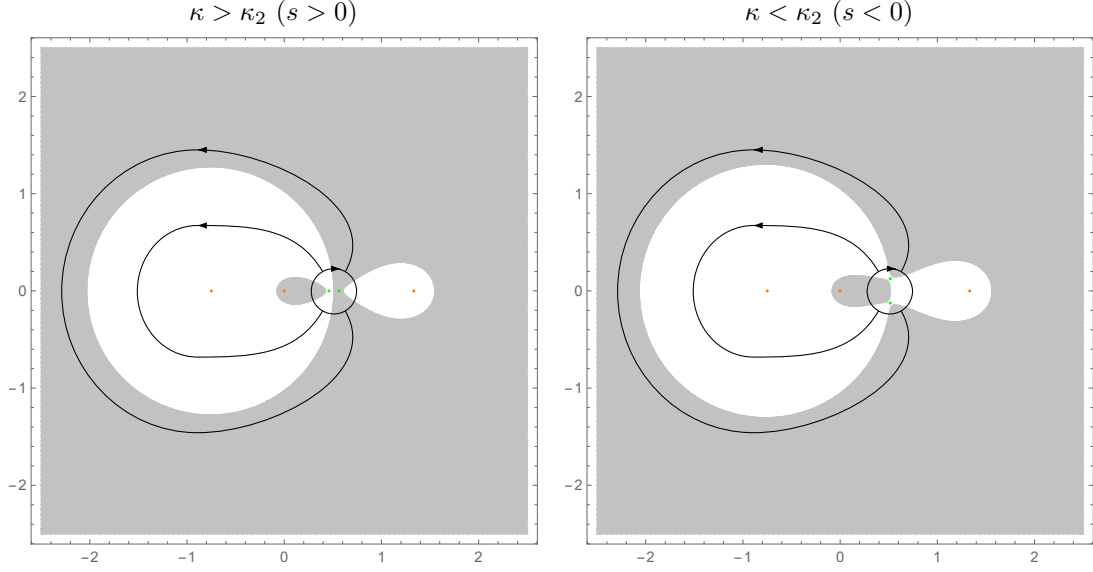


Figure 10: In all images, Σ_R is the black oriented contour. The shaded regions correspond to $\{z : \Re\phi(z; \kappa) > h\}$ and the white regions to $\{z : \Re\phi(z; \kappa) < h\}$, where $h = \phi(x^*; \kappa)$. The orange dots are $-a, 0, 1/a$, and the green dots are $x_1(\kappa), x_2(\kappa)$. The jump contour Σ_R is independent of s and is therefore the same in both images.

RH problem for R

- (a) $R : \mathbb{C} \setminus \Sigma_R \rightarrow \mathbb{C}^{2 \times 2}$ is analytic, where

$$\Sigma_R = \partial\mathcal{D} \cup ((\Sigma_0 \cup \Sigma_1) \setminus \mathcal{D}).$$

The contour Σ_R is oriented as shown in Figure 10. In particular, we orient the circle $\partial\mathcal{D}$ in the clockwise direction.

- (b) For $z \in \Sigma_R$, we have $R_+(z) = R_-(z)J_R(z)$, where

$$\begin{aligned} J_R(z) &= P(z), & z \in \partial\mathcal{D}, \\ J_R(z) &= J_T(z), & z \in \Sigma_R \setminus \partial\mathcal{D}. \end{aligned}$$

- (c) $R(z)$ remains bounded as z tends to the points of self-intersection of Σ_R .

As $z \rightarrow \infty$, $R(z) = I + \frac{R_1}{z} + \mathcal{O}(z^{-2})$ for some R_1 independent of z .

Observe that we have the symmetry $R(z) = \overline{R(\bar{z})}$, $z \in \mathbb{C} \setminus \Sigma_R$.

On $\partial\mathcal{D}$, by (4.32) and (4.30), we have

$$\begin{aligned} J_R(z) &= I + \frac{J_R^{(1)}(z; N^{2/3}s(z; \kappa))}{N^{1/3}} + 1_{|\kappa - \kappa_2| \leq N^{-2/3}} \mathcal{O}(N^{-2/3}) \\ &\quad + 1_{\{\kappa < \kappa_2\}} \mathcal{O}\left(N^2(\kappa_2 - \kappa)^4\right) + 1_{\{\kappa \geq \kappa_2\}} \mathcal{O}\left(\frac{(\kappa - \kappa_2)^{1/4}}{N^{1/2}} e^{-c'N(\kappa - \kappa_2)^{3/2}}\right), \end{aligned} \quad (4.34)$$

as $N \rightarrow \infty$ uniformly for $z \in \partial\mathcal{D}$ and $\kappa \in [\kappa_2 - \frac{1}{N^\epsilon}, \kappa_2 + \delta]$, for some fixed constants $\delta > 0$, $\epsilon > 1/2$ and $c' \in (0, \frac{2}{3}(s^*)^{3/2})$, and for some matrix $J_R^{(1)}(z; s)$. On the rest of the (bounded) contour, by Corollary 3.2 (part 2, using also that $\phi(z; \kappa)$ vary smoothly with κ) and (4.1), we have

$$J_R(z) = I + \mathcal{O}(e^{-cN}), \quad \text{as } N \rightarrow +\infty$$

uniformly for $z \in \Sigma_R \setminus \partial\mathcal{D}$ and $\kappa \in [\kappa_2 - \frac{1}{N^\epsilon}, \kappa_2 + \delta]$. By small-norm theory of RH problems [19, 18], we then obtain a similar expansion for R :

$$\begin{aligned} R(z) = I + \frac{R^{(1)}(z; N^{2/3}s(z; \kappa))}{N^{1/3}} + 1_{|\kappa - \kappa_2| \leq N^{-2/3}} \mathcal{O}\left(\frac{1}{N^{2/3}(1+|z|)}\right) \\ + 1_{\{\kappa < \kappa_2\}} \mathcal{O}\left(\frac{N^2(\kappa_2 - \kappa)^4}{1+|z|}\right) + 1_{\{\kappa \geq \kappa_2\}} \mathcal{O}\left(\frac{(\kappa - \kappa_2)^{1/4} e^{-c'N(\kappa - \kappa_2)^{3/2}}}{N^{1/2}(1+|z|)}\right), \end{aligned} \quad (4.35)$$

as $N \rightarrow \infty$ uniformly for $z \in \mathbb{C} \setminus \Sigma_R$ and $\kappa \in [\kappa_2 - \frac{1}{N^\epsilon}, \kappa_2 + \delta]$. By substituting (4.34) and (4.35) in the jump relation $R_+ = R_- J_R$ valid on $\partial\mathcal{D}$ we obtain the relation (omitting the dependence on $N^{2/3}s(z; \kappa)$ in our notations)

$$R_+^{(1)}(z) - R_-^{(1)}(z) = J_R^{(1)}(z), \quad z \in \partial\mathcal{D}.$$

Since $R^{(1)}(z) \rightarrow 0$ as $z \rightarrow \infty$, this relation allows us to compute $R^{(1)}$ explicitly as the Cauchy integral

$$R^{(1)}(z) = \frac{1}{2\pi i} \int_{\partial\mathcal{D}} \frac{J_R^{(1)}(s)}{s - z} ds,$$

where we recall that the orientation of the disk is clockwise. Therefore, for $z \in \mathbb{C} \setminus \overline{\mathcal{D}}$, we have

$$R^{(1)}(z) = \frac{1}{z - x^*} \text{Res}\left(J_R^{(1)}(s); s = x^*\right).$$

The above residue can be computed explicitly using (4.31), (4.32) and (4.28):

$$\text{Res}\left(J_R^{(1)}(s); s = x^*\right) = \frac{1}{f_0} \begin{pmatrix} -\frac{1}{2}q(N^{\frac{2}{3}}(\kappa - \kappa_2)s^*) & -\frac{1}{2}u(N^{\frac{2}{3}}(\kappa - \kappa_2)s^*) \frac{x^*}{(1-ax^*)^\epsilon} \\ \frac{1}{2}u(N^{\frac{2}{3}}(\kappa - \kappa_2)s^*) \frac{(1-ax^*)^\epsilon}{x^*} & \frac{1}{2}q(N^{\frac{2}{3}}(\kappa - \kappa_2)s^*) \end{pmatrix}. \quad (4.36)$$

We now have all the ingredients needed to compute the large N asymptotics for $F_N^{m,k}(a; \epsilon)$.

Proposition 4.1 (Ratio asymptotics in the Tracy-Widom region). *As $N \rightarrow \infty$, we have*

$$\begin{aligned} \log F_N^{m,k}(a; \epsilon) - \log F_N^{m,k+1}(a; \epsilon) = \frac{s^*}{N^{1/3}} q(N^{\frac{2}{3}}(\kappa - \kappa_2)s^*) + 1_{\{|\kappa - \kappa_2| \leq N^{-2/3}\}} \mathcal{O}(N^{-2/3}) \\ + 1_{\{\kappa < \kappa_2\}} \mathcal{O}\left(N^2(\kappa_2 - \kappa)^4\right) + 1_{\{\kappa \geq \kappa_2\}} \mathcal{O}(N^{-1/2} e^{-c'N(\kappa - \kappa_2)^{3/2}}), \end{aligned}$$

uniformly for $\frac{a^2}{1+a^2}(1+\delta) \leq \mu \leq 1-\delta$ and for $\kappa_2 - N^{-\epsilon} \leq \kappa \leq \kappa_2 + \delta$ with $\epsilon > 1/2$, $c' \in (0, \frac{2}{3}(s^*)^{3/2})$ fixed and $\delta > 0$ fixed and sufficiently small.

Proof. By (3.3) (with $h = \phi(x^*; \kappa)$) and (4.33), for $z = 0$, we have

$$Y(z) = Y(z; k) = e^{-\frac{N\phi(x^*; \kappa)}{2}\sigma_3} R(z) e^{\frac{N\phi(x^*; \kappa)}{2}\sigma_3}.$$

Using also (4.35), (4.36) and the fact that for any $0 < c'' < c'$, there exists N_0 such that

$$x^{1/4}e^{-c'Nx^{3/2}} \leq e^{-c''Nx^{3/2}}, \quad \text{for all } x \geq 0, N \geq N_0, \quad (4.37)$$

we obtain (after renaming c'' as c')

$$\begin{aligned} Y_{22}(0; k) = R_{22}(0; k) = 1 - \frac{1}{N^{\frac{1}{3}}} \frac{1}{2f_0 x^*} q(N^{-\frac{1}{3}}(k - N\kappa_2)s^*) + 1_{\{|\kappa - \kappa_2| \leq N^{-2/3}\}} \mathcal{O}(N^{-2/3}) \\ + 1_{\{\kappa < \kappa_2\}} \mathcal{O}(N^2(\kappa_2 - \kappa)^4) + 1_{\{\kappa \geq \kappa_2\}} \mathcal{O}\left(\frac{e^{-c'N(\kappa - \kappa_2)^{3/2}}}{N^{1/2}}\right). \end{aligned}$$

By (2.4) and (4.31), the result follows. \square

Corollary 4.2. *As $N \rightarrow +\infty$, we have*

$$\log F_N^{m,k}(a; \epsilon) - \log F_N(a) = \log F^{\text{TW}}\left(s^* N^{2/3}(\kappa - \kappa_2)\right) + \mathcal{E}_N,$$

uniformly for $\frac{a^2}{1+a^2}(1+\delta) \leq \mu \leq 1-\delta$ and for $\kappa_2 - N^{\mathfrak{c}-1} \leq \kappa \leq \kappa_2 + \delta$ with $\mathfrak{c} < 2/5$ fixed and $\delta > 0$ fixed and sufficiently small, where \mathcal{E}_N satisfies

$$\mathcal{E}_N = \begin{cases} \mathcal{O}(N^{-1/3}), & \text{if } N^{\frac{2}{3}}(\kappa - \kappa_2) \text{ is bounded,} \\ \mathcal{O}\left(\frac{e^{-c'N(\kappa - \kappa_2)^{3/2}}}{N^{1/2}(\kappa - \kappa_2)^{1/4}}\right), & \text{if } N^{\frac{2}{3}}(\kappa - \kappa_2) \rightarrow +\infty, \\ \mathcal{O}(N^3(\kappa_2 - \kappa)^5), & \text{if } N^{\frac{2}{3}}(\kappa - \kappa_2) \rightarrow -\infty, \end{cases} \quad (4.38)$$

and where $c' \in (0, \frac{2}{3}(s^*)^{3/2})$ is arbitrary but fixed.

Proof. We take the sum of $\log F_N^{m,j}(a; \epsilon) - \log F_N^{m,j+1}(a; \epsilon)$ for $j = k, k+1, \dots, k_{\max} - 1$, where we choose $N(\kappa_2 + \delta/2) < k_{\max} < N(\kappa_2 + \delta)$. By Proposition 4.1, we get

$$\begin{aligned} \log F_N^{m,k}(a; \epsilon) - \log F_N^{m,k_{\max}}(a; \epsilon) = \sum_{j=k}^{k_{\max}-1} \left(\frac{s^*}{N^{\frac{1}{3}}} q(N^{-\frac{1}{3}}(j - N\kappa_2)s^*) + 1_{\{|k - \kappa_2|N \leq N^{1/3}\}} \mathcal{O}(N^{-2/3}) \right. \\ \left. + 1_{\{k < N\kappa_2\}} \mathcal{O}(N^{-2}(N\kappa_2 - k)^4) + 1_{\{k \geq N\kappa_2\}} \mathcal{O}(N^{-1/2}e^{-c'N^{-1/2}(k - N\kappa_2)^{3/2}}) \right), \end{aligned}$$

as $N \rightarrow \infty$. We recognize the first part of the sum as a Riemann sum for the (smooth and fast decaying at $+\infty$) function q :

$$\begin{aligned} \frac{s^*}{N^{\frac{1}{3}}} \sum_{j=k}^{k_{\max}-1} q(N^{-\frac{1}{3}}(j - N\kappa_2)s^*) \\ = \int_{s^*N^{-1/3}(k - N\kappa_2)}^{s^*N^{-1/3}(k_{\max} - N\kappa_2)} q(s) ds + \mathcal{O}\left(\frac{q(N^{\frac{2}{3}}(\kappa - \kappa_2)s^*)}{N^{\frac{1}{3}}}\right), \quad \text{as } N \rightarrow +\infty. \end{aligned}$$

By (4.16) and (4.23), as $N \rightarrow \infty$, we have

$$\frac{q(N^{\frac{2}{3}}(\kappa - \kappa_2)s^*)}{N^{\frac{1}{3}}} = \begin{cases} \mathcal{O}(N^{-1/3}), & \text{if } N^{\frac{2}{3}}(\kappa - \kappa_2) \text{ is bounded,} \\ \mathcal{O}\left(\frac{e^{-\frac{2}{3}(s^*)^{3/2}N(\kappa - \kappa_2)^{3/2}}}{N^{1/2}(\kappa - \kappa_2)^{1/4}}\right), & \text{if } N^{\frac{2}{3}}(\kappa - \kappa_2) \rightarrow +\infty, \\ \mathcal{O}(N(\kappa - \kappa_2)^2), & \text{if } N^{\frac{2}{3}}(\kappa - \kappa_2) \rightarrow -\infty. \end{cases}$$

Observe also that as $N \rightarrow +\infty$,

$$\begin{aligned} \sum_{j=k}^{k_{\max}-1} 1_{\{k < N\kappa_2\}} N^{-2} (N\kappa_2 - k)^4 &= \begin{cases} \mathcal{O}(N^{-1/3}), & \text{if } N^{\frac{2}{3}}(\kappa - \kappa_2) \text{ is bounded,} \\ \mathcal{O}(N^3(\kappa_2 - \kappa)^5), & \text{if } N^{\frac{2}{3}}(\kappa - \kappa_2) \rightarrow -\infty, \end{cases} \\ \sum_{j=k}^{k_{\max}-1} 1_{\{k \geq N\kappa_2\}} N^{-1/2} e^{-c' N(\kappa - \kappa_2)^{3/2}} &= \begin{cases} \mathcal{O}(N^{-1/2}), & \text{if } N^{\frac{2}{3}}(\kappa - \kappa_2) \text{ is bounded} \\ \mathcal{O}\left(\frac{e^{-c' N(\kappa - \kappa_2)^{3/2}}}{N^{1/2}}\right), & \text{if } N^{\frac{2}{3}}(\kappa - \kappa_2) \rightarrow +\infty. \end{cases} \end{aligned}$$

Using also that $\log F_N^{m, k_{\max}}(a; \epsilon) - \log F_N(a)$ is exponentially small as $N \rightarrow \infty$ by Theorem 1.11, we obtain

$$\log F_N^{m, k}(a; \epsilon) - \log F_N(a) = \int_{s^* N^{2/3}(\kappa - \kappa_2)}^{+\infty} q(s) ds + \mathcal{E}_N, \quad \text{as } N \rightarrow +\infty,$$

where \mathcal{E}_N satisfies (4.38). Since $u^2(s)$ is the derivative of $q(s)$ (with $u(s)$ the Hastings-McLeod solution of Painlevé II), we can integrate by parts to obtain

$$\begin{aligned} \log F_N^{m, k}(a; \epsilon) - \log F_N(a) &= - \int_{s^* N^{2/3}(\kappa - \kappa_2)}^{+\infty} (s - s^* N^{-1/3}(k - N\kappa_2)) u^2(s) ds + \mathcal{E}_N \\ &= \log F^{\text{TW}}\left(s^* N^{-1/3}(k - N\kappa_2)\right) + \mathcal{E}_N, \quad N \rightarrow \infty. \end{aligned}$$

□

We finally observe that $s^* = (c^*)^{-1/3}$, by (1.12), (2.6), (4.29) and (4.31). This completes the proof of Theorem 1.9.

5 Almost maximal removed corner

In this section, $k \in \{1, \dots, M\}$ for some fixed $M \in \mathbb{N}$, and $\mu = m/N \in (0, 1)$.

5.1 The RH problem for Y

We start from the RH problem for Y from Section 2, and we deform the contour Σ_0 so that it coincides with Σ_1 (here we use the fact that Σ_0 is allowed to cross $-a$). In this way, Y satisfies the following properties. Note that the jump matrix in (5.1) below is the product of the jump matrices on Σ_1 and Σ_0 from (2.7).

RH problem for Y

- (a) $Y : \mathbb{C} \setminus \Sigma_1 \rightarrow \mathbb{C}^{2 \times 2}$ is analytic, with Σ_1 positively oriented and enclosing 0, $-a$ without enclosing $1/a$.
- (b) $Y_+(z) = Y_-(z) J_Y(z)$ for $z \in \Sigma_1$, with

$$J_Y(z) = \begin{pmatrix} 0 & \frac{z}{(1-az)^\epsilon} z^{-k} e^{-N\phi(z;0)} \\ -\frac{(1-az)^\epsilon}{z} z^k e^{N\phi(z;0)} & 1 \end{pmatrix}, \quad z \in \Sigma_1. \quad (5.1)$$

- (c) As $z \rightarrow \infty$, $Y(z) = I + \mathcal{O}(z^{-1})$.

5.2 Transformation $Y \mapsto T$

With our next transformation, we reshuffle and renormalize the entries of the jump matrix by defining

$$T(z) = \begin{cases} -\sigma_1 Y(z) \sigma_3 (1 - az)^{-(1-\mu)N\sigma_3}, & \text{inside } \Sigma_1, \\ \sigma_1 Y(z) \sigma_1 \left(\frac{z+a}{z} \right)^{\mu N\sigma_3}, & \text{outside } \Sigma_1. \end{cases} \quad (5.2)$$

T satisfies the following RH problem.

RH problem for T

- (a) $T : \mathbb{C} \setminus \Sigma_1 \rightarrow \mathbb{C}^{2 \times 2}$ is analytic.
- (b) $T_+(z) = T_-(z) J_T(z)$ for $z \in \Sigma_1$, with

$$J_T(z) = \begin{pmatrix} \frac{(1-az)^\epsilon}{z} z^k & e^{N\varphi_0(z)} \\ 0 & \frac{z}{(1-az)^\epsilon} z^{-k} \end{pmatrix}, \quad z \in \Sigma_1,$$

where

$$\varphi_0(z) := (1 - \mu) \log(1 - az) - \mu \log(z + a) + \mu \log z$$

and the principal branch is used for the logarithms.

- (c) As $z \rightarrow \infty$, $T(z) = I + \mathcal{O}(z^{-1})$.

Note that $\varphi_0(z)$ is not equal to $\phi(z; 0)$ defined in (2.6): indeed the signs of two terms are different. The new phase function φ_0 has two saddle points, which are given by

$$x_0 = \frac{-a - \sqrt{a^2 + 4\mu(1-\mu)}}{2(1-\mu)} \in (-\infty, -a), \quad \gamma_0 = \frac{-a + \sqrt{a^2 + 4\mu(1-\mu)}}{2(1-\mu)} \in (0, \frac{1}{a}).$$

The relevant saddle point for our analysis is x_0 . Since $\varphi_0''(x_0) > 0$, there are four vertical trajectories emanating from x_0 , making angles $\pm \frac{\pi}{4}, \pm \frac{3\pi}{4}$ with respect to \mathbb{R} . Since

$$\Re \varphi_0(\infty) = \Re \varphi_0(-a) = +\infty, \quad \Re \varphi_0(0) = \Re \varphi_0(\frac{1}{a}) = -\infty, \quad (5.3)$$

the two trajectories (say Γ_1, Γ_2) going into the upper half-plane cannot connect with $+\infty, -a, 0, \frac{1}{a}$. By the max/min principle for harmonic functions, these trajectories can neither form closed loops in the upper half-plane nor intersect each other. Hence they must intersect \mathbb{R} at two distinct points. A direct inspection of $x \mapsto \Re \varphi_0(x)$ for $x \in \mathbb{R}$ then shows that one curve must intersect $(-a, 0)$ and the other one must intersect $(\frac{1}{a}, +\infty)$. The symmetry $\varphi_0(z) = \overline{\varphi_0(\bar{z})}$ then implies that Γ_1, Γ_2 are symmetric with respect to \mathbb{R} (hence they must be closed loops). The graph of $x \mapsto \Re \varphi_0(x)$ for $x \in \mathbb{R}$ also shows that

$$\{x \in \mathbb{R} \setminus \{x_0\} : \Re \varphi_0(x) = \varphi_0(x_0)\}$$

consists of exactly two points; hence, by the max/min principle for harmonic functions, the level set

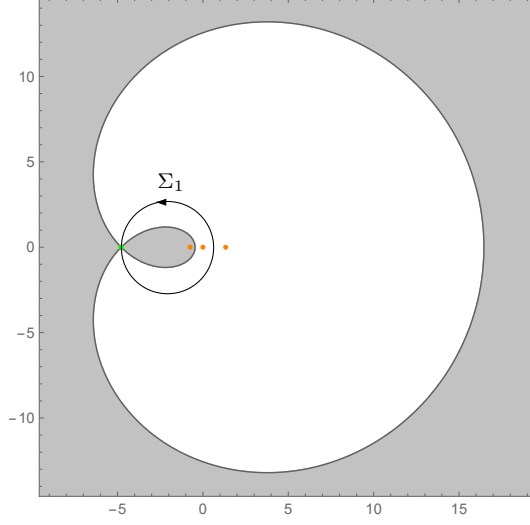


Figure 11: The shaded regions correspond to $\{z : \Re \varphi_0(z) > h\}$ and the white regions to $\{z : \Re \varphi_0(z) < h\}$, where $h = \varphi_0(x_0)$. The orange dots are $-a, 0, 1/a$, and the green dot is x_0 . The figure is drawn for $a = 0.75$ and $\mu = 0.808 \in (\frac{a^2}{1+a^2}, 1)$.

$$\{z \in \mathbb{C} : \Re \varphi_0(z) = \varphi_0(x_0)\}$$

consists exclusively of $\Gamma_1 \cup \Gamma_2$, see also Figure 11. The set $\Gamma_1 \cup \Gamma_2$ delimits three regions, and the sign of φ_0 within each region is determined by (5.3).

The above discussion shows that we can deform the contour Σ_1 of the RH problem for T so that

$$\Sigma_1 \setminus \{x_0\} \subset \{z \in \mathbb{C} : \Re \varphi_0(z) < \varphi_0(x_0)\}, \quad (5.4)$$

see again Figure 11.

5.3 Transformation $T \mapsto S$

Next, in order to create jump matrices close to the identity matrix, we define

$$S(z) = e^{-\frac{N}{2} \varphi_0(x_0) \sigma_3} T(z) e^{\frac{N}{2} \varphi_0(x_0) \sigma_3}. \quad (5.5)$$

S satisfies the following RH problem.

RH problem for S

- (a) $S : \mathbb{C} \setminus \Sigma_1 \rightarrow \mathbb{C}^{2 \times 2}$ is analytic.
- (b) $S_+(z) = S_-(z) J_S(z)$ for $z \in \Sigma_1$, with

$$J_S(z) = \begin{pmatrix} \frac{(1-az)^\epsilon}{z} z^k & e^{N(\varphi_0(z) - \varphi_0(x_0))} \\ 0 & \frac{z}{(1-az)^\epsilon} z^{-k} \end{pmatrix}, \quad z \in \Sigma_1.$$

- (c) As $z \rightarrow \infty$, $S(z) = I + \mathcal{O}(z^{-1})$.

By (5.4), the $(1, 2)$ -entry of J_S is uniformly exponentially small on Σ_1 as $N \rightarrow +\infty$, except within a fixed neighborhood of x_0 .

5.4 Global parametrix

We now construct a global parametrix $\hat{P}^{(\infty)}$ satisfying the following properties.

RH problem for $\hat{P}^{(\infty)}$

- (a) $\hat{P}^{(\infty)} : \mathbb{C} \setminus \Sigma_1 \rightarrow \mathbb{C}^{2 \times 2}$ is analytic.
- (b) $\hat{P}_+^{(\infty)}(z) = \hat{P}_-^{(\infty)}(z) \begin{pmatrix} \frac{(1-az)^\epsilon}{z} z^k & 0 \\ 0 & \frac{z}{(1-az)^\epsilon} z^{-k} \end{pmatrix}$ for $z \in \Sigma_1 \setminus \{x_0\}$.
- (c) As $z \rightarrow \infty$, $\hat{P}^{(\infty)}(z) = I + \mathcal{O}(z^{-1})$.

A solution to the above RH problem is given by

$$\hat{P}^{(\infty)}(z) = \begin{cases} \begin{pmatrix} \frac{(1-az)^\epsilon}{z-x_0} (z-x_0)^k & 0 \\ 0 & \frac{z-x_0}{(1-az)^\epsilon} (z-x_0)^{-k} \end{pmatrix}, & \text{if } z \text{ is inside } \Sigma_1, \\ \begin{pmatrix} \frac{(z-x_0)^{k-1}}{z^{k-1}} & 0 \\ 0 & \frac{z^{k-1}}{(z-x_0)^{k-1}} \end{pmatrix}, & \text{otherwise.} \end{cases} \quad (5.6)$$

Note that $\hat{P}^{(\infty)}$ has a singularity at x_0 .

5.5 Local parametrix

We need to construct a local parametrix P near x_0 satisfying the following conditions. We denote \mathcal{D} for the open disk centered at x_0 with small but fixed radius $\eta > 0$.

RH problem for P

- (a) $P : \mathcal{D} \setminus \Sigma_1 \rightarrow \mathbb{C}^{2 \times 2}$ is analytic.
- (b) $P_+(z) = P_-(z) J_S(z)$ for $z \in \Sigma_1 \cap \mathcal{D}$.
- (c) $P(z) = \hat{P}^{(\infty)}(z) (I + \mathcal{O}(N^{-1/2}))$ as $N \rightarrow \infty$ uniformly for $z \in \partial \mathcal{D}$.

We will construct P using the following model RH problem, whose solution can be constructed using Hermite polynomials.

RH problem for Υ

- (a) $\Upsilon : \mathbb{C} \setminus \mathbb{R} \rightarrow \mathbb{C}^{2 \times 2}$ is analytic, where \mathbb{R} is oriented from left to right.
- (b) For $x \in \mathbb{R}$,

$$\Upsilon_+(x) = \Upsilon_-(x) \begin{pmatrix} 1 & e^{-x^2/2} \\ 0 & 1 \end{pmatrix}.$$

- (c) As $\zeta \rightarrow \infty$, we have

$$\Upsilon(\zeta) = \left(I + \frac{1}{\zeta} \begin{pmatrix} 0 & \frac{i(k-1)!}{\sqrt{2\pi}} \\ \frac{-i\sqrt{2\pi}}{(k-2)!} & 0 \end{pmatrix} + \mathcal{O}(\zeta^{-2}) \right) \zeta^{(k-1)\sigma_3}. \quad (5.7)$$

This is a special case of the Fokas-Its-Kitaev RH problem characterizing orthogonal polynomials [24], corresponding to the weight function $e^{-x^2/2}$. The relevant orthogonal polynomials are then Hermite

polynomials. Writing p_j for the normalized Hermite polynomial of degree j and $\kappa_j = \frac{1}{(2\pi)^{1/4}\sqrt{j!}}$ for its leading coefficient, and the solution Υ can be constructed as follows,

$$\Upsilon(\zeta) = \begin{pmatrix} \frac{1}{\kappa_{k-1}} p_{k-1}(\zeta) & \frac{1}{2\pi i \kappa_{k-1}} \int_{\mathbb{R}} p_{k-1}(s) e^{-s^2/2} \frac{ds}{s-\zeta} \\ -2\pi i \kappa_{k-2} p_{k-2}(\zeta) & -\kappa_{k-2} \int_{\mathbb{R}} p_{k-2}(s) e^{-s^2/2} \frac{ds}{s-\zeta} \end{pmatrix}.$$

Then $\hat{\Upsilon}(z) := \Upsilon(z) e^{-\frac{z^2}{4}\sigma_3}$ has constant jumps. We construct the local parametrix $P(z)$ for $z \in \mathcal{D} \setminus \Sigma_1$ as follows:

$$P(z) = E(z) \hat{\Upsilon}(\sqrt{N}f(z)) e^{-\frac{N}{2}(\varphi_0(z) - \varphi_0(x_0))\sigma_3} \hat{\mathcal{G}}(z)^{\sigma_3},$$

where f is the conformal map from \mathcal{D} to a neighborhood of 0 given by

$$f(z) = i\sqrt{2(\varphi_0(z) - \varphi_0(x_0))}, \quad (5.8)$$

and E and $\hat{\mathcal{G}}$ are defined by

$$E(z) = \hat{P}^{(\infty)}(z) \hat{\mathcal{G}}(z)^{-\sigma_3} f(z)^{-(k-1)\sigma_3}, \quad (5.9)$$

$$\hat{\mathcal{G}}(z) = \begin{cases} (1-az)^{\frac{\sigma_3}{2}} i^{-k+1} (-z)^{\frac{k-1}{2}}, & \text{if } z \text{ is inside } \Sigma_1, \\ (1-az)^{-\frac{\sigma_3}{2}} i^{k-1} (-z)^{-\frac{k-1}{2}}, & \text{if } z \text{ is outside } \Sigma_1, \end{cases} \quad (5.10)$$

In (5.10), the principal branch is used for the roots, and in (5.8), the branch for the root is chosen so that

$$f(z) = i\sqrt{\varphi_0''(x_0)(z-x_0)}(1 + \mathcal{O}(z-x_0)), \quad \text{as } z \rightarrow x_0.$$

We also choose the contour Σ_1 so that $f(\Sigma_1) \subset \mathbb{R}$. It is easy to check that $E(z)$ has no jumps for $z \in \mathcal{D}$. Moreover, by (5.6), $E(z) = \mathcal{O}(1)$ as $z \rightarrow x_0$. Hence E is analytic in \mathcal{D} . Using (5.7), we obtain

$$P(z) \hat{P}^{(\infty)}(z)^{-1} = N^{-\frac{k-1}{2}\sigma_3} \left\{ I + \frac{E(z)}{\sqrt{N}f(z)} \begin{pmatrix} 0 & \frac{i(k-1)!}{\sqrt{2\pi}} \\ \frac{-i\sqrt{2\pi}}{(k-2)!} & 0 \end{pmatrix} E(z)^{-1} + \mathcal{O}(N^{-1}) \right\} N^{\frac{k-1}{2}\sigma_3}, \quad (5.11)$$

as $N \rightarrow \infty$ uniformly for $z \in \partial\mathcal{D}$.

5.6 Small norm RH problem

Define

$$R(z) = \begin{cases} N^{\frac{k-1}{2}\sigma_3} S(z) \hat{P}^{(\infty)}(z)^{-1} N^{-\frac{k-1}{2}\sigma_3}, & z \in \mathbb{C} \setminus \overline{\mathcal{D}}, \\ N^{\frac{k-1}{2}\sigma_3} S(z) P(z)^{-1} N^{-\frac{k-1}{2}\sigma_3}, & z \in \mathcal{D}. \end{cases} \quad (5.12)$$

R satisfies the following RH problem.

RH problem for R

(a) $R : \mathbb{C} \setminus \Sigma_R \rightarrow \mathbb{C}^{2 \times 2}$ is analytic, where

$$\Sigma_R = \partial\mathcal{D} \cup (\Sigma_1 \setminus \mathcal{D})$$

and where $\partial\mathcal{D}$ is oriented in the clockwise direction.

(b) For $z \in \Sigma_R$, we have $R_+(z) = R_-(z)J_R(z)$, where

$$\begin{aligned} J_R(z) &= P(z)\hat{P}^{(\infty)}(z)^{-1}, & z \in \partial\mathcal{D}, \\ J_R(z) &= \hat{P}^{(\infty)}(z)J_S(z)\hat{P}^{(\infty)}(z)^{-1}, & z \in \Sigma_R \setminus \partial\mathcal{D}. \end{aligned}$$

(c) $R(z)$ remains bounded as z tends to the points of self-intersections of Σ_R .

As $z \rightarrow \infty$, $R(z) = I + \frac{R_1}{z} + \mathcal{O}(z^{-2})$ for some R_1 independent of z .

From the matching condition (5.11), we obtain

$$J_R(z) = I + \frac{E(z)}{\sqrt{N}f(z)} \begin{pmatrix} 0 & \frac{i(k-1)!}{\sqrt{2\pi}} \\ \frac{-i\sqrt{2\pi}}{(k-2)!} & 0 \end{pmatrix} E(z)^{-1} + \mathcal{O}(N^{-1}),$$

for $z \in \partial\mathcal{D}$. It follows from standard theory for small norm RH problems [19, 18] that

$$R(z) = I + \frac{R^{(1)}(z)}{\sqrt{N}} + \mathcal{O}\left(\frac{1}{N(1+|z|)}\right), \quad N \rightarrow \infty, \quad (5.13)$$

uniformly for $z \in \mathbb{C} \setminus \Sigma_R$. For $z \in \mathbb{C} \setminus \bar{\mathcal{D}}$, we obtain by residue computation that

$$R^{(1)}(z) = \frac{1}{z-x_0} \frac{1}{\sqrt{\varphi_0''(x_0)}} \begin{pmatrix} 0 & E_{11}(x_0)^2 \frac{(k-1)!}{\sqrt{2\pi}} \\ \frac{-\sqrt{2\pi}}{(k-2)!E_{11}(x_0)^2} & 0 \end{pmatrix}. \quad (5.14)$$

The quantity $E_{11}(x_0)$ can be computed explicitly using (5.9):

$$E_{11}(x_0) = \frac{|1-ax_0|^{\frac{\epsilon}{2}}}{|x_0|^{\frac{k-1}{2}} \varphi_0''(x_0)^{\frac{k-1}{2}}} > 0.$$

5.7 Ratio asymptotics and proof of Theorem 1.1

Proposition 5.1 (Ratio asymptotics for a near-maximal removed corner). *For any fixed $\delta, M > 0$, we have*

$$\begin{aligned} \log F_N^{m,k+1}(a; \epsilon) - \log F_N^{m,k}(a; \epsilon) &= N\varphi_0(x_0) - \left(k - \frac{1}{2}\right) \log N + \log((k-1)!) \\ &\quad - \left(k - \frac{1}{2}\right) \log(|x_0|^2 \varphi_0''(x_0)) + \epsilon \log(1-ax_0) - \frac{1}{2} \log(2\pi) + \mathcal{O}(N^{-1/2}), \end{aligned} \quad (5.15)$$

uniformly for $k \in \{1, \dots, M\}$ and for $\delta \leq \mu \leq 1 - \delta$.

Proof. By (5.2), (5.5), (5.6), (5.12), we have

$$Y_{22}(0) = T_{12}(0) = e^{N\varphi_0(x_0)} S_{12}(0) = e^{N\varphi_0(x_0)} N^{-k+1} |x_0|^{-k+1} R_{12}(0).$$

Using the large N asymptotics (5.13) of R , we obtain

$$\log Y_{22}(0) = N\varphi_0(x_0) - \left(k - \frac{1}{2}\right) \log N + \log \frac{R_{12}^{(1)}(0)}{|x_0|^{k-1}} + \mathcal{O}(N^{-1/2}).$$

Substituting (5.14) in the above expansion and using (2.4), we obtain the claim. \square

Let $K > 0$ be any fixed number. Summing (5.15) with k running from 1 to K yields

$$\begin{aligned} \log \frac{F_N^{m,K+1}(a; \epsilon)}{F_N^{m,1}(a; \epsilon)} &= KN\varphi_0(x_0) - \frac{K}{2} \log N + \log G(K+1) - \frac{K^2}{2} \log(|x_0|^2 \varphi_0''(x_0)) \\ &\quad + K\epsilon \log(1 - ax_0) - \frac{K}{2} \log(2\pi) + \mathcal{O}(N^{-1/2}) \end{aligned} \quad (5.16)$$

as $N \rightarrow +\infty$. By (1.3),

$$\log F_N^{m,1}(a; \epsilon) = \left(\frac{N^2}{2} + \left(\frac{1}{2} - m \right) N + m^2 - \epsilon m \right) \log(1 + a^2). \quad (5.17)$$

Summing (5.16) and (5.17) and using $m = \mu N$, we obtain

$$\log F_N^{m,K+1}(a; \epsilon) = F_2(\mu)N^2 + F_1(K, \mu)N - \frac{K^2}{2} \log N + F_0(K, \mu) + \mathcal{O}(N^{-1/2})$$

as $N \rightarrow +\infty$, where F_2, F_1, F_0 are given by (1.9)–(1.11). This proves Theorem 1.1.

6 Large removed corner

In this section, $\mu = m/N \in (0, 1)$, and $\kappa = k/N \in (0, \kappa_2)$. We observe from (1.7) that $\kappa_2 < \mu$ for $\mu \in (0, 1) \setminus \{\frac{a^2}{1+a^2}\}$.

6.1 Construction and analysis of the g -function

Here, we cannot simply deform the jump contours Σ_0, Σ_1 to arrive at a small-norm RH problem. Instead, we need to construct a g -function, with a branch cut on a curve \mathcal{S} connecting two points z_0, \bar{z}_0 , depending on μ, κ and to be determined later. It has to satisfy the following properties.

RH problem for g

- (a) $g : \mathbb{C} \setminus \mathcal{S} \rightarrow \mathbb{C}$ is analytic.
- (b) There exists a constant $\ell \in \mathbb{C}$ such that

$$g_+(z) + g_-(z) + \ell = \phi(z; \kappa), \quad z \in \mathcal{S}. \quad (6.1)$$

- (c) $g(z) = g_1 z^{-1} + \mathcal{O}(z^{-2})$ as $z \rightarrow \infty$, for some $g_1 \in \mathbb{C}$.

Recall the definition of ϕ from (2.6). Since ϕ contains logarithmic terms, it is convenient to first solve the RH problem for g' and afterwards construct g by integrating. The derivative of g needs to satisfy the following properties.

RH problem for g'

- (a) $g' : \mathbb{C} \setminus \mathcal{S} \rightarrow \mathbb{C}$ is analytic.
- (b) $g'_+(z) + g'_-(z) = \phi'(z; \kappa)$ for $z \in \mathcal{S}$.
- (c) $g'(z) = -g_1 z^{-2} + \mathcal{O}(z^{-3})$ as $z \rightarrow \infty$, for some $g_1 \in \mathbb{C}$.

Note that g depends on μ, κ , although this is not visible in our notation. Let $\mathcal{R}(z) = ((z - z_0)(z - \bar{z}_0))^{1/2}$, where the branch cut is on \mathcal{S} and such that $\mathcal{R}(z) > 0$ for $z \in (\Re z_0, +\infty)$. Then

$$\frac{g'_+(z)}{\mathcal{R}_+(z)} - \frac{g'_-(z)}{\mathcal{R}_-(z)} = \frac{\phi'(z; \kappa)}{\mathcal{R}_+(z)}, \quad z \in \mathcal{S}.$$

We can construct g' in such a way that $\frac{g'(z)}{\mathcal{R}(z)} = \mathcal{O}(1)$ as $z \rightarrow z_0$ and as $z \rightarrow \bar{z}_0$, by setting

$$g'(z) = \frac{\mathcal{R}(z)}{2\pi i} \int_{\bar{z}_0}^{z_0} \frac{\phi'(s; \kappa)}{\mathcal{R}_+(s)} \frac{ds}{s - z}, \quad z \in \mathbb{C} \setminus \mathcal{S}.$$

We make the ansatz that \mathcal{S} crosses the real axis between 0 and $\frac{1}{a}$. With this choice, we have

$$\mathcal{R}(1/a) = |z_0 - 1/a| > 0, \quad \mathcal{R}(-a) = -|z_0 + a| < 0, \quad \mathcal{R}(0) = -|z_0| < 0.$$

We can compute g' explicitly in terms of z_0 using residue calculus and obtain

$$\begin{aligned} g'(z) &= \mathcal{R}(z) \left((\kappa - \mu) \frac{\frac{1}{\mathcal{R}(0)} - \frac{1}{\mathcal{R}(z)}}{2(0 - z)} + (1 - \mu) \frac{\frac{1}{\mathcal{R}(\frac{1}{a})} - \frac{1}{\mathcal{R}(z)}}{2(\frac{1}{a} - z)} + \mu \frac{\frac{1}{\mathcal{R}(-a)} - \frac{1}{\mathcal{R}(z)}}{2(-a - z)} \right) \\ &= \frac{\phi'(z; \kappa)}{2} - \frac{\mathcal{R}(z)}{2} \left(\frac{\mu - \kappa}{|z_0|z} + \frac{1 - \mu}{|z_0 - \frac{1}{a}|(z - \frac{1}{a})} - \frac{\mu}{|z_0 + a|(z + a)} \right). \end{aligned} \quad (6.2)$$

We must choose z_0 such that $g'(z) = \mathcal{O}(z^{-2})$ as $z \rightarrow \infty$, i.e. z_0 must be such that

$$\begin{cases} \frac{1 - \mu}{|z_0 - \frac{1}{a}|} + \frac{\mu - \kappa}{|z_0|} - \frac{\mu}{|z_0 + a|} = 0, \\ \kappa + 1 - \mu - \frac{a\mu}{|z_0 + a|} - \frac{1 - \mu}{a|z_0 - \frac{1}{a}|} = 0. \end{cases} \quad (6.3)$$

Existence and uniqueness of z_0 . The equations in (6.3) can be rewritten as

$$\begin{cases} |z_0 + a| = \frac{(1 + a^2)\mu}{(a + \gamma)(\kappa + 1 - \mu)}, \\ |z_0 - 1/a| = \frac{(1 + a^2)(1 - \mu)}{a(1 - a\gamma)(\kappa + 1 - \mu)}, \end{cases} \quad (6.4)$$

where

$$\gamma := \frac{\mu - \kappa}{1 - \mu + \kappa} \frac{1}{|z_0|}. \quad (6.5)$$

This parametrization in terms of γ turns out to be convenient. Given $\gamma > 0$, the equations in (6.4) describe the intersection of two circles with center on the real line, and thus uniquely fix the value of $z_0 \in \mathbb{C}$ with $\Im z_0 \geq 0$, provided that

$$|z_0 + a| + |z_0 - \frac{1}{a}| \geq a + \frac{1}{a}, \quad (|z_0 + a| - |z_0 - \frac{1}{a}|)^2 \leq (a + \frac{1}{a})^2. \quad (6.6)$$

For $0 < \kappa < \kappa_2 \leq \mu < 1$, the next lemma shows that both inequalities hold strictly and simultaneously if and only if $\gamma \in (0, \frac{1}{a})$.

Lemma 6.1. *Let $\mu \in (0, 1)$, and suppose that $z_0 \in \mathbb{C}$ satisfies the two equations in (6.4) for some $\gamma \in (0, \frac{1}{a})$. Then*

$$|z_0 + a| + |z_0 - \frac{1}{a}| > a + \frac{1}{a}, \quad \text{for all } \kappa \in (0, \kappa_2), \quad (6.7)$$

$$(a + \frac{1}{a})^2 > (|z_0 + a| - |z_0 - \frac{1}{a}|)^2, \quad \text{for all } \kappa \in (0, \kappa_2). \quad (6.8)$$

Moreover, (6.7) does not hold if $\gamma \notin (0, \frac{1}{a})$.

Proof. By (6.4),

$$|z_0 + a| + |z_0 - \frac{1}{a}| - (a + \frac{1}{a}) = \frac{(1 + a^2)p_1(\gamma)}{a(a + \gamma)(1 - a\gamma)(1 - \mu + \kappa)}, \quad (6.9)$$

where

$$p_1(\gamma) = a(1 + \kappa - \mu)\gamma^2 + (a^2(1 + \kappa - 2\mu) - \kappa)\gamma + a(\mu - \kappa).$$

The discriminant of p_1 is < 0 for $\kappa \in (0, \kappa_2)$. Hence $p_1(\gamma) > 0$ for all $\gamma \in \mathbb{R}$ and $\kappa \in (0, \kappa_2)$, and therefore (6.7) holds if and only if $\gamma \in (0, \frac{1}{a})$. Similarly, using the equations in (6.4), we obtain

$$(a + \frac{1}{a})^2 - (|z_0 + a| - |z_0 - \frac{1}{a}|)^2 = \frac{(1 + a^2)^2 p_2(\gamma) p_3(\gamma)}{a^2(a + \gamma)^2(1 - a\gamma)^2(1 + \kappa - \mu)^2},$$

where

$$p_2(\gamma) = a(1 + \kappa - \mu)\gamma^2 + (a^2(1 + \kappa) - \kappa)\gamma - a(\kappa + \mu),$$

$$p_3(\gamma) = a(1 + \kappa - \mu)\gamma^2 + (a^2(1 + \kappa - 2\mu) + 2\mu - 2 - \kappa)\gamma - a(2 + \kappa - 3\mu).$$

A direct computation shows that the discriminants of p_2 and p_3 are negative for any $\kappa \in \mathbb{R}$. Thus $p_2(\gamma) > 0$ and $p_3(\gamma) > 0$ for all $\gamma \in \mathbb{R}$ and $\kappa \in \mathbb{R}$, and (6.8) follows. \square

To finish our proof that z_0 is uniquely determined by the condition $\Im z_0 \geq 0$ and (6.4), it remains to prove that there exists a unique $\gamma \in (0, \frac{1}{a})$ which is compatible with (6.4) and (6.5). To show this, we apply the law of cosines to the triangles $(-a, 0, z_0)$ and $(0, \frac{1}{a}, z_0)$, and obtain

$$\begin{cases} |z_0 - \frac{1}{a}|^2 = |z_0|^2 + \frac{1}{a^2} - \frac{2}{a}\Re z_0, \\ |z_0 + a|^2 = |z_0|^2 + a^2 + 2a\Re z_0. \end{cases}$$

Using the first equality to eliminate $\Re z_0$ from the second, we find

$$(1 + a^2)(1 + |z_0|^2) = a^2|z_0 - 1/a|^2 + |z_0 + a|^2.$$

Substituting the expressions for $|z_0|$, $|z_0 + a|$, $|z_0 - 1/a|$ from (6.4)–(6.5) in terms of γ , we obtain the following equation for γ ,

$$\frac{(1 + a^2)(1 - \mu)^2}{(1 - a\gamma)^2} + \frac{(1 + a^2)\mu^2}{(a + \gamma)^2} - \frac{(\mu - \kappa)^2}{\gamma^2} = (\kappa + 1 - \mu)^2. \quad (6.10)$$

Since $0 < \kappa < \kappa_2 \leq \mu < 1$, we have $\mu - \kappa \in (0, 1)$. Hence, the left hand side of (6.10) is 0 at $\gamma = \pm\infty$, $-\infty$ at $\gamma = 0$ and $+\infty$ at $\gamma = -a$ and $\gamma = 1/a$, and therefore this equation has at least one solution $\gamma_1 < -a$, one solution $-a < \gamma_2 < 0$, one solution $0 < \gamma_3 < 1/a$, and one solution $\gamma_4 > 1/a$. We can also rewrite (6.10) as a polynomial equation $p(\gamma)q(\gamma) = 0$, with

$$p(\gamma) = a\gamma^4(\kappa + 1 - \mu) + \gamma^3(a^2\kappa + a^2 - \kappa + 2\mu - 2) - 3a\gamma^2 + \gamma(a^2(\kappa - 1) + (2\mu - \kappa)) + a(\mu - \kappa), \quad (6.11)$$

$$q(\gamma) = a(\kappa + 1 - \mu)\gamma^2 + (a^2(\kappa - 2\mu + 1) - \kappa)\gamma + a(\mu - \kappa).$$

The discriminant of the quadratic equation $q(\gamma) = 0$ is negative for $\kappa_1 < \kappa < \kappa_2$, such that $\gamma_1, \gamma_2, \gamma_3, \gamma_4$ are the (only) roots of the degree 4 polynomial p . If $\kappa_1 > 0$ and $\kappa \in (0, \kappa_1)$, then q has two distinct roots, which can be computed explicitly, and both are bigger than $\frac{1}{a}$. For $\kappa = \kappa_1 > 0$, q has a double root, which coincides with the root of p lying on $(\frac{1}{a}, +\infty)$.

We conclude that there is a unique $\gamma \in (0, \frac{1}{a})$ which is compatible with (6.4) and (6.5).

We obtain the following result.

Proposition 6.2. *Let $\mu \in (0, 1)$ and $\kappa \in (0, \kappa_2)$. There exists a unique $z_0 = z_0(\kappa) \in \mathbb{C}$ with $\Im z_0 > 0$, smooth in $\mu \in (0, 1)$ and $\kappa \in (0, \kappa_2)$, such that (6.3) holds. We have the expansions*

$$\begin{aligned} z_0 &= \tilde{z}_0^{(0)} + i\tilde{z}_0^{(1/2)}\sqrt{\kappa_2 - \kappa} + \tilde{z}_0^{(1)}(\kappa_2 - \kappa) + i\tilde{z}_0^{(3/2)}(\kappa_2 - \kappa)^{3/2} \\ &\quad + \tilde{z}_0^{(2)}(\kappa_2 - \kappa)^2 + \mathcal{O}((\kappa_2 - \kappa)^{5/2}), \end{aligned} \quad \text{as } \kappa \rightarrow \kappa_2, \quad (6.12)$$

for some $\tilde{z}_0^{(0)}, \tilde{z}_0^{(1/2)}, \tilde{z}_0^{(1)}, \tilde{z}_0^{(3/2)}, \tilde{z}_0^{(2)} \in \mathbb{R}$, and

$$z_0 = z_0^{(0)} + iz_0^{(1/2)}\sqrt{\kappa} + z_0^{(1)}\kappa + iz_0^{(3/2)}\kappa^{3/2} + z_0^{(2)}\kappa^2 + \mathcal{O}(\kappa^{5/2}), \quad \text{as } \kappa \rightarrow 0, \quad (6.13)$$

for some $z_0^{(0)}, z_0^{(1/2)}, z_0^{(1)}, z_0^{(3/2)}, z_0^{(2)} \in \mathbb{R}$. Both (6.12) and (6.13) hold uniformly for $\mu \in [\delta, 1 - \delta]$ for any fixed $\delta > 0$. The coefficients of the leading terms are given by

$$\begin{aligned} \tilde{z}_0^{(0)} &= \frac{a - (1 + a^2)\sqrt{\mu(1 - \mu)}}{(1 + a^2)\mu - 1} \in (-a, \frac{1}{a}), & z_0^{(0)} &= \frac{-a - \sqrt{a^2 + 4\mu(1 - \mu)}}{2(1 - \mu)} \in (-\infty, -a), \\ \tilde{z}_0^{(1/2)} &= \frac{\sqrt{2}(1 + a^2)^{3/2}((1 - \mu)\mu)^{1/4}}{\sqrt{a}(1 - (1 - a^2)\mu + 2a\sqrt{(1 - \mu)\mu})}, \end{aligned}$$

and moreover $z_0^{(1/2)} > 0$.

Remark 6.3. All constants appearing in (6.12) and (6.13) can be computed explicitly. However, since these expressions are rather lengthy, we omit them.

Remark 6.4. If $\mu - \kappa_2 \geq \delta$ for some fixed $\delta > 0$, then $\tilde{z}_0^{(0)}$ remains bounded away from 0. Thus, by (6.12),

$$z_0 = \tilde{z}_0^{(0)}(1 + \mathcal{O}(\sqrt{\kappa_2 - \kappa})), \quad \text{as } \kappa \rightarrow \kappa_2, \quad (6.14)$$

uniformly for $\mu \in [\delta, 1 - \delta]$ with $\mu - \kappa_2 \geq \delta$.

Proof. The existence and uniqueness of z_0 follows from the discussion above. The smoothness directly follows from (6.3). The expansions (6.12) and (6.13) require a technical and involved analysis, which we omit; in particular, we first need to show that $z_0(\kappa, \mu) - \tilde{z}_0^{(0)}$ and $z_0(\kappa, \mu) - z_0^{(0)}$ are small as $\kappa \rightarrow \kappa_2$ and as $\kappa \rightarrow 0$, respectively; the coefficients in the expansions can then be obtained recursively using a long but straightforward computation. \square

Remark 6.5. The expansions (6.12) and (6.14) imply that

$$|z_0| = \tilde{z}_0^{(0)} + \left(\frac{(\tilde{z}_0^{(1/2)})^2}{2\tilde{z}_0^{(0)}} + \tilde{z}_0^{(1)} \right) (\kappa_2 - \kappa) + \mathcal{O}((\kappa_2 - \kappa)^2), \quad \text{as } \kappa \rightarrow \kappa_2$$

uniformly for $\mu \in [\delta, 1 - \delta]$ and $\mu - \kappa_2 \geq \delta$ for any fixed $\delta > 0$. Using the fact that $\gamma(\kappa_2) = z_0(\kappa_2) = \tilde{z}_0^{(0)}$, we then obtain

$$\gamma = \frac{\mu - \kappa}{(1 - \mu + \kappa)|z_0|} = \tilde{z}_0^{(0)} + C_2(\kappa_2 - \kappa) + \mathcal{O}((\kappa_2 - \kappa)^2), \quad \text{as } \kappa \rightarrow \kappa_2, \quad (6.15)$$

for some $C_2 \neq 0$ uniformly for $\mu \in [\delta, 1 - \delta]$ and $\mu - \kappa_2 \geq \delta$. We will use this later on.

Construction of the g -function Integrating (6.2) from ∞ to $z \in \mathbb{C} \setminus (\mathcal{S} \cup [\overline{z_0}, \overline{z_0} - i\infty))$ yields

$$g(z) = \int_{\infty}^z g'(s) ds, \quad z \in \mathbb{C} \setminus (\mathcal{S} \cup [\overline{z_0}, \overline{z_0} - i\infty)).$$

A residue computation, which uses (6.3), then shows that g can be analytically continued across $(\overline{z_0}, \overline{z_0} - i\infty)$, as desired.

We define, with the constant $\ell \in \mathbb{C}$ as in the RH conditions for g ,

$$\xi(z) = g(z) - \frac{1}{2}\phi(z; \kappa) + \frac{\ell}{2}, \quad z \in \mathbb{C} \setminus (\mathcal{S} \cup (-\infty, 0] \cup [\frac{1}{a}, +\infty)). \quad (6.16)$$

By (6.2), we have

$$\xi'(z) = -\frac{\mathcal{R}(z)}{2} \left(\frac{\mu - \kappa}{|z_0|z} + \frac{1 - \mu}{|z_0 - \frac{1}{a}|(z - \frac{1}{a})} - \frac{\mu}{|z_0 + a|(z + a)} \right) \quad (6.17)$$

We can rewrite this as

$$\xi'(z) = -Q(z)\mathcal{R}(z), \quad Q(z) = \frac{\kappa + 1 - \mu}{2} \frac{z - \gamma}{z(z + a)(z - 1/a)}, \quad (6.18)$$

where γ is given by (6.5). As $z \rightarrow -a, 0, 1/a$, we have that $g'(z)$ is bounded, such that $\xi'(z) \sim -\frac{1}{2}\phi'(z)$. Moreover, by (6.17), $\xi'(x)/\mathcal{R}(x)$ increases from $-\infty$ to $+\infty$ as $x \in (0, \frac{1}{a})$ increases, so we must have $\gamma \in (0, 1/a)$, which is consistent with the discussion surrounding (6.9).

By (6.18), we have

$$\xi'(z)^2 = \frac{(\kappa + 1 - \mu)^2}{4} \frac{(z - \gamma)^2(z - z_0)(z - \overline{z_0})}{z^2(z + a)^2(z - 1/a)^2}. \quad (6.19)$$

In a similar way as in Section 3, we now analyze the vertical trajectories of the quadratic differential

$$\frac{(z - \gamma)^2(z - z_0)(z - \overline{z_0})}{z^2(z + a)^2(z - 1/a)^2} dz^2,$$

in terms of the parameters $\gamma \in (0, 1/a)$ and z_0 with $\Im z_0 > 0$, i.e. the curves on which

$$\Re \left(\frac{(z - \gamma)\mathcal{R}(z)}{z(z + a)(z - 1/a)} dz \right) = 0.$$

Instead of a quadratic differential with two double zeros, we now have a quadratic differential with one double zero γ and two simple zeros $z_0, \overline{z_0}$. Note that the trajectories are independent of the choice of the branch cut \mathcal{S} for \mathcal{R} . Since $\xi_+ + \xi_- = 0$ on \mathcal{S} , we have $\xi(z_0) = \xi(\overline{z_0}) = 0$, and thus we can write

$$\xi(z) = \int_{z_0}^z \xi'(z) dz, \quad z \in \mathbb{C} \setminus (\mathcal{S} \cup (-\infty, 0] \cup [\frac{1}{a}, +\infty)), \quad (6.20)$$

where the path of integration does not cross $\mathcal{S} \cup (-\infty, 0] \cup [\frac{1}{a}, +\infty)$. Note that for any $h \in \mathbb{R}$, the level set

$$\mathcal{T}_h := \{z \in \mathbb{C} : \Re \xi(z) = h\}$$

depends on the choice of the branch cut. (However, for $h = 0$, the connected component of \mathcal{T}_0 containing z_0 is independent of the branch cut, since $\xi_+ = -\xi_-$ on \mathcal{S} .) It is therefore important to

specify \mathcal{S} . We will define it in terms of a horizontal trajectory. For this, first recall that the *horizontal* trajectories of $\xi'(z)^2 dz^2$ are the curves on which

$$\Im \left(\frac{(z - \gamma)\mathcal{R}(z)}{z(z + a)(z - 1/a)} dz \right) = 0.$$

Since $\xi'(x) \in \mathbb{R}$ for $x \in \mathbb{R} \setminus \{-a, 0, \frac{1}{a}\}$, $\Im \xi$ is piecewise constant on \mathbb{R} . In particular, the two horizontal trajectories of $\xi'(z)^2 dz^2$ emanating from any $x \in \mathbb{R} \setminus \{-a, 0, \gamma, \frac{1}{a}\}$ must follow the real line. Since γ is a simple zero of ξ' , there are four horizontal trajectories emanating from γ , two of which are subsets of \mathbb{R} , and the other two make angles $\pm \frac{\pi}{2}$ with \mathbb{R} . Let $\Gamma_{h,+}$ and $\Gamma_{h,-}$ be the trajectories going into the upper and lower half-plane, respectively. By the above discussion, $\Gamma_{h,+}$ cannot intersect $\mathbb{R} \setminus \{-a, 0, \frac{1}{a}\}$. Moreover, for any $0 \leq \alpha_1 \leq \alpha_2 \leq \pi$, we easily check that as $\epsilon \rightarrow 0_+$,

$$\begin{aligned} \xi(-a + e^{\alpha_1 i} \epsilon) - \xi(-a + e^{\alpha_2 i} \epsilon) &= \frac{\mu(\alpha_2 - \alpha_1)i}{4}(1 + o(1)), \\ \xi(e^{\alpha_1 i} \epsilon) - \xi(e^{\alpha_2 i} \epsilon) &= \frac{(\kappa - \mu)(\alpha_2 - \alpha_1)i}{4}(1 + o(1)), \\ \xi(\frac{1}{a} + e^{\alpha_1 i} \epsilon) - \xi(\frac{1}{a} + e^{\alpha_2 i} \epsilon) &= \frac{(1 - \mu)(\alpha_2 - \alpha_1)i}{4}(1 + o(1)). \end{aligned} \quad (6.21)$$

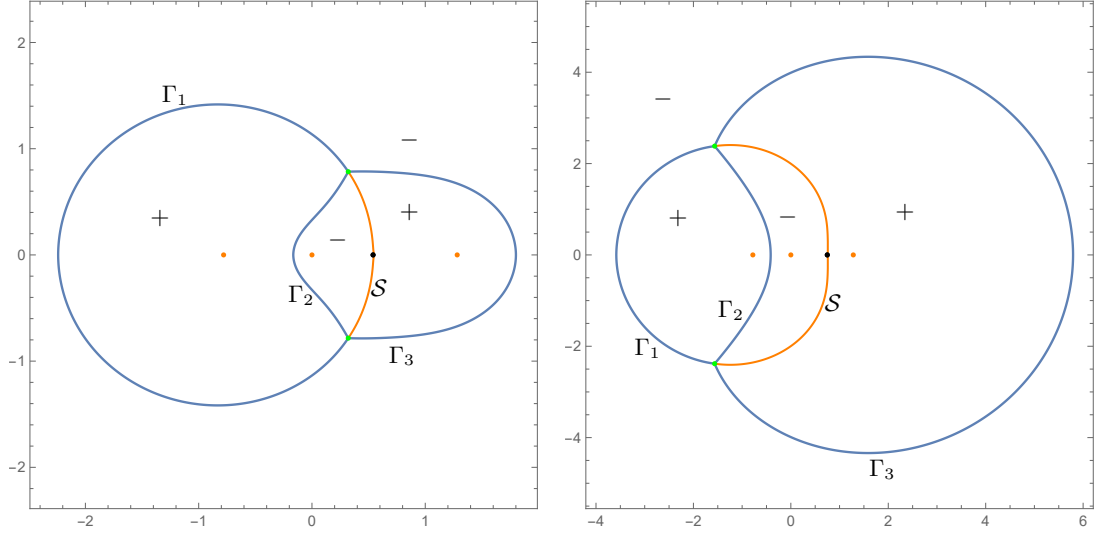


Figure 12: In each image, the blue curves are $\Gamma_1, \Gamma_2, \Gamma_3$, and the orange curve is \mathcal{S} . Together, these curves delimit four regions in the complex plane, with the sign of $\Re \xi$ in each region indicated by \pm . The orange dots are $-a$, 0 and $\frac{1}{a}$; the black dot is γ ; and the green dots are z_0 and \bar{z}_0 . The figures are drawn for $a = 0.78$, $\mu = 0.76$, and with $\kappa = 0.44$ (left) and $\kappa = 0.08$ (right).

Equations (6.21) with $\alpha_1 = 0$ and $\alpha_2 = \pi$ show that for $0 < \kappa < \kappa_2 \leq \mu < 1$, $\Im \xi_+$ assumes four distinct values on the four connected components of $\mathbb{R} \setminus \{-a, 0, \frac{1}{a}\}$. Equations (6.21) also imply that $\Gamma_{h,+}$ cannot intersect $\{-a, 0, \frac{1}{a}\}$. Hence $\Gamma_{h,+}$ must connect with z_0 . (By (6.20), this also shows that $\Im \xi = 0$ on $(0, \frac{1}{a})$.) Since $\xi(z) = \overline{\xi(\bar{z})}$ holds for all $z \in \mathbb{C}$, we have $\Gamma_{h,-} = \overline{\Gamma_{h,+}}$. We define $\mathcal{S} := \Gamma_{h,+} \cup \Gamma_{h,-}$ with the orientation going from \bar{z}_0 to z_0 , see also the orange curves in Figure 12. The next result establishes the structure of \mathcal{T}_0 .

Proposition 6.6. *Let $\mu \in (0, 1)$ and $\kappa \in (0, \kappa_2)$. Then the level set \mathcal{T}_0 satisfies*

$$\mathcal{T}_0 = \Gamma_1 \sqcup \Gamma_2 \sqcup \Gamma_3 \sqcup \{z_0, \bar{z}_0\},$$

where the contours $\Gamma_1, \Gamma_2, \Gamma_3$ are disjoint, have no self-intersections, and

- Γ_1 connects z_0 with \bar{z}_0 and crosses the real line at a point smaller than $-a$;
- Γ_2 connects z_0 with \bar{z}_0 and crosses the real line at a point between $-a$ and 0 ;
- Γ_3 connects z_0 with \bar{z}_0 and crosses the real line at a point bigger than $1/a$.

Moreover,

- $\Re \xi > 0$ in the region delimited by Γ_1 and Γ_2 , and in the region delimited by \mathcal{S} and Γ_3 ;
- $\Re \xi < 0$ in the region delimited by Γ_2 and \mathcal{S} , and in the outer region.

Proof. Since $\xi'(z)$ vanishes as a square root at z_0 , there are three vertical trajectories emanating at z_0 , which we denote by $\Gamma_1, \Gamma_2, \Gamma_3$. By the max/min principle for harmonic functions, the curves $\Gamma_1, \Gamma_2, \Gamma_3$ cannot form a closed loop in the upper-half plane. They also cannot connect with infinity, since $\Re \xi(\infty) = -\infty$. So they must intersect $\mathbb{R} \setminus \{-a, 0, \frac{1}{a}\}$ at three distinct points. Since $\xi(z) = \overline{\xi(\bar{z})}$ holds for all $z \in \mathbb{C}$, the branches must obey the symmetries $\Gamma_j = \overline{\Gamma_j}$, $j = 1, 2, 3$, and therefore they must connect z_0 with \bar{z}_0 .

By inspection of the sign of $\Re \xi'(x)$ for x on the real line, we also see that the level set \mathcal{T}_0 must contain exactly one point $x_1 < -a$, exactly one point $-a < x_2 < 0$ and exactly one point $x_3 > 1/a$. In addition, since $\Re \xi'(x) > 0$ for all $x \in (0, \frac{1}{a}) \setminus \{\gamma\}$ and $\Re \xi$ is possibly discontinuous at $x = \gamma$, there

must be 0, 1 or 2 points of the level set between 0 and $1/a$ (if there are two points, one must be on $(0, \gamma)$ and the other one must be on $(\gamma, \frac{1}{a})$). In fact there cannot be 1 point, otherwise we again find a contradiction using the max/min principle for harmonic functions. There also cannot be 2 points. To see this, note that $\text{Im } \xi$ is constant along \mathcal{S} . Since z_0 is the only critical point of $\xi'(z)^2 dz^2$ in the upper half-plane \mathbb{C}^+ , $\Re \xi_{\pm}$ must be monotone on $\mathcal{S} \cap \mathbb{C}^+$. This, together with a local analysis of ξ' around z_0 , implies that $\Re \xi_+(z)$ (resp. $\Re \xi_-$) is decreasing (resp. increasing) as z follows \mathcal{S} from z_0 to γ . In particular,

$$\Re \xi(\gamma - 0_+) < 0, \quad \Re \xi(\gamma + 0_+) > 0,$$

and therefore $\Gamma_1, \Gamma_2, \Gamma_3$ cannot intersect $(0, \frac{1}{a})$. By construction, the curves $\Gamma_1, \Gamma_2, \Gamma_3$ and \mathcal{S} divide \mathbb{C} into four regions where the sign of $\Re \xi$ remains constant. These signs can be determined from

$$\Re \xi(-a) = +\infty, \quad \Re \xi(0) = -\infty, \quad \Re \xi(\frac{1}{a}) = +\infty, \quad \Re \xi(\infty) = -\infty.$$

□

The following is a direct corollary of Proposition 6.6.

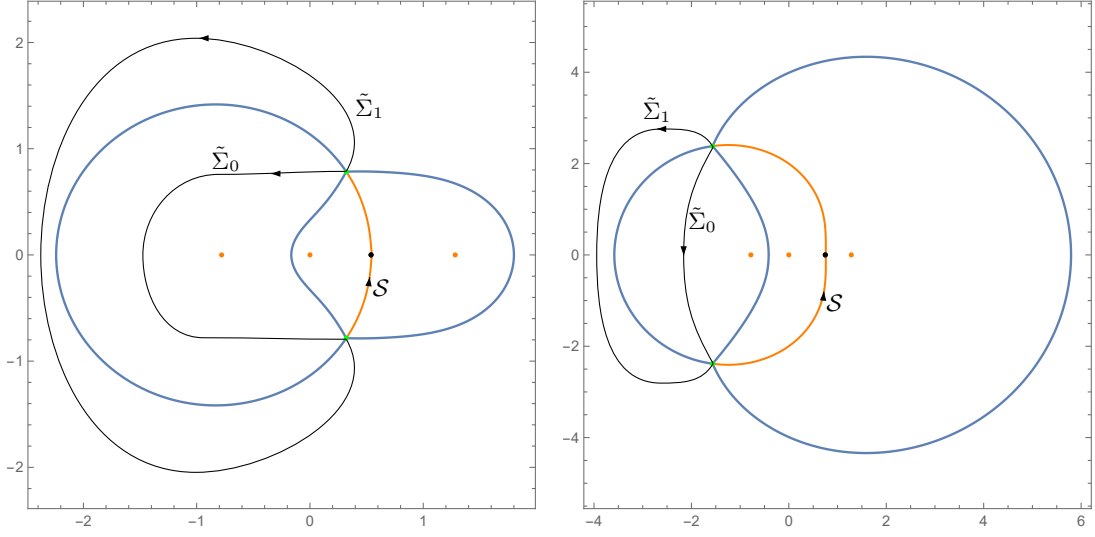


Figure 13: In each image, the black curves are $\tilde{\Sigma}_0, \tilde{\Sigma}_1$, the blue curves are \mathcal{T}_0 , and the orange curve is \mathcal{S} . The orange dots are $-a, 0$ and $\frac{1}{a}$; the black dot is γ ; and the green dots are z_0 and \bar{z}_0 . The figures are drawn for $a = 0.78$, $\mu = 0.76$, and with $\kappa = 0.44$ (left) and $\kappa = 0.08$ (right).

Corollary 6.7. *Let $\mu \in (0, 1)$ and $\kappa \in (0, \kappa_2)$. For any $\delta > 0$, there exist $c, \eta > 0$ and a contour $\Sigma_T = \tilde{\Sigma}_0 \cup \tilde{\Sigma}_1 \cup \mathcal{S} \cup \{z_0, \bar{z}_0\}$ as shown in Figure 13, such that the following holds for $z \in \Sigma_T$:*

$$\begin{aligned} \Re \xi(z; \kappa) &< -c, & z \in \tilde{\Sigma}_1, \quad |z - z_0| \geq \eta, \quad |z - \bar{z}_0| \geq \eta, \\ \Re \xi(z; \kappa) &> c, & z \in \tilde{\Sigma}_0, \quad |z - z_0| \geq \eta, \quad |z - \bar{z}_0| \geq \eta, \\ \Re \xi_+(z; \kappa) &< -c, & z \in \mathcal{S}, \quad |z - z_0| \geq \eta, \quad |z - \bar{z}_0| \geq \eta, \end{aligned}$$

uniformly for $\kappa \in [\delta, \kappa_2 - \delta]$ and $\mu \in [\delta, 1 - \delta]$.

We can compute g and ℓ explicitly in terms of z_0 as follows. Integrating (6.2) from ∞ to $z \in \mathbb{C} \setminus \mathcal{S}$, we find

$$\begin{aligned}
g(z) &= \int_{\infty}^z g'(s) ds \\
&= \frac{\kappa - \mu}{2|z_0|} \left\{ -(\Re z_0) \log \left(\frac{z + \mathcal{R}(z) - \Re z_0}{i \Im z_0} \right) + |z_0| \log \left(\frac{(\Re z_0)z - |z_0|^2 + |z_0| \mathcal{R}(z)}{i \Im z_0} \right) \right\} - \frac{1 - \mu}{2|\frac{1}{a} - z_0|} \left\{ \right. \\
&\quad \left. \left(\frac{1}{a} - \Re z_0 \right) \log \left(\frac{z + \mathcal{R}(z) - \Re z_0}{i \Im z_0} \right) - \left| \frac{1}{a} - z_0 \right| \log \left(\frac{(\frac{1}{a} - \Re z_0)z - \frac{\Re z_0}{a} + |z_0|^2 + |\frac{1}{a} - z_0| \mathcal{R}(z)}{i \frac{1}{a} \Im z_0} \right) \right\} \\
&\quad + \frac{\mu}{2|a + z_0|} \left\{ - (a + \Re z_0) \log \left(\frac{z + \mathcal{R}(z) - \Re z_0}{i \Im z_0} \right) \right. \\
&\quad \left. + |a + z_0| \log \left(\frac{(a + \Re z_0)z - a \Re z_0 - |z_0|^2 + |a + z_0| \mathcal{R}(z)}{i \Im z_0} \right) \right\} - \frac{\ell}{2}, \tag{6.22}
\end{aligned}$$

where

$$\begin{aligned}
\ell &= (1 - \mu) \log a - (\kappa + 1 - \mu) \log 2 + (1 - \mu) \log \left(\frac{1}{a} - \Re z_0 + \left| \frac{1}{a} - z_0 \right| \right) \\
&\quad + (\kappa - \mu) \log (\Re z_0 + |z_0|) + \mu \log (a + \Re z_0 + |a + z_0|). \tag{6.23}
\end{aligned}$$

In (6.22) and (6.23), the principal branch is used for the logarithms. Note that the first line of equation (6.22) defines a single-valued function, because the integral of g' along any closed loop surrounding \mathcal{S} is 0.

6.2 First transformation: $Y \mapsto T$

Our first transformation consists in deforming the contours: according to the results obtained in Corollary 6.7, we deform Σ_0, Σ_1 in such a way that they coincide along \mathcal{S} , and we denote $\tilde{\Sigma}_0, \tilde{\Sigma}_1$ for the parts of these deformed contours away from \mathcal{S} , as shown in Figure 13. We construct the solution of the resulting RH problem by analytically continuing the RH solution Y from the region inside Σ_0 and from the region outside Σ_1 respectively. As a result of the fact that the two jump contours coincide on \mathcal{S} , the jump matrix for T on \mathcal{S} is the product of the jump matrices for Y on Σ_1 and on Σ_0 . We obtain the following RH problem.

RH problem for T

- (a) $T : \mathbb{C} \setminus \Sigma_T \rightarrow \mathbb{C}^{2 \times 2}$ is analytic, with

$$\Sigma_T = (\tilde{\Sigma}_0 \cup \tilde{\Sigma}_1 \cup \mathcal{S}) \cup \{z_0, \overline{z_0}\}.$$

- (b) $T_+(z) = T_-(z)J_{\hat{Y}}(z)$ for $z \in \tilde{\Sigma}_0 \cup \tilde{\Sigma}_1 \cup \mathcal{S}$, with

$$J_T(z) = \begin{cases} \begin{pmatrix} 1 & e^{-N\phi(z)\frac{z}{(1-az)^\epsilon}} \\ 0 & 1 \end{pmatrix}, & z \in \tilde{\Sigma}_1, \\ \begin{pmatrix} 1 & 0 \\ -e^{N\phi(z)\frac{(1-az)^\epsilon}{z}} & 1 \end{pmatrix}, & z \in \tilde{\Sigma}_0, \\ \begin{pmatrix} 0 & e^{-N\phi(z)\frac{z}{(1-az)^\epsilon}} \\ -e^{N\phi(z)\frac{(1-az)^\epsilon}{z}} & 1 \end{pmatrix}, & z \in \mathcal{S}. \end{cases} \quad (6.24)$$

- (c) As $z \rightarrow \infty$, $T(z) = I + \mathcal{O}(z^{-1})$.

As $z \rightarrow z_0$ and as $z \rightarrow \overline{z_0}$, we have $T(z) = \mathcal{O}(1)$.

6.3 Second transformation: $T \mapsto S$

We now define

$$S(z) := e^{\frac{N\ell}{2}\sigma_3} T(z) e^{-Ng(z)\sigma_3} e^{-\frac{N\ell}{2}\sigma_3}. \quad (6.25)$$

Using (6.1), we infer that S satisfies the following RH problem.

RH problem for S

- (a) $S : \mathbb{C} \setminus \Sigma_T \rightarrow \mathbb{C}^{2 \times 2}$ is analytic.

- (b) $S_+(z) = S_-(z)J_S(z)$ for $z \in \tilde{\Sigma}_0 \cup \tilde{\Sigma}_1 \cup \mathcal{S}$, with

$$J_S(z) = \begin{cases} \begin{pmatrix} 1 & e^{-N(\phi(z)-2g(z)-\ell)\frac{z}{(1-az)^\epsilon}} \\ 0 & 1 \end{pmatrix}, & z \in \tilde{\Sigma}_1, \\ \begin{pmatrix} 1 & 0 \\ -e^{N(\phi(z)-2g(z)-\ell)\frac{(1-az)^\epsilon}{z}} & 1 \end{pmatrix}, & z \in \tilde{\Sigma}_0, \\ \begin{pmatrix} 0 & \frac{z}{(1-az)^\epsilon} \\ -\frac{(1-az)^\epsilon}{z} & e^{N(g_+(z)-g_-(z))} \end{pmatrix}, & z \in \mathcal{S}. \end{cases} \quad (6.26)$$

(c) As $z \rightarrow \infty$, $S(z) = I + \mathcal{O}(z^{-1})$.

As $z \rightarrow z_0$ and as $z \rightarrow \bar{z}_0$, $S(z) = \mathcal{O}(1)$.

In terms of the function ξ defined in (6.16), we can rewrite the jump matrix J_S as

$$J_S(z) = \begin{cases} \begin{pmatrix} 1 & e^{2N\xi(z)} \frac{z}{(1-az)^\epsilon} \\ 0 & 1 \end{pmatrix}, & z \in \tilde{\Sigma}_1, \\ \begin{pmatrix} 1 & 0 \\ -e^{-2N\xi(z)} \frac{(1-az)^\epsilon}{z} & 1 \end{pmatrix}, & z \in \tilde{\Sigma}_0, \\ \begin{pmatrix} 0 & \frac{z}{(1-az)^\epsilon} \\ -\frac{(1-az)^\epsilon}{z} & e^{2N\xi_+(z)} \end{pmatrix}, & z \in \mathcal{S}. \end{cases} \quad (6.27)$$

By Corollary 6.7, we now easily see that for z bounded away from z_0, \bar{z}_0 , the jump matrix $J_S(z)$ converges as $N \rightarrow \infty$ to the identity matrix on $\tilde{\Sigma}_1$ and on $\tilde{\Sigma}_0$, and to the N -independent matrix $\begin{pmatrix} 0 & \frac{z}{(1-az)^\epsilon} \\ -\frac{(1-az)^\epsilon}{z} & 0 \end{pmatrix}$ on \mathcal{S} . We will deal with this N -independent matrix by constructing a global parametrix which has exactly this jump matrix, and we will afterwards deal with small neighborhoods of z_0, \bar{z}_0 by constructing local parametrices there.

6.4 Global parametrix

First, we will construct the global parametrix $P^{(\infty)}$, which needs to satisfy the following conditions.

RH problem for $P^{(\infty)}$

(a) $P^{(\infty)} : \mathbb{C} \setminus \mathcal{S} \rightarrow \mathbb{C}^{2 \times 2}$ is analytic.

(b) $P_+^{(\infty)}(z) = P_-^{(\infty)}(z) \begin{pmatrix} 0 & \frac{z}{(1-az)^\epsilon} \\ -\frac{(1-az)^\epsilon}{z} & 0 \end{pmatrix}$ for $z \in \mathcal{S}$.

(c) As $z \rightarrow \infty$, $P^{(\infty)}(z) = I + \mathcal{O}(z^{-1})$.

A solution is given by

$$P^{(\infty)}(z) = \mathcal{G}_\infty^{-\sigma_3} \begin{pmatrix} \frac{\beta(z)+\beta(z)^{-1}}{2} & \frac{\beta(z)-\beta(z)^{-1}}{2i} \\ \frac{\beta(z)-\beta(z)^{-1}}{-2i} & \frac{\beta(z)+\beta(z)^{-1}}{2} \end{pmatrix} \mathcal{G}(z)^{\sigma_3}, \quad z \in \mathbb{C} \setminus \mathcal{S}, \quad (6.28)$$

where $\beta(z)$, $\mathcal{G}(z) = \mathcal{G}(z; \epsilon)$ and $\mathcal{G}_\infty = \mathcal{G}_\infty(\epsilon)$ are given by

$$\beta(z) = \frac{(z - z_0)^{\frac{1}{4}}}{(z - \bar{z}_0)^{\frac{1}{4}}}, \quad (6.29)$$

$$\mathcal{G}(z) = \exp \left(\frac{\mathcal{R}(z)}{2\pi i} \int_{\mathcal{S}} \frac{\epsilon \log(1-as) - \log s}{\mathcal{R}_+(s)} \frac{ds}{s-z} \right), \quad (6.30)$$

$$\mathcal{G}_\infty = \exp \left(\frac{-1}{2\pi i} \int_{\mathcal{S}} \frac{\epsilon \log(1-as) - \log s}{\mathcal{R}_+(s)} ds \right) > 0, \quad (6.31)$$

and the branch cuts in (6.5) are such that $\beta : \mathbb{C} \setminus \mathcal{S} \rightarrow \mathbb{C}$ is analytic and satisfies $\lim_{z \rightarrow +\infty} \beta(z) = 1$. The branch of the logarithms in (6.30)–(6.31) is the principal one. Note that this solution is not unique because we did not specify how $P^{(\infty)}$ must behave around z_0 and \bar{z}_0 .

The following lemma simplifies the expressions of $\mathcal{G}(0)$ and \mathcal{G}_∞ .

Lemma 6.8. *We have the identities*

$$\mathcal{G}(0) = \left(\frac{|z_0| + \Re z_0}{2|z_0|^2} \right)^{\frac{1}{2}} \left(\frac{|z_0| + \frac{1}{a} - |z_0 - \frac{1}{a}|}{|z_0| + |z_0 - \frac{1}{a}| - \frac{1}{a}} \frac{|z_0| - \Re z_0}{|z_0| + \Re z_0} \right)^{\frac{\epsilon}{2}}, \quad (6.32)$$

$$\mathcal{G}_\infty = \left(\frac{2}{|z_0| + \Re z_0} \right)^{\frac{1}{2}} \left(\frac{a(\Im z_0)^2}{2(|z_0 - \frac{1}{a}| + \Re z_0 - \frac{1}{a})} \right)^{\frac{\epsilon}{2}}. \quad (6.33)$$

Proof. By (6.30) and the definition of \mathcal{R} ,

$$\log \mathcal{G}(0) = -\frac{|z_0|}{2\pi i} \int_{\mathcal{S}} \frac{\epsilon \log(1 - as) - \log s}{\mathcal{R}_+(s)} \frac{ds}{s} = \frac{|z_0|}{4\pi i} \int_{\mathcal{C}_{\mathcal{S}}} \frac{\epsilon \log(1 - as) - \log s}{\mathcal{R}(s)} \frac{ds}{s},$$

where $\mathcal{C}_{\mathcal{S}}$ is a closed loop surrounding \mathcal{S} once in the positive direction, but not enclosing 0 and $\frac{1}{a}$. Let $M > \frac{1}{a}$ be a large but fixed constant, and let $\delta > 0$ be a small but fixed constant. By deforming $\mathcal{C}_{\mathcal{S}}$ into $\mathcal{C}(0, M) \cup (-\mathcal{C}(0, \delta)) \cup (-M + i0_+, -\delta + i0_+) \cup (-\delta - i0_+, -M - i0_+) \cup (M - i0_+, \frac{1}{a} - i0_+) \cup (\frac{1}{a} + i0_+, M + i0_+)$, where $\pm \mathcal{C}(c', R')$ denotes the positively (resp. negatively) oriented circle centered at c' of radius $R' > 0$, we obtain

$$\begin{aligned} \log \mathcal{G}(0) = \frac{|z_0|}{2} \left\{ \int_{\mathcal{C}(0, M)} \frac{\epsilon \log(1 - as) - \log s}{\mathcal{R}(s)} \frac{ds}{2\pi i s} + \int_{\mathcal{C}(0, \delta)} \frac{\log s}{\mathcal{R}(s)} \frac{ds}{2\pi i s} \right. \\ \left. + \int_{-M}^{-\delta} \frac{-1}{\mathcal{R}(x)} \frac{dx}{x} + \int_{\frac{1}{a}}^M \frac{-\epsilon}{\mathcal{R}(x)} \frac{dx}{x} \right\}. \end{aligned}$$

Letting $M \rightarrow +\infty$ in the above expression, we find

$$\log \mathcal{G}(0) = \frac{|z_0|}{2} \left\{ \int_{\mathcal{C}(0, \delta)} \frac{\log s}{\mathcal{R}(s)} \frac{ds}{2\pi i s} + \int_{-\infty}^{-\delta} \frac{1}{|\mathcal{R}(x)|} \frac{dx}{x} + \int_{\frac{1}{a}}^{+\infty} \frac{-\epsilon}{\mathcal{R}(x)} \frac{dx}{x} \right\}. \quad (6.34)$$

Using primitives, we obtain

$$\begin{aligned} \int_{-\infty}^{-\delta} \frac{1}{|\mathcal{R}(x)|} \frac{dx}{x} &= \frac{1}{|z_0|} \log \left(\frac{\sqrt{(\Im z_0)^2 + (\delta + \Re z_0)^2} + \delta - |z_0|}{\sqrt{(\Im z_0)^2 + (\delta + \Re z_0)^2} + \delta + |z_0|} \right) \\ &= \frac{\log \delta}{|z_0|} + \frac{1}{|z_0|} \log \left(\frac{\Re z_0 + |z_0|}{2|z_0|^2} \right) + \mathcal{O}(\delta), \quad \text{as } \delta \rightarrow 0. \end{aligned}$$

Since

$$\int_{\mathcal{C}(0, \delta)} \frac{\log s}{\mathcal{R}(s)} \frac{ds}{2\pi i s} = -\frac{\log \delta}{|z_0|} + \mathcal{O}(\delta), \quad \text{as } \delta \rightarrow 0,$$

by letting $\delta \rightarrow 0$ in (6.34) we obtain

$$\log \mathcal{G}(0) = \frac{|z_0|}{2} \left\{ \frac{1}{|z_0|} \log \left(\frac{\Re z_0 + |z_0|}{2|z_0|^2} \right) + \int_{\frac{1}{a}}^{+\infty} \frac{-\epsilon}{\mathcal{R}(x)} \frac{dx}{x} \right\}. \quad (6.35)$$

The remaining integral can also be evaluated explicitly using primitives:

$$\int_{\frac{1}{a}}^{+\infty} \frac{-\epsilon}{\mathcal{R}(x)} \frac{dx}{x} = \frac{\epsilon}{|z_0|} \log \left(\frac{|z_0| + \frac{1}{a} - |z_0 - \frac{1}{a}|}{|z_0| + |z_0 - \frac{1}{a}| - \frac{1}{a}} \frac{|z_0| - \Re z_0}{|z_0| + \Re z_0} \right).$$

Substituting the above in (6.35), we find (6.32). The proof of (6.33) is similar (and slightly simpler) and we omit it. \square

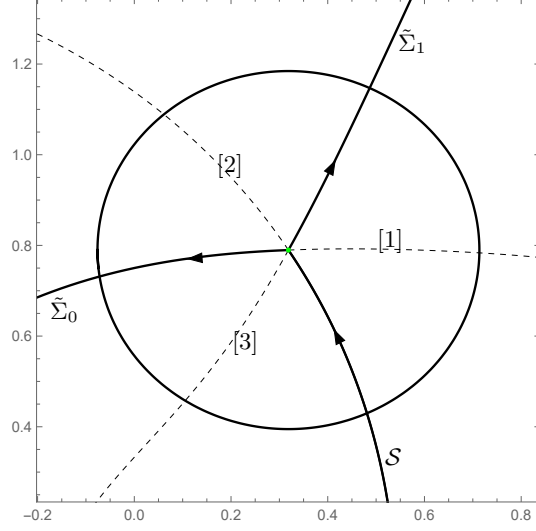


Figure 14: The solid curves are $\tilde{\Sigma}_0, \tilde{\Sigma}_1, \mathcal{S}, \partial\mathcal{D}_{z_0}$ and the thin dashed curves are \mathcal{T}_0 . The curves $\tilde{\Sigma}_0, \tilde{\Sigma}_1, \mathcal{S}$ divide \mathcal{D}_{z_0} in three regions which are denoted by [1], [2] and [3]. The green dot is z_0 . The figure is drawn for $a = 0.78$, $\mu = 0.76$ and $\kappa = 0.44$.

6.5 Local parametrix near z_0

We let \mathcal{D}_{z_0} be a sufficiently small disk around z_0 , with radius at most $\frac{1}{2}\Im z_0$, such that \mathcal{D}_{z_0} lies entirely in the upper half plane. We will construct a local parametrix $P^{(z_0)}$ in $\mathcal{D}_{z_0} \setminus \Sigma_T$, which satisfies exactly the same jump relations as S on $\Sigma_T \cap \mathcal{D}_{z_0}$, and which is close to the global parametrix $P^{(\infty)}$ on the boundary $\partial\mathcal{D}_{z_0}$ of the disk.

RH problem for $P^{(z_0)}$

- (a) $P^{(z_0)} : \mathcal{D}_{z_0} \setminus \Sigma_T \rightarrow \mathbb{C}^{2 \times 2}$ is analytic.
- (b) $P_+^{(z_0)}(z) = P_-^{(z_0)}(z)J_T(z)$ for $z \in \Sigma_T \cap \mathcal{D}_{z_0}$.
- (c) $P^{(z_0)}(z) = P^{(\infty)}(z)(I + o(1))$ as $N \rightarrow +\infty$ uniformly for $z \in \partial\mathcal{D}_{z_0}$.

We will construct the local parametrix using a model RH solution related to the Airy function. Such a construction of a local Airy parametrix is rather standard, see e.g. [18]. We recall this construction here, but without going into much detail.

First, define the complex-valued functions $\{y_j(\zeta)\}_{j=0}^2$ by

$$y_j(\zeta) = e^{\frac{2\pi i j}{3}} \text{Ai}(e^{\frac{2\pi i j}{3}} \zeta), \quad j = 0, 1, 2,$$

where Ai is the Airy function, and let the 2×2 -matrix valued functions $\{A_j(\zeta)\}_{j=1}^3$ be given by

$$A_1(\zeta) = -2i\sqrt{\pi} \begin{pmatrix} -y_2(\zeta) & -y_0(\zeta) \\ -y_2'(\zeta) & -y_0'(\zeta) \end{pmatrix}, \quad (6.36)$$

$$A_2(\zeta) = -2i\sqrt{\pi} \begin{pmatrix} -y_2(\zeta) & y_1(\zeta) \\ -y_2'(\zeta) & y_1'(\zeta) \end{pmatrix}, \quad (6.37)$$

$$A_3(\zeta) = -2i\sqrt{\pi} \begin{pmatrix} y_0(\zeta) & y_1(\zeta) \\ y'_0(\zeta) & y'_1(\zeta) \end{pmatrix}. \quad (6.38)$$

These functions satisfy

$$A_1(\zeta) = A_2(\zeta) \begin{pmatrix} 1 & -1 \\ 0 & 1 \end{pmatrix}, \quad A_2(\zeta) = A_3(\zeta) \begin{pmatrix} 1 & 0 \\ 1 & 1 \end{pmatrix}, \quad A_1(\zeta) = A_3(\zeta) \begin{pmatrix} 1 & -1 \\ 1 & 0 \end{pmatrix}.$$

Moreover,

$$A_k(\zeta) = \zeta^{-\frac{\sigma_3}{4}} \begin{pmatrix} 1 & i \\ 1 & -i \end{pmatrix} \left[I + \frac{1}{8\zeta^{3/2}} \begin{pmatrix} -\frac{1}{6} & -i \\ -i & \frac{1}{6} \end{pmatrix} + \mathcal{O}(\zeta^{-3}) \right] e^{\frac{2}{3}\zeta^{3/2}\sigma_3} \quad (6.39)$$

as $\zeta \rightarrow \infty$ in the sector S_k for $k = 1, 2, 3$, with

$$S_k = \left\{ \zeta \in \mathbb{C} : \frac{2k-3}{3}\pi + \delta \leq \arg \zeta \leq \frac{2k+1}{3}\pi - \delta \right\}, \quad k = 1, 2, 3, \quad (6.40)$$

and the branches of the complex powers in (6.39) are such that $\zeta^u = e^{u \log |\zeta| + iu \arg \zeta}$ where $\arg \zeta$ belongs to $(-\pi/3, \pi)$, $(\pi/3, 5\pi/3)$, and $(\pi, 7\pi/3)$ for ζ in S_1, S_2, S_3 , respectively.

We construct the local parametrix $P^{(z_0)}$ for $\zeta \in \mathcal{D}_{z_0} \setminus \Sigma_T$ of the following form:

$$P^{(z_0)}(z) = E(z) A_k \left(-N^{\frac{2}{3}} f(z) \right) e^{-N\xi(z)\sigma_3} \left(\frac{(1-az)^\epsilon}{z} \right)^{\frac{\sigma_3}{2}}, \quad z \in [k], \quad k = 1, 2, 3, \quad (6.41)$$

where the principal branch is used for the roots. Here, the regions $[k]$, $k = 1, 2, 3$, denote the three components of $\mathcal{D}_{z_0} \setminus \Sigma_T$ as shown in Figure 14, f is the conformal map from \mathcal{D}_{z_0} to a neighborhood of 0 defined by

$$f(z) = -\left(\frac{3}{2} \xi(z) \right)^{\frac{2}{3}}, \quad (6.42)$$

and E denotes the 2×2 -matrix valued function analytic on \mathcal{D}_{z_0} defined by

$$E(z) = P^{(\infty)}(z) \left(\frac{(1-az)^\epsilon}{z} \right)^{-\frac{\sigma_3}{2}} \begin{pmatrix} 1 & i \\ 1 & -i \end{pmatrix}^{-1} \left(-N^{\frac{2}{3}} f(z) \right)^{\frac{\sigma_3}{4}}. \quad (6.43)$$

As $z \rightarrow z_0$, we have

$$f(z) = -c_0(z - z_0)(1 + c_1(z - z_0) + \mathcal{O}((z - z_0)^2)), \quad (6.44)$$

where

$$c_0 = (2\Im z_0)^{1/3} (-e^{\frac{\pi i}{4}} Q(z_0))^{2/3}, \quad c_1 = \frac{2}{5} (\log Q)'(z_0) - \frac{i}{10\Im z_0}, \quad (6.45)$$

and the principal branch is used for $(-e^{\frac{\pi i}{4}} Q(z_0))^{2/3}$. Note that we need to take \mathcal{D}_{z_0} sufficiently small so that f is conformal on \mathcal{D}_{z_0} .

From (6.39) and (6.41), we obtain the matching condition

$$\begin{aligned} & P^{(z_0)}(z) P^{(\infty)}(z)^{-1} \\ &= P^{(\infty)}(z) \left[I + \frac{1}{8N(-f(z))^{3/2}} \begin{pmatrix} -\frac{1}{6} & -i\frac{z}{(1-az)^\epsilon} \\ -i\frac{(1-az)^\epsilon}{z} & \frac{1}{6} \end{pmatrix} + \mathcal{O}(N^{-2}) \right] P^{(\infty)}(z)^{-1}, \end{aligned} \quad (6.46)$$

as $N \rightarrow \infty$ uniformly for $z \in \partial D_{z_0}$. This matching condition is also uniform in $\kappa \in [\delta, \kappa_2 - \delta]$ and in $\mu \in [\delta, 1 - \delta]$, for any fixed $\delta > 0$. As $\kappa \rightarrow 0$, we need to replace the error term $\mathcal{O}(N^{-2})$, using (6.13), (6.39), (6.44) and (6.45), by

$$\mathcal{O}(N^{-2}f(z)^{-3}) = \mathcal{O}(N^{-2}(\Im z_0)^{-4}) = \mathcal{O}(N^{-2}\kappa^{-2}). \quad (6.47)$$

On the other hand, as $\kappa \rightarrow \kappa_2$ with $\mu - \kappa_2 \geq \delta$, we use (6.12), (6.15), (6.39), (6.44) and (6.45) to replace the error term $\mathcal{O}(N^{-2})$ by

$$\mathcal{O}(N^{-2}f(z)^{-3}) = \mathcal{O}(N^{-2}|z_0 - \gamma|^{-2}(\Im z_0)^{-4}) = \mathcal{O}(N^{-2}(\kappa_2 - \kappa)^{-3}). \quad (6.48)$$

This extends the analysis to the range

$$\frac{M}{N} \leq \kappa \leq \min\{\kappa_2 - \frac{M}{N^{2/3}}, \mu - \delta\}, \quad \delta \leq \mu \leq 1 - \delta$$

for sufficiently large but fixed $M > 0$, and for any fixed $\delta > 0$.

6.6 Local parametrix near $\overline{z_0}$

Near $\overline{z_0}$, we need to construct a local parametrix satisfying the following conditions.

RH problem for $P^{(\overline{z_0})}$

- (a) $P^{(\overline{z_0})} : \mathcal{D}_{\overline{z_0}} \setminus \Sigma_T \rightarrow \mathbb{C}^{2 \times 2}$ is analytic.
- (b) $P_+^{(\overline{z_0})}(z) = P_-^{(\overline{z_0})}(z)J_T(z)$ for $z \in \Sigma_T \cap \mathcal{D}_{\overline{z_0}}$.
- (c) $P^{(\overline{z_0})}(z) = P^{(\infty)}(I + \mathcal{O}(N^{-1}))$ as $N \rightarrow +\infty$ uniformly for $z \in \partial \mathcal{D}_{\overline{z_0}}$.

We can simply use the local parametrix near z_0 for this, and define

$$P^{(\overline{z_0})}(z) = \overline{P^{(z_0)}(\overline{z})}, \quad z \in \mathcal{D}_{\overline{z_0}} \setminus \Sigma_T \quad (6.49)$$

By (6.46) and by the symmetry $\overline{P^{(\infty)}(\overline{z})} = P^{(\infty)}(z)$, we obtain the matching condition

$$P^{(\overline{z_0})}(z)P^{(\infty)}(z)^{-1} = P^{(\infty)}(z) \left[I + \frac{1}{8N(-f(\overline{z}))^{3/2}} \begin{pmatrix} -\frac{1}{6} & i\frac{z}{(1-az)^\epsilon} \\ i\frac{(1-az)^\epsilon}{z} & \frac{1}{6} \end{pmatrix} + \mathcal{O}(N^{-2}) \right] P^{(\infty)}(z)^{-1}, \quad (6.50)$$

as $N \rightarrow \infty$ uniformly for $z \in \overline{\partial D_{z_0}}$ and for $\kappa \in [\delta, \kappa_2 - \delta]$ for any fixed $\delta > 0$. If $\kappa \rightarrow 0$ (respectively $\kappa \rightarrow \kappa_2$ with $\kappa \leq \mu - \delta$), then the error term $\mathcal{O}(N^{-2})$ in (6.50) must be replaced by (6.47) (respectively (6.48)).

6.7 Small norm RH problem

Define

$$R(z) = \begin{cases} S(z)P^{(\infty)}(z)^{-1}, & z \in \mathbb{C} \setminus (\overline{\mathcal{D}_{z_0}} \cup \mathcal{D}_{\overline{z_0}}), \\ S(z)P^{(z_0)}(z)^{-1}, & z \in \mathcal{D}_{z_0}, \\ S(z)P^{(\overline{z_0})}(z)^{-1}, & z \in \mathcal{D}_{\overline{z_0}}. \end{cases} \quad (6.51)$$

R satisfies the following RH problem.

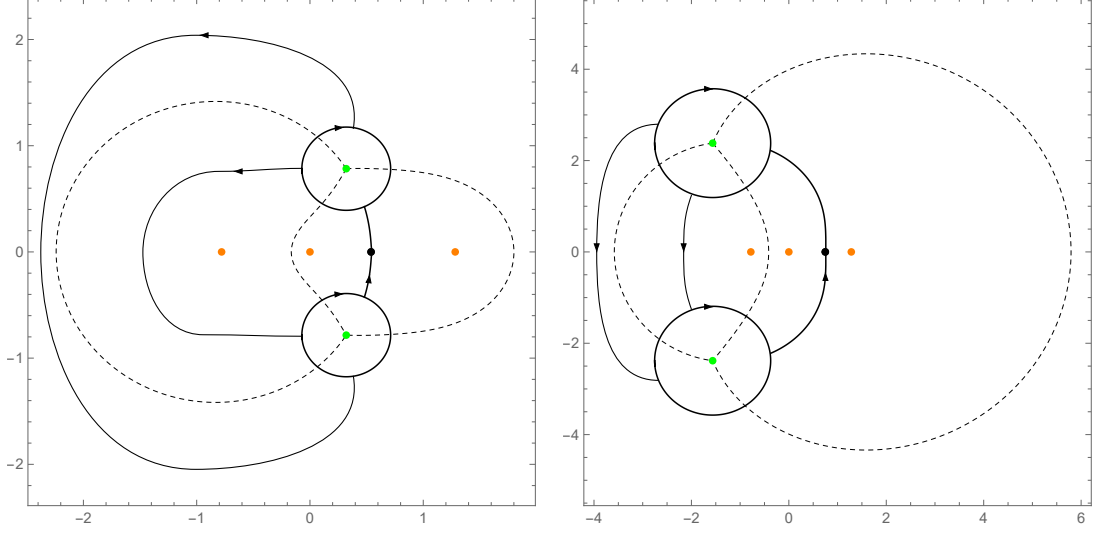


Figure 15: In each image, the solid black curves are Σ_R and the dashed curves are \mathcal{T}_0 . The orange dots are $-a$, 0 and $\frac{1}{a}$; the black dot is γ ; and the green dots are z_0 and \bar{z}_0 . The figures are drawn for $a = 0.78$, $\mu = 0.76$, and with $\kappa = 0.44$ (left) and $\kappa = 0.08$ (right).

RH problem for R

- (a) $R : \mathbb{C} \setminus \Sigma_R \rightarrow \mathbb{C}^{2 \times 2}$ is analytic, where

$$\Sigma_R = \partial \mathcal{D}_{z_0} \cup \partial \mathcal{D}_{\bar{z}_0} \cup (\Sigma_T \setminus (\mathcal{D}_{z_0} \cup \mathcal{D}_{\bar{z}_0}))$$

The contour Σ_R is oriented as shown in Figure 15. In particular, we orient the circles $\partial \mathcal{D}_{z_0}$ and $\partial \mathcal{D}_{\bar{z}_0}$ in the clockwise direction.

- (b) For $z \in \Sigma_R$, we have $R_+(z) = R_-(z)J_R(z)$, where

$$\begin{aligned} J_R(z) &= P^{(z_0)}(z)P^{(\infty)}(z)^{-1}, & z \in \partial \mathcal{D}_{z_0}, \\ J_R(z) &= P^{(\bar{z}_0)}(z)P^{(\infty)}(z)^{-1}, & z \in \partial \mathcal{D}_{\bar{z}_0}, \\ J_R(z) &= P^{(\infty)}(z)J_S(z)P^{(\infty)}(z)^{-1}, & z \in \Sigma_R \setminus (\partial \mathcal{D}_{z_0} \cup \partial \mathcal{D}_{\bar{z}_0}). \end{aligned}$$

- (c) $R(z)$ remains bounded as z tends to the points of self-intersections of Σ_R .

As $z \rightarrow \infty$, $R(z) = I + \frac{R_1}{z} + \mathcal{O}(z^{-2})$ for some R_1 independent of z .

Observe that we have the symmetry $R(z) = \overline{R(\bar{z})}$, $z \in \mathbb{C} \setminus \Sigma_R$.

On $\partial \mathcal{D}_{z_0} \cup \partial \mathcal{D}_{\bar{z}_0}$, by (6.46) and (6.50), we have

$$J_R(z) = I + \frac{J_R^{(1)}(z)}{N} + \mathcal{O}(N^{-2}), \quad \text{as } N \rightarrow +\infty \quad (6.52)$$

uniformly for $z \in \partial \mathcal{D}_{z_0} \cup \partial \mathcal{D}_{\bar{z}_0}$, $\kappa \in [\delta, \kappa_2 - \delta]$ and $\mu \in [\delta, 1 - \delta]$, for any fixed $\delta > 0$ and for some matrix $J_R^{(1)}$ that can be explicitly computed. On the rest of the contour, using Corollary 6.7, we obtain

$$J_R(z) = I + \mathcal{O}(e^{-cN}), \quad \text{as } N \rightarrow +\infty, \quad (6.53)$$

uniformly for $z \in \Sigma_R \setminus (\partial\mathcal{D}_{z_0} \cup \partial\mathcal{D}_{\bar{z}_0})$, $\kappa \in [\delta, \kappa_2 - \delta]$ and $\mu \in [\delta, 1 - \delta]$, for some $c = c(\delta) > 0$ and any fixed $\delta > 0$. By small-norm theory for RH problems [19, 18], we thus have

$$R(z) = I + \frac{R^{(1)}(z)}{N} + \mathcal{O}\left(\frac{N^{-2}}{1 + |z|}\right), \quad \text{as } N \rightarrow +\infty, \quad (6.54)$$

uniformly for $z \in \mathbb{C} \setminus \Sigma_R$, where

$$R^{(1)}(z) = \frac{1}{2\pi i} \int_{\partial\mathcal{D}_{z_0} \cup \partial\mathcal{D}_{\bar{z}_0}} \frac{J_R^{(1)}(s)}{s - z} ds,$$

and we recall that the orientation of the circles is clockwise. Therefore, for $z \in \mathbb{C} \setminus (\overline{\mathcal{D}_{z_0}} \cup \overline{\mathcal{D}_{\bar{z}_0}})$, we have

$$\begin{aligned} R^{(1)}(z) &= \frac{1}{z - z_0} \text{Res}\left(J_R^{(1)}(s); s = z_0\right) + \frac{1}{(z - z_0)^2} \text{Res}\left((s - z_0)J_R^{(1)}(s); s = z_0\right) \\ &\quad + \frac{1}{z - \bar{z}_0} \text{Res}\left(J_R^{(1)}(s); s = \bar{z}_0\right) + \frac{1}{(z - \bar{z}_0)^2} \text{Res}\left((s - \bar{z}_0)J_R^{(1)}(s); s = \bar{z}_0\right). \end{aligned} \quad (6.55)$$

The above residues can be computed explicitly using (6.44) and (6.49):

$$\begin{aligned} \text{Res}\left((s - z_0)J_R^{(1)}(s); s = z_0\right) &= \frac{5\sqrt{\text{Im } z_0} e^{\frac{\pi i}{4}}}{48\sqrt{2} c_0^{\frac{3}{2}}} \begin{pmatrix} 1 & -i\mathcal{G}_\infty^{-2} \\ -i\mathcal{G}_\infty^2 & -1 \end{pmatrix}, \\ \text{Res}\left((s - \bar{z}_0)J_R^{(1)}(s); s = \bar{z}_0\right) &= \overline{\text{Res}\left((s - z_0)J_R^{(1)}(s); s = z_0\right)}, \\ \text{Res}\left(J_R^{(1)}(s); s = z_0\right) &= \frac{e^{-\frac{\pi i}{4}}}{64\sqrt{2} c_0^{\frac{3}{2}} \sqrt{\text{Im } z_0}} \begin{pmatrix} -3 - 10i c_1 \text{Im } z_0 & (-\frac{19}{3}i - 10 c_1 \text{Im } z_0)\mathcal{G}_\infty^{-2} \\ (-\frac{19}{3}i - 10 c_1 \text{Im } z_0)\mathcal{G}_\infty^2 & 3 + 10i c_1 \text{Im } z_0 \end{pmatrix} \\ &\quad + \frac{\mathfrak{g}_1}{4\sqrt{2} c_0^{\frac{3}{2}}} \begin{pmatrix} e^{\frac{\pi i}{4}} \sqrt{\text{Im } z_0} \mathfrak{g}_1 & \frac{\sqrt{2} + e^{\frac{\pi i}{4}} \sqrt{\text{Im } z_0} \mathfrak{g}_1}{i\mathcal{G}_\infty^2} \\ \frac{\sqrt{2} - e^{\frac{\pi i}{4}} \sqrt{\text{Im } z_0} \mathfrak{g}_1}{-i\mathcal{G}_\infty^{-2}} & -e^{\frac{\pi i}{4}} \sqrt{\text{Im } z_0} \mathfrak{g}_1 \end{pmatrix} \\ \text{Res}\left(J_R^{(1)}(s); s = \bar{z}_0\right) &= \overline{\text{Res}\left(J_R^{(1)}(s); s = z_0\right)}, \end{aligned}$$

where \mathcal{G}_∞ is given by (6.33) and

$$\mathfrak{g}_1 = -\frac{e^{-\frac{\pi i}{4}} \sqrt{\text{Im } z_0}}{\sqrt{2}} \oint_{\mathcal{C}} \frac{\epsilon \log(1 - as) - \log s}{\mathcal{R}(s)} \frac{ds}{s - z_0}.$$

Here, the principal branch is used for the logarithms, and $\mathcal{C} \subset \mathbb{C} \setminus ((-\infty, 0] \cup [\frac{1}{a}, +\infty))$ is a closed contour surrounding \mathcal{S} once in the positive direction. Using contour deformation, it is possible to simplify \mathfrak{g}_1 as in (6.64) below; the proof is similar to the proof of Lemma 6.8 and we omit it.

We can again extend the range of validity of our asymptotic analysis as $\kappa \rightarrow \kappa_2$ with $\kappa \leq \mu - \delta$ and as $\kappa \rightarrow 0$: since $P^{(\infty)}$ remains bounded near z_0, \bar{z}_0 in these limits, we have that (6.53) holds uniformly for $M/N \leq \kappa \leq \min\{\kappa_2 - MN^{-2/3}, \mu - \delta\}$ with M large, if we replace the error term $\mathcal{O}(e^{-cN})$ by $\mathcal{O}(e^{-c\kappa N})$ as $\kappa \rightarrow 0$, and by $\mathcal{O}(e^{-c(\kappa_2 - \kappa)^{3/2}N})$ as $\kappa \rightarrow \kappa_2$ with $\kappa \leq \mu - \delta$. Similarly, (6.52) and (6.54) hold uniformly for $M/N \leq \kappa \leq \min\{\kappa_2 - MN^{-2/3}, \mu - \delta\}$ with M large, if we replace the error terms $\mathcal{O}(N^{-2})$ by

$$\mathcal{O}(N^{-2}\xi(z)^{-2}) = \mathcal{O}(N^{-2}|\Im z_0|^{-4}) = \mathcal{O}(N^{-2}\kappa^{-2}), \quad (6.56)$$

as $\kappa \rightarrow 0$, and by

$$\mathcal{O}(N^{-2}\xi(z)^{-2}) = \mathcal{O}(N^{-2}(z_0 - \gamma)^{-2}|\Im z_0|^{-4}) = \mathcal{O}(N^{-2}(\kappa_2 - \kappa)^{-3}), \quad (6.57)$$

as $\kappa \rightarrow \kappa_2$ with $\kappa \leq \mu - \delta$. All of these error terms are also uniform in $\mu \in [\delta, 1 - \delta]$, for any fixed $\delta > 0$.

6.8 Ratio asymptotics

Proposition 6.9 (Ratio asymptotics in the rough region). *For any $\delta > 0$ and for sufficiently large $M > 0$, we have*

$$\begin{aligned} \log F_N^{m,k+1}(a; \epsilon) - \log F_N^{m,k}(a; \epsilon) &= NG(\kappa, \mu) + H(\kappa, \mu) + \frac{1}{N}F(\kappa, \mu) \\ &\quad + \mathcal{O}(N^{-2}(\kappa_2 - \kappa)^{-3}) + \mathcal{O}(N^{-2}\kappa^{-2}), \end{aligned}$$

as $N \rightarrow \infty$, uniformly for $\delta \leq \mu \leq 1 - \delta$ and for $M/N \leq \kappa \leq \min\{\kappa_2 - MN^{-2/3}, \mu - \delta\}$, with $\mu = \frac{m}{N}$, $\kappa = k/N$. Here,

$$G(\kappa, \mu) = -g(0; \kappa, \mu), \quad (6.58)$$

$$H(\kappa, \mu) = \log \frac{\mathcal{G}_\infty}{\mathcal{G}(0)} + \log \cos\left(\frac{\arg z_0}{2}\right), \quad (6.59)$$

$$F(\kappa, \mu) = R_{22}^{(1)}(0) + \frac{R_{21}^{(1)}(0)}{\mathcal{G}_\infty^2} \tan\left(\frac{\arg z_0}{2}\right). \quad (6.60)$$

Proof. By the construction of T , (6.25), and (6.51) (note that $0 \in \mathbb{C} \setminus (\overline{\mathcal{D}_{z_0}} \cup \overline{\mathcal{D}_{\bar{z}_0}})$), we have

$$\begin{aligned} Y_{22}(0) &= e^{-Ng(0)} S_{22}(0) \\ &= e^{-Ng(0)} \left(R_{21}(0) P_{12}^{(\infty)}(0) + R_{22}(0) P_{22}^{(\infty)}(0) \right). \end{aligned}$$

By (6.28) and (6.5), we have

$$P_{22}^{(\infty)}(0) = \frac{\mathcal{G}_\infty}{\mathcal{G}(0)} \cos\left(\frac{\arg z_0}{2}\right), \quad P_{12}^{(\infty)}(0) = \frac{1}{\mathcal{G}(0)\mathcal{G}_\infty} \sin\left(\frac{\arg z_0}{2}\right).$$

Using the large N asymptotic expansion (6.54) of R , we obtain

$$Y_{22}(0) = e^{-Ng(0)} \frac{\mathcal{G}_\infty}{\mathcal{G}(0)} \cos\left(\frac{\arg z_0}{2}\right) \left(1 + \frac{1}{N} \left[R_{22}^{(1)}(0) + \frac{R_{21}^{(1)}(0)}{\mathcal{G}_\infty^2} \tan\left(\frac{\arg z_0}{2}\right) \right] + \mathcal{O}(N^{-2}) \right),$$

where we need to replace the error term by $\mathcal{O}(N^{-2}(\kappa_2 - \kappa)^{-3})$ or by $\mathcal{O}(N^{-2}\kappa^{-2})$ as $\kappa \rightarrow \kappa_2$ or as $\kappa \rightarrow 0$, respectively (see (6.56) and (6.57)). So

$$\log Y_{22}(0) = -Ng(0) + \log \frac{\mathcal{G}_\infty}{\mathcal{G}(0)} + \log \cos\left(\frac{\arg z_0}{2}\right) + \frac{1}{N} \left[R_{22}^{(1)}(0) + \frac{R_{21}^{(1)}(0)}{\mathcal{G}_\infty^2} \tan\left(\frac{\arg z_0}{2}\right) \right] + \mathcal{O}(N^{-2}),$$

again with modified error term as $\kappa \rightarrow \kappa_2$ or as $\kappa \rightarrow 0$. The result now follows from (2.4). \square

We can evaluate G, H, F explicitly in terms of z_0 . For H , we use (6.32)–(6.33) and obtain

$$H(\kappa, \mu) = \frac{\epsilon}{2} \log \left(\left(\frac{a(\operatorname{Im} z_0)^2}{2(|z_0 - \frac{1}{a}| + \Re z_0 - \frac{1}{a})} \right) \left(\frac{|z_0| + |z_0 - \frac{1}{a}| - \frac{1}{a}}{|z_0| + \frac{1}{a} - |z_0 - \frac{1}{a}|} \frac{|z_0| + \Re z_0}{|z_0| - \Re z_0} \right) \right) \\ + \log \left(\frac{2|z_0|}{|z_0| + \Re z_0} \right) + \log \cos \left(\frac{\arg z_0}{2} \right). \quad (6.61)$$

For G , we evaluate (6.22) at $z = 0$ and use (6.23) to obtain

$$G(\kappa, \mu) = \frac{\mu - \kappa}{2} \left\{ \log \left(\frac{4|z_0|^2}{(\operatorname{Im} z_0)(|z_0| + \Re z_0)} \right) - \frac{\Re z_0}{|z_0|} \log \left(\frac{|z_0| + \Re z_0}{\operatorname{Im} z_0} \right) \right\} \\ - \frac{1 - \mu}{2} \left\{ \log \left(\frac{|z_0| |z_0 - \frac{1}{a}| + \frac{1}{a} \Re z_0 - |z_0|^2}{\frac{\operatorname{Im} z_0}{2} (|z_0 - \frac{1}{a}| + \frac{1}{a} - \Re z_0)} \right) + \frac{\Re z_0 - \frac{1}{a}}{|z_0 - \frac{1}{a}|} \log \left(\frac{|z_0| + \Re z_0}{\operatorname{Im} z_0} \right) \right\} \\ - \frac{\mu}{2} \left\{ \log \left(\frac{|z_0| |z_0 + a| + |z_0|^2 + a \Re z_0}{\frac{\operatorname{Im} z_0}{2} (|z_0 + a| + a + \Re z_0)} \right) - \frac{\Re z_0 + a}{|z_0 + a|} \log \left(\frac{|z_0| + \Re z_0}{\operatorname{Im} z_0} \right) \right\}. \quad (6.62)$$

Finally, for F , we use (6.55) and obtain

$$F(\kappa) = \frac{\sqrt{\operatorname{Im} z_0}}{2\sqrt{2}} \left\{ \tan \left(\frac{\arg z_0}{2} \right) \operatorname{Im} \left(\frac{5}{12} \frac{1}{z_0^2 e_0} + \frac{5}{8} \frac{e_1}{z_0 e_0} - \frac{\mathfrak{g}_1^2}{z_0 e_0} \right) - \operatorname{Re} \left(\frac{5}{12} \frac{1}{z_0^2 e_0} + \frac{5}{8} \frac{e_1}{z_0 e_0} - \frac{\mathfrak{g}_1^2}{z_0 e_0} \right) \right\} \\ - \frac{\operatorname{Im} \left(\frac{3}{16} \frac{1}{z_0 e_0} \right)}{2\sqrt{2}\sqrt{\operatorname{Im} z_0}} + \tan \left(\frac{\arg z_0}{2} \right) \left\{ \frac{\operatorname{Im} \left(\frac{19}{48} \frac{1}{z_0 e_0} \right)}{2\sqrt{2}\sqrt{\operatorname{Im} z_0}} + \operatorname{Im} \left[\frac{e^{-\frac{\pi i}{4}} \mathfrak{g}_1}{2z_0 e_0} \right] \right\}, \quad (6.63)$$

where e_0 , e_1 and \mathfrak{g}_1 are given by

$$e_0 = -\sqrt{2}\sqrt{\operatorname{Im} z_0} Q(z_0), \quad e_1 = \frac{2}{5} \frac{Q'(z_0)}{Q(z_0)} - \frac{i}{10 \operatorname{Im} z_0}, \\ Q(z) = \frac{\kappa + 1 - \mu}{2} \frac{z - \gamma}{z(z + a)(z - 1/a)}, \quad \gamma = \frac{\mu - \kappa}{1 - \mu + \kappa} \frac{1}{|z_0|}, \\ \mathfrak{g}_1 = e^{\frac{\pi i}{4}} \sqrt{2}\sqrt{\operatorname{Im} z_0} \left(\frac{1}{z_0 + |z_0|} + \frac{\epsilon}{\frac{1}{a} - z_0 + |\frac{1}{a} - z_0|} \right). \quad (6.64)$$

Note that all the quantities defined above have a highly nontrivial dependence on κ and μ , via $z_0 = z_0(\kappa, \mu)$.

It is crucial for us to understand the asymptotics of the quantities $H(\kappa, \mu)$, $F(\kappa, \mu)$ and $G(\kappa, \mu)$ as $\kappa \rightarrow 0$ and as $\kappa \rightarrow \kappa_2$.

Proposition 6.10. *Let $\mu \in (0, 1)$. As $\kappa \rightarrow 0$, we have*

$$G(\kappa, \mu) = G_0 + G_* \kappa \log \kappa + G_1 \kappa + \mathcal{O}(\kappa^2), \quad \partial_\kappa G(\kappa, \mu) = G_* \log \kappa + G_* + G_1 + \mathcal{O}(\kappa), \\ \partial_\kappa^j G(\kappa, \mu) = \mathcal{O}(\kappa^{-j+1}) \quad \text{for } j = 2, 3, 4, \\ H(\kappa, \mu) = -\frac{1}{2} \log \kappa + H_0 + \mathcal{O}(\kappa), \quad F(\kappa, \mu) = \frac{F_{-1}}{\kappa} + \mathcal{O}(1), \\ \partial_\kappa^j H(\kappa, \mu) = \mathcal{O}(\kappa^{-j}), \quad \partial_\kappa^j F(\kappa, \mu) = \mathcal{O}(\kappa^{-j-1}) \quad \text{for } j = 1, 2, 3, 4,$$

with

$$G_0 = \varphi_0(x_0), \quad G_* = 1, \quad G_1 = -1 - \log(|x_0|^2 \varphi_0''(x_0)). \quad (6.65)$$

$$H_0 = \frac{1}{2} \log(|x_0|^2 \varphi_0''(x_0)) + \epsilon \log(1 - ax_0), \quad F_{-1} = \frac{1}{12}, \quad (6.66)$$

The error terms are moreover uniform for $\mu \in [\delta, 1 - \delta]$ for any fixed $\delta > 0$.

Proof. Using (6.61) and Proposition 6.2, we obtain after a straightforward computation that

$$H(\kappa, \mu) = -\frac{1}{2} \log \kappa + H_0 + \mathcal{O}(\kappa) \quad \text{as } \kappa \rightarrow 0,$$

for some $H_0 \in \mathbb{R}$, and that $\partial_\kappa^j H(\kappa, \mu) = \mathcal{O}(\kappa^{-j})$ as $\kappa \rightarrow 0$ for $j = 1, 2, 3, 4$. Similarly, by (6.63) and Proposition 6.2, we can prove that

$$F(\kappa, \mu) = \frac{F_{-1}}{\kappa} + \mathcal{O}(1) \quad \text{as } \kappa \rightarrow 0,$$

for some $F_{-1} \in \mathbb{R}$, and that $\partial_\kappa^j F(\kappa, \mu) = \mathcal{O}(\kappa^{-j-1})$ as $\kappa \rightarrow 0$ for $j = 1, 2, 3, 4$.

Finally, by (6.62) and Proposition 6.2, we find after a lengthy computation that

$$G(\kappa, \mu) = G_0 + G_* \kappa \log \kappa + G_1 \kappa + \mathcal{O}(\kappa^2),$$

and that $\partial_\kappa G(\kappa, \mu) = G_1 \log \kappa + G_* + G_1 + \mathcal{O}(\kappa)$, $\partial_\kappa^j G(\kappa, \mu) = \mathcal{O}(\kappa^{-j+1})$ for $j = 2, 3, 4$, as $\kappa \rightarrow 0$, for some constants $G_0, G_*, G_1 \in \mathbb{R}$.

To compute the constants $H_0, F_{-1}, G_0, G_*, G_1$, we can now use Proposition 5.1 for k fixed but sufficiently large: this gives

$$\begin{aligned} \log F_N^{m,k+1}(a; \epsilon) - \log F_N^{m,k}(a; \epsilon) &= N\varphi_0(x_0) - \left(k - \frac{1}{2}\right) \log N + \log((k-1)!) \\ &\quad - \left(k - \frac{1}{2}\right) \log(|x_0|^2 \varphi_0''(x_0)) + \epsilon \log(1 - ax_0) - \frac{1}{2} \log(2\pi) + \mathcal{O}(N^{-1/2}), \end{aligned}$$

as $N \rightarrow \infty$, which we can rewrite in terms of $\kappa = k/N$ as

$$\begin{aligned} \log F_N^{m,k+1}(a; \epsilon) - \log F_N^{m,k}(a; \epsilon) &= N\varphi_0(x_0) + N\kappa \log \kappa - \kappa N - \kappa N \log(|x_0|^2 \varphi_0''(x_0)) - \frac{1}{2} \log \kappa \\ &\quad + \frac{1}{2} \log(|x_0|^2 \varphi_0''(x_0)) + \epsilon \log(1 - ax_0) + S(k) + \mathcal{O}(N^{-1/2}), \end{aligned} \quad (6.67)$$

with

$$S(k) = \log((k-1)!) - \left(k - \frac{1}{2}\right) \log k + k - \frac{1}{2} \log(2\pi),$$

which is $\frac{1}{12k} + \mathcal{O}(1/k^3)$ as $k \rightarrow \infty$ by Stirling's approximation.

Now we compare this with Proposition 6.9 in which we substitute the above expansions for $H(\kappa, \mu)$, $F(\kappa, \mu)$, $G(\kappa, \mu)$: this gives

$$\begin{aligned} \log F_N^{m,k+1}(a; \epsilon) - \log F_N^{m,k}(a; \epsilon) &= NG_0 + G_* N\kappa \log \kappa + G_1 N\kappa - \frac{1}{2} \log \kappa + H_0 + \frac{F_{-1}}{k} \\ &\quad + \mathcal{O}(k^2 N^{-1}) + \mathcal{O}(k N^{-1}) + \mathcal{O}(N^{-1}) + \mathcal{O}(k^{-2}), \end{aligned}$$

as $N \rightarrow \infty$ for k large. Comparing the latter with (6.67), we obtain (6.65)–(6.66). \square

Proposition 6.11. *As $\kappa \rightarrow \kappa_2$, we have*

$$\begin{aligned} G(\kappa, \mu) &= \tilde{G}_2(\kappa_2 - \kappa)^2 + \mathcal{O}((\kappa_2 - \kappa)^3), \\ \partial_\kappa G(\kappa, \mu) &= \mathcal{O}(\kappa_2 - \kappa), \quad \partial_\kappa^j G(\kappa, \mu) = \mathcal{O}(1) \quad \text{for } j = 2, 3, 4, \end{aligned}$$

$$H(\kappa, \mu) = \mathcal{O}(\kappa_2 - \kappa), \quad F(\kappa) = \frac{\tilde{F}_{-1}}{\kappa_2 - \kappa} + \mathcal{O}(1),$$

$$\partial_\kappa^j H(\kappa, \mu) = \mathcal{O}(1), \quad \partial_\kappa^j F(\kappa, \mu) = \mathcal{O}((\kappa_2 - \kappa)^{-j-1}) \quad \text{for } j = 1, 2, 3, 4,$$

with

$$\tilde{G}_2 = \frac{(s^*)^3}{4}, \quad \tilde{F}_{-1} = \frac{1}{8}. \quad (6.68)$$

The error terms are moreover uniform for $\mu \in [\delta, 1 - \delta] \setminus (\frac{a^2}{1+a^2} - \delta, \frac{a^2}{1+a^2} + \delta)$ for any fixed $\delta > 0$.

Proof. We proceed similarly as in the proof of Proposition 6.10. Using (6.61) and Proposition 6.2, we obtain

$$H(\kappa, \mu) = \mathcal{O}(\kappa_2 - \kappa), \quad \partial_\kappa^j H(\kappa, \mu) = \mathcal{O}(1), \quad \text{as } \kappa \rightarrow \kappa_2, \quad j = 1, 2, 3, 4.$$

By (6.63), Proposition 6.2 and (6.55), we find

$$F(\kappa, \mu) = \frac{\tilde{F}_{-1}}{\kappa_2 - \kappa} + \mathcal{O}(1) \quad \text{as } \kappa \rightarrow \kappa_2,$$

for some $\tilde{F}_{-1} \in \mathbb{R}$, and $\partial_\kappa^j F(\kappa, \mu) = \mathcal{O}((\kappa_2 - \kappa)^{-j-1})$ as $\kappa \rightarrow \kappa_2$ for $j = 1, 2, 3, 4$. By (6.62) and Proposition 6.2, we obtain after a long computation that

$$G(\kappa, \mu) = \tilde{G}_2(\kappa_2 - \kappa)^2 + \mathcal{O}((\kappa_2 - \kappa)^3),$$

and that $\partial_\kappa G(\kappa, \mu) = \mathcal{O}(\kappa_2 - \kappa)$ as $\kappa \rightarrow \kappa_2$, for some constant $\tilde{G}_2 \in \mathbb{R}$, as well as the fact that $\partial_\kappa^j G(\kappa, \mu)$ is bounded for $j = 2, 3, 4$.

To compute the constant \tilde{G}_2 , we use Proposition 4.1 and (4.24) for $\kappa_2 - \kappa = N^{-\frac{2}{3}+\eta}$ with $\eta \in (\frac{1}{15}, \frac{1}{6})$. We get

$$\begin{aligned} \log F_N^{m,k+1}(a; \epsilon) - \log F_N^{m,k}(a; \epsilon) &= \frac{(s^*)^3}{4} N^{-\frac{1}{3}+2\eta} \\ &\quad + \frac{1}{8} N^{-\frac{1}{3}-\eta} + \mathcal{O}\left(N^{-\frac{2}{3}+4\eta} + N^{-\frac{1}{3}-\frac{5}{2}\eta}\right), \end{aligned} \quad (6.69)$$

as $N \rightarrow \infty$. We compare this with Proposition 6.9 in which we substitute the above expansions of $H(\kappa, \mu)$, $F(\kappa, \mu)$, $G(\kappa, \mu)$,

$$\log F_N^{m,k+1}(a; \epsilon) - \log F_N^{m,k}(a; \epsilon) = \tilde{G}_2 N^{-\frac{1}{3}+2\eta} + \tilde{F}_{-1} N^{-\frac{1}{3}-\eta} + \mathcal{O}(N^{-1+3\eta} + N^{-\frac{2}{3}+\eta} + N^{-3\eta}), \quad (6.70)$$

as $N \rightarrow \infty$. Comparing the latter with (6.69), we find the expression for \tilde{G}_2 in (6.68). Note that \tilde{F}_{-1} cannot be obtained by comparing (6.69) with (6.70), because η cannot be chosen in such a way that the \mathcal{O} -terms in both (6.69) and (6.70) are simultaneously small. However, a long and tedious computation, which uses the explicit expressions of the constants $\tilde{z}_0^{(0)}$, $\tilde{z}_0^{(1/2)}$ from Proposition 6.2, shows that $\tilde{F}_{-1} = \frac{1}{8}$. \square

6.9 Proof of Theorem 1.4

We will now sum the result from Proposition 6.9 over k running from k_- to k_+ , where $k_-, k_+ \in [M+1, N(\kappa_2 - MN^{-2/3})] \cap \mathbb{N}$. We will explicitly evaluate the summation of the main terms, and estimate the summation of the error terms. The key will be to recognize the sums as Riemann sums of integrals. We record the following elementary lemma to estimate the difference between Riemann sums and integrals.

Lemma 6.12. *Let $k_- < k_+$ be integers and let $N \in \mathbb{N}$. Write*

$$\kappa_- = \frac{k_- - \frac{1}{2}}{N}, \quad \kappa_+ = \frac{k_+ + \frac{1}{2}}{N}. \quad (6.71)$$

Let h be C^4 on $[\kappa_-, \kappa_+]$. We have

$$\sum_{k=k_-}^{k_+} h(k/N) = N \int_{\kappa_-}^{\kappa_+} h(x) dx - \frac{1}{24N} (h'(\kappa_+) - h'(\kappa_-)) + \mathcal{O}(N^{-4} \Sigma_{h^{(4)}}), \quad N \rightarrow \infty,$$

where

$$\Sigma_f := \sum_{k=k_-}^{k_+} \max_{\kappa \in [k/N, (k+1)/N]} |f(\kappa)|.$$

Proof. Using a mid-point rule for the integrals of h and h'' , we obtain that

$$\begin{aligned} \int_{\kappa_-}^{\kappa_+} h(x) dx &= \frac{1}{N} \sum_{k=k_-}^{k_+} h(k/N) + \frac{1}{24N^3} \sum_{k=k_-}^{k_+} h''(k/N) + \mathcal{O}(N^{-5} \Sigma_{h^{(4)}}), \\ \int_{\kappa_-}^{\kappa_+} h''(x) dx &= \frac{1}{N} \sum_{k=k_-}^{k_+} h''(k/N) + \mathcal{O}(N^{-3} \Sigma_{h^{(4)}}), \end{aligned}$$

as $N \rightarrow \infty$. This implies that

$$\begin{aligned} \int_{\kappa_-}^{\kappa_+} h(x) dx &= \frac{1}{N} \sum_{k=k_-}^{k_+} h(k/N) + \frac{1}{24N^2} \int_{\kappa_-}^{\kappa_+} h''(x) dx + \mathcal{O}(N^{-5} \Sigma_{h^{(4)}}) \\ &= \frac{1}{N} \sum_{k=k_-}^{k_+} h(k/N) + \frac{1}{24N^2} (h'(\kappa_+) - h'(\kappa_-)) + \mathcal{O}(N^{-5} \Sigma_{h^{(4)}}). \end{aligned}$$

Consequently,

$$\sum_{k=k_-}^{k_+} h(k/N) = N \int_{\kappa_-}^{\kappa_+} h(x) dx - \frac{1}{24N} (h'(\kappa_+) - h'(\kappa_-)) + \mathcal{O}(N^{-4} \Sigma_{h^{(4)}}).$$

□

Lemma 6.13. *Let $M \in \mathbb{N}$ be fixed but sufficiently large, and let $\delta > 0$ be fixed. As $N \rightarrow +\infty$, we have*

$$\sum_{k=k_-}^{k_+} NG(\kappa = \frac{k}{N}, \mu) = N^2 \int_{\kappa_-}^{\kappa_+} G(\kappa, \mu) d\kappa - \frac{\partial_\kappa G(\kappa_+, \mu) - \partial_\kappa G(\kappa_-, \mu)}{24} + \mathcal{O}(\kappa_-^{-2} N^{-2}), \quad (6.72)$$

uniformly for $k_-, k_+ \in [M+1, \min\{N(\kappa_2 - MN^{-2/3}), N(\mu - \delta)\}] \cap \mathbb{N}$ and $\mu \in [\delta, 1 - \delta]$, and where κ_+, κ_- are as in (6.71). In particular, the following hold.

- *As $N \rightarrow +\infty$, we have*

$$\sum_{k=M+1}^{k_+} NG(\frac{k}{N}, \mu) = N^2 \int_0^{\kappa_+} G(\kappa, \mu) d\kappa - G_0 \left(M + \frac{1}{2} \right) N - \frac{6M^2 + 6M + 1}{12} \log \frac{2M+1}{2N}$$

$$-\frac{\partial_\kappa G(\kappa_+, \mu)}{24} + \frac{5}{48} - \frac{G_1}{12} + \frac{1}{4} (M^2 + M) (1 - 2G_1) + \mathcal{O}\left(\frac{1}{M^2} + \frac{M^3}{N}\right), \quad (6.73)$$

uniformly for $k_+ \in [M+1, \min\{N(\kappa_2 - MN^{-2/3}), N(\mu - \delta)\}] \cap \mathbb{N}$ and $\mu \in [\delta, 1 - \delta]$.

- Let $k_+ = \lfloor N(\kappa_2 - \frac{M}{N^{2/3}}) \rfloor$. As $N \rightarrow +\infty$, we have

$$\sum_{k=k_-}^{k_+} NG(\frac{k}{N}, \mu) = N^2 \int_{\kappa_-}^{\kappa_2} G(\kappa, \mu) d\kappa + \frac{\partial_\kappa G(\kappa_-, \mu)}{24} - \frac{\tilde{G}_2}{3} M^3 + \mathcal{O}\left(\frac{1}{\kappa_-^2 N^2} + \frac{M^2}{N^{1/3}}\right). \quad (6.74)$$

uniformly for $k_- \in [M+1, N(\kappa_2 - MN^{-2/3})] \cap \mathbb{N}$ and for $\mu \in [\delta, 1 - \delta] \setminus (\frac{a^2}{1+a^2} - \delta, \frac{a^2}{1+a^2} + \delta)$.

Proof. The result (6.72) follows from Lemma 6.12 applied to the function $h(\kappa) = G(\kappa, \mu)$ and from the estimates for $\partial_\kappa^4 G(\kappa, \mu)$ obtained in Propositions 6.10 and 6.11.

To derive (6.73), we again use Proposition 6.10, with $k_- = M+1$. We use it to obtain

$$\begin{aligned} \sum_{k=k_-}^{k_+} NG(\frac{k}{N}, \mu) &= N^2 \int_{\kappa_-}^{\kappa_+} G(\kappa, \mu) d\kappa - \frac{\partial_\kappa G(\kappa_+, \mu) - \partial_\kappa G(\kappa_-, \mu)}{24} + \mathcal{O}(M^{-2}) \\ &= N^2 \int_0^{\kappa_+} G(\kappa, \mu) d\kappa - N^2 \int_0^{\kappa_-} G(\kappa, \mu) d\kappa + \frac{1}{24} \left(-\partial_\kappa G(\kappa_+, \mu) + \log \frac{2M+1}{2N} + 1 + G_1 \right) + \mathcal{O}(M^{-2}), \end{aligned}$$

which yields the result after a straightforward computation. We obtain (6.74) similarly using Proposition 6.11. \square

Lemma 6.14. Let $M \in \mathbb{N}$ be fixed but sufficiently large, and let $\delta > 0$ be fixed. As $N \rightarrow +\infty$, we have

$$\sum_{k=k_-}^{k_+} H(\kappa = \frac{k}{N}) = N \int_{\kappa_-}^{\kappa_+} H(\kappa, \mu) d\kappa + \mathcal{O}\left(\frac{1}{\kappa_- N}\right). \quad (6.75)$$

uniformly for $k_-, k_+ \in [M+1, \min\{N(\kappa_2 - MN^{-2/3}), N(\mu - \delta)\}] \cap \mathbb{N}$ and $\mu \in [\delta, 1 - \delta]$, and where κ_+, κ_- are as in (6.71). In particular, the following hold.

- As $N \rightarrow +\infty$, we have

$$\sum_{k=M+1}^{k_+} H(\kappa = \frac{k}{N}, \mu) = N \int_0^{\kappa_+} H(\kappa, \mu) d\kappa + \frac{2M+1}{4} \log \frac{2M+1}{2N} - \frac{2M+1}{4} (2H_0 + 1) + \mathcal{O}\left(\frac{1}{M} + \frac{M^2}{N}\right),$$

uniformly for $k_+ \in [M+1, \min\{N(\kappa_2 - MN^{-2/3}), N(\mu - \delta)\}] \cap \mathbb{N}$ and $\mu \in [\delta, 1 - \delta]$.

- Let $k_+ = \lfloor N(\kappa_2 - \frac{M}{N^{2/3}}) \rfloor$. As $N \rightarrow +\infty$, we have

$$\sum_{k=k_-}^{k_+} H(\kappa = \frac{k}{N}, \mu) = N \int_{\kappa_-}^{\kappa_2} H(\kappa, \mu) d\kappa + \mathcal{O}\left(\frac{1}{\kappa_- N} + \frac{M^2}{N^{1/3}}\right)$$

uniformly for $k_- \in [M+1, N(\kappa_2 - MN^{-2/3})] \cap \mathbb{N}$ and for $\mu \in [\delta, 1 - \delta] \setminus (\frac{a^2}{1+a^2} - \delta, \frac{a^2}{1+a^2} + \delta)$.

Proof. Similarly as in the proof of Lemma 6.13, we apply Lemma 6.12, but now with $h(\kappa) = H(\kappa, \mu)$. To estimate the error term, we use the bounds for $\partial_\kappa H(\kappa, \mu)$ and $\partial_\kappa^4 H(\kappa, \mu)$ from Propositions 6.10 and 6.11. The two special cases are obtained in a similar way as in the proof of Lemma 6.13, using Propositions 6.10 and 6.11. \square

Lemma 6.15. *Let $M \in \mathbb{N}$ be fixed but sufficiently large, and let $\delta > 0$ be fixed. As $N \rightarrow +\infty$, we have*

$$\frac{1}{N} \sum_{k=k_-}^{k_+} F\left(\frac{k}{N}, \mu\right) = \int_{\kappa_-}^{\kappa_+} F(\kappa, \mu) d\kappa + \mathcal{O}\left(\frac{1}{N^2 \kappa_-^2} + \frac{1}{N^2 (\kappa_2 - \kappa_+)^2}\right).$$

uniformly for $k_-, k_+ \in [M+1, \min\{N(\kappa_2 - MN^{-2/3}), N(\mu - \delta)\}] \cap \mathbb{N}$ and $\mu \in [\delta, 1 - \delta]$, and where κ_+, κ_- are as in (6.71). In particular, the following hold.

- *As $N \rightarrow +\infty$, we have*

$$\begin{aligned} \frac{1}{N} \sum_{k=M+1}^{k_+} F\left(\frac{k}{N}, \mu\right) &= -\frac{1}{12} \log \frac{2M+1}{2N} + \int_0^{\kappa_+} \left(F(\kappa, \mu) - \frac{1}{12\kappa}\right) d\kappa \\ &\quad + \frac{1}{12} \log \kappa_+ + \mathcal{O}\left(\frac{1}{M^2} + \frac{M}{N}\right), \end{aligned}$$

uniformly for $k_+ \in [M+1, \min\{N(\kappa_2 - MN^{-2/3}), N(\mu - \delta)\}] \cap \mathbb{N}$ and $\mu \in [\delta, 1 - \delta]$.

- *Let $k_+ = \lfloor N(\kappa_2 - \frac{M}{N^{2/3}}) \rfloor$. As $N \rightarrow +\infty$, we have*

$$\begin{aligned} \frac{1}{N} \sum_{k=k_-}^{k_+} F\left(\frac{k}{N}, \mu\right) &= \frac{1}{12} \log N - \frac{1}{8} \log M + \frac{1}{8} \log(\kappa_2 - \kappa_-) \\ &\quad + \int_{\kappa_-}^{\kappa_2} \left(F(\kappa, \mu) - \frac{1}{8} \frac{1}{\kappa_2 - \kappa}\right) d\kappa + \mathcal{O}\left(\frac{1}{N^2 \kappa_-^2} + \frac{1}{MN^{1/3}}\right), \end{aligned}$$

uniformly for $k_- \in [M+1, N(\kappa_2 - MN^{-2/3})] \cap \mathbb{N}$ and for $\mu \in [\delta, 1 - \delta] \setminus (\frac{a^2}{1+a^2} - \delta, \frac{a^2}{1+a^2} + \delta)$.

Proof. The proof is again a straightforward application of Lemma 6.12, now with $h(\kappa) = F(\kappa, \mu)$. \square

Now we are going back to Proposition 6.9 and sum that result from $k = M+1$ to k_+ : this yields

$$\begin{aligned} \log F_N^{m, k_+ + 1} &= \log F_N^{m, M+1} + N \sum_{k=M+1}^{k_+} G\left(\frac{k}{N}, \mu\right) + \sum_{k=M+1}^{k_+} H\left(\frac{k}{N}, \mu\right) + \frac{1}{N} \sum_{k=M+1}^{k_+} F\left(\frac{k}{N}, \mu\right) \\ &\quad + \mathcal{O}(M^{-1} + N^{-1}(\kappa_2 - \kappa_+)^{-2}) \end{aligned}$$

as $N \rightarrow \infty$ for M large, where κ_+ is as in (6.71). Then we substitute the results from Lemmas 6.13–6.15 as well as the expressions for G_0, G_1, H_0 from Proposition 6.10 and obtain as $N \rightarrow +\infty$,

$$\begin{aligned} \log F_N^{m, k_+ + 1} &= \log F_N^{m, M+1} + A_2(\kappa_+, \mu) N^2 + A_1(\kappa_+, \mu) N + \left(\frac{M^2}{2} - \frac{1}{12}\right) \log N + A_0(\kappa_+, \mu) \\ &\quad + \mathcal{O}\left(\frac{1}{M} + \frac{M^3}{N} + \frac{1}{N(\kappa_2 - \kappa_+)^2}\right), \end{aligned} \tag{6.76}$$

uniformly for $k_+ \in [M+1, \min\{N(\kappa_2 - MN^{-2/3}), N(\mu - \delta)\}] \cap \mathbb{N}$, where

$$A_2(\kappa_+, \mu) = \int_0^{\kappa_+} G(\kappa', \mu) d\kappa',$$

$$\begin{aligned}
A_1(\kappa_+, \mu) &= \int_0^{\kappa_+} H(\kappa', \mu) d\kappa' - (\tfrac{1}{2} + M)\varphi_0(x_0), \\
A_0(\kappa_+, \mu) &= \int_0^{\kappa_+} \left(F(\kappa', \mu) - \frac{1}{12\kappa'} \right) d\kappa' + \frac{1}{12} \log \kappa_+ + \frac{1-6M^2}{12} \log(M + \tfrac{1}{2}) - \frac{\partial_{\kappa_+} G(\kappa_+, \mu)}{24} \\
&\quad + \frac{M+3M^2}{4} - \frac{1}{16} + \frac{3M^2-1}{6} \log(|x_0|^2 \varphi_0''(x_0)) - \frac{\epsilon(1+2M)}{2} \log(1-ax_0).
\end{aligned}$$

Now we substitute the asymptotics of Theorem 1.1 for $\log F_N^{m, M+1}$ in (6.76). This yields

$$\log F_N^{m, \kappa_++1} = C_2(\kappa_+, \mu)N^2 + C_1(\kappa_+, \mu)N - \frac{1}{12} \log N + \widehat{C}_0(\kappa_+, \mu) + \mathcal{O}\left(\frac{1}{M} + \frac{M^3}{N} + \frac{1}{N(\kappa_2 - \kappa_+)^2}\right),$$

with

$$\begin{aligned}
C_2(\kappa_+, \mu) &= A_2(\kappa_+, \mu) + F_2(\mu), \\
C_1(\kappa_+, \mu) &= A_1(\kappa_+, \mu) + F_1(M, \mu), \\
\widehat{C}_0(\kappa_+, \mu) &= A_0(\kappa_+, \mu) + F_0(M, \mu)
\end{aligned}$$

In other words,

$$C_2(\kappa_+, \mu) = \left(\frac{1}{2} - \mu + \mu^2\right) \log(1+a^2) + \int_0^{\kappa_+} G(\kappa', \mu) d\kappa', \quad (6.77)$$

$$C_1(\kappa_+, \mu) = \int_0^{\kappa_+} H(\kappa', \mu) d\kappa' - \frac{1}{2} \varphi_0(x_0) + \left(\frac{1}{2} - \epsilon\mu\right) \log(1+a^2), \quad (6.78)$$

$$\begin{aligned}
\widehat{C}_0(\kappa_+, \mu) &= \int_0^{\kappa_+} \left(F(\kappa', \mu) - \frac{1}{12\kappa'} \right) d\kappa' + \frac{1}{12} \log \kappa_+ + \frac{1-6M^2}{12} \log(M + \tfrac{1}{2}) - \frac{\partial_{\kappa_+} G(\kappa_+, \mu)}{24} \\
&\quad - \frac{M}{2} \log(2\pi) + \frac{-1+4M+12M^2}{16} - \frac{1}{6} \log(|x_0|^2 \varphi_0''(x_0)) - \frac{\epsilon}{2} \log(1-ax_0) + \log \mathcal{G}(M+1).
\end{aligned} \quad (6.79)$$

Here we observe that the asymptotics (1.16) of $\log \mathcal{G}(M+1)$ as $M \rightarrow \infty$ imply that

$$\log \mathcal{G}(M+1) + \frac{1-6M^2}{12} \log(M + \tfrac{1}{2}) - \frac{M}{2} \log(2\pi) + \frac{-1+4M+12M^2}{16} = \zeta'(-1) + \mathcal{O}(1/M).$$

This implies that we can set

$$\begin{aligned}
C_0(\kappa_+, \mu) &= \int_0^{\kappa_+} \left(F(\kappa', \mu) - \frac{1}{12\kappa'} \right) d\kappa' + \frac{1}{12} \log \kappa_+ - \frac{\partial_{\kappa_+} G(\kappa_+, \mu)}{24} \\
&\quad - \frac{1}{6} \log(|x_0|^2 \varphi_0''(x_0)) - \frac{\epsilon}{2} \log(1-ax_0) + \zeta'(-1),
\end{aligned} \quad (6.80)$$

and obtain

$$\log F_N^{m, \kappa_++1} = C_2(\kappa_+, \mu)N^2 + C_1(\kappa_+, \mu)N - \frac{1}{12} \log N + C_0(\kappa_+, \mu) + \mathcal{O}\left(\frac{1}{M} + \frac{M^3}{N} + \frac{1}{N(\kappa_2 - \kappa_+)^2}\right). \quad (6.81)$$

Since we can choose M arbitrarily large, the error term is

$$o(1) + \mathcal{O}\left(\frac{1}{N(\kappa_2 - \kappa_+)^2}\right),$$

which finishes the proof of (1.14). By Proposition 6.10, we obtain the $\kappa_+ \rightarrow 0$ asymptotics (1.15). This completes the proof of Theorem 1.4.

6.10 Consistency check and proof of (1.21)

Alternatively, we can obtain asymptotics by summing the result of Proposition 6.9 from $k_- = k + 1$ to a value $k_+ = k_+(N)$ defined by

$$k_+ + 1 = N \left(\kappa_2 - \frac{M_N}{N^{2/3}} \right),$$

for some M_N satisfying $\lim_{N \rightarrow \infty} M_N = +\infty$, and which we will determine later. By Proposition 6.9, we get

$$\begin{aligned} \log F_N^{m,k+1} &= \log F_N^{m,k_++1} - N \sum_{j=k+1}^{k_+} G\left(\frac{j}{N}, \mu\right) - \sum_{j=k+1}^{k_+} H\left(\frac{j}{N}, \mu\right) \\ &\quad - \frac{1}{N} \sum_{j=k+1}^{k_+} F\left(\frac{j}{N}, \mu\right) + \mathcal{O}\left(M_N^{-2} N^{1/3}\right) + \mathcal{O}\left(k^{-1}\right) \end{aligned} \quad (6.82)$$

as $N \rightarrow \infty$, uniformly for $k \in [M+1, N(\kappa_2 - \delta)] \cap \mathbb{N}$ and for $\mu \in [\delta, 1 - \delta] \setminus (\frac{a^2}{1+a^2} - \delta, \frac{a^2}{1+a^2} + \delta)$, for some fixed $\delta > 0$ and some fixed but large $M > 0$.

Let $\kappa_- = \frac{k_- - \frac{1}{2}}{N} = \frac{k + \frac{1}{2}}{N}$. Now we use again Lemmas 6.13–6.15 to obtain

$$\begin{aligned} \log F_N^{m,k+1} &= \log F_N^{m,k_++1} - N^2 \int_{\kappa_-}^{\kappa_2} G(\kappa, \mu) d\kappa - N \int_{\kappa_-}^{\kappa_2} H(\kappa, \mu) d\kappa - \int_{\kappa_-}^{\kappa_2} \left(F(\kappa, \mu) - \frac{1}{8} \frac{1}{\kappa_2 - \kappa} \right) d\kappa \\ &\quad - \frac{\partial_\kappa G(\kappa_-, \mu)}{24} + \frac{\tilde{G}_2}{3} M_N^3 - \frac{1}{12} \log N + \frac{1}{8} \log \frac{M_N}{\kappa_2 - \kappa_-} + \mathcal{O}\left(M_N^2 N^{-1/3} + M_N^{-2} N^{1/3} + k^{-1}\right). \end{aligned}$$

Substituting the Tracy-Widom asymptotics (1.20), we obtain

$$\begin{aligned} \log F_N^{m,k+1} &= \frac{N^2}{2} \log(1 + a^2) - N^2 \int_{\kappa_-}^{\kappa_2} G(\kappa, \mu) d\kappa + \frac{N}{2} \log(1 + a^2) - N \int_{\kappa_-}^{\kappa_2} H(\kappa, \mu) d\kappa \\ &\quad - \int_{\kappa_-}^{\kappa_2} \left(F(\kappa, \mu) - \frac{1}{8} \frac{1}{\kappa_2 - \kappa} \right) d\kappa - \frac{M_N^3}{12c^*} - \frac{1}{8} \log M_N + \frac{1}{24} \log(2c^*) + \zeta'(-1) - \frac{\partial_\kappa G(\kappa_-, \mu)}{24} \\ &\quad + \frac{\tilde{G}_2}{3} M_N^3 - \frac{1}{12} \log N + \frac{1}{8} \log \frac{M_N}{\kappa_2 - \kappa_-} + \mathcal{O}\left(M_N^2 N^{-1/3} + M_N^{-2} N^{1/3} + k^{-1}\right). \end{aligned}$$

Here one should note that we need $M_N^2 = o(N^{1/15})$ as $N \rightarrow \infty$ in order to apply (1.20). Let us set $M_N = N^{\frac{1}{15} - \frac{\eta}{2}}$ for a sufficiently small $\eta > 0$. We obtain

$$\log F_N^{m,k+1} = N^2 B_2(\kappa_-, \mu) + N B_1(\kappa_-, \mu) + \mathcal{O}(N^{\frac{1}{5} + \eta} + k^{-1}), \quad (6.83)$$

where

$$B_1(\kappa_-, \mu) = \frac{1}{2} \log(1 + a^2) - \int_{\kappa_-}^{\kappa_2} G(\kappa, \mu) d\kappa, \quad (6.84)$$

$$B_2(\kappa_-, \mu) = \frac{1}{2} \log(1 + a^2) - \int_{\kappa_-}^{\kappa_2} H(\kappa, \mu) d\kappa. \quad (6.85)$$

Comparing this with (6.81), we see that $B_1(\kappa, \mu) = C_1(\kappa, \mu)$ and that $B_2(\kappa, \mu) = C_2(\kappa, \mu)$. In other words, we have the integral identities

$$\int_0^{\kappa_2} G(\kappa, \mu) d\kappa = \mu(1 - \mu) \log(1 + a^2), \quad (6.86a)$$

$$\int_0^{\kappa_2} H(\kappa, \mu) d\kappa = \frac{\varphi_0(x_0)}{2} + \epsilon \mu \log(1 + a^2). \quad (6.86b)$$

We can now substitute the results from Proposition 6.11 in (6.84)–(6.85) to obtain (1.21).

Remark 6.16. *Both identities (6.86) have been verified numerically. In fact, we even verified numerically that*

$$\begin{aligned} \int_0^{\kappa_2} \left(F(\kappa', \mu) - \frac{1}{12\kappa'} - \frac{1}{8} \frac{1}{\kappa_2 - \kappa'} \right) d\kappa' = & -\frac{5}{24} \log \kappa_2 + \frac{1}{6} \log(|x_0|^2 \varphi_0''(x_0)) \\ & + \frac{\epsilon}{2} \log(1 - ax_0) + \frac{1}{24} \log(2c^*). \end{aligned}$$

We can however not prove this because the error term in (6.83) is bigger than $\mathcal{O}(1)$.
