# THE MASCHKE OCTIC CONTAINS 96 PAIRWISE DISJOINT LINES

**Abstract.** — Miyaoka proved that a smooth surface of degree  $d$  in  $\mathbf{P}^3(\mathbb{C})$  contains at most  $2d(d-2)$  pairwise disjoint lines. In this note, we verify that the Maschke octic contains 96 pairwise disjoint lines, thereby proving that Miyaoka's bound is optimal for  $d = 8$ .

Let  $i$  be a square root of  $-1$  in the field  $\mathbb{C}$  of complex numbers. For better readability, we use dots to represent zeroes in sparse matrices (as is standard for character tables of finite groups). Let

$$s_1 = \begin{pmatrix} \cdot & 1 & \cdot & \cdot \\ 1 & \cdot & \cdot & \cdot \\ \cdot & \cdot & 1 & \cdot \\ \cdot & \cdot & \cdot & 1 \end{pmatrix}, \quad s_2 = \begin{pmatrix} 1 & \cdot & \cdot & \cdot \\ \cdot & \cdot & 1 & \cdot \\ \cdot & 1 & \cdot & \cdot \\ \cdot & \cdot & \cdot & 1 \end{pmatrix}, \quad s_3 = \begin{pmatrix} \cdot & -i & \cdot & \cdot \\ i & \cdot & \cdot & \cdot \\ \cdot & \cdot & 1 & \cdot \\ \cdot & \cdot & \cdot & 1 \end{pmatrix},$$

$$s_4 = \frac{1}{2} \begin{pmatrix} 1 & -1 & -1 & -1 \\ -1 & 1 & -1 & -1 \\ -1 & -1 & 1 & -1 \\ -1 & -1 & -1 & 1 \end{pmatrix} \quad \text{and} \quad s_5 = \begin{pmatrix} -1 & \cdot & \cdot & \cdot \\ \cdot & 1 & \cdot & \cdot \\ \cdot & \cdot & 1 & \cdot \\ \cdot & \cdot & \cdot & 1 \end{pmatrix}$$

be elements of  $\mathbf{GL}_4(\mathbb{C})$ . Then  $s_1, s_2, s_3, s_4$  and  $s_5$  are reflections of order 2: they generate a subgroup of  $\mathbf{GL}_4(\mathbb{C})$  which we denote by  $G_{31}$ . It is well-known that  $G_{31}$  is finite and is the group denoted by  $G_{31}$  in Shephard-Todd classification of finite complex reflection groups [ShTo]. For its natural action on  $V = \mathbb{C}^4$ , it is irreducible and primitive.

We denote by  $(x, y, z, t)$  the dual basis of the canonical basis of  $V$ : the algebra  $\mathbb{C}[V]$  of polynomial functions on  $V$  is the polynomial algebra  $\mathbb{C}[x, y, z, t]$ . If  $m$  is a monomial in  $x, y, z$  and  $t$ , we denote by  $\Sigma_4(m)$  the sum of all the monomials obtained from  $m$  by permutation of these four variables. For instance,

$$\Sigma_4(xy) = xy + xz + xt + yz + yt + zt \quad \text{and} \quad \Sigma_4(xyz t) = xyz t.$$

We set

$$f = \Sigma_4(x^8) + 14 \Sigma_4(x^4 y^4) + 168 x^2 y^2 z^2 t^2.$$

Then,  $f$  is, up to a scalar, the unique invariant polynomial of  $G_{31}$  of degree 8. We denote by  $\mathcal{M}$  the surface in  $\mathbf{P}(V) = \mathbf{P}^3(\mathbb{C})$  defined as the zero locus of  $f$ . It is straightforward to verify with MAGMA [Mag] that  $\mathcal{M}$  is smooth, which implies that the polynomial  $f$  and the surface  $\mathcal{M}$  are irreducible. The surface  $\mathcal{M}$  is called the *Maschke octic*.

It was proved by Boissière and Sarti that  $\mathcal{M}$  contains 352 lines [BoiSa, Theo 3.1]. It was checked by Sarti and the author [BonSa, §6.5] that these 352 lines are divided into two  $G_{31}$ -orbits  $\Omega_{160}$  and  $\Omega_{192}$  of respective cardinality 160 and 192. More precisely, let  $L_{160}$  and  $L_{192}$  denote the lines in  $\mathbf{P}^3(\mathbb{C})$  defined by

$$L_{160} : \begin{cases} 2x + (i+1)(\sqrt{3}+1)y = 0, \\ 2z + (i+1)(\sqrt{3}+1)t = 0 \end{cases} \quad \text{and} \quad L_{192} : \begin{cases} (i+1)(\sqrt{5}+1)x - 2(y+z) = 0, \\ 2(y-z) + (i-1)(\sqrt{5}+1)t = 0. \end{cases}$$

Here,  $\sqrt{n}$  denotes a square root of  $n$  (for  $n \in \{3, 5\}$ ). Then  $L_{160}$  and  $L_{192}$  are contained in  $\mathcal{M}$  and  $\Omega_k$  is the orbit of  $L_k$  (for  $k \in \{160, 192\}$ ). A computer calculation with MAGMA allows to check easily the main result of this note:

**Theorem.** *The orbit  $\Omega_{192}$  contains a family of 96 pairwise disjoint lines.*

*Proof.* — Let us give a few details about how this computation is made and some precision on the statement (again, everything is checked with MAGMA). First, let

$$a = \frac{1-i}{2} \begin{pmatrix} 1 & . & . & 1 \\ . & 1 & 1 & . \\ . & -1 & 1 & . \\ 1 & . & . & -1 \end{pmatrix} \quad \text{and} \quad b = \begin{pmatrix} . & . & -1 & . \\ -1 & . & . & . \\ . & 1 & . & . \\ . & . & . & 1 \end{pmatrix}.$$

Then  $a, b \in G_{31}$ . Let  $G = \langle a, b \rangle$  and let  $\Omega$  denote the  $G$ -orbit of the line  $L_{192}$ . Then  $|G| = 1152$  and  $|\Omega| = 96$ . One can then check that, if  $L, L' \in \Omega$  are such that  $L \neq L'$ , then  $L \cap L' = \emptyset$ . This shows that one can choose for the family of 96 pairwise distinct lines in  $\Omega_{192}$  the orbit of  $L_{192}$  under the action of  $G$ .  $\square$

*Remarks.* For  $d \geq 5$ , it is known that there exists a smooth surface of degree  $d$  in  $\mathbf{P}^3(\mathbb{C})$  containing  $d(d-2) + 2$  pairwise disjoint lines [Ram2]<sup>(1)</sup>. For  $d = 8$ , this gives a smooth octic surface with 50 pairwise disjoint lines: the above theorem improves drastically this record.

On the other hand, Miyaoka [Miy, §2.2] proved that a smooth surface of degree  $d \geq 3$  in  $\mathbf{P}^3(\mathbb{C})$  contains at most  $2d(d-2)$  pairwise disjoint lines. The above theorem shows that Miyaoka's bound is optimal for  $d = 8$ .

*Questions.* (1) Miyaoka's bound is optimal for  $d \in \{2, 3, 4, 8\}$ . Is it optimal for all  $d$ ?

(2) Is the Maschke octic the unique octic surface of  $\mathbf{P}^3(\mathbb{C})$  (up to the action of  $\mathbf{GL}_4(\mathbb{C})$ ) containing 96 pairwise disjoint lines?
