

Periodic Regularized Q-Learning

Abstract

In reinforcement learning (RL), Q-learning is a fundamental algorithm whose convergence is guaranteed in the tabular setting. However, this convergence guarantee does not hold under linear function approximation. To overcome this limitation, a significant line of research has introduced regularization techniques to ensure stable convergence under function approximation. In this work, we propose a new algorithm, periodic regularized Q-learning (PRQ). We first introduce regularization at the level of the projection operator and explicitly construct a regularized projected value iteration (RP-VI), subsequently extending it to a sample-based RL algorithm. By appropriately regularizing the projection operator, the resulting projected value iteration becomes a contraction. By extending this regularized projection into the stochastic setting, we establish the PRQ algorithm and provide a rigorous theoretical analysis that proves finite-time convergence guarantees for PRQ under linear function approximation.

1. Introduction

Recent advances in deep reinforcement learning (deep RL) have achieved remarkable empirical success across a wide range of domains, including board games such as Go (Silver et al., 2017) and video games such as Atari (Mnih et al., 2013). At the foundation of these achievements lies one of the most fundamental algorithms in reinforcement learning (RL), known as Q-learning (Watkins & Dayan, 1992). Despite its simplicity and broad applicability, the theoretical understanding of the convergence properties of Q-learning is still incomplete. The tabular version of Q-learning is known to converge under standard assumptions, but when combined with function approximation, the algorithm can exhibit instability. This phenomenon is commonly attributed to the so-called deadly triad of off-policy learning, bootstrap-

ping, and function approximation (Sutton et al., 1998). Such instability appears even in the relatively simple case of linear function approximation. To address these challenges, a substantial body of research has sought to identify sufficient conditions for convergence (Melo & Ribeiro, 2007; Melo et al., 2008; Yang & Wang, 2019; Lee & He, 2020b; Chen et al., 2022; Lim & Lee, 2025) or to design regularized or constrained variants of Q-learning that promote stable learning dynamics (Gallici et al., 2025; Lim & Lee, 2024; Maei et al., 2010; Zhang et al., 2021; Lu et al., 2021; Devraj & Meyn, 2017). Among these approaches, our focus lies on regularization in Q-learning, where a properly designed regularizer facilitates convergence and stabilizes the iterative learning process. However, we hypothesize that regularization alone is insufficient for stable convergence in Q-learning. Introducing periodic parameter updates, which separate the update rule into an inner convex optimization and an outer Bellman update, is the key structure to stabilize learning and successfully converge to the desired solution. Building on this perspective, we propose a new framework that introduces the principles of periodic updates into the structure of a regularized method. We refer to this unified approach as *periodic regularized Q-learning* (PRQ). By incorporating a parameterized regularizer into the projection step, PRQ induces a contraction mapping in the projected Bellman operator. This property ensures both stable and provable convergence of the learning process.

1.1. Related works

Regularized methods and Bellman equation RL with function approximation frequently suffers from instability. A prominent approach to address this issue is to introduce regularization into the algorithm, a direction explored by several prior works. Regularization has been widely employed to stabilize temporal-difference (TD) learning (Sutton et al., 1998) and Q-learning, improving convergence under challenging conditions. Farahmand et al. (2016) studied a regularized policy iteration which solves a regularized policy evaluation problem and then takes a policy improvement step. The authors derived the performance loss and used a regularization coefficient which decreases as the number of samples used in the policy evaluation step increases. Bertsekas (2011) applied a regularized approach to solve a policy evaluation problem with singular feature matrices. Zhang

et al. (2021) studied convergence of Q-learning with a target network and a projection method. Lim & Lee (2024) studied convergence of Q-learning with regularization without using a target network or requiring projection onto a ball. Manek & Kolter (2022) studied fixed points of off-policy TD-learning algorithms with regularization, showing that error bounds can be large under certain ill-conditioned scenarios. Meanwhile, a different line of research (Geist et al., 2019) focuses on regularization on the policy parametrization.

Target-based update In a broader sense, our periodic update mechanism can be viewed as a target-based approach, as it intentionally holds one set of parameters stationary while updating the other. This target-based paradigm was originally introduced in temporal-difference learning to improve stability and convergence, and has since been extended to Q-learning. Lee & He (2019) studied finite-time analysis of TD-learning, followed by Lee & He (2020a), who presented a non-asymptotic analysis under the tabular setup. Further research has addressed specific algorithmic modifications. For instance, Chen et al. (2023) examined truncation methods, while Che et al. (2024) explored the effects of overparameterization. Asadi et al. (2024) studied target network updates of TD-learning. Focusing on off-policy TD learning, Fellows et al. (2023) investigated a target network update mechanism combined with a regularization term that vanishes when the target parameters and the current iterate coincide, under the assumption of bounded variance. Finally, Wu et al. (2025) studied convergence of TD-learning and target-based TD learning from a matrix splitting perspective.

1.2. Contributions

Our main contributions are summarized as follows:

1. We formulate the regularized projected Bellman equation (RP-BE) and the associated regularized projected value iteration (RP-VI), and provide a convergence analysis of the resulting operator. Building on its convergence analysis, we develop PRQ, a fully model-free RL algorithm.
2. We develop a rigorous theoretical analysis of PRQ establishing finite-time convergence and sample-complexity bounds under both i.i.d. and Markovian observation models. Our results provide non-asymptotic convergence guarantees for Q-learning with linear function approximation using a single regularization mechanism. These guarantees hold in a broad range of settings without relying on truncation, projection, or strong local convexity assumptions (Zhang et al., 2021; Chen et al., 2023; Lim & Lee, 2024; Zhang et al., 2023).

3. We empirically demonstrate that the joint use of periodic target updates (Lee & He, 2020a) and regularization (Lim & Lee, 2024) is crucial for stable learning. In particular, we provide counterexamples showing that the algorithm can fail when either component is removed, while stable learning is achieved only when both mechanisms are employed.

2. Preliminaries and notations

Markov decision process A Markov decision process (MDP) consists of a 5-tuple $(\mathcal{S}, \mathcal{A}, \gamma, \mathcal{P}, r)$, where $\mathcal{S} := \{1, 2, \dots, |\mathcal{S}|\}$ and $\mathcal{A} := \{1, 2, \dots, |\mathcal{A}|\}$ are the finite sets of states and actions, respectively, and $\gamma \in (0, 1)$ is the discount factor. $\mathcal{P} : \mathcal{S} \times \mathcal{A} \rightarrow \Delta(\mathcal{S})$ is the Markov transition kernel, and $r : \mathcal{S} \times \mathcal{A} \times \mathcal{S} \rightarrow \mathbb{R}$ is the reward function. A policy $\pi : \mathcal{S} \rightarrow \Delta(\mathcal{A})$ defines a probability distribution over the action space for each state, and a deterministic policy $\pi : \mathcal{S} \rightarrow \mathcal{A}$ maps a state s to an action $a \in \mathcal{A}$. The set of deterministic policies is denoted as Ω . An agent at state s selects an action a following a policy π , transitions to the next state $s' \sim \mathcal{P}(\cdot | s, a)$, and receives a reward $r(s, a, s')$. The action-value function induced by policy π is the expected sum of discounted rewards following a policy π , i.e., $Q^\pi(s, a) = \mathbb{E}[\sum_{k=0}^{\infty} \gamma^k r(s_k, a_k, s_{k+1}) | (s_0, a_0) = (s, a)]$. The goal is to find a policy π that maximizes the overall sum of rewards $\pi^* := \arg \max_{\pi \in \Omega} \mathbb{E}[\sum_{k=0}^{\infty} \gamma^k r(s_k, a_k, s_{k+1}) | \pi]$. We denote the action-value function induced by π^* as $Q^* : \mathcal{S} \times \mathcal{A} \rightarrow \mathbb{R}$, and π^* can be recovered from Q^* by the greedy policy, i.e., $\pi^*(s) = \arg \max_{a \in \mathcal{A}} Q^*(s, a)$. Q^* can be obtained by solving the Bellman optimality equation: $Q^*(s, a) = \mathbb{E}[r(s, a, s') + \gamma \max_{u \in \mathcal{A}} Q^*(s', u) | s, a]$.

Notations Let us introduce some matrix notations used throughout the paper. $\mathbf{D} \in \mathbb{R}^{|\mathcal{S}||\mathcal{A}| \times |\mathcal{S}||\mathcal{A}|}$ is a diagonal matrix such that $[\mathbf{D}]_{(s-1)|\mathcal{A}|+a, (s-1)|\mathcal{A}|+a} = d(s, a)$ where d is a probability distribution over the state-action space, which will be clarified in a further section; $\mathbf{P} \in \mathbb{R}^{|\mathcal{S}||\mathcal{A}| \times |\mathcal{S}||\mathcal{A}|}$ is defined such that $[\mathbf{P}]_{(s-1)|\mathcal{A}|+a, s'} = \mathcal{P}(s' | s, a)$; and $\mathbf{R} \in \mathbb{R}^{|\mathcal{S}||\mathcal{A}|}$ is such that $[\mathbf{R}]_{(s-1)|\mathcal{A}|+a} = \mathbb{E}[r(s, a, s') | s, a]$. For a vector $\mathbf{Q} \in \mathbb{R}^{|\mathcal{S}||\mathcal{A}|}$, the greedy policy with respect to \mathbf{Q} , $\pi_{\mathbf{Q}} : \mathcal{S} \rightarrow \mathcal{A}$ is defined as $\pi(s) = \arg \max_{a \in \mathcal{A}} (\mathbf{e}_s \otimes \mathbf{e}_a)^\top \mathbf{Q}$ where $\mathbf{e}_s \in \mathbb{R}^{|\mathcal{S}|}$ and $\mathbf{e}_a \in \mathbb{R}^{|\mathcal{A}|}$ are unit vectors whose s -th and a -th elements are one, while all others are zero, respectively. \otimes denotes the Kronecker product. Moreover, we denote a policy defined by a deterministic policy $\pi \in \Omega$ as a matrix notation $\mathbf{\Pi}_\pi \in \mathbb{R}^{|\mathcal{S}| \times |\mathcal{S}||\mathcal{A}|}$ such that the s -th row vector is $(\mathbf{e}_s \otimes \mathbf{e}_{\pi(s)})^\top$ for $s \in \mathcal{S}$. For simplicity, we denote $\mathbf{\Pi}_{\mathbf{Q}} := \mathbf{\Pi}_{\pi_{\mathbf{Q}}}$. A linear parametrization is used to represent an action-value function induced by a policy π , $Q^\pi(s, a) \approx \phi^\top(s, a)\boldsymbol{\theta}$ given a feature map $\phi : \mathcal{S} \times \mathcal{A} \rightarrow \mathbb{R}^h$. $\boldsymbol{\theta}$ is the learnable parameter and h is the feature dimension. We denote by $\boldsymbol{\Phi} \in \mathbb{R}^{|\mathcal{S}||\mathcal{A}| \times h}$

the feature matrix, where the row indexed by $(s-1)|\mathcal{A}|+a$ corresponds to $\phi(s, a)^\top$. Throughout the paper, let us adopt the following standard assumption on the feature matrix:

Assumption 2.1. $\Phi \in \mathbb{R}^{|\mathcal{S}||\mathcal{A}|\times h}$ is a full-column rank matrix and $\|\Phi\|_\infty \leq 1$.

2.1. Projected Bellman equation

The Bellman operator $\mathcal{T}Q = R + \gamma P\Pi_Q Q$ is a non-linear operator that may yield a vector outside the image of $\Phi \in \mathbb{R}^{|\mathcal{S}||\mathcal{A}|\times h}$. Therefore, a composition of the Bellman operator and the weighted Euclidean projection is often used, yielding the following equation

$$\Gamma\mathcal{T}\Phi\theta = \Phi\theta \quad (1)$$

where $\Gamma := \Phi(\Phi^\top D\Phi)^{-1}\Phi^\top D$ is the weighted Euclidean projection operator. This equation is called the projected Bellman equation (P-BE). To find the solution of the above equation (we defer the discussion of existence and uniqueness of the solution to a later section), we consider minimizing the following objective function:

$$f(\theta) = \frac{1}{2} \|\Gamma(R + \gamma P\Pi_{\Phi\theta}\Phi\theta) - \Phi\theta\|_D^2. \quad (2)$$

Since the max operator Π introduces nonsmoothness, the function f is non-differentiable at certain points. Therefore, to find the minimizer of $f(\theta)$, we investigate the Clarke subdifferential (Clarke, 1981) of the above objective, which satisfies

$$\partial f(\theta) \subseteq \text{conv}\{(\gamma P\Pi_\beta\Phi - \Phi)^\top D\Gamma(\mathcal{T}\Phi\theta - \Phi\theta) \mid \beta \in \Lambda(\theta)\}$$

where $\Lambda(\theta) := \{\pi \in \Omega : \pi(s) \in \arg \max_{a \in \mathcal{A}} \phi(s, a)^\top \theta\}$ and $\text{conv}(A)$ for a set A denotes the convex hull of the set A . The detailed derivation is deferred to Lemma C.5 in the Appendix. A necessary condition for some point $\theta \in \mathbb{R}^h$ to be a minimizer of f is

$$0 \in \partial f(\theta).$$

Such a point θ is called a (Clarke) stationary point (Clarke, 1981). At a stationary point θ , there exists some policy β such that

$$(\gamma P\Pi_\beta\Phi - \Phi)^\top D\Gamma(\mathcal{T}\Phi\theta - \Phi\theta) = 0$$

or equivalently

$$\begin{aligned} & \Phi^\top (\gamma P\Pi_\beta - I)^\top D\Phi\theta \\ &= \Phi^\top (\gamma P\Pi_\beta - I)^\top D\Gamma(R + \gamma P\Pi_{\Phi\theta}\Phi\theta). \end{aligned}$$

Assuming that $\Phi^\top (\gamma P\Pi_\beta - I)^\top D\Phi$ is invertible, we obtain the P-BE in (1). Since a stationary point always exists, a solution to the P-BE also exists, under the assumption that

$\Phi^\top (\gamma P\Pi_\beta - I)^\top D\Phi$ is invertible at the stationary point. It will admit a unique solution if $\Gamma\mathcal{T}$ is a contraction. This P-BE can be equivalently written as

$$\Phi^\top DR + \gamma \Phi^\top DP\Pi_{\Phi\theta}\Phi\theta = (\Phi^\top D\Phi)\theta. \quad (3)$$

Despite its simple appearance, the P-BE is not guaranteed to have a unique solution, and in some cases may not admit any solution at all (De Farias & Van Roy, 2000; Meyn, 2024). If the P-BE does not admit a fixed point, this means that, at any stationary point θ, β satisfying $0 \in \partial f(\theta)$ fails to make $\Phi^\top (\gamma P\Pi_\beta - I)^\top D\Phi$ invertible. Moreover, if $D = I$, then $\Phi^\top (\gamma P\Pi_\beta - I)^\top D\Phi$ is always invertible, and hence, the fixed point of the P-BE always exists even if $\Gamma\mathcal{T}$ is not a contraction. There may exist multiple fixed points of the P-BE.

In summary, if we can find a stationary point of (2), then we obtain a solution to the P-BE, which is referred to as the Bellman residual method (Baird et al., 1995). However, directly optimizing (2) is challenging because (2) is a nonconvex and nondifferentiable function; hence, one typically has to resort to subdifferential-based methods (Clarke, 1981), which are often not computationally efficient. Moreover, when extending to model-free RL, a double-sampling issue (Baird et al., 1995) arises. For these reasons, one often instead considers dynamic programming approaches (Bertsekas, 2012) such as value iteration. For instance, we can consider the following projected value iteration (P-VI):

$$\Phi\theta_{k+1} = \Gamma\mathcal{T}\Phi\theta_k \quad (4)$$

which however is not guaranteed to converge unless $\Gamma\mathcal{T}$ is a contraction. To mitigate these issues, in the next section we introduce RP-VI, which incorporates an additional regularization term.

3. Regularized projection operator




Figure 1. Illustration of the regularized projection. With a proper choice of η , $\Gamma_\eta \mathcal{T}x$ and $\Gamma_\eta \mathcal{T}y$ will be close to the origin and $\|\Gamma_\eta \mathcal{T}(x - y)\|_2 \leq \|\Gamma \mathcal{T}(x - y)\|_2$.

Let us begin with the standard P-VI in (4). P-VI can be equivalently written as the following optimization problem:

$$\theta_{k+1} = \arg \min_{\theta \in \mathbb{R}^h} L(\theta, \theta_k) := \frac{1}{2} \|\Gamma\mathcal{T}\Phi\theta_k - \Phi\theta\|_D^2. \quad (5)$$

As mentioned before, this P-VI does not guarantee convergence unless $\Gamma\mathcal{T}$ is a contraction. To address the potential ill-posedness of solving (2) and the projected Bellman equation (P-BE), we introduce an additional parameter vector θ' (called target parameter) to approximate the next state-action value and a regularized formulation. In particular, we modify the objective function in (5) as follows:

$$L_\eta(\theta, \theta') = \frac{1}{2} \|\Gamma(R + \gamma P \Pi_{\Phi\theta'} \Phi\theta) - \Phi\theta\|_D^2 + \frac{\eta}{2} \|\theta\|_2^2 \quad (6)$$

where $\eta \in [0, \infty)$ is a non-negative constant. The objective in (6) differs from the original formulation in (2) in two key aspects. First, we separate the parameters for estimating the next state-action value and the current state-action value. Optimizing with respect to θ and considering θ' as a fixed parameter, we can avoid the problem of non-differentiability from the max-operator in the original formulation in (2). Second, a quadratic regularization term is incorporated to ensure the contraction property of the regularized projection operator, thereby facilitating the convergence.

By taking the derivative of $L_\eta(\theta, \theta')$ with respect to θ , and using the first-order optimality condition for convex functions, we find that the minimizer of (6) satisfies

$$\Phi^\top D R + \gamma \Phi^\top D P \Pi_{\Phi\theta'} \Phi\theta = (\Phi^\top D \Phi + \eta I) \theta \quad (7)$$

Equivalently, multiplying both sides by $\Phi(\Phi^\top D \Phi + \eta I)^{-1}$ yields

$$\begin{aligned} \Phi\theta &= \underbrace{\Phi(\Phi^\top D \Phi + \eta I)^{-1} \Phi^\top D (R + \gamma P \Pi_{\Phi\theta'} \Phi\theta')}_{:= \Gamma_\eta} \\ &\Leftrightarrow \Phi\theta = \Gamma_\eta \mathcal{T} \Phi\theta' \end{aligned}$$

where Γ_η is referred to as the regularized projection (Lim & Lee, 2024). We will discuss it in more detail soon. When θ and θ' coincide, we recover a variant of P-BE in (1) with an additional identity term, which corresponds to the RP-BE:

$$\Phi\theta = \Gamma_\eta \mathcal{T} \Phi\theta$$

which can be equivalently written as

$$\Phi^\top D R + \gamma \Phi^\top D P \Pi_{\Phi\theta} \Phi\theta = (\Phi^\top D \Phi + \eta I) \theta \quad (8)$$

Let us denote the solution to (8) as θ_η^* . Especially, Zhang et al. (2021) consider a solution in a certain ball and Lim & Lee (2024) choose a sufficiently large η to guarantee the existence and uniqueness of the solution to the above equation in \mathbb{R}^h .

We can see that Γ_η plays a central role in characterizing the existence of the solution to (8). Before proceeding further, let us first investigate the limiting behavior of the regularized projection operator:

Lemma 3.1. [Lemma 3.1 in Lim & Lee (2024)] The matrix Γ_η satisfies the following properties: $\lim_{\eta \rightarrow \infty} \Gamma_\eta = 0$ and $\lim_{\eta \rightarrow 0} \Gamma_\eta = \Gamma$.

In view of this limiting behavior, it follows that with sufficiently large η , the composition of the regularized projection operator and the Bellman operator becomes a contractive operator. Figure 1 provides a geometric illustration of this effect. As η increases, the image of Γ_η is concentrated near the origin. Leveraging this observation, the following lemma characterizes conditions under which (8) admits a unique solution, for which the contractivity of the operator $\Gamma_\eta \mathcal{T}(\cdot)$ is sufficient.

Lemma 3.2. [Lemma 3.2 in Lim & Lee (2024)] The solution of (8) exists and is unique if

$$\gamma \|\Gamma_\eta P\|_\infty < 1. \quad (9)$$

Remark 3.3. Note that this is only a sufficient condition but not a necessary condition for the existence and uniqueness of (8).

Remark 3.4. If $\eta > 2$ and $\|\Phi\|_\infty \leq 1$, then (9) is satisfied. The proof is given in Appendix E.1. If each element of Φ is uniformly sampled from $[0, 1]$, then only $\frac{1}{h}$ scaling is sufficient to ensure the condition $\|\Phi\|_\infty \leq 1$.

4. Regularized projected value iteration

In this section, we present a theoretical analysis of the behavior of RP-VI, the regularized version of projected value iteration designed to solve (8). While this approach relies on knowledge of the model and reward, it serves as a foundational step toward the development of practical algorithms, which will be discussed in a later section. The RP-VI algorithm for solving (8) is given by

$$\Phi\theta_{k+1} = \Gamma_\eta \mathcal{T} \Phi\theta_k \quad (10)$$

or equivalently, it can be written as, for $\theta_0 \in \mathbb{R}^h$,

$$\theta_{k+1} = (\Phi^\top D \Phi + \eta I)^{-1} \Phi^\top D (R + \gamma P \Pi_{\Phi\theta_k} \Phi\theta_k). \quad (11)$$

Note that Equation (11) can be expressed as

$$\theta_{k+1} = \arg \min_{\theta \in \mathbb{R}^h} L_\eta(\theta, \theta_k) \quad (12)$$

which differs from (5) by replacing $L(\cdot, \cdot)$ with $L_\eta(\cdot, \cdot)$. This reformulation will be key to our subsequent development of the model-free version of this approach. The convergence of the above update can be characterized as follows:

Lemma 4.1. Suppose that there exists a unique solution θ_η^* to (8), and consider the update in (11). We have

$$\|\Phi(\theta_k - \theta_\eta^*)\|_\infty \leq (\gamma \|\Gamma_\eta\|_\infty)^{k+1} \|\Phi\theta_0 - \Phi\theta_\eta^*\|_\infty.$$

The proof is given in Appendix E.2. From the above lemma, if $\gamma \|\Gamma_\eta\|_\infty < 1$, then $\Phi\theta_k \rightarrow \Phi\theta_\eta^*$ at the rate of $\gamma \|\Gamma_\eta\|_\infty$.

5. Periodic regularized Q-learning

In this section, we present PRQ, our main algorithmic contribution. Conceptually, PRQ can be seen as a stochastic version of RP-VI in (11). The idea of PRQ is to approximate the RP-VI update in (11), which cannot be implemented directly in a model-free setting due to the matrix inverse and the requirement for knowledge of system parameters. The key idea for implementing RP-VI in a model-free RL setting is that RP-VI can be reformulated in the optimization form in (12). The optimization in (12) can be solved to an arbitrarily accurate approximate solution via the stochastic gradient descent method. Therefore, we can develop an efficient algorithm based on stochastic gradient descent. The algorithm operates in two stages: the inner loop and the outer loop update. Each loop updates separate learning parameters, the inner loop iterate and the outer loop iterate, respectively. The inner loop involves a stochastic gradient descent method applied to a loss function, while the outer loop update adjusts the second argument in the objective function in (12), which is referred to as the target parameter.

The overall algorithm is summarized in Algorithm 1. Let $\theta_{t,k}$ denote the parameter vector at the k -th step of the inner loop during the t -th outer iteration. The objective of the inner loop is to approximate the update in (11) given $\theta_{t,0}$. Specifically, the inner loop aims to approximately solve the optimization problem $\min_{\theta \in \mathbb{R}^h} L_\eta(\theta, \theta_{t,0})$; accordingly, after K steps of inner iterations,

$$\theta_{t,K} \approx \theta^*(\theta_{t,0}) := \arg \min_{\theta \in \mathbb{R}^h} L_\eta(\theta, \theta_{t,0}) \quad (13)$$

where we define a function $\theta^* : \mathbb{R}^h \rightarrow \mathbb{R}^h$ for the simplicity of the notation. The stochastic gradient descent method to solve the inner loop minimization problem can be applied in the following manner: upon observing $o = (s, a, s') \in \mathcal{S} \times \mathcal{A} \times \mathcal{S}$, where $(s, a) \sim d(\cdot, \cdot)$, $s' \sim \mathcal{P}(\cdot | s, a)$, we construct the stochastic gradient estimator

$$g(\theta, \theta'; o) = -\left(r(s, a, s') + \gamma \max_{a \in \mathcal{A}} \phi(s', a)^\top \theta' - \phi(s, a)^\top \theta\right) \phi(s, a) + \eta \theta$$

which satisfies $\mathbb{E}[g(\theta, \theta'; o)] = \nabla_\theta L_\eta(\theta, \theta')$. Therefore, given a step-size $\alpha \in (0, 1)$, the inner loop update can be written as follows:

$$\theta_{t,k+1} = \theta_{t,k} + \alpha (-g(\theta_{t,k}, \theta_{t,0}; o)). \quad (14)$$

After K steps in the inner loop update, we update the target parameter $\theta_{t+1,0} \leftarrow \theta_{t,K}$ and then repeat the inner loop procedure. This combined process is an approximation of RP-VI in (11), with stochastic gradient descent. Consequently,

the period length K plays a critical role in controlling approximation error; a sufficiently large K ensures accurate regularized projection, thereby guaranteeing stability and convergence.

6. Main theoretical result

In this section, we present the theoretical analysis of PRQ. We first derive a loop error decomposition and present a key proposition. We then analyze convergence under the independent and identically distributed (i.i.d.) observation model and subsequently extend the results to the Markovian observation model.

6.1. Outer loop decomposition

Before proceeding to the error analysis, we establish a structural decomposition of the overall approximation error in the PRQ procedure. One component is the inner loop error, which arises from stochastic gradient descent on the regularized objective. The other component is the outer loop error, which is induced by the RP-VI update.

Proposition 6.1. *For $t \in \mathbb{N}$ and $\delta > 0$, we have*

$$\begin{aligned} & \mathbb{E} [\|\Phi\theta_{t,K} - \Phi\theta_\eta^*\|_\infty^2] \\ & \leq \frac{2(1+\delta)}{\mu_\eta} \mathbb{E} [L_\eta(\theta_{t,K}, \theta_{t-1,K}) - L_\eta(\theta^*(\theta_{t-1,K}), \theta_{t-1,K})] \\ & \quad + \gamma^2 \|\Gamma_\eta\|_\infty^2 (1 + \delta^{-1}) \mathbb{E} [\|\Phi\theta_{t-1,K} - \Phi\theta_\eta^*\|_\infty^2]. \end{aligned}$$

Remark 6.2. The proof is provided in Appendix E.3. The first term in the above proposition can be controlled via the inner loop update. The second term captures the contraction effect induced by the outer-loop update under the RP-VI scheme and decays at a rate governed by $\gamma \|\Gamma_\eta\|_\infty$. Here, μ_η represents the strong convexity constant of L_η , the explicit definition of which is provided in Lemma 6.3.

The above result is independent of the observation model; in particular, it holds under both the i.i.d. and Markovian observation settings.

6.2. i.i.d. observation model

In this section, we present our main theoretical result, showing that the proposed PRQ algorithm achieves an error bound of $\mathbb{E}[\|\Phi(\theta_{t,K} - \theta_\eta^*)\|_\infty^2] \leq \epsilon$ under appropriate choices of the step size, the number of inner iterations, and the number of outer updates. The proof follows a standard approach to the analysis of strongly-convex and smooth objectives in the optimization literature (Bottou et al., 2018).

Lemma 6.3 (Strong convexity and smoothness of $L_\eta(\theta, \theta')$). *For any fixed θ' , the function $L_\eta(\theta, \theta')$ is μ_η -strongly convex and l_η -smooth with respect to θ , where $\mu_\eta := \lambda_{\min}(\Phi^\top D \Phi) + \eta$, $l_\eta := \lambda_{\max}(\Phi^\top D \Phi) + \eta$.*

The detailed proofs are deferred to Lemma F.1 and F.2 in the Appendix.

Theorem 6.4. *Suppose $\alpha \leq \min\{\bar{\alpha}_1, \bar{\alpha}_2, \bar{\alpha}_3, \bar{\alpha}_4\}$, which are defined in Appendix G.2. For $\mathbb{E}[\|\Phi(\theta_{t,K} - \theta_\eta^*)\|_\infty^2] \leq \epsilon$ to hold, we need at most the following number of iterations:*

$$K = \mathcal{O}\left(\frac{l_\eta \|\theta_\eta^*\|_2^2}{\epsilon \mu_\eta^3 (1 - \gamma \|\Gamma_\eta\|_\infty)^2}\right), \quad t = \mathcal{O}\left(\frac{1}{1 - \gamma \|\Gamma_\eta\|_\infty}\right).$$

The detailed proof of Theorem 6.4 is deferred to Appendix G.2. Table 1 situates our contribution within the literature on Q-learning with target network updates. Early work by Lee & He (2019) establishes non-asymptotic convergence guarantees, but the analysis is restricted to the tabular setting. Subsequent studies extend the scope to function approximation. In particular, Zhang et al. (2021) considers linear function approximation and ensures asymptotic convergence through projection and regularization. Chen et al. (2023) derives non-asymptotic guarantees under linear function approximation by introducing truncation, but convergence is only shown to a bounded set rather than a single point. More recently, Zhang et al. (2023) establishes non-asymptotic point convergence for neural network approximation, albeit under restrictive local convexity assumptions. In contrast, our work provides non-asymptotic convergence guarantees under linear function approximation using a single regularization mechanism. This unifies and strengthens existing results by simultaneously achieving finite-time guarantees, non-asymptotic convergence, and broad applicability, without relying on truncation, projection, or strong local convexity assumptions.

Now, let us briefly discuss the sample complexity result. From Theorem 6.4, the total sample complexity is given by:

$$tK = \mathcal{O}\left(\frac{l_\eta \|\theta_\eta^*\|_2^2}{\epsilon \mu_\eta^3 (1 - \gamma \|\Gamma_\eta\|_\infty)^3}\right).$$

Compared with Lee & He (2020a), which provides a sample complexity bound measured in terms of $\mathbb{E}[\|\hat{Q} - Q^*\|_\infty]$,

our result is expressed in terms of the squared error $\mathbb{E}[\|\Phi(\theta_{t,K} - \theta_\eta^*)\|_\infty^2]$. To ensure a fair comparison, we adjust the ϵ -dependence in the complexity result of Lee & He (2020a) accordingly, yielding an equivalent form of the bound

$$\mathcal{O}\left(\frac{|\mathcal{S}|^3 |\mathcal{A}|^3}{\epsilon (1 - \gamma)^4}\right).$$

Under the same measurement, our PRQ analysis in the tabular limit ($\eta \rightarrow 0$, $D = \frac{1}{|\mathcal{S}||\mathcal{A}|} \mathbf{I}$, $\Phi = \mathbf{I}$, $\|\Gamma_\eta\|_\infty \rightarrow 1$) yields

$$tK = \mathcal{O}\left(\frac{|\mathcal{S}|^2 |\mathcal{A}|^2}{\epsilon (1 - \gamma)^5}\right),$$

since $\|\theta_\eta^*\| = \|Q^*\| = \mathcal{O}(1/(1 - \gamma))$. More generally, while (Lee & He, 2020a) focuses on the tabular case, our framework allows linear function approximation.

6.3. Markovian observation model

In this subsection, we analyze the behavior of PRQ with a single trajectory generated under a fixed behavior policy β . We assume that the underlying Markov chain is irreducible. Consequently, for a finite state space, the chain admits a unique stationary distribution $\mu_\infty \in \Delta(\mathcal{S} \times \mathcal{A})$ satisfying $\mu_\infty(s, a) = \sum_{(\tilde{s}, \tilde{a}) \in \mathcal{S} \times \mathcal{A}} P_\beta(s, a | \tilde{s}, \tilde{a}) \mu_\infty(\tilde{s}, \tilde{a})$ and $P_\beta(\cdot | \tilde{s}, \tilde{a}) \in \Delta(\mathcal{S} \times \mathcal{A})$ such that $P_\beta(s, a | \tilde{s}, \tilde{a}) = \beta(a | s) P(s | \tilde{s}, \tilde{a})$. Let us denote the corresponding vector and matrix form of μ_∞ and P_β as μ_∞ and P_β , respectively. Given a stochastic process $\{(S_k, A_k)\}_{k=0}^\infty$ where (S_k, A_k) are random variables induced by the Markov chain, we define the hitting time $\tau(\tilde{s}, \tilde{a}) = \inf\{n \geq 1 : (S_n, A_n) = (\tilde{s}, \tilde{a})\}$ for some $(\tilde{s}, \tilde{a}) \in \mathcal{S} \times \mathcal{A}$, and denote $\tau_{\max} := \max_{(s,a) \in \mathcal{S} \times \mathcal{A}} \tau(s, a)$.

Recently, Haque & Maguluri (2024) utilized Poisson's equation to analyze stochastic approximation schemes under the Markovian observation model. Building upon their approach and extending the i.i.d. model analysis presented in the previous section, we establish the following result, with the detailed proof provided in Appendix H.3.

Theorem 6.5. *Suppose $\alpha \leq \min\{\bar{\alpha}_1, \bar{\alpha}_2, \bar{\alpha}_3, \bar{\alpha}_4\}$ which are defined in (47) in the Appendix. For $\mathbb{E}[\|\Phi(\theta_{t,K} - \theta_\eta^*)\|_\infty^2] \leq \epsilon$ to hold, we need at most the following number of iterations:*

$$K = \mathcal{O}\left(\frac{(l_\eta + \kappa) \tau_{\max} \eta^2 \|\theta_\eta^*\|_2^2}{\mu_\eta^2 (1 - \gamma \|\Gamma_\eta\|_\infty)}\right), \quad t = \mathcal{O}\left(\frac{1}{1 - \gamma \|\Gamma_\eta\|_\infty}\right)$$

where $\kappa = l_\eta / \mu_\eta$.

Remark 6.6. In addition to the result of the i.i.d. analysis, we have an additional factor of the hitting time τ_{\max} .

7. Experiments

In this section, we investigate the behavioral differences between the proposed PRQ and regularized Q-learning (RegQ) (Lim & Lee, 2024), with a particular focus on the learning trajectories induced under linear function approximation. We consider an MDP that is deliberately chosen so that no solution exists for the P-BE in the unregularized setting. RegQ employs a direct semi-gradient update with ℓ_2 regularization and does not incorporate any form of target-based or periodic update mechanism. In contrast, PRQ periodically resets the optimization target. Throughout this experiment, we observe that although both RegQ and PRQ can induce solutions to a RP-BE through the use of regularization, their resulting learning trajectories exhibit qualitatively different behaviors. The MDP considered in this experiment is summarized in the example below.

Example 7.1. Consider the following MDP with $|\mathcal{S}| = |\mathcal{A}| = 2$ and $h = 2$:

$$\Phi = \begin{bmatrix} 0.25 & -0.81 \\ 0.88 & -0.92 \\ 1 & -0.93 \\ 0.03 & -0.19 \end{bmatrix}, \quad P = \begin{bmatrix} 0.90 & 0.10 \\ 0.94 & 0.06 \\ 0 & 1 \\ 0.44 & 0.56 \end{bmatrix}, \quad R = \begin{bmatrix} -0.63 \\ 0.24 \\ 0.50 \\ 0.92 \end{bmatrix}.$$

Let $\beta(1 | 1) = 0.13$ and $\beta(1 | 2) = 0.63$. Then, no solution exists for P-BE, which is the case for $\eta = 0$. Based on this

MDP, we divide our experiments into two main settings: a model-based setting and a sample-based setting. In the model-based setting, full knowledge of the transition dynamics is assumed, allowing updates to be performed using the complete transition matrices without sampling. This setting serves to isolate the intrinsic algorithmic behavior of PRQ and RegQ. The sample-based setting is further divided into an i.i.d. sampling regime and a Markovian sampling regime. In the i.i.d. regime, state-action pairs are drawn independently from a fixed distribution, whereas in the Markovian regime, samples are generated sequentially along trajectories induced by the predefined policy.

7.1. Model-based setting

In a model-based simulation, sampling is skipped and updates are performed using the full transition matrices. For PRQ, this setting can be implemented straightforwardly by directly applying the update rule of RP-VI described in Section 4. In contrast, for RegQ, we reimplement the deterministic, model-based update equation following Lim & Lee (2024). The resulting update can be expressed in matrix form as

$$\theta_{k+1} = \theta_k + \alpha \Phi^\top D(R + \gamma P \Pi_{\Phi \theta_k} \Phi \theta_k - \Phi \theta_k - \eta \theta_k).$$




Figure 2. Comparison of PRQ and RegQ in the model-based setting with $\eta = 0.01$. The top row corresponds to PRQ, while the bottom row corresponds to RegQ. In each row, the left subplot shows the temporal evolution of the parameters θ_0 and θ_1 during iterations, and the right subplot shows the corresponding trajectory in the two-dimensional (θ_0, θ_1) parameter space, including the initialization point and the RP-BE solution. PRQ exhibits stable convergence toward the solution, whereas RegQ displays periodic behavior and fails to show convergence.

When $\eta = 0$, the update reduces to the standard model-based Q-learning update under linear function approximation. For $\eta > 0$, the additional term $-\eta \theta_k$ acts as an ℓ_2 regularizer, yielding the regularized Q-learning (RegQ) algorithm. For the MDP presented in Example 7.1, we observe that with $\eta = 0.01$, only the model-based version of PRQ in (11) converges, whereas RegQ exhibits persistent oscillations and fails to converge, as shown in Figure 2. Importantly, the RP-BE admits a unique solution in this setting. However, despite the existence and uniqueness of the solution, RegQ fails to converge to it, while PRQ follows a stable and efficient trajectory in the two-dimensional parameter space and successfully converges.

7.2. Sample-based setting

Beyond the model-based setting, which requires full knowledge of the transition dynamics, the sample-based setting assumes that the agent has access only to a single transi-




Figure 3. Comparison of PRQ and RegQ in the i.i.d. sample-based setting with $\eta = 0.01$. The figure follows the same layout as Figure 2.




Figure 4. Comparison of PRQ and RegQ under the Markovian sample-based setting with $\eta = 0.01$. The figure follows the same layout as Figure 2.

tion sample at each step. In the sample-based setting, the sampling scheme may vary depending on whether the underlying probability distribution is i.i.d. or Markovian. Under the i.i.d. setting, PRQ is applied directly using the sampling procedure in Algorithm 1, while RegQ follows the update rule of Lim & Lee (2024). Despite the additional variance induced by stochastic sampling, convergence of both algorithms in the i.i.d. setting is theoretically guaranteed if η is sufficiently large: convergence for PRQ is established in this paper, and for RegQ in Lim & Lee (2024). For the Markovian setting, the algorithmic structure remains unchanged and only the sampling procedure differs: trajectories are generated by rolling out the transition dynamics under a behavior policy β , as in Example 7.1. In the Markovian setting, PRQ admits a finite-time convergence guarantee if η is sufficiently large (Theorem 6.5), whereas no such guarantee is available for RegQ. The experimental results are presented in Figure 3 and Figure 4. Despite sharing the same theoretical solution defined by (8), the two algorithms display distinct convergence properties. In particular, PRQ demonstrates a stochastic yet consistent and efficient trajectory toward the solution, remaining in a small neighborhood once it converges. In contrast, RegQ exhibits extreme oscillations in both θ_0 and θ_1 , and its trajectory forms large periodic excursions in the parameter space. More specifically, although the RegQ trajectory may occasionally pass near the solution point, it shows a weak tendency to remain in its neighborhood.

8. Conclusion

In this paper, we theoretically study a regularized projection operator and its contraction property. Building on this analysis, we introduce an RP-VI algorithm and its sample-based extension, PRQ, which features an inner–outer loop structure consisting of an inner convex optimization step and an outer value iteration. Our main theoretical result establishes finite-time, non-asymptotic convergence of PRQ under both i.i.d. and Markovian sampling settings. Through empirical evaluations, we demonstrate that both the regularization mechanism and the periodic structure are essential for achieving stable training and convergence in practice.

C. Auxiliary preliminaries

C.1. Differential methods

Definition C.1 (Locally Lipschitz function). A function $\varphi : \mathbb{R}^h \rightarrow \mathbb{R}$ is said to be locally Lipschitz if for a bounded subset $B \subset \mathbb{R}^h$, there exists a positive real number K such that

$$|\varphi(x_1) - \varphi(x_2)| \leq K \|x_1 - x_2\|_2, \quad \forall x_1, x_2 \in B.$$

Definition C.2 (Generalized directional derivative (Clarke, 1981)). Let $\varphi : \mathbb{R}^h \rightarrow \mathbb{R}$. The generalized directional derivative of φ at $x \in \mathbb{R}^h$ in direction $v \in \mathbb{R}^h$, denoted $\varphi^\circ(x; v)$ is given by

$$\varphi^\circ(x; v) = \limsup_{\substack{y \rightarrow x \\ \lambda \downarrow 0}} \frac{\varphi(y + \lambda v) - \varphi(y)}{\lambda}$$

Definition C.3 (Generalized gradient (Clarke, 1976)). Consider a locally Lipschitz function $\varphi : \mathbb{R}^h \rightarrow \mathbb{R}$. The generalized gradient of φ at x , denoted $\partial\varphi(x)$ is defined to be the subdifferential of the convex function $\varphi^\circ(x; \cdot)$ at 0. Thus, an element ξ of \mathbb{R}^h belongs to $\partial\varphi(x)$ if and only if for all $v \in \mathbb{R}^h$,

$$\varphi^\circ(x; v) \geq v^\top \xi.$$

Lemma C.4 (Proposition 1.4 in (Clarke, 1975)). Suppose $\varphi : \mathbb{R}^h \rightarrow \mathbb{R}$ is a locally Lipschitz function. Then, the following holds:

$$\partial\varphi(x) = \text{conv} \left(\left\{ \lim_{k \rightarrow \infty} \nabla\varphi(v_k) : \{v_k\}_{k=0}^\infty \text{ such that } v_k \rightarrow x, \text{ each } \varphi(v_k) \text{ is differentiable and } \lim_{k \rightarrow \infty} \nabla\varphi(v_k) \text{ exists.} \right\} \right). \quad (15)$$

Lemma C.5. Consider the function f in (2). The subdifferential of f at $\theta \in \mathbb{R}^h$ can be expressed as

$$\partial f(\theta) \subseteq \text{conv} \{ (\gamma P \Pi_\beta \Phi - \Phi)^\top D \Gamma (\mathcal{T} \Phi \theta - \Phi \theta) \mid \beta \in \Lambda(\theta) \}$$

Proof. Let us check that $f(\theta)$ is a locally Lipschitz function to apply Lemma C.4. Observe that the function $f(\theta)$ can be written as a composition of weighted squared norm $\|\cdot\|_D^2$ and the map $\theta \mapsto \Gamma \mathcal{T} \Phi \theta - \Phi \theta$. Both functions are Lipschitz, and therefore the objective function $f(\theta)$ becomes a locally Lipschitz function. Now, we can express the subdifferential of $f(\theta)$ as a convex hull of gradients as in (15). The possible choice of sequences $\{v_k\}_{k=0}^\infty$ such that $v_k \rightarrow \theta$ and $\lim_{k \rightarrow \infty} \nabla f(v_k)$ exists is to choose $v_k \in S_\beta$ where $S_\beta = \{x \in \mathbb{R}^h : |\arg \max_{a \in \mathcal{A}} \phi(s, a)^\top x| = 1, \beta(s) = \arg \max_{a \in \mathcal{A}} \phi(s, a)^\top x\}$ for $k \geq N$ and some $N \in \mathbb{N}$ and $v_k \neq \theta$. The result follows by applying the chain rule at points of differentiability of the Lipschitz function. Since a Lipschitz function is differentiable almost everywhere, the set of points where the derivative fails to exist has Lebesgue measure zero and can therefore be excluded (Clarke, 1975). \square

C.2. Optimization methods

Definition C.6 ((Nesterov et al., 2018)). The continuously differentiable function $\varphi : \mathbb{R}^h \rightarrow \mathbb{R}$ is μ -strongly convex if there exists a constant $\mu > 0$ such that

$$\varphi(\theta') \geq \varphi(\theta) + \nabla \varphi(\theta)^\top (\theta' - \theta) + \frac{\mu}{2} \|\theta - \theta'\|_2^2.$$

φ is said to be l -smooth if

$$\|\nabla \varphi(\theta) - \nabla \varphi(\theta')\|_2 \leq l \|\theta - \theta'\|_2.$$

For a twice continuously differentiable function φ that is μ -strongly convex and l -smooth, the Hessian satisfies

$$\mu \mathbf{I} \preceq \nabla^2 \varphi(\theta) \preceq l \mathbf{I}, \quad \forall \theta \in \mathbb{R}^h,$$

and consequently, all eigenvalues of $\nabla^2 \varphi(\theta)$ are lower bounded by μ and upper bounded by l .

D. Constants used throughout the proof

Before proceeding, we introduce several constants to simplify the notation:

$$l_{V_1} := 2\tau_{\max}(1 + \eta), \quad l_{V_2} := \max\{2\tau_{\max}\gamma, 1\}, \quad l_{V_3} := \tau_{\max} \left(R_{\max} + (1 + \gamma + \eta) \|\theta_\eta^*\|_2 \right), \quad (16)$$

$$D_1 := (l_\eta(6l_{V_1} + l_{V_3}) + \kappa l_{V_1} \gamma), \quad D_2 := \kappa(4l_{V_1}(1 + l_\eta)), \quad D_3 := \kappa l_{V_1} + l_\eta l_{V_2}. \quad (17)$$

$$g_{1,\eta} := 16 + 16\eta, \quad g_{2,\eta} := (42 + 32\eta)\gamma^2, \quad g_{3,\eta} := 32(1 + \eta)\gamma^2 \|\Phi \theta_\eta^*\|_\infty^2 + (16 + 16\eta)R_{\max}^2 + 8\sigma_\eta^2, \quad (18)$$

$$\mathcal{E}_1 := \left(D_1 + \frac{l_\eta}{2} \right) g_{2,\eta} + D_3, \quad \mathcal{E}_2 := \left(D_1 + \frac{l_\eta}{2} \right) g_{3,\eta} + 2l_\eta l_{V_3} \quad (19)$$

$$\sigma_\eta^2 := \max_{(s,a) \in \mathcal{S} \times \mathcal{A}} \left(\mathbb{E} \left[\left\| \left(r(s, a, s') + \gamma \max_{u \in \mathcal{A}} \phi(s', u)^\top \theta_\eta^* - \mathbb{E} \left[\left(r(s, a, \tilde{s}) + \gamma \max_{u \in \mathcal{A}} \phi(\tilde{s}, u)^\top \theta_\eta^* \right) \right] \right\|_2^2 \middle| s, a \right] \right) \right] \quad (20)$$

The constants introduced in (16) are utilized in Lemma H.3, whereas those defined in (17) appear in Lemma H.5. The constant specified in (18) and (20) are used in Lemma E.2, and the constants in (19) are employed in Proposition H.6 in the Appendix.

E. Omitted proofs in the main manuscript

E.1. Proof of Remark 3.4

Lemma E.1 (Lemma 3.3 in Lim & Lee (2024)). For $\eta > \gamma \|\Phi^\top D\|_\infty \|\Phi\|_\infty + \|\Phi^\top D \Phi\|_\infty$, we have $\gamma \|\Gamma_\eta\|_\infty < 1$.

Proof. If $\|\Phi\|_\infty \leq 1$, then $\|\phi(s, a)\|_\infty \leq 1$ for all $(s, a) \in \mathcal{S} \times \mathcal{A}$. Then,

$$\|\Phi^\top D\|_\infty = \left\| \begin{bmatrix} d(1, 1)\phi(1, 1) & \cdots & d(|\mathcal{S}|, |\mathcal{A}|\phi(|\mathcal{S}|, |\mathcal{A}|)) \end{bmatrix} \right\|_\infty = \max_{i \in [h]} \sum_{(s,a) \in \mathcal{S} \times \mathcal{A}} d(s, a) |\phi(s, a)_i| \leq 1.$$

Therefore, from Lemma E.1 in the Appendix, $\eta > 2$ is enough. \square

E.2. Proof of Lemma 4.1

Proof. We have

$$\Phi\theta_{k+1} = \Gamma_\eta \mathcal{T}\Phi\theta_k = \Gamma_\eta (R + \gamma P \Pi_{\Phi\theta_k} \Phi\theta_k).$$

The above equation can be re-written noting that θ_η^* is the solution of (8):

$$\Phi\theta_{k+1} - \Phi\theta_\eta^* = \gamma \Gamma_\eta P (\Pi_{\Phi\theta_k} \Phi\theta_k - \Pi_{\Phi\theta_\eta^*} \Phi\theta_\eta^*)$$

Taking the infinity norm on both sides,

$$\begin{aligned} \|\Phi\theta_{k+1} - \Phi\theta_\eta^*\|_\infty &\leq \gamma \|\Gamma_\eta P\|_\infty \|\Pi_{\Phi\theta_k} \Phi\theta_k - \Pi_{\Phi\theta_\eta^*} \Phi\theta_\eta^*\|_\infty \\ &\leq \gamma \|\Gamma_\eta P\|_\infty \|\Phi\theta_k - \Phi\theta_\eta^*\|_\infty \\ &\leq (\gamma \|\Gamma_\eta P\|_\infty)^{k+1} \|\Phi\theta_0 - \Phi\theta_\eta^*\|_\infty \end{aligned}$$

This gives the desired result. □

E.3. Proof of Proposition 6.1

Proof. We have

$$\begin{aligned} &\mathbb{E} \left[\|\Phi\theta_{t,K} - \Phi\theta_\eta^*\|_\infty^2 \right] \\ &\leq (1 + \delta) \mathbb{E} \left[\|\Phi\theta_{t,K} - \Gamma_\eta \mathcal{T}\Phi\theta_{t-1,K}\|_\infty^2 \right] \\ &\quad + (1 + \delta^{-1}) \mathbb{E} \left[\|\Gamma_\eta \mathcal{T}\Phi\theta_{t-1,K} - \Phi\theta_\eta^*\|_\infty^2 \right] \\ &= (1 + \delta) \mathbb{E} \left[\|\Phi\theta_{t,K} - \Gamma_\eta \mathcal{T}\Phi\theta_{t-1,K}\|_\infty^2 \right] \\ &\quad + (1 + \delta^{-1}) \mathbb{E} \left[\|\Gamma_\eta \mathcal{T}\Phi\theta_{t-1,K} - \Gamma_\eta \mathcal{T}\Phi\theta_\eta^*\|_\infty^2 \right] \\ &\leq (1 + \delta) \mathbb{E} \left[\|\Phi\theta_{t,K} - \Gamma_\eta \mathcal{T}\Phi\theta_{t-1,K}\|_\infty^2 \right] \\ &\quad + \gamma^2 \|\Gamma_\eta\|_\infty^2 (1 + \delta^{-1}) \mathbb{E} \left[\|\Phi\theta_{t-1,K} - \Phi\theta_\eta^*\|_\infty^2 \right] \\ &\leq (1 + \delta) \mathbb{E} \left[\|\Phi\theta_{t,K} - \Phi(\Phi^\top D\Phi + \eta I)^{-1} \Phi^\top D\mathcal{T}\Phi\theta_{t-1,K}\|_\infty^2 \right] \\ &\quad + \gamma^2 \|\Gamma_\eta\|_\infty^2 (1 + \delta^{-1}) \mathbb{E} \left[\|\Phi\theta_{t-1,K} - \Phi\theta_\eta^*\|_\infty^2 \right] \\ &\leq \frac{2(1 + \delta)}{\mu_\eta} (\mathbb{E} [L_\eta(\theta_{t,K}, \theta_{t-1,K}) - L_\eta(\theta^*(\theta_{t-1,K}), \theta_{t-1,K})]) \\ &\quad + \gamma^2 \|\Gamma_\eta\|_\infty^2 (1 + \delta^{-1}) \mathbb{E} \left[\|\Phi\theta_{t-1,K} - \Phi\theta_\eta^*\|_\infty^2 \right]. \end{aligned}$$

The first inequality follows from the relation $(a + b)^2 \leq (1 + \delta)a^2 + (1 + \delta^{-1})b^2$. The first equality follows from the fact that θ_η^* is the unique fixed point of (8). The second inequality follows from Lemma 3.2. The last inequality follows from Corollary E.4. This concludes the proof. □

Next, let us define the following set:

$$\mathcal{F}_{t,k} := \{(s_{t,j}, a_{t,j})_{j=0}^k, \theta_{t,0}\}.$$

Lemma E.2. For $t \in \mathbb{N}$ and $1 \leq k \leq K$, we have

$$\mathbb{E} \left[\|g(\theta_{t,k}, \theta_{t-1,K}; o_{t,k})\|_2^2 \middle| \mathcal{F}_{t,k} \right] \leq 10\gamma^2 \|\Phi(\theta_{t-1,K} - \theta_\eta^*)\|_\infty^2 + (16 + 16\eta)L_\eta(\theta_{t,k}, \theta_{t-1,K}) + 8\sigma_\eta^2.$$

and

$$\begin{aligned} \mathbb{E} \left[\|g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k})\|_2^2 \middle| \mathcal{F}_{t,k} \right] &\leq g_{1,\eta}(L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})) \\ &\quad + g_{2,\eta} \|\boldsymbol{\Phi}(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 \\ &\quad + g_{3,\eta}. \end{aligned}$$

Proof. For simplicity of the proof, let us denote $r_{t,k} = r(s_{t,k}, a_{t,k}, s'_{t,k})$ and $\phi_{t,k} = \phi(s_{t,k}, a_{t,k})$. We have

$$\begin{aligned} &\mathbb{E} \left[\|g(\boldsymbol{\theta}_{t,k}; \boldsymbol{\theta}_{t-1,K}; o_{t,k})\|_2^2 \middle| \mathcal{F}_{t,k} \right] \\ &= \mathbb{E} \left[\left\| \left(r_{t,k} + \gamma \max_{a \in \mathcal{A}} \phi(s', a)^\top \boldsymbol{\theta}_{t-1,K} - \phi_{t,k}^\top \boldsymbol{\theta}_{t,k} \right) (-\phi_{t,k}) + \eta \boldsymbol{\theta}_{t,k} \right\|_2^2 \middle| \mathcal{F}_{t,k} \right] \\ &\leq 2\mathbb{E} \left[\left\| \gamma \left(\max_{u \in \mathcal{A}} \phi(s'_{t,k}, u)^\top \boldsymbol{\theta}_{t-1,K} - \max_{u \in \mathcal{A}} \phi(s'_{t,k}, u)^\top \boldsymbol{\theta}_\eta^* \right) \phi_{t,k} \right\|_2^2 \middle| \mathcal{F}_{t,k} \right] \end{aligned} \quad (21)$$

$$+ 2\mathbb{E} \left[\left\| \left(r_{t,k} + \gamma \max_{a \in \mathcal{A}} \phi(s'_{t,k}, a)^\top \boldsymbol{\theta}_\eta^* - \phi_{t,k}^\top \boldsymbol{\theta}_{t,k} \right) (-\phi_{t,k}) + \eta \boldsymbol{\theta}_{t,k} \right\|_2^2 \middle| \mathcal{F}_{t,k} \right]. \quad (22)$$

The first inequality follows from the relation $\|\mathbf{a} + \mathbf{b}\|_2^2 \leq 2\|\mathbf{a}\|_2^2 + 2\|\mathbf{b}\|_2^2$ for any $\mathbf{a}, \mathbf{b} \in \mathbb{R}^d$. We will bound each term in (21) and (22).

Let us first bound the term in (21):

$$\begin{aligned} &\mathbb{E} \left[\left\| \gamma \left(\max_{u \in \mathcal{A}} \phi(s'_{t,k}, u)^\top \boldsymbol{\theta}_{t-1,K} - \max_{u \in \mathcal{A}} \phi(s'_{t,k}, u)^\top \boldsymbol{\theta}_\eta^* \right) \phi_{t,k} \right\|_2^2 \middle| \mathcal{F}_{t,k} \right] \\ &\leq \gamma^2 \mathbb{E} \left[\left\| \max_{u \in \mathcal{A}} \phi(s'_{t,k}, u)^\top \boldsymbol{\theta}_{t-1,K} - \max_{u \in \mathcal{A}} \phi(s'_{t,k}, u)^\top \boldsymbol{\theta}_\eta^* \right\|_2^2 \|\phi_{t,k}\|_2^2 \middle| \mathcal{F}_{t,k} \right] \\ &\leq \gamma^2 \mathbb{E} \left[\left(\max_{u \in \mathcal{A}} |\phi(s'_{t,k}, u)^\top (\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)| \right)^2 \|\phi_{t,k}\|_2^2 \middle| \mathcal{F}_{t,k} \right] \\ &\leq \gamma^2 \mathbb{E} \left[\|\boldsymbol{\Phi}(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 \|\phi_{t,k}\|_2^2 \middle| \mathcal{F}_{t,k} \right] \\ &\leq \gamma^2 \|\boldsymbol{\Phi}(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2. \end{aligned} \quad (23)$$

The second inequality follows from the non-expansiveness of the max-operator. The third inequality follows from $\max_{u \in \mathcal{A}} |\phi(s'_{t,k}, u)^\top \boldsymbol{\theta}| \leq \|\boldsymbol{\Phi} \boldsymbol{\theta}\|_\infty = \max_{(s,u) \in \mathcal{S} \times \mathcal{A}} |\phi(s, u)^\top \boldsymbol{\theta}|$ for any $\boldsymbol{\theta} \in \mathbb{R}^d$.

Now, the term in (22) can be bounded as follows:

$$\begin{aligned} &\mathbb{E} \left[\left\| \left(r_{t,k} + \gamma \max_{u \in \mathcal{A}} \phi(s'_{t,k}, u)^\top \boldsymbol{\theta}_\eta^* - \phi_{t,k}^\top \boldsymbol{\theta}_{t,k} \right) (-\phi_{t,k}) + \eta \boldsymbol{\theta}_{t,k} \right\|_2^2 \middle| \mathcal{F}_{t,k} \right] \\ &\leq 2\mathbb{E} \left[\left\| \left(\mathbb{E} \left[(r(s_{t,k}, a_{t,k}, \tilde{s}) + \gamma \max_{u \in \mathcal{A}} \phi(\tilde{s}, u)^\top \boldsymbol{\theta}_{t-1,K}) \middle| \mathcal{F}_{t,k} \right] - \phi_{t,k}^\top \boldsymbol{\theta}_{t,k} \right) (-\phi_{t,k}) + \eta \boldsymbol{\theta}_{t,k} \right\|_2^2 \middle| \mathcal{F}_{t,k} \right] \\ &\quad + 2\mathbb{E} \left[\left\| \left(r_{t,k} + \gamma \max_{u \in \mathcal{A}} \phi(s'_{t,k}, u)^\top \boldsymbol{\theta}_\eta^* - \mathbb{E} \left[(r(s_{t,k}, a_{t,k}, \tilde{s}) + \gamma \max_{u \in \mathcal{A}} \phi(\tilde{s}, u)^\top \boldsymbol{\theta}_{t-1,K}) \middle| \mathcal{F}_{t,k} \right] \right) \phi_{t,k} \right\|_2^2 \middle| \mathcal{F}_{t,k} \right] \end{aligned} \quad (24)$$

The first inequality again follows from the relation $\|\mathbf{a} + \mathbf{b}\|_2^2 \leq 2\|\mathbf{a}\|_2^2 + 2\|\mathbf{b}\|_2^2$.

We note that the term in (24) can be bounded as follows:

$$\mathbb{E} \left[\left\| \left(\mathbb{E} \left[(r(s_{t,k}, a_{t,k}, \tilde{s}) + \gamma \max_{u \in \mathcal{A}} \phi(\tilde{s}, u)^\top \boldsymbol{\theta}_{t-1,K}) \middle| \mathcal{F}_{t,k} \right] - \phi_{t,k}^\top \boldsymbol{\theta}_{t,k} \right) (-\phi_{t,k}) + \eta \boldsymbol{\theta}_{t,k} \right\|_2^2 \middle| \mathcal{F}_{t,k} \right]$$

$$\begin{aligned}
 &\leq 2\mathbb{E} \left[\left\| \mathbb{E} \left[(r(s_{t,k}, a_{t,k}, \tilde{s}) + \gamma \max_{u \in \mathcal{A}} \phi(\tilde{s}, u)^\top \boldsymbol{\theta}_{t-1,K}) - \phi_{t,k}^\top \boldsymbol{\theta}_{t,k} \right] \right\|_2^2 + \eta^2 \|\boldsymbol{\theta}_{t,k}\|_2^2 \middle| \mathcal{F}_{t,k} \right] \\
 &\leq (4 + 4\eta) L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}).
 \end{aligned}$$

The last inequality follows from the definition of $L_\eta(\cdot, \cdot)$ in (6). Now, applying this result to (24), we get

$$\begin{aligned}
 &\mathbb{E} \left[\left\| \left(r_{t,k} + \gamma \max_{u \in \mathcal{A}} \phi(s'_{t,k}, u)^\top \boldsymbol{\theta}_\eta^* - \phi_{t,k}^\top \boldsymbol{\theta}_{t,k} \right) (-\phi_{t,k}) + \eta \boldsymbol{\theta}_{t,k} \right\|_2^2 \middle| \mathcal{F}_{t,k} \right] \\
 &\leq (8 + 8\eta) L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) \\
 &\quad + 2\mathbb{E} \left[\left\| \left(r_{t,k} + \gamma \max_{u \in \mathcal{A}} \phi(s'_{t,k}, u)^\top \boldsymbol{\theta}_\eta^* - \mathbb{E} \left[(r(s_{t,k}, a_{t,k}, \tilde{s}) + \gamma \max_{u \in \mathcal{A}} \phi(\tilde{s}, u)^\top \boldsymbol{\theta}_{t-1,K}) \right] \right) \phi_{t,k} \right\|_2^2 \middle| \mathcal{F}_{t,k} \right] \\
 &\leq (8 + 8\eta) L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) \\
 &\quad + 4\mathbb{E} \left[\left\| \left(r_{t,k} - \mathbb{E} [r(s_{t,k}, a_{t,k}, \tilde{s})] + \gamma \max_{u \in \mathcal{A}} \phi(s'_{t,k}, u)^\top \boldsymbol{\theta}_\eta^* - \gamma \mathbb{E} \left[\max_{u \in \mathcal{A}} \phi(\tilde{s}, u)^\top \boldsymbol{\theta}_\eta^* \right] \right) \phi_{t,k} \right\|_2^2 \middle| \mathcal{F}_{t,k} \right] \\
 &\quad + 4\mathbb{E} \left[\left\| \left(\gamma \mathbb{E} \left[\max_{u \in \mathcal{A}} \phi(s'_{t,k}, u)^\top \boldsymbol{\theta}_\eta^* - \gamma \max_{u \in \mathcal{A}} \phi(\tilde{s}, u)^\top \boldsymbol{\theta}_{t-1,K} \right] \right) \phi_{t,k} \right\|_2^2 \middle| \mathcal{F}_{t,k} \right] \\
 &\leq (8 + 8\eta) L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) + 4\sigma_\eta^2 + 4\gamma^2 \|\Phi(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2. \tag{25}
 \end{aligned}$$

The second inequality follows from the definition of $L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})$ in (6). The last inequality follows from the same logic in (23).

Now applying the bounds in (23) and (25) to (21) and (22), respectively, we get

$$\begin{aligned}
 \mathbb{E} \left[\|g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k})\|_2^2 \middle| \mathcal{F}_{t,k} \right] &\leq 10\gamma^2 \|\Phi(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 \\
 &\quad + (16 + 16\eta) L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) + 8\sigma_\eta^2.
 \end{aligned}$$

This completes the proof of the first statement.

The second statement follows from simple decomposition:

$$\begin{aligned}
 \mathbb{E} \left[\|g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k})\|_2^2 \middle| \mathcal{F}_{t,k} \right] &\leq 10\gamma^2 \|\Phi(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 + (16 + 16\eta) L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) + 8\sigma_\eta^2 \\
 &\leq 10\gamma^2 \|\Phi(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 \\
 &\quad + (16 + 16\eta) (L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})) \\
 &\quad + (16 + 16\eta) L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K}) + 8\sigma_\eta^2 \\
 &\leq 10\gamma^2 \|\Phi(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 \\
 &\quad + (16 + 16\eta) (L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})) \\
 &\quad + (16 + 16\eta) \left(R_{\max}^2 + 2\gamma^2 \|\Phi(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 + 2\gamma^2 \|\Phi \boldsymbol{\theta}_\eta^*\|_\infty^2 \right) + 8\sigma_\eta^2 \\
 &= (16 + 16\eta) (L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})) \\
 &\quad + (42 + 32\eta) \gamma^2 \|\Phi(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 \\
 &\quad + 32(1 + \eta) \gamma^2 \|\Phi \boldsymbol{\theta}_\eta^*\|_\infty^2 + (16 + 16\eta) R_{\max}^2 + 8\sigma_\eta^2.
 \end{aligned}$$

The last inequality follows from Lemma E.3. □

The following lemma bounds the inner loop loss in terms of the error of previous final iterate:

Lemma E.3. *For any $\boldsymbol{\theta}' \in \mathbb{R}^h$ the following holds:*

$$L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}'), \boldsymbol{\theta}') \leq R_{\max}^2 + 2\gamma^2 \|\Phi(\boldsymbol{\theta}' - \boldsymbol{\theta}_\eta^*)\|_\infty^2 + 2\gamma^2 \|\Phi \boldsymbol{\theta}_\eta^*\|_\infty^2$$

Proof. By the definition of $\theta^*(\theta')$ as the minimizer of $L_\eta(\cdot, \theta')$, we have $L_\eta(\theta^*(\theta'), \theta') \leq L_\eta(\mathbf{0}, \theta')$. Plugging in the zero vector, we have

$$\begin{aligned} L_\eta(\mathbf{0}, \theta') &= \frac{1}{2} \|R + \gamma P \Pi_{\theta'} \Phi \theta'\|_D^2 \\ &\leq R_{\max}^2 + \gamma^2 \|P \Pi_{\theta'} \Phi \theta' - P \Pi_{\theta_\eta^*} \Phi \theta_\eta^* + P \Pi_{\theta_\eta^*} \Phi \theta_\eta^*\|_D^2 \\ &\leq R_{\max}^2 + 2\gamma^2 \|\Phi(\theta' - \theta_\eta^*)\|_\infty^2 + 2\gamma^2 \|\Phi \theta_\eta^*\|_\infty^2 \end{aligned}$$

This completes the proof. \square

Corollary E.4. *We have*

$$L_\eta(\theta, \theta') - L_\eta(\theta^*(\theta'), \theta') \geq \frac{\mu_\eta}{2} \|\Gamma_\eta \mathcal{T} \Phi \theta' - \Phi \theta\|_\infty^2.$$

Proof. The quadratic growth condition in Lemma F.4 implies that

$$\begin{aligned} L_\eta(\theta, \theta') - L_\eta(\theta^*(\theta'), \theta') &\geq \frac{\mu_\eta}{2} \|\theta^*(\theta') - \theta\|_2^2 \\ &= \frac{\mu_\eta}{2} \|(\Phi^\top D \Phi + \eta I)^{-1} \Phi^\top D \mathcal{T} \Phi \theta' - \theta\|_2^2 \\ &\geq \frac{\mu_\eta}{2} \|(\Phi^\top D \Phi + \eta I)^{-1} \Phi^\top D \mathcal{T} \Phi \theta' - \theta\|_\infty^2 \\ &\geq \frac{\mu_\eta}{2} \|\Phi(\Phi^\top D \Phi + \eta I)^{-1} \Phi^\top D \mathcal{T} \Phi \theta' - \Phi \theta\|_\infty^2 \end{aligned}$$

The first equality follows from the definition of $\theta^*(\theta')$ in (13). The second inequality follows from the vector norm inequality $\|\cdot\|_\infty \leq \|\cdot\|_2$, and the last inequality follows from Assumption 2.1. \square

Lemma E.5. *For $\theta \in \mathbb{R}^h$, we have*

$$\|\gamma P \Pi_\theta - I\|_\infty \leq 2.$$

Proof. Note that we have

$$1 - \gamma[P \Pi_\theta]_{ii} + \gamma \sum_{j \neq i} |[P \Pi_\theta]_{ij}| \leq 2.$$

This completes the proof. \square

Lemma E.6. *For $x, y, \theta, \theta' \in \mathbb{R}^h$ and $(s, a) \in \mathcal{S} \times \mathcal{A}$, we have*

$$\|\bar{g}(x, \theta'; s, a) - \bar{g}(y, \theta'; s, a)\|_2 \leq (1 + \eta) \|x - y\|_2.$$

Moreover, we have

$$\begin{aligned} \|\bar{g}(x, \theta; s, a) - \bar{g}(x, \theta'; s, a)\|_2 &\leq \gamma \|\Phi \theta - \Phi \theta'\|_\infty, \\ \|\nabla L_\eta(x, \theta) - \nabla L_\eta(x, \theta')\|_2 &\leq \gamma \|\Phi \theta - \Phi \theta'\|_\infty. \end{aligned}$$

Proof. From the definition of $\bar{g}(\cdot)$ in (41), we have

$$\begin{aligned} \|\bar{g}(x, \theta'; s, a) - \bar{g}(y, \theta'; s, a)\|_2 &= \|-\phi(s, a)^\top (x - y) \phi(s, a) + \eta(x - y)\|_2 \\ &\leq (1 + \eta) \|x - y\|_2 \end{aligned}$$

The last line follows from the boundedness of the feature vector.

Now, the second statement follows from

$$\begin{aligned}
 & \|\bar{g}(\mathbf{x}, \boldsymbol{\theta}'; s, a) - \bar{g}(\mathbf{x}, \boldsymbol{\theta}; s, a)\|_2 \\
 &= \left\| \gamma \phi(s, a) \sum_{s' \in \mathcal{S}} \mathcal{P}(s' | s, a) \left(\max_{u \in \mathcal{A}} \phi(s', u)^\top \boldsymbol{\theta} - \max_{u \in \mathcal{A}} \phi(s', u)^\top \boldsymbol{\theta}' \right) \right\|_2 \\
 &\leq \gamma \sum_{s' \in \mathcal{S}} \mathcal{P}(s' | s, a) \left| \max_{u \in \mathcal{A}} \phi(s', u)^\top \boldsymbol{\theta} - \max_{u \in \mathcal{A}} \phi(s', u)^\top \boldsymbol{\theta}' \right| \\
 &\leq \gamma \sum_{s' \in \mathcal{S}} \mathcal{P}(s' | s, a) \left| \max_{u \in \mathcal{A}} \phi(s', u)^\top (\boldsymbol{\theta} - \boldsymbol{\theta}') \right| \\
 &\leq \gamma \|\Phi \boldsymbol{\theta} - \Phi \boldsymbol{\theta}'\|_\infty.
 \end{aligned} \tag{26}$$

The first inequality follows from the non-expansiveness of the max-operator. The last inequality follows from the definition of the infinity norm.

The same logic holds for the Lipschitzness of ∇L_η with respect to its second argument:

$$\begin{aligned}
 \|\nabla L_\eta(\mathbf{x}, \boldsymbol{\theta}) - \nabla L_\eta(\mathbf{x}, \boldsymbol{\theta}')\|_2 &= \left\| \sum_{(s,a) \in \mathcal{S} \times \mathcal{A}} d(s, a) (\bar{g}(\mathbf{x}, \boldsymbol{\theta}'; s, a) - \bar{g}(\mathbf{x}, \boldsymbol{\theta}; s, a)) \right\|_2 \\
 &\leq \sum_{(s,a) \in \mathcal{S} \times \mathcal{A}} d(s, a) \|\bar{g}(\mathbf{x}, \boldsymbol{\theta}'; s, a) - \bar{g}(\mathbf{x}, \boldsymbol{\theta}; s, a)\|_2 \\
 &\leq \gamma \|\Phi \boldsymbol{\theta} - \Phi \boldsymbol{\theta}'\|_\infty.
 \end{aligned}$$

The last line follows from (26). This completes the proof. \square

F. Geometry of the Inner-Loop Objective

This section provides properties on the geometry of the inner-loop objective. We adopt the standard optimization framework (Nesterov et al., 2018).

Lemma F.1 (Strong convexity and smoothness). *For fixed $\boldsymbol{\theta}' \in \mathbb{R}^h$, the function $L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}')$ is μ_η -strongly convex in $\boldsymbol{\theta}$, where $\mu_\eta = \lambda_{\min}(\Phi^\top \mathbf{D} \Phi) + \eta$ and l_η -smooth where $l_\eta = \lambda_{\max}(\Phi^\top \mathbf{D} \Phi) + \eta$.*

Proof. The derivative of $L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}')$ with respect to $\boldsymbol{\theta}$ is

$$\nabla L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}') = \mathbb{E}_{s,a} \left[\left(\mathbb{E}_{s'} [r(s, a, s') + \gamma \max_{u \in \mathcal{A}} \phi(s', u)^\top \boldsymbol{\theta}' - \phi(s, a)^\top \boldsymbol{\theta}] (-\phi(s, a)) + \eta \boldsymbol{\theta} \right) \right].$$

The second-order derivative is

$$\nabla^2 L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}') = \sum_{(s,a) \in \mathcal{S} \times \mathcal{A}} d(s, a) (\phi(s, a) \phi(s, a)^\top + \eta \mathbf{I}) = \Phi^\top \mathbf{D} \Phi + \eta \mathbf{I}.$$

Since $\Phi^\top \mathbf{D} \Phi$ is positive semidefinite, all eigenvalues of $\nabla^2 L_\eta$ are bounded below by $\lambda_{\min}(\Phi^\top \mathbf{D} \Phi) + \eta = \mu_\eta > 0$. Hence $L_\eta(\cdot, \boldsymbol{\theta}')$ is μ_η -strongly convex. The smoothness also follows from the definition in Definition C.6. \square

Lemma F.2 (Descent lemma). *Fix $\boldsymbol{\theta}' \in \mathbb{R}^h$ and let $l_\eta = \lambda_{\max}(\Phi^\top \mathbf{D} \Phi) + \eta$. Then for any $\boldsymbol{\theta}, \boldsymbol{\Delta} \in \mathbb{R}^h$ and $\alpha > 0$:*

$$L_\eta(\boldsymbol{\theta} - \alpha \boldsymbol{\Delta}, \boldsymbol{\theta}') \leq L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}') - \alpha \nabla L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}')^\top \boldsymbol{\Delta} + \frac{l_\eta}{2} \alpha^2 \|\boldsymbol{\Delta}\|^2.$$

Proof. Since $L_\eta(\cdot, \boldsymbol{\theta}')$ is l_η -smooth in $\boldsymbol{\theta}$, its gradient is l_η -Lipschitz. From the definition of smoothness in Definition C.6, for any $\boldsymbol{\theta}, \boldsymbol{\Delta}$ and any $\alpha > 0$,

$$L_\eta(\boldsymbol{\theta} - \alpha \boldsymbol{\Delta}, \boldsymbol{\theta}') \leq L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}') + \nabla L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}')^\top ((\boldsymbol{\theta} - \alpha \boldsymbol{\Delta}) - \boldsymbol{\theta}) + \frac{l_\eta}{2} \|\boldsymbol{\theta} - \alpha \boldsymbol{\Delta} - \boldsymbol{\theta}\|^2,$$

which simplifies to

$$L_\eta(\boldsymbol{\theta} - \alpha \boldsymbol{\Delta}, \boldsymbol{\theta}') \leq L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}') - \alpha \nabla L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}')^\top \boldsymbol{\Delta} + \frac{l_\eta}{2} \alpha^2 \|\boldsymbol{\Delta}\|^2.$$

This completes the proof. \square

The definitions of strong convexity and smoothness are provided in Section C.2 of the Appendix. The following properties will be useful throughout the paper:

Lemma F.3 (Theorem 2 in Karimi et al. (2016)). *For fixed $\boldsymbol{\theta}' \in \mathbb{R}^h$, $\boldsymbol{\theta}^*(\boldsymbol{\theta}') = \arg \min_{\boldsymbol{\theta} \in \mathbb{R}^h} L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}')$ and any $\boldsymbol{\theta} \in \mathbb{R}^h$,*

$$\|\nabla L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}')\|^2 \geq 2\mu_\eta (L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}') - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}'), \boldsymbol{\theta}')).$$

Lemma F.4. *For fixed $\boldsymbol{\theta}' \in \mathbb{R}^h$ and any $\boldsymbol{\theta} \in \mathbb{R}^h$,*

$$L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}') - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}'), \boldsymbol{\theta}') \leq \frac{l_\eta}{2} \|\boldsymbol{\theta} - \boldsymbol{\theta}^*(\boldsymbol{\theta}')\|^2.$$

Proof. By Lemma F.2 (the l_η -smoothness of $L_\eta(\cdot, \boldsymbol{\theta}')$), for any $\mathbf{x}, \mathbf{y} \in \mathbb{R}^h$,

$$L_\eta(\mathbf{y}, \boldsymbol{\theta}') \leq L_\eta(\mathbf{x}, \boldsymbol{\theta}') + \nabla L_\eta(\mathbf{x}, \boldsymbol{\theta}')^\top (\mathbf{y} - \mathbf{x}) + \frac{l_\eta}{2} \|\mathbf{y} - \mathbf{x}\|^2.$$

Apply this with $\mathbf{x} = \boldsymbol{\theta}^*(\boldsymbol{\theta}')$ and $\mathbf{y} = \boldsymbol{\theta}$. Since $\boldsymbol{\theta}^*(\boldsymbol{\theta}')$ minimizes $L_\eta(\cdot, \boldsymbol{\theta}')$, we have $\nabla L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}'), \boldsymbol{\theta}') = 0$, hence

$$L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}') - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}'), \boldsymbol{\theta}') \leq \frac{l_\eta}{2} \|\boldsymbol{\theta} - \boldsymbol{\theta}^*(\boldsymbol{\theta}')\|^2.$$

\square

Lemma F.5 (Lipschitz property). *For any $\boldsymbol{\theta} \in \mathbb{R}^h$,*

$$\|\boldsymbol{\theta}^*(\boldsymbol{\theta}) - \boldsymbol{\theta}_\eta^*\|_2 \leq \frac{\gamma}{\mu_\eta} \|\boldsymbol{\Phi}(\boldsymbol{\theta} - \boldsymbol{\theta}_\eta^*)\|_\infty.$$

Proof. We have

$$\begin{aligned} & \|\boldsymbol{\theta}^*(\boldsymbol{\theta}) - \boldsymbol{\theta}_\eta^*\|_2 \\ &= \left\| \gamma (\boldsymbol{\Phi}^\top \mathbf{D} \boldsymbol{\Phi} + \eta \mathbf{I})^{-1} \boldsymbol{\Phi}^\top \mathbf{D} \mathbf{P} \left(\boldsymbol{\Pi}_\theta \boldsymbol{\Phi} \boldsymbol{\theta} - \boldsymbol{\Pi}_{\boldsymbol{\theta}_\eta^*} \boldsymbol{\Phi} \boldsymbol{\theta}_\eta^* \right) \right\|_2 \\ &\leq \gamma \left\| (\boldsymbol{\Phi}^\top \mathbf{D} \boldsymbol{\Phi} + \eta \mathbf{I})^{-1} \right\|_2 \left\| \sum_{(s,a) \in \mathcal{S} \times \mathcal{A}} d(s,a) \boldsymbol{\phi}(s,a) \left(\sum_{s' \in \mathcal{S}} \mathcal{P}(s' | s, a) \left(\max_{u \in \mathcal{A}} \boldsymbol{\phi}(s', u)^\top \boldsymbol{\theta} - \max_{u \in \mathcal{A}} \boldsymbol{\phi}(s', u)^\top \boldsymbol{\theta}_\eta^* \right) \right) \right\|_2 \\ &\leq \frac{\gamma}{\mu_\eta} \left(\sum_{(s,a) \in \mathcal{S} \times \mathcal{A}} d(s,a) \|\boldsymbol{\phi}(s,a)\|_2 \sum_{s' \in \mathcal{S}} \mathcal{P}(s' | s, a) \left| \max_{u \in \mathcal{A}} \boldsymbol{\phi}(s', u)^\top \boldsymbol{\theta} - \max_{u \in \mathcal{A}} \boldsymbol{\phi}(s', u)^\top \boldsymbol{\theta}_\eta^* \right| \right) \\ &\leq \frac{\gamma}{\mu_\eta} \left(\sum_{(s,a) \in \mathcal{S} \times \mathcal{A}} d(s,a) \sum_{s' \in \mathcal{S}} \mathcal{P}(s' | s, a) \|\boldsymbol{\Phi} \boldsymbol{\theta} - \boldsymbol{\Phi} \boldsymbol{\theta}_\eta^*\|_\infty \right) \\ &\leq \frac{\gamma}{\mu_\eta} \|\boldsymbol{\Phi} \boldsymbol{\theta} - \boldsymbol{\Phi} \boldsymbol{\theta}_\eta^*\|_\infty. \end{aligned}$$

This completes the proof. \square

G. Analysis and proof for i.i.d observation model

Our goal is to establish an ϵ -accurate error guarantee of the form in i.i.d. observation model,

$$\mathbb{E}[\|\Phi(\theta_{t,K} - \theta_\eta^*)\|_\infty^2] \leq \epsilon.$$

To that end, we analyze the geometry of the inner-loop objective $L_\eta(\theta, \theta')$, collecting strong convexity, smoothness, gradient-gap, and related Lipschitz properties that will serve as our basic tools (Section F). We then derive a finite-time bound by viewing the inner loop as stochastic gradient descent on a strongly convex and smooth objective under the i.i.d. sampling assumption (Section G.1). This analysis yields a single linear recursion, whose solution leads to our main result (Theorem 6.4), showing that, with appropriate choices of the step size, inner-loop length, and number of outer iterations, the desired ϵ -accuracy is achieved.

G.1. Finite Time Error Analysis (i.i.d)

Lemma G.1. Suppose the step size $\alpha \leq \frac{3\mu_\eta}{l_\eta g_{1,\eta}}$. Then for each inner iteration k ,

$$\begin{aligned} \mathbb{E}[L_\eta(\theta_{t,k+1}, \theta_{t-1,K}) - L_\eta(\theta^*(\theta_{t-1,K}), \theta_{t-1,K})] &\leq \left(1 - \frac{\mu_\eta}{2}\alpha\right) \\ &\quad \times \mathbb{E}[L_\eta(\theta_{t,k}, \theta_{t-1,K}) - L_\eta(\theta^*(\theta_{t-1,K}), \theta_{t-1,K})] \\ &\quad + \frac{l_\eta}{2}\alpha^2 \left[g_{2,\eta}\mathbb{E}[\|\Phi(\theta_{t-1,K} - \theta_\eta^*)\|_\infty^2] + g_{3,\eta}\right]. \end{aligned}$$

Proof. Fix t and k , and condition on $(\theta_{t,k}, \theta_{t-1,K})$. Apply Lemma F.2 with $g = g(\theta_{t,k}, \theta_{t-1,K}; o_{t,k})$ and stepsize $\alpha > 0$:

$$L_\eta(\theta_{t,k+1}, \theta_{t-1,K}) \leq L_\eta(\theta_{t,k}, \theta_{t-1,K}) - \alpha \nabla L_\eta(\theta_{t,k}, \theta_{t-1,K})^\top g(\theta_{t,k}, \theta_{t-1,K}; o_{t,k}) + \frac{l_\eta}{2}\alpha^2 \|g(\theta_{t,k}, \theta_{t-1,K}; o_{t,k})\|^2.$$

Taking conditional expectation given $(\theta_{t,k}, \theta_{t-1,K})$ and using Lemma E.2, we have,

$$\begin{aligned} \mathbb{E}[g(\theta_{t,k}, \theta_{t-1,K}; o_{t,k}) \mid \theta_{t,k}, \theta_{t-1,K}] &= \nabla L_\eta(\theta_{t,k}, \theta_{t-1,K}), \\ \mathbb{E}[\|g(\theta_{t,k}, \theta_{t-1,K}; o_{t,k})\|^2 \mid \theta_{t,k}, \theta_{t-1,K}] &\leq g_{1,\eta}(L_\eta(\theta_{t,k}, \theta_{t-1,K}) - L_\eta(\theta^*(\theta_{t-1,K}), \theta_{t-1,K})) \\ &\quad + g_{2,\eta}\|\Phi(\theta_{t-1,K} - \theta_\eta^*)\|_\infty^2 \\ &\quad + g_{3,\eta}. \end{aligned}$$

Thus, we obtain

$$\begin{aligned} \mathbb{E}[L_\eta(\theta_{t,k+1}, \theta_{t-1,K}) \mid \theta_{t,k}, \theta_{t-1,K}] &\leq L_\eta(\theta_{t,k}, \theta_{t-1,K}) - \alpha \|\nabla L_\eta(\theta_{t,k}, \theta_{t-1,K})\|^2 \\ &\quad + \frac{l_\eta}{2}\alpha^2 \left[g_{1,\eta}(L_\eta(\theta_{t,k}, \theta_{t-1,K}) - L_\eta(\theta^*(\theta_{t-1,K}), \theta_{t-1,K}))\right. \\ &\quad \left.+ g_{2,\eta}\|\Phi(\theta_{t-1,K} - \theta_\eta^*)\|_\infty^2 + g_{3,\eta}\right]. \end{aligned}$$

Using Lemma F.3

$$\|\nabla L_\eta(\theta_{t,k}, \theta_{t-1,K})\|^2 \geq 2\mu_\eta(L_\eta(\theta_{t,k}, \theta_{t-1,K}) - L_\eta(\theta^*(\theta_{t-1,K}), \theta_{t-1,K})),$$

we obtain

$$\begin{aligned} \mathbb{E}[L_\eta(\theta_{t,k+1}, \theta_{t-1,K}) - L_\eta(\theta^*(\theta_{t-1,K}), \theta_{t-1,K}) \mid \theta_{t,k}, \theta_{t-1,K}] &\leq \left(1 - 2\mu_\eta\alpha + \frac{l_\eta}{2}\alpha^2 g_{1,\eta}\right) \\ &\quad \times (L_\eta(\theta_{t,k}, \theta_{t-1,K}) - L_\eta(\theta^*(\theta_{t-1,K}), \theta_{t-1,K})) \\ &\quad + \frac{l_\eta}{2}\alpha^2 \left[g_{2,\eta}\|\Phi(\theta_{t-1,K} - \theta_\eta^*)\|_\infty^2 + g_{3,\eta}\right]. \end{aligned}$$

For $0 < \alpha \leq \frac{3\mu_\eta}{l_\eta g_{1,\eta}}$, one can replace the quadratic rate term by a linear bound:

$$1 - 2\mu_\eta\alpha + \frac{l_\eta}{2}g_{1,\eta}\alpha^2 \leq 1 - \frac{\mu_\eta}{2}\alpha.$$

Thus,

$$\begin{aligned} \mathbb{E}[L_\eta(\boldsymbol{\theta}_{t,k+1}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K}) \mid \boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}] &\leq \left(1 - \frac{\mu_\eta}{2}\alpha\right) \\ &\quad \times (L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})) \\ &\quad + \frac{l_\eta}{2}\alpha^2 \left[g_{2,\eta} \|\boldsymbol{\Phi}(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 + g_{3,\eta} \right]. \end{aligned}$$

Finally, take total expectation on $(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})$ to conclude the claim. \square

Lemma G.2. Suppose the one-step recursion (Lemma G.1 with $\alpha \leq \frac{3\mu_\eta}{l_\eta g_{1,\eta}}$) holds. Then

$$\begin{aligned} \mathbb{E}[L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})] &\leq \left(1 - \frac{\mu_\eta}{2}\alpha\right)^k \mathbb{E}[L_\eta(\boldsymbol{\theta}_{t,0}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})] \\ &\quad + \frac{l_\eta}{\mu_\eta} \alpha \left[g_{2,\eta} \mathbb{E}[\|\boldsymbol{\Phi}(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2] + g_{3,\eta} \right]. \end{aligned} \quad (27)$$

Proof. Let

$$x_k := \mathbb{E}[L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})].$$

From Lemma G.1, with the stepsize condition $\alpha \leq \frac{3\mu_\eta}{l_\eta g_{1,\eta}}$, the recursion becomes

$$x_{k+1} \leq \left(1 - \frac{\mu_\eta}{2}\alpha\right) x_k + \frac{l_\eta}{2}\alpha^2 \left[g_{2,\eta} \mathbb{E}[\|\boldsymbol{\Phi}(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2] + g_{3,\eta} \right].$$

By induction, this yields

$$x_k \leq \left(1 - \frac{\mu_\eta}{2}\alpha\right)^k x_0 + \frac{l_\eta}{2}\alpha^2 \left[g_{2,\eta} \mathbb{E}[\|\boldsymbol{\Phi}(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2] + g_{3,\eta} \right] \sum_{i=0}^{k-1} \left(1 - \frac{\mu_\eta}{2}\alpha\right)^i.$$

Since the sum is geometric and bounded by the infinite series,

$$\sum_{i=0}^{k-1} \left(1 - \frac{\mu_\eta}{2}\alpha\right)^i \leq \sum_{i=0}^{\infty} \left(1 - \frac{\mu_\eta}{2}\alpha\right)^i = \frac{1}{\frac{\mu_\eta}{2}\alpha} = \frac{2}{\mu_\eta\alpha},$$

we obtain the bound

$$x_k \leq \left(1 - \frac{\mu_\eta}{2}\alpha\right)^k x_0 + \frac{l_\eta}{\mu_\eta} \alpha \left[g_{2,\eta} \mathbb{E}[\|\boldsymbol{\Phi}(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2] + g_{3,\eta} \right].$$

\square

Lemma G.3. The following lemma holds.

$$L_\eta(\boldsymbol{\theta}_{t,0}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K}) \leq R_{\max}^2 + 8 \|\boldsymbol{\Phi}(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 + 8 \|\boldsymbol{\Phi}\boldsymbol{\theta}_\eta^*\|_\infty^2$$

Proof. We have

$$\begin{aligned} &L_\eta(\boldsymbol{\theta}_{t-1,K}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K}) \\ &\leq \frac{1}{2} \|\mathbf{R} + \gamma \mathbf{P} \boldsymbol{\Pi}_{\boldsymbol{\theta}_{t-1,K}} \boldsymbol{\Phi} \boldsymbol{\theta}_{t-1,K} - \boldsymbol{\Phi} \boldsymbol{\theta}_{t-1,K}\|_D^2 \end{aligned}$$

$$\begin{aligned}
 &\leq R_{\max}^2 + \|\gamma P \Pi_{\theta_{t-1,K}} \Phi \theta_{t-1,K} - \Phi \theta_{t-1,K}\|_{\infty}^2 \\
 &\leq R_{\max}^2 + 2 \|\gamma P \Pi_{\theta_{t-1,K}} \Phi(\theta_{t-1,K} - \theta_{\eta}^*) - \Phi(\theta_{t-1,K} - \theta_{\eta}^*)\|_{\infty}^2 + 2 \|\gamma P \Pi_{\theta_{t-1,K}} \Phi \theta_{\eta}^* - \Phi \theta_{\eta}^*\|_{\infty}^2 \\
 &\leq R_{\max}^2 + 8 \|\Phi(\theta_{t-1,K} - \theta_{\eta}^*)\|_{\infty}^2 + 8 \|\Phi \theta_{\eta}^*\|_{\infty}^2
 \end{aligned}$$

The first inequality follows from the definition of $L_{\eta}(\cdot, \cdot)$ in (6). The second and third inequalities follow from the relation $\|\mathbf{a} + \mathbf{b}\|_{\infty}^2 \leq 2\|\mathbf{a}\|_{\infty}^2 + 2\|\mathbf{b}\|_{\infty}^2$ for $\mathbf{a}, \mathbf{b} \in \mathbb{R}^d$. The last line follows from Lemma E.5. This completes the proof. \square

Lemma G.4 (Main recursion). *Let*

$$y_t := \mathbb{E}[\|\Phi \theta_{t,K} - \Phi \theta_{\eta}^*\|_{\infty}^2], \quad y_{t-1} := \mathbb{E}[\|\Phi \theta_{t-1,K} - \Phi \theta_{\eta}^*\|_{\infty}^2].$$

Under the step size condition $\left(0 < \alpha \leq \min\left\{\frac{3\mu_{\eta}}{l_{\eta}g_{1,\eta}}, \frac{2}{\mu_{\eta}}\right\}\right)$, the following inequality holds:

$$\begin{aligned}
 y_t &\leq \left[\frac{16(1 + \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2)}{\mu_{\eta}(1 - \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2)} \left(1 - \frac{\mu_{\eta}}{2}\alpha\right)^K + \frac{2(1 + \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2) l_{\eta}}{\mu_{\eta}^2(1 - \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2)} \alpha g_{2,\eta} + \frac{1 + \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2}{2} \right] y_{t-1} \\
 &\quad + \frac{2(1 + \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2)}{\mu_{\eta}(1 - \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2)} \left(1 - \frac{\mu_{\eta}}{2}\alpha\right)^K R_{\max}^2 + \frac{16(1 + \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2)}{\mu_{\eta}(1 - \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2)} \left(1 - \frac{\mu_{\eta}}{2}\alpha\right)^K \|\Phi \theta_{\eta}^*\|_{\infty}^2 \\
 &\quad + \frac{2(1 + \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2) l_{\eta}}{\mu_{\eta}^2(1 - \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2)} \alpha g_{3,\eta}.
 \end{aligned}$$

Proof. Let

$$y_t := \mathbb{E}[\|\Phi \theta_{t,K} - \Phi \theta_{\eta}^*\|_{\infty}^2], \quad y_{t-1} := \mathbb{E}[\|\Phi \theta_{t-1,K} - \Phi \theta_{\eta}^*\|_{\infty}^2].$$

From Proposition 6.1,

$$y_t \leq \frac{2(1 + \delta)}{\mu_{\eta}} (\mathbb{E}[L_{\eta}(\theta_{t,K}, \theta_{t-1,K}) - L_{\eta}(\theta^*(\theta_{t-1,K}), \theta_{t-1,K})]) + \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2 (1 + \delta^{-1}) y_{t-1}.$$

With $\delta = \frac{2\gamma^2 \|\Gamma_{\eta}\|_{\infty}^2}{1 - \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2}$, we have

$$1 + \delta = \frac{1 + \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2}{1 - \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2}, \quad \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2 (1 + \delta^{-1}) = \frac{1 + \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2}{2}.$$

Hence,

$$y_t \leq \frac{2(1 + \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2)}{\mu_{\eta}(1 - \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2)} \mathbb{E}[L_{\eta}(\theta_{t,K}, \theta_{t-1,K}) - L_{\eta}(\theta^*(\theta_{t-1,K}), \theta_{t-1,K})] + \frac{1 + \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2}{2} y_{t-1}.$$

Using Lemma G.2, replacing $\mathbb{E}[L_{\eta}(\theta_{t,K}, \theta_{t-1,K}) - L_{\eta}(\theta^*(\theta_{t-1,K}), \theta_{t-1,K})]$ gives

$$\begin{aligned}
 y_t &\leq \frac{2(1 + \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2)}{\mu_{\eta}(1 - \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2)} \left(\left(1 - \frac{\mu_{\eta}}{2}\alpha\right)^K \mathbb{E}[L_{\eta}(\theta_{t,0}, \theta_{t-1,K}) - L_{\eta}(\theta^*(\theta_{t-1,K}), \theta_{t-1,K})] + \frac{l_{\eta}}{\mu_{\eta}} \alpha [g_{2,\eta} y_{t-1} + g_{3,\eta}] \right) \\
 &\quad + \frac{1 + \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2}{2} y_{t-1}.
 \end{aligned} \tag{28}$$

Next, applying Lemma G.3 yields

$$y_t \leq \frac{2(1 + \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2)}{\mu_{\eta}(1 - \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2)} \left(\left(1 - \frac{\mu_{\eta}}{2}\alpha\right)^K [8 y_{t-1} + R_{\max}^2 + 8 \|\Phi \theta_{\eta}^*\|_{\infty}^2] + \frac{l_{\eta}}{\mu_{\eta}} \alpha [g_{2,\eta} y_{t-1} + g_{3,\eta}] \right) + \frac{1 + \gamma^2 \|\Gamma_{\eta}\|_{\infty}^2}{2} y_{t-1}$$

$$\begin{aligned}
 &= \left[\frac{16(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)}{\mu_\eta(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \left(1 - \frac{\mu_\eta}{2}\alpha\right)^K + \frac{2(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2) l_\eta}{\mu_\eta^2(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \alpha g_{2,\eta} + \frac{1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{2} \right] y_{t-1} \\
 &+ \frac{2(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)}{\mu_\eta(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \left(1 - \frac{\mu_\eta}{2}\alpha\right)^K R_{\max}^2 + \frac{16(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)}{\mu_\eta(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \left(1 - \frac{\mu_\eta}{2}\alpha\right)^K \|\Phi\theta_\eta^*\|_\infty^2 \\
 &+ \frac{2(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2) l_\eta}{\mu_\eta^2(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \alpha g_{3,\eta}.
 \end{aligned} \tag{29}$$

This concludes the proof and establishes the desired result. \square

Fix $\delta = \frac{2\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}$ and assume $\left(0 < \alpha \leq \min\left\{\frac{3\mu_\eta}{l_\eta g_{1,\eta}}, \frac{2}{\mu_\eta}\right\}\right)$.

From Lemma G.4, we have

$$\begin{aligned}
 y_t &\leq \left[\frac{16(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)}{\mu_\eta(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \left(1 - \frac{\mu_\eta}{2}\alpha\right)^K + \frac{2(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2) l_\eta}{\mu_\eta^2(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \alpha g_{2,\eta} + \frac{1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{2} \right] y_{t-1} \\
 &+ \frac{2(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)}{\mu_\eta(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \left(1 - \frac{\mu_\eta}{2}\alpha\right)^K R_{\max}^2 + \frac{16(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)}{\mu_\eta(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \left(1 - \frac{\mu_\eta}{2}\alpha\right)^K \|\Phi\theta_\eta^*\|_\infty^2 \\
 &+ \frac{2(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2) l_\eta}{\mu_\eta^2(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \alpha g_{3,\eta}.
 \end{aligned} \tag{30}$$

Let us define, for convenience,

$$\mathcal{E}_{K,\alpha} := \frac{2(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)}{\mu_\eta(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \left(1 - \frac{\mu_\eta}{2}\alpha\right)^K \left(R_{\max}^2 + 8\|\Phi\theta_\eta^*\|_\infty^2\right) + \frac{2(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2) l_\eta}{\mu_\eta^2(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \alpha g_{3,\eta}. \tag{31}$$

so that the recursion can be compactly written as

$$y_t \leq \left[\frac{16(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)}{\mu_\eta(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \left(1 - \frac{\mu_\eta}{2}\alpha\right)^K + \frac{2(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2) l_\eta}{\mu_\eta^2(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \alpha g_{2,\eta} + \frac{1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{2} \right] y_{t-1} + \mathcal{E}_{K,\alpha}. \tag{32}$$

We make the coefficient of y_{t-1} in (30) strictly smaller than 1 by choosing K large enough. It suffices to ensure

$$\frac{16(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)}{\mu_\eta(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \left(1 - \frac{\mu_\eta}{2}\alpha\right)^K + \frac{2(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2) l_\eta}{\mu_\eta^2(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \alpha g_{2,\eta} + \frac{1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{2} \leq 1 - \frac{1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{4} = \frac{3 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{4}.$$

To guarantee this bound, it suffices to allocate half of the available margin $\frac{1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{4}$ to each of the first two terms,

$$\begin{cases} \frac{16(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)}{\mu_\eta(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \left(1 - \frac{\mu_\eta}{2}\alpha\right)^K \leq \frac{1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{8}, \\ \frac{2(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2) l_\eta}{\mu_\eta^2(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \alpha g_{2,\eta} \leq \frac{1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{8}. \end{cases}$$

The second condition yields an explicit upper bound on α ,

$$\alpha \leq \frac{\mu_\eta^2(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)^2}{16(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2) l_\eta g_{2,\eta}}. \quad (33)$$

Substituting this into the first inequality then specifies the required lower bound on K ,

$$K \geq \frac{\ln\left(\frac{128(1+\gamma^2\|\mathbf{\Gamma}_\eta\|_\infty^2)}{\mu_\eta(1-\gamma^2\|\mathbf{\Gamma}_\eta\|_\infty^2)^2}\right)}{-\ln\left(1 - \frac{\mu_\eta}{2}\alpha\right)}.$$

These two design constraints ensure the desired contraction condition.

Using the inequality $-\ln(1 - x) \geq x$ for $x \in (0, 1)$, we further obtain

$$K \geq \frac{2}{\mu_\eta \alpha} \ln\left(\frac{128(1 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)}{\mu_\eta(1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)^2}\right). \quad (34)$$

Substituting the contraction condition derived above into the recursion in (32), we obtain

$$y_t \leq \left(1 - \frac{1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{4}\right) y_{t-1} + \mathcal{E}_{K,\alpha}. \quad (35)$$

Let $a := 1 - \frac{1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{4} = \frac{3 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{4} \in (0, 1)$. Iterating (35) yields

$$y_t \leq \left(\frac{3 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{4}\right)^t y_0 + \frac{1}{1 - a} \mathcal{E}_{K,\alpha}.$$

Since $1 - a = \frac{1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{4}$, we conclude that

$$y_t \leq \left(\frac{3 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{4}\right)^t y_0 + \frac{4}{1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2} \mathcal{E}_{K,\alpha}, \quad (36)$$

It remains to make the geometric term at most $\epsilon/2$, i.e.,

$$\left(\frac{3 + \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{4}\right)^t y_0 \leq \frac{\epsilon}{2}.$$

Taking logarithms gives

$$t \geq \frac{\ln(2y_0/\epsilon)}{-\ln a}.$$

Since $-\ln a \geq 1 - a = \frac{1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{4}$, we have

$$\frac{1}{-\ln a} \leq \frac{4}{1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}.$$

Therefore, a sufficient condition is

$$t \geq \frac{4}{1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2} \ln\left(\frac{2y_0}{\epsilon}\right). \quad (37)$$

In addition, to ensure the steady-state residue is at most $\epsilon/2$, it suffices to require

$$\frac{4}{1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2} \mathcal{E}_{K,\alpha} \leq \frac{\epsilon}{2} \iff \mathcal{E}_{K,\alpha} \leq \frac{1 - \gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{8} \epsilon, \quad (38)$$

where $\mathcal{E}_{K,\alpha}$ is defined in (31).

From (38), it suffices to make each term in (31) smaller than $\frac{1-\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{16} \epsilon$:

$$\begin{aligned} \frac{2(1+\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)}{\mu_\eta(1-\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \left(1 - \frac{\mu_\eta}{2} \alpha\right)^K \left(R_{\max}^2 + 8\|\Phi\theta_\eta^*\|_\infty^2\right) &\leq \frac{1-\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{16} \epsilon, \\ \frac{2(1+\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2) l_\eta}{\mu_\eta^2(1-\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \alpha g_{3,\eta} &\leq \frac{1-\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{16} \epsilon. \end{aligned}$$

This allocation is sufficient to guarantee $\mathcal{E}_{K,\alpha} \leq \frac{1-\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{8} \epsilon$.

From the two sufficient inequalities above, we can derive explicit complexity bounds for K and α .

(a) Bound on K . From the first inequality,

$$\frac{2(1+\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)}{\mu_\eta(1-\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \left(1 - \frac{\mu_\eta}{2} \alpha\right)^K \left(R_{\max}^2 + 8\|\Phi\theta_\eta^*\|_\infty^2\right) \leq \frac{1-\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{16} \epsilon.$$

Rearranging gives

$$\left(1 - \frac{\mu_\eta}{2} \alpha\right)^K \leq \frac{\mu_\eta(1-\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)^2}{32(1+\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)(R_{\max}^2 + 8\|\Phi\theta_\eta^*\|_\infty^2)} \epsilon.$$

Taking logarithms on both sides yields

$$K \geq \frac{\ln\left(\frac{32(1+\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)(R_{\max}^2 + 8\|\Phi\theta_\eta^*\|_\infty^2)}{\mu_\eta(1-\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)^2 \epsilon}\right)}{-\ln\left(1 - \frac{\mu_\eta}{2} \alpha\right)}.$$

Using the inequality $-\ln(1-x) \geq x$ for $x \in (0, 1)$, we further have

$$K \geq \frac{2}{\mu_\eta \alpha} \ln\left(\frac{32(1+\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)(R_{\max}^2 + 8\|\Phi\theta_\eta^*\|_\infty^2)}{\mu_\eta(1-\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)^2 \epsilon}\right). \quad (39)$$

(b) Bound on α . From the second inequality,

$$\frac{2(1+\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2) l_\eta}{\mu_\eta^2(1-\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)} \alpha g_{3,\eta} \leq \frac{1-\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{16} \epsilon,$$

which directly gives

$$\alpha \leq \frac{\mu_\eta^2(1-\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)^2}{32(1+\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2) l_\eta g_{3,\eta}} \epsilon. \quad (40)$$

Combining (39) and (40), one obtains the sufficient conditions on (α, K) ensuring $\mathcal{E}_{K,\alpha} \leq \frac{1-\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2}{8} \epsilon$, and consequently $y_t \leq \epsilon$ for t satisfying (37).

Collecting the step-size conditions from Lemma G.1, (33), and (40), define

$$\bar{\alpha}_1 := \frac{2}{\mu_\eta}, \quad \bar{\alpha}_2 := \frac{3\mu_\eta}{l_\eta g_{1,\eta}}, \quad \bar{\alpha}_3 := \frac{\mu_\eta^2(1-\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)^2}{16(1+\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2) l_\eta g_{2,\eta}}, \quad \bar{\alpha}_4 := \frac{\mu_\eta^2(1-\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2)^2}{32(1+\gamma^2 \|\mathbf{\Gamma}_\eta\|_\infty^2) l_\eta g_{3,\eta}} \epsilon,$$

and set

$$\bar{\alpha} := \min\{\bar{\alpha}_1, \bar{\alpha}_2, \bar{\alpha}_3, \bar{\alpha}_4\}.$$

Then it suffices to choose $0 < \alpha \leq \bar{\alpha}$. These four components correspond precisely to $\bar{\alpha}_1, \bar{\alpha}_2, \bar{\alpha}_3, \bar{\alpha}_4$.

Similarly, gathering the bounds on K from (34), (39), we obtain

$$K \geq \max \left\{ \frac{2}{\mu_\eta \alpha} \ln \left(\frac{32(1 + \gamma^2 \|\Gamma_\eta\|_\infty^2)(R_{\max}^2 + 8\|\Phi\theta_\eta^*\|_\infty^2)}{\mu_\eta(1 - \gamma^2 \|\Gamma_\eta\|_\infty^2)^2 \epsilon} \right), \frac{2}{\mu_\eta \alpha} \ln \left(\frac{128(1 + \gamma^2 \|\Gamma_\eta\|_\infty^2)}{\mu_\eta(1 - \gamma^2 \|\Gamma_\eta\|_\infty^2)^2} \right) \right\}$$

Replacing α with its asymptotically minimal bound $\alpha \asymp \frac{\mu_\eta^2(1 - \gamma^2 \|\Gamma_\eta\|_\infty^2)^2}{(1 + \gamma^2 \|\Gamma_\eta\|_\infty^2) l_\eta g_{3,\eta}} \epsilon$ gives the α -free form

$$K \geq \frac{2(1 + \gamma^2 \|\Gamma_\eta\|_\infty^2) l_\eta g_{3,\eta}}{\mu_\eta^3(1 - \gamma^2 \|\Gamma_\eta\|_\infty^2)^2 \epsilon} \max \left\{ \ln \frac{32(1 + \gamma^2 \|\Gamma_\eta\|_\infty^2)(R_{\max}^2 + 8\|\Phi\theta_\eta^*\|_\infty^2)}{\mu_\eta(1 - \gamma^2 \|\Gamma_\eta\|_\infty^2)^2 \epsilon}, \ln \frac{128(1 + \gamma^2 \|\Gamma_\eta\|_\infty^2)}{\mu_\eta(1 - \gamma^2 \|\Gamma_\eta\|_\infty^2)^2} \right\}.$$

Since $g_{3,\eta} = 32(1 + \eta)\gamma^2 \|\Phi\theta_\eta^*\|_\infty^2 + (16 + 16\eta)R_{\max}^2 + 8\sigma_\eta^2$ depends on $\|\theta_\eta^*\|_\infty^2$, absorbing these constants into the complexity, there exists a choice of iteration numbers of the form

$$K = \mathcal{O} \left(\frac{l_\eta \|\theta_\eta^*\|_2^2}{\epsilon \mu_\eta^3(1 - \gamma \|\Gamma_\eta\|_\infty)^2} \right), \quad t = \mathcal{O} \left(\frac{1}{1 - \gamma \|\Gamma_\eta\|_\infty} \right),$$

for which the desired accuracy guarantee holds. □

H. Analysis under the Markovian observation model

In this section, we present a detailed analysis and establish the convergence rate under the Markovian observation model introduced in Section 6.3.

H.1. Markov chain and Poisson Equation

For the analysis of the Markovian observation model in Section 6.3, we introduce the so-called Poisson's equation. The Poisson equation (Glynn & Meyn, 1996) serves as a fundamental tool in the study of Markov chains and has been utilized in various works, including Haque & Maguluri (2024), for the analysis of stochastic approximation schemes. Following the approach of Haque & Maguluri (2024), we leverage this framework to establish our results.

Let $\{(S_k, A_k)\}_{k=0}^\infty$ be a sequence of random variables induced by the irreducible Markov chain with behavior policy β in Section 6.3. Then, for some functions $\varphi, \psi : \mathcal{S} \times \mathcal{A} \rightarrow \mathbb{R}$, the Poisson's equation is defined as

$$\mathbb{E}[\psi(S_1, A_1) | (S_0, A_0) = (s, a)] - \psi(s, a) = -\varphi(s, a)$$

Given φ , a candidate solution for ψ is $\mathbb{E} \left[\sum_{k=0}^{\tau(\tilde{s}, \tilde{a})-1} \varphi(S_k, A_k) \middle| (S_0, A_0) = (s, a) \right]$ where $\tau(\tilde{s}, \tilde{a}) = \inf\{n \geq 1 : (S_n, A_n) = (\tilde{s}, \tilde{a})\}$ is a hitting time for some $(\tilde{s}, \tilde{a}) \in \mathcal{S} \times \mathcal{A}$.

H.2. Main Analysis

First, we define two key quantities used throughout the analysis. First, let

$$\bar{g}(\theta, \theta'; s, a) := \sum_{s' \in \mathcal{S}} \mathcal{P}(s' | s, a) g(\theta, \theta'; s, a, s'), \quad (41)$$

and

$$V(\theta, \theta', s, a) = \mathbb{E} \left[\sum_{k=0}^{\tau(\tilde{s}, \tilde{a})-1} \bar{g}(\theta, \theta'; S_k, A_k) - \nabla L_\eta(\theta, \theta') \middle| (S_0, A_0) = (s, a) \right]. \quad (42)$$

For simplicity, let us denote $\tau = \tau(\tilde{s}, \tilde{a})$. With a slight abuse of notation, we define L_η in (6) by taking d to be the stationary distribution μ_∞ .

Lemma H.1. Consider the sequence of random variables $\{(S_k, A_k)\}_{k=0}^\infty$ induced by the Markov chain. Then, for $\boldsymbol{\theta}, \boldsymbol{\theta}' \in \mathbb{R}^h$, the following equation holds :

$$V(\boldsymbol{\theta}, \boldsymbol{\theta}', s, a) - \mathbb{E}[V(\boldsymbol{\theta}, \boldsymbol{\theta}', S_1, A_1) | (S_0, A_0) = (s, a)] = \bar{g}(\boldsymbol{\theta}, \boldsymbol{\theta}'; s, a) - \nabla L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}').$$

Proof. From the definition of V in (42), we have

$$\begin{aligned} & V(\boldsymbol{\theta}, \boldsymbol{\theta}', s, a) - \mathbb{E}[V(\boldsymbol{\theta}, \boldsymbol{\theta}', S_1, A_1) | (S_0, A_0) = (s, a)] \\ &= \bar{g}(\boldsymbol{\theta}, \boldsymbol{\theta}'; s, a) - \nabla L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}') + \mathbb{E} \left[\mathbf{1}_{\{\tau \geq 2\}} \left(\sum_{k=1}^{\tau-1} \bar{g}(\boldsymbol{\theta}, \boldsymbol{\theta}'; S_k, A_k) - \nabla L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}') \right) \middle| (S_0, A_0) = (s, a) \right] \\ & \quad - \mathbb{E} \left[\mathbb{E} \left[\sum_{k=0}^{\tilde{\tau}-1} \bar{g}(\boldsymbol{\theta}, \boldsymbol{\theta}'; \tilde{S}_k, \tilde{A}_k) - \nabla L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}') \middle| (\tilde{S}_0, \tilde{A}_0) = (S_1, A_1) \right] \middle| (S_0, A_0) = (s, a) \right] \\ &= \bar{g}(\boldsymbol{\theta}, \boldsymbol{\theta}'; s, a) - \nabla L_\eta(\boldsymbol{\theta}, \boldsymbol{\theta}'). \end{aligned}$$

where $\tilde{\tau}$ is the hitting time defined by a sequence of random variables $\{(\tilde{S}_k, \tilde{A}_k)\}_{k=0}^\infty$ induced by the Markov chain. The second equality follows from the fact that conditioned on $(\tilde{S}_0, \tilde{A}_0) = (S_1, A_1)$, $\tilde{\tau}$ follows the same law of distribution of τ for $\tau \geq 2$ and $V(\boldsymbol{\theta}, \boldsymbol{\theta}', \tilde{s}, \tilde{a}) = 0$. □

Now, let us provide several useful properties related to the solution of Poisson's equation, V :

Lemma H.2. For $(s, a) \in \mathcal{S} \times \mathcal{A}$, we have

$$\|V(\boldsymbol{\theta}_\eta^*, \boldsymbol{\theta}_\eta^*, s, a)\|_2 \leq \tau_{\max} \left(R_{\max} + (1 + \gamma + \eta) \|\boldsymbol{\theta}_\eta^*\|_2 \right).$$

Proof. We have

$$\begin{aligned} \|V(\boldsymbol{\theta}_\eta^*, \boldsymbol{\theta}_\eta^*, s, a)\|_2 &= \left\| \mathbb{E} \left[\sum_{k=0}^{\tau-1} \bar{g}(\boldsymbol{\theta}_\eta^*, \boldsymbol{\theta}_\eta^*; S_k, A_k) \middle| (S_0, A_0) = (s, a) \right] \right\|_2 \\ &= \mathbb{E} \left[\sum_{k=0}^{\tau-1} (R_{\max} + (1 + \gamma) \|\boldsymbol{\theta}_\eta^*\|_2) + \eta \|\boldsymbol{\theta}_\eta^*\|_2 \middle| (S_0, A_0) = (s, a) \right] \\ &\leq \tau_{\max} \left(R_{\max} + (1 + \gamma + \eta) \|\boldsymbol{\theta}_\eta^*\|_2 \right). \end{aligned}$$

The second equality follows from the definition of \bar{g} in (41). This completes the proof. □

Lemma H.3 (Properties of V). For $\mathbf{x}, \mathbf{y}, \boldsymbol{\theta}' \in \mathbb{R}^h$ and $(s, a) \in \mathcal{S} \times \mathcal{A}$, we have

$$\begin{aligned} \|V(\mathbf{x}, \boldsymbol{\theta}', s, a) - V(\mathbf{y}, \boldsymbol{\theta}', s, a)\|_2 &\leq l_{V_1} \|\mathbf{x} - \mathbf{y}\|_2, \\ \|V(\mathbf{x}, \boldsymbol{\theta}', s, a) - V(\mathbf{x}, \boldsymbol{\theta}, s, a)\|_2 &\leq l_{V_2} \|\boldsymbol{\Phi}\boldsymbol{\theta} - \boldsymbol{\Phi}\boldsymbol{\theta}'\|_\infty, \\ \|V(\boldsymbol{\theta}, \boldsymbol{\theta}', s, a)\|_2 &\leq l_{V_1} \|\boldsymbol{\theta} - \boldsymbol{\theta}_\eta^*\|_2 + l_{V_2} \|\boldsymbol{\Phi}\boldsymbol{\theta}' - \boldsymbol{\Phi}\boldsymbol{\theta}_\eta^*\|_\infty + l_{V_3}. \end{aligned}$$

Proof. The definition of Poisson solution in (42) yields

$$\begin{aligned} & V(\mathbf{x}, \boldsymbol{\theta}', s, a) - V(\mathbf{y}, \boldsymbol{\theta}', s, a) \\ &= \left\| \mathbb{E} \left[\sum_{k=0}^{\tau-1} \bar{g}(\mathbf{x}, \boldsymbol{\theta}'; S_k, A_k) - \bar{g}(\mathbf{y}, \boldsymbol{\theta}'; S_k, A_k) - \nabla L_\eta(\mathbf{x}, \boldsymbol{\theta}') + \nabla L_\eta(\mathbf{y}, \boldsymbol{\theta}') \middle| (S_0, A_0) = (s, a) \right] \right\|_2 \\ &\leq \mathbb{E} \left[\left\| \sum_{k=0}^{\tau-1} \bar{g}(\mathbf{x}, \boldsymbol{\theta}'; S_k, A_k) - \bar{g}(\mathbf{y}, \boldsymbol{\theta}'; S_k, A_k) - \nabla L_\eta(\mathbf{x}, \boldsymbol{\theta}') + \nabla L_\eta(\mathbf{y}, \boldsymbol{\theta}') \right\|_2 \middle| (S_0, A_0) = (s, a) \right] \end{aligned}$$

$$\begin{aligned}
 &\leq \mathbb{E} \left[\sum_{k=0}^{\tau-1} \|\bar{g}(\mathbf{x}, \boldsymbol{\theta}'; S_k, A_k) - \bar{g}(\mathbf{y}, \boldsymbol{\theta}'; S_k, A_k)\|_2 + \|\nabla L_\eta(\mathbf{x}, \boldsymbol{\theta}') - \nabla L_\eta(\mathbf{y}, \boldsymbol{\theta}')\|_2 \middle| (S_0, A_0) = (s, a) \right] \\
 &\leq \mathbb{E}[\tau] (1 + \eta) \|\mathbf{x} - \mathbf{y}\|_2 + \mathbb{E}[\tau] (\lambda_{\max}(\boldsymbol{\Phi}^\top \mathbf{D} \boldsymbol{\Phi}) + \eta) \|\mathbf{x} - \mathbf{y}\|_2.
 \end{aligned}$$

The last inequality follows from Lemma E.6 and Lemma F.1.

The second statement follows by the same reasoning as in the preceding proof:

 &= \left\| \mathbb{E} \left[\sum_{k=0}^{\tau-1} \bar{g}(\mathbf{x}, \boldsymbol{\theta}'; S_k, A_k) - \bar{g}(\mathbf{x}, \boldsymbol{\theta}; S_k, A_k) - \nabla L_\eta(\mathbf{x}, \boldsymbol{\theta}') + \nabla L_\eta(\mathbf{x}, \boldsymbol{\theta}) \middle| (S_0, A_0) = (s, a) \right] \right\|_2 \\
 &\leq \mathbb{E} \left[\sum_{k=0}^{\tau-1} \|\bar{g}(\mathbf{x}, \boldsymbol{\theta}'; S_k, A_k) - \bar{g}(\mathbf{x}, \boldsymbol{\theta}; S_k, A_k)\|_2 + \|\nabla L_\eta(\mathbf{x}, \boldsymbol{\theta}') - \nabla L_\eta(\mathbf{x}, \boldsymbol{\theta})\|_2 \middle| (S_0, A_0) = (s, a) \right] \\
 &\leq 2\tau_{\max} \gamma \|\boldsymbol{\Phi} \boldsymbol{\theta} - \boldsymbol{\Phi} \boldsymbol{\theta}'\|_\infty.
 \end{aligned}$$

The last inequality follows from Lemma E.6 in the Appendix.

The last statement follows from the following:

$$\begin{aligned}
 \|V(\boldsymbol{\theta}, \boldsymbol{\theta}', s, a)\|_2 &\leq \|V(\boldsymbol{\theta}, \boldsymbol{\theta}', s, a) - V(\boldsymbol{\theta}_\eta^*, \boldsymbol{\theta}_\eta^*, s, a)\|_2 + \|V(\boldsymbol{\theta}_\eta^*, \boldsymbol{\theta}_\eta^*, s, a)\|_2 \\
 &\leq \|V(\boldsymbol{\theta}, \boldsymbol{\theta}', s, a) - V(\boldsymbol{\theta}, \boldsymbol{\theta}_\eta^*, s, a)\|_2 + \|V(\boldsymbol{\theta}, \boldsymbol{\theta}_\eta^*, s, a) - V(\boldsymbol{\theta}_\eta^*, \boldsymbol{\theta}_\eta^*, s, a)\|_2 \\
 &\quad + \|V(\boldsymbol{\theta}_\eta^*, \boldsymbol{\theta}_\eta^*, s, a)\|_2 \\
 &\leq l_{V_1} \|\boldsymbol{\theta}' - \boldsymbol{\theta}_\eta^*\|_2 + l_{V_2} \|\boldsymbol{\Phi} \boldsymbol{\theta} - \boldsymbol{\Phi} \boldsymbol{\theta}_\eta^*\|_\infty + l_{V_3}.
 \end{aligned}$$

The first and second inequality follows from simple algebraic decomposition and triangle inequality. The last inequality follows from the previous two results, and applying Lemma H.2. \square

Now, we present the descent lemma version for the Markovian observation model:

Proposition H.4. For $t \in \mathbb{N}$ and $1 \leq k \leq K - 1$, we have

 &\quad - \alpha_k 2\mu_\eta (L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})) + \frac{1}{2} \alpha_k^2 l_\eta \mathbb{E} [\|g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k})\|_2^2 | \mathcal{F}_{t,k}], \quad (43)
 \end{aligned}$$

where

$$\mathcal{F}_{t,k} := \{\boldsymbol{\theta}_{0,0}, \{(s_{i,j}, a_{i,j}) : 1 \leq i \leq t, 1 \leq j \leq k\}\}.$$

Proof. We will bound the term the cross term $\nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})^\top g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k})$ in Lemma F.2 using the Poisson equation in Lemma H.1. Let us first observe the following simple decomposition of the cross term:

 &\quad + \underbrace{\nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})^\top (g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k}) - \bar{g}(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; s_{t,k}, a_{t,k}))}_{I_2}
 \end{aligned}$$

The term in I_2 disappears if we take the expectation with respect to $s_{t,k+1}$, therefore, our interest is to bound I_1 . The term I_1 can be re-written using the Poisson equation in Lemma H.1:

 &= \nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})^\top (\bar{g}(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; s_{t,k}, a_{t,k}) - \nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t,0})) + \|\nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})\|_2^2 \\
 &= \nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})^\top (V(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t,0}, s_{t,k}, a_{t,k}) - \mathbb{E}[V(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t,0}, S_1, A_1)|(S_0, A_0) = s_{t,k}, a_{t,k}]) \\
 &\quad + \|\nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})\|_2^2.
 \end{aligned}$$

The first equality follows from using simple algebraic decomposition.

Now, plugging in I_1 and I_2 , the inequality in Lemma F.2 becomes:

 &\quad - \alpha_k \|\nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})\|_2^2 + \frac{1}{2} \alpha_k^2 l_\eta \|g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k})\|_2^2 \\
 &\quad + \nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})^\top (g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k}) - \bar{g}(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; s_{t,k}, a_{t,k}))
 \end{aligned}$$

Taking conditional expectation, we get

$$\begin{aligned}
 &\mathbb{E}[L_\eta(\boldsymbol{\theta}_{t,k+1}, \boldsymbol{\theta}_{t-1,K})|\mathcal{F}_{t,k}] - L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) \\
 &\leq - \alpha_k \mathbb{E}[\mathcal{E}|\mathcal{F}_{t,k}] - \alpha_k \|\nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})\|_2^2 + \frac{1}{2} \alpha_k^2 l_\eta \mathbb{E}[\|g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k})\|_2^2|\mathcal{F}_{t,k}]. \tag{44}
 \end{aligned}$$

This is because

 &\mathbb{E}[\nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})^\top (g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k}) - \bar{g}(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; s_{t,k}, a_{t,k}))|\mathcal{F}_{t,k}] \\
 &= \nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})^\top \mathbb{E}[(g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k}) - \bar{g}(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; s_{t,k}, a_{t,k}))|\mathcal{F}_{t,k}] \\
 &= 0.
 \end{aligned}$$

Now, bounding $\|\nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})\|_2^2$ with $L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})$ from Lemma F.3 completes the proof. \square

From the above Proposition, we need to bound the following term in (44):

 & \quad + \alpha_k D_2 (L(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})) \\
 & \quad + 2\alpha_k D_3 \|\boldsymbol{\Phi}\boldsymbol{\theta}_{t,0} - \boldsymbol{\Phi}\boldsymbol{\theta}_\eta^*\|_\infty^2 + 2\alpha_k l_\eta l_{V_3}.
 \end{aligned}$$

 &= \nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})^\top (V(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t,0}, s_{t,k}, a_{t,k}) - V(\boldsymbol{\theta}_{t,k+1}, \boldsymbol{\theta}_{t,0}, s_{t,k+1}, a_{t,k+1})) \\
 &\quad + \underbrace{\nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})^\top (V(\boldsymbol{\theta}_{t,k+1}, \boldsymbol{\theta}_{t,0}, s_{t,k+1}, a_{t,k+1}) - V(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t,0}, s_{t,k+1}, a_{t,k+1}))}_{T_3} \\
 &\quad + T_4 \\
 &= \underbrace{\nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})^\top V(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t,0}, s_{t,k}, a_{t,k}) - \nabla L_\eta(\boldsymbol{\theta}_{t,k+1}, \boldsymbol{\theta}_{t-1,K})^\top V(\boldsymbol{\theta}_{t,k+1}, \boldsymbol{\theta}_{t,0}, s_{t,k+1}, a_{t,k+1})}_{T_1} \\

Then, we have

 &\leq -T_1 + |T_2| + |T_3| - T_4.
 \end{aligned} \tag{46}$$

Let us bound the terms T_2 and T_3 . First, observe the following:

 &= l_\eta \alpha_k \|g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k})\|_2 \|V(\boldsymbol{\theta}_{t,k+1}, \boldsymbol{\theta}_{t,0}, s_{t,k+1}, a_{t,k+1})\|_2 \\
 &\leq \alpha_k^2 l_\eta l_{V_1} \|g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k})\|_2^2 + \alpha_k l_\eta l_{V_1} \|g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k})\|_2 \|\boldsymbol{\theta}_{t,k} - \boldsymbol{\theta}^*(\boldsymbol{\theta}_{t,0})\|_2 \\

 \end{aligned}$$

The first inequality follows smoothness of $L_\eta(\cdot)$ in Lemma F.2. The bound on the term $\|V(\boldsymbol{\theta}_{t,k+1}, \boldsymbol{\theta}_{t,0}, s_{t,k+1}, a_{t,k+1})\|_2$ comes from Lemma H.8 in the Appendix. The last inequality comes from the quadratic growth condition in Lemma F.4 in the Appendix.

Next, we will bound T_3 . From the Lipschitzness of $V(\cdot)$ in Lemma H.3, we have

 &= |\nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})^\top (V(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t,0}, s_{t,k+1}, a_{t,k+1}) - V(\boldsymbol{\theta}_{t,k+1}, \boldsymbol{\theta}_{t,0}, s_{t,k+1}, a_{t,k+1}))| \\
 &\leq l_{V_1} \|\nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})\|_2 \|\boldsymbol{\theta}_{t,k} - \boldsymbol{\theta}_{t,k+1}\|_2 \\
 &\leq 2\alpha_k l_{V_1} \left(\|\nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})\|_2^2 + \|g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t,0}; o_{t,k})\|_2^2 \right) \\
 &\leq \alpha_k \frac{4l_{V_1} l_\eta^2}{\mu_\eta} (L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})) \\
 &\quad + 2\alpha_k l_{V_1} \|g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t,0}; o_{t,k})\|_2^2.
 \end{aligned}$$

The second inequality follows from the Cauchy-Schwarz inequality. The last inequality follows from Lemma F.4 in the Appendix.

Now, collecting the bound on T_2 and T_3 , from (46), we get

$$\begin{aligned}
 & -\nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K})^\top (V(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t,0}, s_{t,k}, a_{t,k}) - \mathbb{E}[V(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t,0}, S_1, A_1)|(S_0, A_0) = (s_{t,k}, a_{t,k})]) \\
 & \leq -d_{t,k} + d_{t,k+1} \\
 & \quad + \alpha_k (\kappa(\mu_\eta(6l_{V_1} + l_{V_3}) + l_{V_1}\gamma)) \|g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k})\|_2^2 \\
 & \quad + \alpha_k \kappa(4l_{V_1}(1 + l_\eta)) (L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})) \\
 & \quad + 2\alpha_k (\kappa l_{V_1} + l_\eta l_{V_2}) \|\Phi\boldsymbol{\theta}_{t,0} - \Phi\boldsymbol{\theta}_\eta^*\|_\infty^2 + 2\alpha_k l_\eta l_{V_3} \\
 & \quad - T_4.
 \end{aligned}$$

Taking the conditional expectation, noting that $\mathbb{E}[T_4|\mathcal{F}_{t,k}] = 0$, we get the desired result. \square

The above lemma allows us to bound the cross term in Lemma H.4. Now, applying the bound on $\mathbb{E}\left[\|g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k})\|_2^2|\mathcal{F}_{t,k}\right]$, we obtain the following result:

Proposition H.6 (Descent-lemma for inner loop). *For $\alpha_k \leq \frac{\mu_\eta}{(D_1 + \frac{l_\eta}{2})g_{1,\eta} + 2D_2}$, we have*

 & \quad - \mu_\eta \alpha_k (L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})) \\
 & \quad + \alpha_k^2 \left(\mathcal{E}_1 \|\Phi(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 + \mathcal{E}_2 \right)
 \end{aligned}$$

Proof. Applying the result of Lemma H.5 to Lemma H.4,

$$\begin{aligned}
 & \mathbb{E}[L_\eta(\boldsymbol{\theta}_{t,k+1}, \boldsymbol{\theta}_{t-1,K})|\mathcal{F}_{t,k}] - L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) \\
 & \leq -\alpha_k(d_{t,k} - \mathbb{E}[d_{t,k+1}|\mathcal{F}_{t,k}]) \\
 & \quad + \alpha_k^2 \left(D_1 + \frac{l_\eta}{2} \right) \mathbb{E}\left[\|g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k})\|_2^2|\mathcal{F}_{t,k}\right] \\
 & \quad + 2\alpha_k^2 D_3 \|\Phi\boldsymbol{\theta}_{t,0} - \Phi\boldsymbol{\theta}_\eta^*\|_\infty^2 + 2\alpha_k^2 l_\eta l_{V_3} \\
 & \quad + (\alpha_k^2 D_2 - 2\mu_\eta \alpha_k) (L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})) \\
 & \leq -\alpha_k(d_{t,k} - \mathbb{E}[d_{t,k+1}|\mathcal{F}_{t,k}]) \\
 & \quad + \alpha_k^2 \left(D_1 + \frac{l_\eta}{2} \right) g_{1,\eta} (L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})) \\
 & \quad + \alpha_k^2 \left(D_1 + \frac{l_\eta}{2} \right) g_{2,\eta} \|\Phi(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 \\
 & \quad + \alpha_k^2 \left(D_1 + \frac{l_\eta}{2} \right) g_{3,\eta} \\
 & \quad + 2\alpha_k^2 D_3 \|\Phi\boldsymbol{\theta}_{t,0} - \Phi\boldsymbol{\theta}_\eta^*\|_\infty^2 + 2\alpha_k^2 l_\eta l_{V_3} \\
 & \quad - (-D_2 \alpha_k^2 + 2\alpha_k \mu_\eta) (L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})) \\
 & \leq -\alpha_k(d_{t,k} - \mathbb{E}[d_{t,k+1}|\mathcal{F}_{t,k}]) \\
 & \quad + \left(\alpha_k^2 \left(\left(D_1 + \frac{l_\eta}{2} \right) g_{1,\eta} + 2D_2 \right) - \alpha_k 2\mu_\eta \right) (L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})) \\
 & \quad + \alpha_k^2 \left(\left(D_1 + \frac{l_\eta}{2} \right) g_{2,\eta} + D_3 \right) \|\Phi(\boldsymbol{\theta}_{t-1,K} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 \\
 & \quad + \alpha_k^2 \left(D_1 + \frac{l_\eta}{2} \right) g_{3,\eta} + 2\alpha_k^2 l_\eta l_{V_3}.
 \end{aligned}$$

The second inequality follows from the bound on $\mathbb{E} \left[\|g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k})\|_2^2 \middle| \mathcal{F}_{t,k} \right]$ in Lemma E.2. The step-size condition

$$\begin{aligned} \alpha_k &\leq \frac{\mu_\eta}{\left(D_1 + \frac{l_\eta}{2}\right) g_{1,\eta} + 2D_2} \\ \Rightarrow \alpha_k^2 \left(\left(D_1 + \frac{l_\eta}{2}\right) g_{1,\eta} + 2D_2 \right) - \alpha_k 2\mu_\eta &\leq -\alpha_k \mu_\eta \end{aligned}$$

yields the desired result. \square

Before proceeding, we introduce the constants that determine the step-size:

$$\begin{aligned} \bar{\alpha}_1 &= \frac{\mu_\eta}{\left(D_1 + \frac{l_\eta}{2}\right) g_{1,\eta} + 2D_2}, \\ \bar{\alpha}_2 &= \frac{\mu_\eta}{16l_\eta(6l_{V_1} + l_{V_3})(1+\eta) + 24\kappa l_{V_1}(1+\eta)}, \\ \bar{\alpha}_3 &= \frac{\mu_\eta^2(\gamma\|\boldsymbol{\Gamma}_\eta\|_\infty)^2(1-(\gamma\|\boldsymbol{\Gamma}_\eta\|_\infty)^2)}{8(1+(\gamma\|\boldsymbol{\Gamma}_\eta\|_\infty)^2)(2\mu_\eta\mathcal{E}_1 + 4\mu_\eta(l_{V_1}\gamma\kappa + l_\eta l_{V_2}))}, \\ \bar{\alpha}_4 &= \frac{2\mu_\eta^2\epsilon\gamma^2(1-(\gamma\|\boldsymbol{\Gamma}_\eta\|_\infty)^2)}{4(1+(\gamma\|\boldsymbol{\Gamma}_\eta\|_\infty)^2)(\mathcal{E}_2 + 3l_\eta l_{V_3}\mu_\eta)}. \end{aligned} \tag{47}$$

Now, using the above descent lemma for the inner loop, we are ready to derive the convergence rate result of the inner-loop iteration:

Proposition H.7. For $\alpha \leq \min\{\bar{\alpha}_1, \bar{\alpha}_2\}$, which is defined in (47), we have

$$\begin{aligned} &\mathbb{E} [L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})] \\ &\leq 2 \left(1 - \frac{\mu_\eta}{2}\right)^k \mathbb{E} [L_\eta(\boldsymbol{\theta}_{t,0}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})] \\ &\quad + 2\alpha \left(\left(\frac{2}{\mu_\eta}\mathcal{E}_1 + 4(l_{V_1}\gamma\kappa + l_\eta l_{V_2})\right) \mathbb{E} \left[\|\boldsymbol{\Phi}(\boldsymbol{\theta}_{t,K-1} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 \middle| \mathcal{F}_{t,0} \right] + \frac{2}{\mu_\eta}\mathcal{E}_2 + 6l_\eta l_{V_3} \right). \end{aligned}$$

Proof. For simplicity of the proof, let $x_k = \mathbb{E} [L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K}) | \mathcal{F}_{t,0}]$. Then, taking the conditional expectation on $\mathcal{F}_{t,0}$ to the result of Proposition H.6, we have

$$\begin{aligned} &x_{k+1} \\ &\leq (1 - \mu_\eta \alpha_k) x_k - \alpha_k \mathbb{E} [d_{t,k} - d_{t,k+1} | \mathcal{F}_{t,0}] + \alpha_k^2 \left(\mathcal{E}_1 \mathbb{E} \left[\|\boldsymbol{\Phi}(\boldsymbol{\theta}_{t,K-1} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 \middle| \mathcal{F}_{t,0} \right] + \mathcal{E}_2 \right) \\ &= (1 - \mu_\eta \alpha_k) x_k - \left(1 - \frac{\mu_\eta}{2}\alpha_k\right) \alpha_k \mathbb{E} [d_{t,k} | \mathcal{F}_{t,0}] - \frac{\mu_\eta}{2} \alpha_k^2 \mathbb{E} [d_{t,k} | \mathcal{F}_{t,0}] + \alpha \mathbb{E} [d_{t,k+1} | \mathcal{F}_{t,0}] \\ &\quad + \alpha_k^2 \left(\mathcal{E}_1 \mathbb{E} \left[\|\boldsymbol{\Phi}(\boldsymbol{\theta}_{t,K-1} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 \middle| \mathcal{F}_{t,0} \right] + \mathcal{E}_2 \right) \\ &\leq (1 - \mu_\eta \alpha_k) x_k - \left(1 - \frac{\mu_\eta}{2}\alpha_k\right) \alpha_k \mathbb{E} [d_{t,k} | \mathcal{F}_{t,0}] + \alpha \mathbb{E} [d_{t,k+1} | \mathcal{F}_{t,0}] + \alpha_k^2 \left(\mathcal{E}_1 \mathbb{E} \left[\|\boldsymbol{\Phi}(\boldsymbol{\theta}_{t,K-1} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 \middle| \mathcal{F}_{t,0} \right] + \mathcal{E}_2 \right) \\ &\quad + \alpha_k^2 \left((l_\eta l_{V_1} + 4l_\eta l_{V_3} + 2(\kappa l_{V_1}\gamma + l_\eta l_{V_2})) x_k + \mu_\eta (l_{V_1}\gamma\kappa + l_\eta l_{V_2}) \mathbb{E} \left[\|\boldsymbol{\Phi}(\boldsymbol{\theta}_{t,0} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 \middle| \mathcal{F}_{t,0} \right] + \mu_\eta l_\eta l_{V_3} \right) \\ &= (1 - \mu_\eta \alpha_k + (l_\eta l_{V_1} + 4l_\eta l_{V_3} + 2(\kappa l_{V_1}\gamma + l_\eta l_{V_2})) \alpha_k^2) x_k - \left(1 - \frac{\mu_\eta}{2}\alpha_k\right) \alpha_k \mathbb{E} [d_{t,k} | \mathcal{F}_{t,0}] + \alpha \mathbb{E} [d_{t,k+1} | \mathcal{F}_{t,0}] \\ &\quad + \alpha_k^2 \left((\mathcal{E}_1 + \mu_\eta (l_{V_1}\gamma\kappa + l_\eta l_{V_2})) \mathbb{E} \left[\|\boldsymbol{\Phi}(\boldsymbol{\theta}_{t,K-1} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 \middle| \mathcal{F}_{t,0} \right] + \mathcal{E}_2 + 2\mu_\eta l_\eta l_{V_3} \right). \end{aligned}$$

where the first equality follows from simple algebraic decomposition. The last inequality follows from bounding $d_{t,k}$ from Lemma H.9 in the Appendix Section H.4.

Since $\frac{\mu_\eta}{16l_\eta(6l_{V_1} + l_{V_3})(1+\eta) + 24\kappa l_{V_1}(1+\eta)} \leq \frac{\mu_\eta}{2(l_\eta l_{V_1} + 4l_\eta l_{V_3} + 2(\kappa l_{V_1}\gamma + l_\eta l_{V_2}))}$, the step-size condition

$$-\mu_\eta \alpha_k + (l_\eta l_{V_1} + 4l_\eta l_{V_3} + 2(\kappa l_{V_1}\gamma + l_\eta l_{V_2})) \alpha^2 \leq -\frac{\mu_\eta \alpha}{2}$$

yields the following:

$$\begin{aligned} x_{k+1} &\leq \left(1 - \frac{\mu_\eta}{2}\alpha\right) x_k - \left(1 - \frac{\mu_\eta}{2}\alpha_k\right) \alpha_k d_{t,k} + \alpha d_{t,k+1} \\ &\quad + \alpha_k^2 \left((\mathcal{E}_1 + \mu_\eta (l_{V_1} \gamma \kappa + l_\eta l_{V_2})) \mathbb{E} \left[\|\Phi(\theta_{t,K-1} - \theta_\eta^*)\|_\infty^2 \middle| \mathcal{F}_{t,0} \right] + \mathcal{E}_2 + 2\mu_\eta l_\eta l_{V_3} \right). \end{aligned}$$

Recursively expanding the terms, we get

$$\begin{aligned} x_{k+1} &\leq \left(1 - \frac{\mu_\eta}{2}\alpha\right)^k x_0 + \alpha d_{t,k+1} \\ &\quad + \frac{2}{\mu_\eta} \alpha_k \left((\mathcal{E}_1 + \mu_\eta (l_{V_1} \gamma \kappa + l_\eta l_{V_2})) \mathbb{E} \left[\|\Phi(\theta_{t,K-1} - \theta_\eta^*)\|_\infty^2 \middle| \mathcal{F}_{t,0} \right] + \mathcal{E}_2 + 2\mu_\eta l_\eta l_{V_3} \right) \\ &\leq \left(1 - \frac{\mu_\eta}{2}\alpha\right)^k x_0 + \alpha \frac{2}{\mu_\eta} (l_\eta l_{V_1} + 4l_\eta l_{V_3} + 2(\kappa l_{V_1} \gamma + l_\eta l_{V_2})) x_{k+1} \\ &\quad + \alpha \left(\left(\frac{2}{\mu_\eta} \mathcal{E}_1 + 4(l_{V_1} \gamma \kappa + l_\eta l_{V_2}) \right) \mathbb{E} \left[\|\Phi(\theta_{t,K-1} - \theta_\eta^*)\|_\infty^2 \middle| \mathcal{F}_{t,0} \right] + \frac{2}{\mu_\eta} \mathcal{E}_2 + 6l_\eta l_{V_3} \right). \end{aligned}$$

The last inequality follows from the bounding $d_{t,k+1}$ of Lemma H.9 in Appendix Section H.4.

Noting that $\frac{\mu_\eta}{16l_\eta(6l_{V_1}+l_{V_3})(1+\eta)+24\kappa l_{V_1}(1+\eta)} \leq \frac{\mu_\eta}{4(l_\eta l_{V_1}+4l_\eta l_{V_3}+2(\kappa l_{V_1} \gamma + l_\eta l_{V_2}))}$, we have

$$\begin{aligned} x_{k+1} &\leq 2 \left(1 - \frac{\mu_\eta}{2}\alpha\right)^k x_0 \\ &\quad + 2\alpha \left(\left(\frac{2}{\mu_\eta} \mathcal{E}_1 + 4(l_{V_1} \gamma \kappa + l_\eta l_{V_2}) \right) \mathbb{E} \left[\|\Phi(\theta_{t,K-1} - \theta_\eta^*)\|_\infty^2 \middle| \mathcal{F}_{t,0} \right] + \frac{2}{\mu_\eta} \mathcal{E}_2 + 6l_\eta l_{V_3} \right). \end{aligned}$$

Taking the total expectation, we have the desired results. \square

We are now ready to present the main result in the proof of Theorem 6.5. By applying the result of the inner iteration analysis to the outer iteration decomposition established in Proposition 6.1, we obtain the desired conclusion.

H.3. Proof of Theorem 6.5

Proof. For simplicity of the proof, let $y_t = \mathbb{E} \left[\|\Phi(\theta_{t,K} - \theta_\eta^*)\|_\infty^2 \right]$.

Applying the result in Proposition H.7 to the bound in Proposition 6.1 with $\delta = \frac{2(\gamma\|\mathbf{\Gamma}_\eta\|_\infty)^2}{1-(\gamma\|\mathbf{\Gamma}_\eta\|_\infty)^2}$, we have

$$\begin{aligned} y_t &\leq \left(\frac{1 + (\gamma\|\mathbf{\Gamma}_\eta\|_\infty)^2}{\mu_\eta(\gamma\|\mathbf{\Gamma}_\eta\|_\infty)^2} \left(16 \left(1 - \frac{\mu_\eta}{2}\alpha_0\right)^K + 2\alpha \left(\frac{2}{\mu_\eta} \mathcal{E}_1 + 4(l_{V_1} \gamma \kappa + l_\eta l_{V_2}) \right) \right) + \frac{1 + (\gamma\|\mathbf{\Gamma}_\eta\|_\infty)^2}{2} \right) y_{t-1} \\ &\quad + \underbrace{\frac{1 + (\gamma\|\mathbf{\Gamma}_\eta\|_\infty)^2}{\mu_\eta(\gamma\|\mathbf{\Gamma}_\eta\|_\infty)^2} \left(2 \left(1 - \frac{\mu_\eta}{2}\alpha_0\right)^K (R_{\max}^2 + 8\|\Phi\theta_\eta^*\|_\infty^2) + 2\alpha \left(\frac{2}{\mu_\eta} \mathcal{E}_2 + 6l_\eta l_{V_3} \right) \right)}_{:= \mathcal{E}_{K,\alpha_0}}. \end{aligned} \quad (48)$$

Let us first bound the coefficient of y_t with $\frac{3+(\gamma\|\mathbf{\Gamma}_\eta\|_\infty)^2}{4}$. Then, it is enough to bound the coefficient in (48) with $\frac{1-(\gamma\|\mathbf{\Gamma}_\eta\|_\infty)^2}{4}$, i.e., we require

$$\frac{1 + (\gamma\|\mathbf{\Gamma}_\eta\|_\infty)^2}{\mu_\eta(\gamma\|\mathbf{\Gamma}_\eta\|_\infty)^2} \left(16 \left(1 - \frac{\mu_\eta}{2}\alpha_0\right)^K + 2\alpha \left(\frac{2}{\mu_\eta} \mathcal{E}_1 + 4(l_{V_1} \gamma \kappa + l_\eta l_{V_2}) \right) \right) \leq \frac{1 - (\gamma\|\mathbf{\Gamma}_\eta\|_\infty)^2}{4}.$$

The above condition is satisfied if

$$16 \left(1 - \frac{\mu_\eta}{2}\alpha_0\right)^K \leq \frac{\mu_\eta(\gamma\|\mathbf{\Gamma}_\eta\|_\infty)^2(1 - (\gamma\|\mathbf{\Gamma}_\eta\|_\infty)^2)}{8(1 + (\gamma\|\mathbf{\Gamma}_\eta\|_\infty)^2)},$$

$$2\alpha \left(\frac{2}{\mu_\eta} \mathcal{E}_1 + 4(l_{V_1} \gamma \kappa + l_\eta l_{V_2}) \right) \leq \frac{\mu_\eta (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2 (1 - (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2)}{8(1 + (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2)}.$$

These inequalities are, in turn, ensured by choosing K and α_0 such that

$$K \geq \frac{2}{\mu_\eta \alpha_0} \ln \left(\frac{\mu_\eta (1 - (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2)}{128(1 + (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2)} \right), \quad \alpha_0 \leq \bar{\alpha}_3 \quad (49)$$

Applying this result to (48), we get

$$\begin{aligned} y_t &\leq \frac{3 + (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2}{4} y_{t-1} + \mathcal{E}_{K, \alpha_0} \\ &\leq \left(\frac{3 + (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2}{4} \right)^2 y_{t-2} + \sum_{j=t-1}^t \left(\frac{3 + (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2}{4} \right)^{t-j} \mathcal{E}_{K, \alpha_0}, \\ &\leq \left(\frac{3 + (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2}{4} \right)^t y_0 + \frac{4}{1 - (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2} \mathcal{E}_{K, \alpha_0}. \end{aligned}$$

For the above bound to be smaller than ϵ , a sufficient condition is to make each terms smaller than $\frac{\epsilon}{2}$:

$$\left(\frac{3 + (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2}{4} \right)^t \mathbb{E} \left[\|\Phi \theta_{0,K} - \Phi \theta_\eta^*\|_\infty^2 \right] \leq \frac{\epsilon}{2},$$

which is satisfied if we choose t as follows:

$$t \geq \frac{4}{1 - (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2} \ln \left(\frac{2 \|\Phi(\theta_{0,K} - \theta_\eta^*)\|_\infty^2}{\epsilon} \right). \quad (50)$$

To bound the remaining term, $\frac{1}{1 - (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2} \mathcal{E}_{K, \alpha_0}$, with $\frac{\epsilon}{2}$, we require

$$\frac{1 + (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2}{\mu_\eta (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2} \left(2 \left(1 - \frac{\mu_\eta}{2} \alpha_0 \right)^K (R_{\max}^2 + 8 \|\Phi \theta_\eta^*\|_\infty^2) + 2\alpha \left(\frac{2}{\mu_\eta} \mathcal{E}_2 + 6l_\eta l_{V_3} \right) \right) \leq \frac{(1 - (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2) \epsilon}{2}.$$

Now, bound each terms with $\frac{(1 - (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2) \epsilon}{4}$, we need

$$\begin{aligned} \exp(-K \mu_\eta \alpha_0 / 2) (R_{\max}^2 + 8 \|\Phi \theta_\eta^*\|_\infty^2) &\leq \frac{\epsilon (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2 \mu_\eta (1 - (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2)}{4(1 + (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2)} \\ \iff K &\geq \frac{2}{\mu_\eta \alpha_0} \ln \left(\frac{1}{R_{\max}^2 + 8 \|\Phi \theta_\eta^*\|_\infty^2} \frac{4(1 + (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2)}{\epsilon (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2 \mu_\eta (1 - (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2)} \right) \end{aligned} \quad (51)$$

Likewise, bounding the remaining term with $\frac{(1 - (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2) \epsilon}{4}$, we require

$$\begin{aligned} \alpha_0 (\mathcal{E}_2 + 3l_\eta l_{V_3} \mu_\eta) &\leq \frac{\epsilon \gamma^2 \mu_\eta (1 - (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2)}{4(1 + (\gamma \|\mathbf{\Gamma}_\eta\|_\infty)^2)} \\ \iff \alpha_0 &\leq \bar{\alpha}_4. \end{aligned} \quad (52)$$

Now, collecting the conditions on α in (49) and (52), we need

$$\begin{aligned} &\alpha_0 \\ &= \min \left\{ \frac{\mu_\eta}{l_\eta (6l_{V_1} + l_{V_3})(1 + \eta) + \kappa l_{V_1}(1 + \eta)}, \bar{\alpha}_2, \bar{\alpha}_3 \right\} \end{aligned}$$

Moreover, collecting the bound on K in (49) and (51), we have

$$K = \mathcal{O} \left(\max \left\{ \frac{l_\eta (6l_{V_1} + l_{V_3})(1 + \eta) + \kappa l_{V_1}(1 + \eta)}{\mu_\eta^2}, \frac{2\mu_\eta \mathcal{E}_1 + 4\mu_\eta (l_{V_1} \kappa + l_\eta l_{V_2})}{\mu_\eta^3 (1 - \gamma \|\mathbf{\Gamma}_\eta\|_\infty)}, \frac{\mathcal{E}_2 + \mu_\eta l_\eta l_{V_3}}{\epsilon \mu_\eta^2 (1 - \gamma \|\mathbf{\Gamma}_\eta\|_\infty)} \right\} \right).$$

This completes the proof. \square

H.4. Auxiliary Lemmas for Markovian Observation Model Analysis

Lemma H.8. *We have for $t \in \mathbb{N}$ and $1 \leq k \leq K-1$,*

$$\begin{aligned} \|V(\boldsymbol{\theta}_{t,k+1}, \boldsymbol{\theta}_{t,0}, s_{t,k+1}, a_{t,k+1})\|_2 &\leq l_{V_1} \alpha_k \|g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k})\|_2 + l_{V_1} \|\boldsymbol{\theta}_{t,k} - \boldsymbol{\theta}^*(\boldsymbol{\theta}_{t,0})\|_2 \\ &\quad + \left(\frac{l_{V_1} \gamma}{\mu_\eta} + l_{V_2} \right) \|\Phi(\boldsymbol{\theta}_{t,0} - \boldsymbol{\theta}_\eta^*)\|_\infty + l_{V_3}. \end{aligned}$$

Proof. We have

$$\begin{aligned} &\|V(\boldsymbol{\theta}_{t,k+1}, \boldsymbol{\theta}_{t,0}, s_{t,k+1}, a_{t,k+1})\|_2 \\ &\leq \|V(\boldsymbol{\theta}_{t,k+1}, \boldsymbol{\theta}_{t,0}, s_{t,k+1}, a_{t,k+1}) - V(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t,0}), \boldsymbol{\theta}_{t,0}, s_{t,k+1}, a_{t,k+1})\|_2 \\ &\quad + \|V(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t,0}), \boldsymbol{\theta}_{t,0}, s_{t,k+1}, a_{t,k+1})\|_2 \\ &\leq l_{V_1} \|\boldsymbol{\theta}_{t,k+1} - \boldsymbol{\theta}^*(\boldsymbol{\theta}_{t,0})\|_2 + \|V(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t,0}), \boldsymbol{\theta}_{t,0}, s_{t,k+1}, a_{t,k+1})\|_2 \\ &\leq l_{V_1} \|\boldsymbol{\theta}_{t,k+1} - \boldsymbol{\theta}_{t,k}\|_2 + l_{V_1} \|\boldsymbol{\theta}_{t,k} - \boldsymbol{\theta}^*(\boldsymbol{\theta}_{t,0})\|_2 \\ &\quad + l_{V_1} \|\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t,0}) - \boldsymbol{\theta}_\eta^*\|_2 + l_{V_2} \|\Phi(\boldsymbol{\theta}_{t,0} - \boldsymbol{\theta}_\eta^*)\|_\infty + l_{V_3} \\ &\leq l_{V_1} \alpha_k \|g(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}; o_{t,k})\|_2 + l_{V_1} \|\boldsymbol{\theta}_{t,k} - \boldsymbol{\theta}^*(\boldsymbol{\theta}_{t,0})\|_2 \\ &\quad + \left(\frac{l_{V_1} \gamma}{\mu_\eta} + l_{V_2} \right) \|\Phi(\boldsymbol{\theta}_{t,0} - \boldsymbol{\theta}_\eta^*)\|_\infty + l_{V_3}. \end{aligned}$$

The first equality follows from algebraic decomposition and triangle inequality. The second inequality follows from lipschitzness of $V(\cdot)$ in Lemma H.3. The last inequality follows lipschitzness of $\boldsymbol{\theta}^*(\cdot)$ in Lemma F.5. This completes the proof. \square

Lemma H.9. *For $t \in \mathbb{N}$ and $1 \leq k \leq K$, we have*

$$\begin{aligned} |d_{t,k}| &\leq \frac{2}{\mu_\eta} (l_\eta l_{V_1} + 4l_\eta l_{V_3} + 2(\kappa l_{V_1} \gamma + l_\eta l_{V_2})) (L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})) \\ &\quad + 2(l_{V_1} \gamma \kappa + l_\eta l_{V_2}) \|\Phi(\boldsymbol{\theta}_{t,0} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 + 2l_\eta l_{V_3}. \end{aligned}$$

Proof. From the definition of $d_{t,k}$ in (45),

$$\begin{aligned} |d_{t,k}| &= |\nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t,0})^\top V(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t,0}, s_{t,k}, a_{t,k})| \\ &\leq \|\nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t,0})\|_2 \|V(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t,0}, s_{t,k}, a_{t,k})\|_2 \\ &= \|\nabla L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t,0}) - \nabla L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t,0}), \boldsymbol{\theta}_{t,0})\|_2 \|V(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t,0}, s_{t,k}, a_{t,k})\|_2 \\ &\leq l_\eta \|\boldsymbol{\theta}_{t,k} - \boldsymbol{\theta}^*(\boldsymbol{\theta}_{t,0})\|_2 \left(l_{V_1} \|\boldsymbol{\theta}_{t,k} - \boldsymbol{\theta}_\eta^*\|_2 + l_2 \|\Phi(\boldsymbol{\theta}_{t,0} - \boldsymbol{\theta}_\eta^*)\|_\infty + l_{V_3} \right) \\ &\leq l_\eta \|\boldsymbol{\theta}_{t,k} - \boldsymbol{\theta}^*(\boldsymbol{\theta}_{t,0})\|_2 \left(l_{V_1} \|\boldsymbol{\theta}_{t,k} - \boldsymbol{\theta}^*(\boldsymbol{\theta}_{t,0})\|_2 + l_{V_1} \|\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t,0}) - \boldsymbol{\theta}_\eta^*\|_2 + l_{V_2} \|\Phi(\boldsymbol{\theta}_{t,0} - \boldsymbol{\theta}_\eta^*)\|_\infty + l_{V_3} \right) \\ &\leq l_\eta l_{V_1} \|\boldsymbol{\theta}_{t,k} - \boldsymbol{\theta}^*(\boldsymbol{\theta}_{t,0})\|_2^2 \\ &\quad + l_\eta \|\boldsymbol{\theta}_{t,k} - \boldsymbol{\theta}^*(\boldsymbol{\theta}_{t,0})\|_2 \left(\left(\frac{l_{V_1} \gamma}{\mu_\eta} + l_{V_2} \right) \|\Phi(\boldsymbol{\theta}_{t,0} - \boldsymbol{\theta}_\eta^*)\|_\infty + l_{V_3} \right) \\ &\leq (l_\eta l_{V_1} + 4l_\eta l_{V_3} + 2(\kappa l_{V_1} \gamma + l_\eta l_{V_2})) \|\boldsymbol{\theta}_{t,k} - \boldsymbol{\theta}^*(\boldsymbol{\theta}_{t,0})\|_2^2 \\ &\quad + 2(l_{V_1} \gamma \kappa + l_\eta l_{V_2}) \|\Phi(\boldsymbol{\theta}_{t,0} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 + 2l_\eta l_{V_3} \\ &\leq \frac{2}{\mu_\eta} (l_\eta l_{V_1} + 4l_\eta l_{V_3} + 2(\kappa l_{V_1} \gamma + l_\eta l_{V_2})) (L_\eta(\boldsymbol{\theta}_{t,k}, \boldsymbol{\theta}_{t-1,K}) - L_\eta(\boldsymbol{\theta}^*(\boldsymbol{\theta}_{t-1,K}), \boldsymbol{\theta}_{t-1,K})) \\ &\quad + 2(l_{V_1} \gamma \kappa + l_\eta l_{V_2}) \|\Phi(\boldsymbol{\theta}_{t,0} - \boldsymbol{\theta}_\eta^*)\|_\infty^2 + 2l_\eta l_{V_3}. \end{aligned}$$

The first inequality follows from the Cauchy-Schwarz inequality. The third inequality follows from the smoothness of L . \square




Figure 5. Double-loop structure of PRQ. The inner loop performs gradient descent to solve the regularized subproblem for K times, and the outer loop updates the target parameter.
